and described.

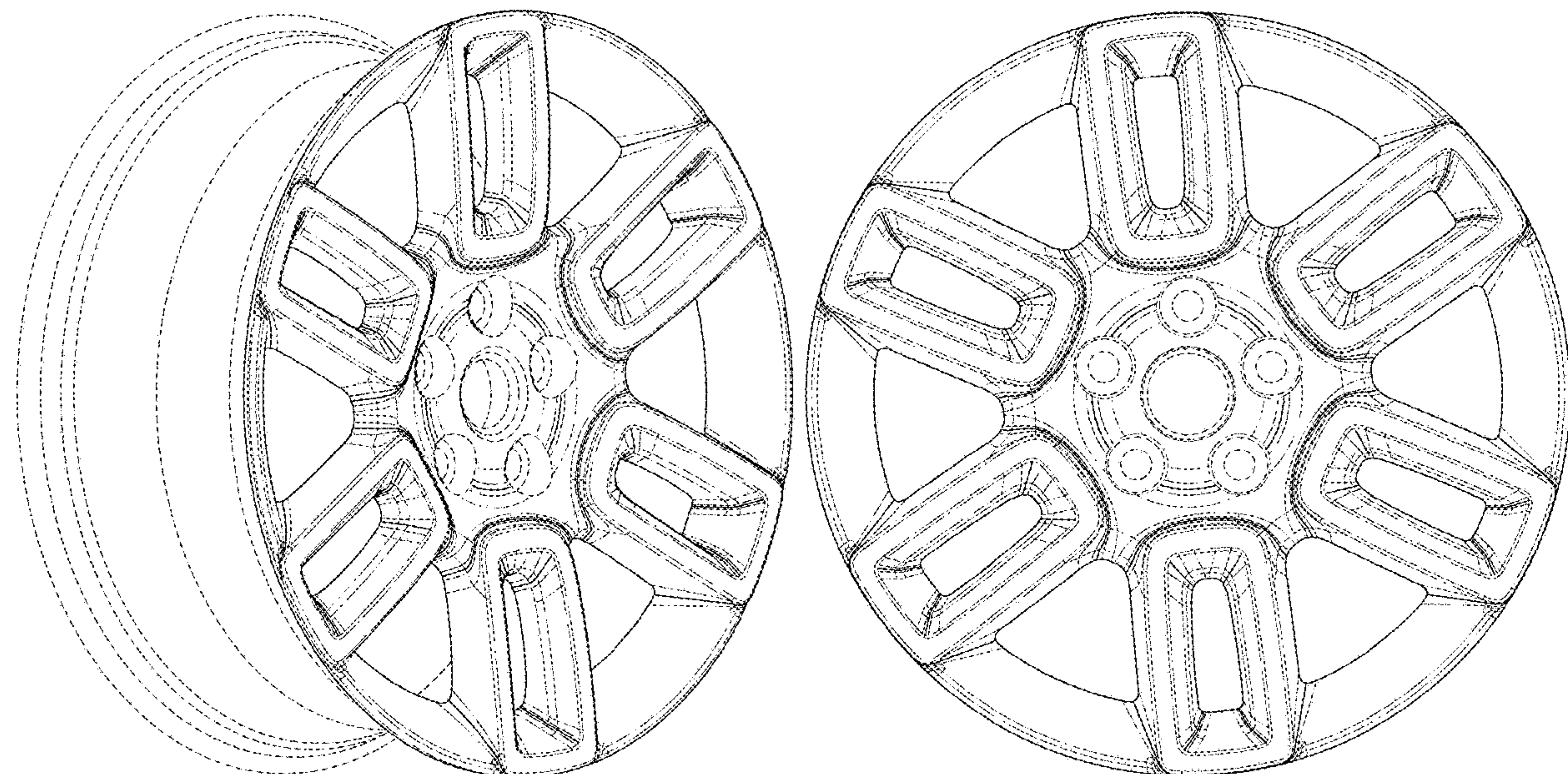
DESCRIPTION

FIG. 1 is a front left perspective view of a wheel for a vehicle
according to the present invention.

FIG. 2 is a front view of the wheel shown in FIG. 1; and,
FIG. 3 is a left side view thereof, the right side view being

instead included to show environmental structure.

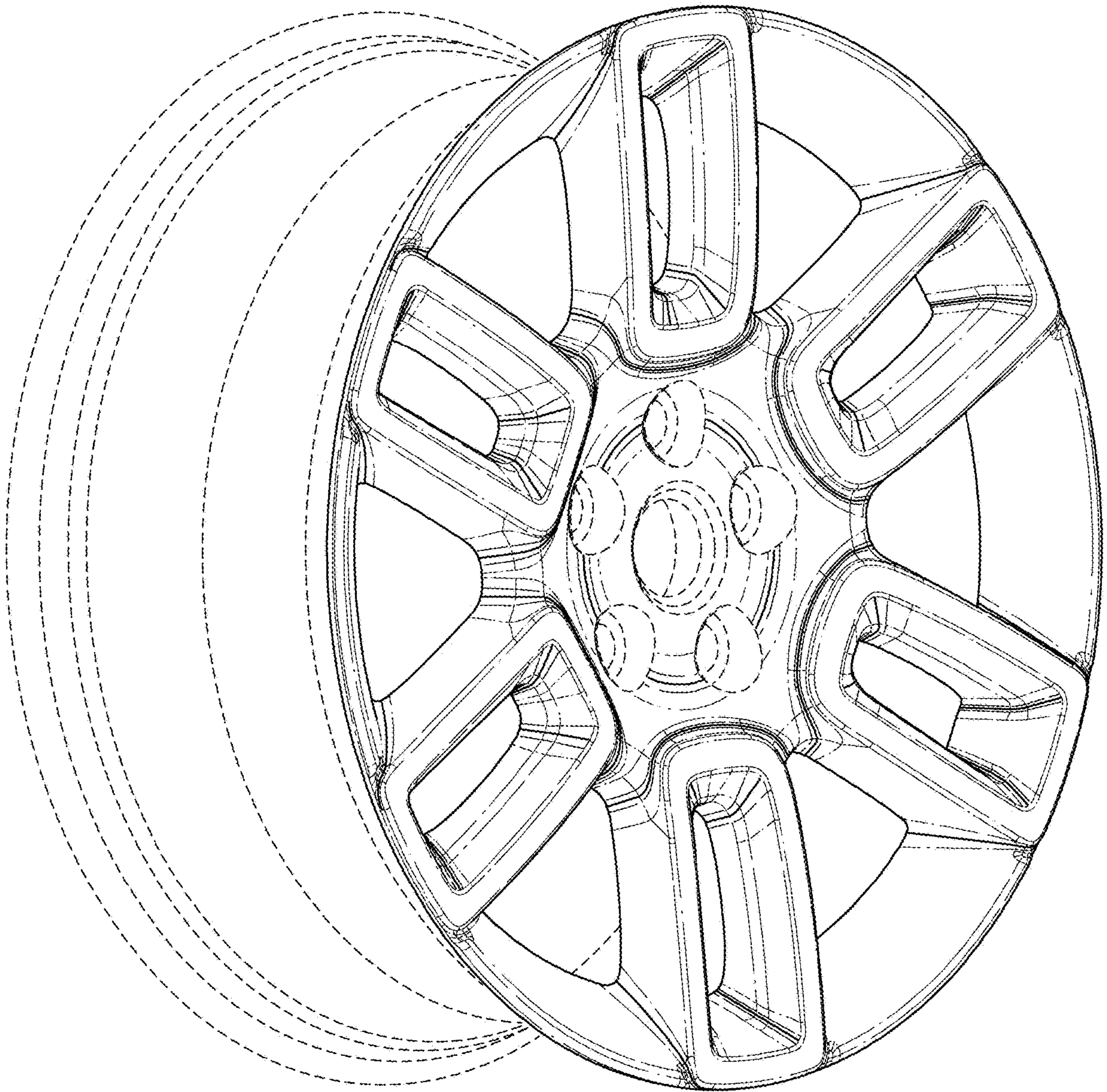

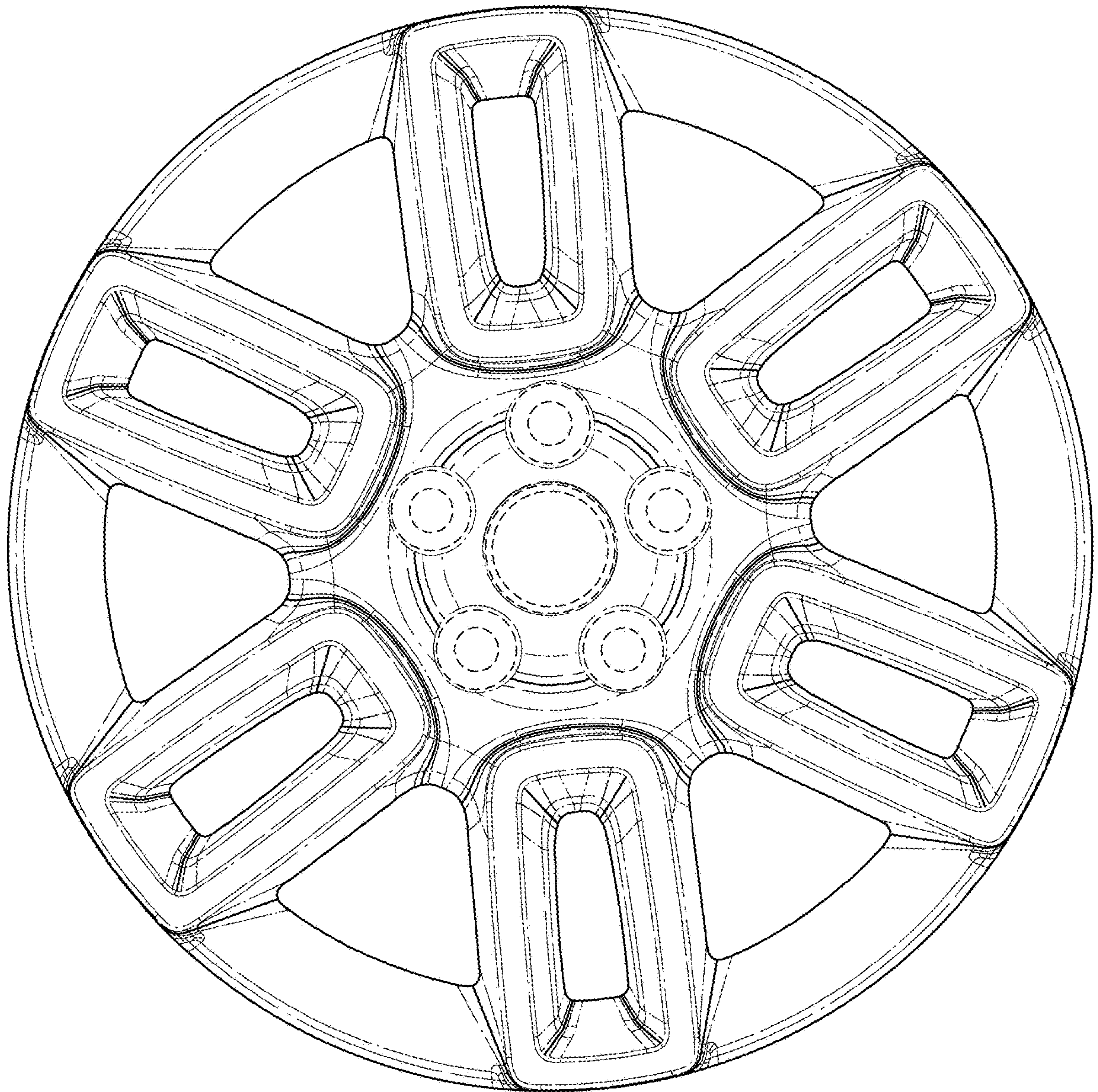

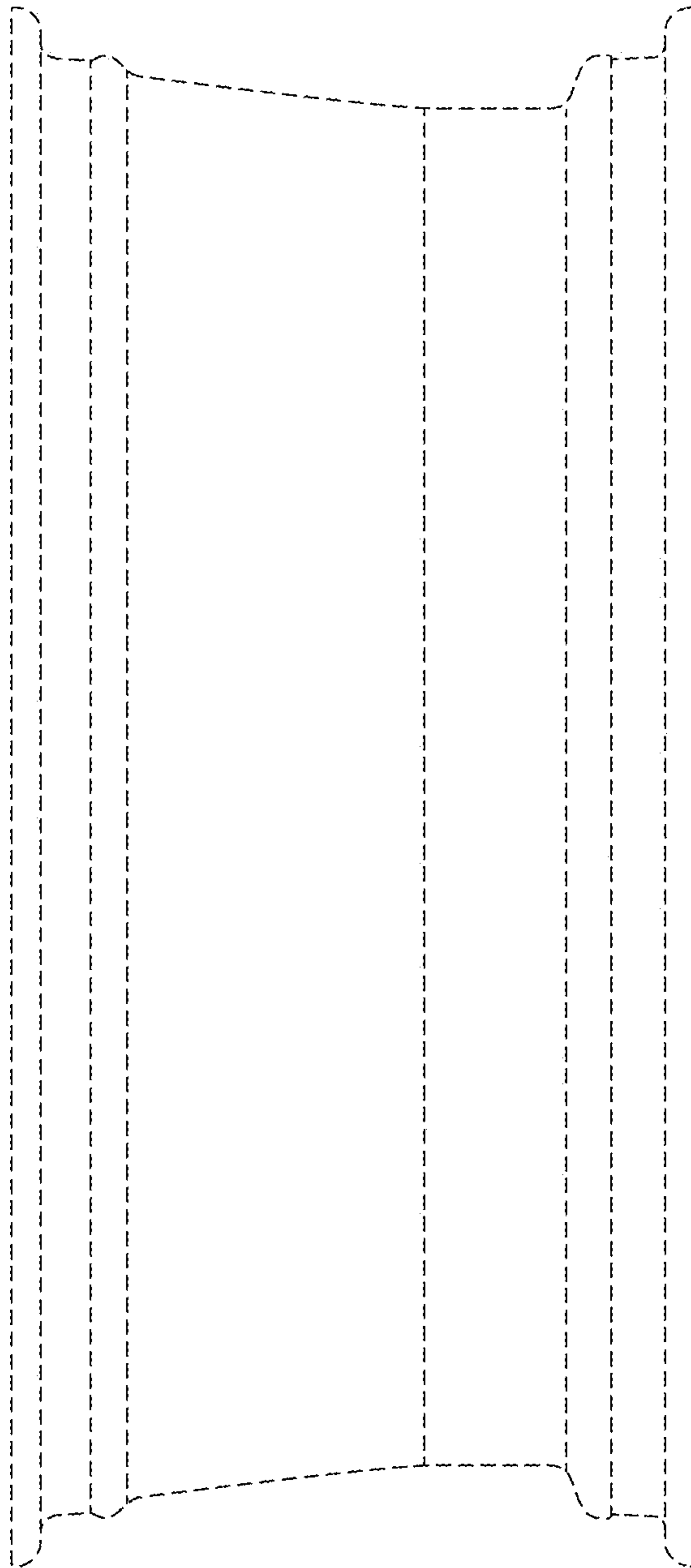
