FIG. 4 is a rear view thereof;


FIG. 5 is a left side view thereof;


FIG. 6 is a right side view thereof;

FIG. 7 is a top view thereof; and,


FIG. 8 is a bottom view thereof.

The broken lines illustrate portions of the filter bracket which form no part of the claimed design. Grayscale shading illustrates contour.












