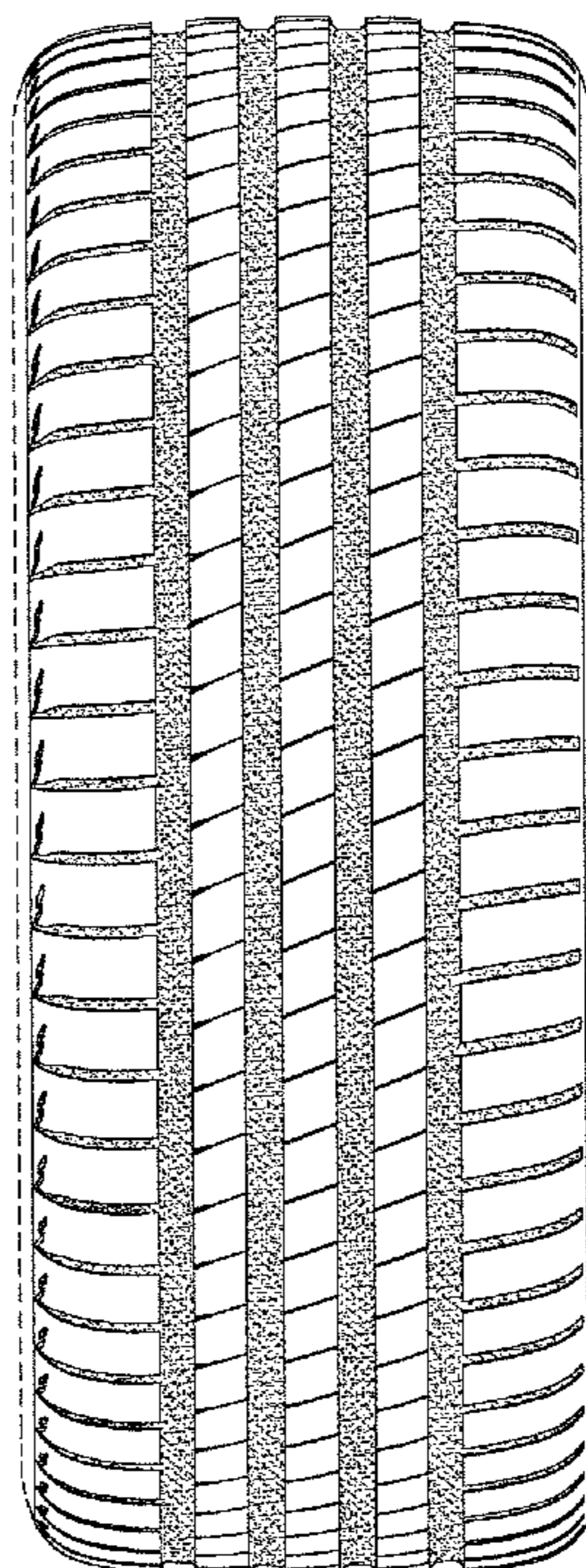

DESCRIPTION

FIG. 1 is a perspective view of the tire;
FIG. 2 is a front view of the tire;
FIG. 3 is a right view of the tire;
FIG. 4 is a left view of the tire;
FIG. 5 is an enlarged view of the tire with section lines related to views 6, 7, 8;
FIG. 6 is a first transversal section view of the tire;
FIG. 7 is a second transversal section view of the tire; and,
FIG. 8 is a third transversal section view of the tire.

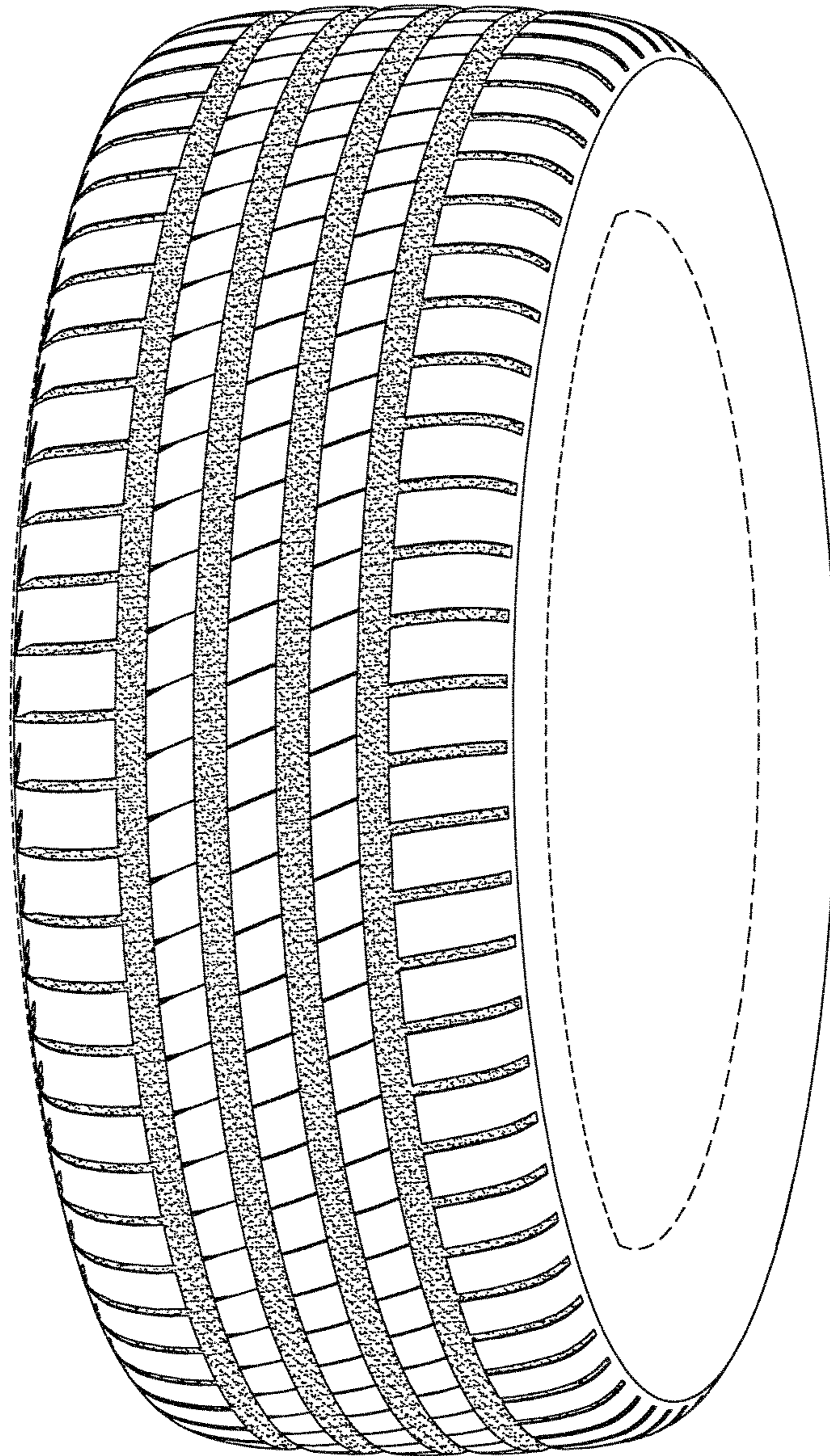

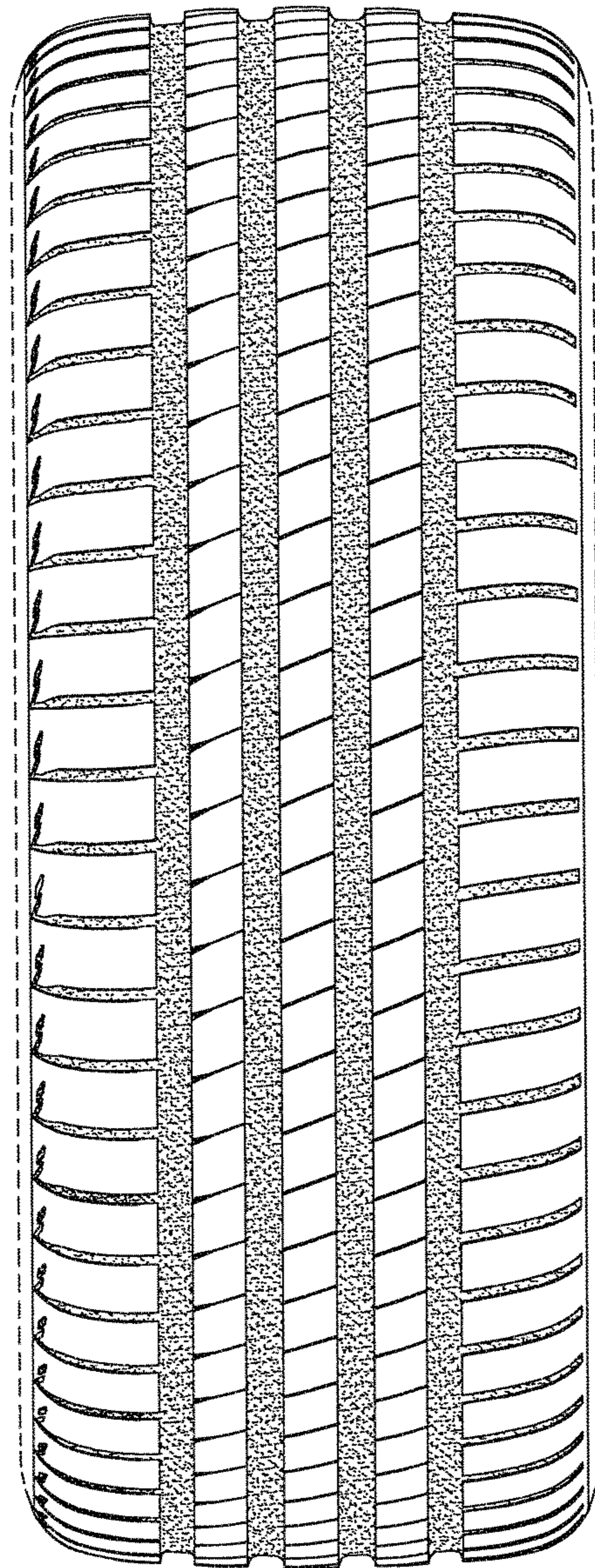

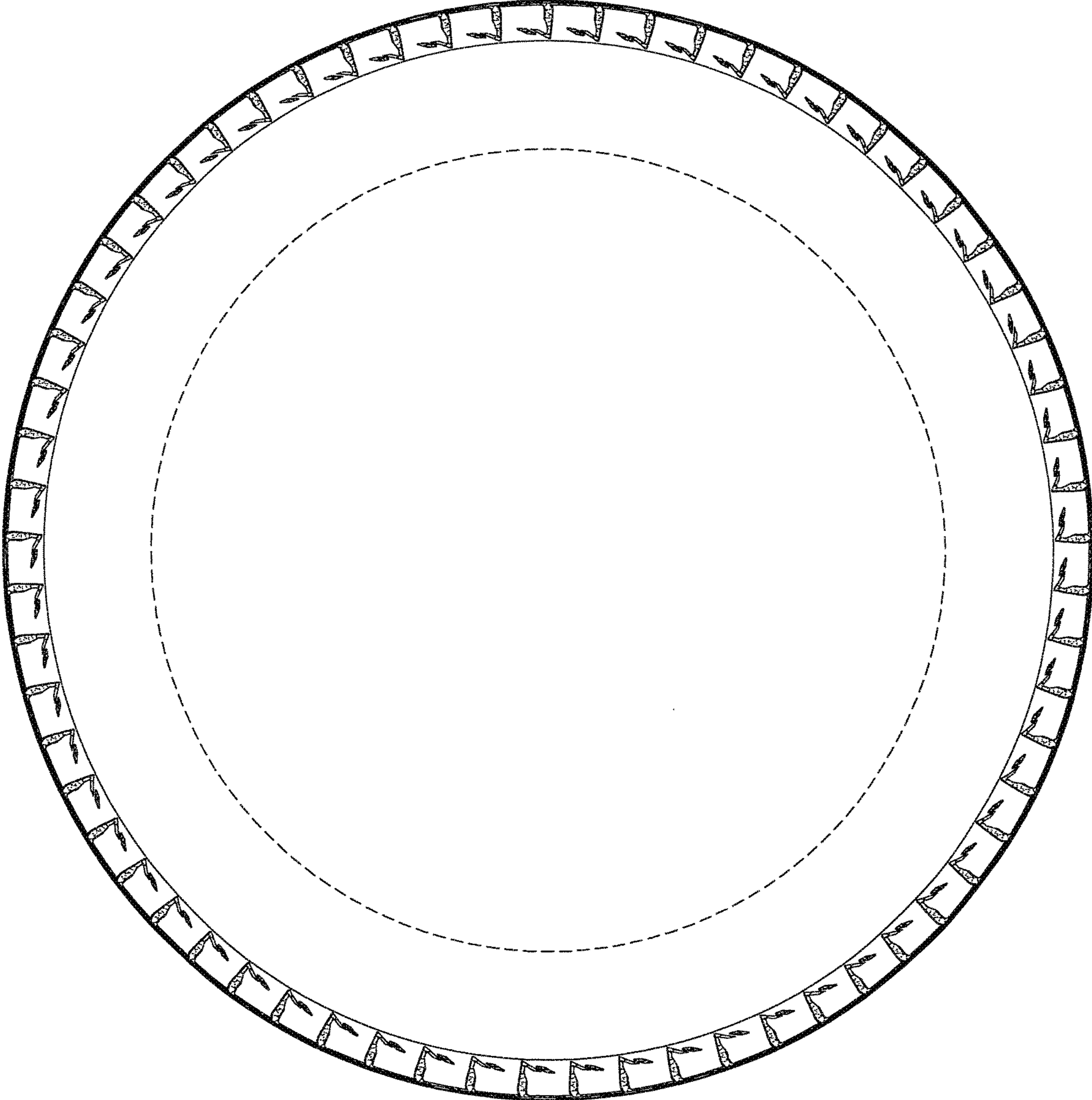

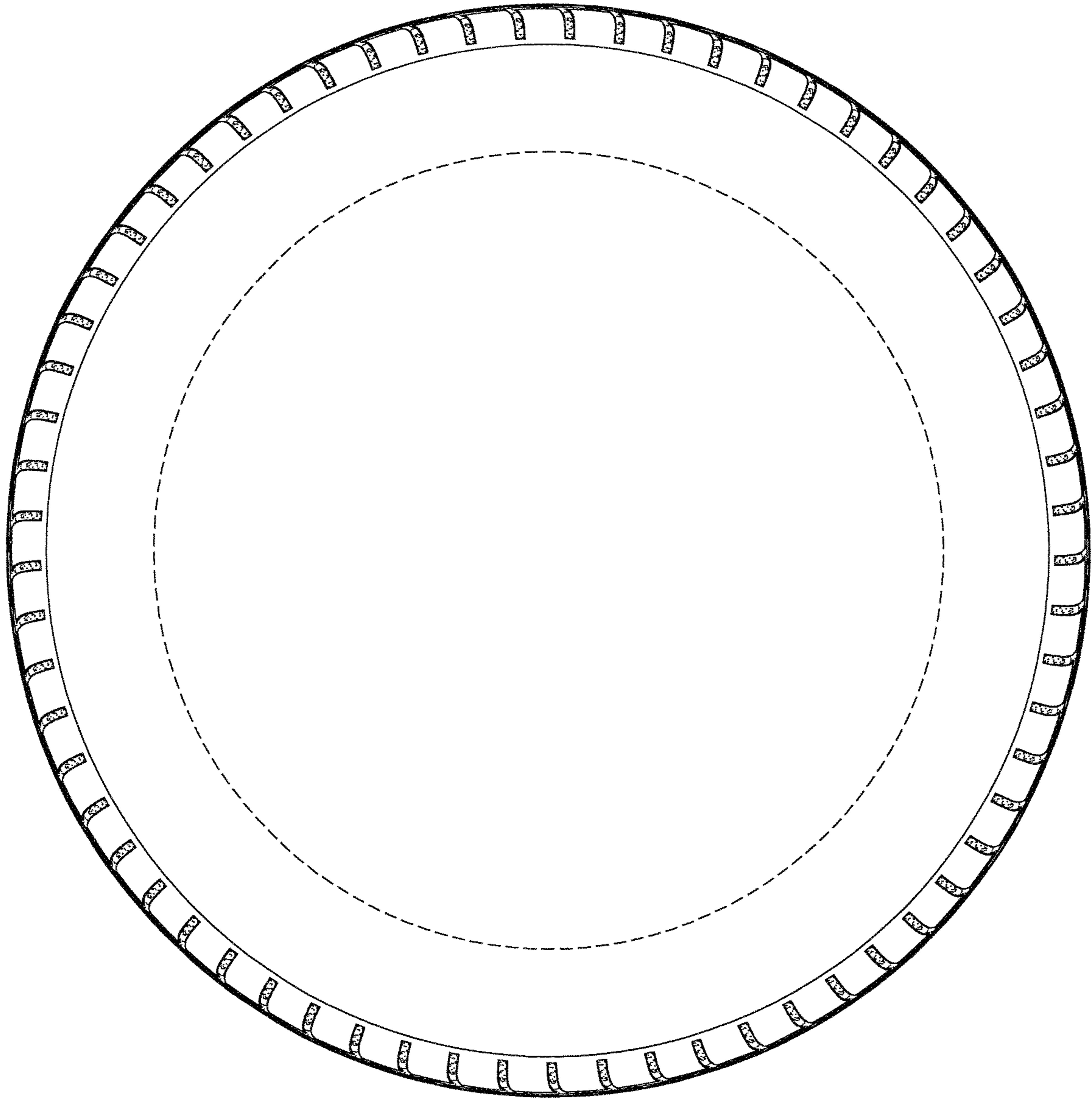

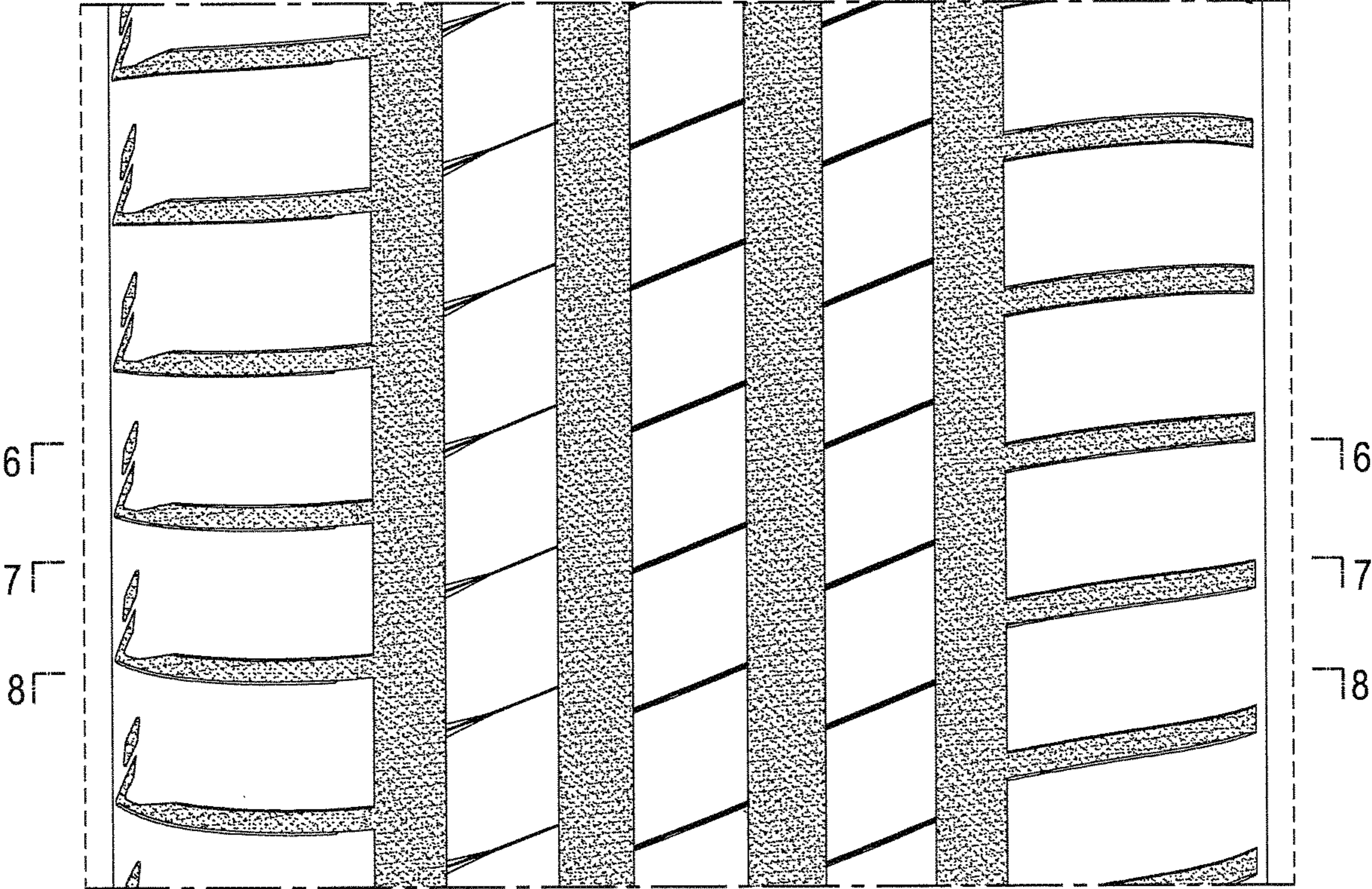

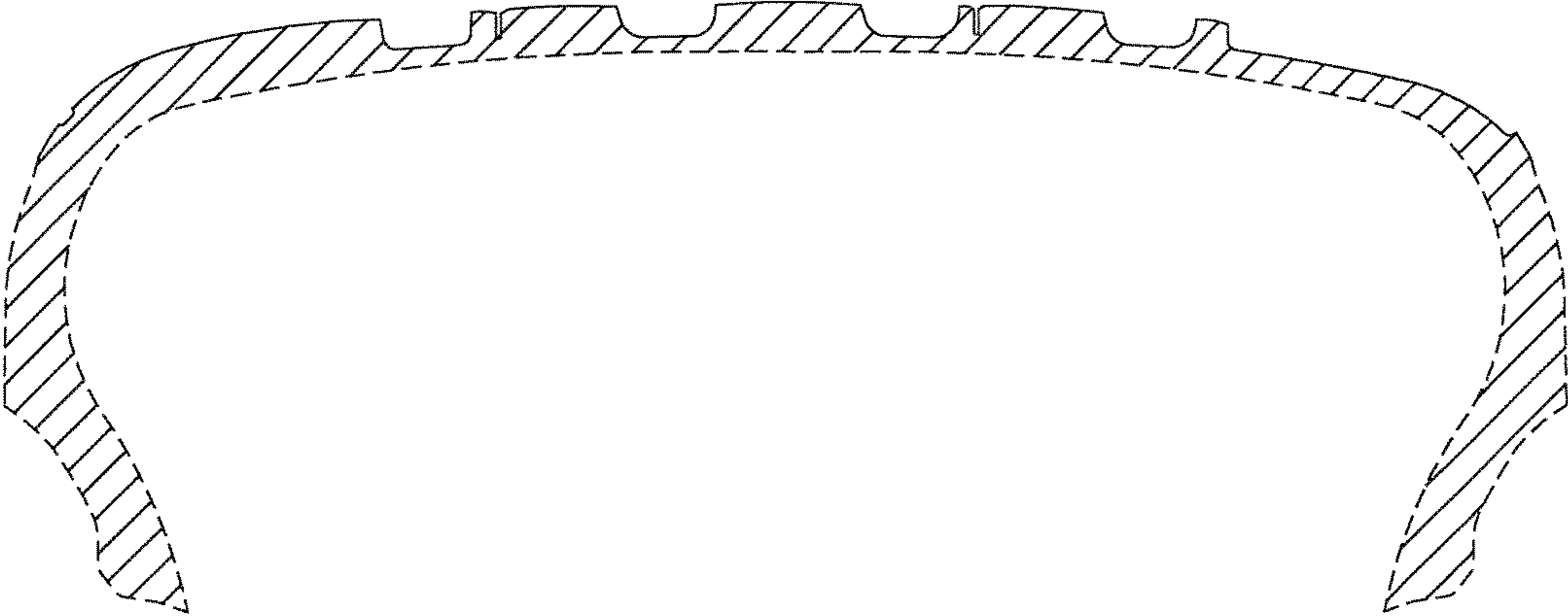

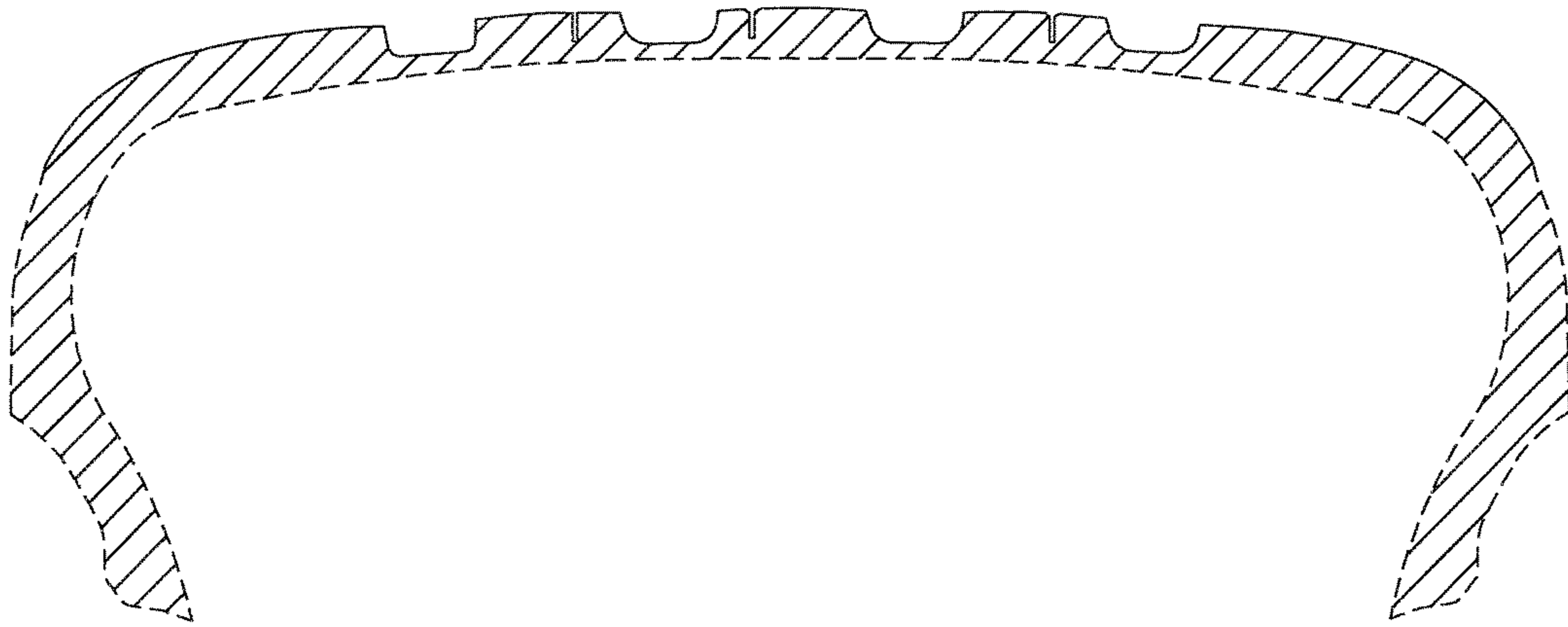

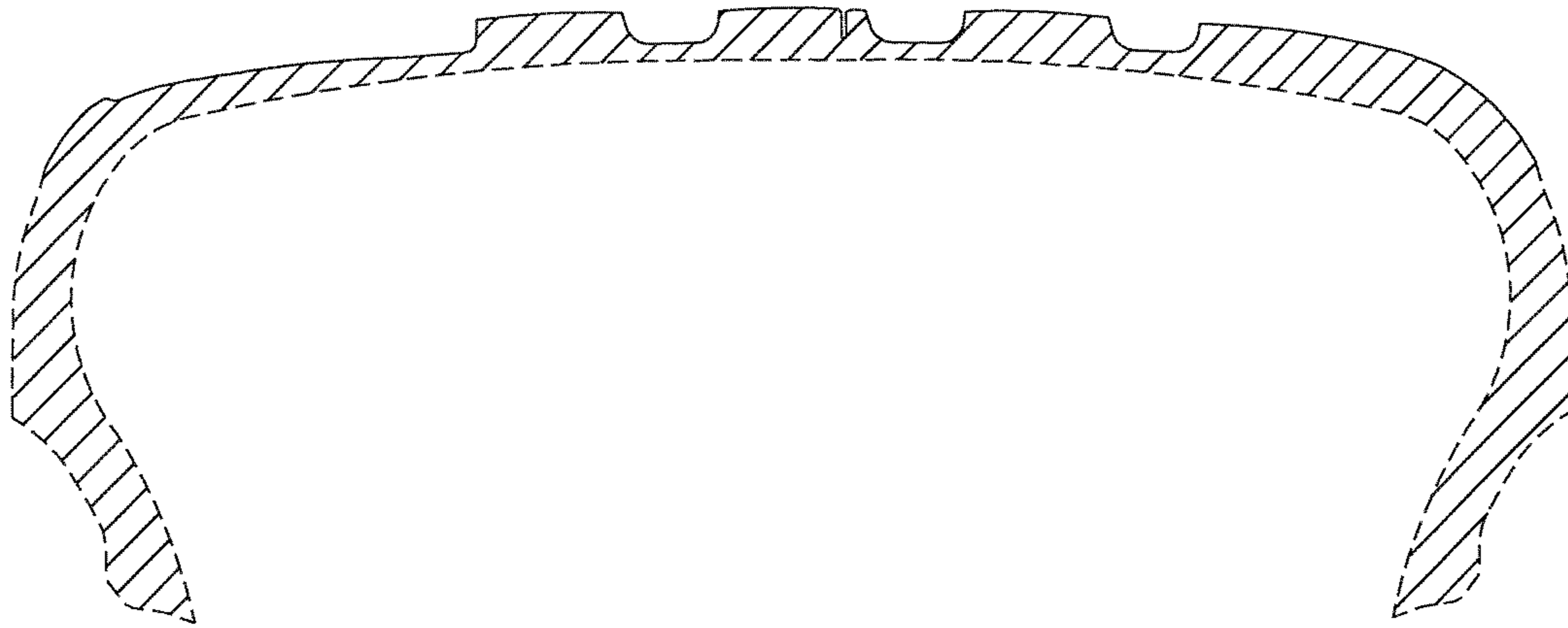
