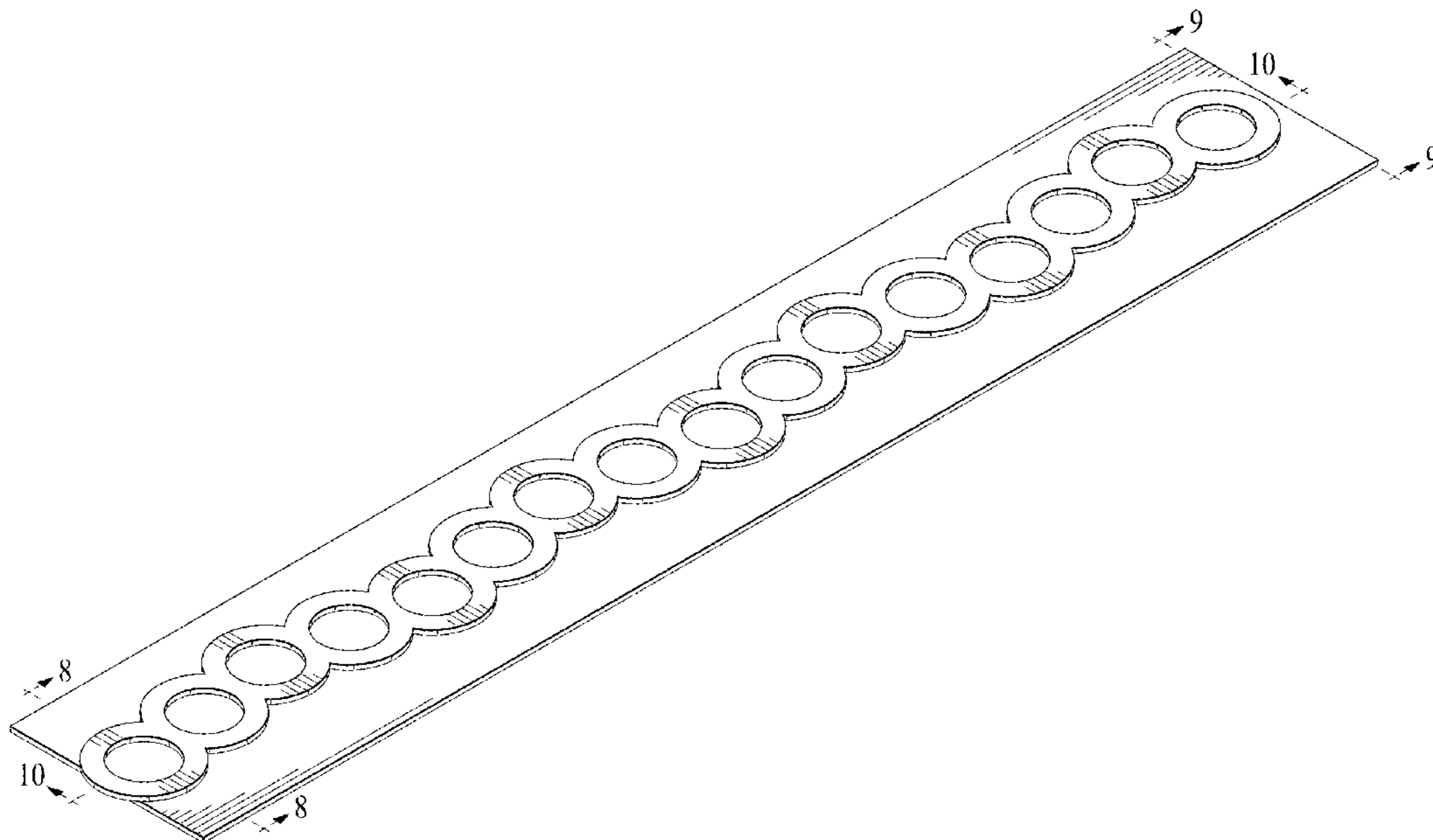
(57) **CLAIM**

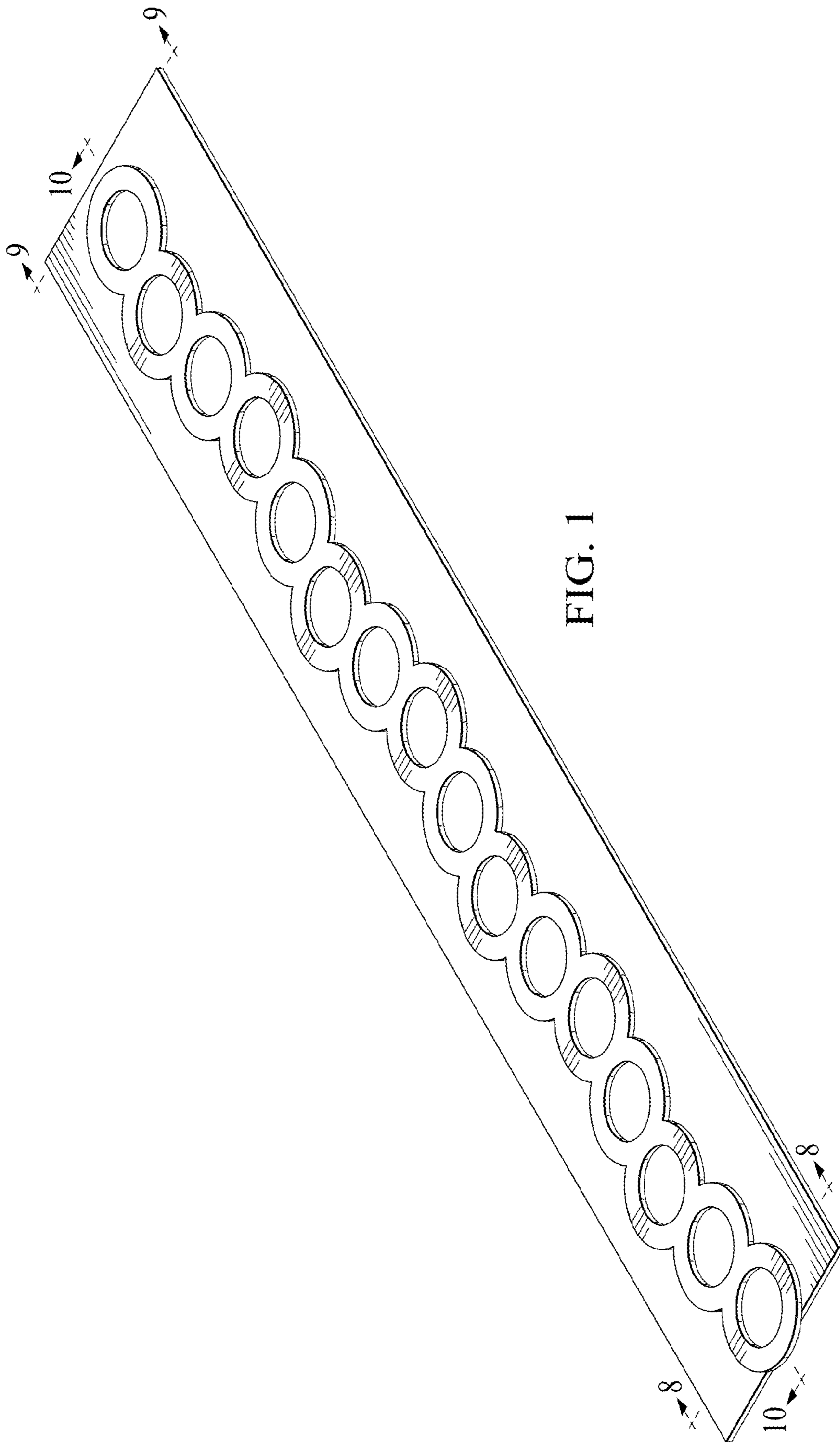
The ornamental design for a staggered hollowed disk antenna sheet, as shown.

DESCRIPTION

FIG. 1 is a top right perspective view of a staggered hollow disk antenna sheet showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a front elevation view thereof; FIG. 7 is a rear elevation view thereof; FIG. 8 is a cross sectional view thereof along line 8-8 in FIG. 1; FIG. 9 is a cross sectional view thereof along line 9-9 in FIG. 1; and, FIG. 10 is a cross sectional view thereof along line 10-10 in FIG. 1.

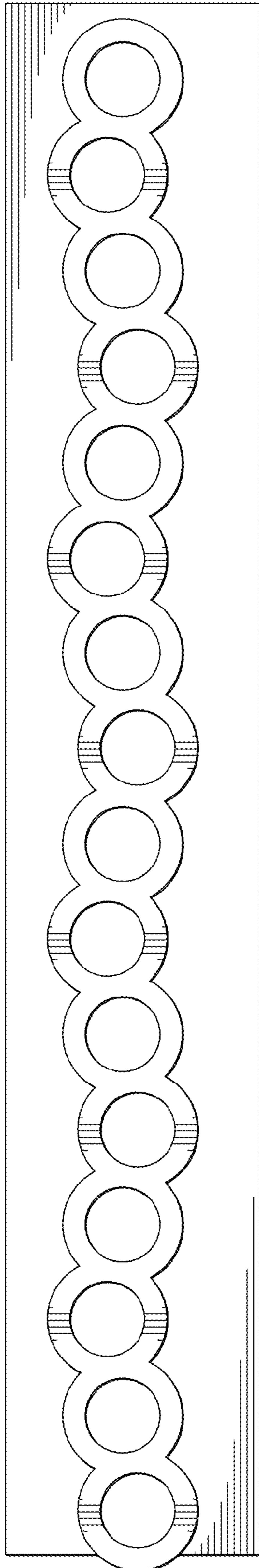

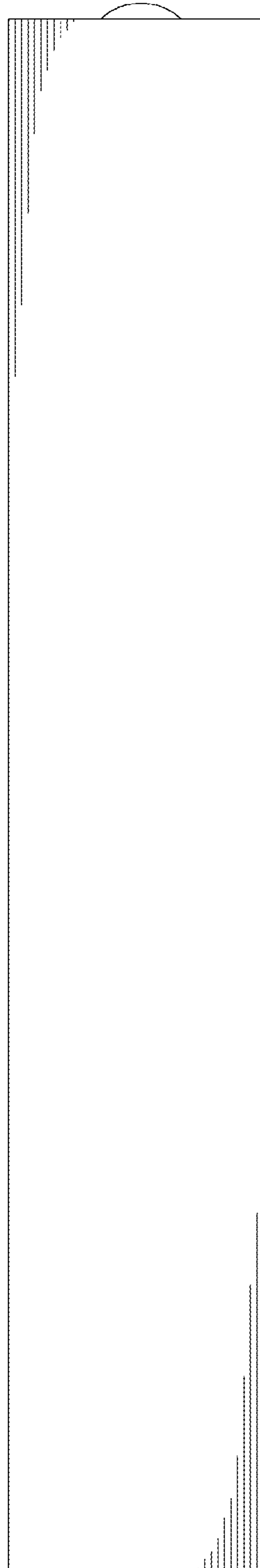

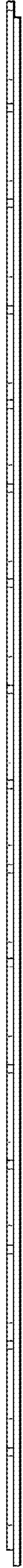

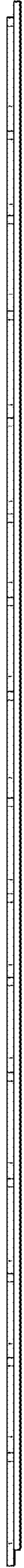
