The ornamental design for an electronic speaker assembly, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an electronic speaker assembly, illustrating our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

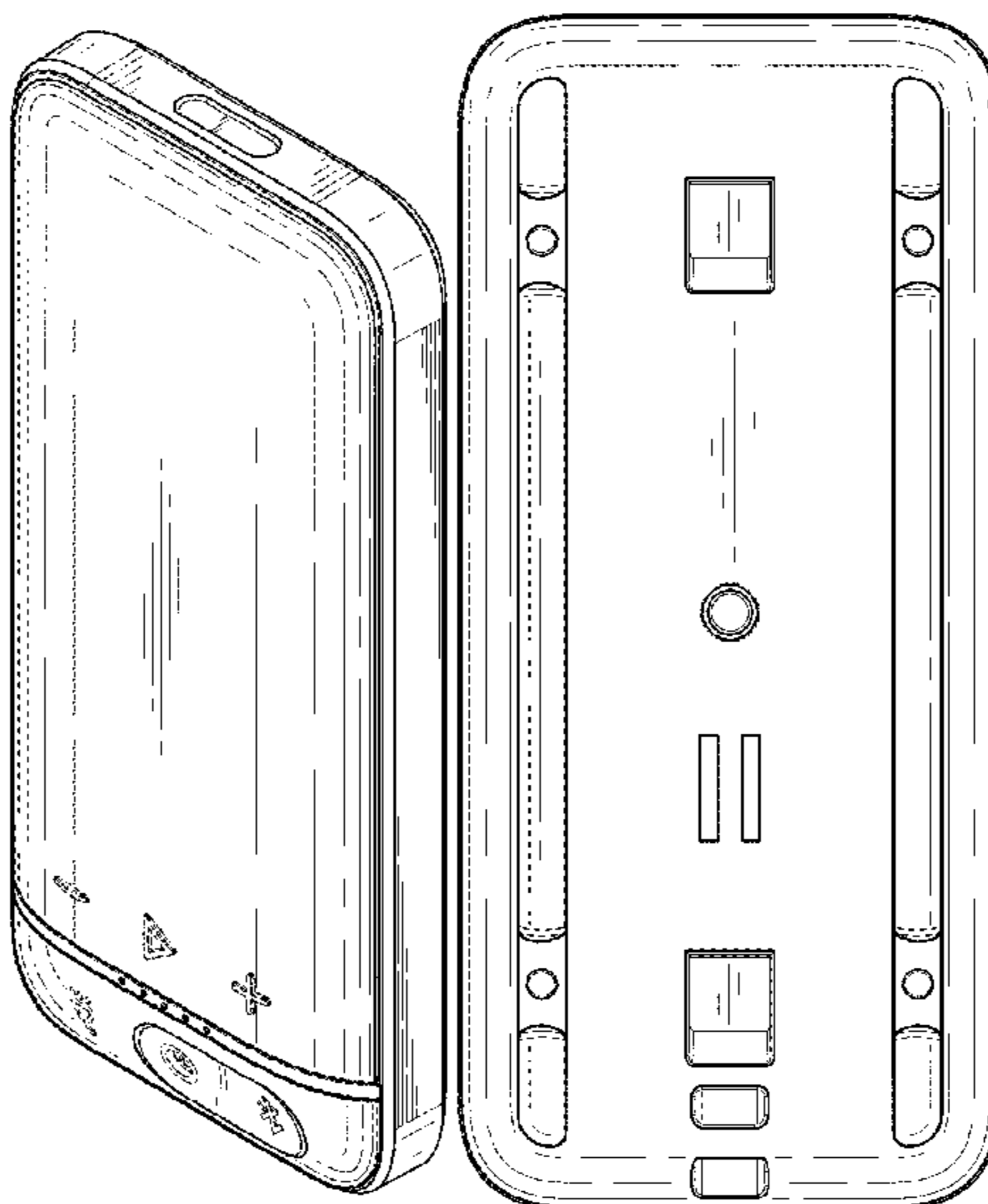
In the drawing, the claimed design is defined by the shaded surfaces; the broken lines depict unclaimed environment that forms no part of the claimed design.

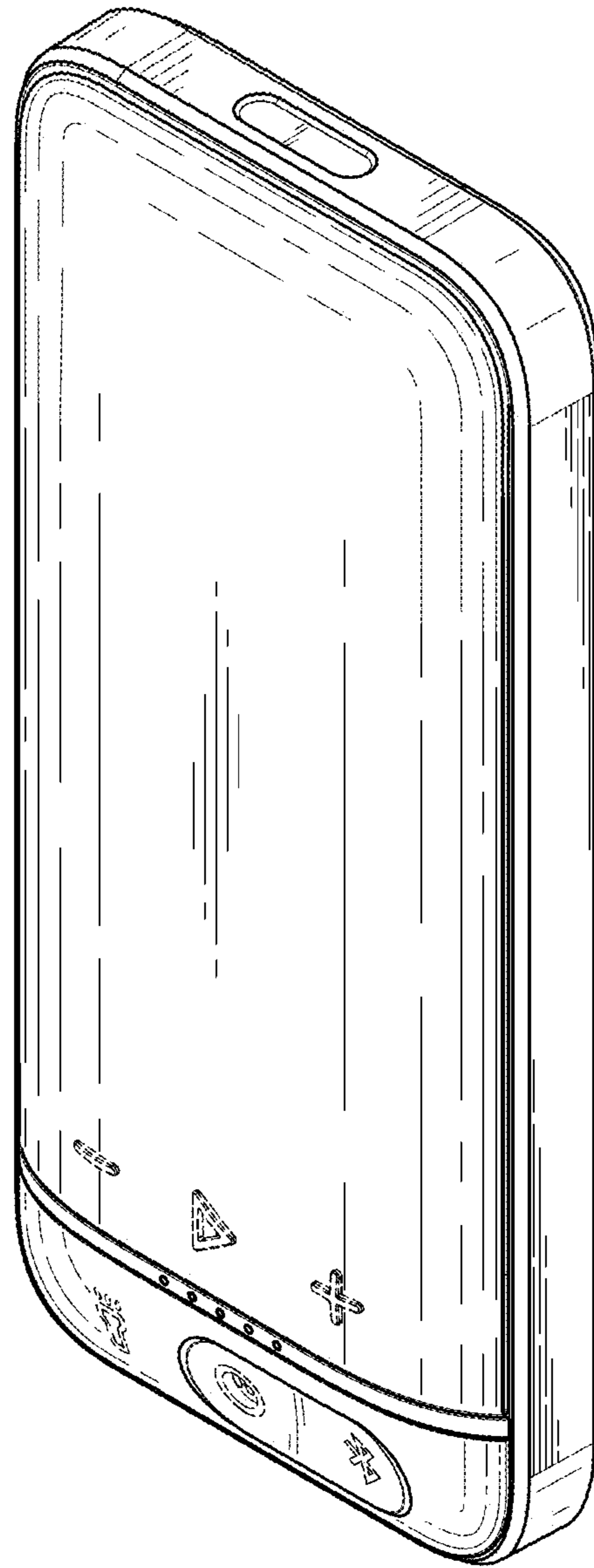

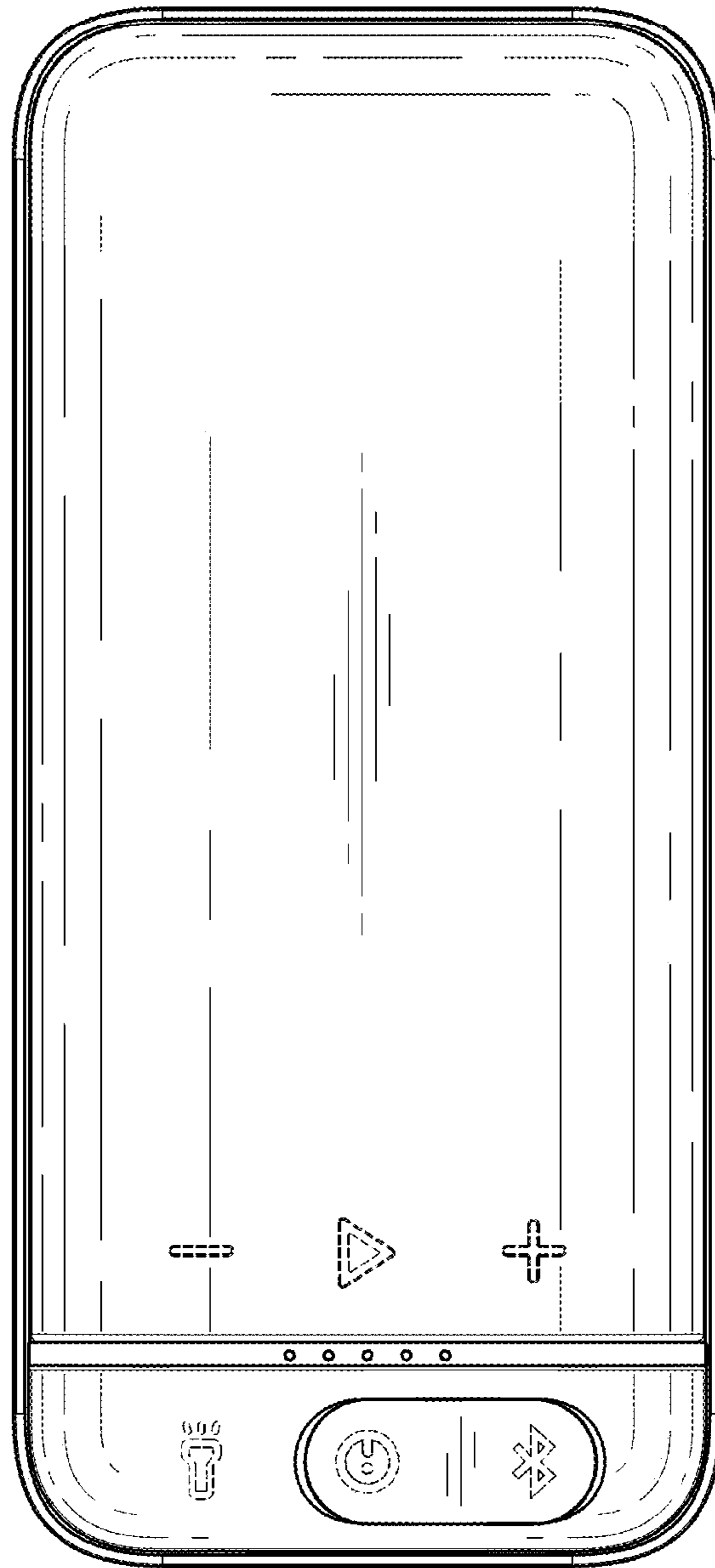

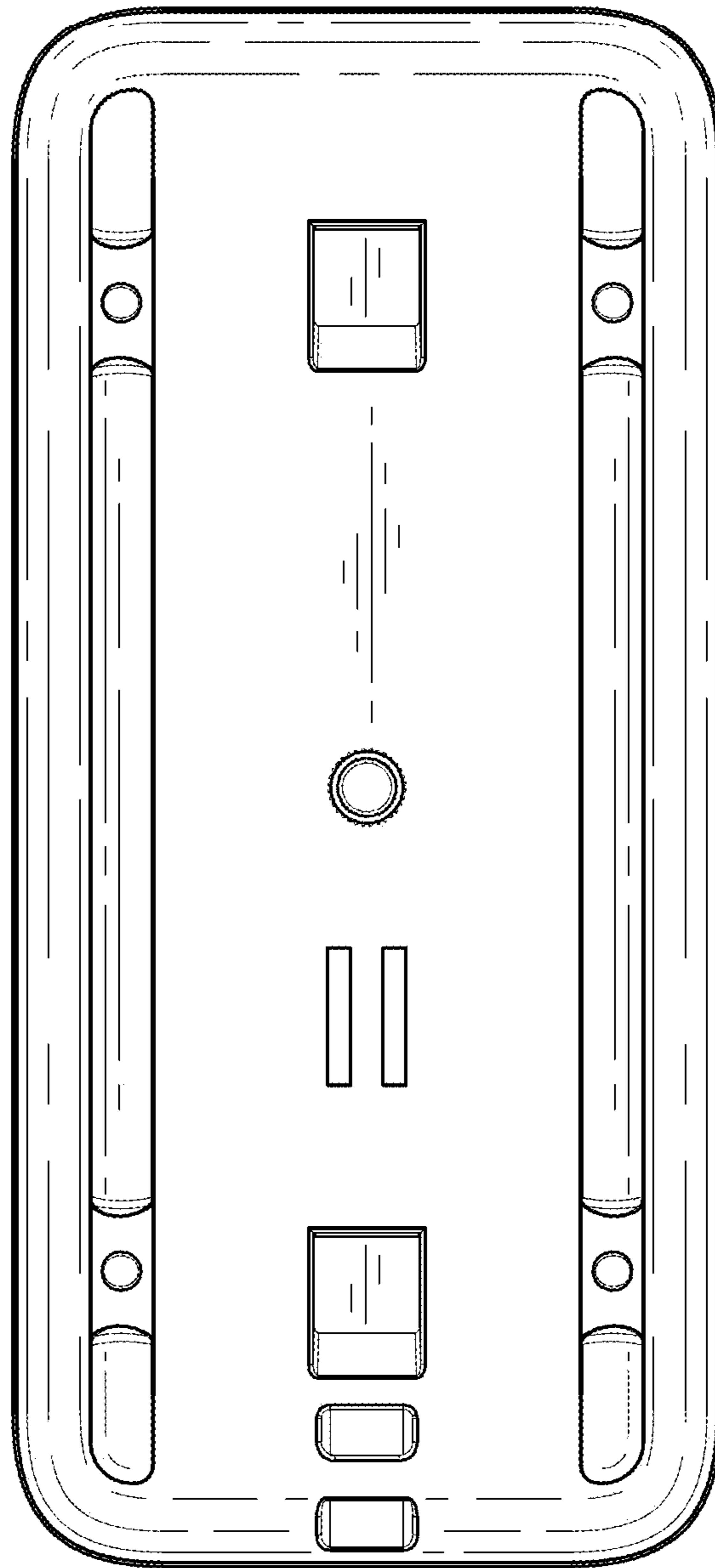

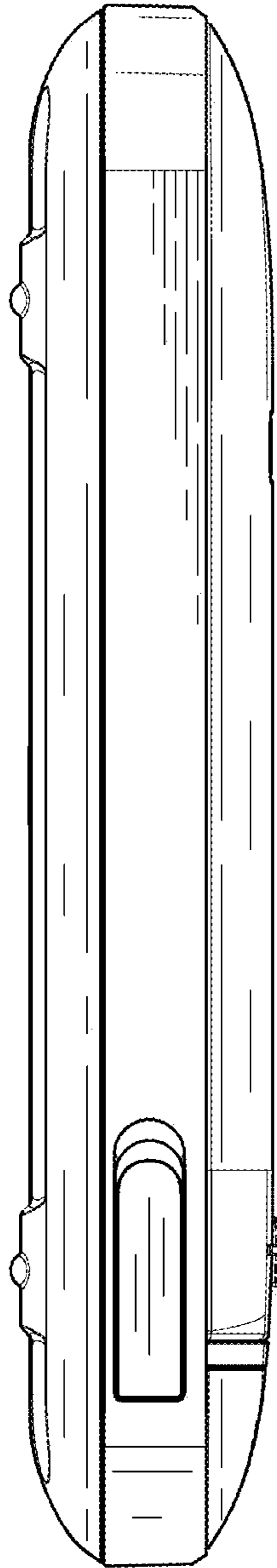

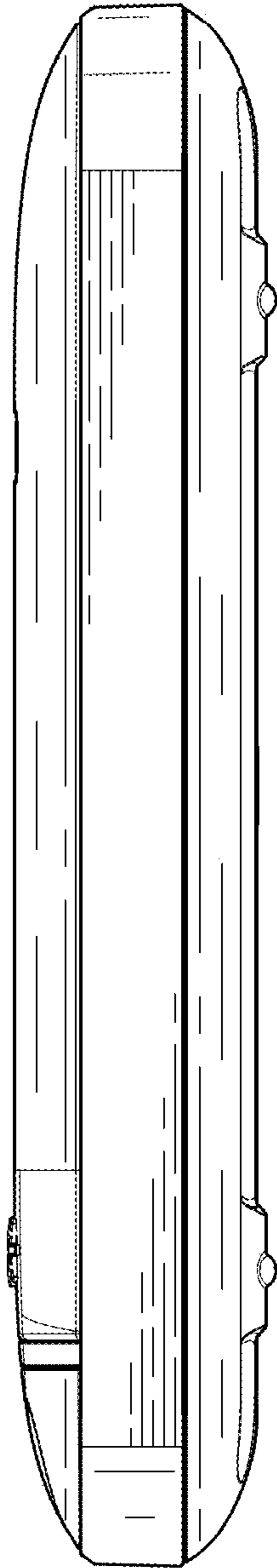

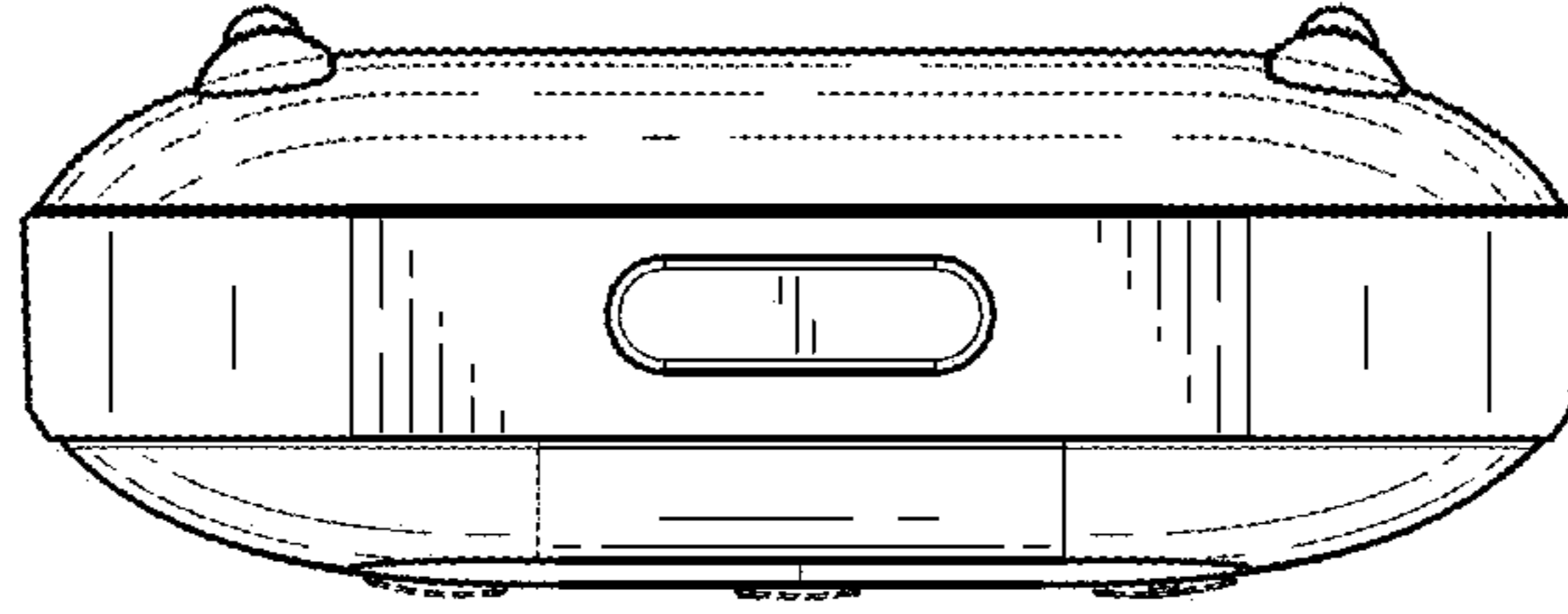

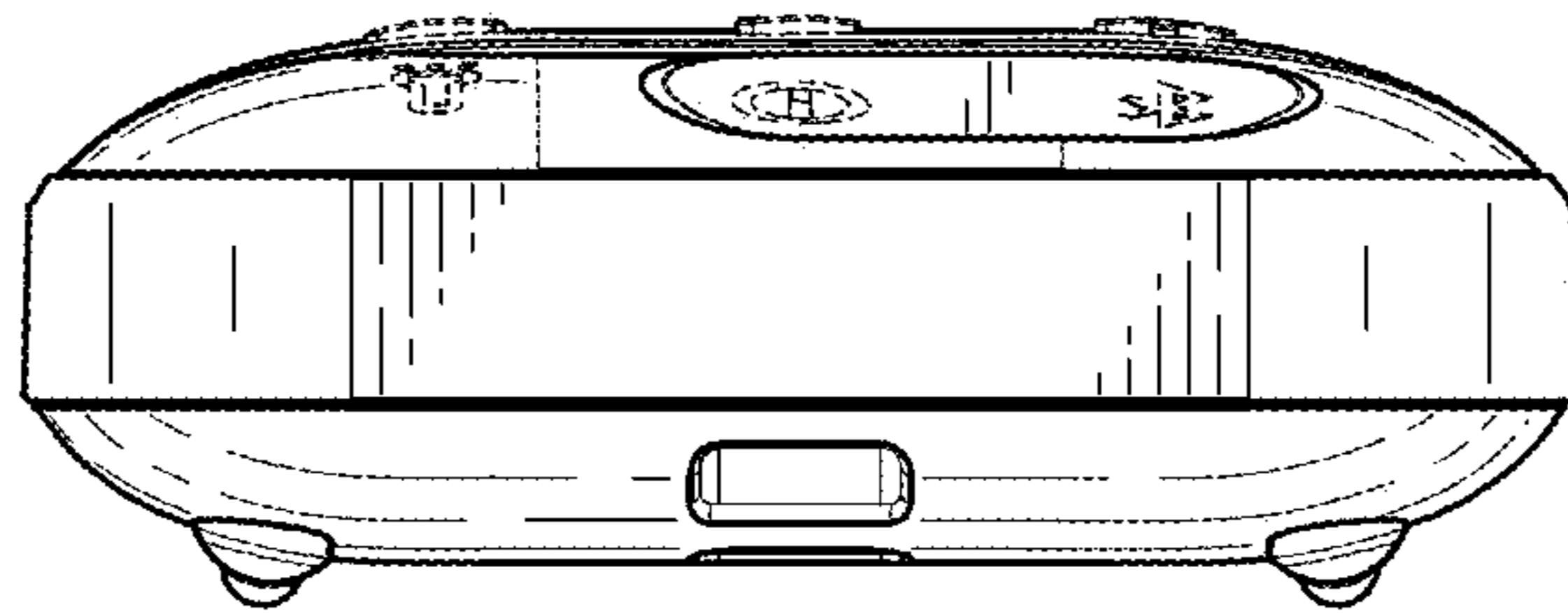
