(57) **CLAIM**

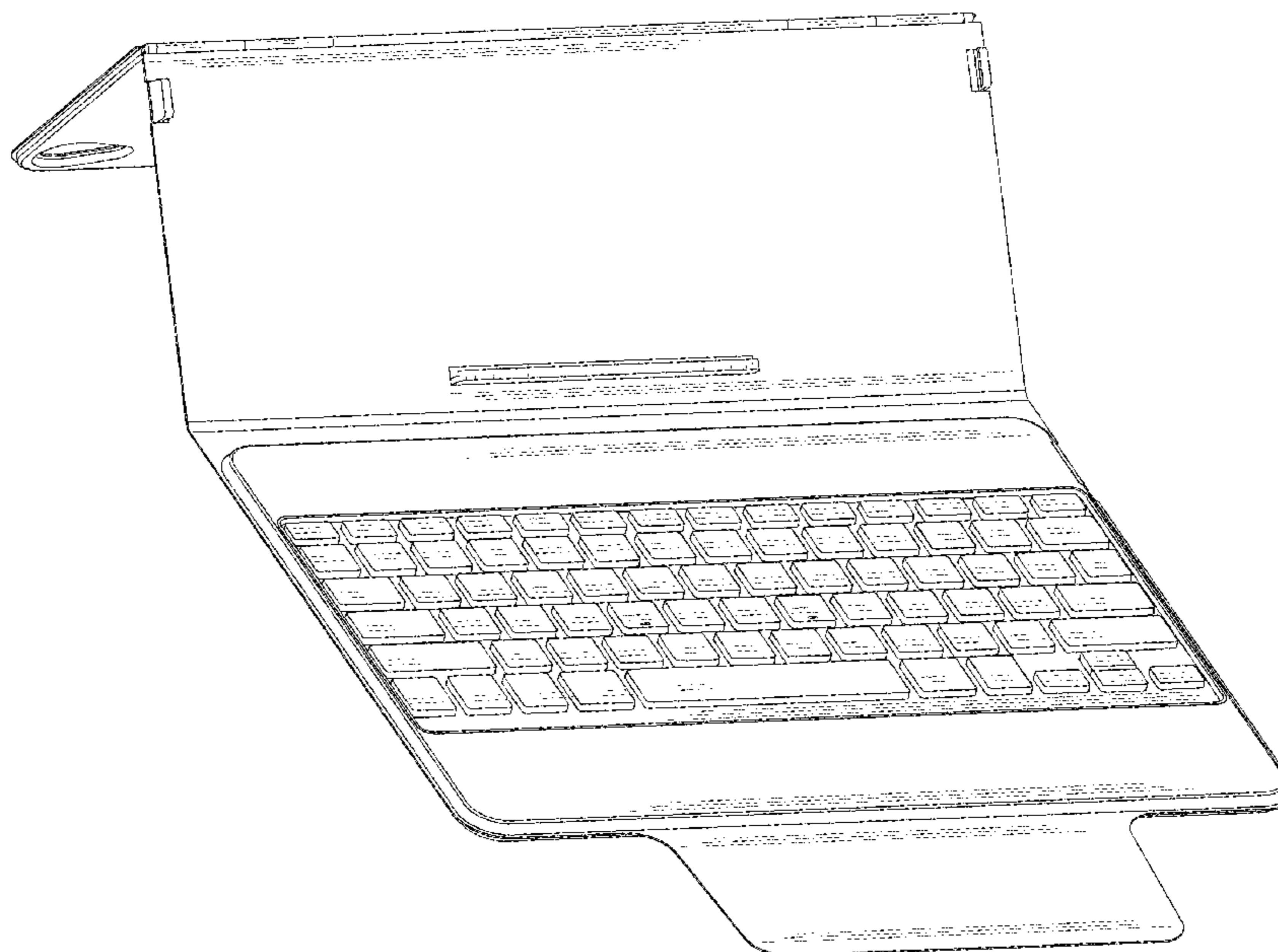
I claim the ornamental design for a tablet keyboard case, as shown and described.

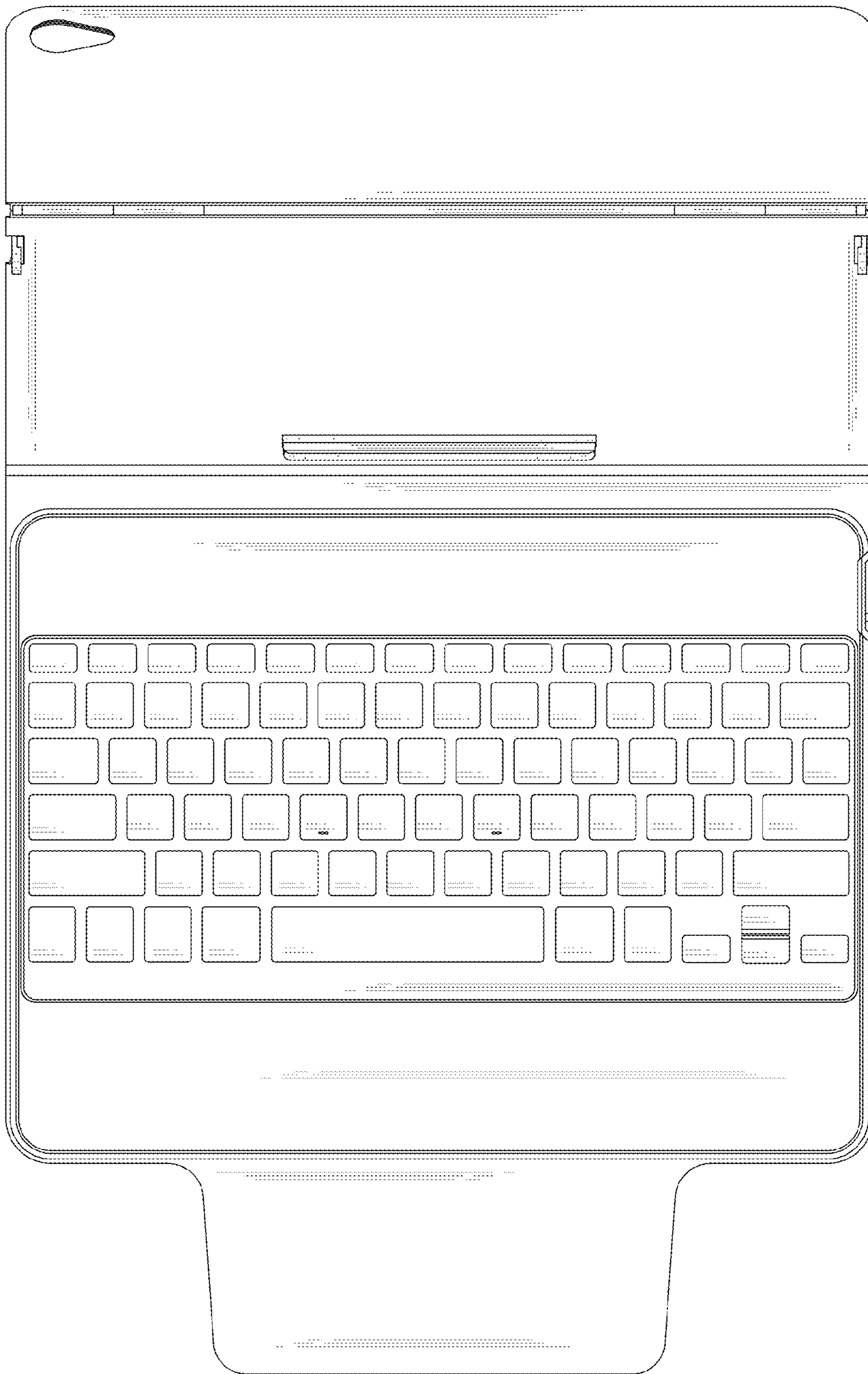

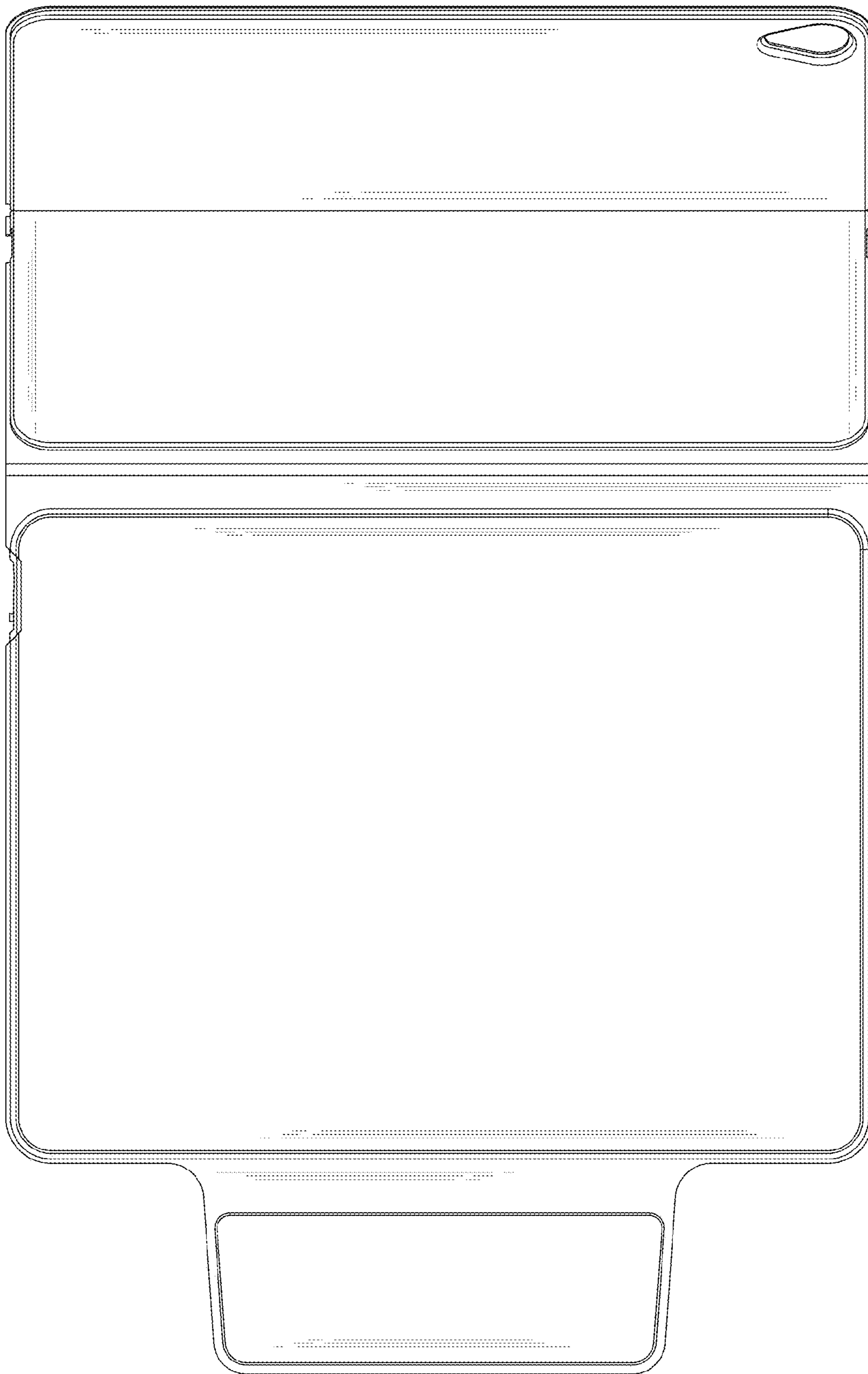

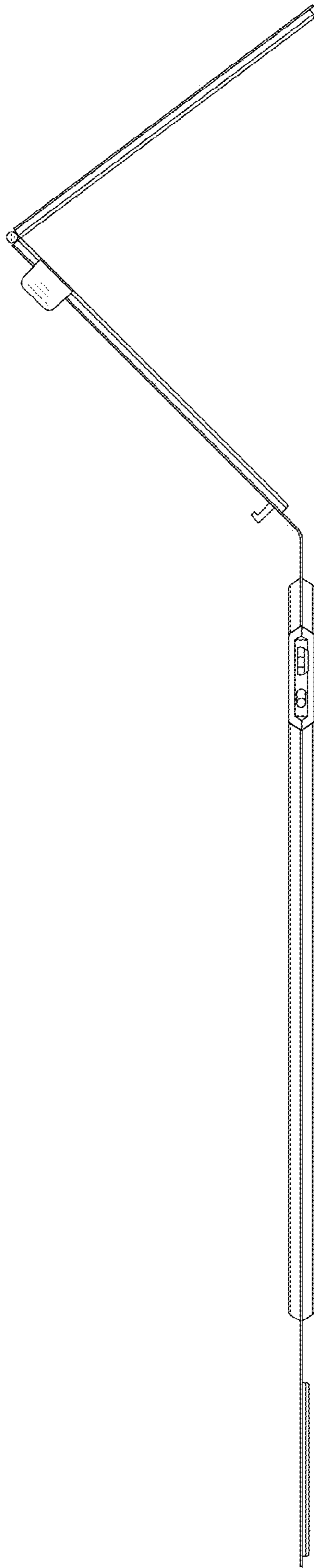

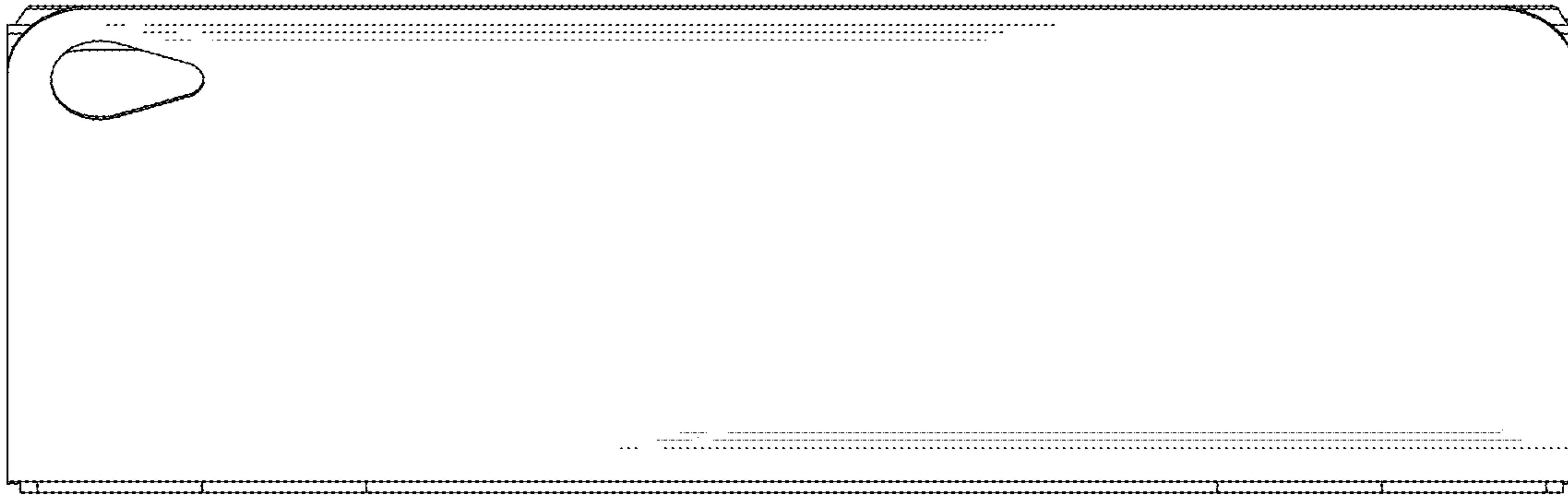

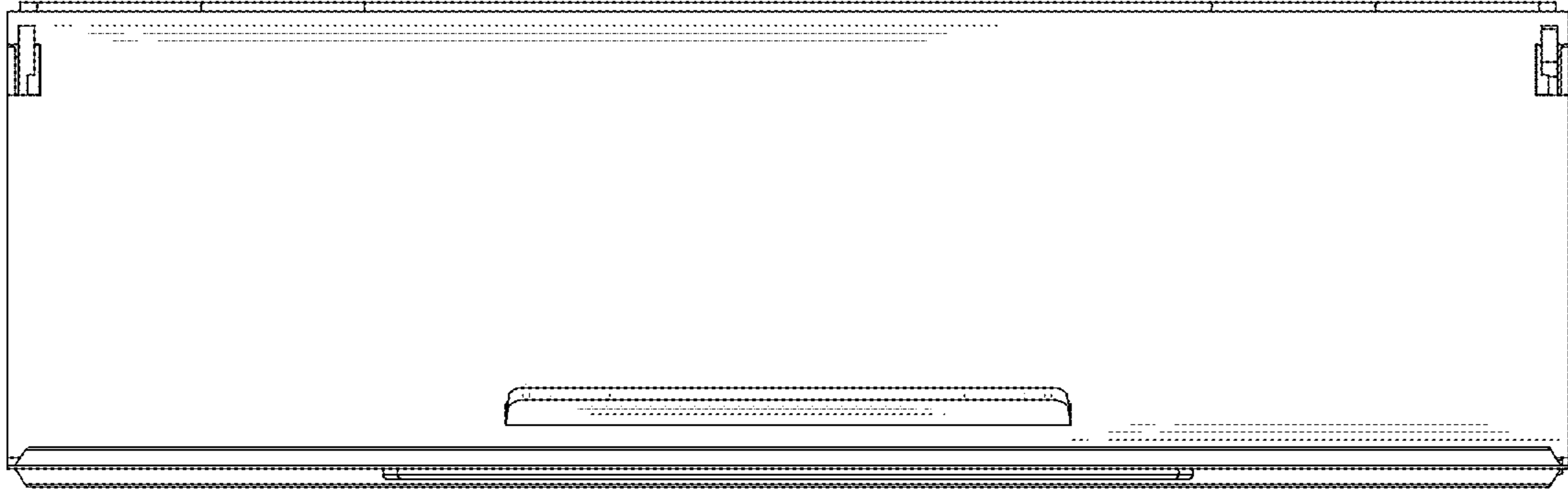

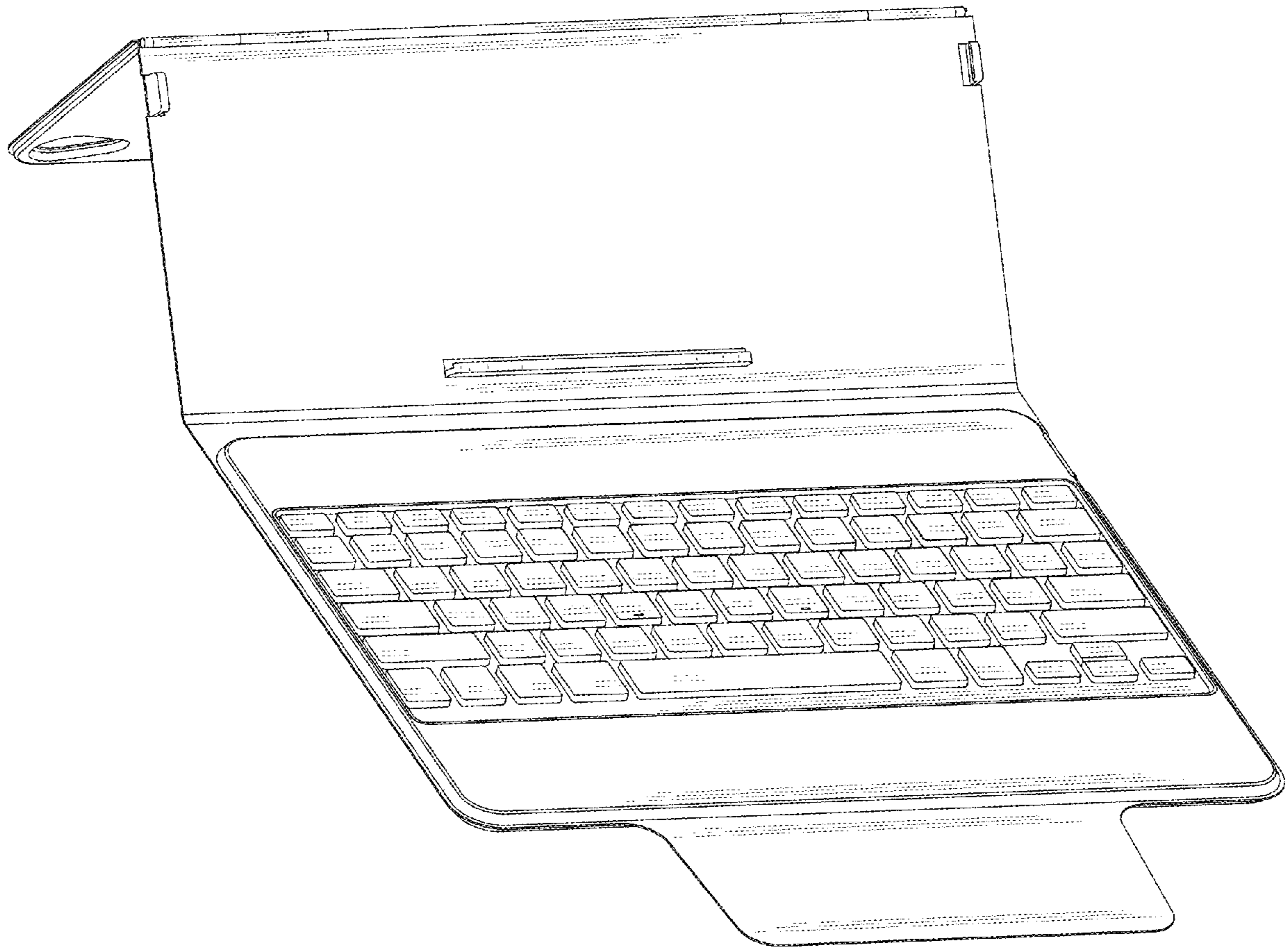

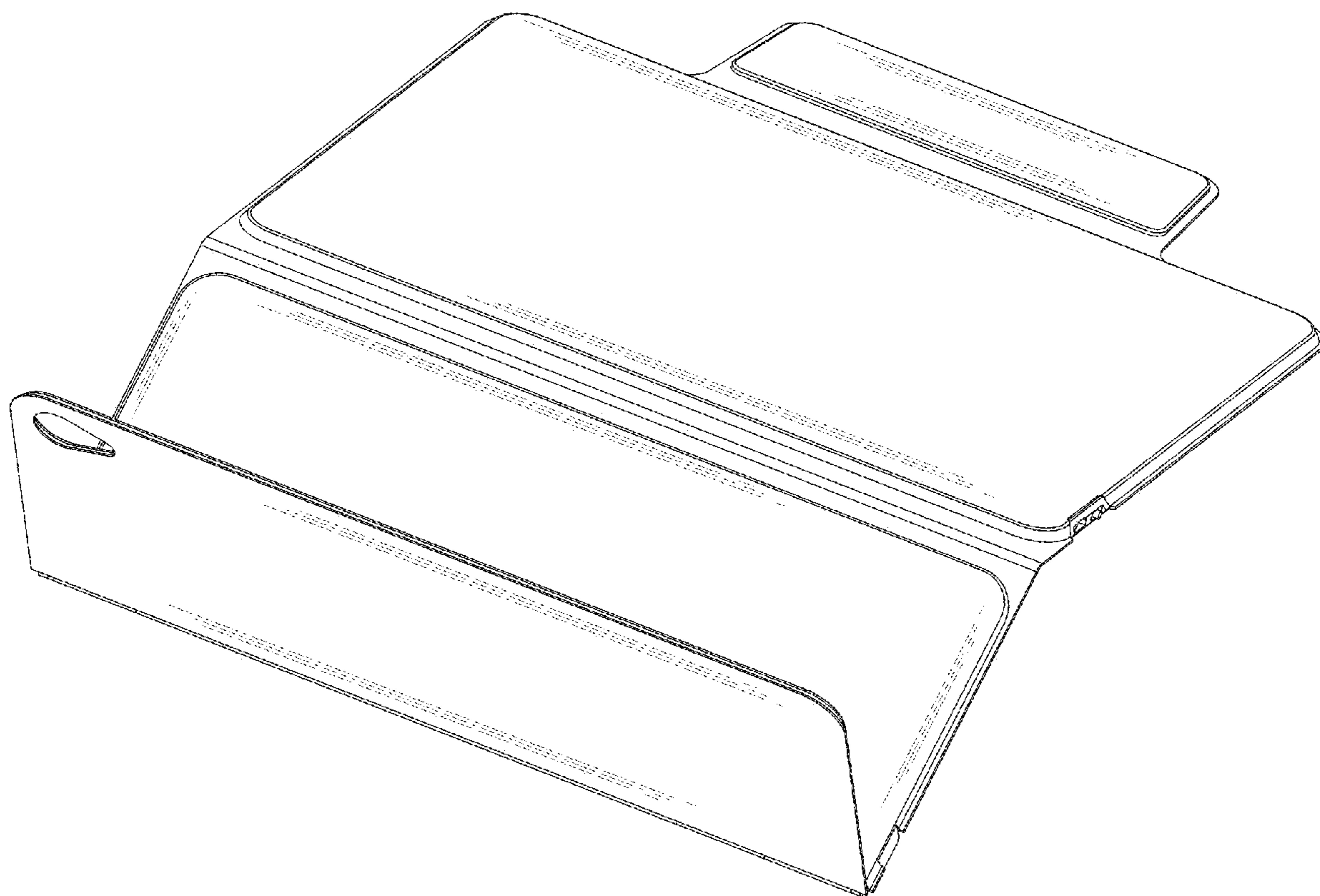
