**DESCRIPTION**

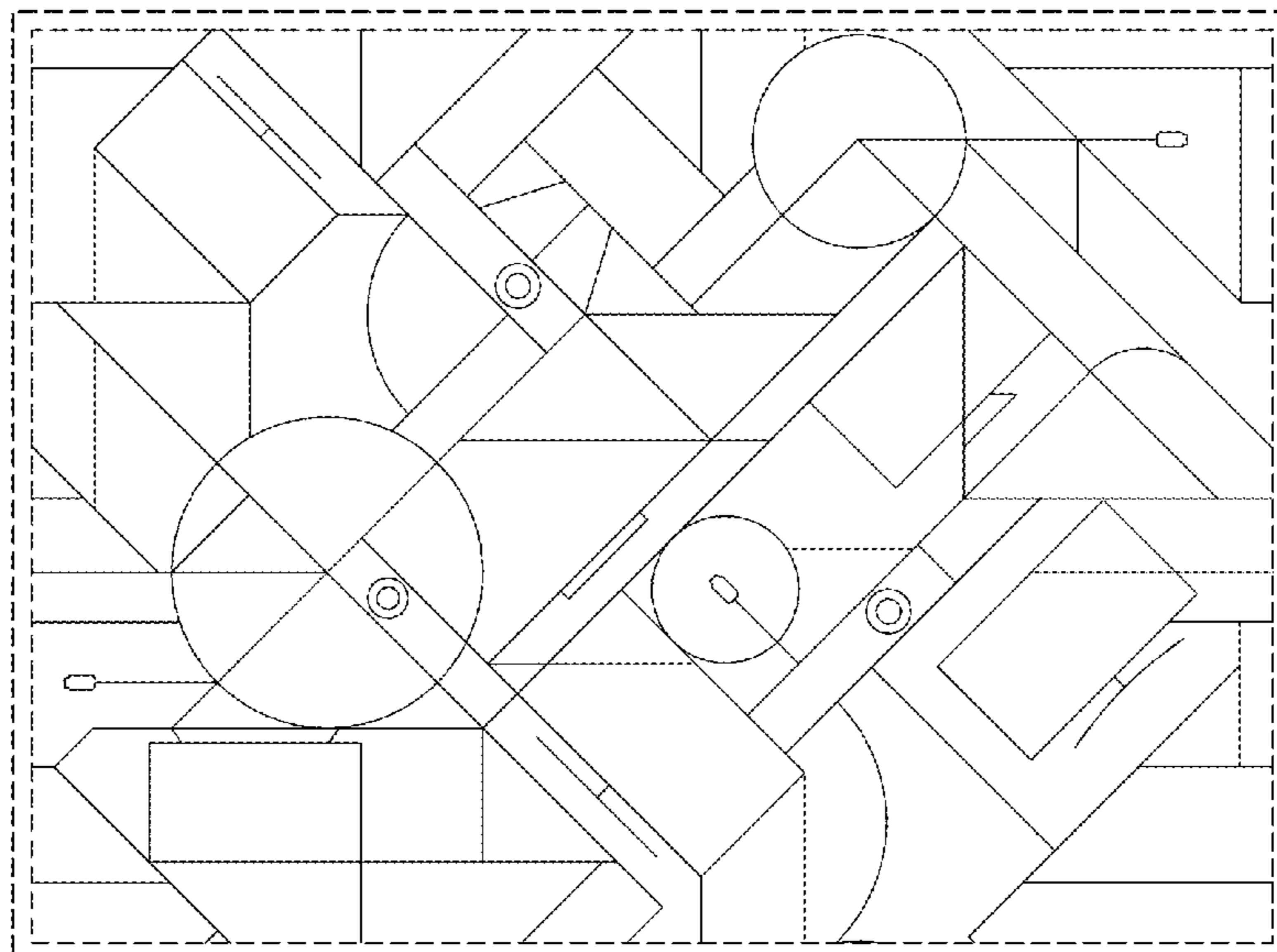

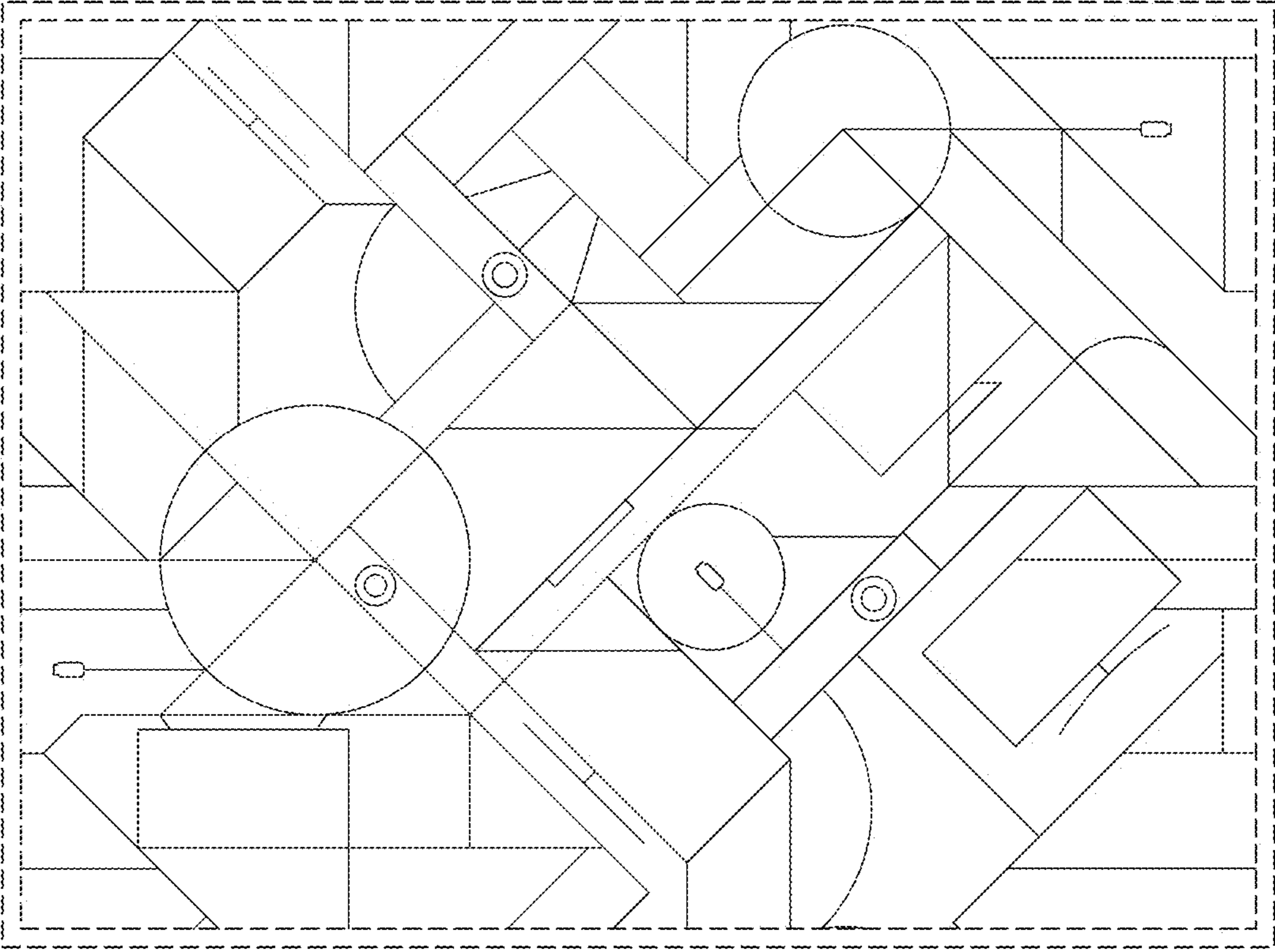
