(57) **CLAIM**

The ornamental design for a display screen with an animated graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display screen with an animated graphical user interface showing a first image of our new design;

FIG. 2 is a second image thereof;

FIG. 3 is a third image thereof;

FIG. 4 is a fourth image thereof;

FIG. 7 is a seventh image thereof;

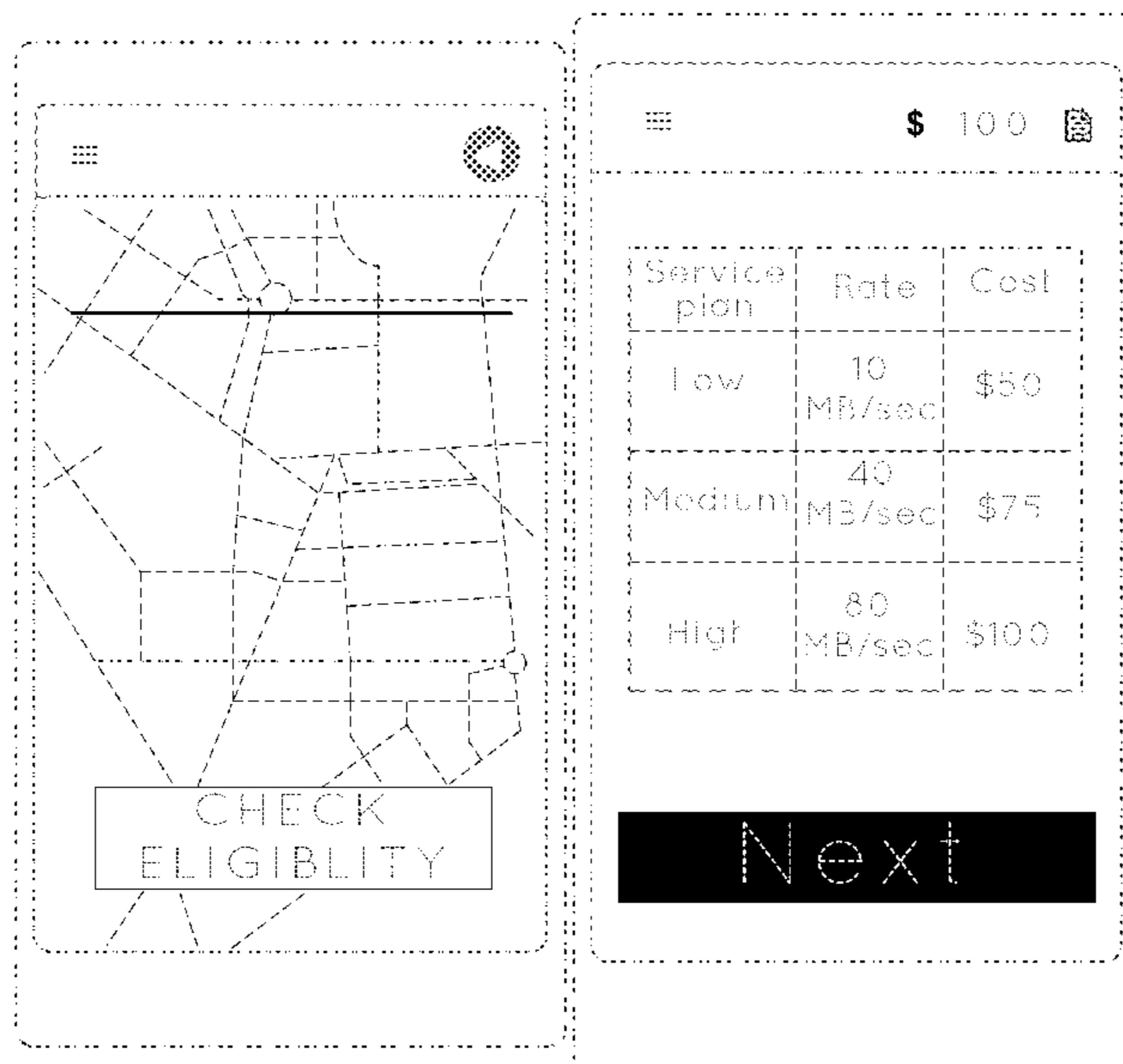
FIG. 8 is an eighth image thereof;

The remaining broken lines, showing portions of the display screen and portions of the graphical user interface, including the icon in the top right portion of FIG. 2 and the lettering in FIGS. 1-10, form no part of the claimed design. The appearance of the transitional image sequentially transitions between the images shown in FIGS. 1-10. The process or period in which one image transitions to another image forms no part of the claimed design.

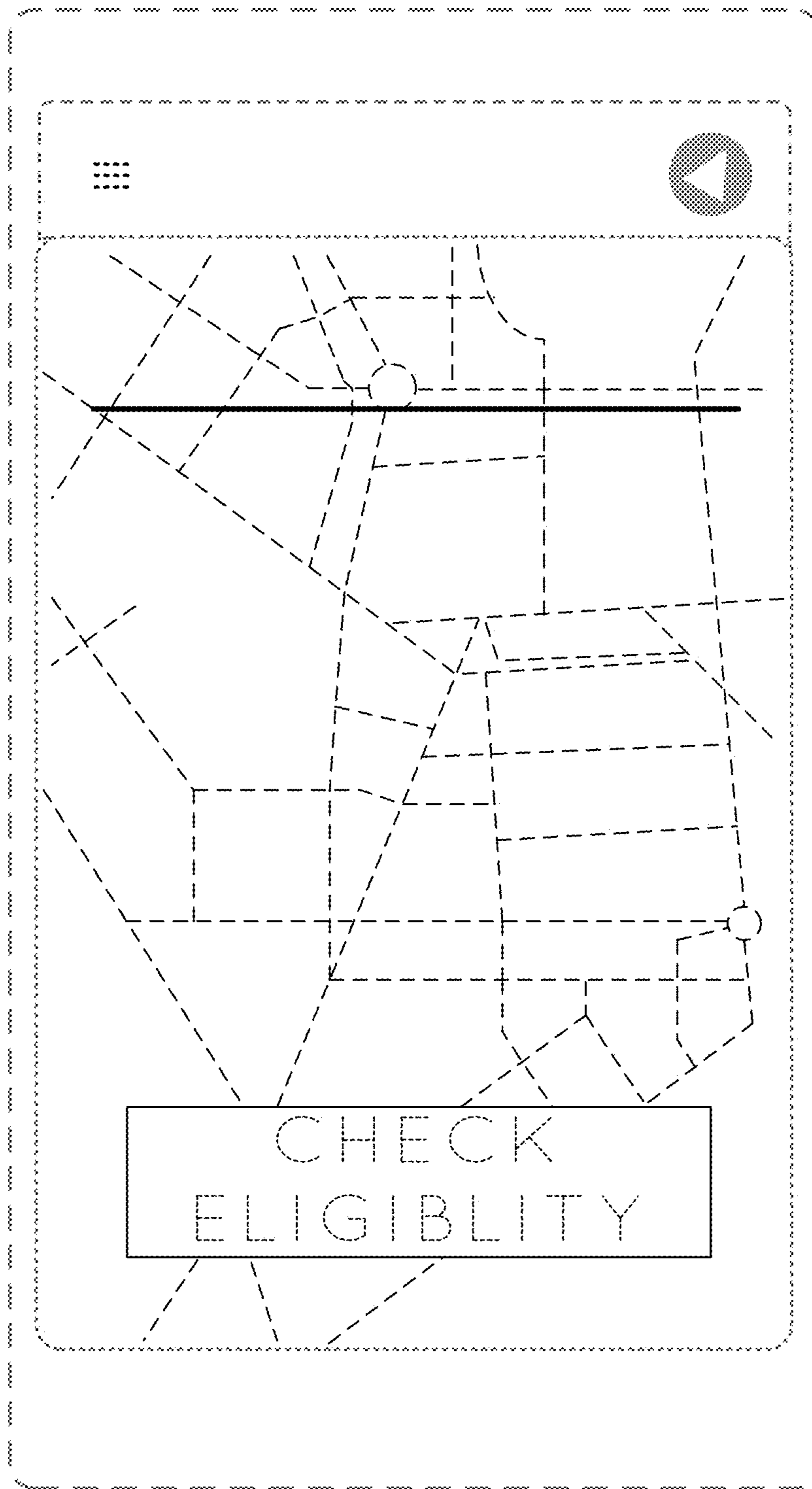
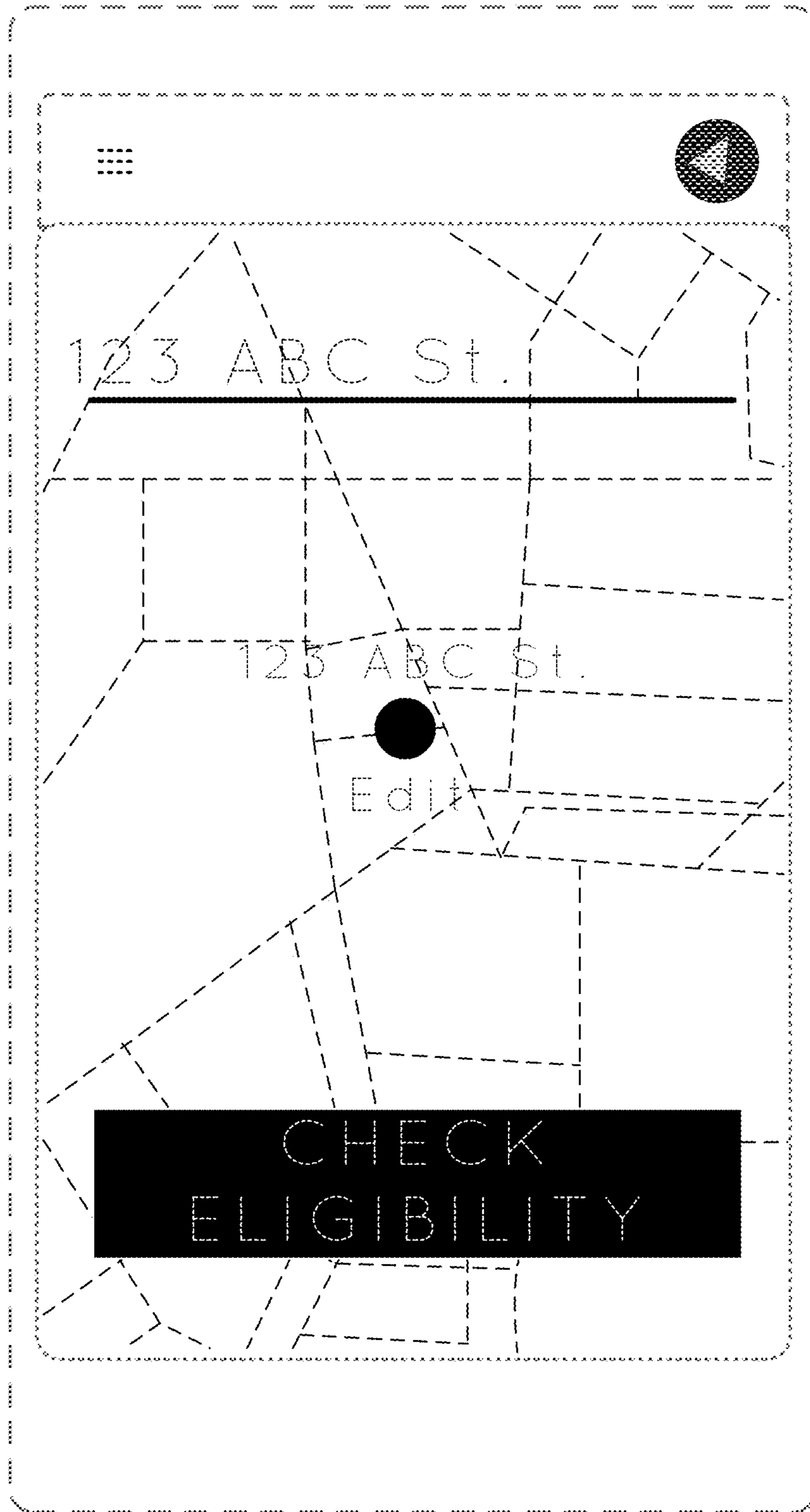

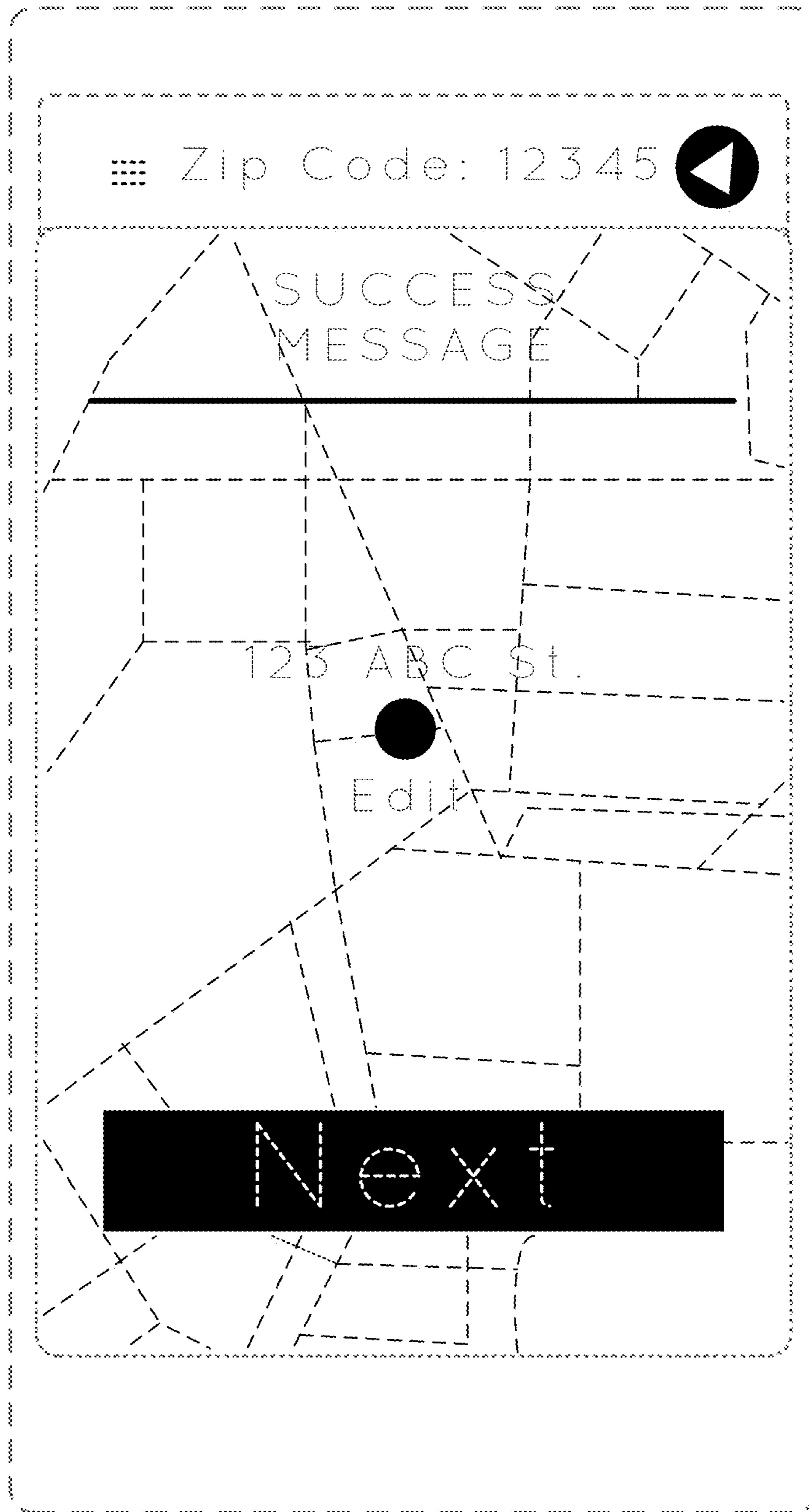
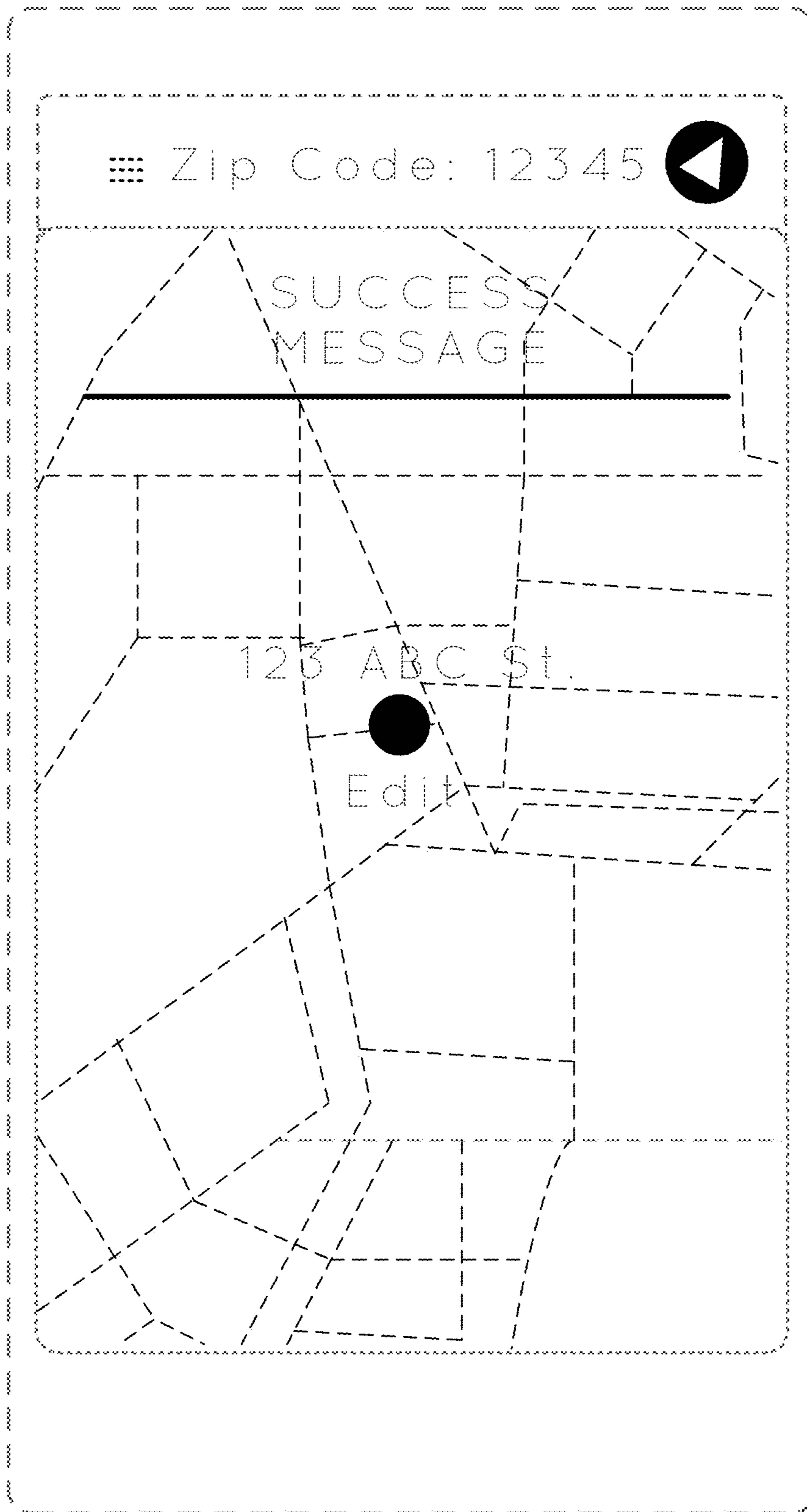




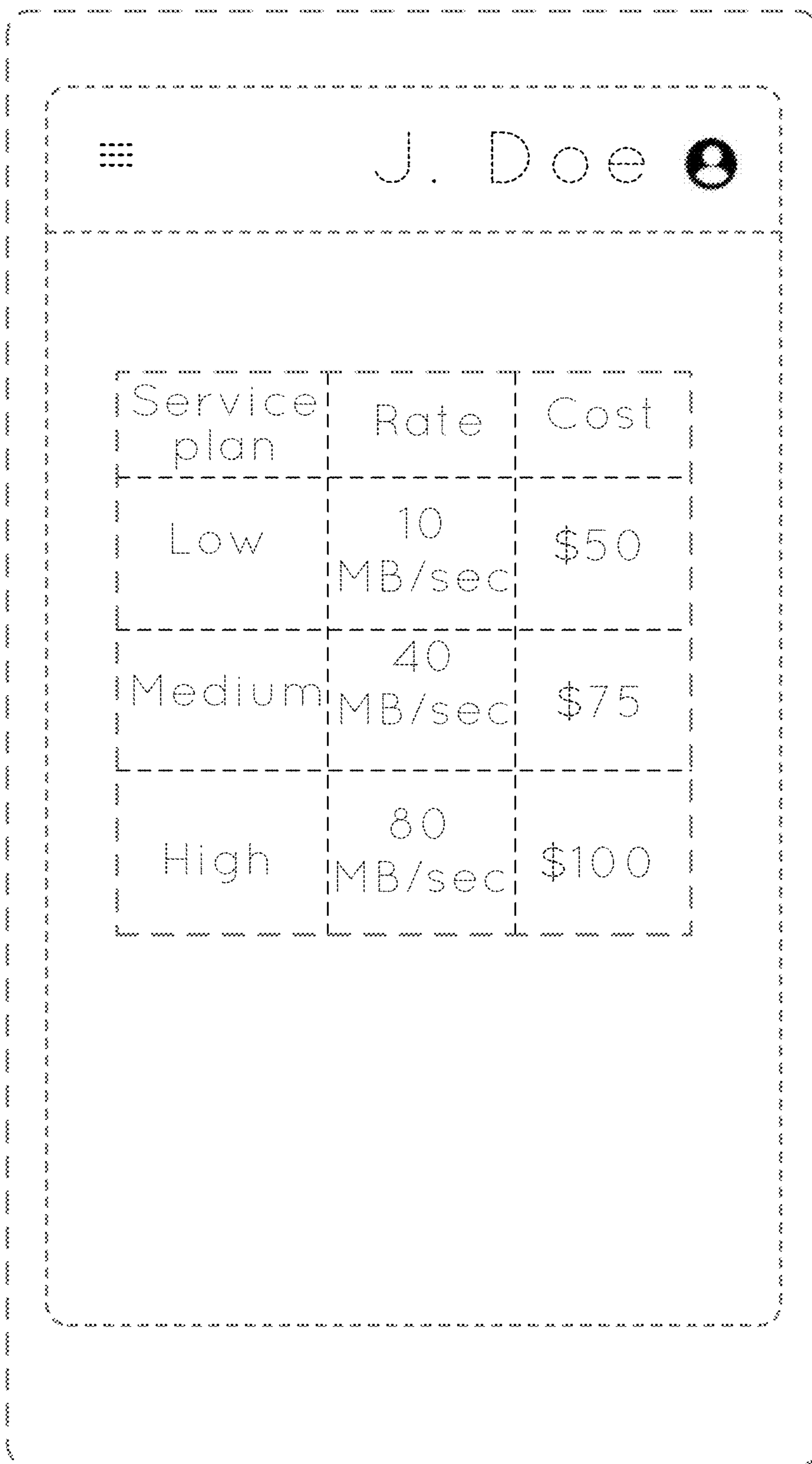

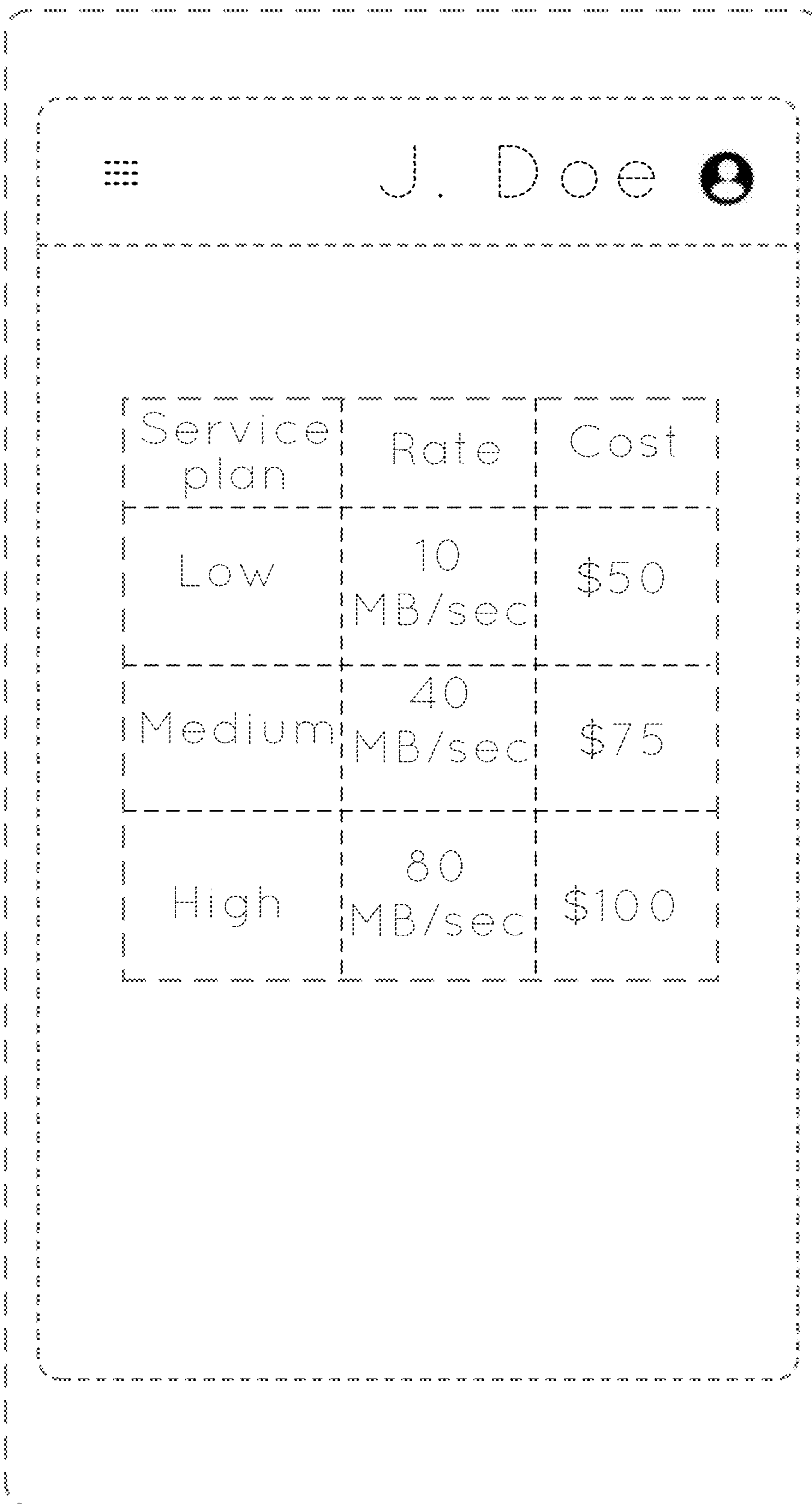
