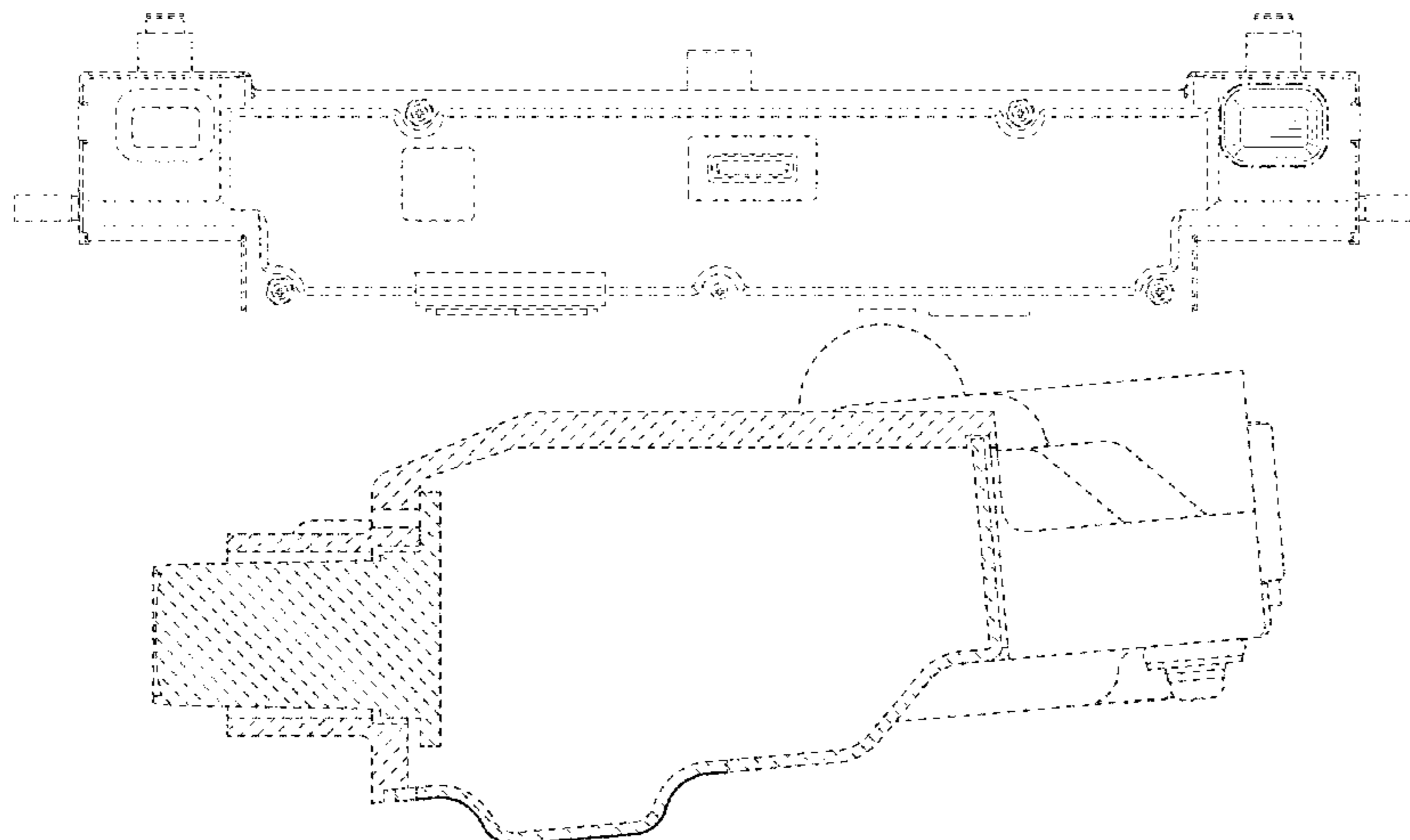

(57) **CLAIM**

The ornamental design for a vehicle-mounted stereo camera, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear, bottom and left side perspective view of a vehicle-mounted stereo camera according to the design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof; and,

FIG. 8 is an enlarged cross-sectional view taken in the direction of line 8-8 in FIG. 2.

The dash-dash broken lines shown in the drawings depict portions of the vehicle-mounted stereo camera that form no part of the claimed design. The dot-dash lines depict the boundary of the claim and form no part of the claimed design.

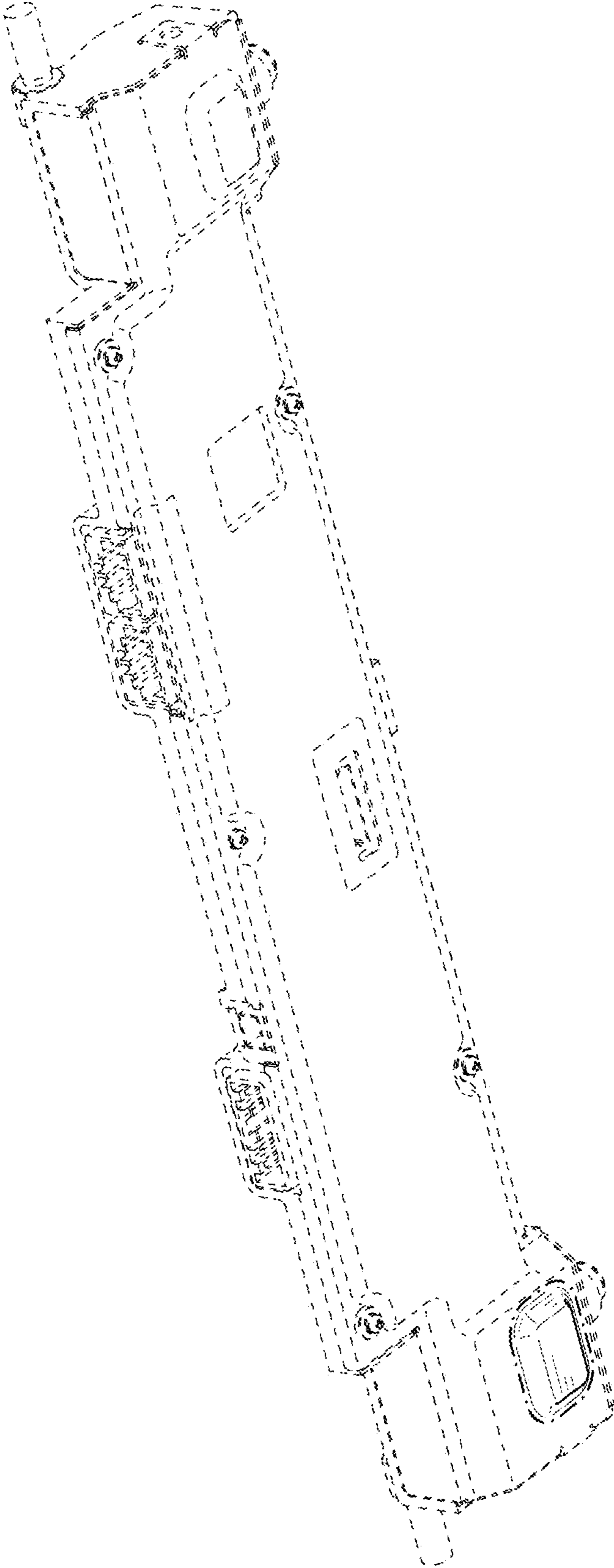
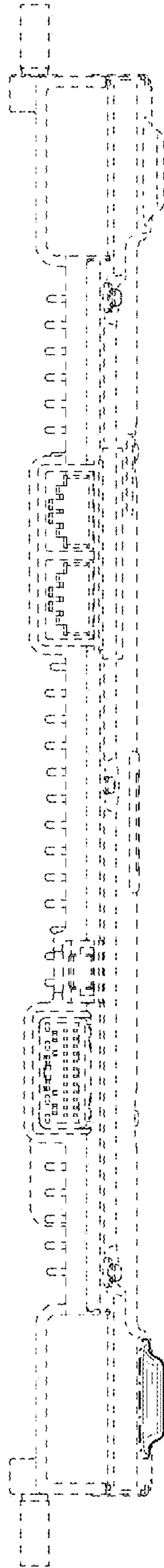
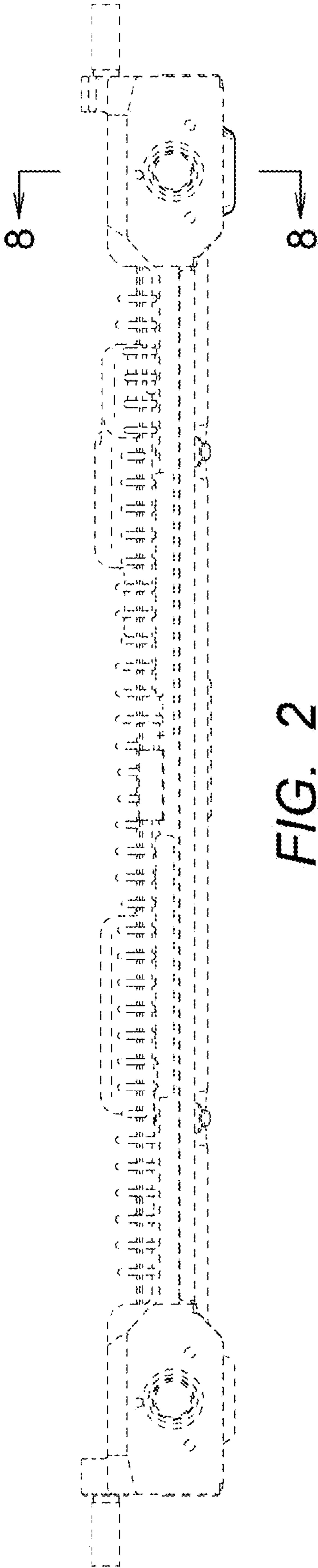

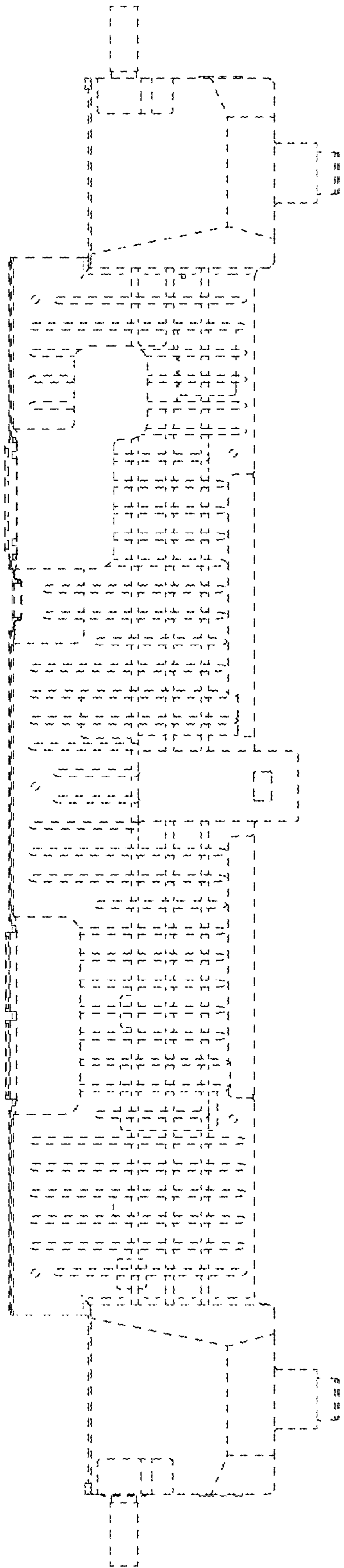

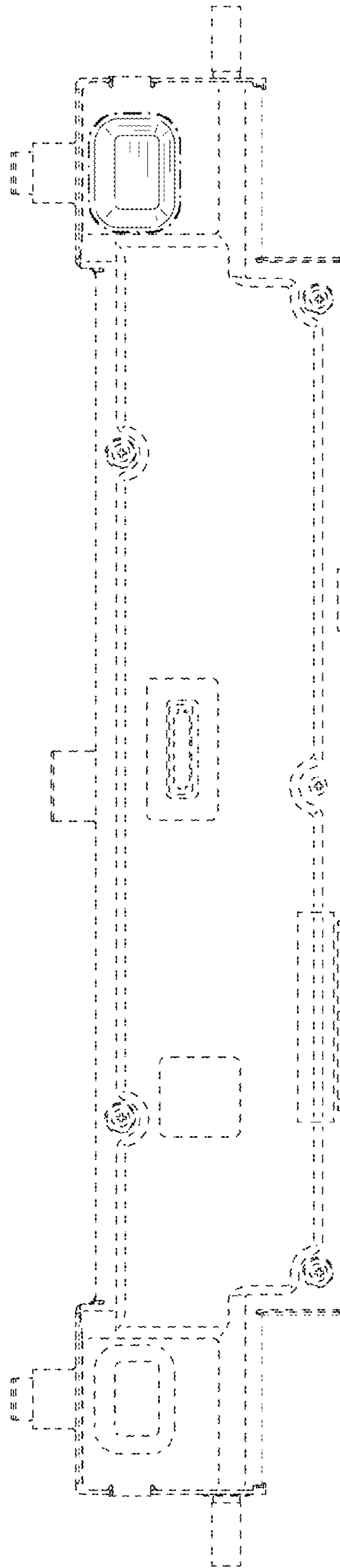

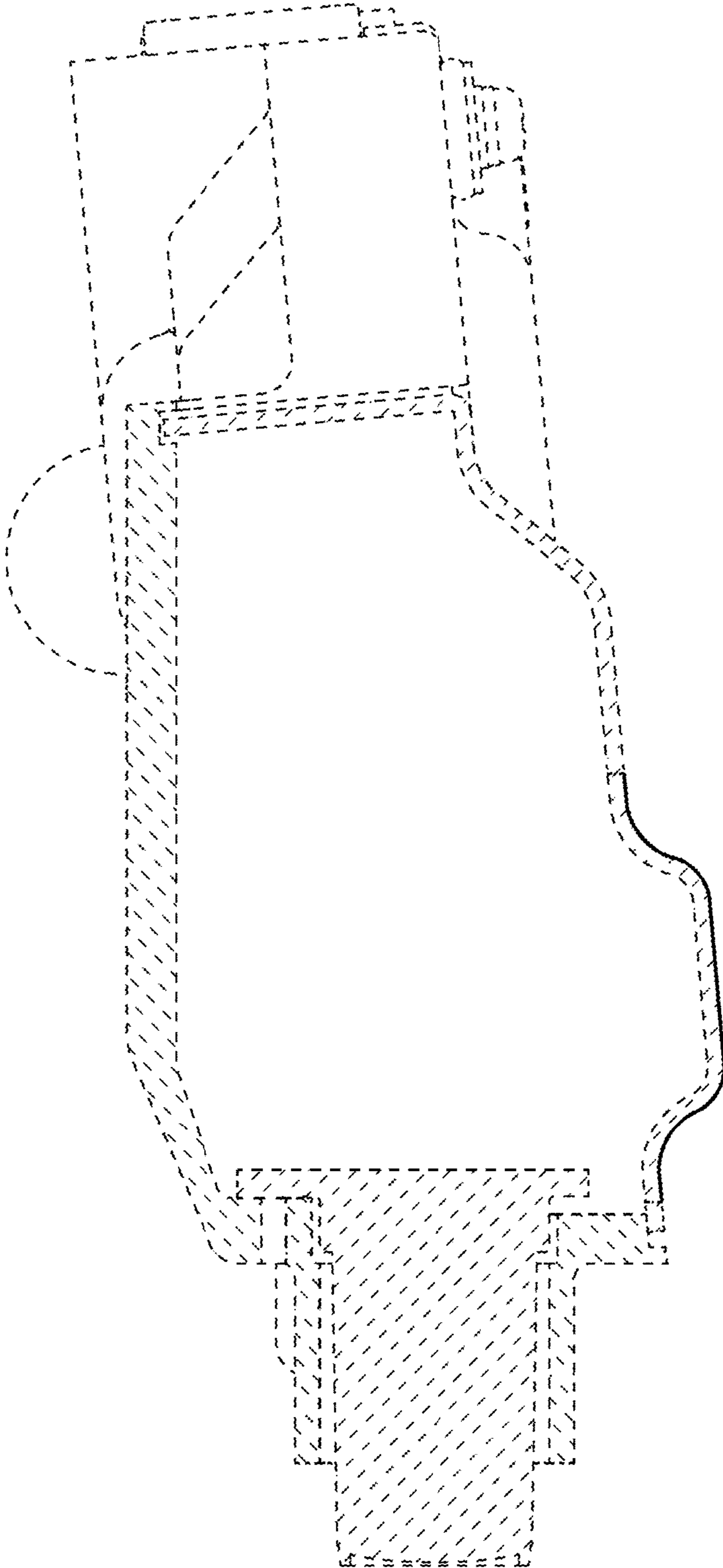
