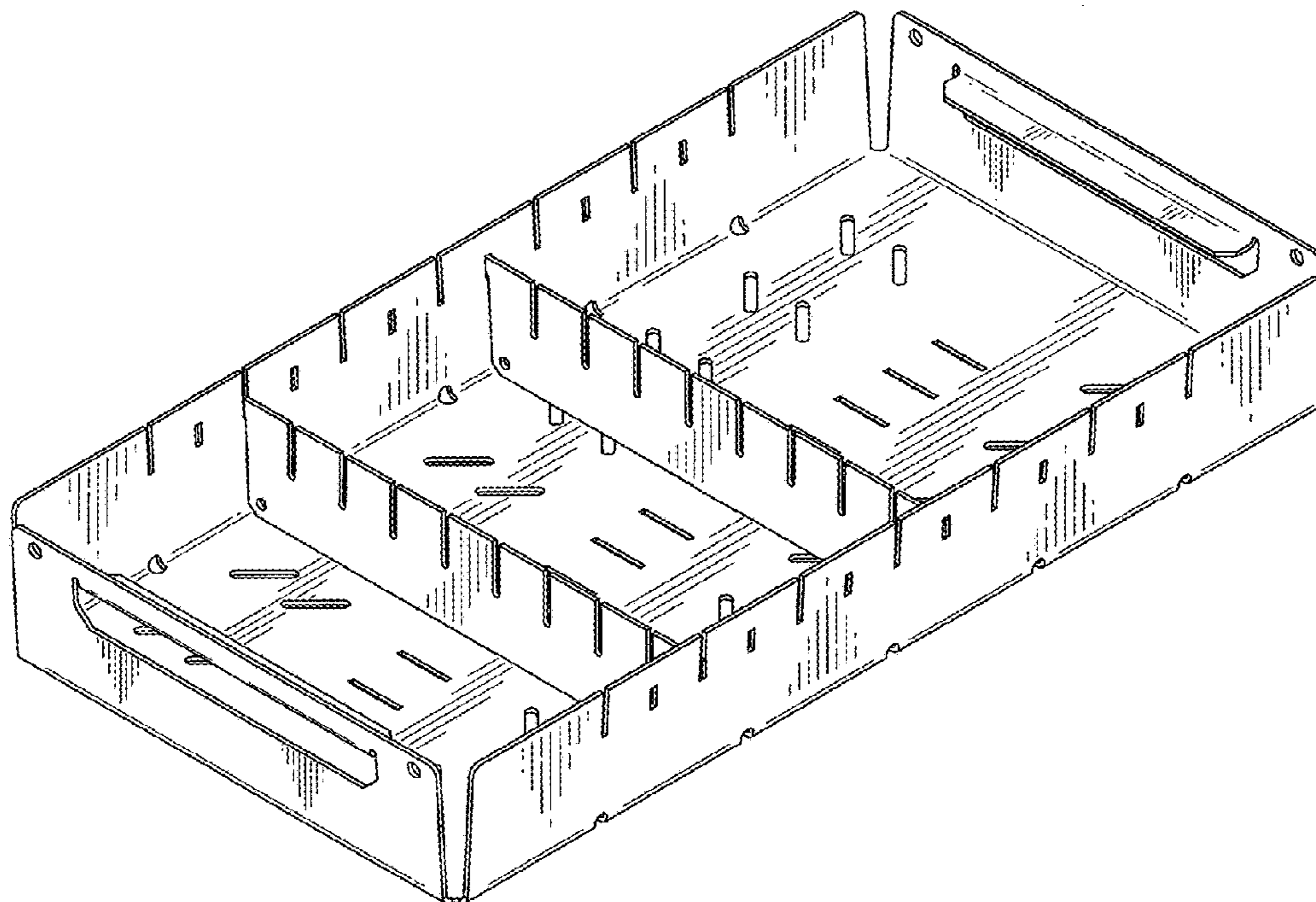
(57) **CLAIM**

The ornamental design for a bait tray, as shown and described.

DESCRIPTION

FIG. 1 is a top front isometric view of the bait tray with removable dividers installed;
FIG. 2 is a bottom rear isometric view of the bait tray;
FIG. 3 is a front view of the bait tray;
FIG. 4 is a rear view of the bait tray;
FIG. 5 is a left side view of the bait tray;
FIG. 6 is a right side view of the bait tray;
FIG. 7 is a top view of the bait tray with removable dividers installed;
FIG. 8 is a bottom view of the bait tray;
FIG. 9 is an exploded isometric view of the bait tray with removable dividers removed; and,
FIG. 10 is an isometric view of the bait tray stacked with a second (disclaimed) bait tray.

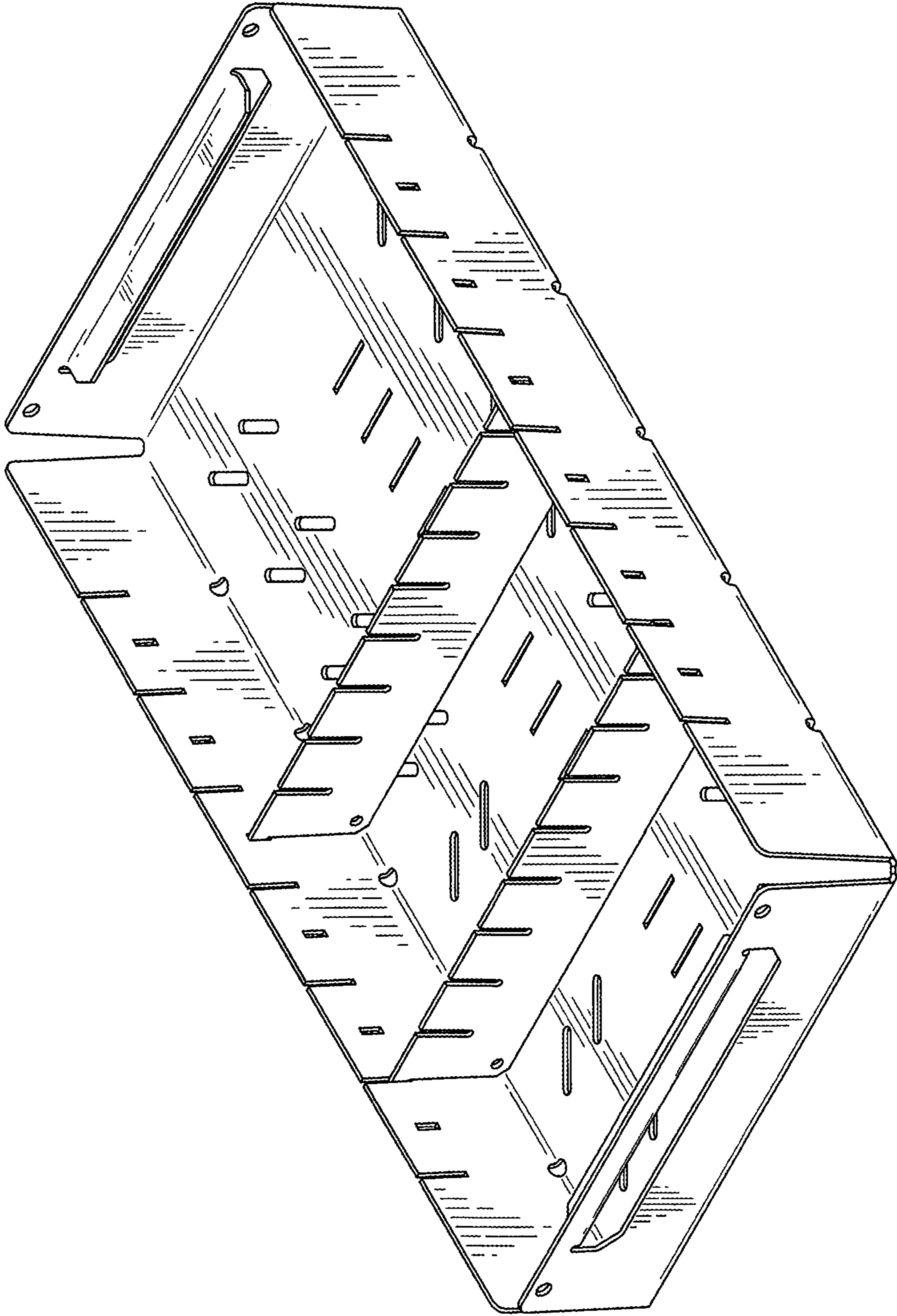

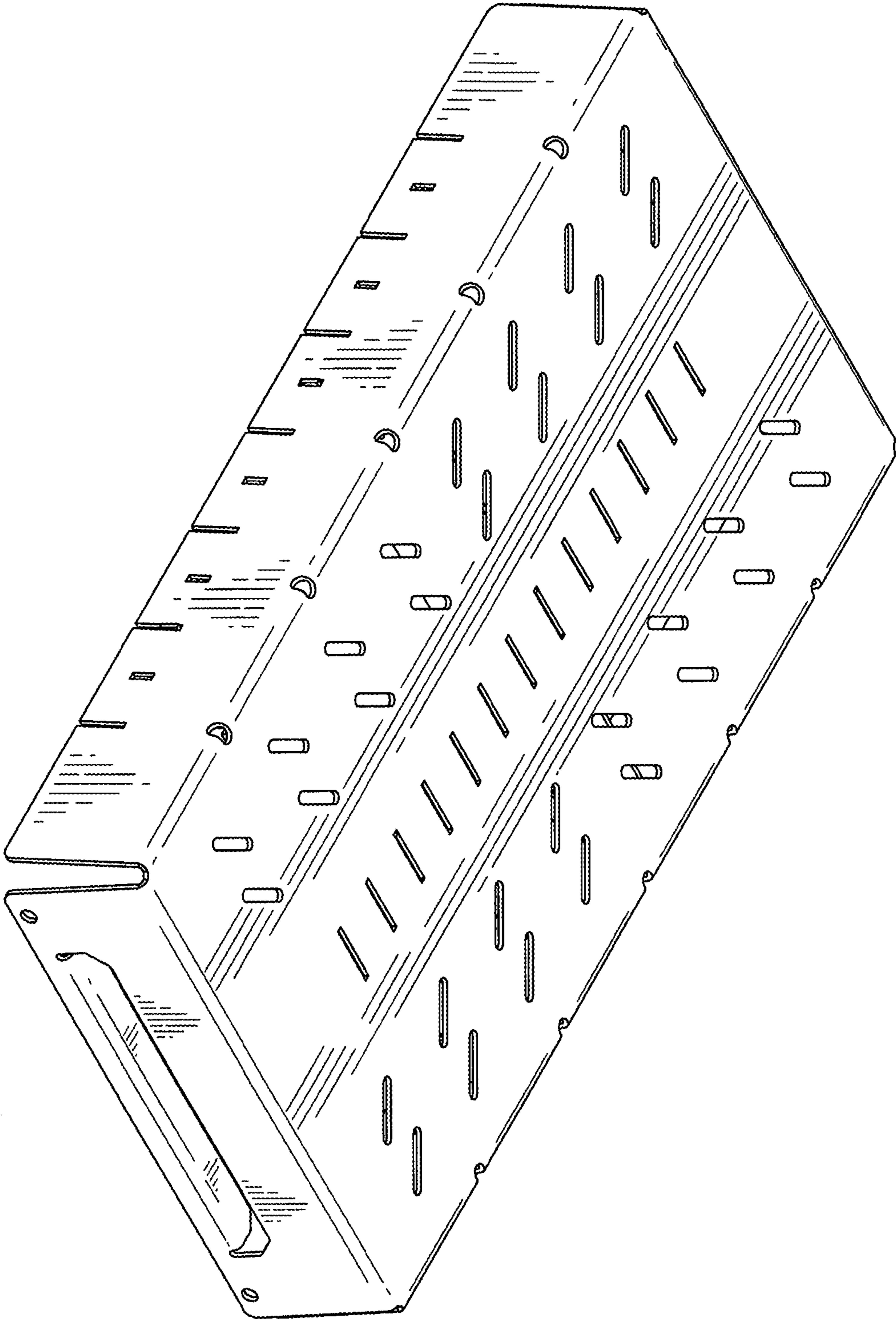

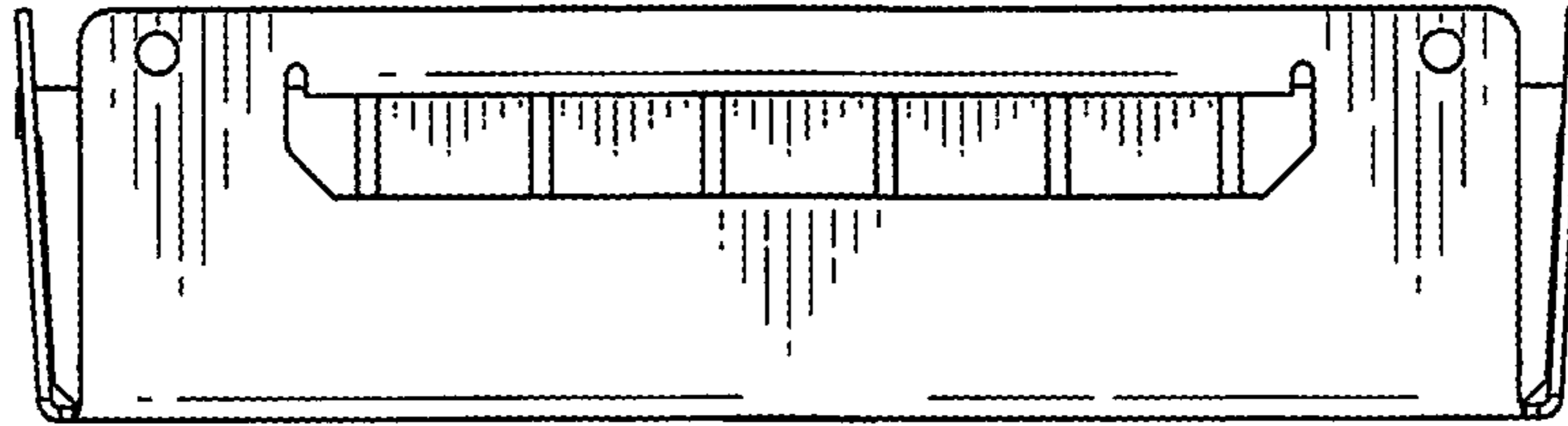

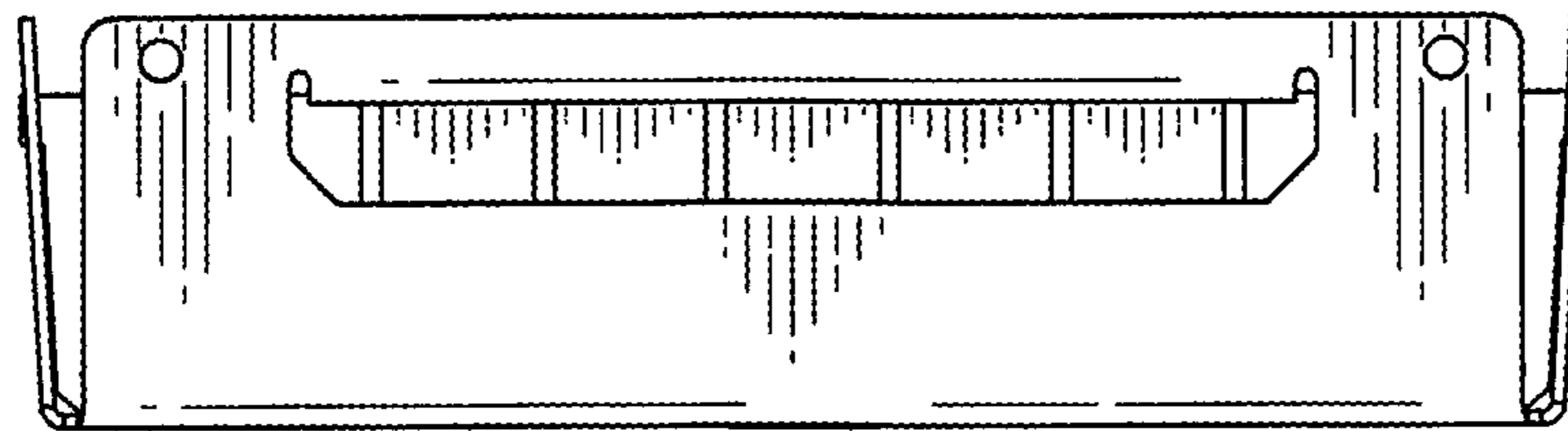

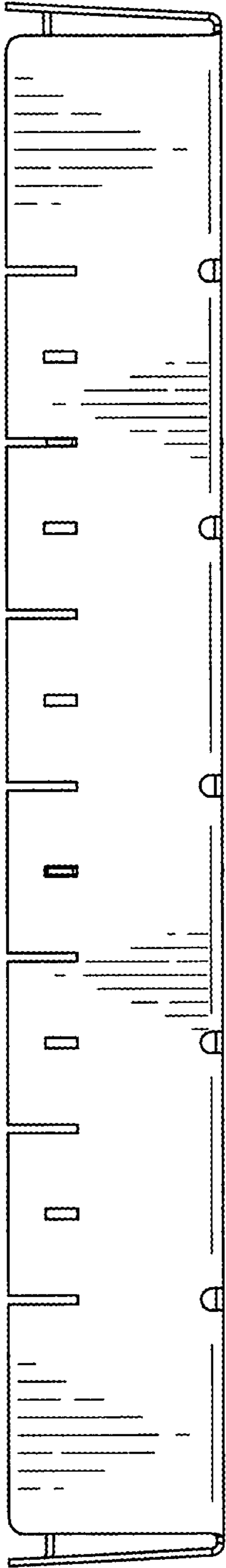

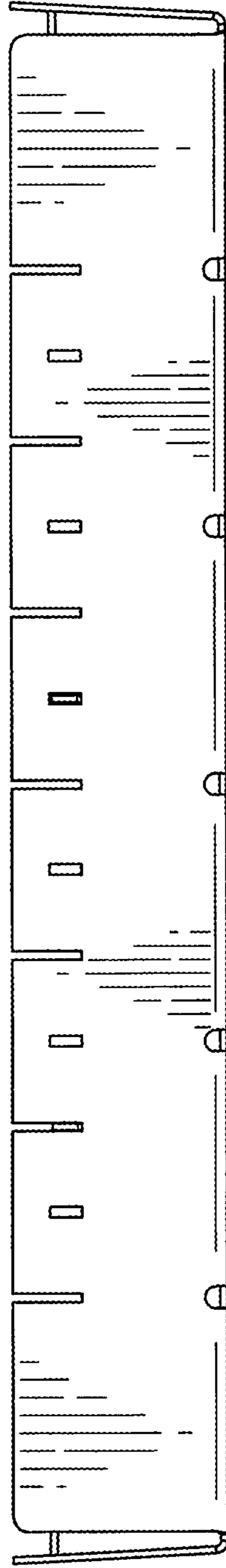

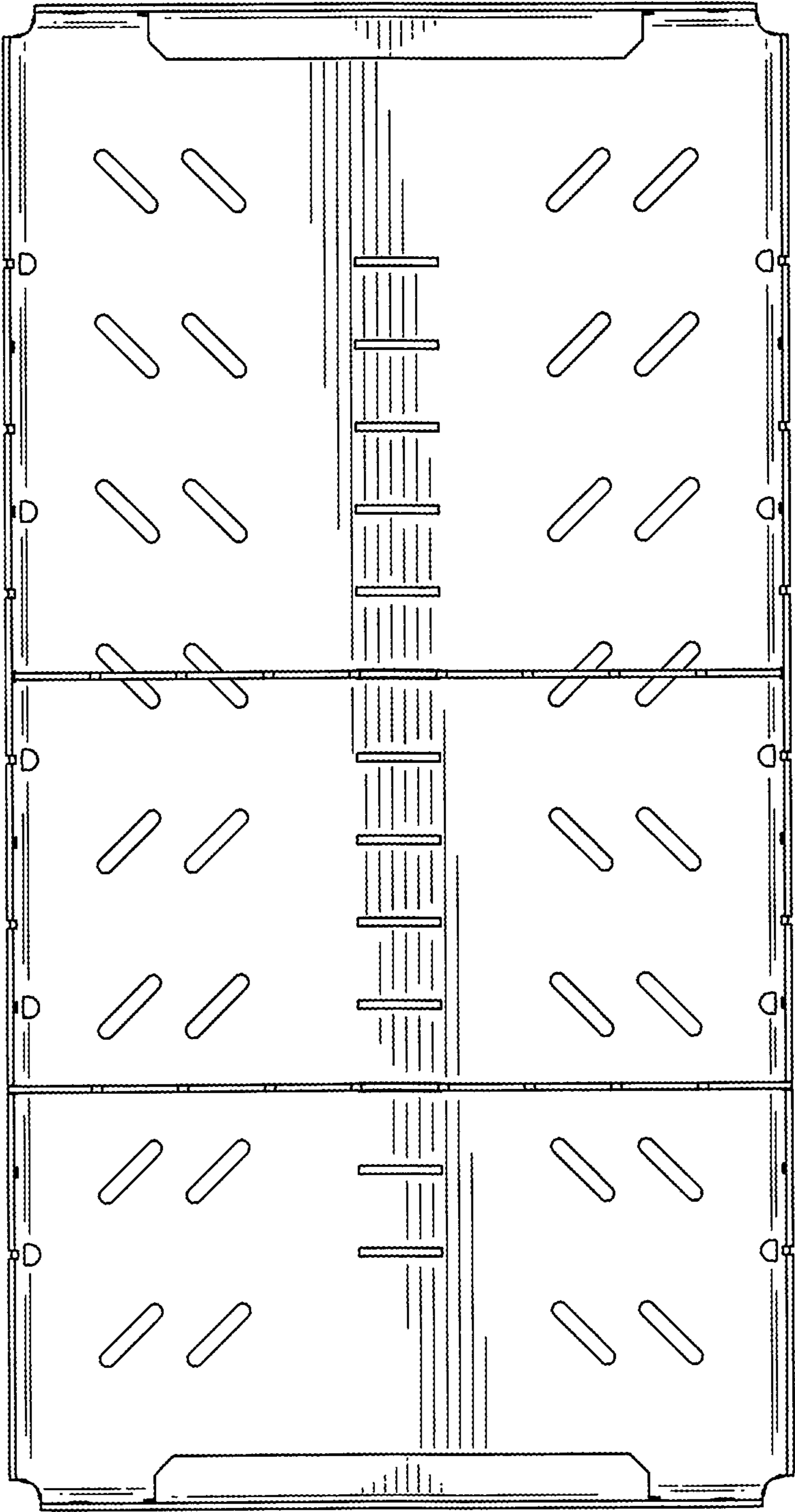

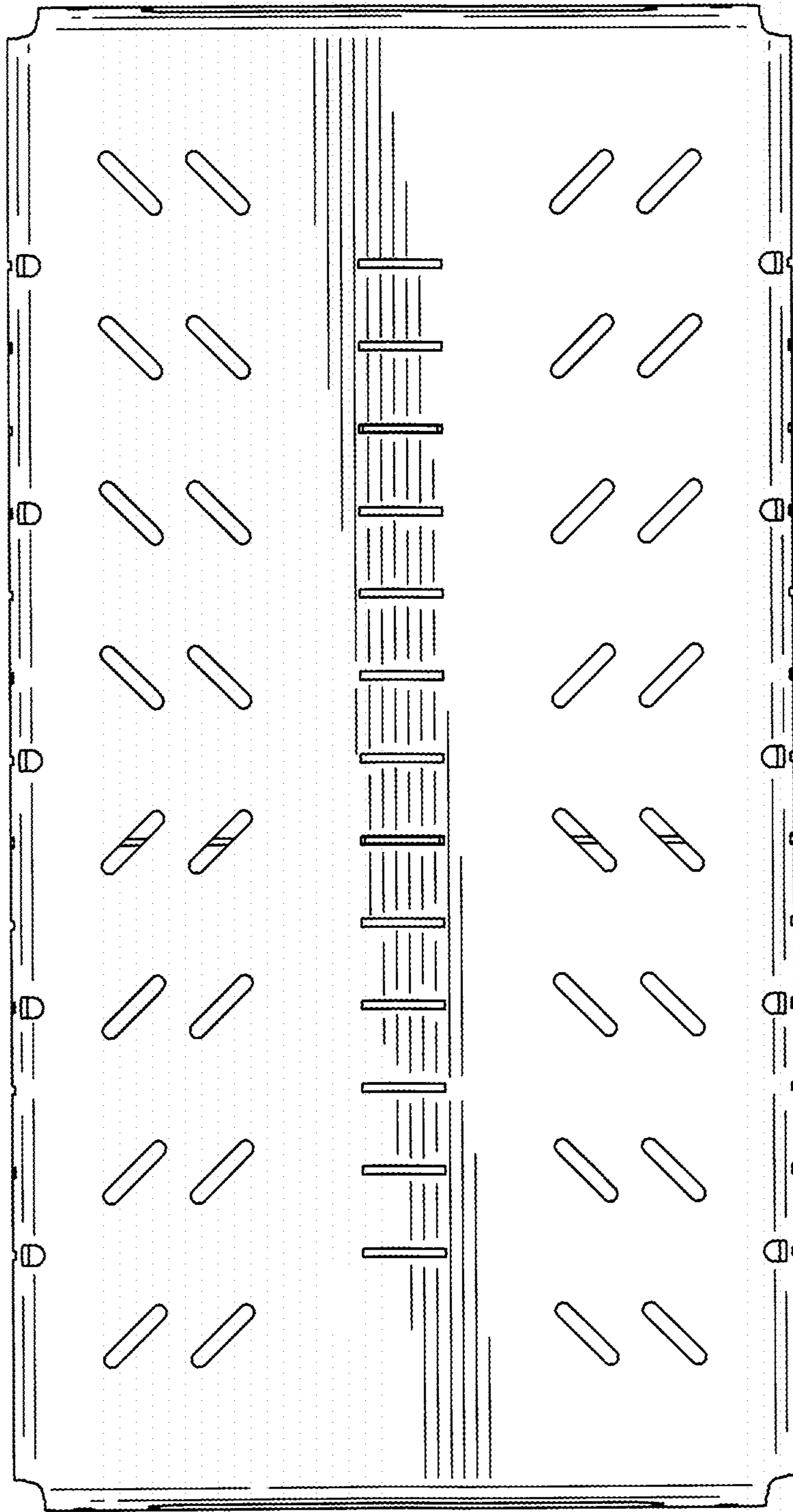

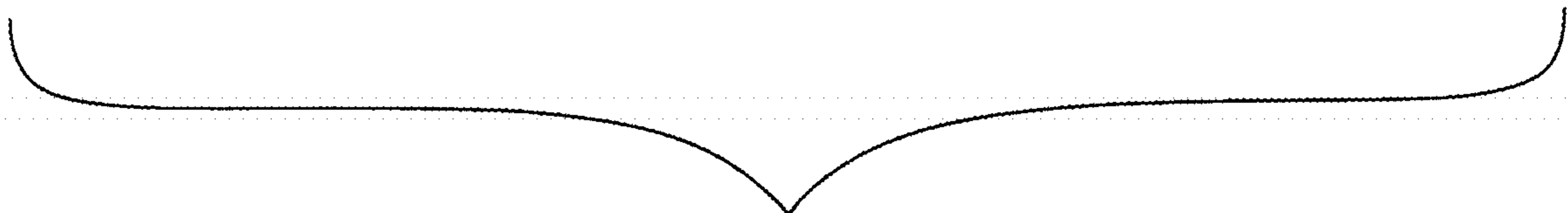
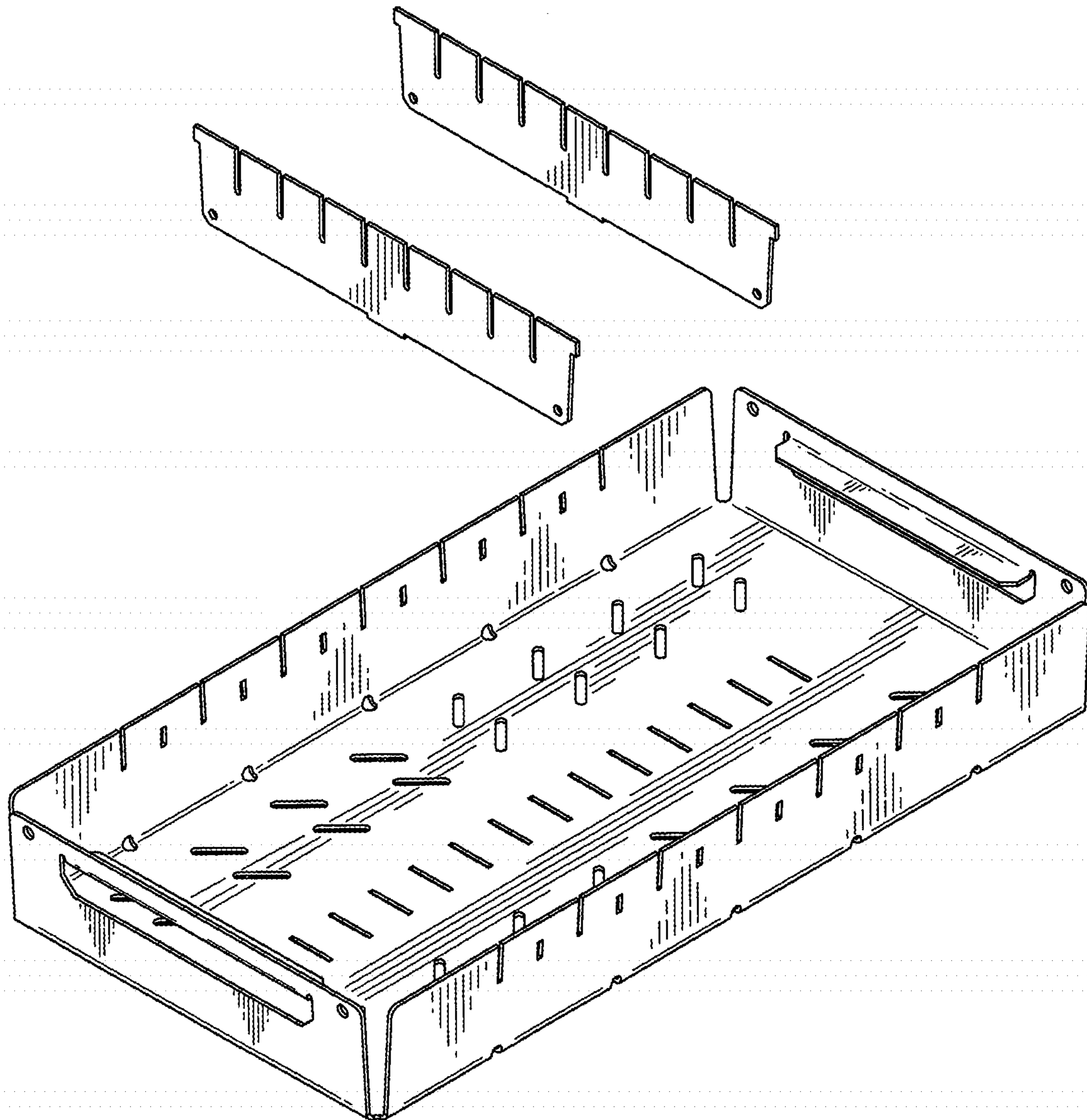

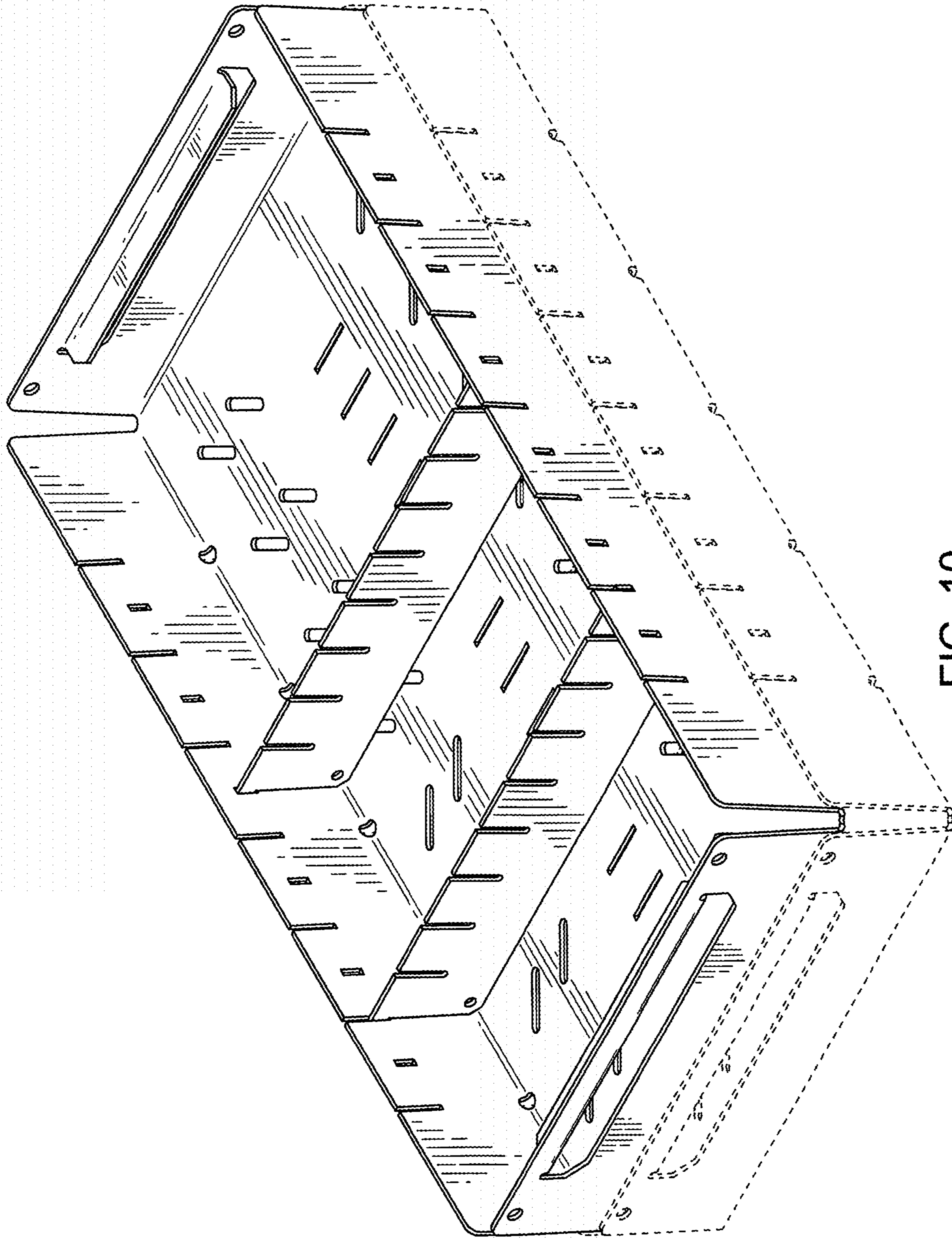
