FIG. 8 is a perspective view thereof;

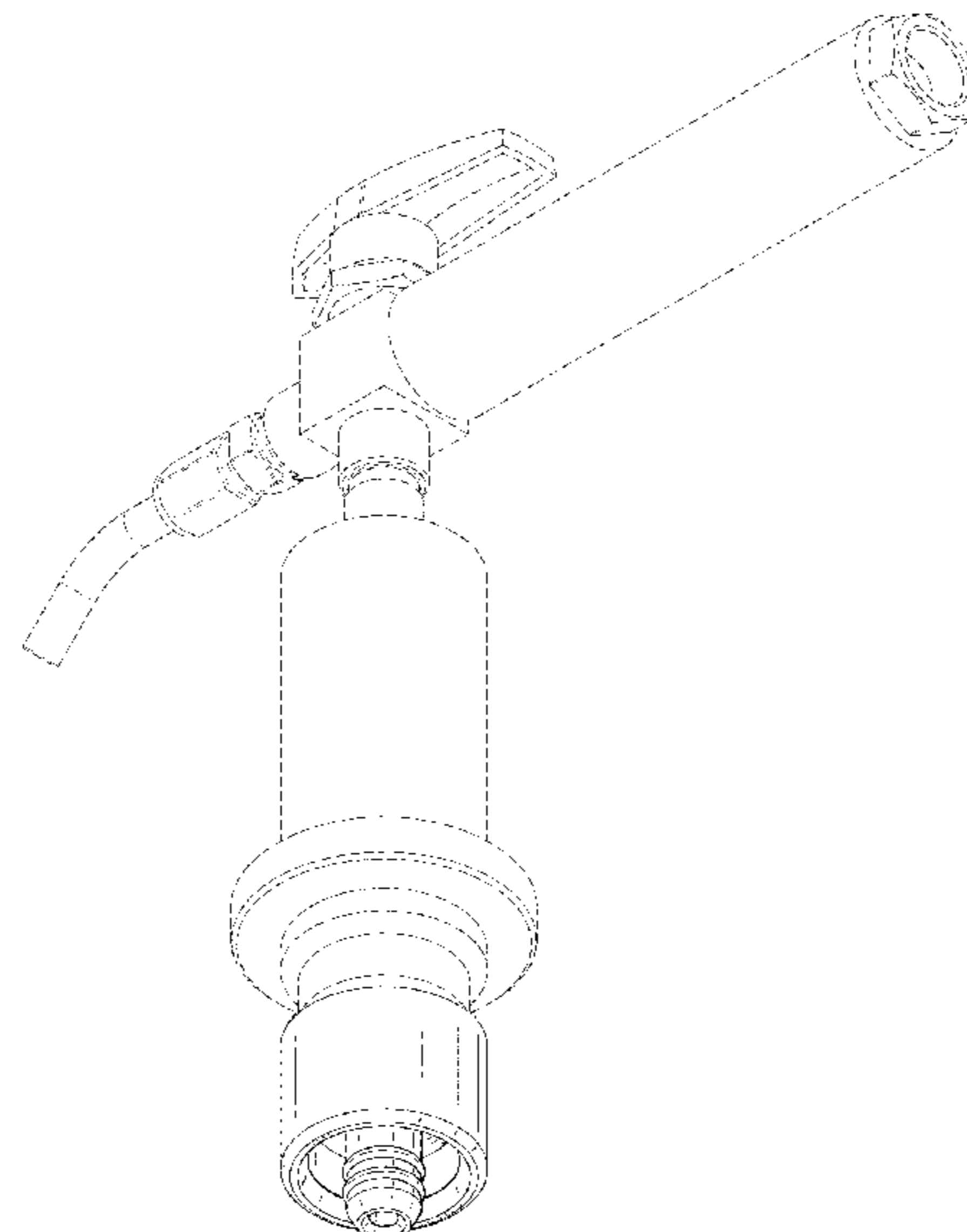
FIG. 9 is a perspective view thereof;

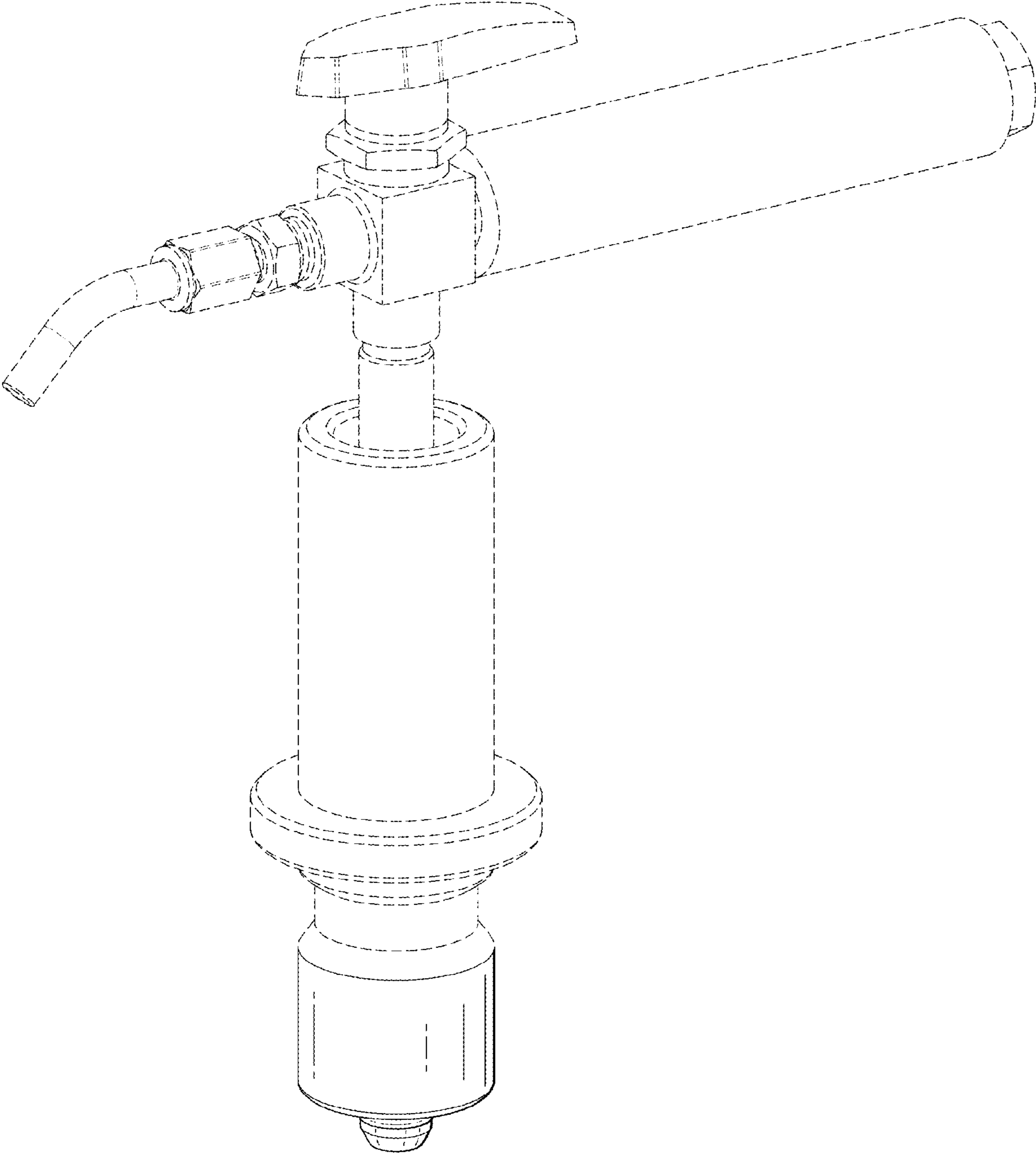

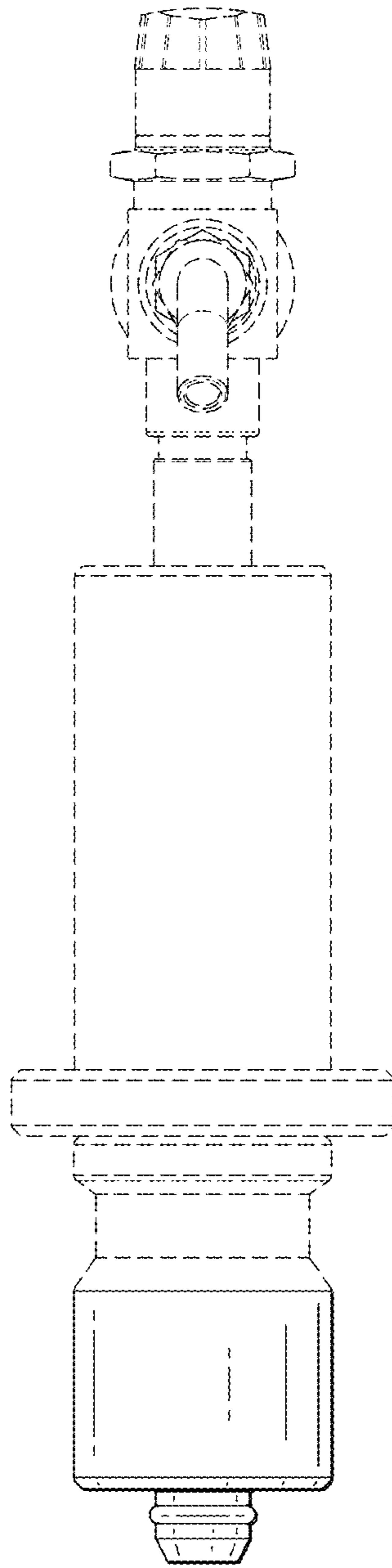

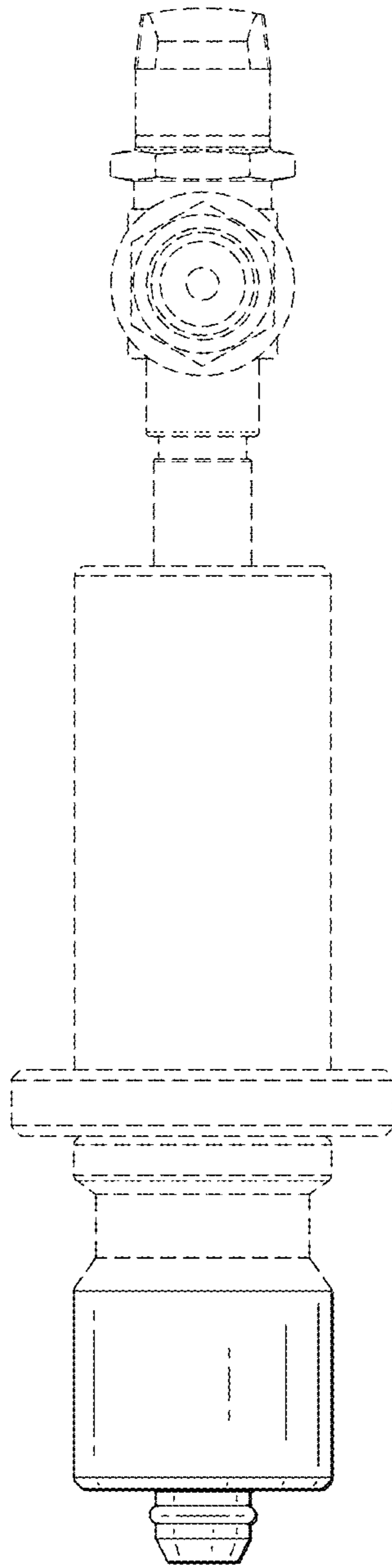

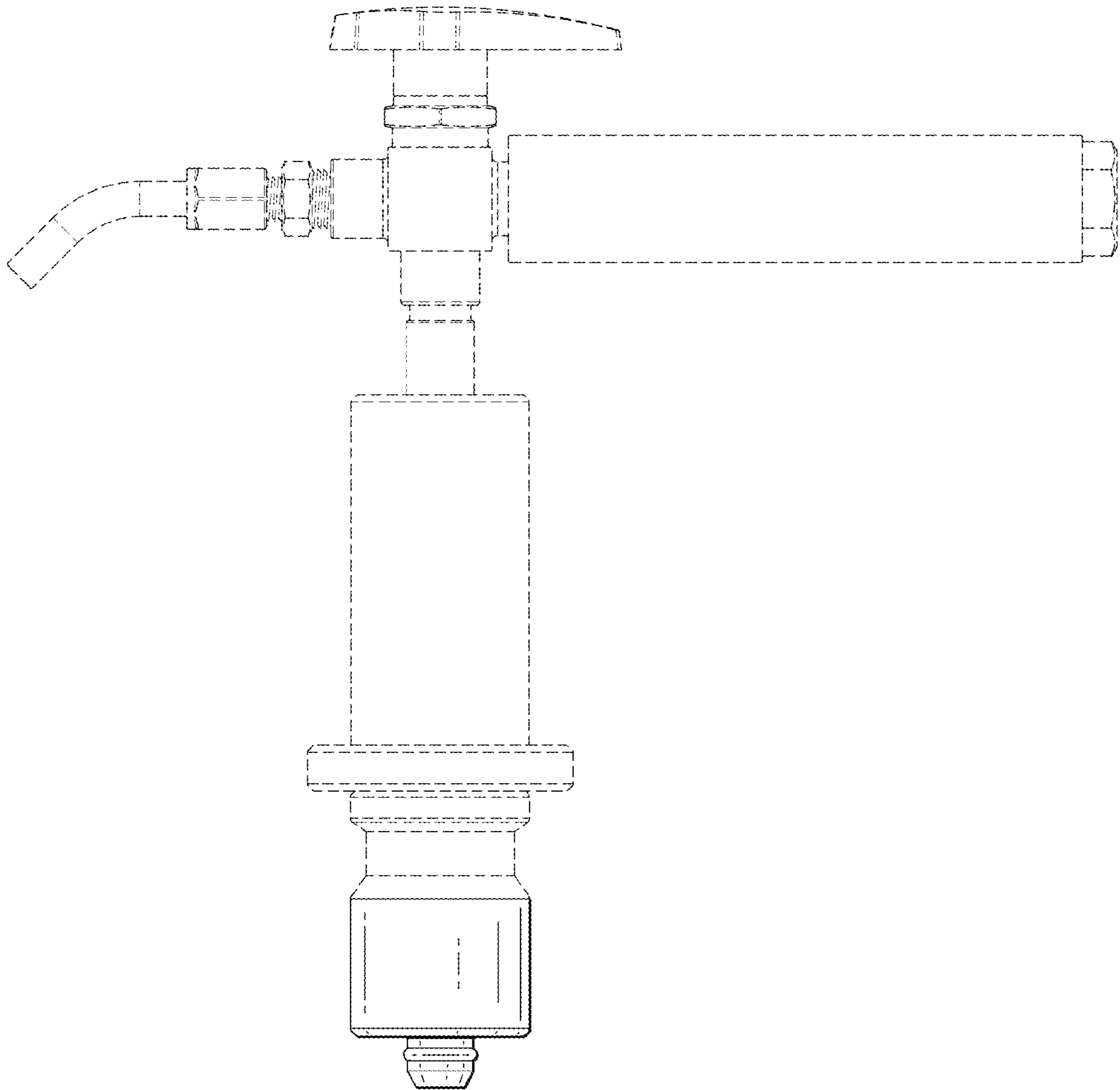

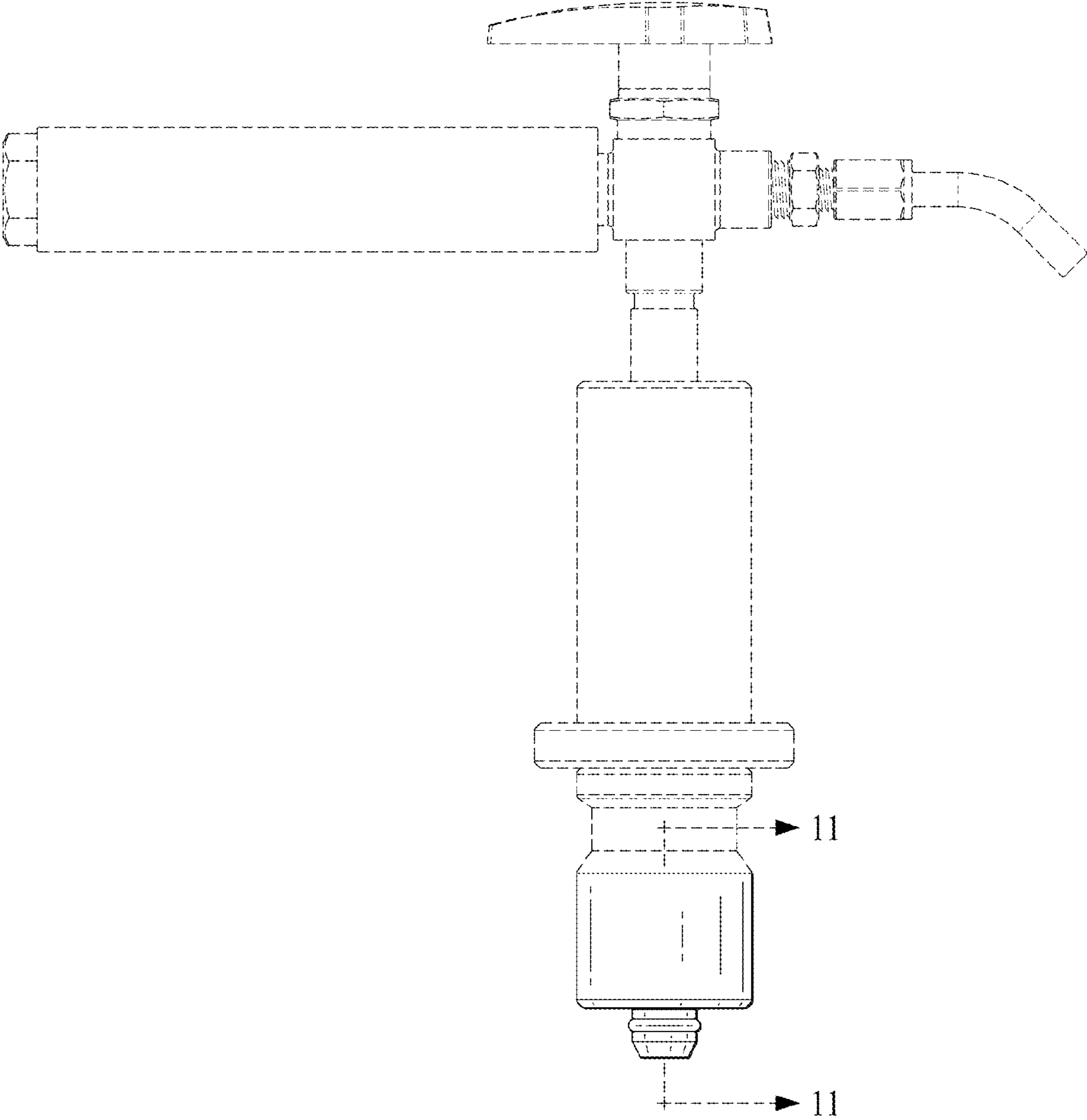

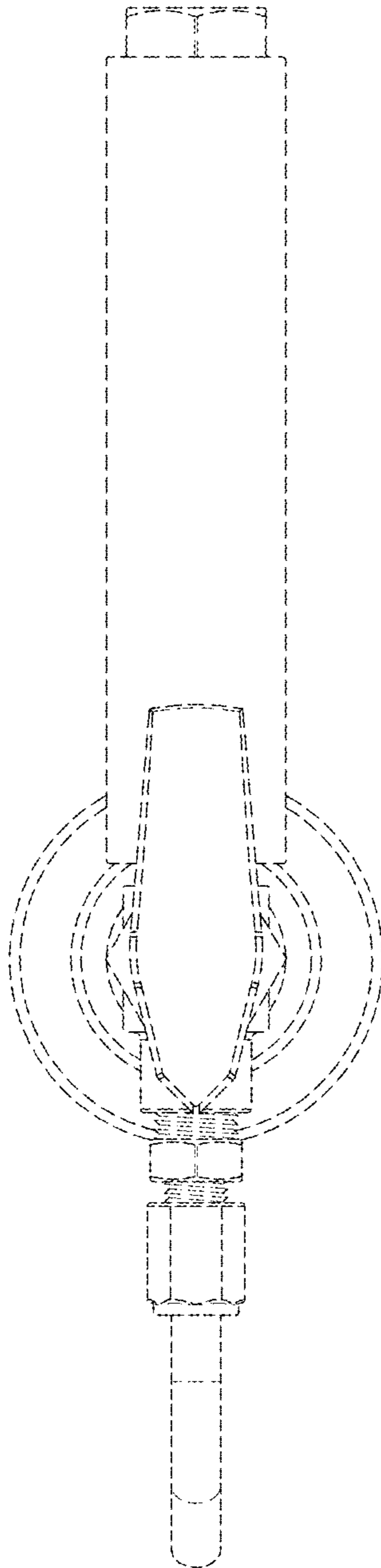

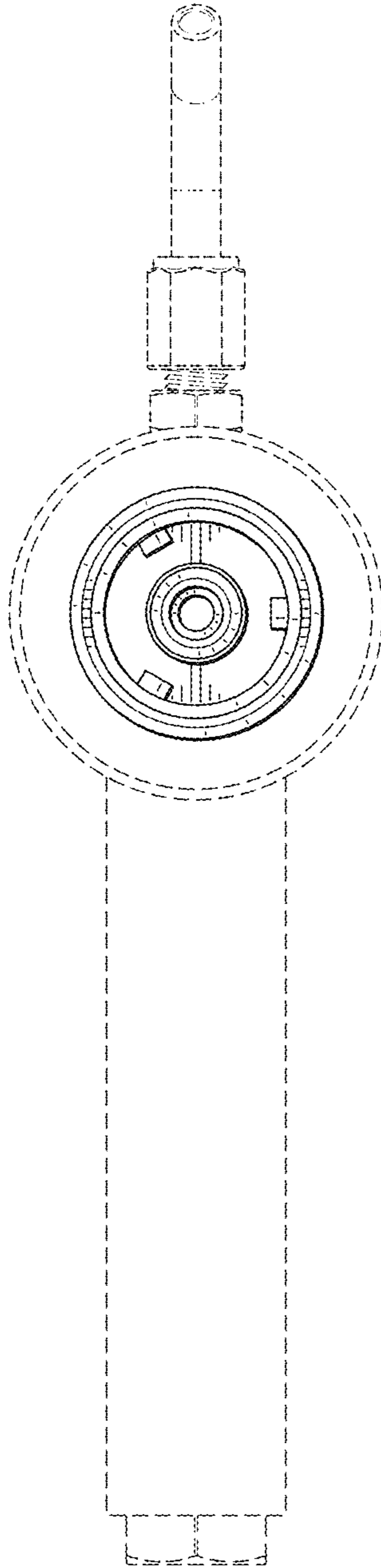

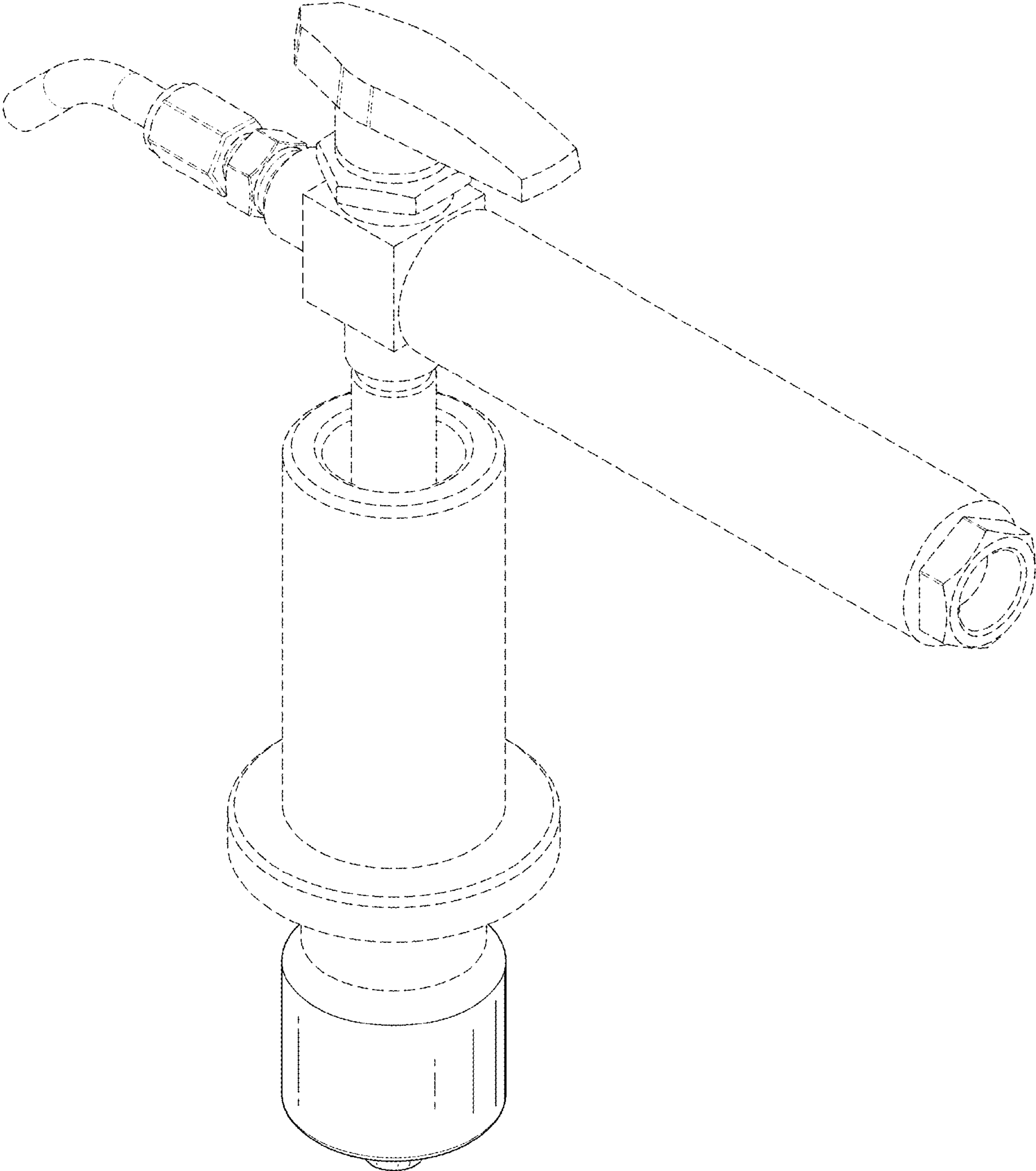

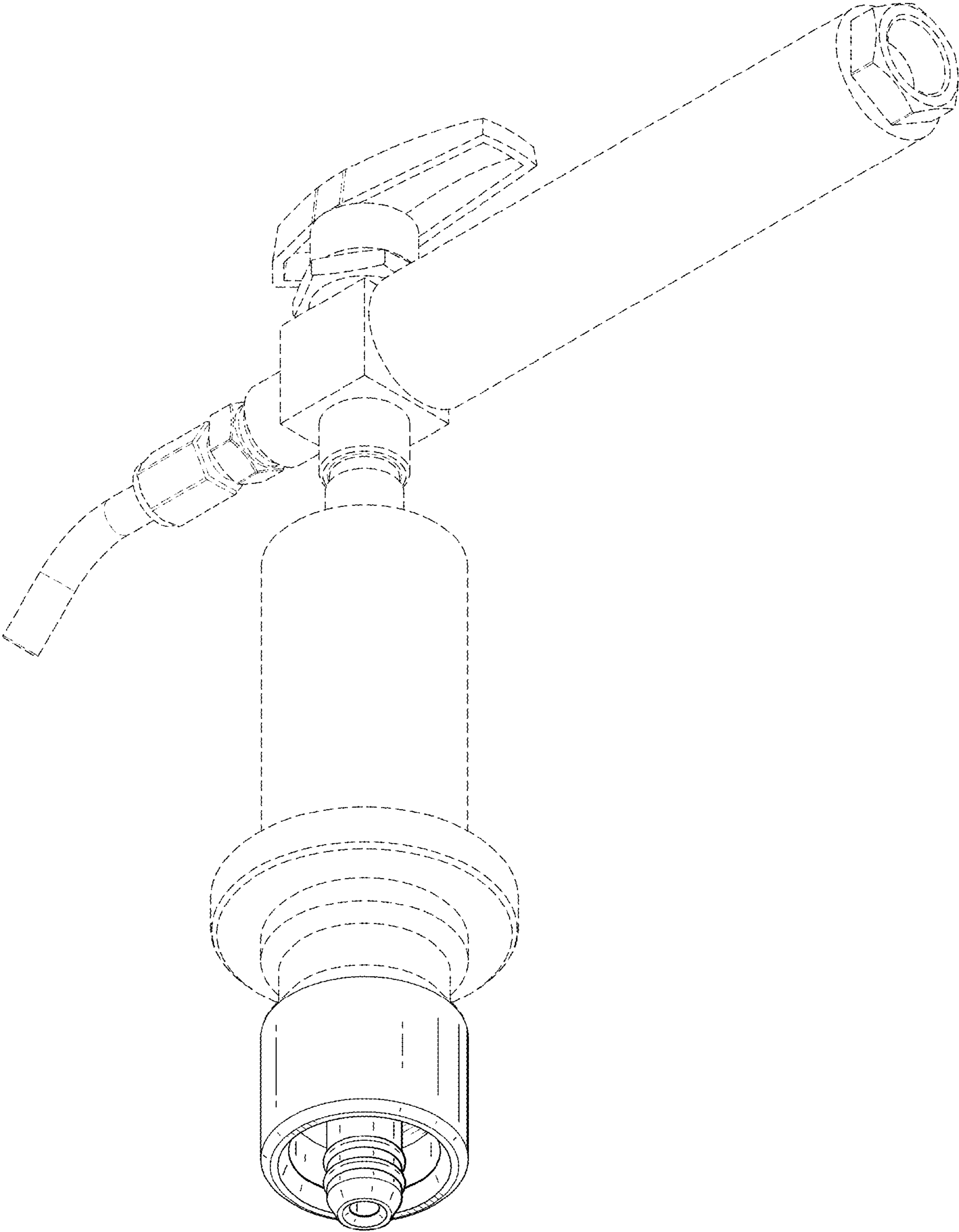

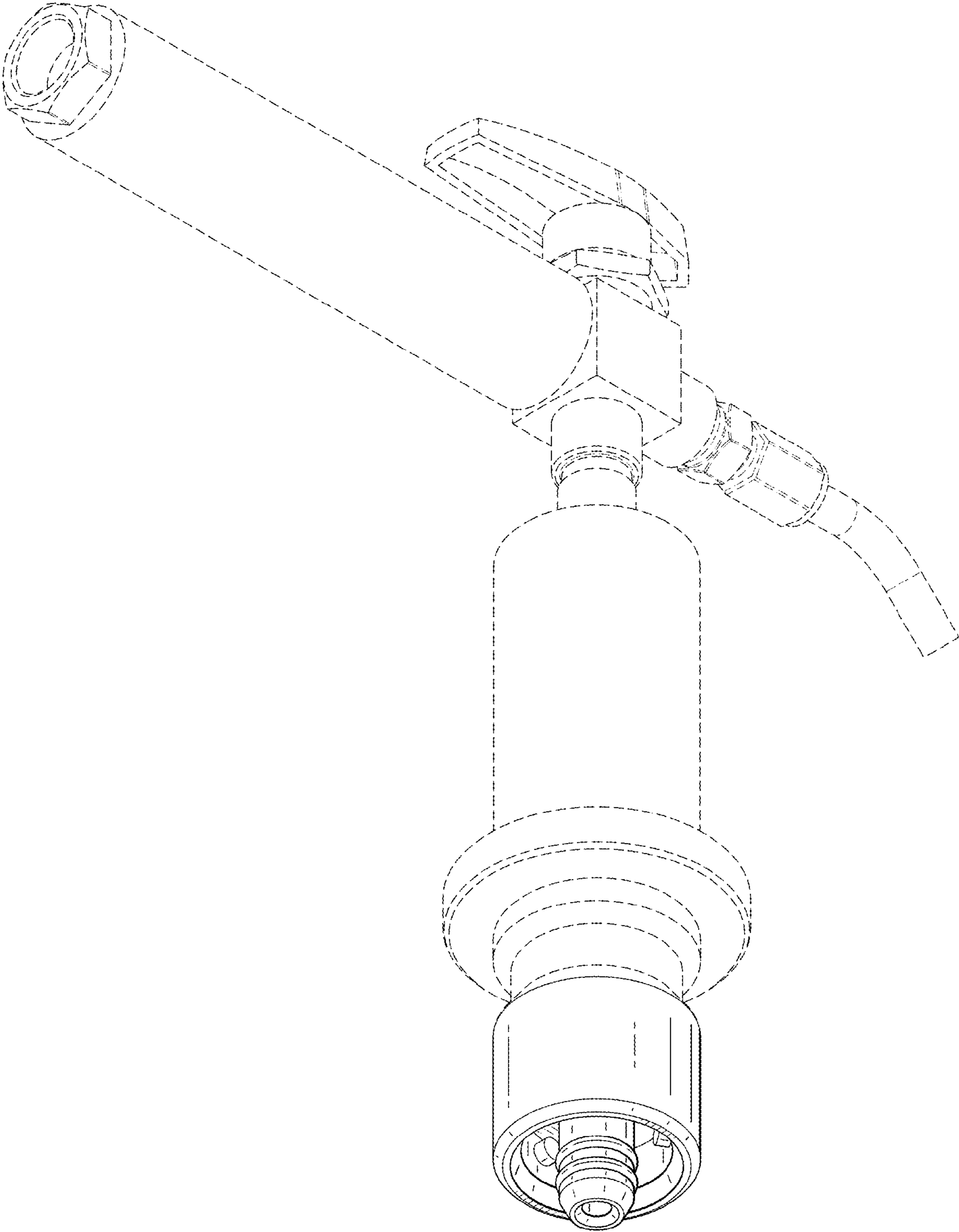

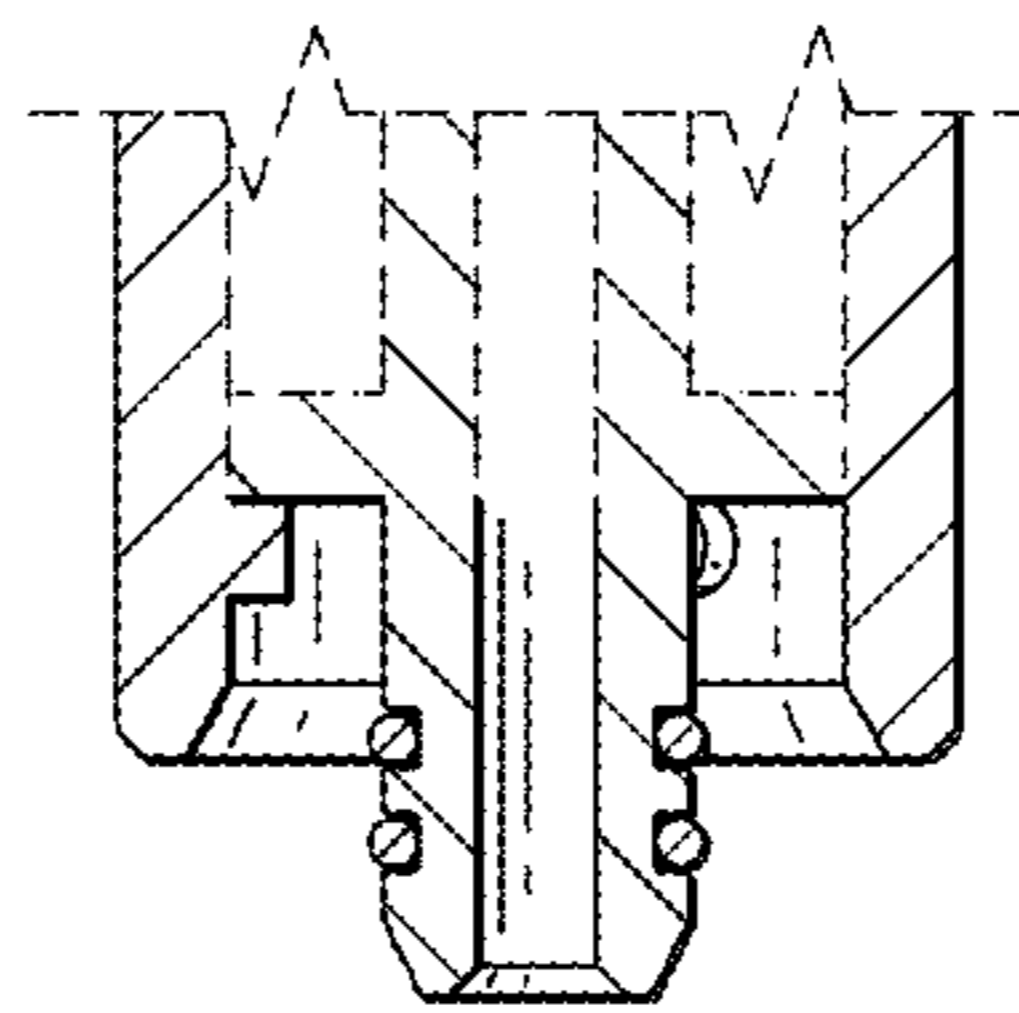
