(57) **CLAIM**

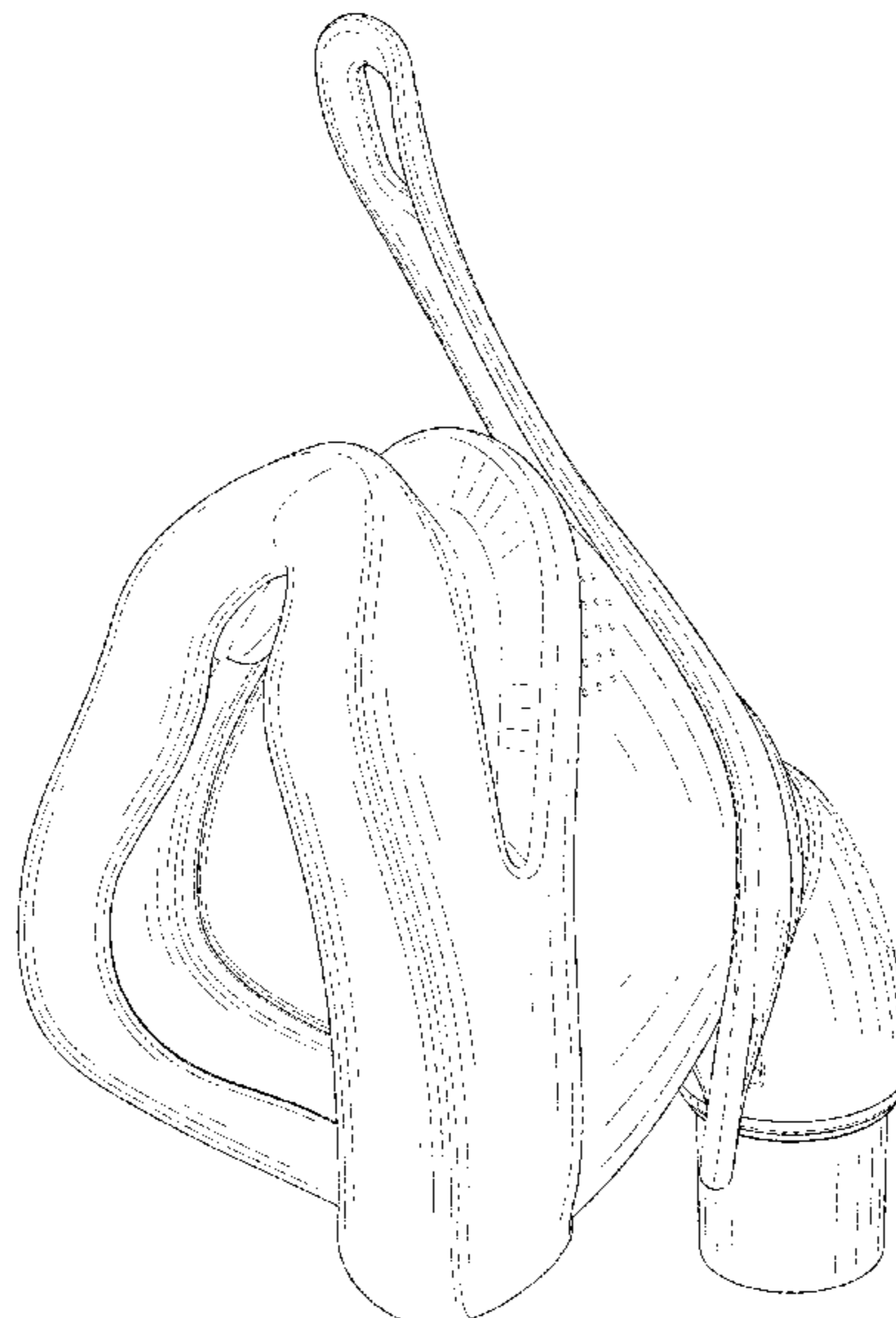
The ornamental design for a patient interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear and left side perspective view of a patient interface showing our new design;

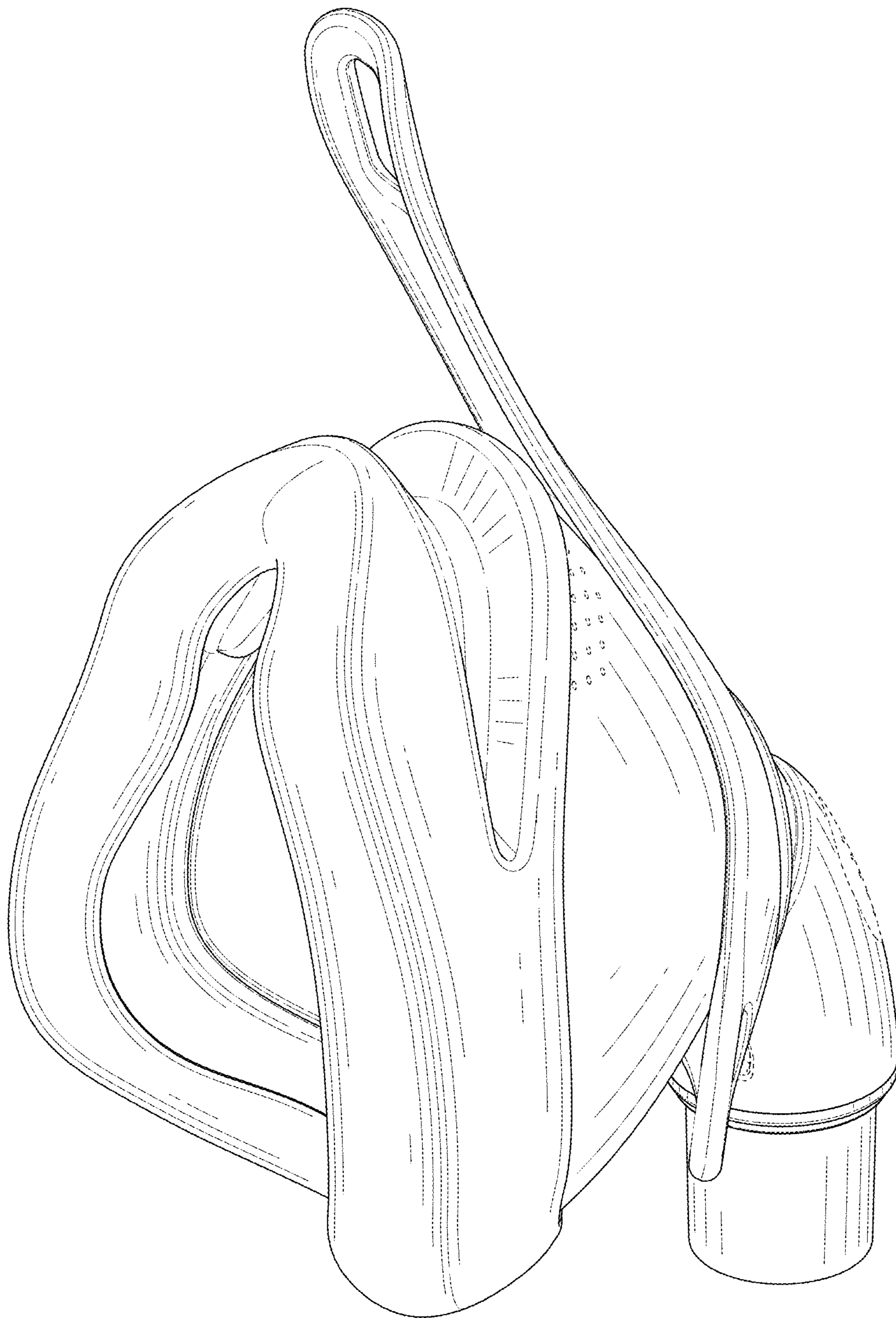

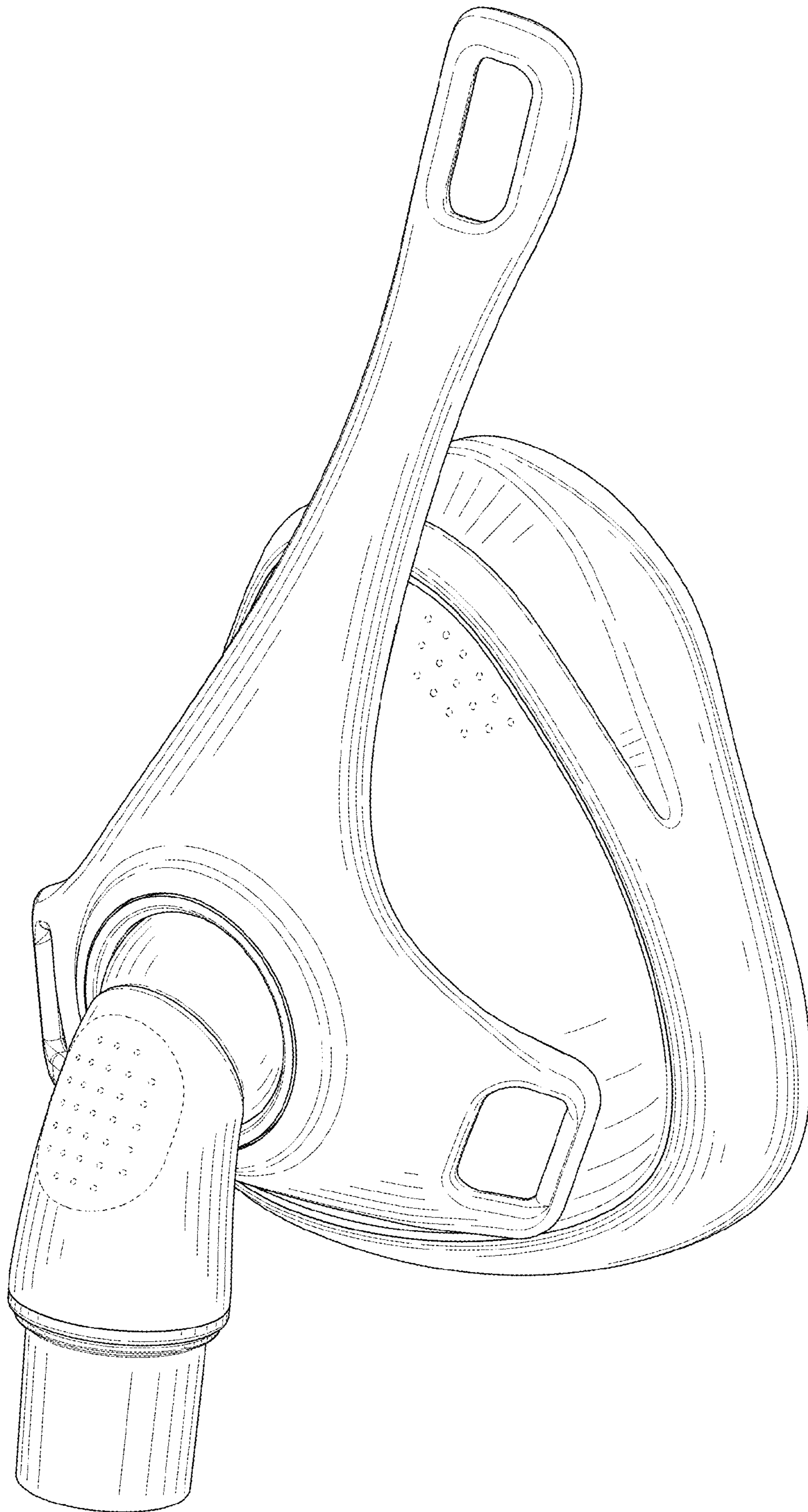

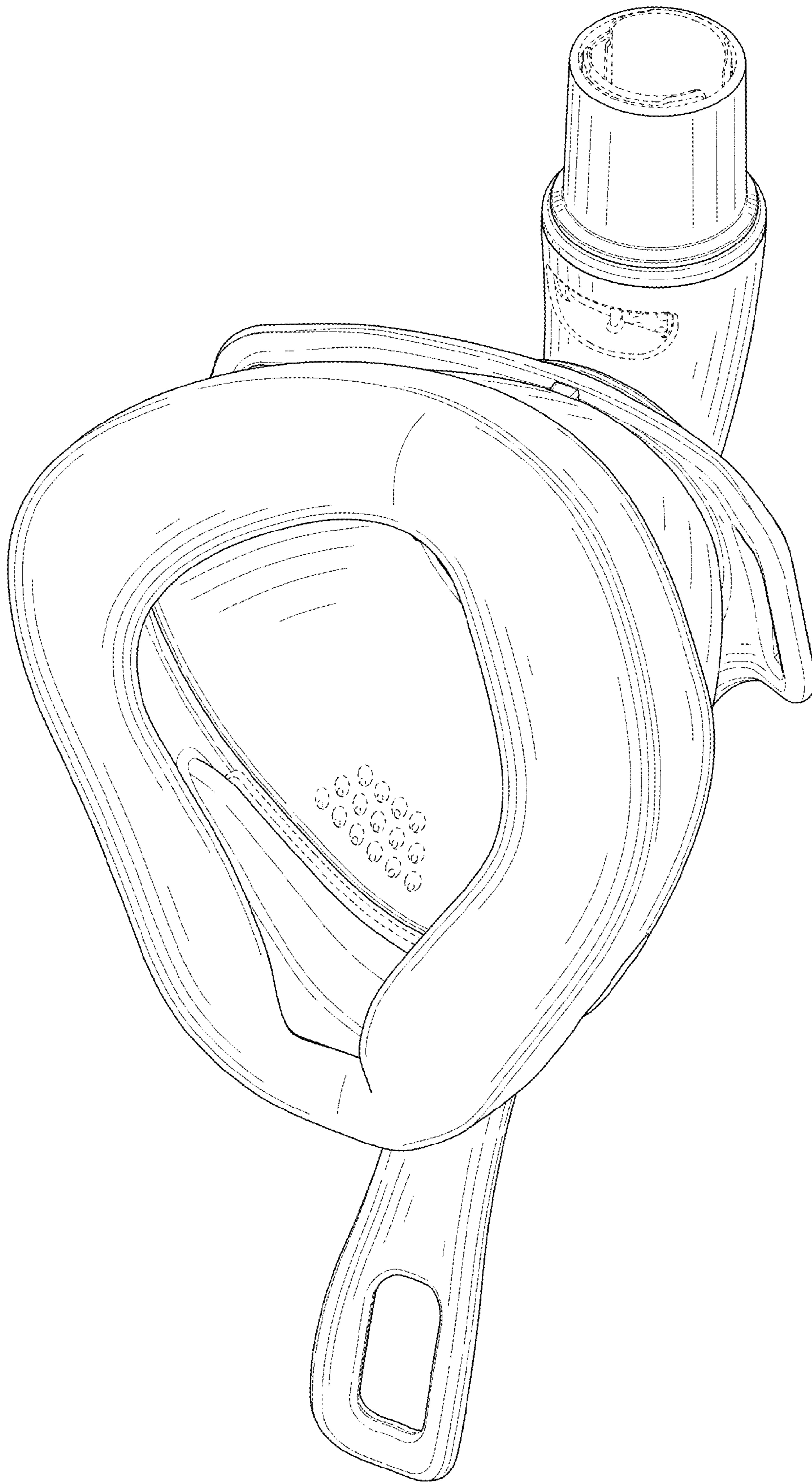

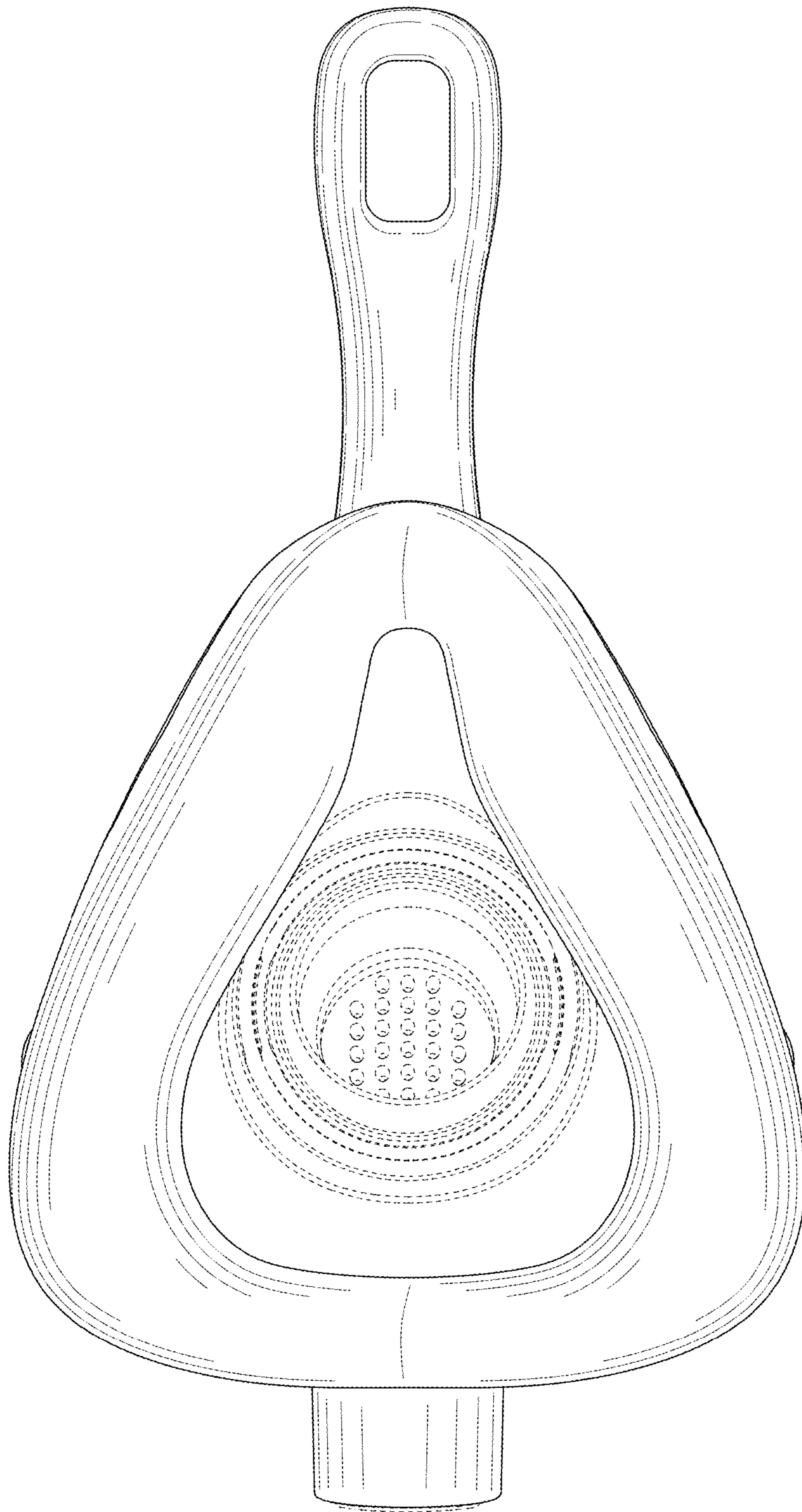

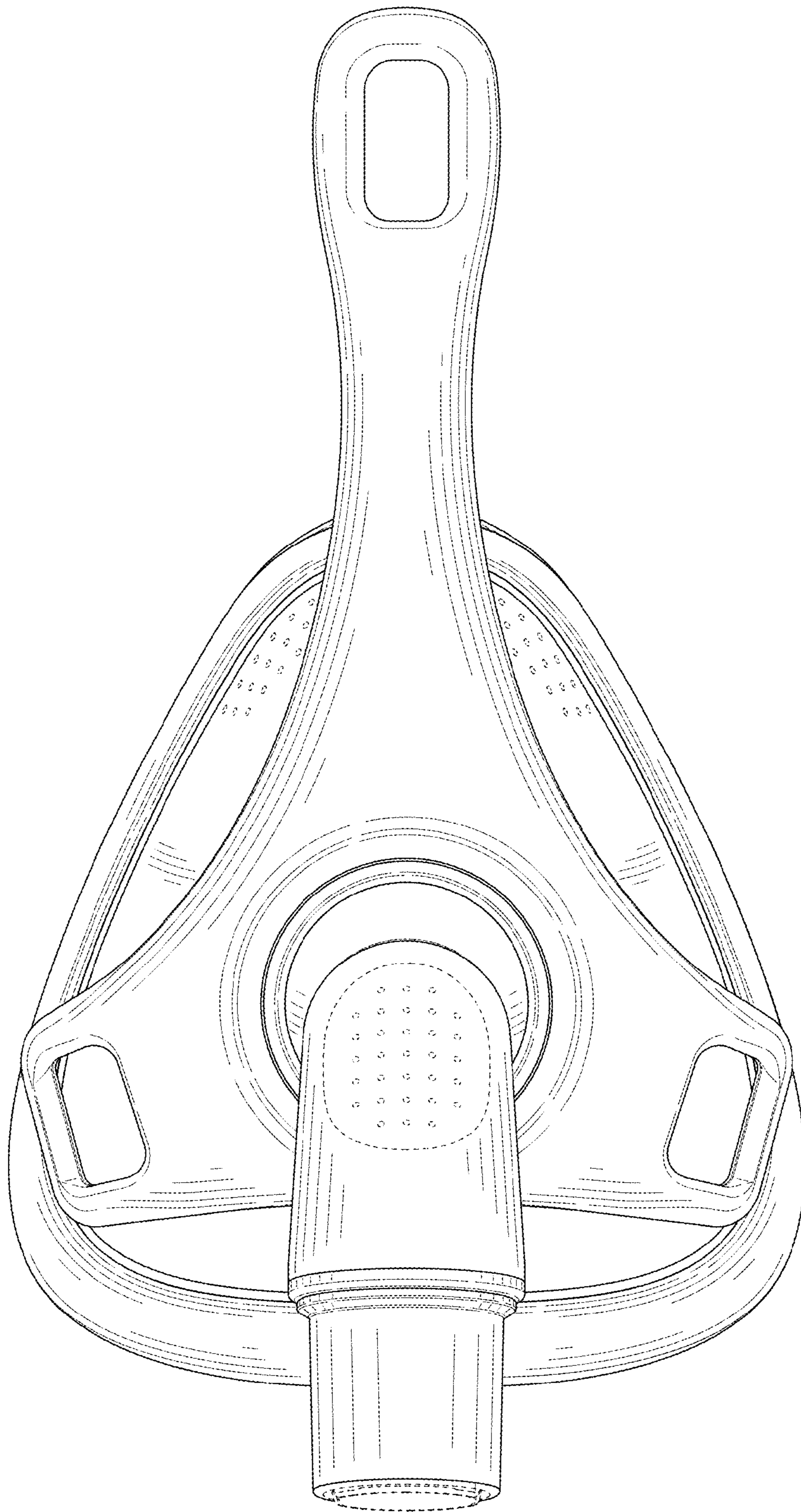

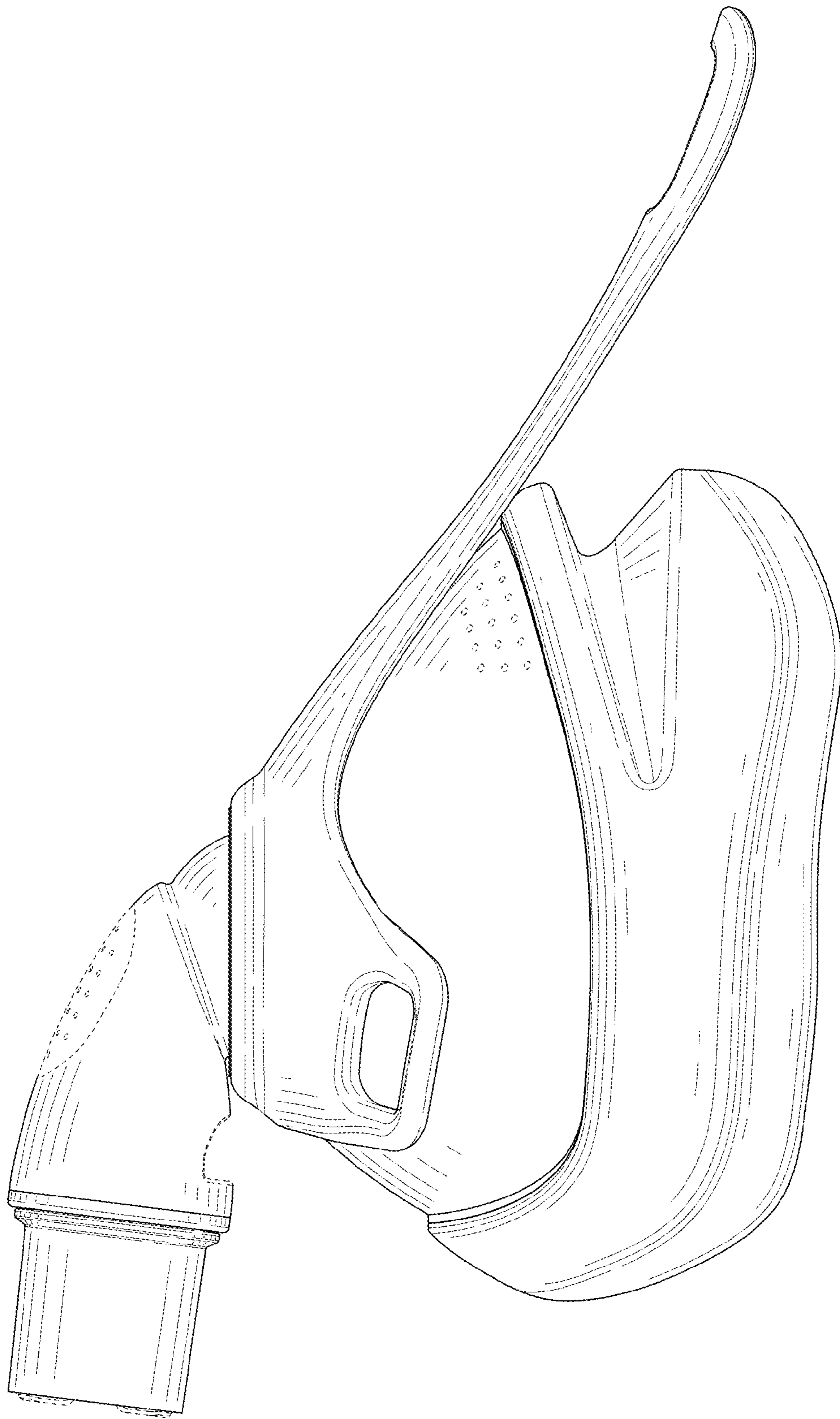

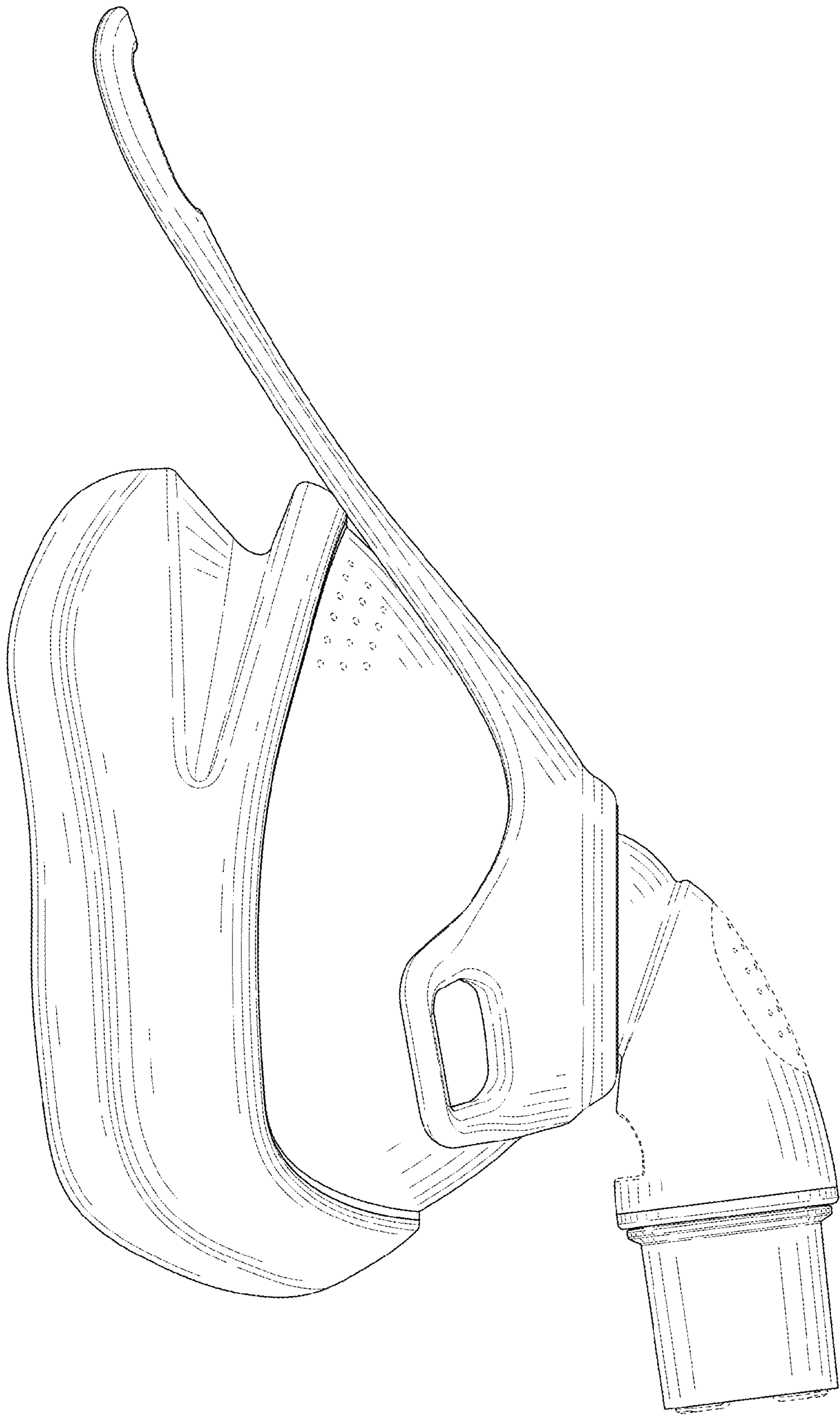

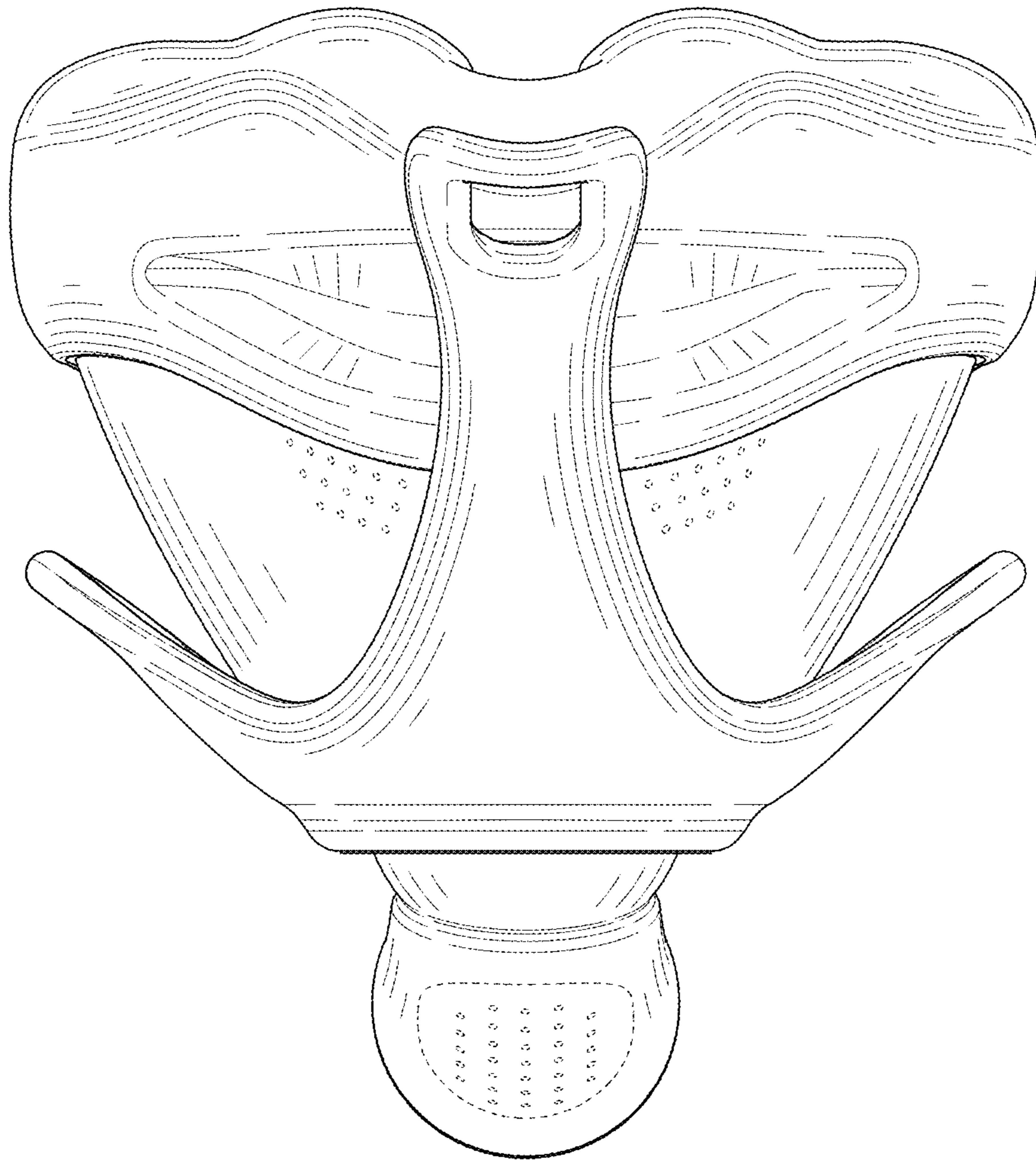

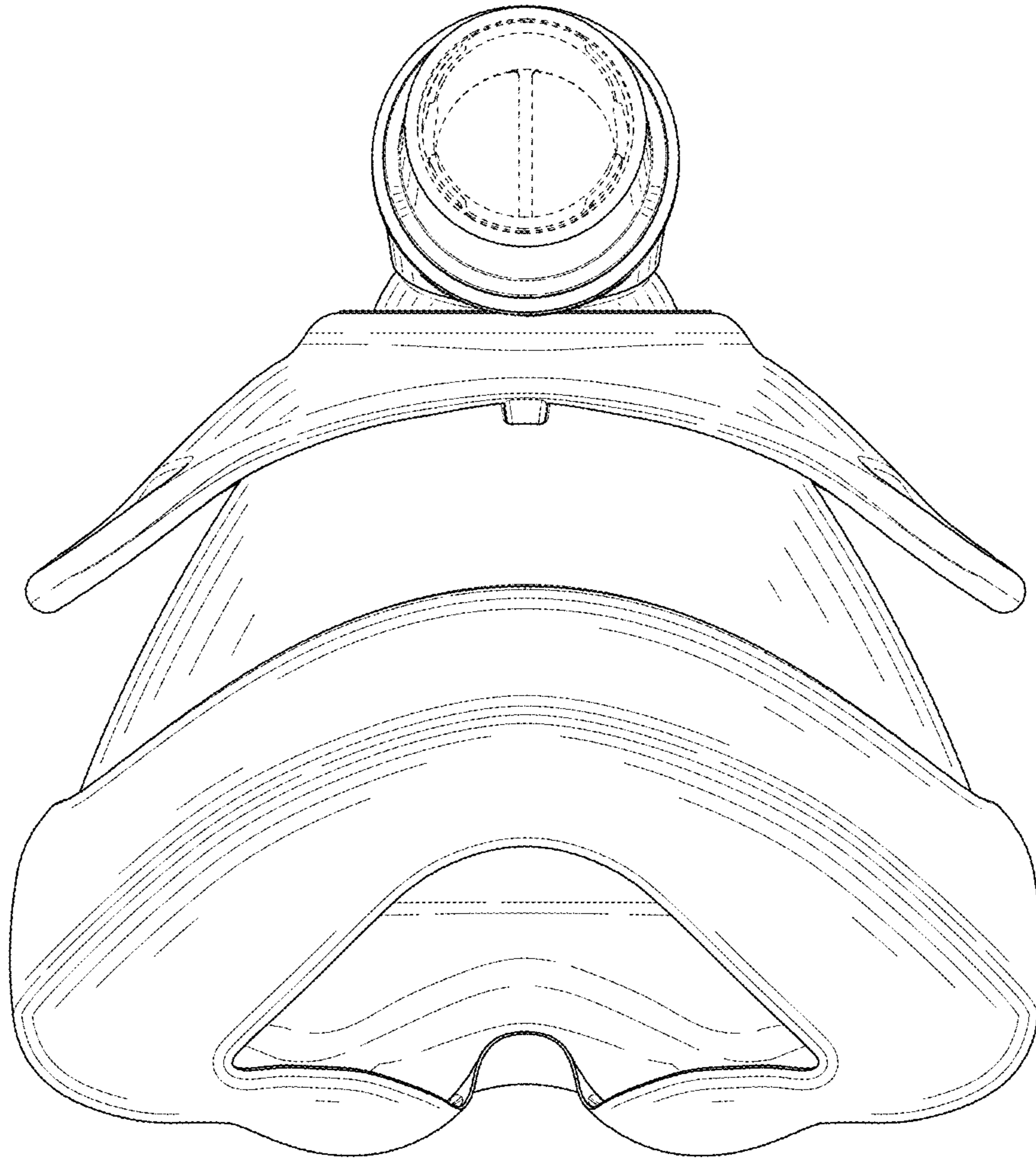
