The ornamental design for a menstrual cup, as shown and described.

**DESCRIPTION**

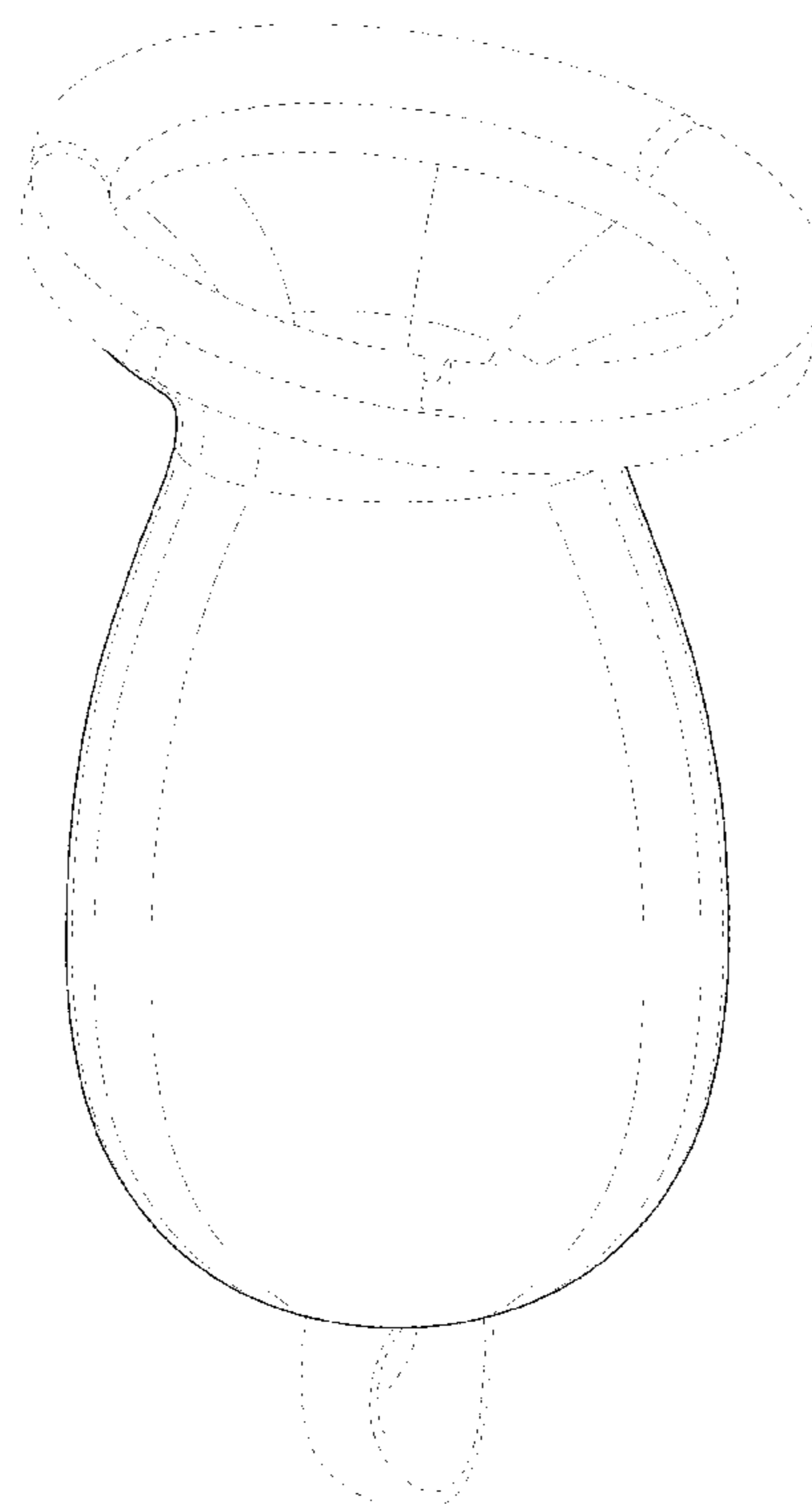

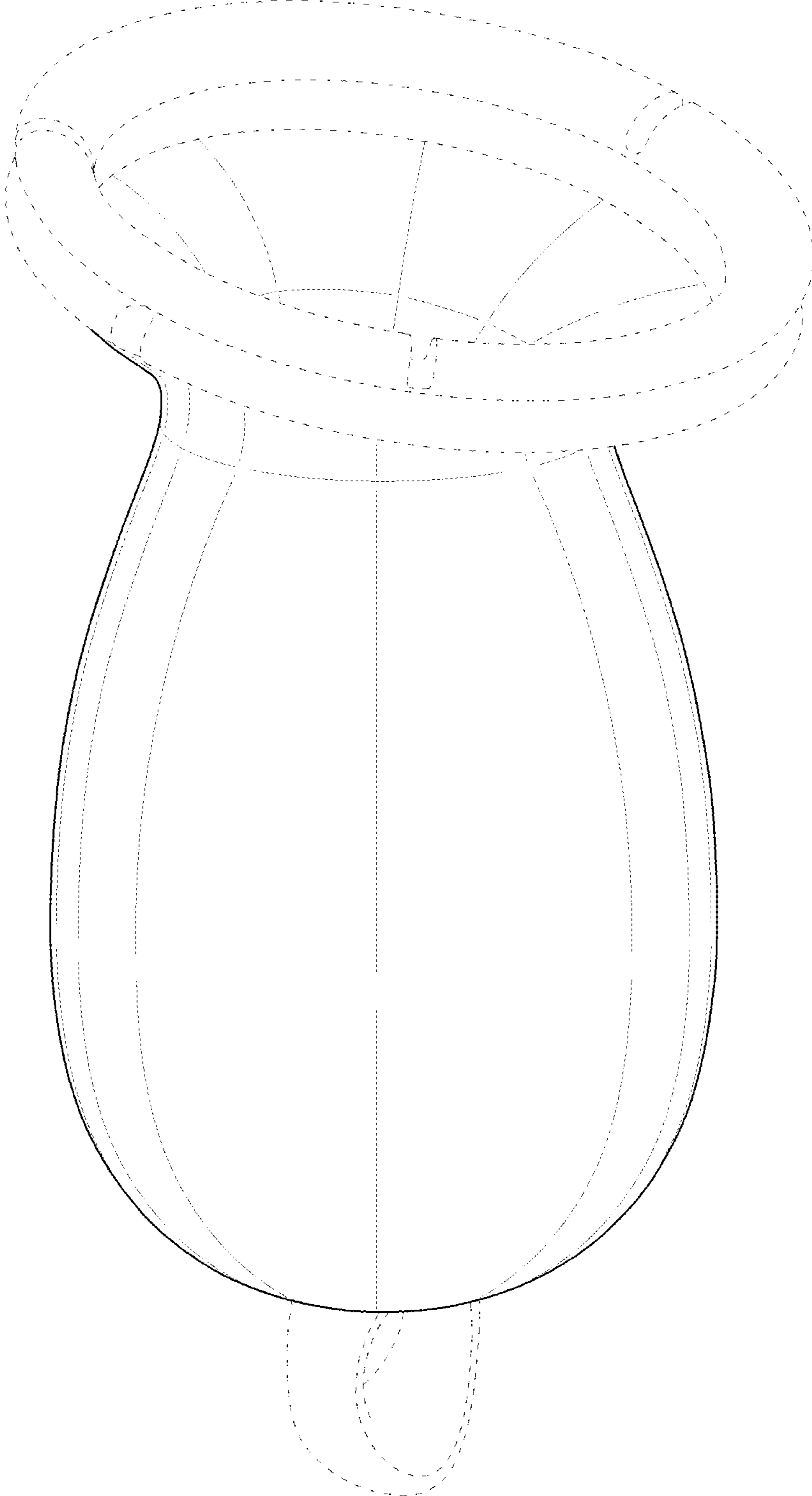

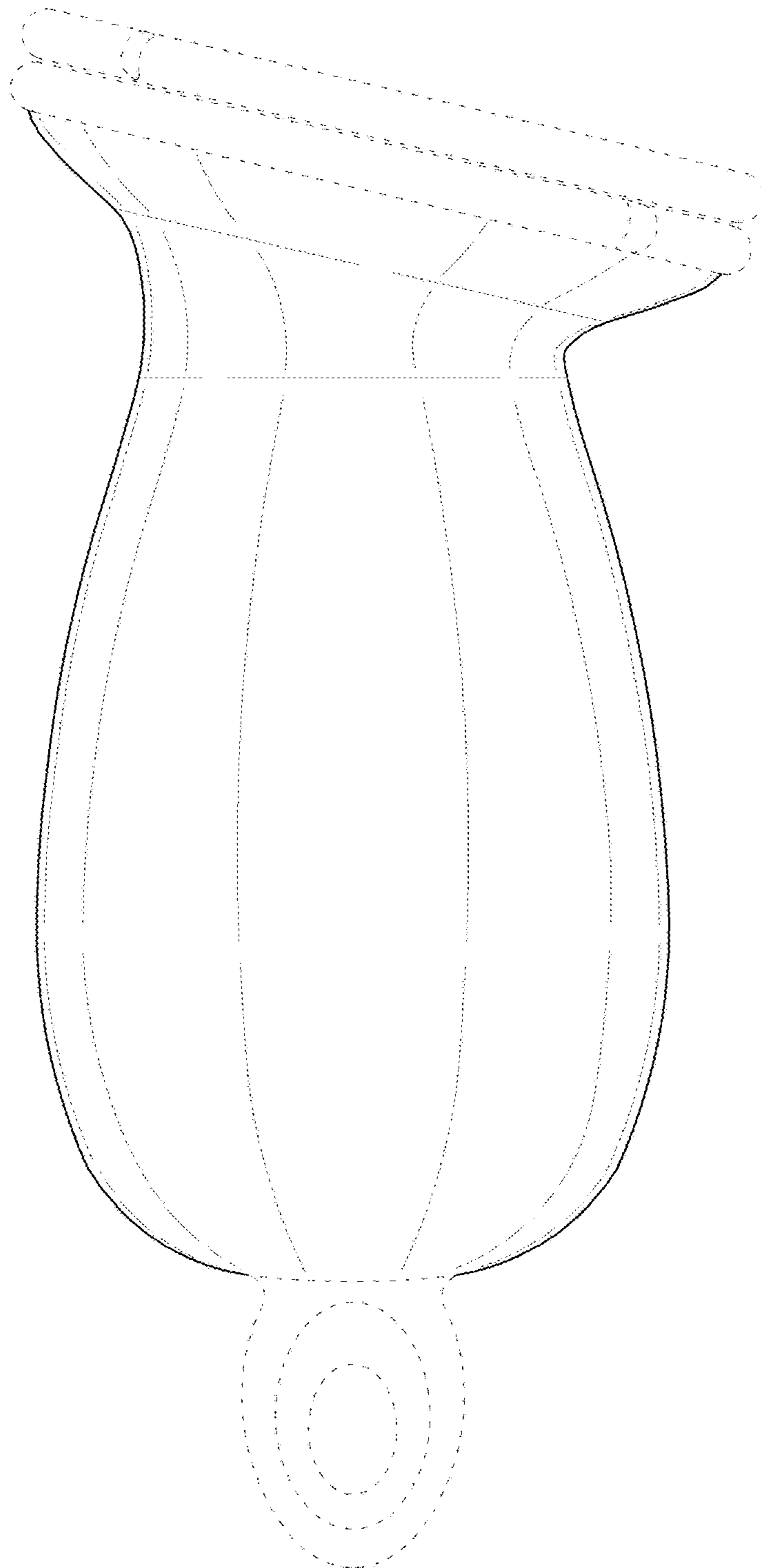

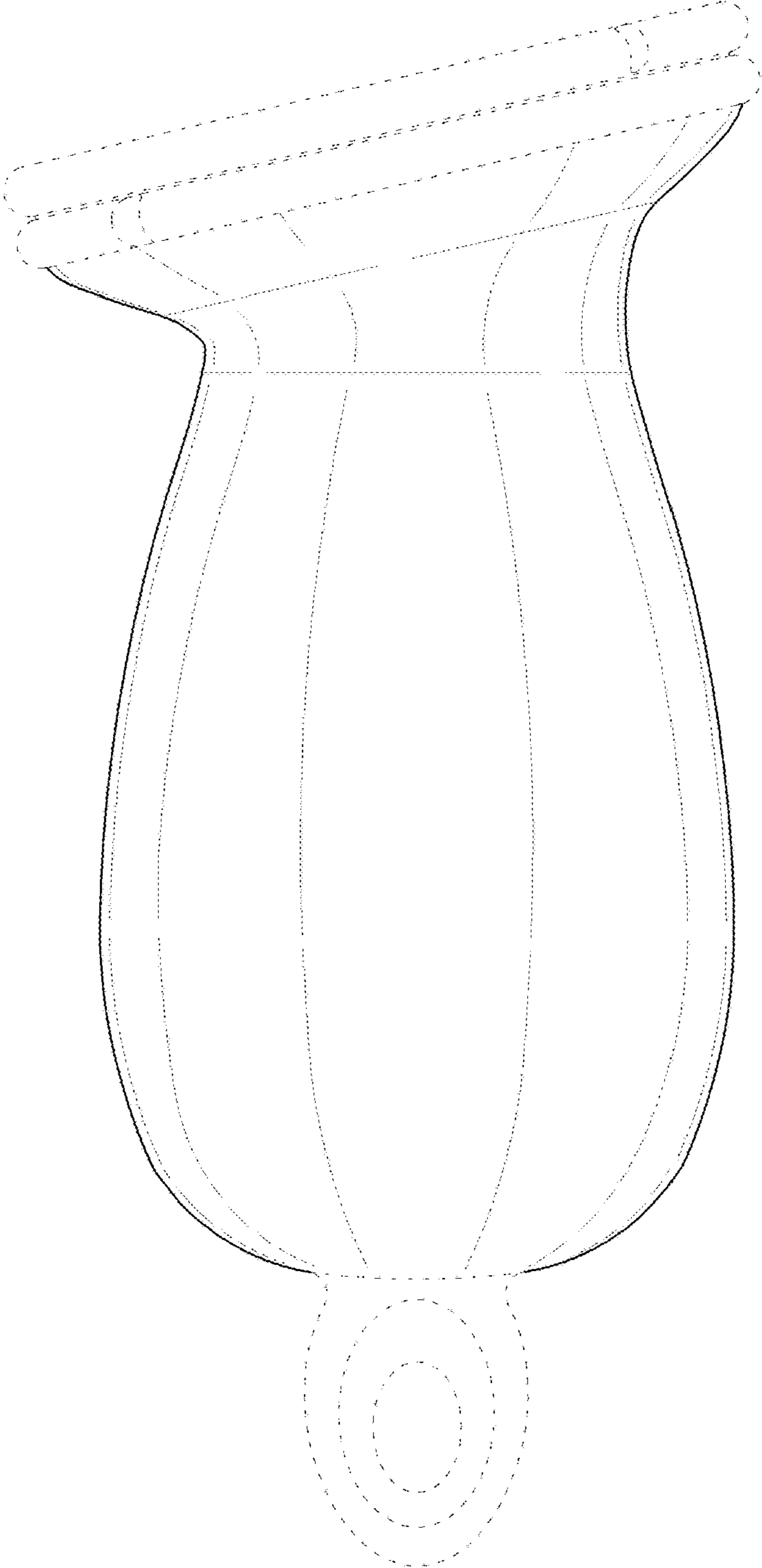

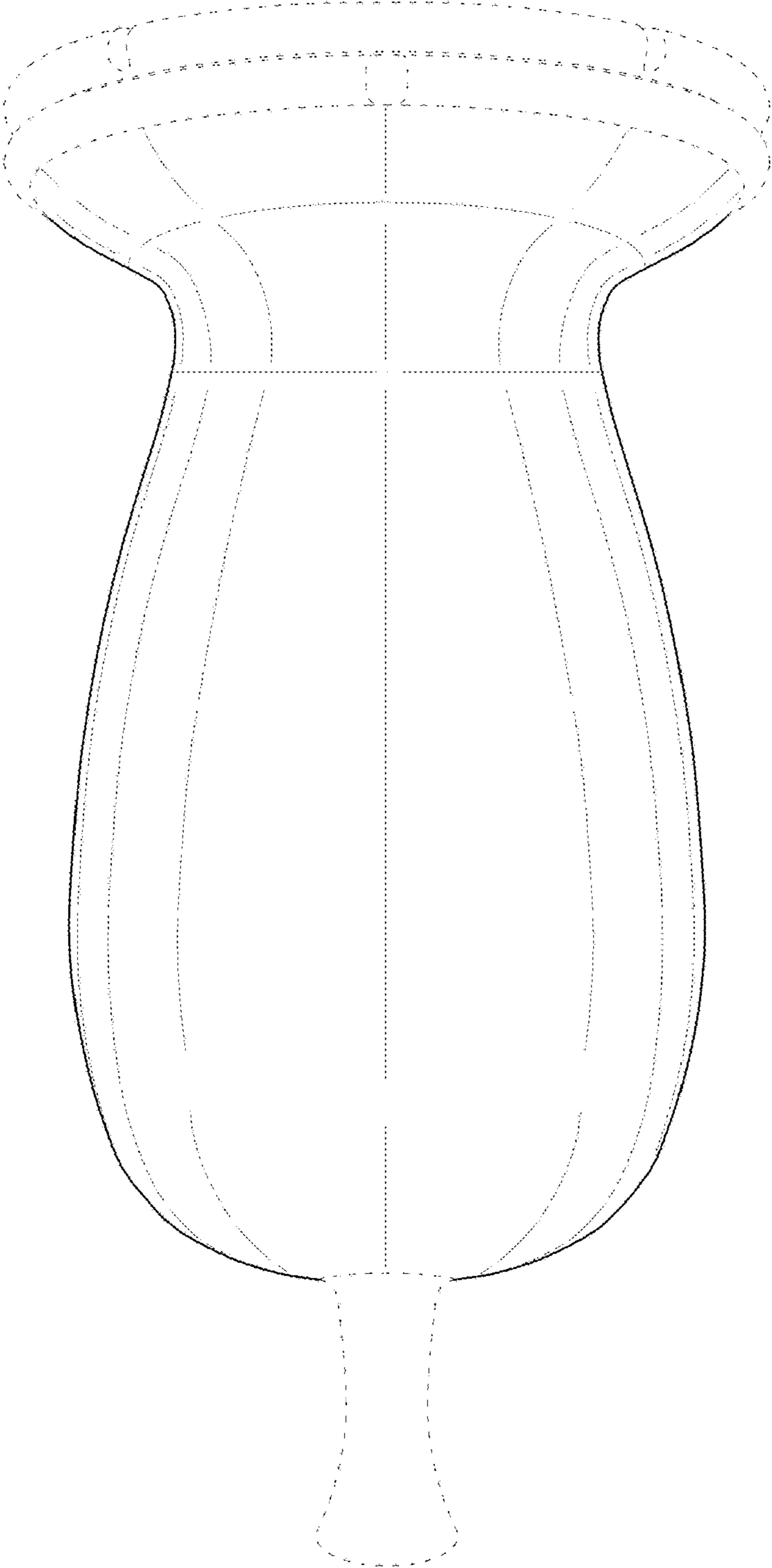

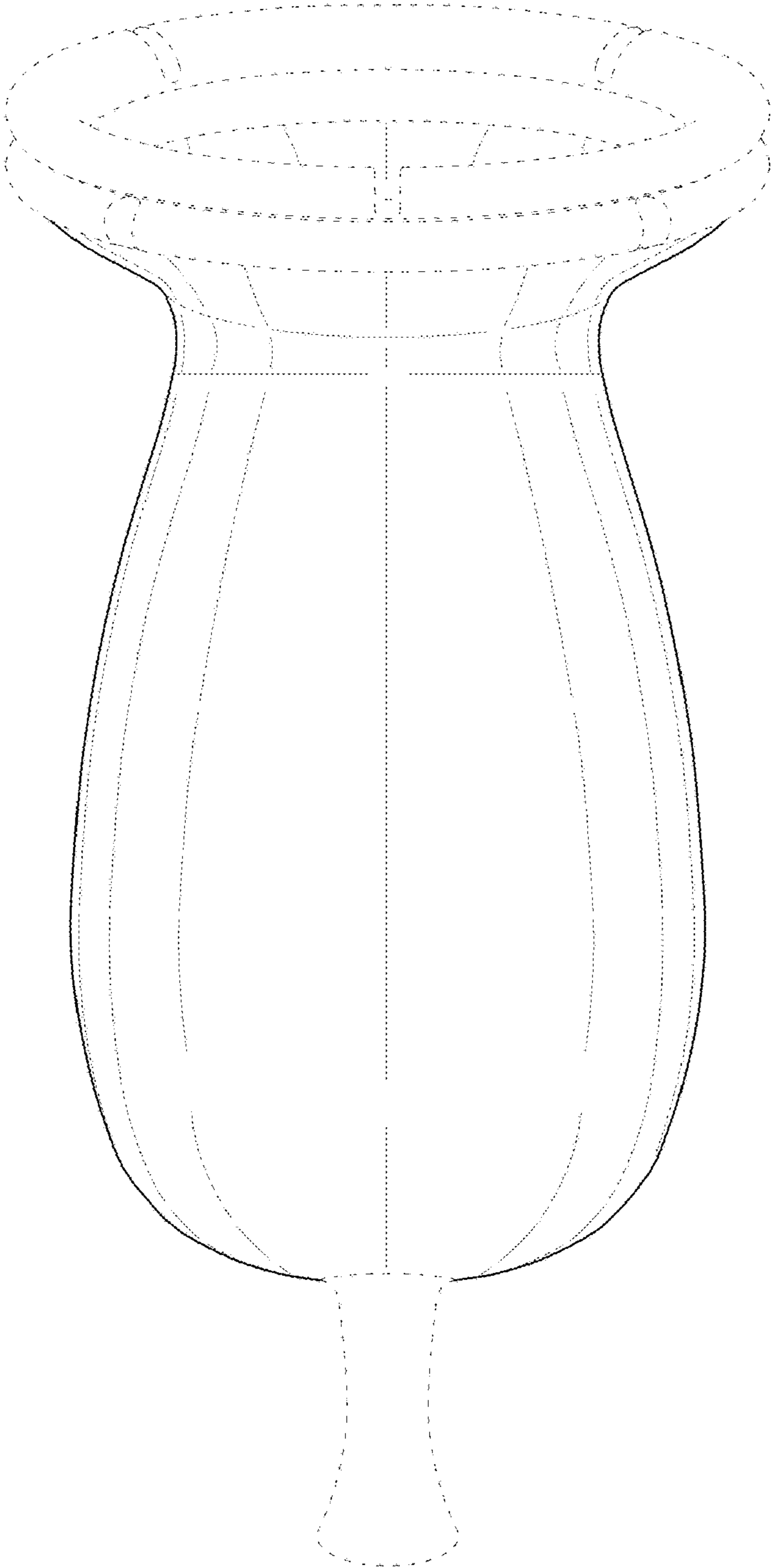

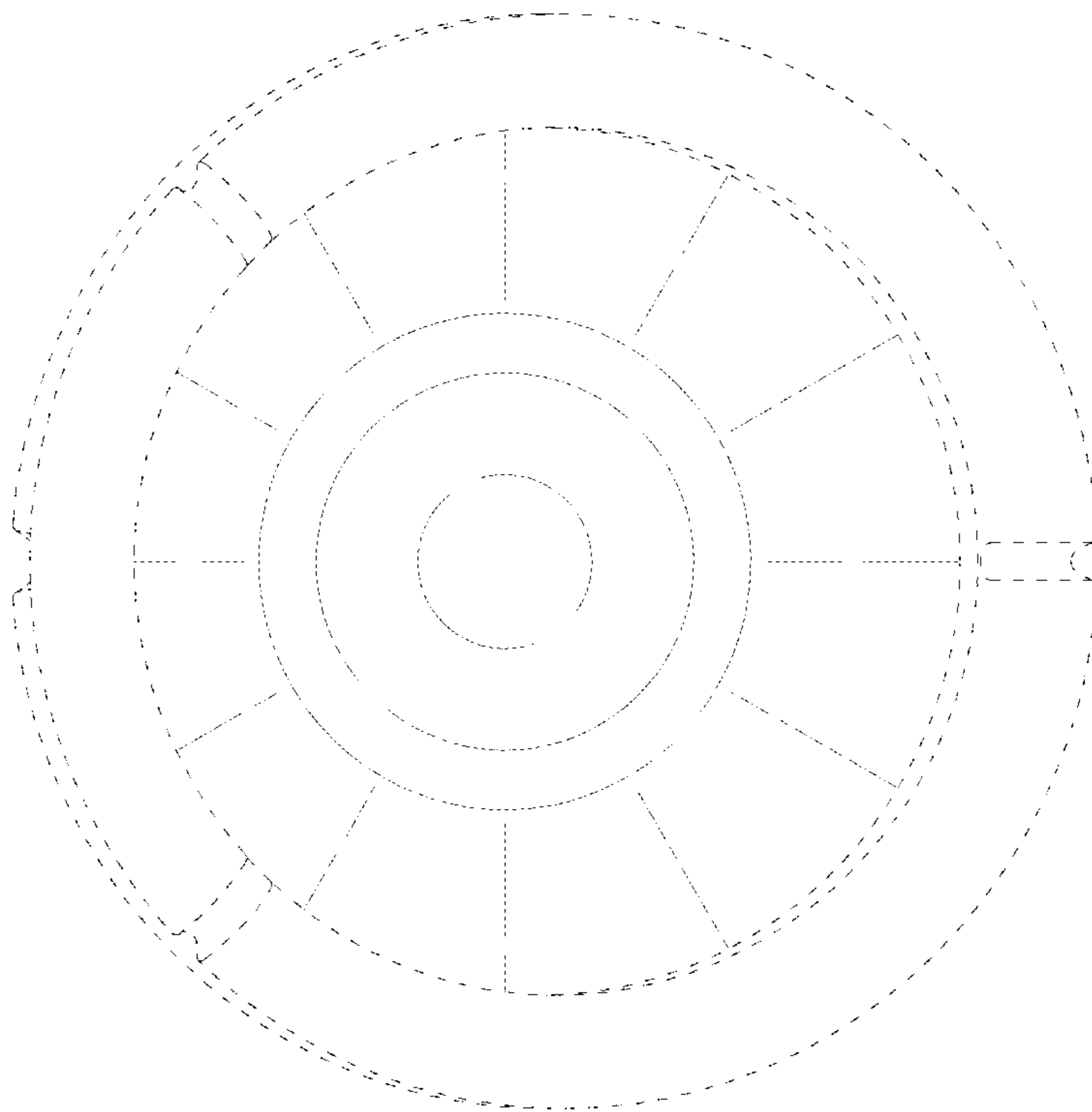
