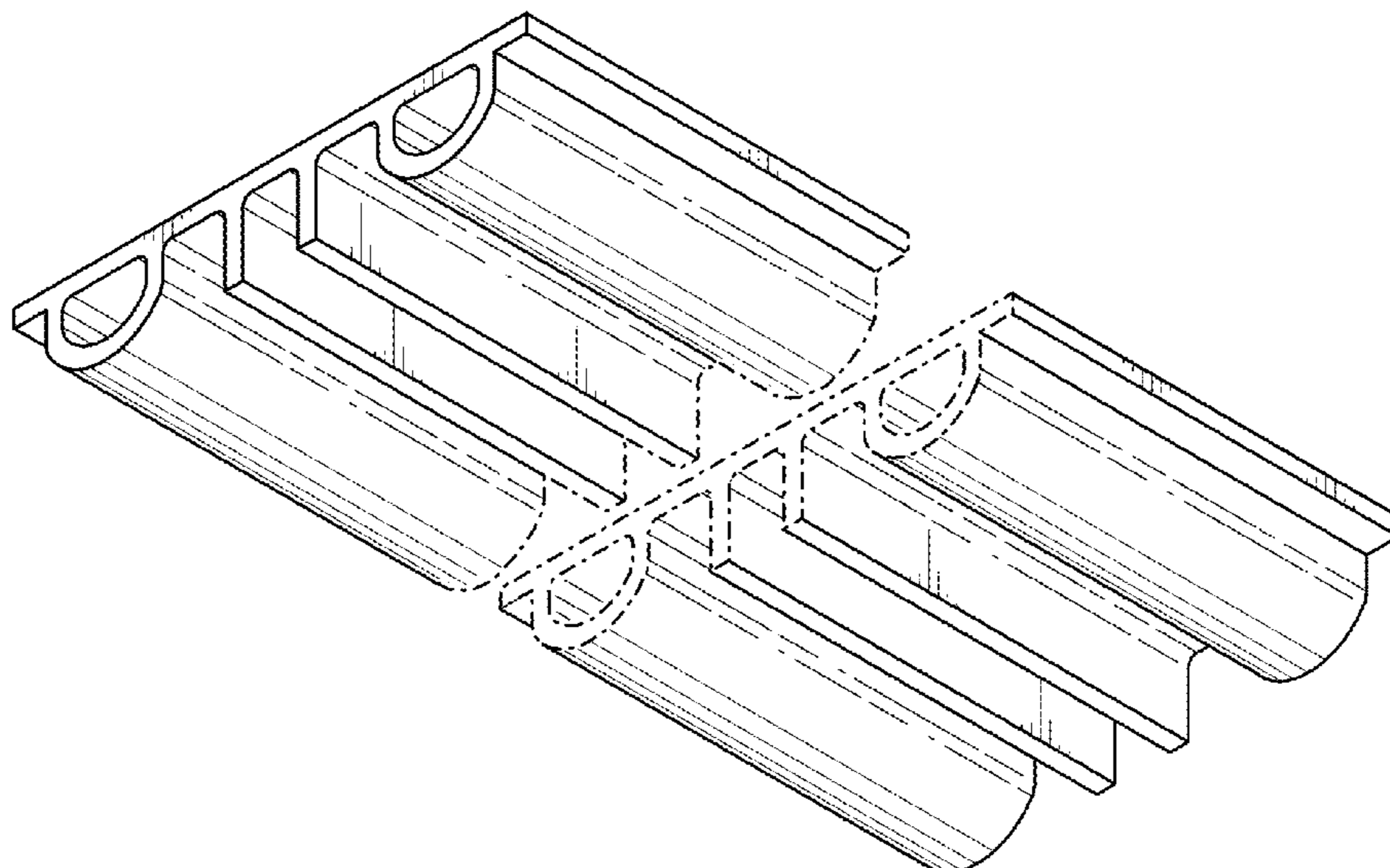
(57) **CLAIM**

The design for an insert for a door seal assembly, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view from below, to the front and to one side of an insert for a door seal assembly;  
FIG. 2 is a front view thereof, with a rear view being identical thereto;  
FIG. 3 is a left side view thereof, with a right side view being identical thereto;  
FIG. 4 is a top view thereof; and,  
FIG. 5 is a bottom view thereof.  
In the drawings, the break lines depict the bounds of the claim. The area between the break lines forms no part of the claimed design.

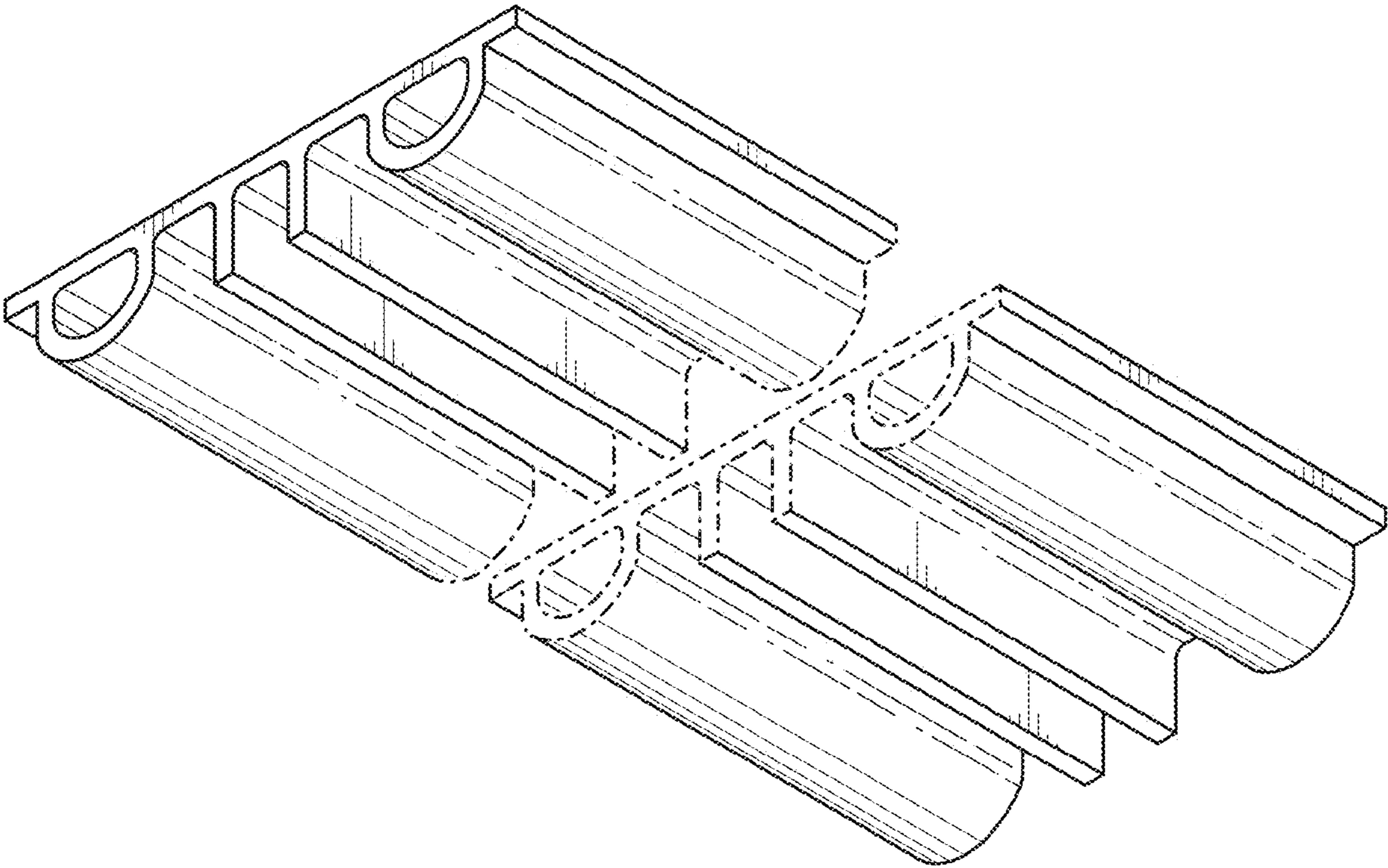

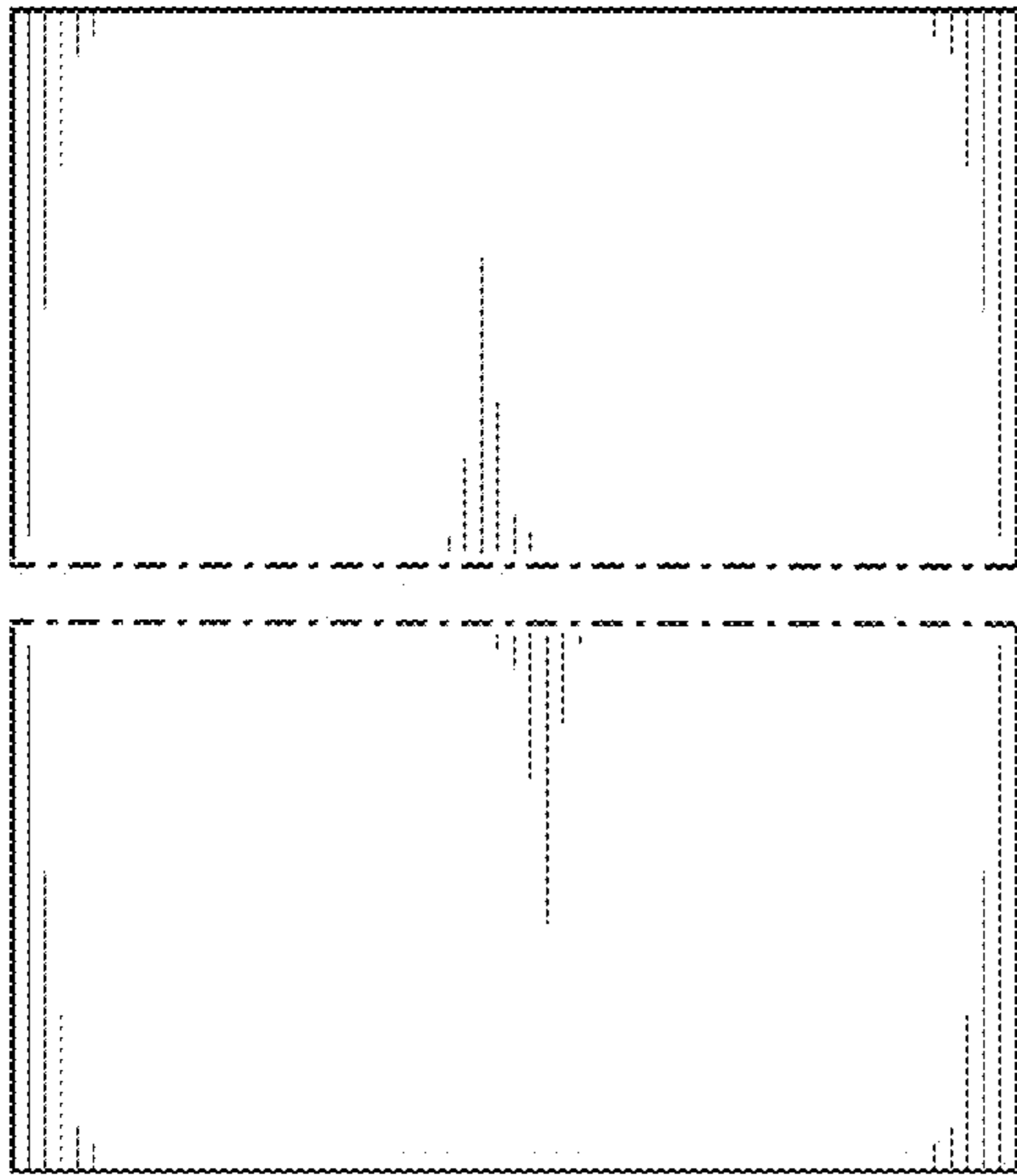

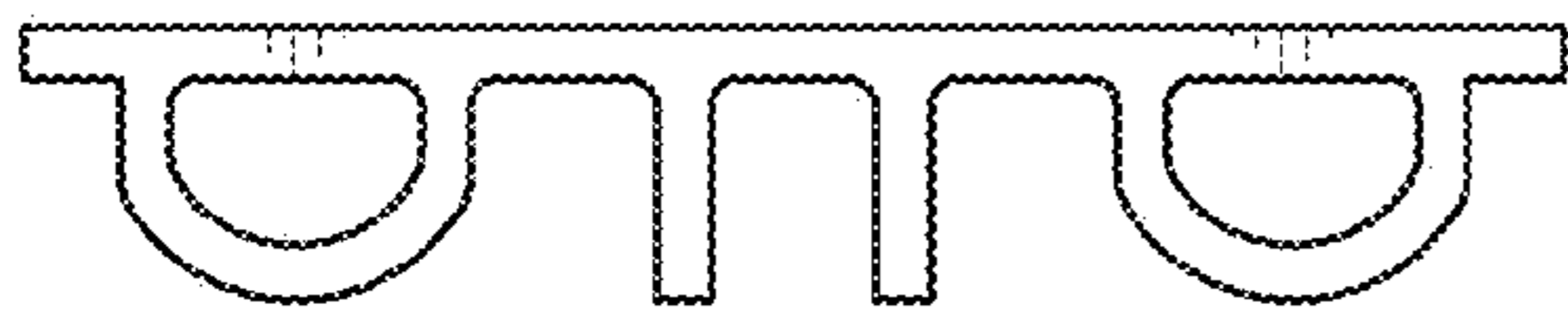

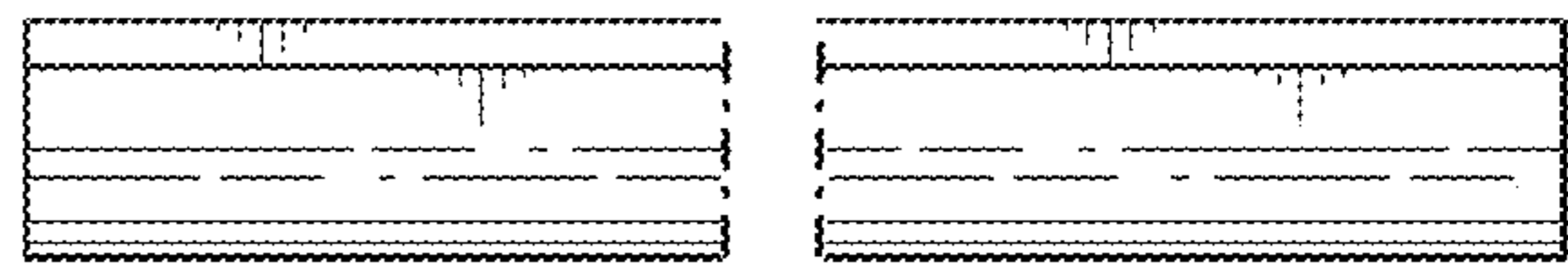

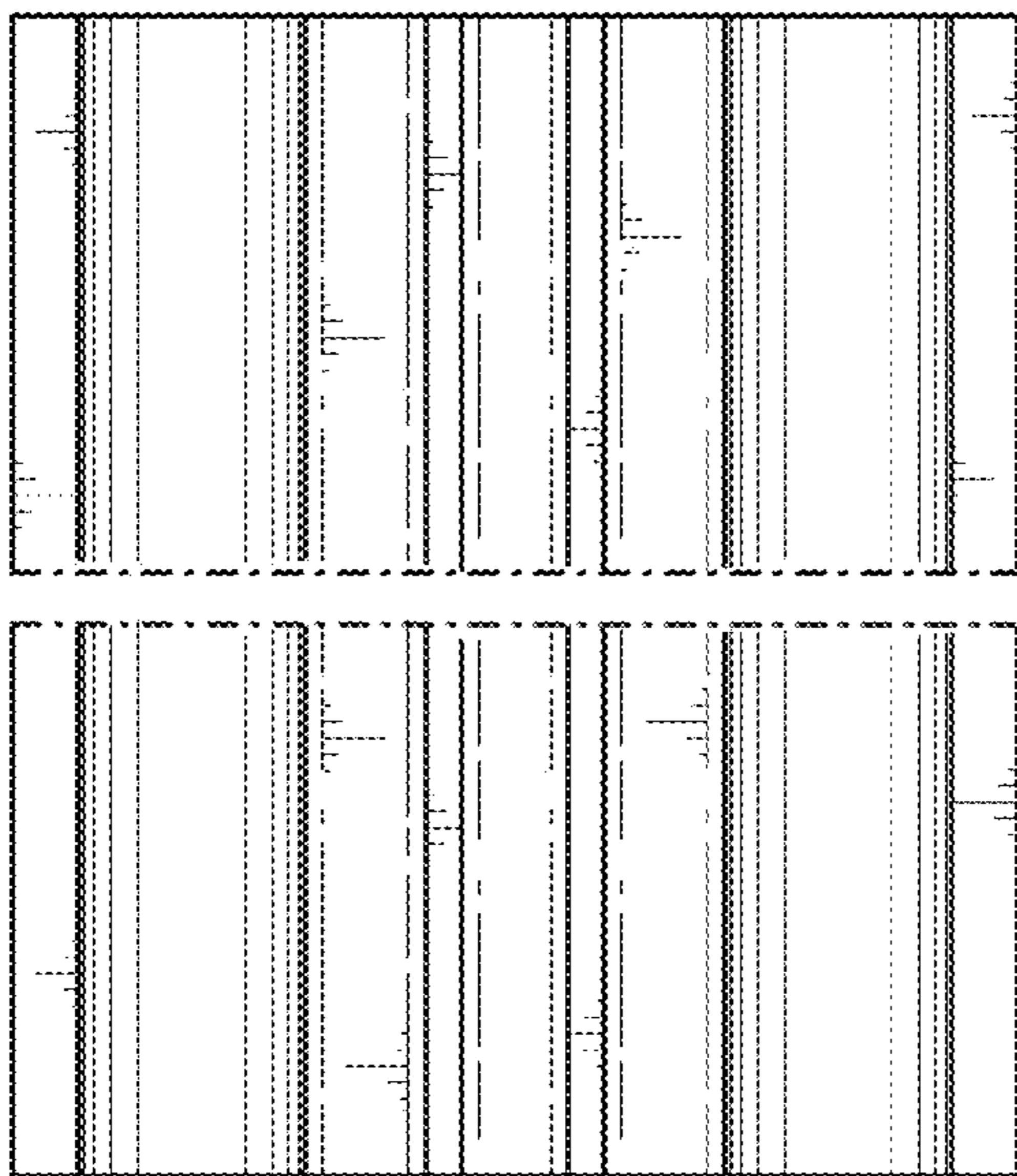
