FIG. 1 is a rear and left side perspective view of a vehicle tail light.

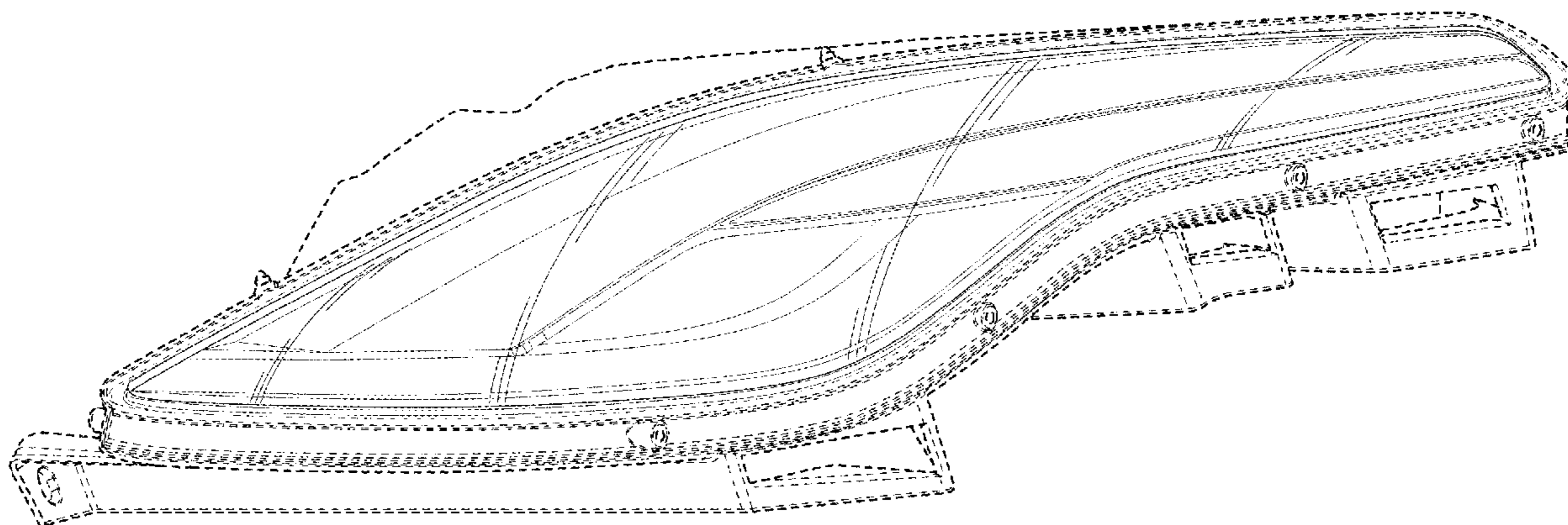
FIG. 2 is a rear view of the vehicle tail light of FIG. 1.

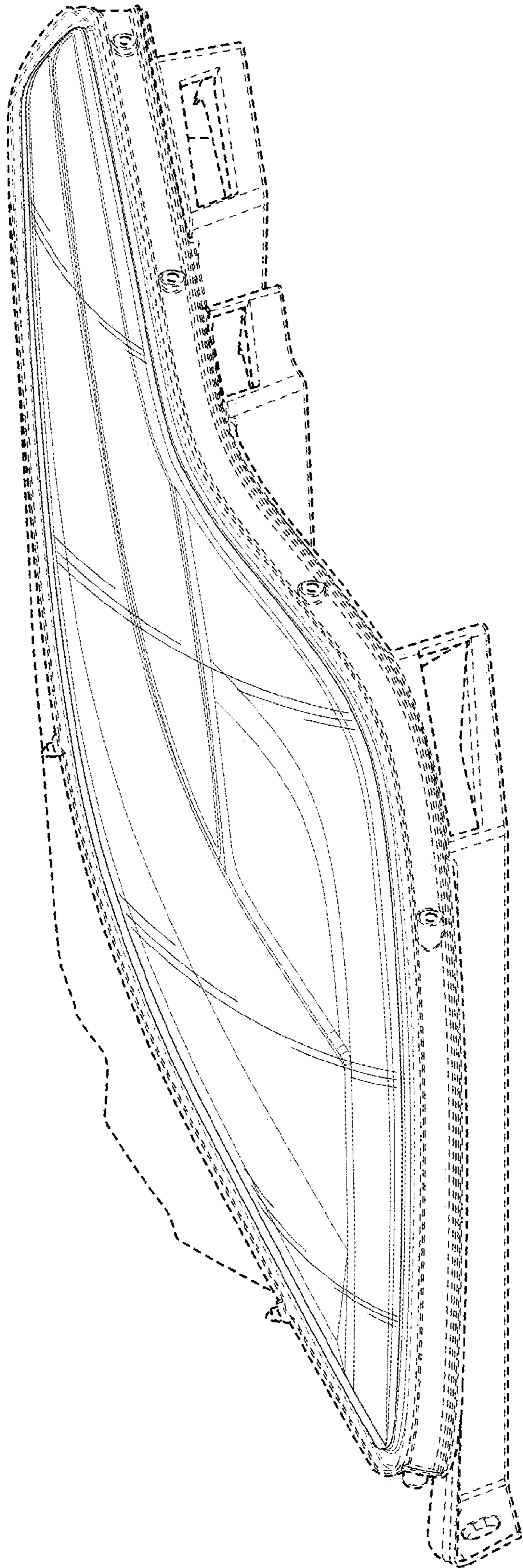

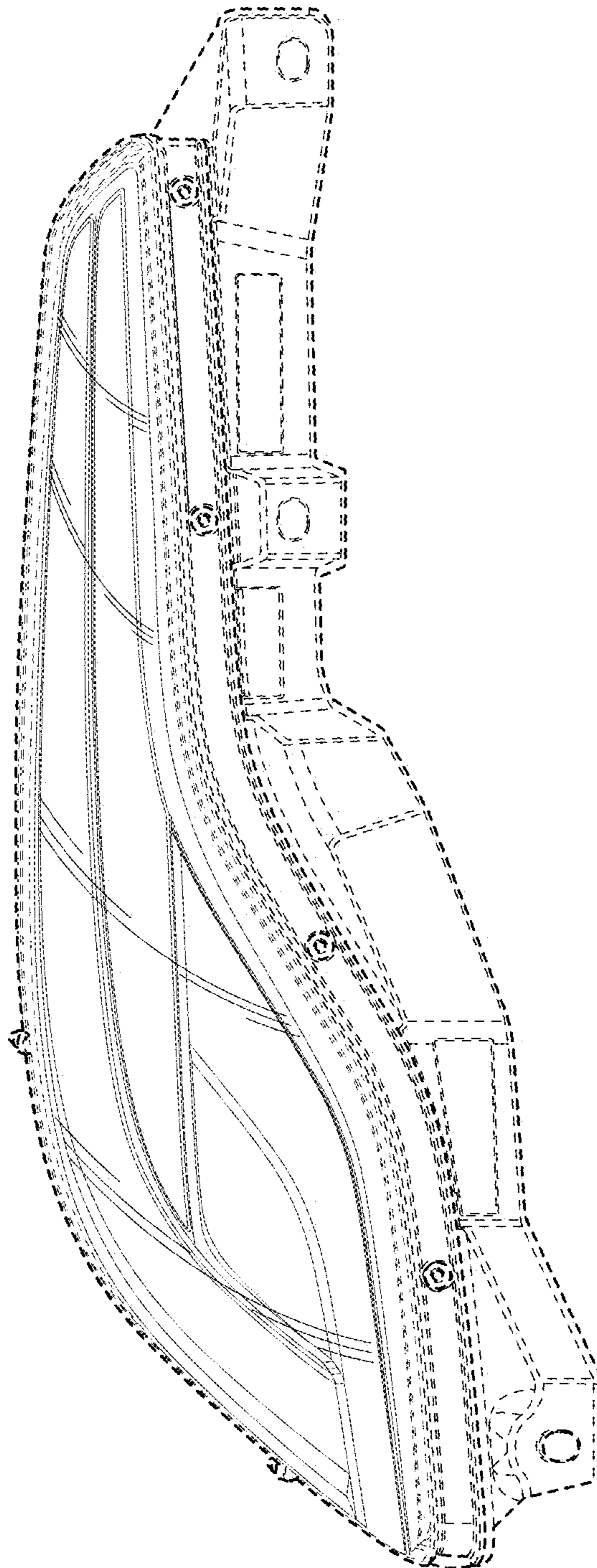

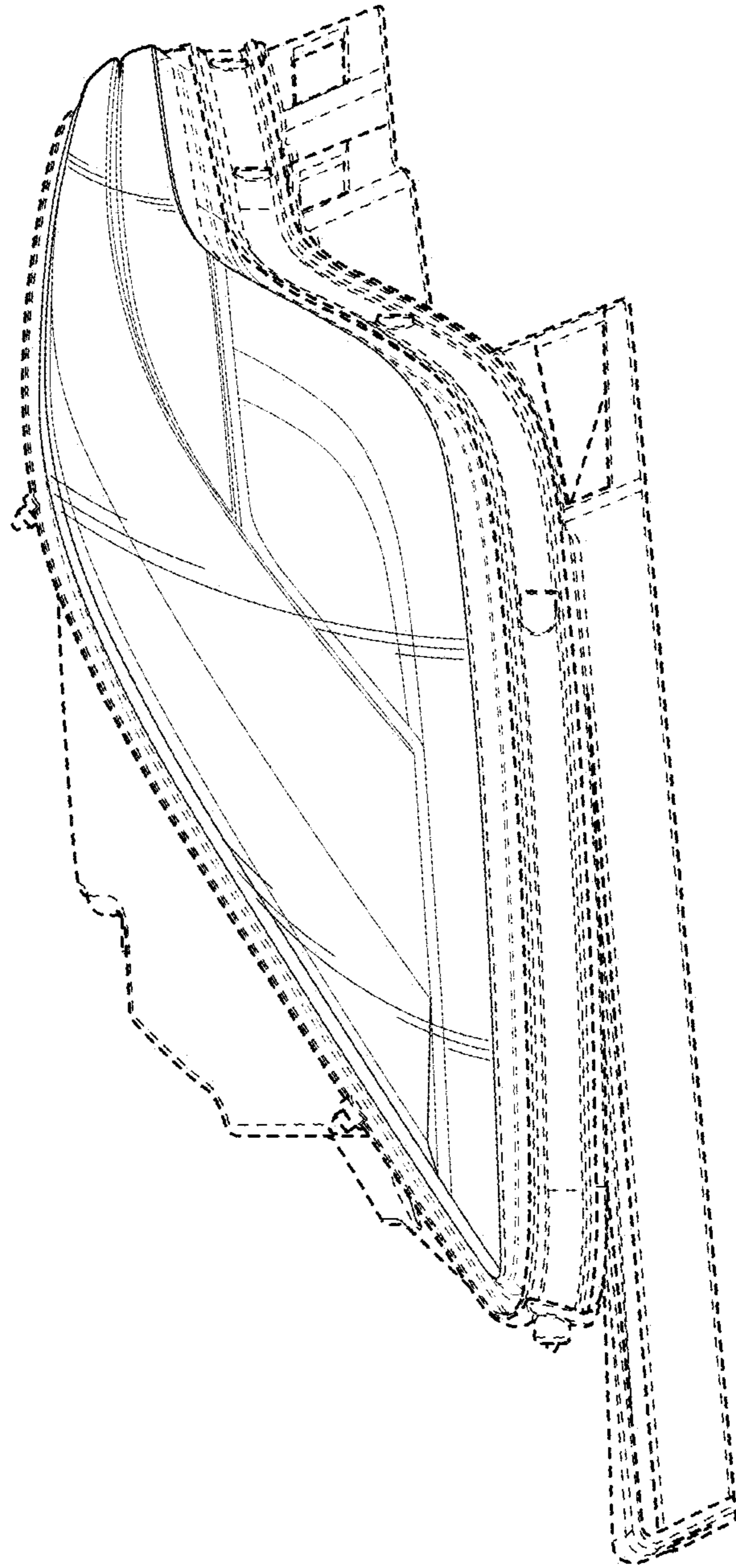

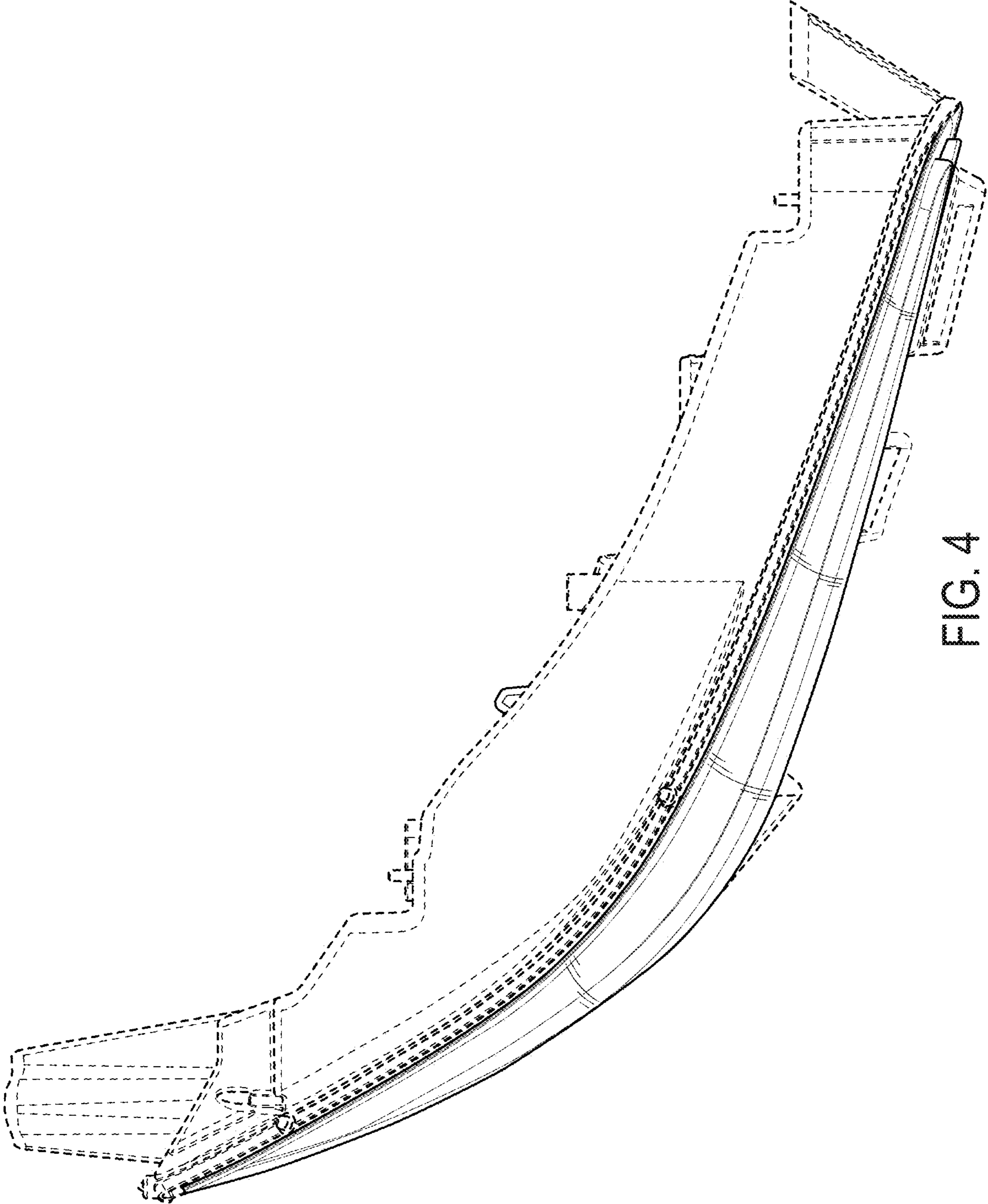
