DESCRIPTION

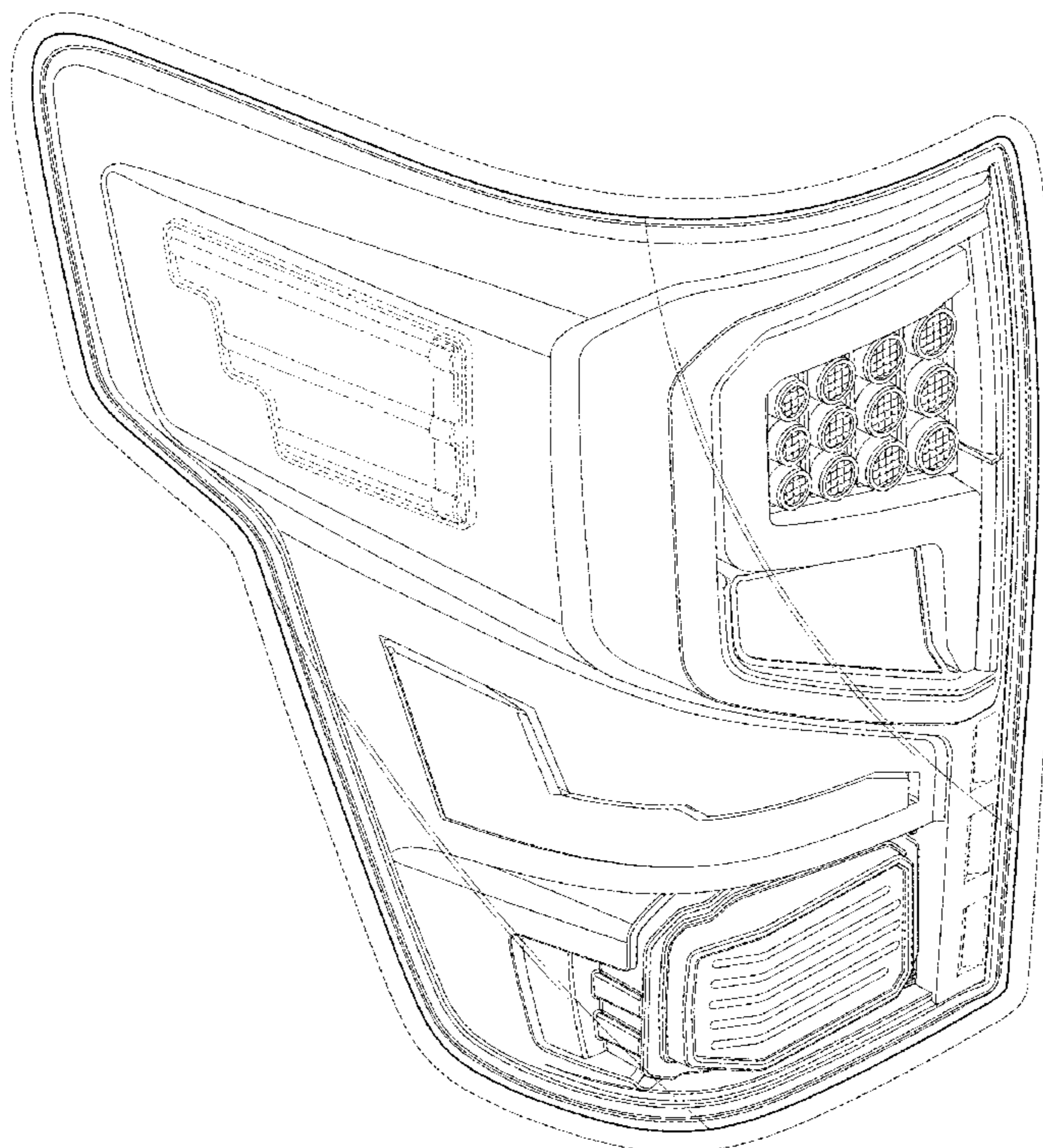
FIG. 1 is a perspective view of a vehicle taillight showing my present design;

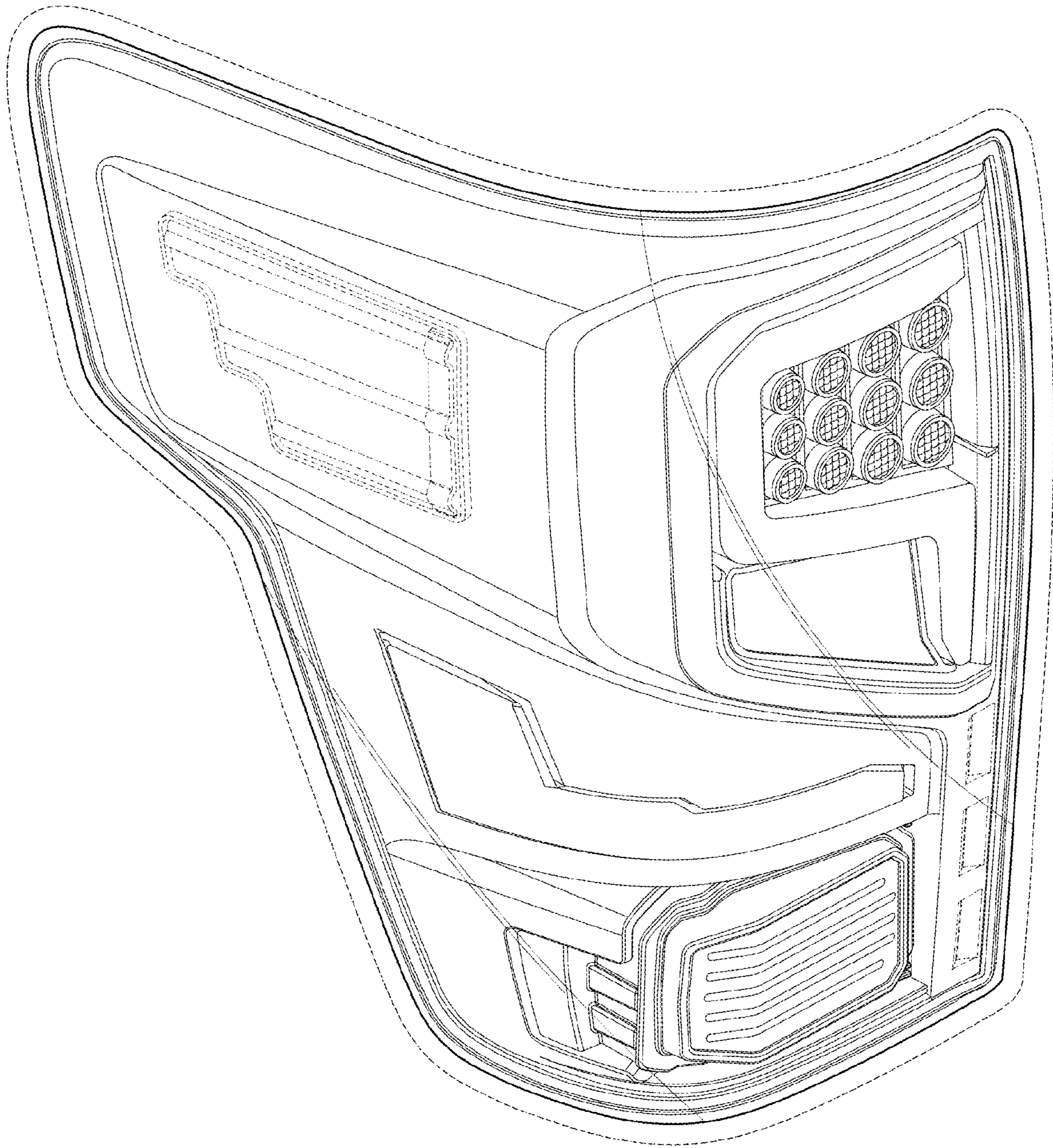

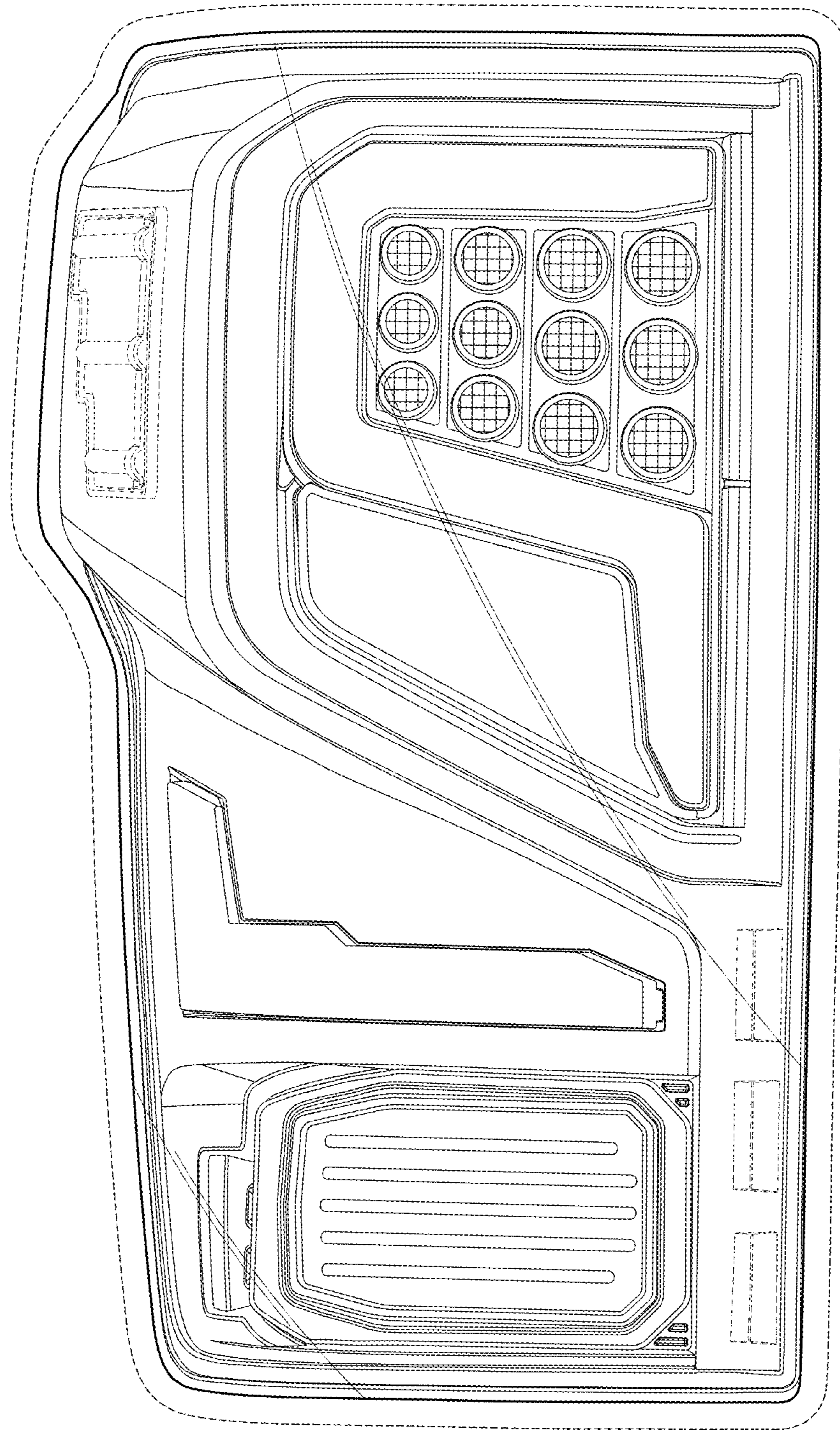

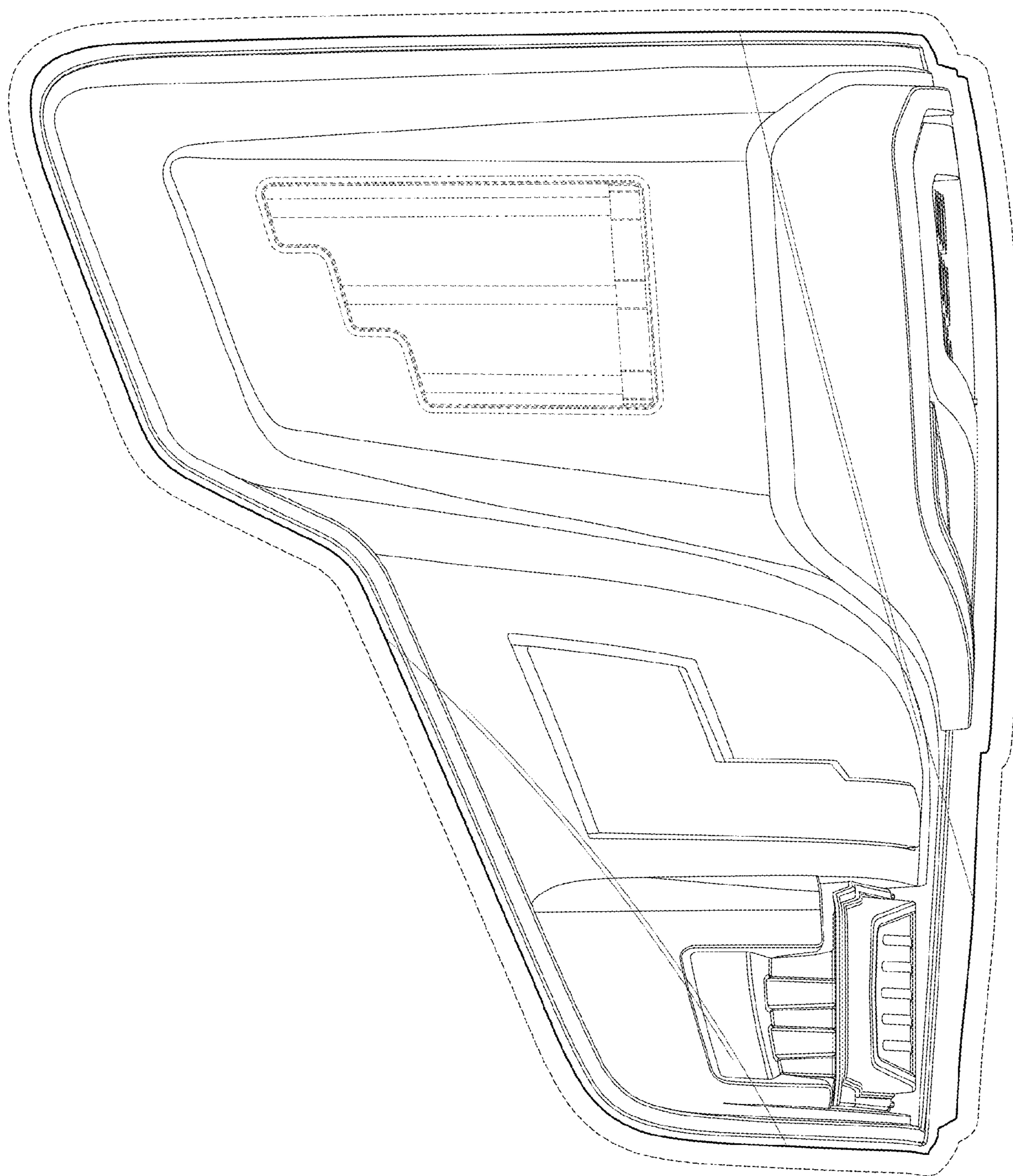

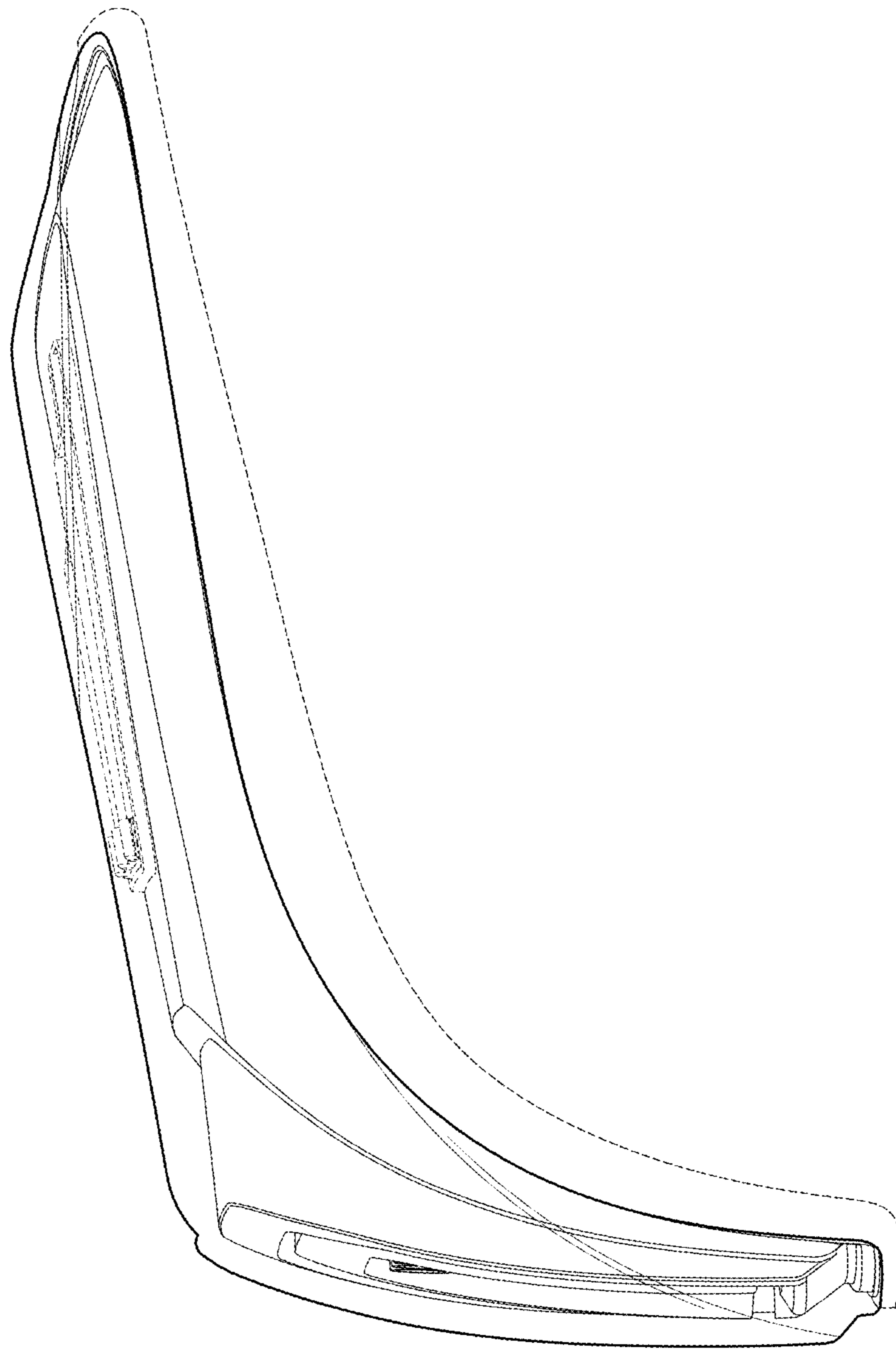

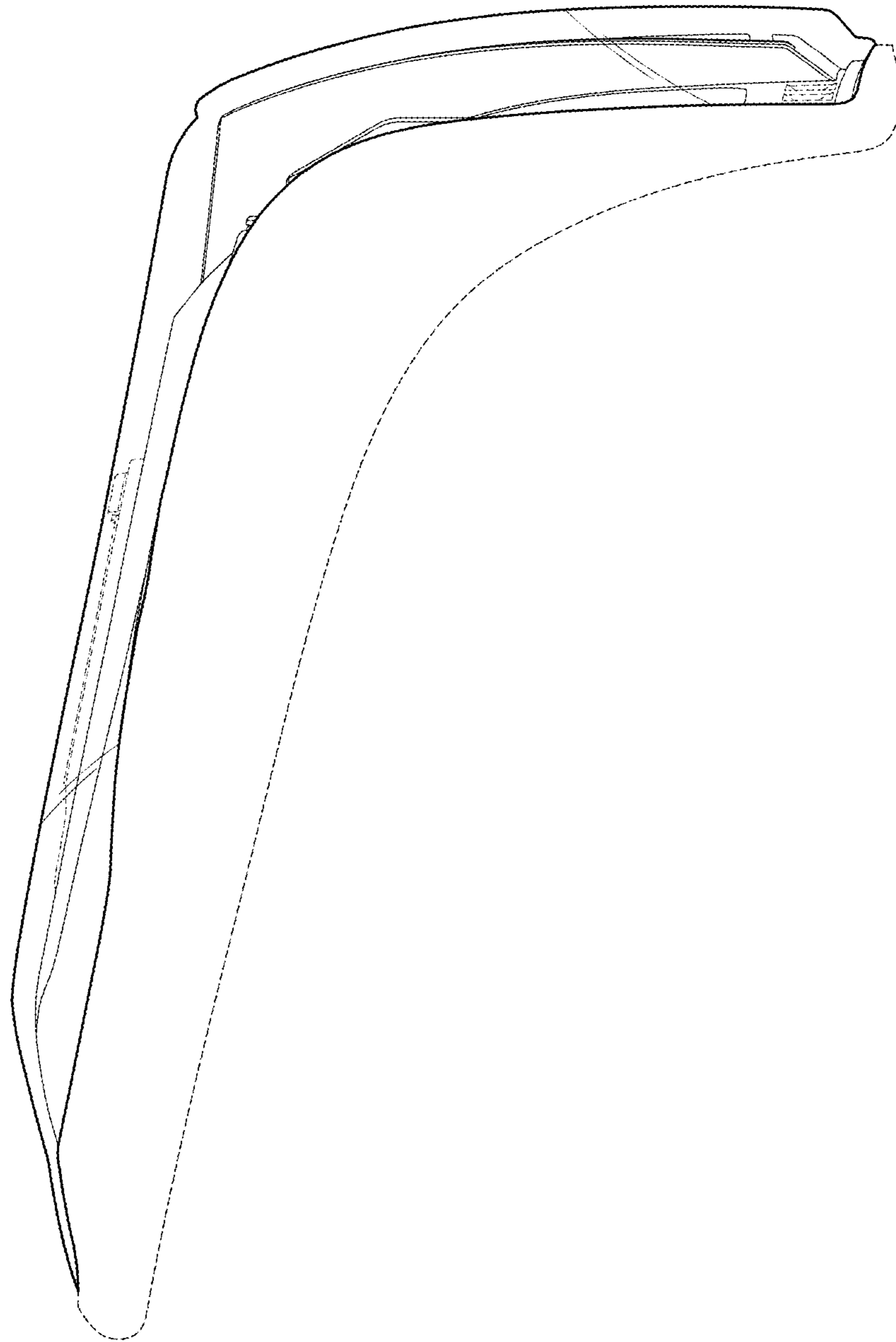

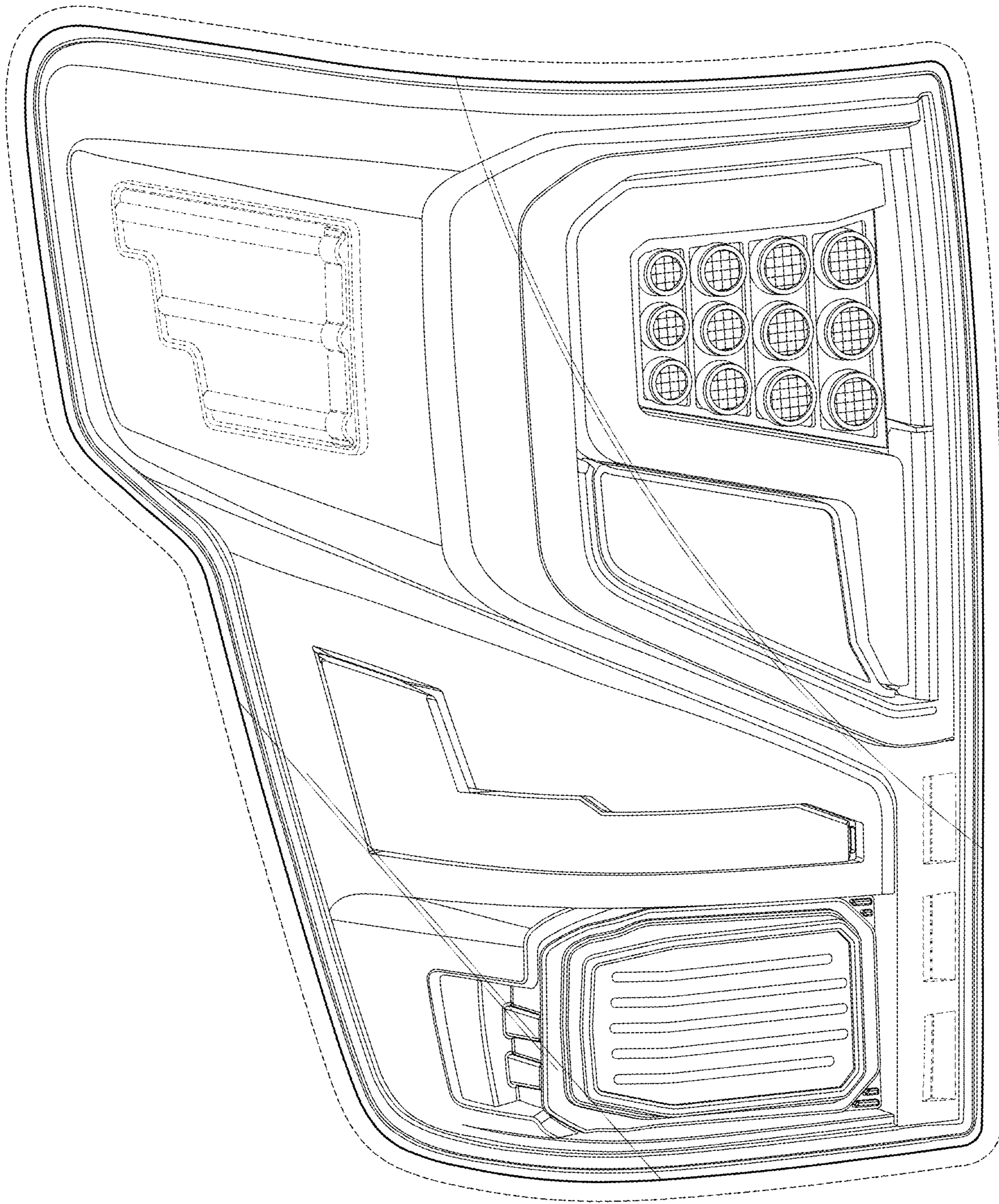
