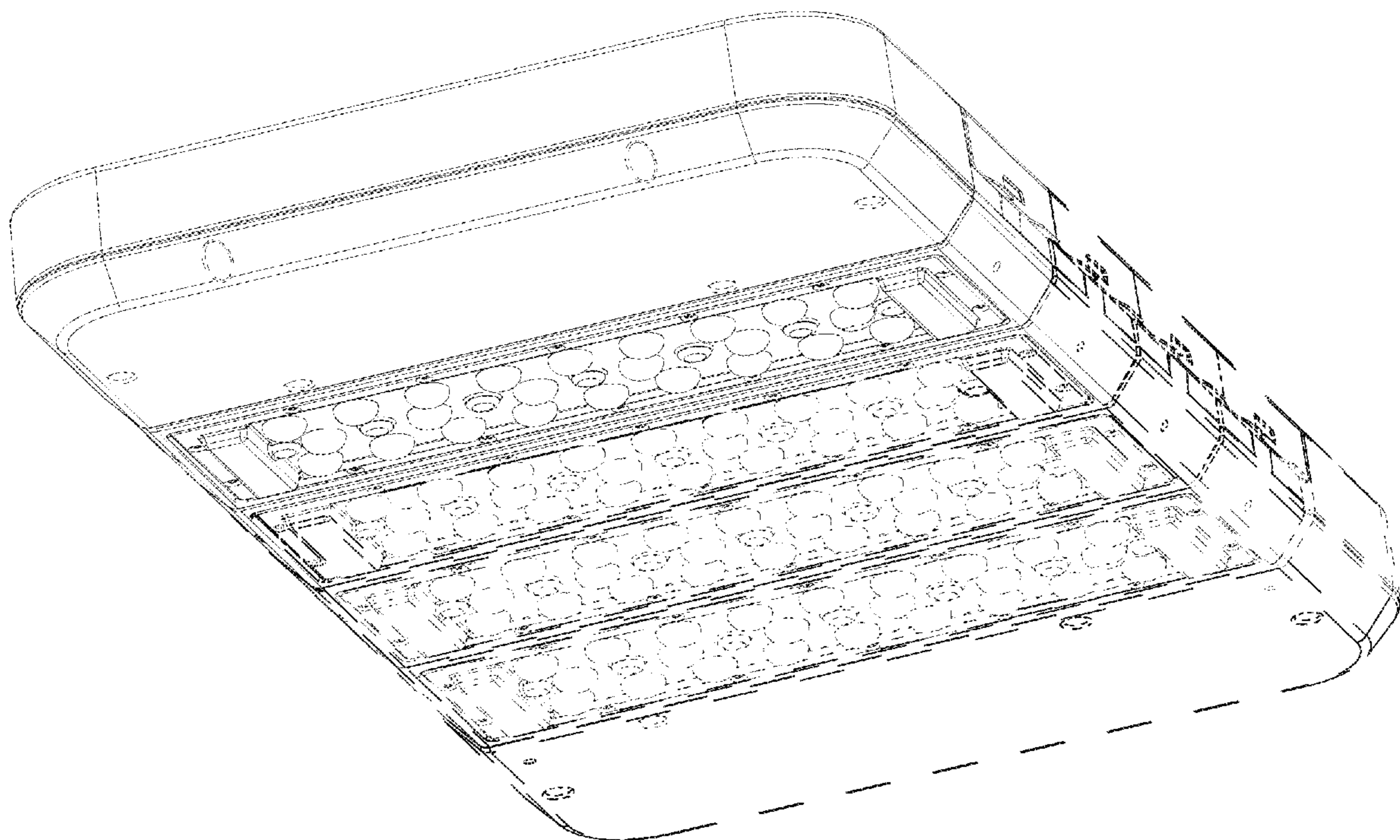
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front, upward perspective view of a modular luminaire;  
FIG. 2 is a front, downward perspective view thereof;

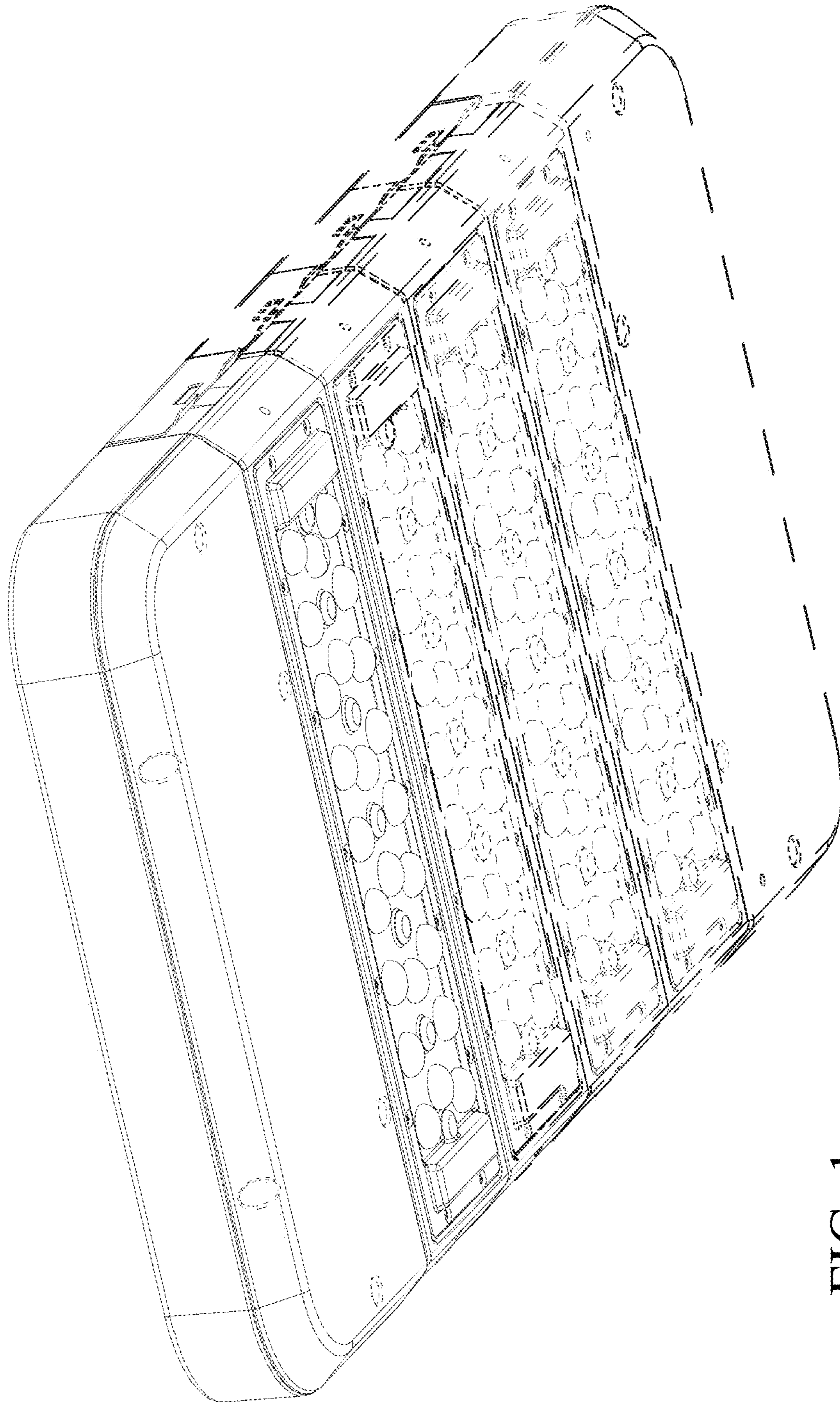

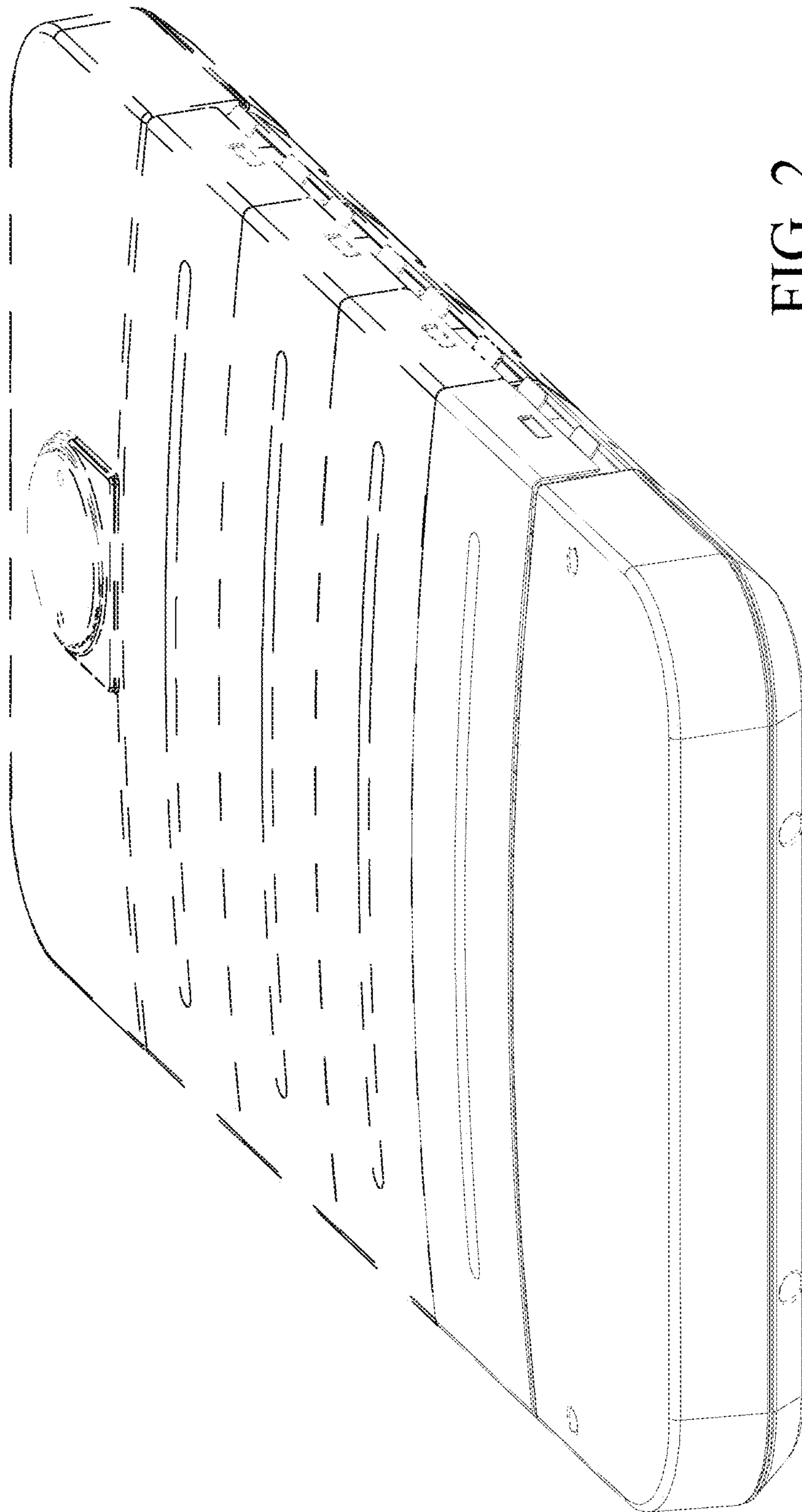

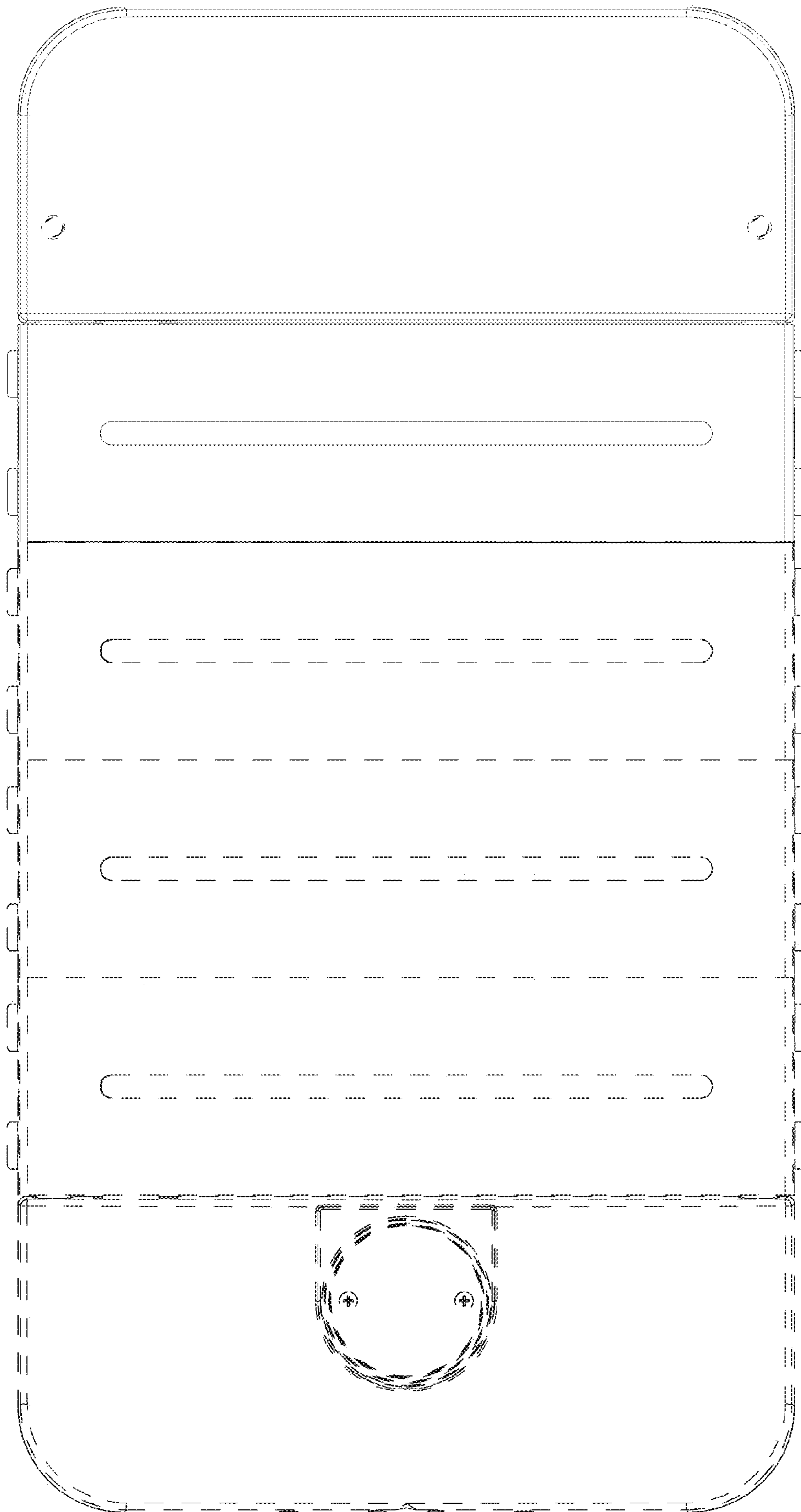

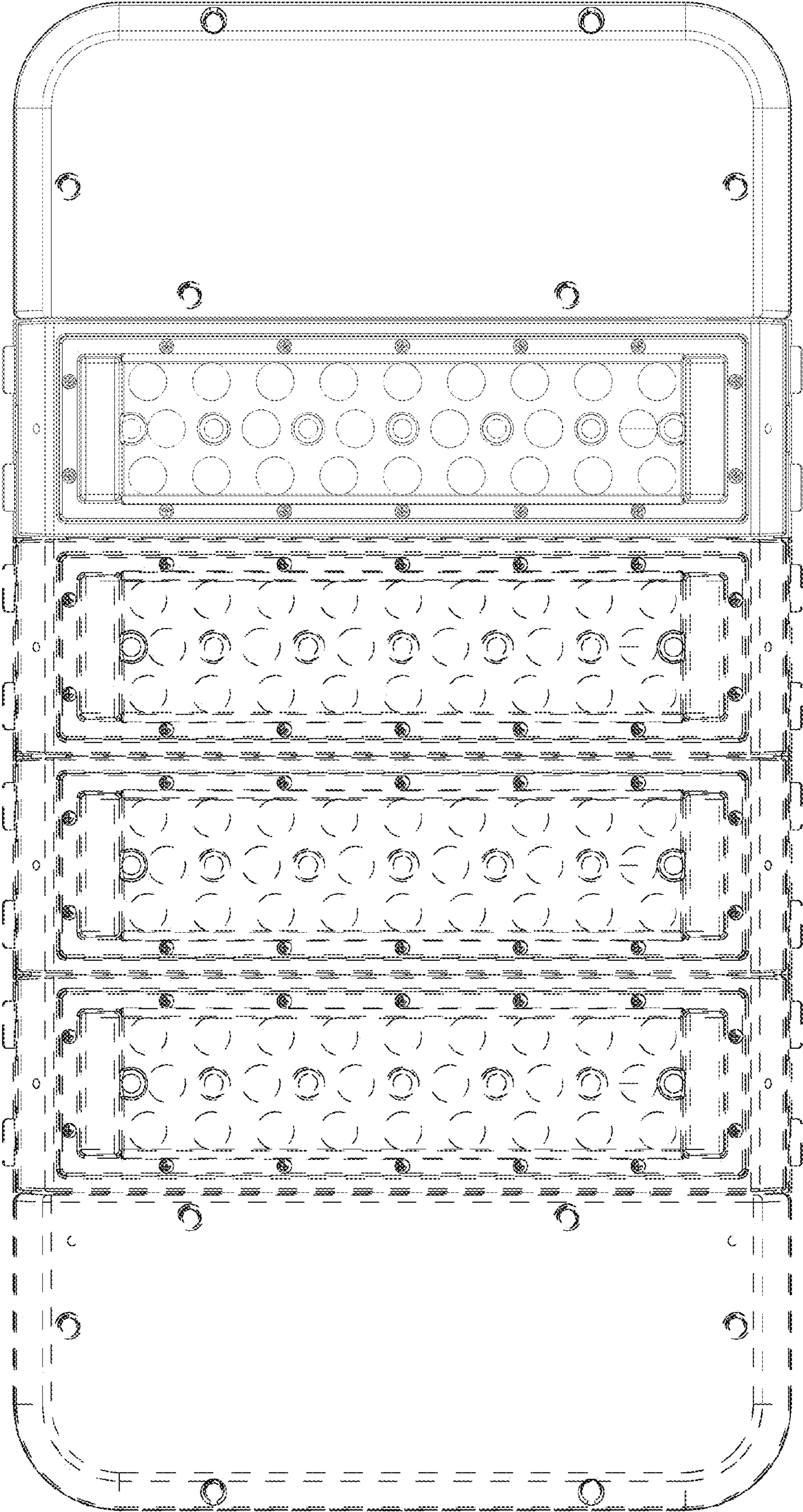

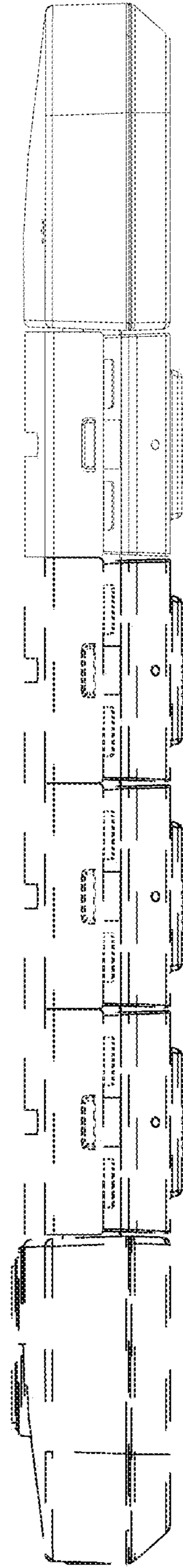

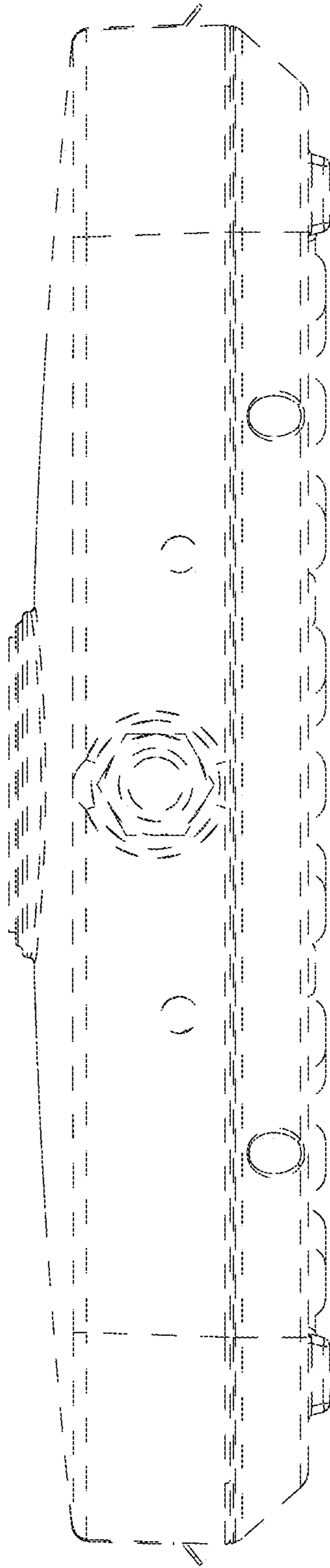

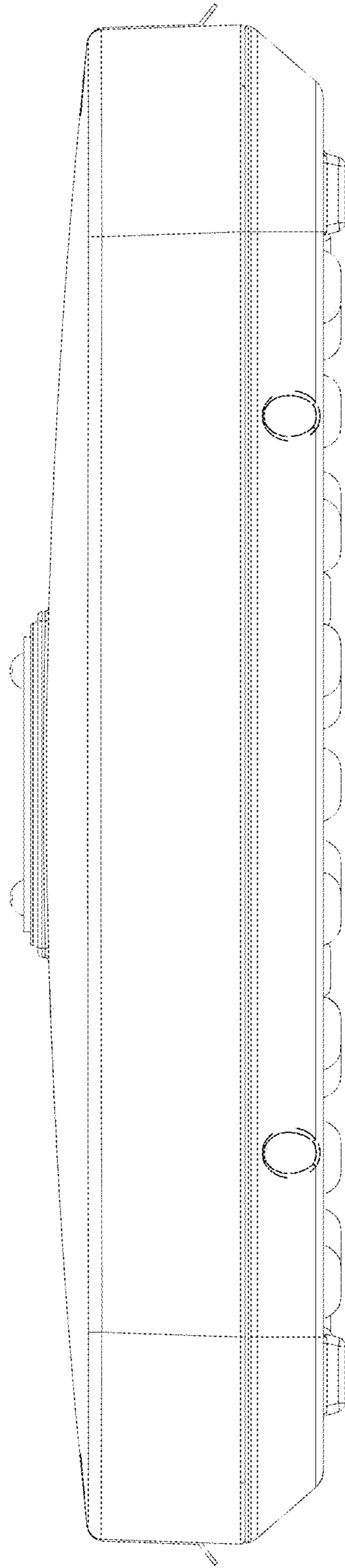
