DESCRIPTION

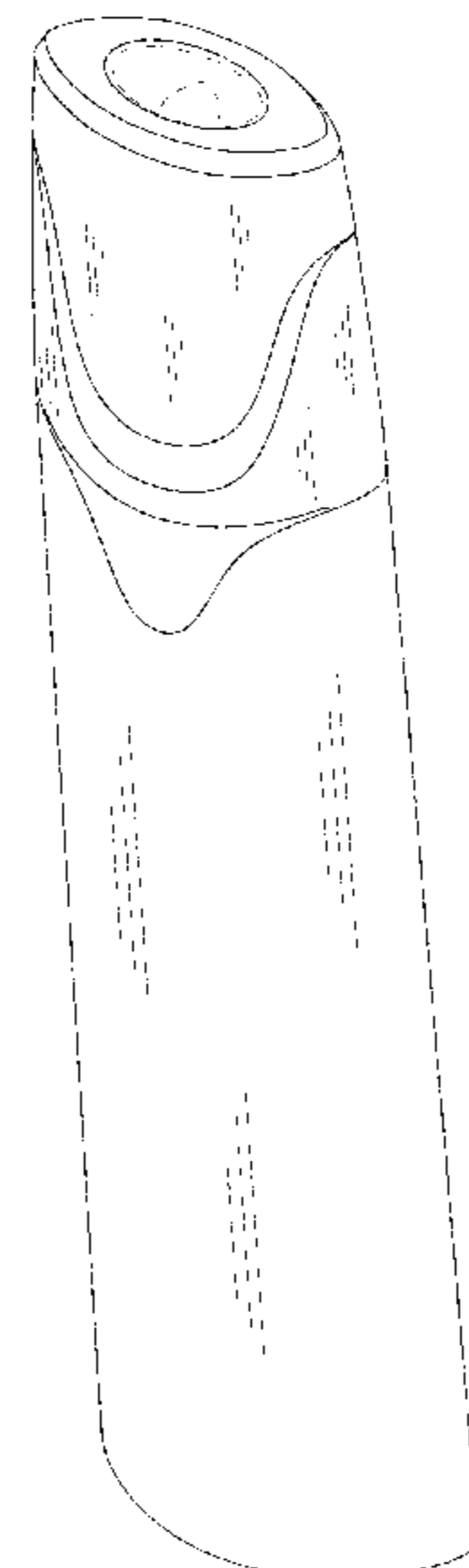
FIG. 1 is a first perspective view of an electronic cigarette showing our new design;

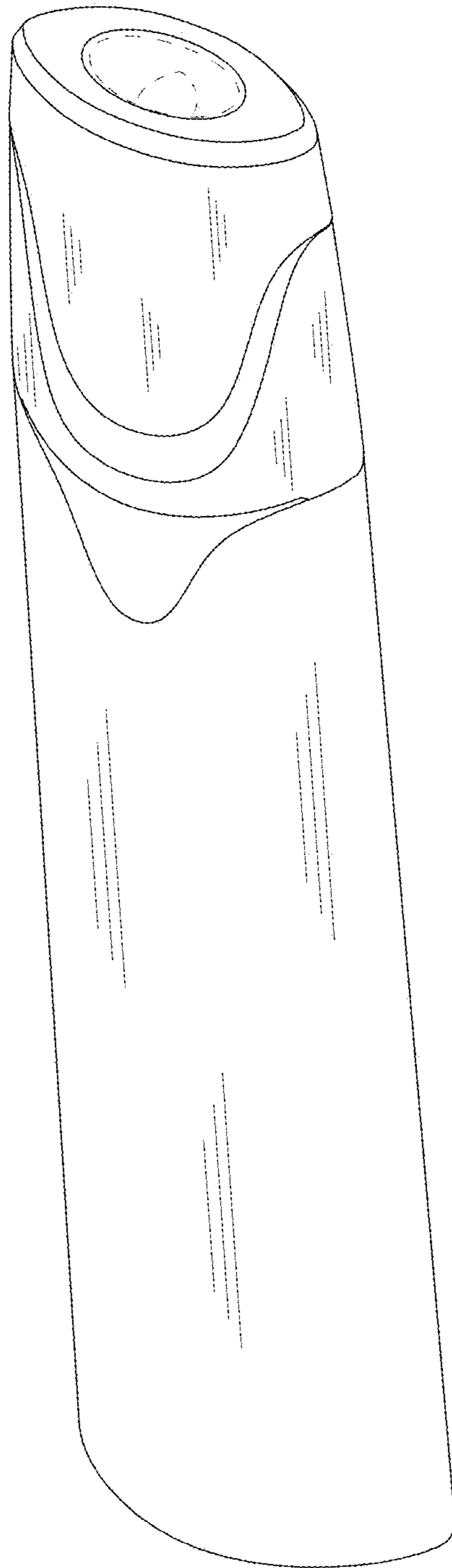

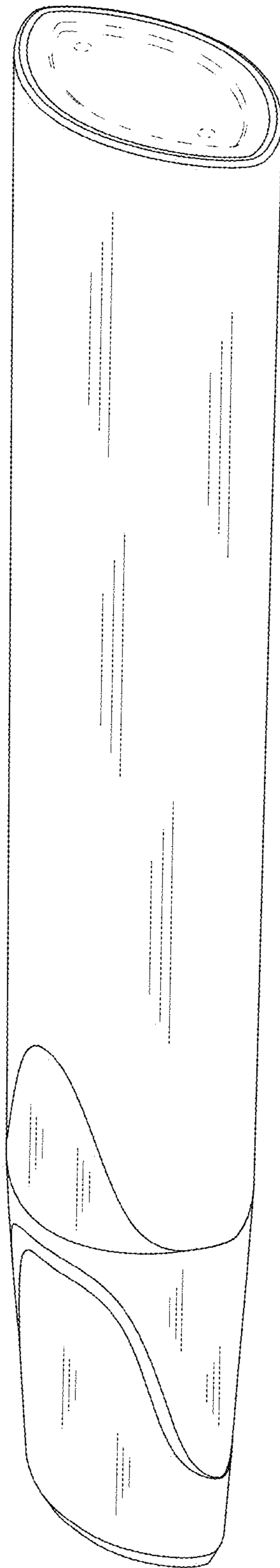

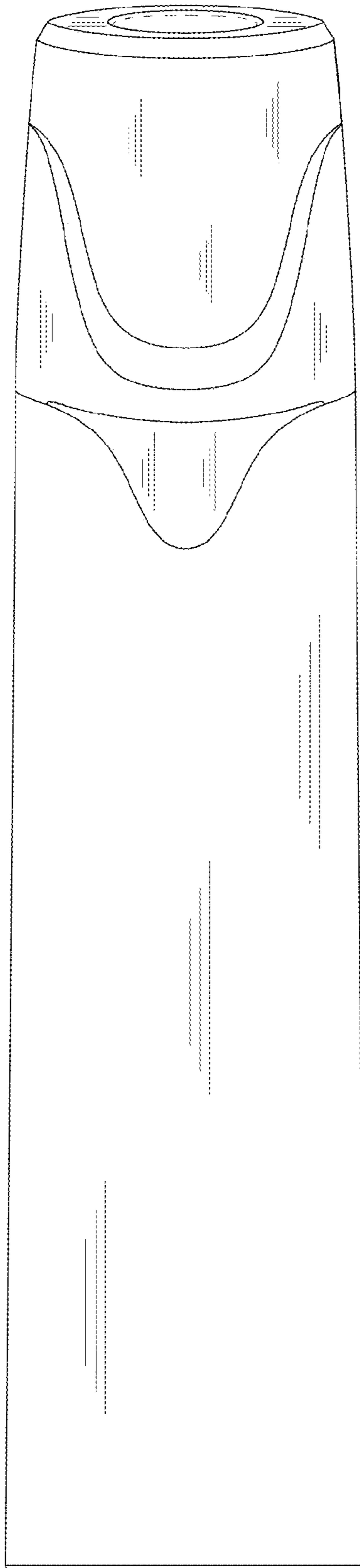

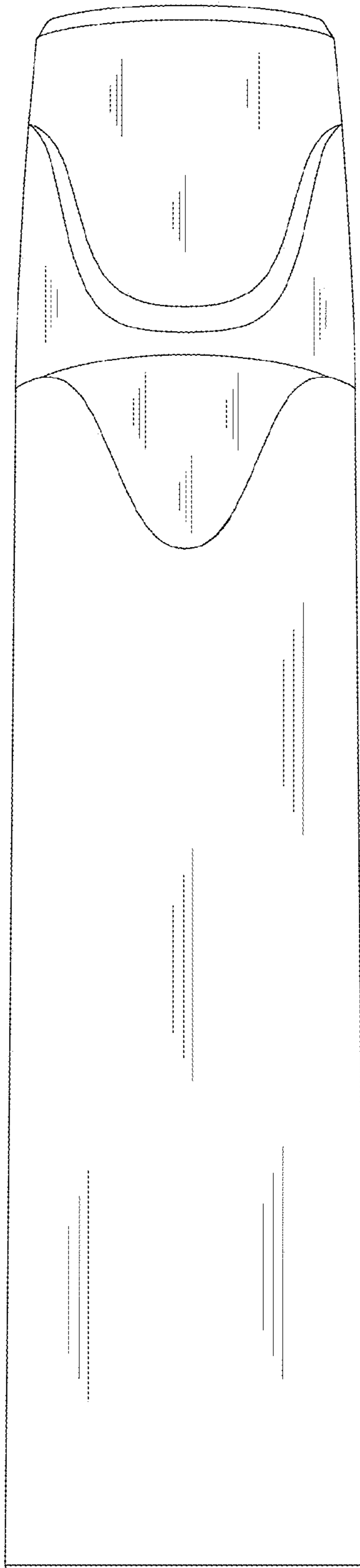

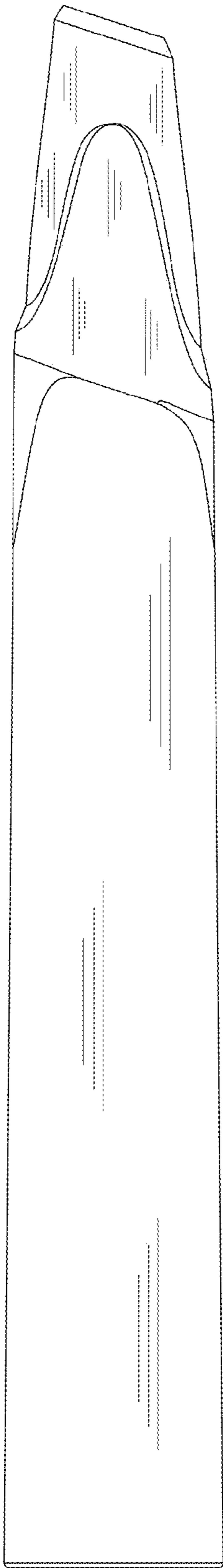

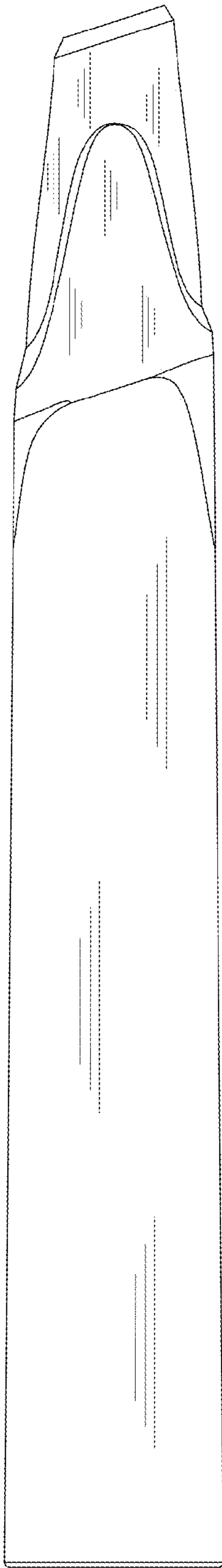

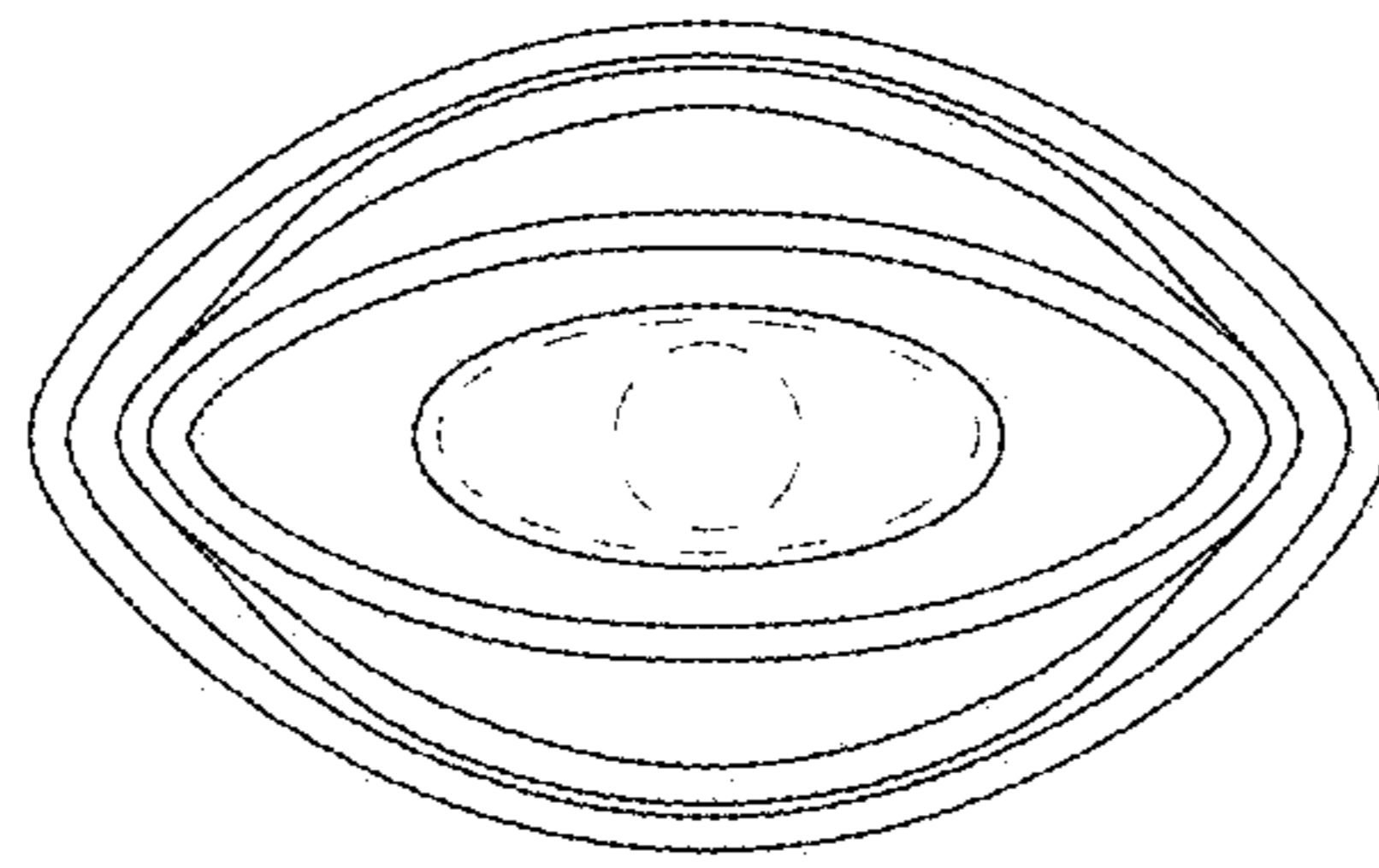

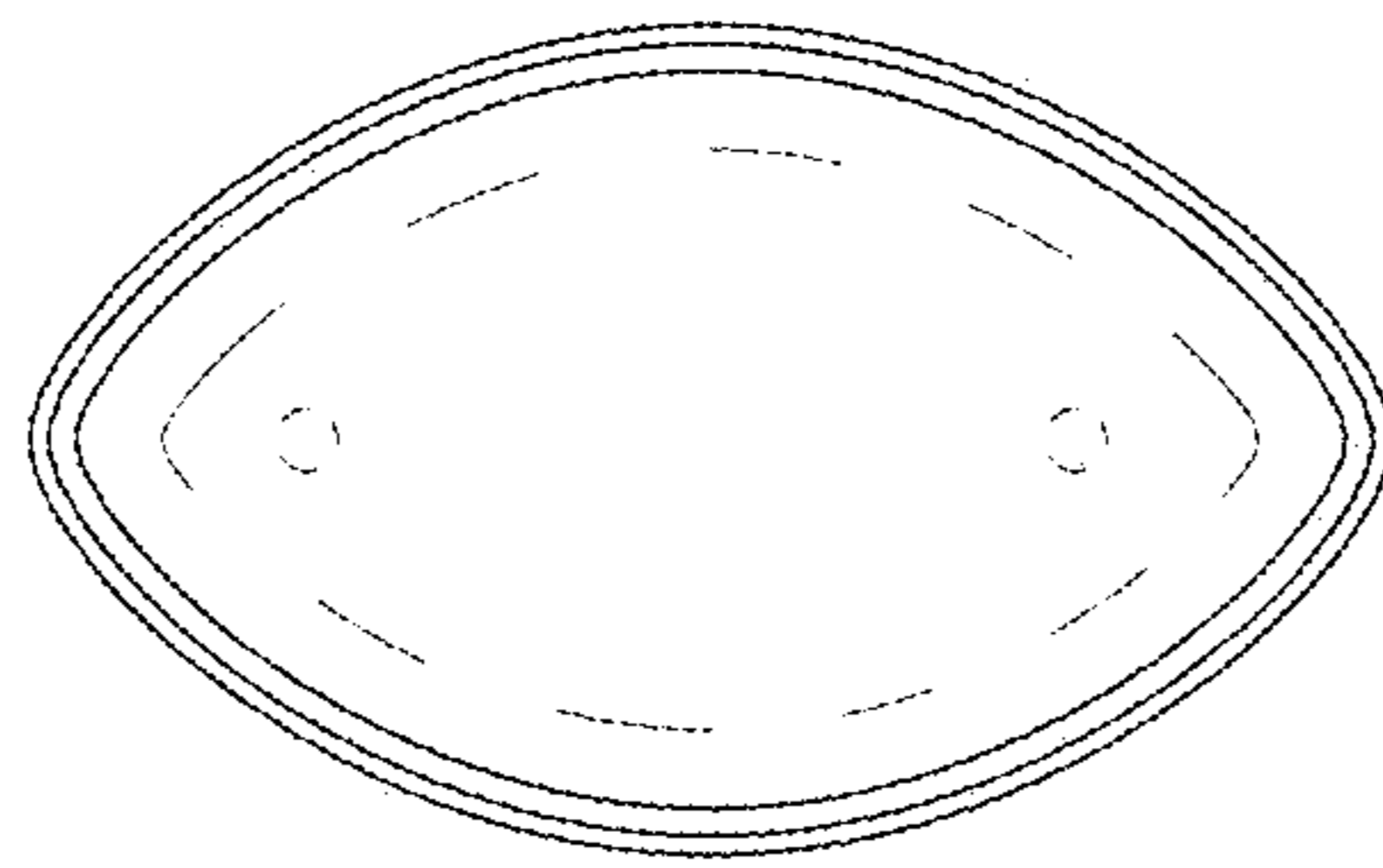
