(57) **CLAIM**

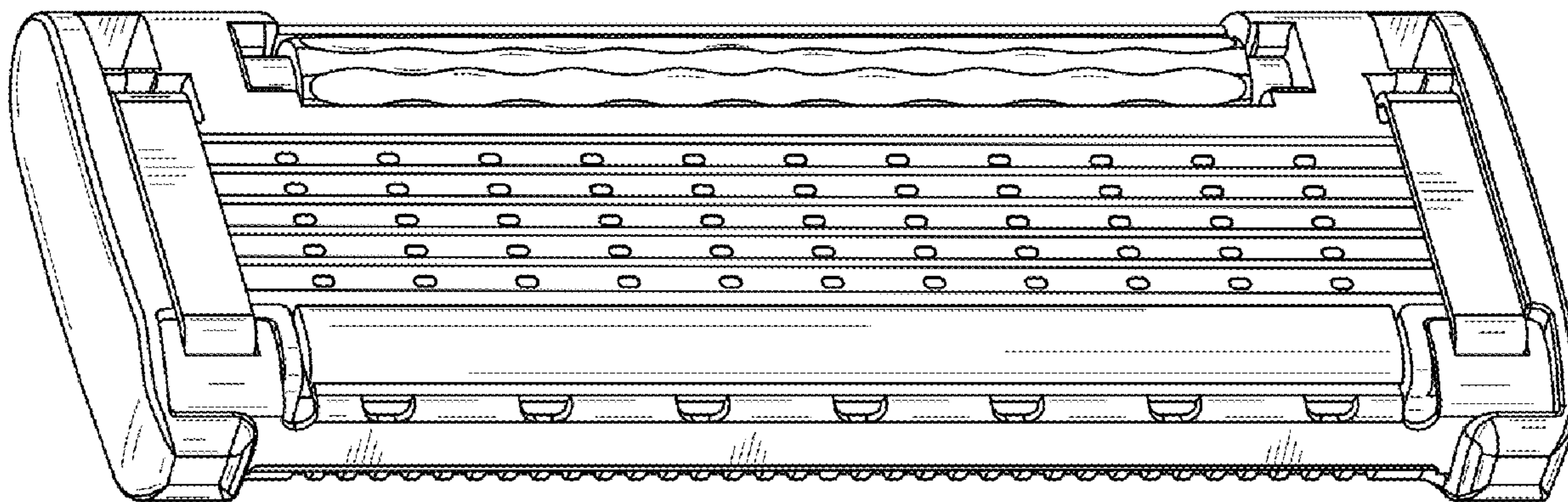
The ornamental design for a razor head, as shown and described.

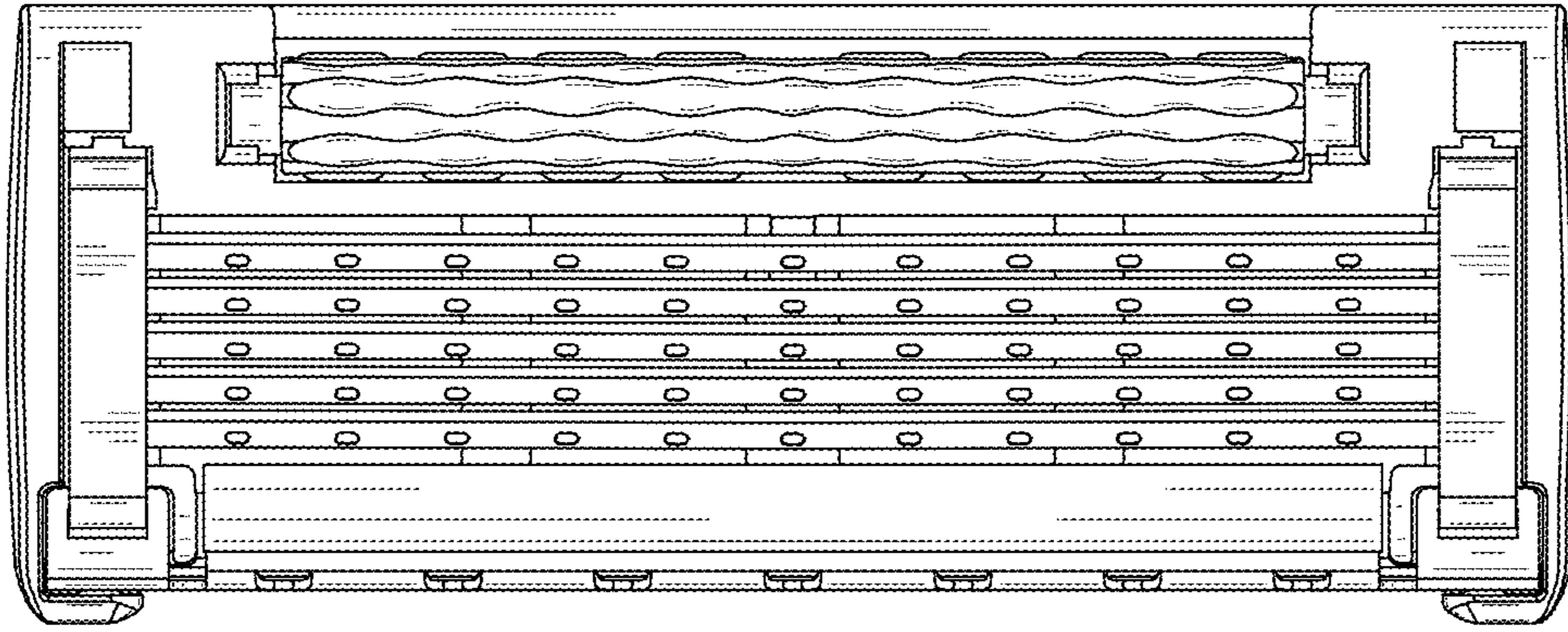

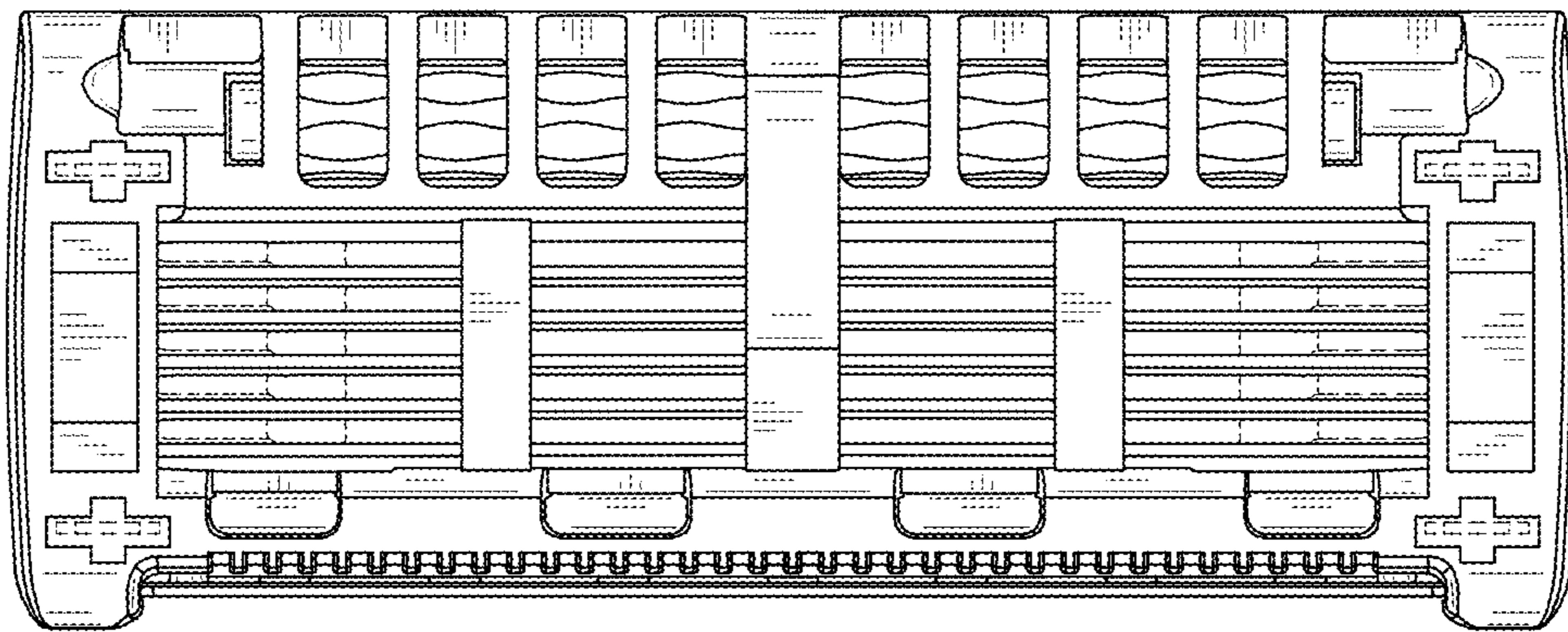

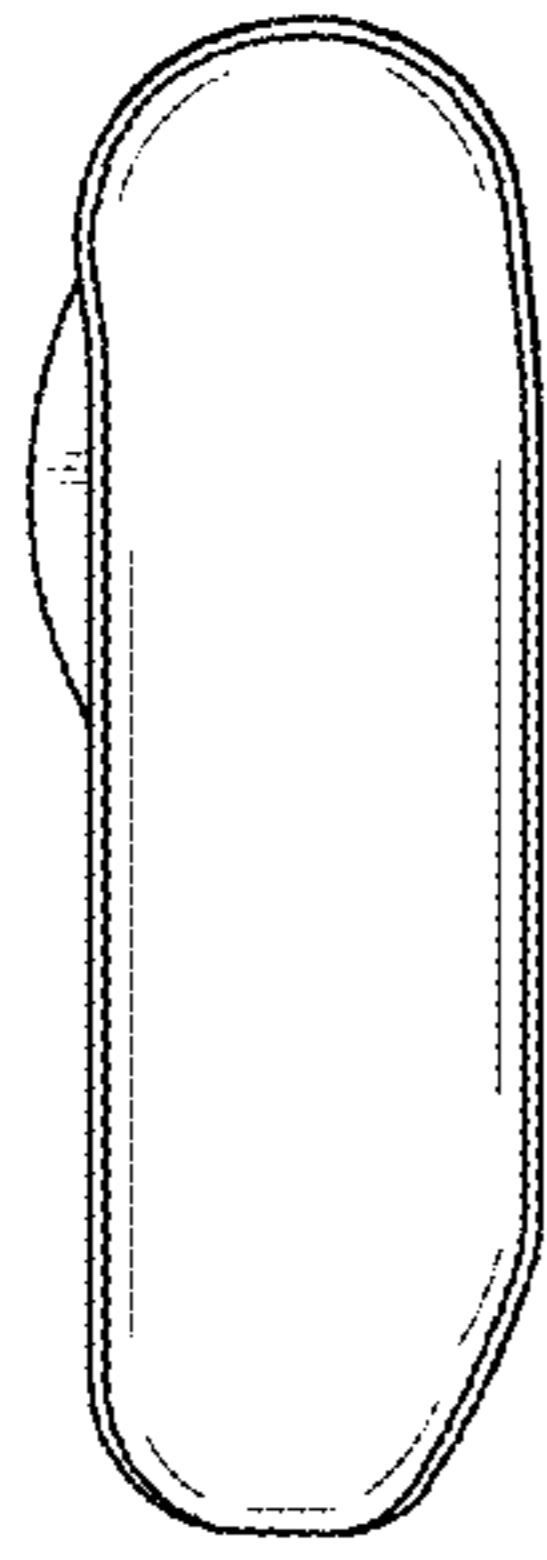

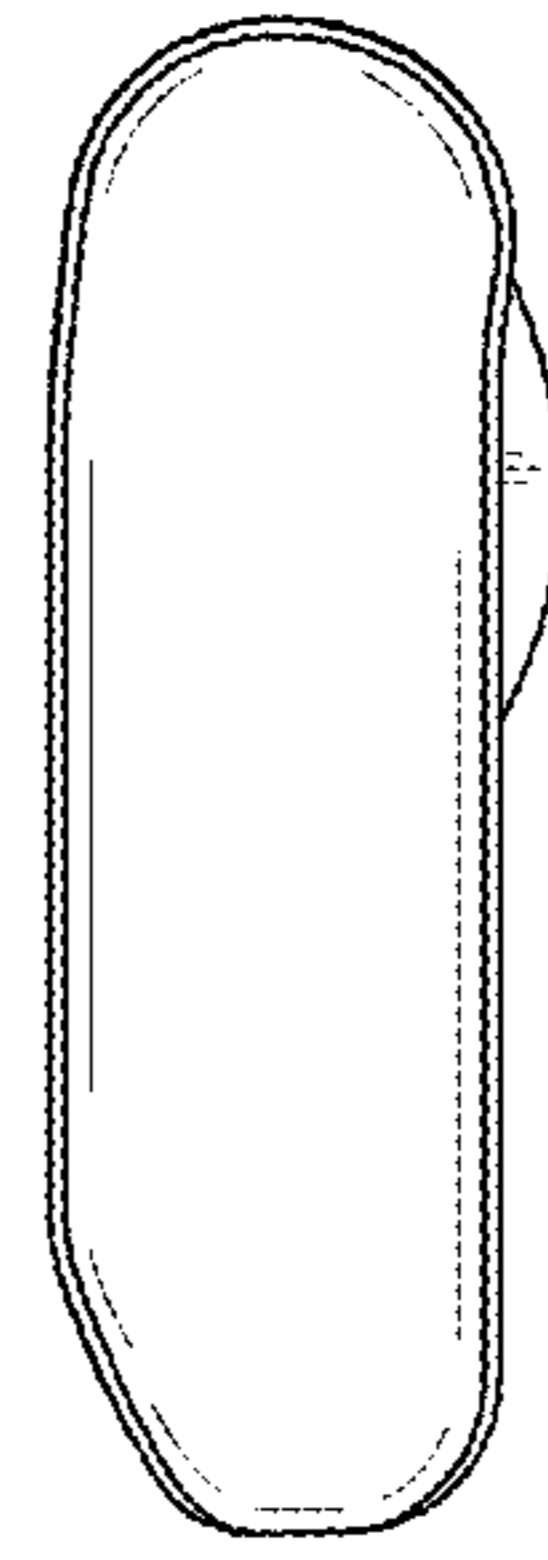

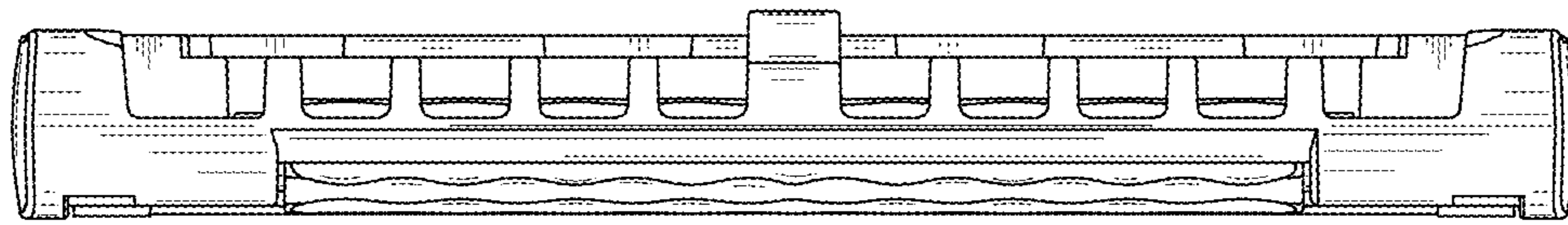

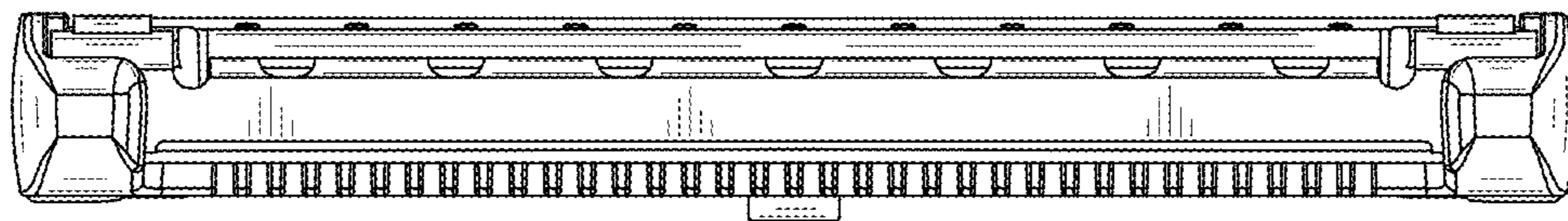

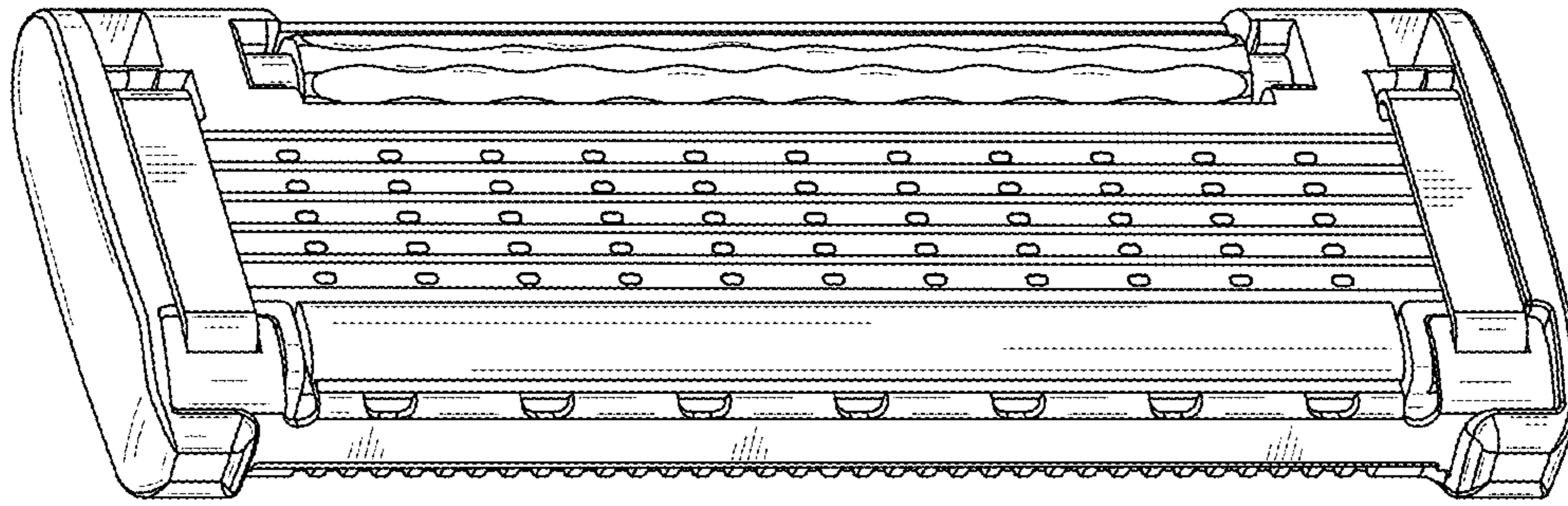

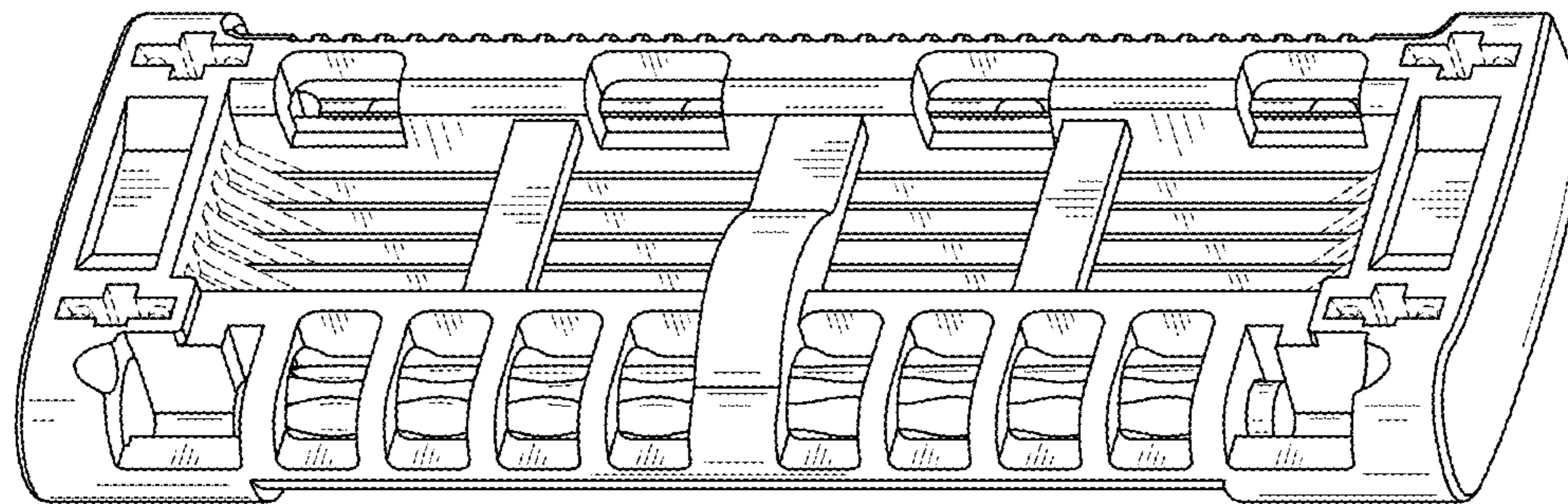
