FIG. 1 illustrates a perspective view of an animal grooming brush showing my new design;

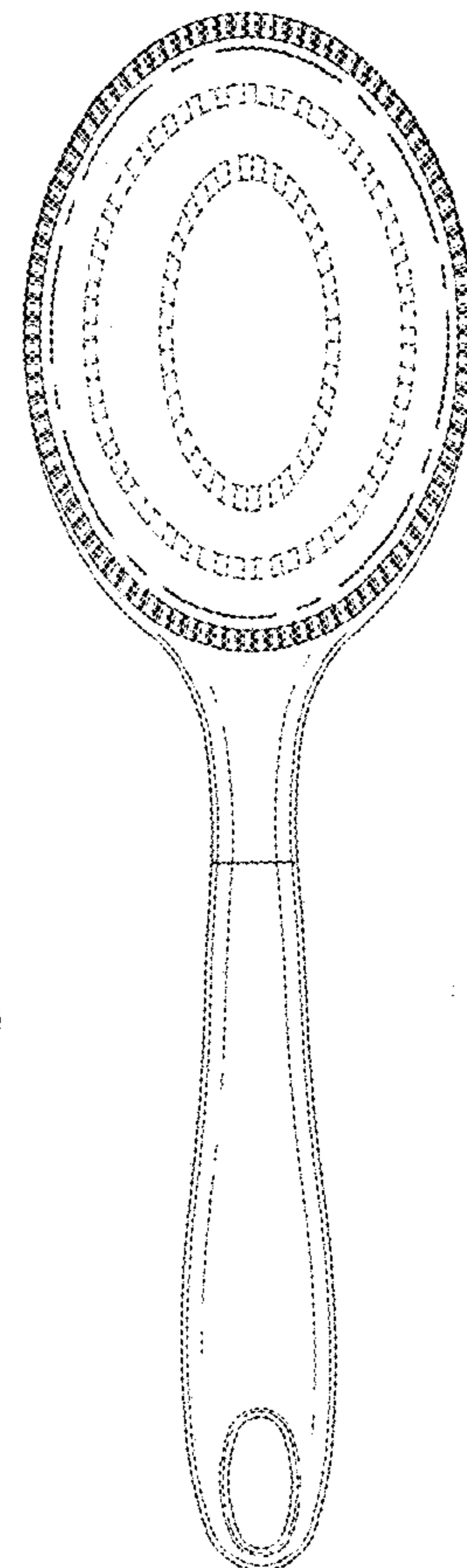
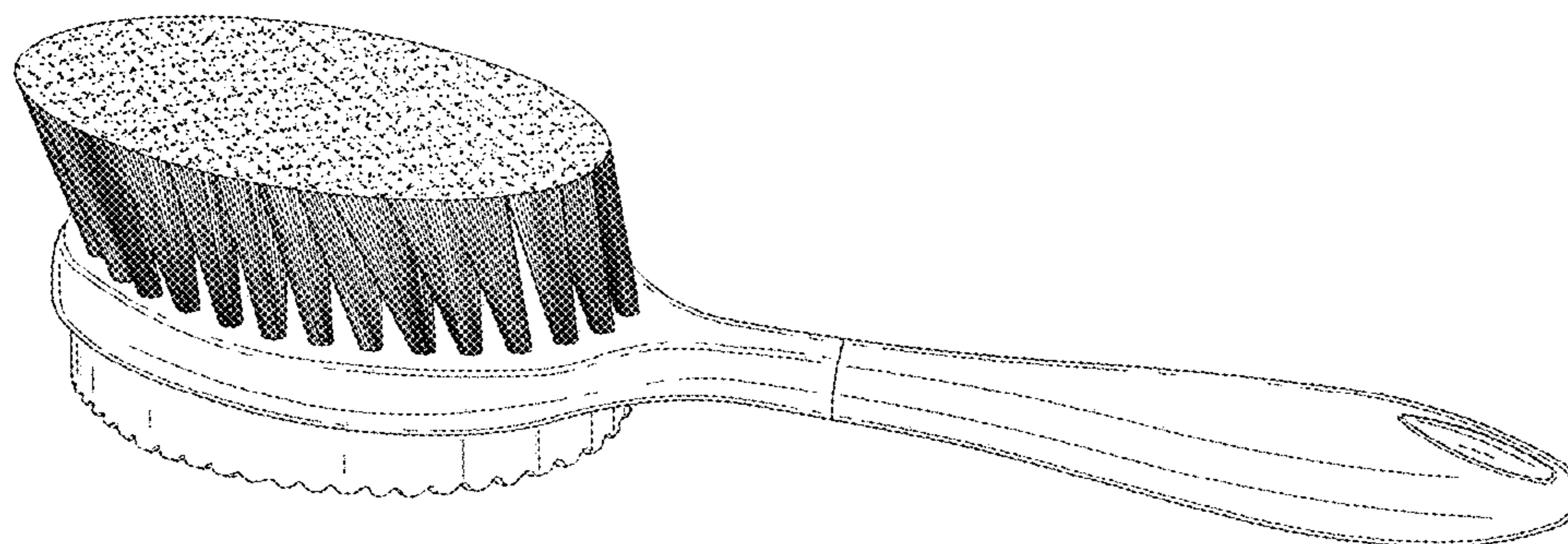
FIG. 2 is a right side elevational view of thereof, the left side being the same as the right side;

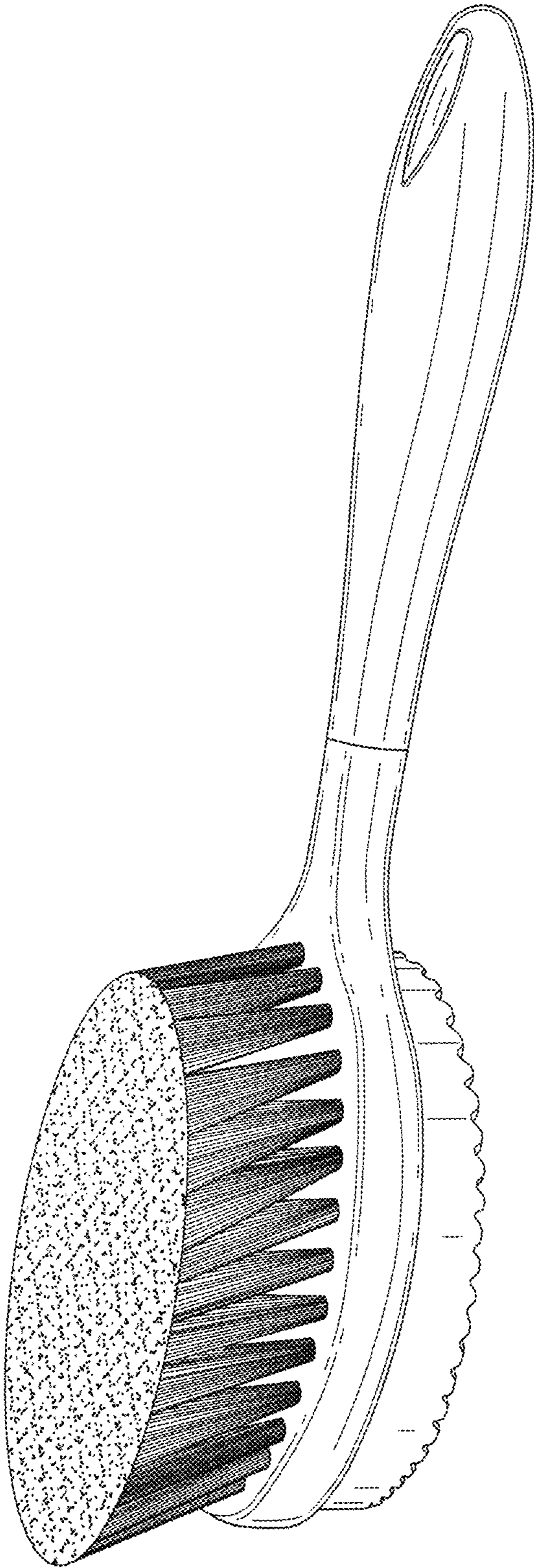

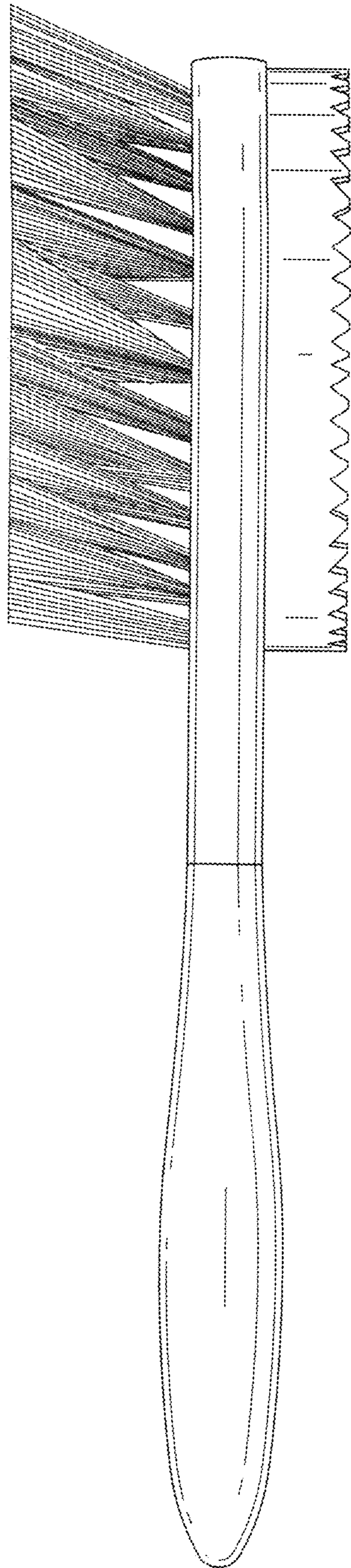
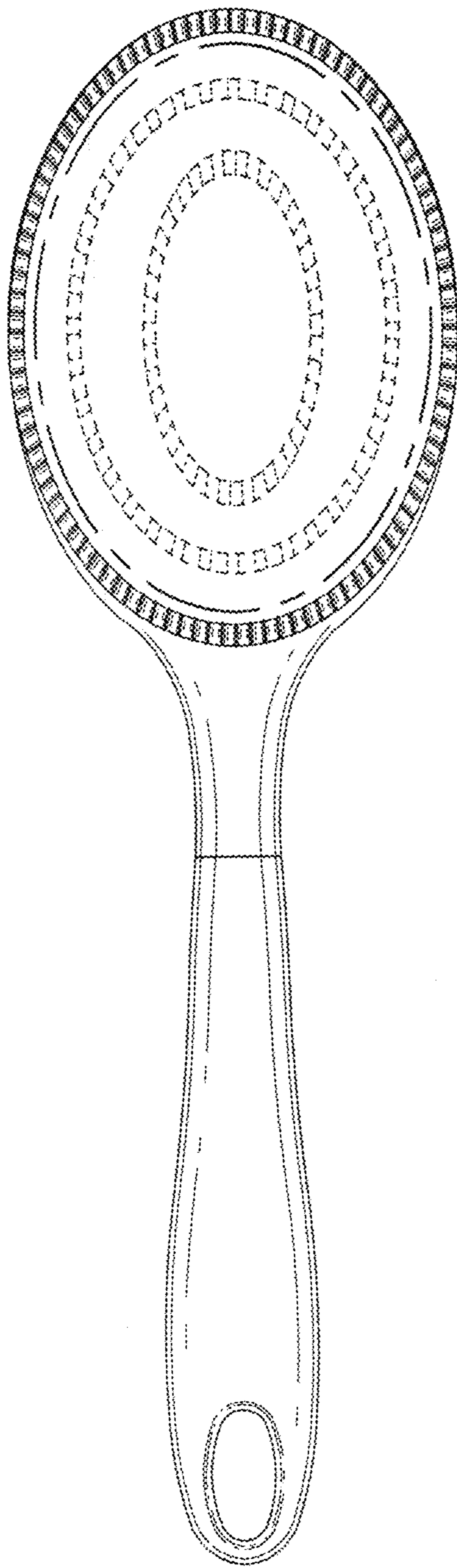
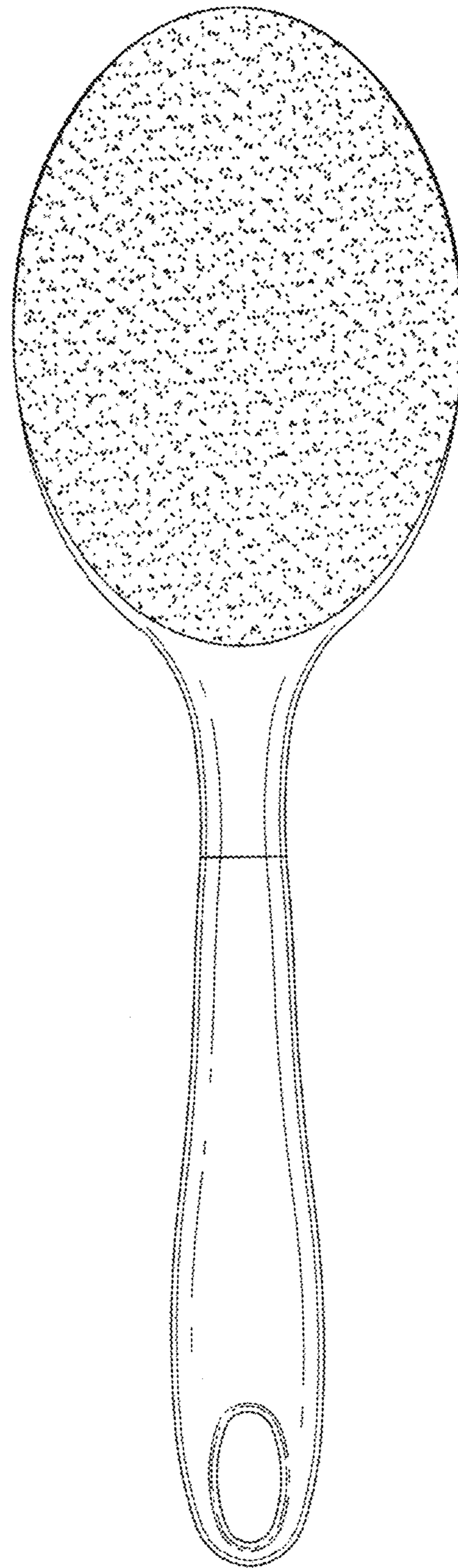
