DESCRIPTION

FIG. 4 is a right elevation view thereof;

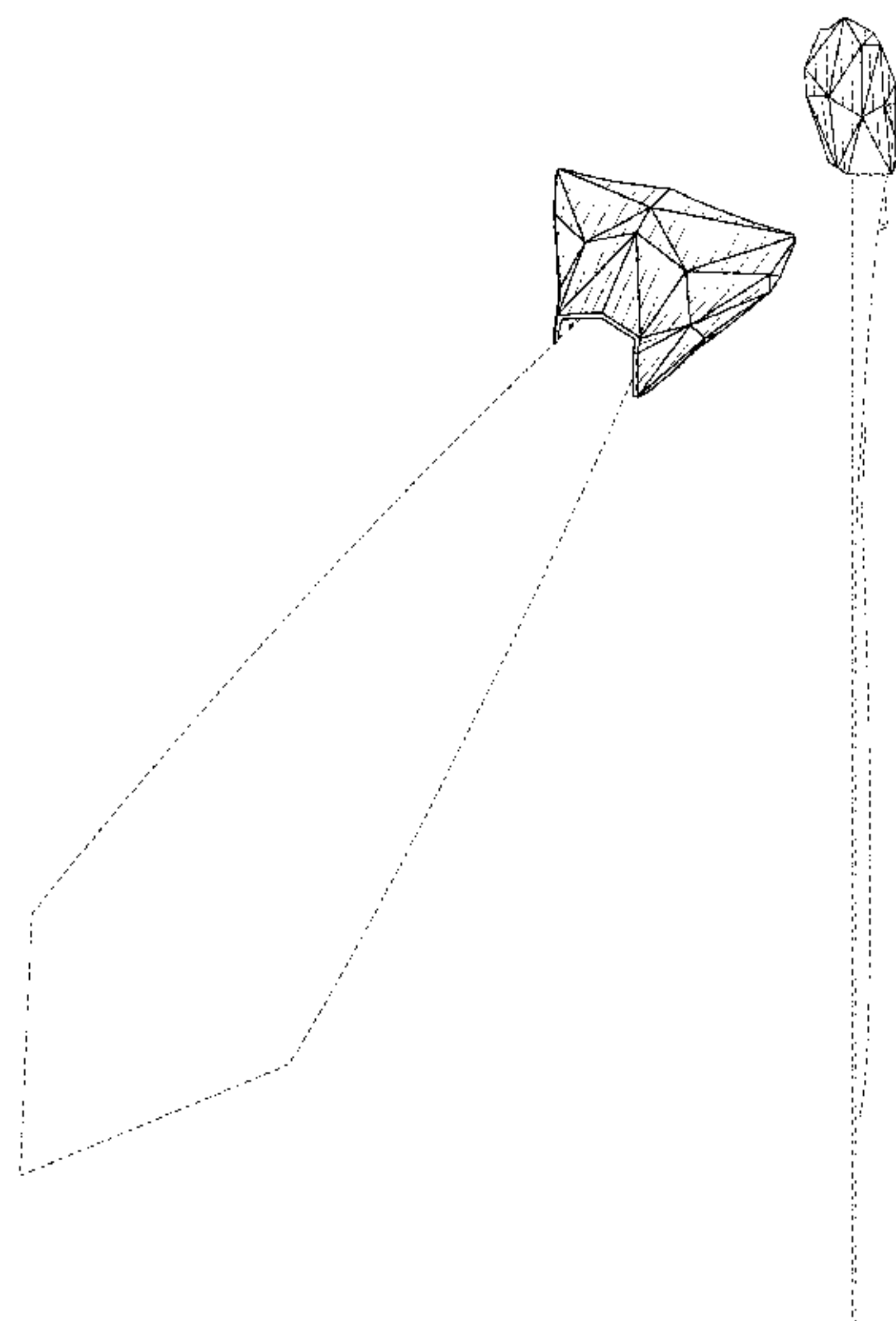
FIG. 5 is a left elevation view thereof;

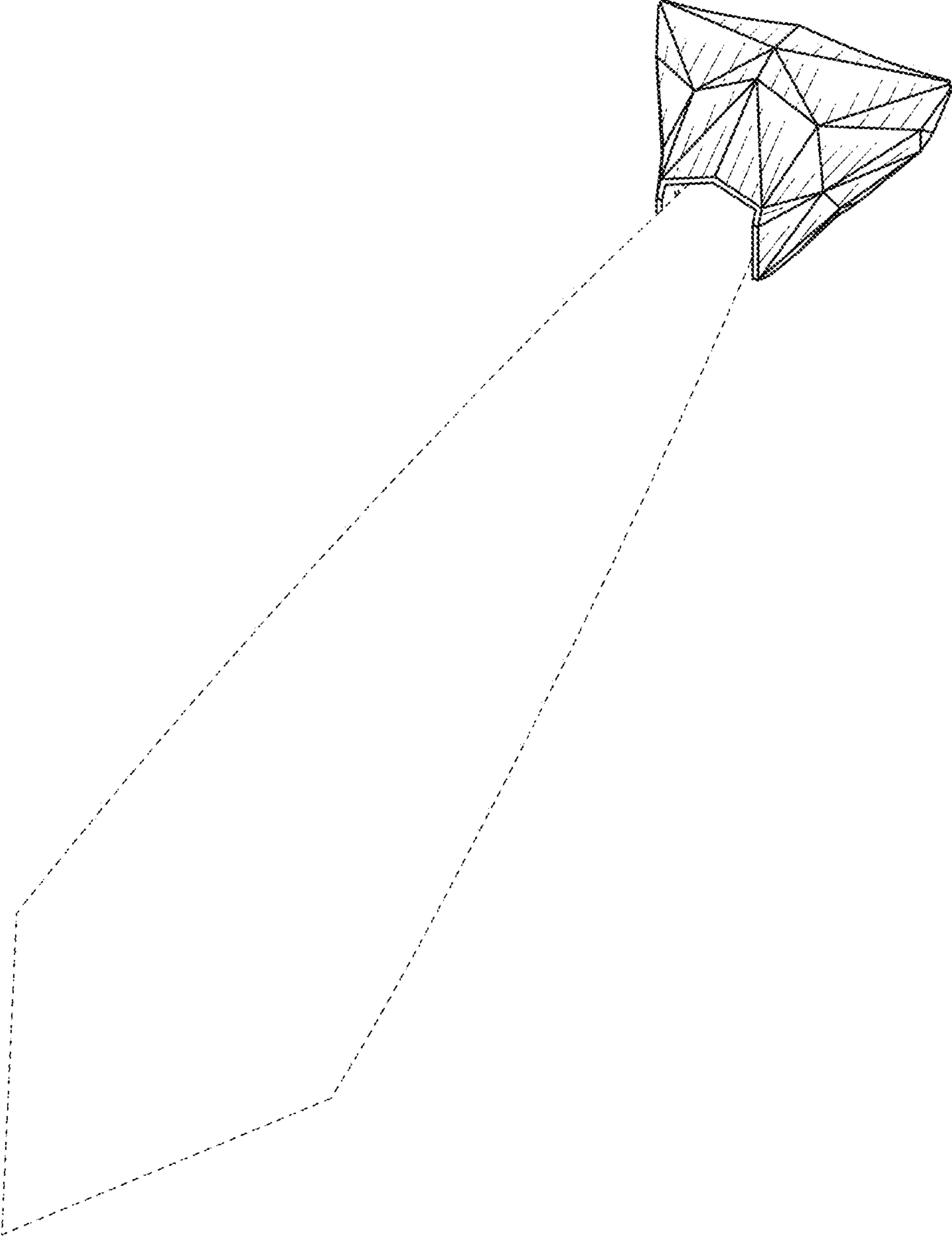

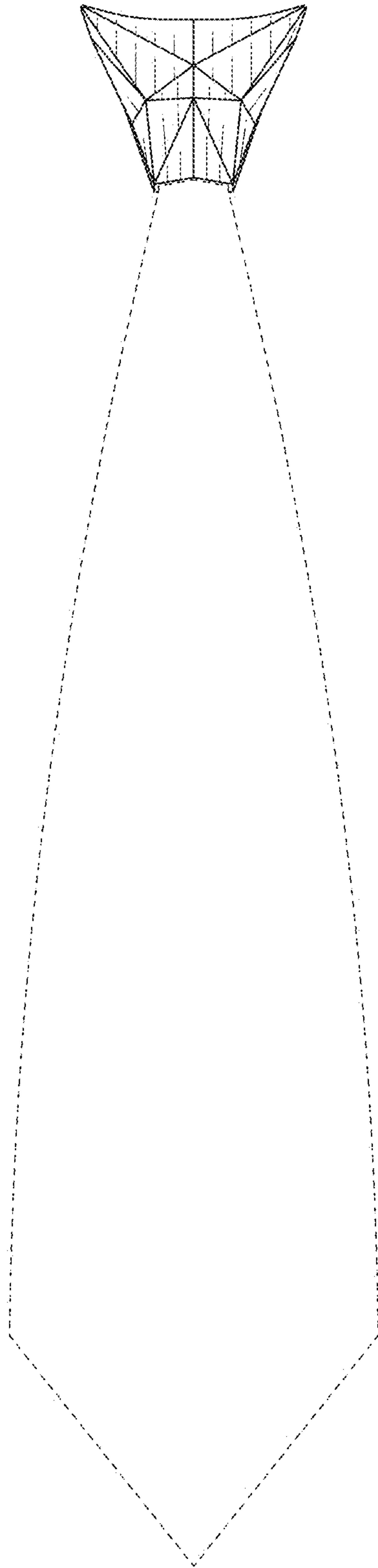

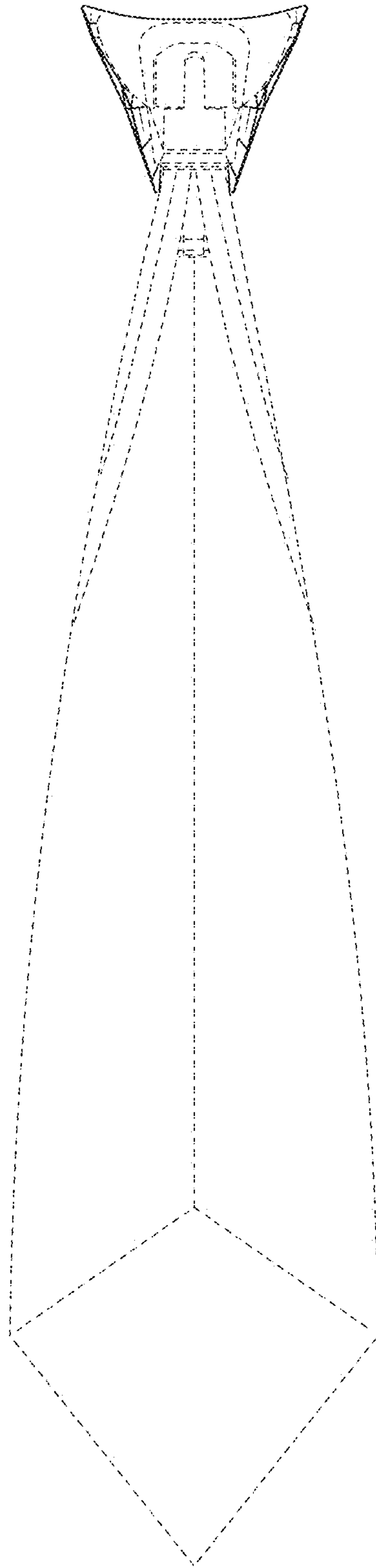

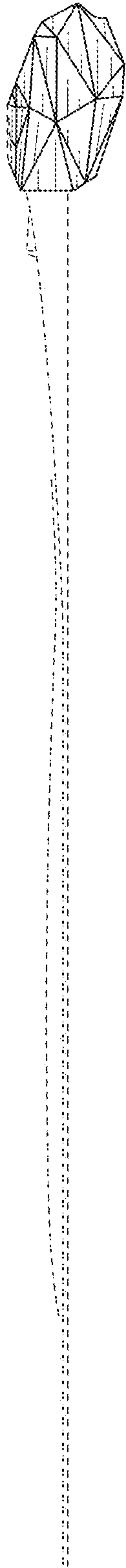

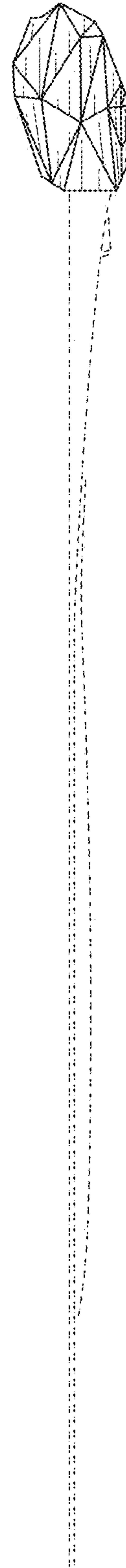

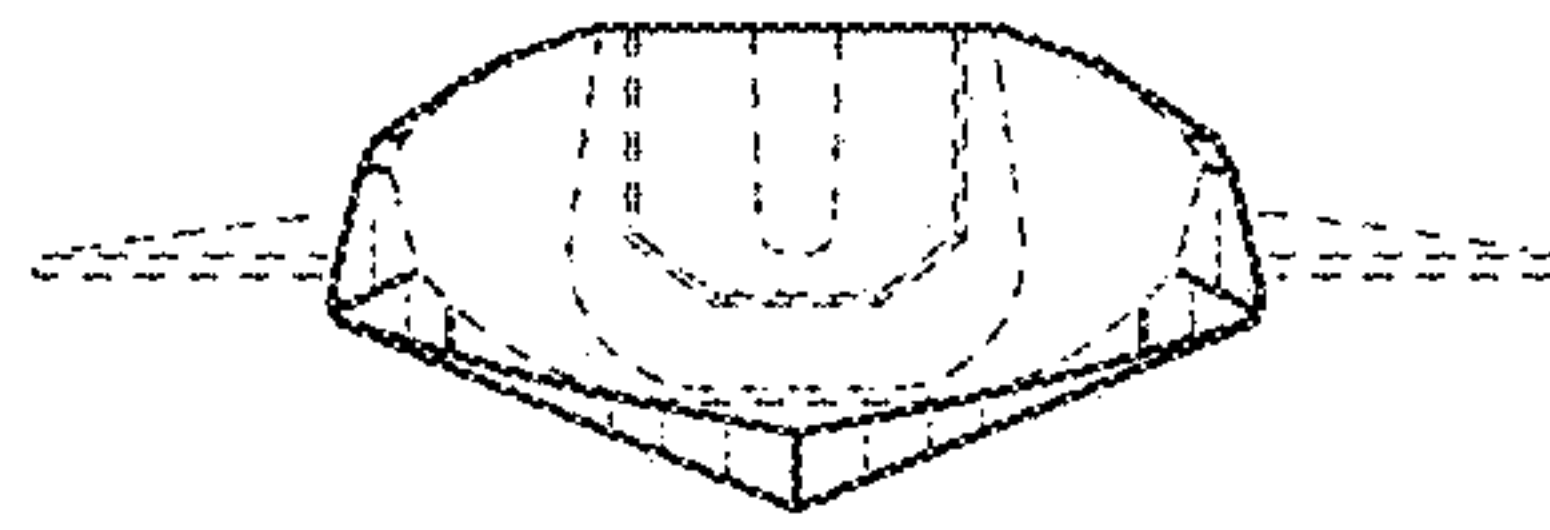

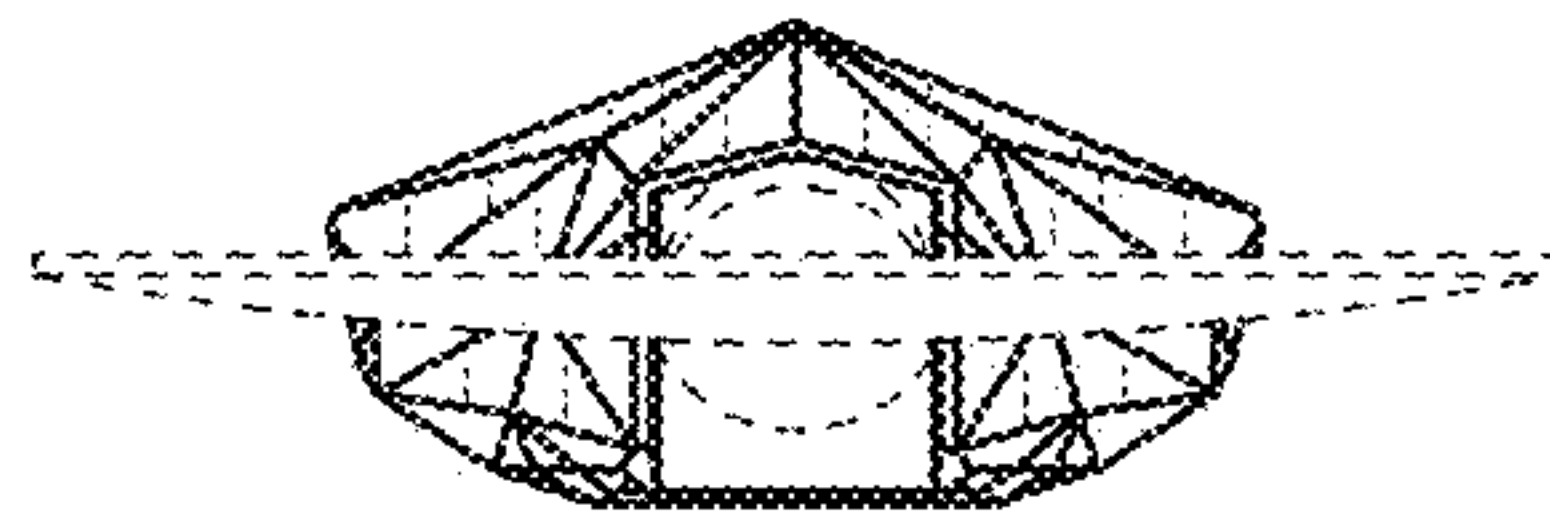
