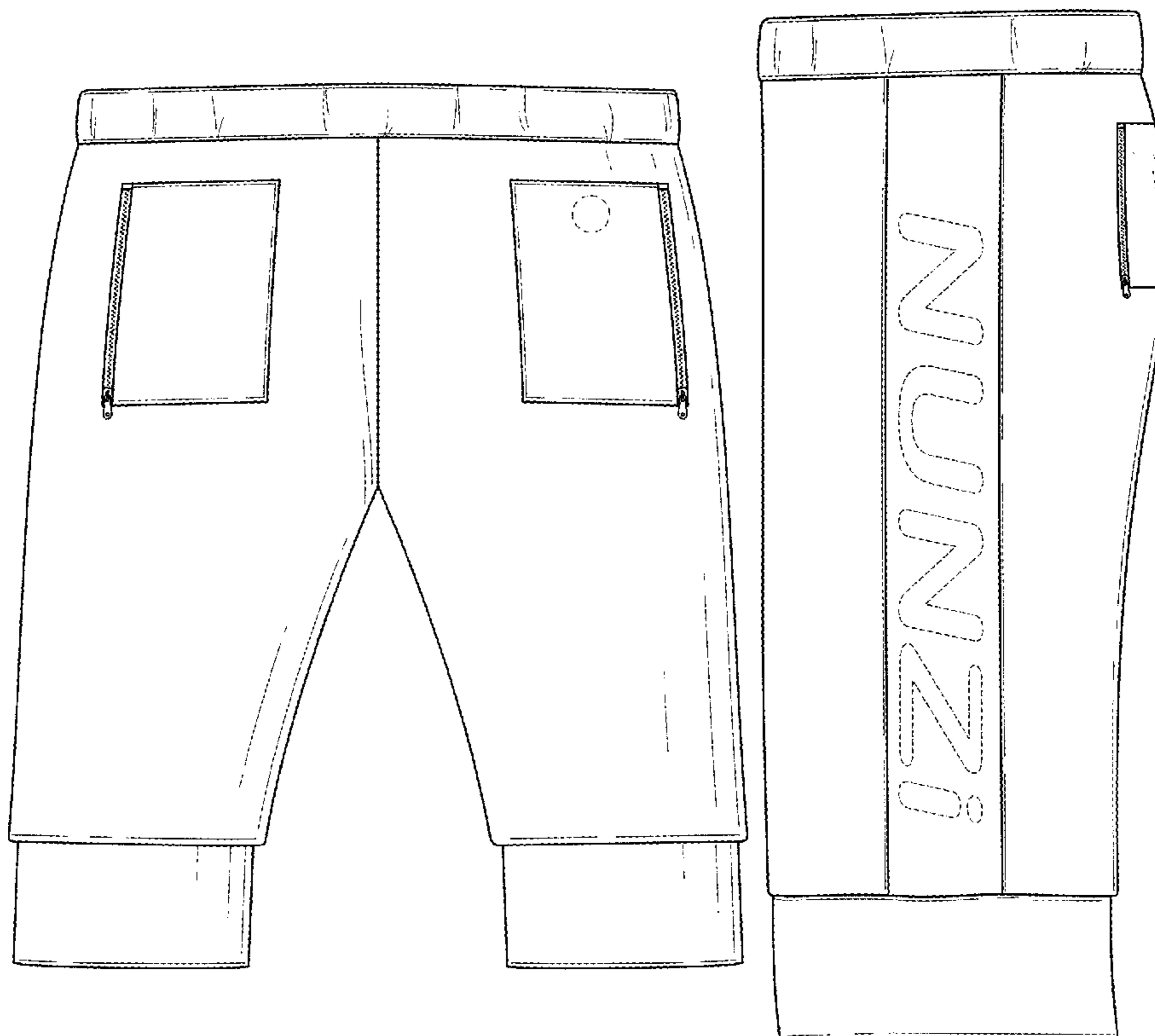
DESCRIPTION

FIG. 1 is a rear view of the Nunzi sports shorts with spandex
sewn on a lower end;

FIG. 2 is a top view of the Nunzi sports shorts, the repeating
circular elements shown within the interior portion of the
Nunzi sports shorts are flat; and,

FIG. 3 is a side view of the Nunzi sports shorts.
The dashed broken lines depict stitching and portions of the
Nunzi sports shorts that form no part of the claim.

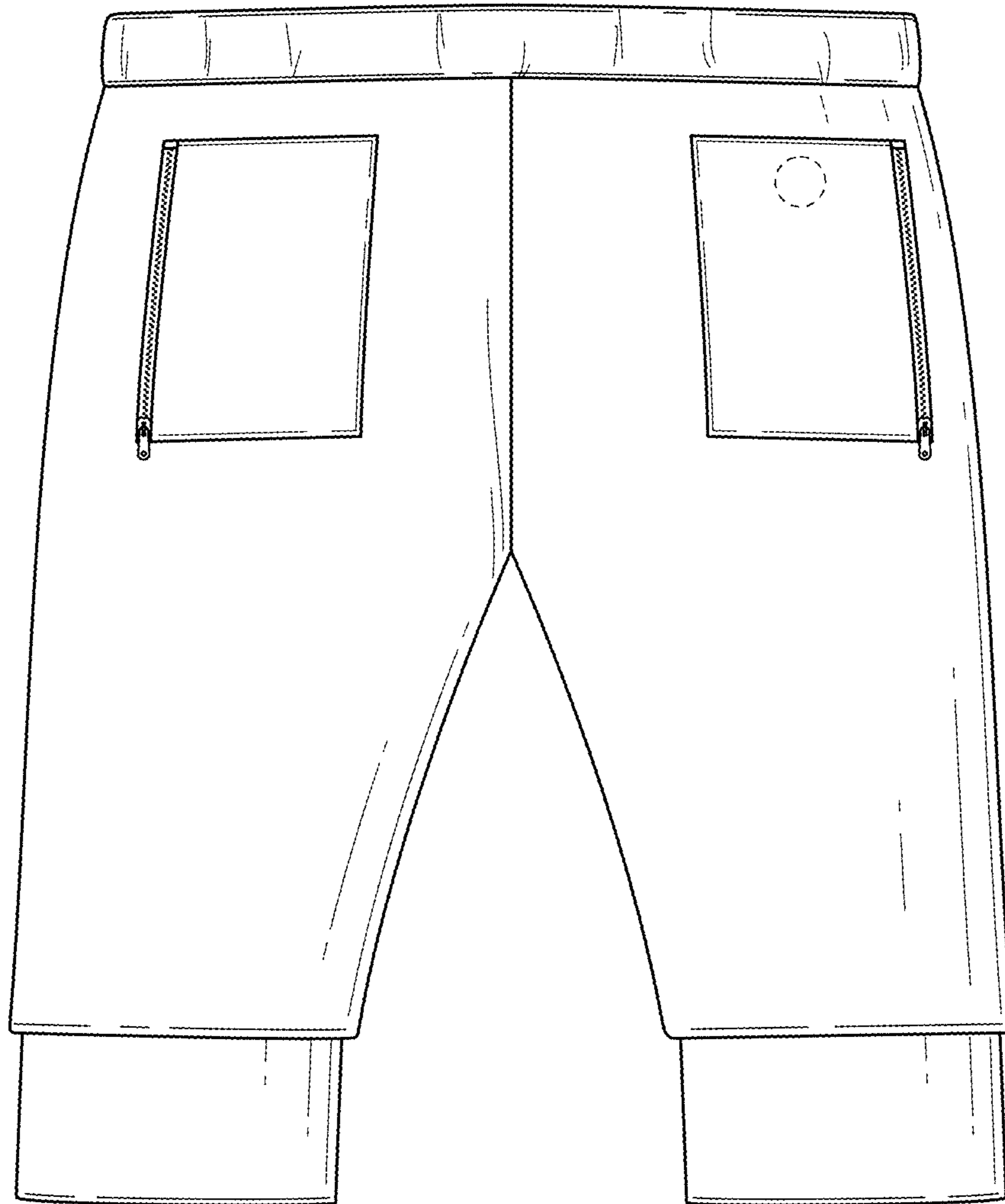

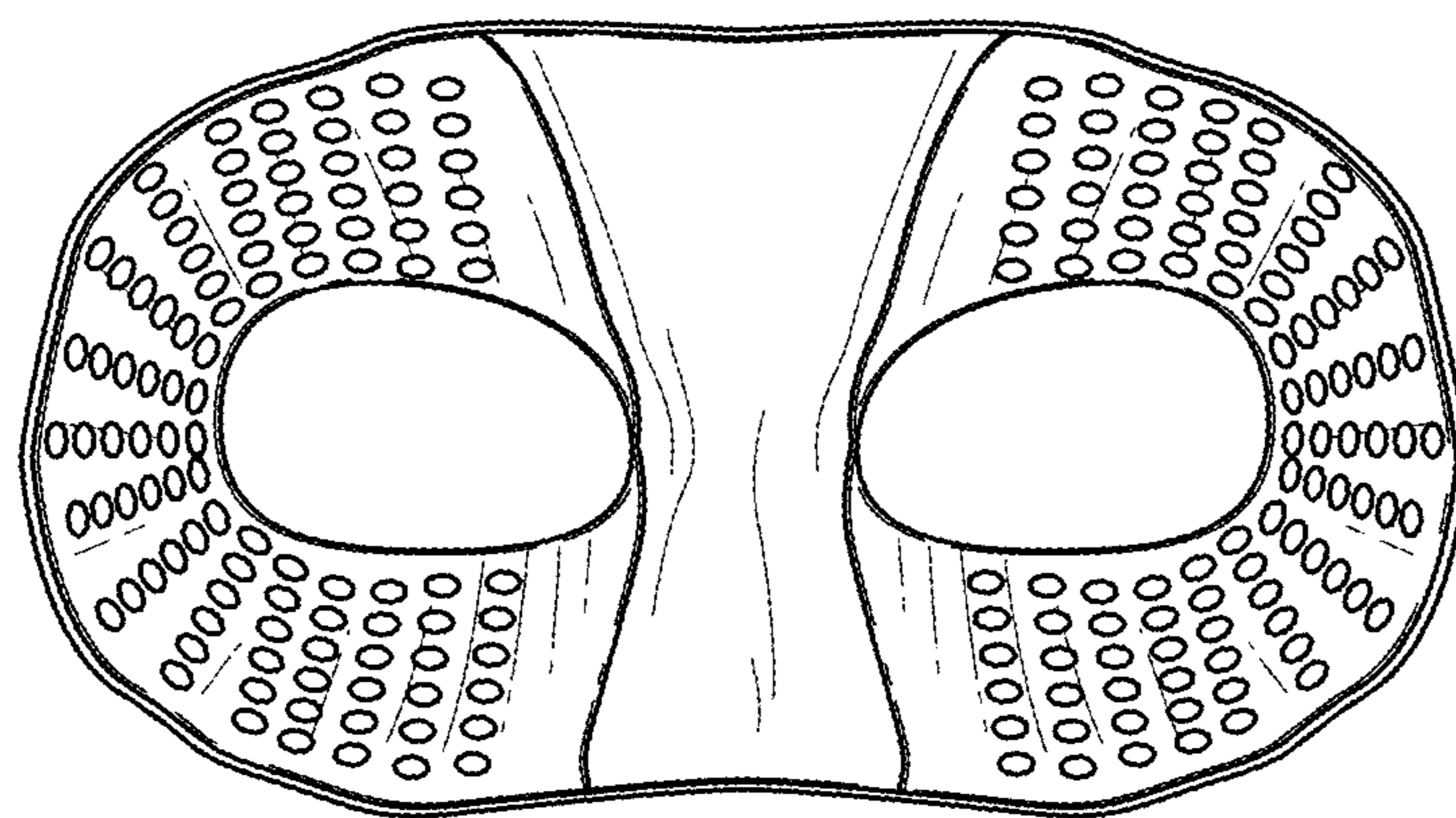

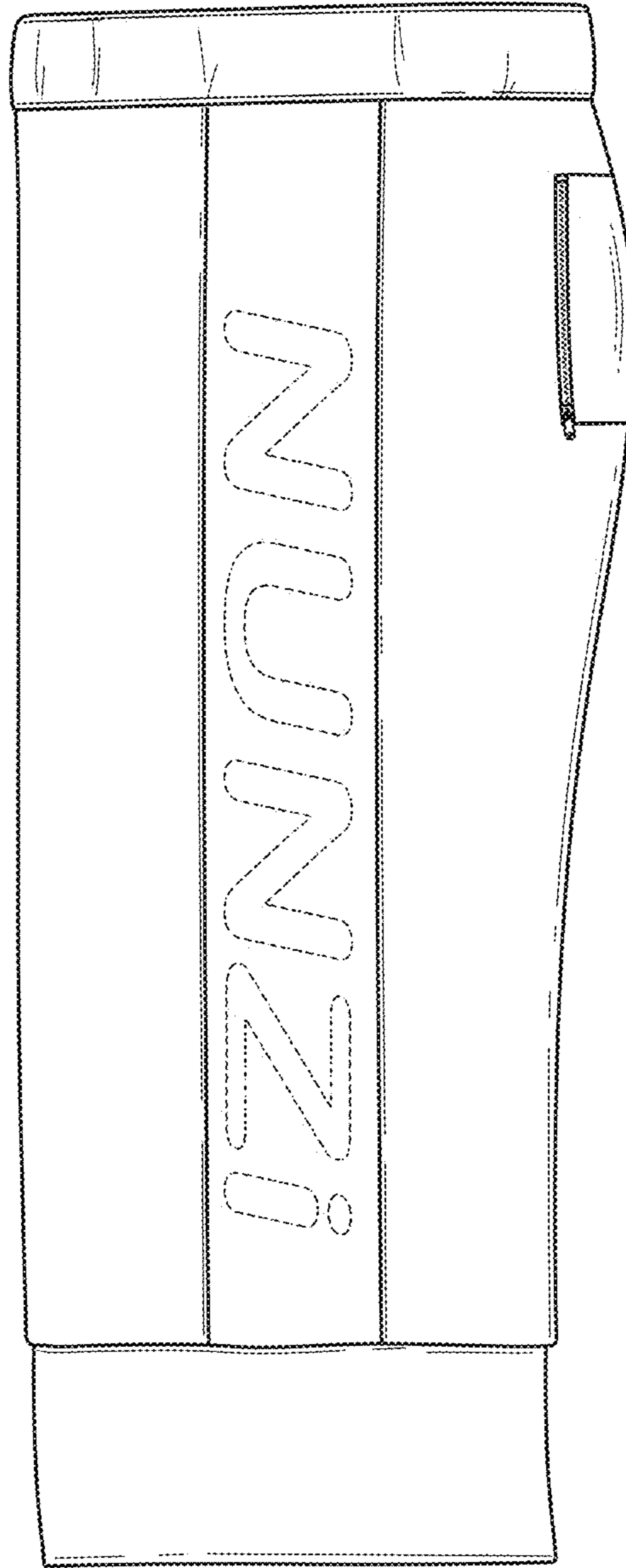
