1. Headdress

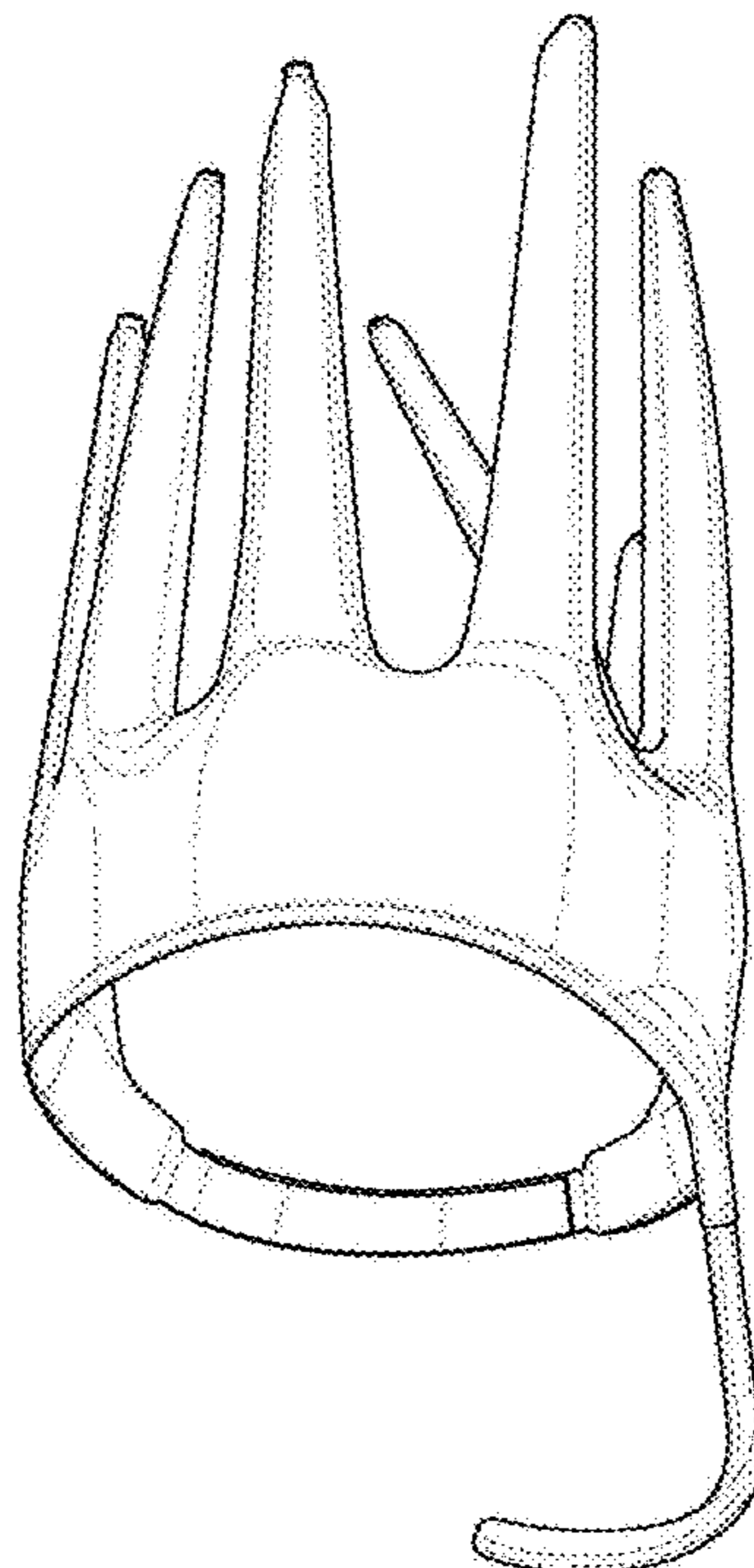
**1.1** is a bottom perspective view of a headdress showing our new design;

**1.2** is a side elevational view thereof;

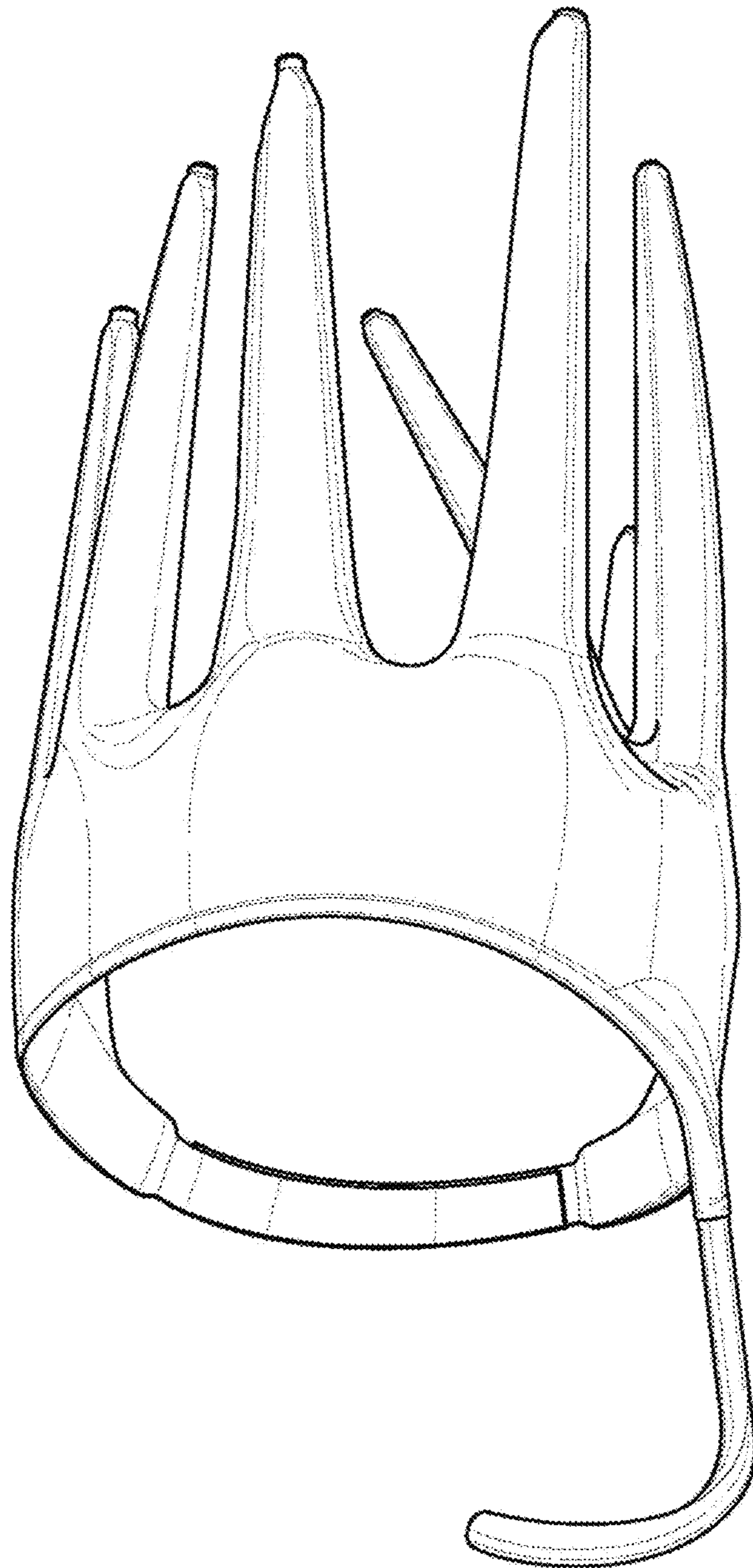
**1.3** is a top perspective view thereof; and

**1.4** is an opposite side elevation view thereof.

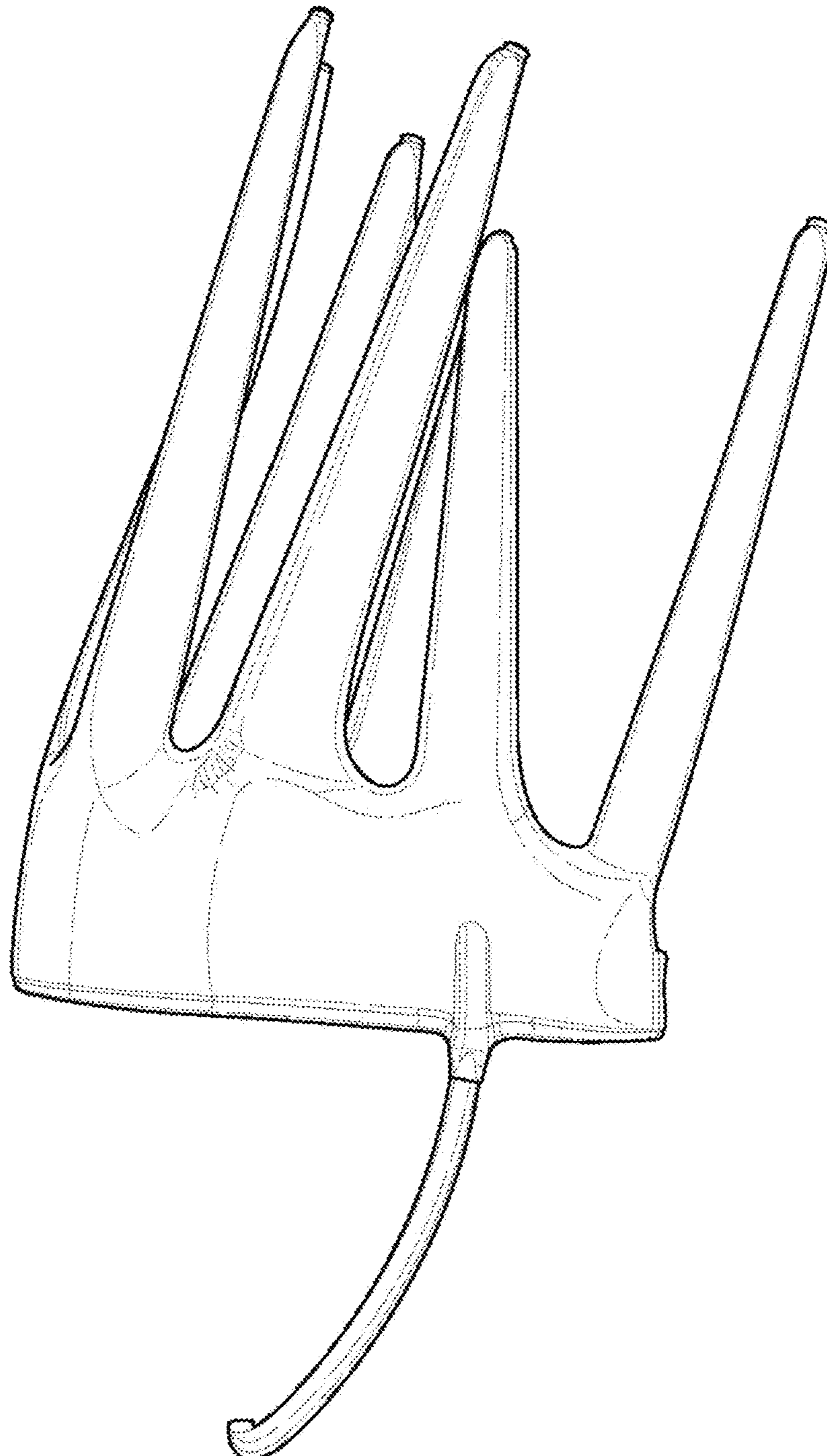

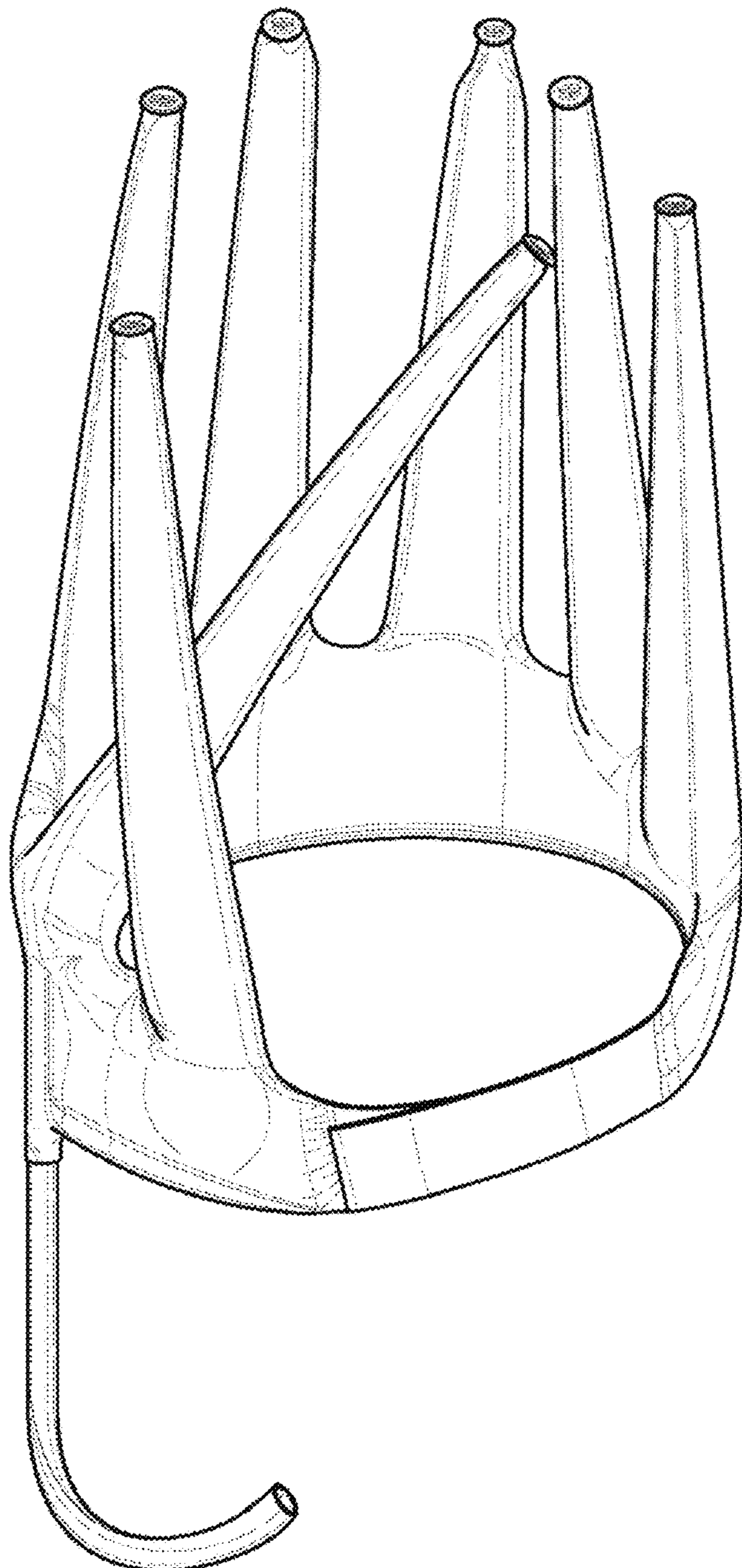
