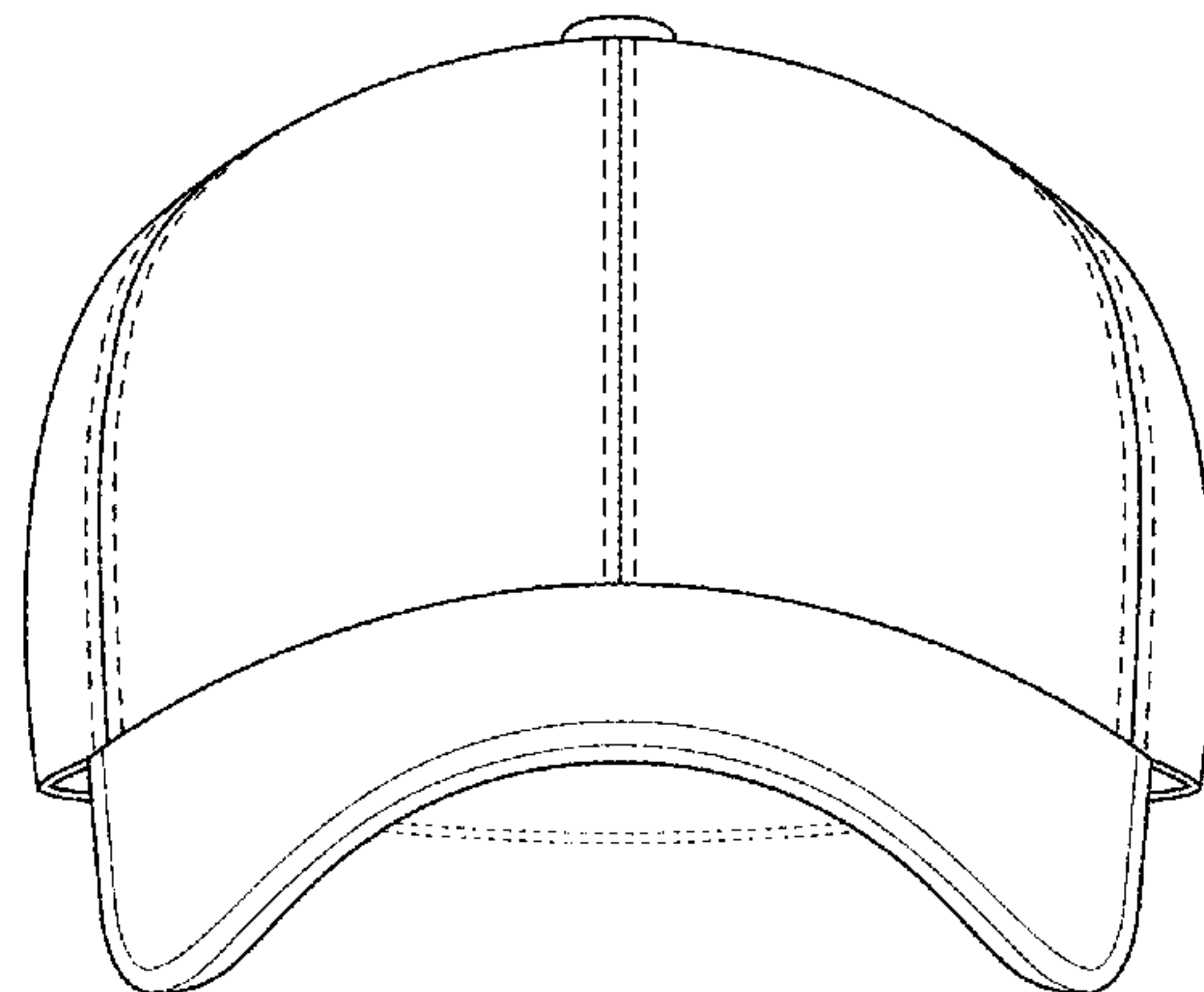
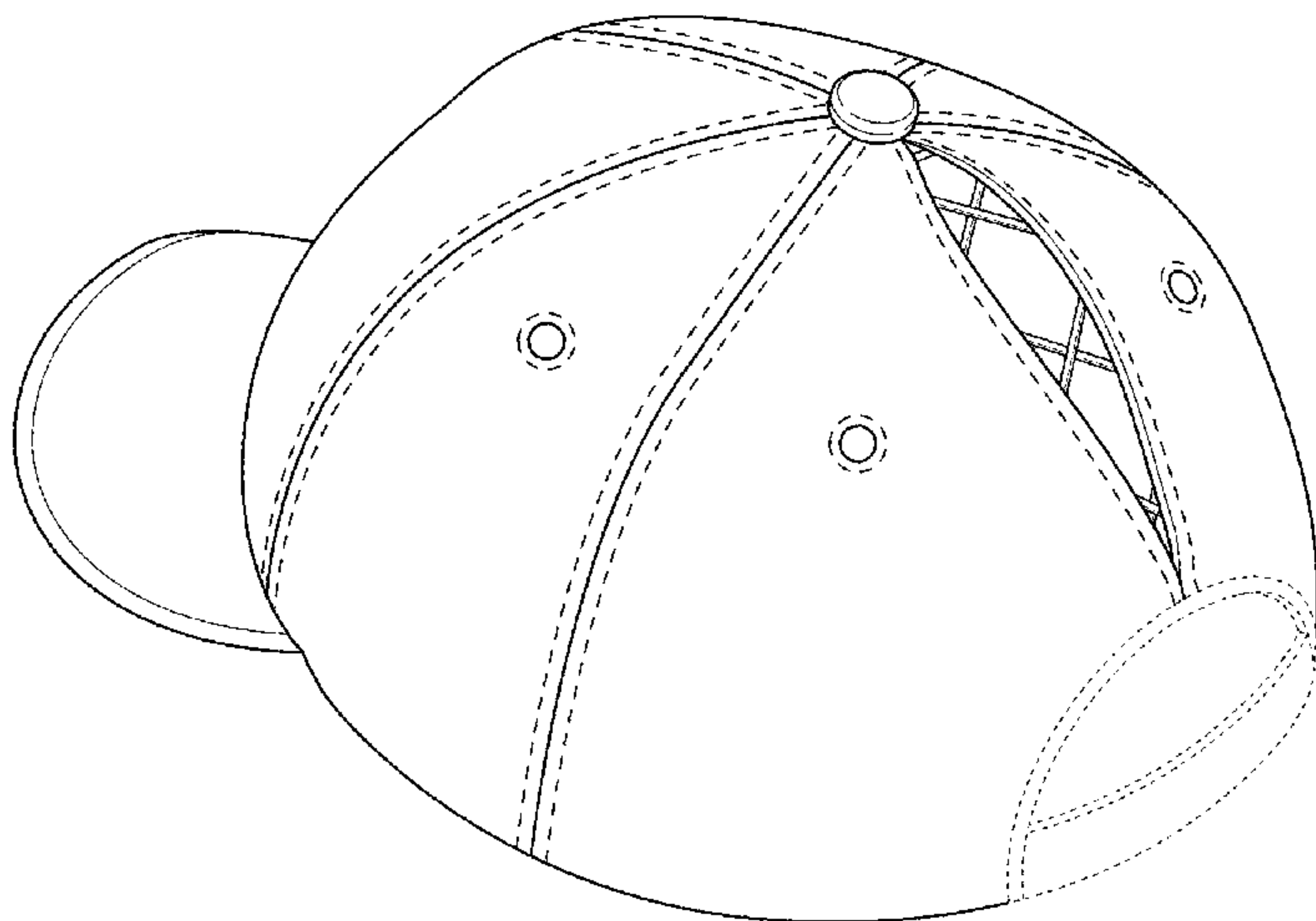
(57) **CLAIM**

The ornamental design for a vented hat, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear perspective view of a vented hat, with the vent portion of the hat in an open orientation;  
 FIG. 2 is a rear elevation view thereof;  
 FIG. 3 is a front elevation view thereof;  
 FIG. 4 is a side elevation view thereof;  
 FIG. 5 is an opposite side elevation view thereof;  
 FIG. 6 is a top plan view thereof;  
 FIG. 7 is a bottom plan view thereof; and,  
 FIG. 8 is a rear perspective view of the vented hat, with the vent portion of the hat in a closed orientation.  
 The broken lines depict portions of the vented hat that form no part of the claimed design.

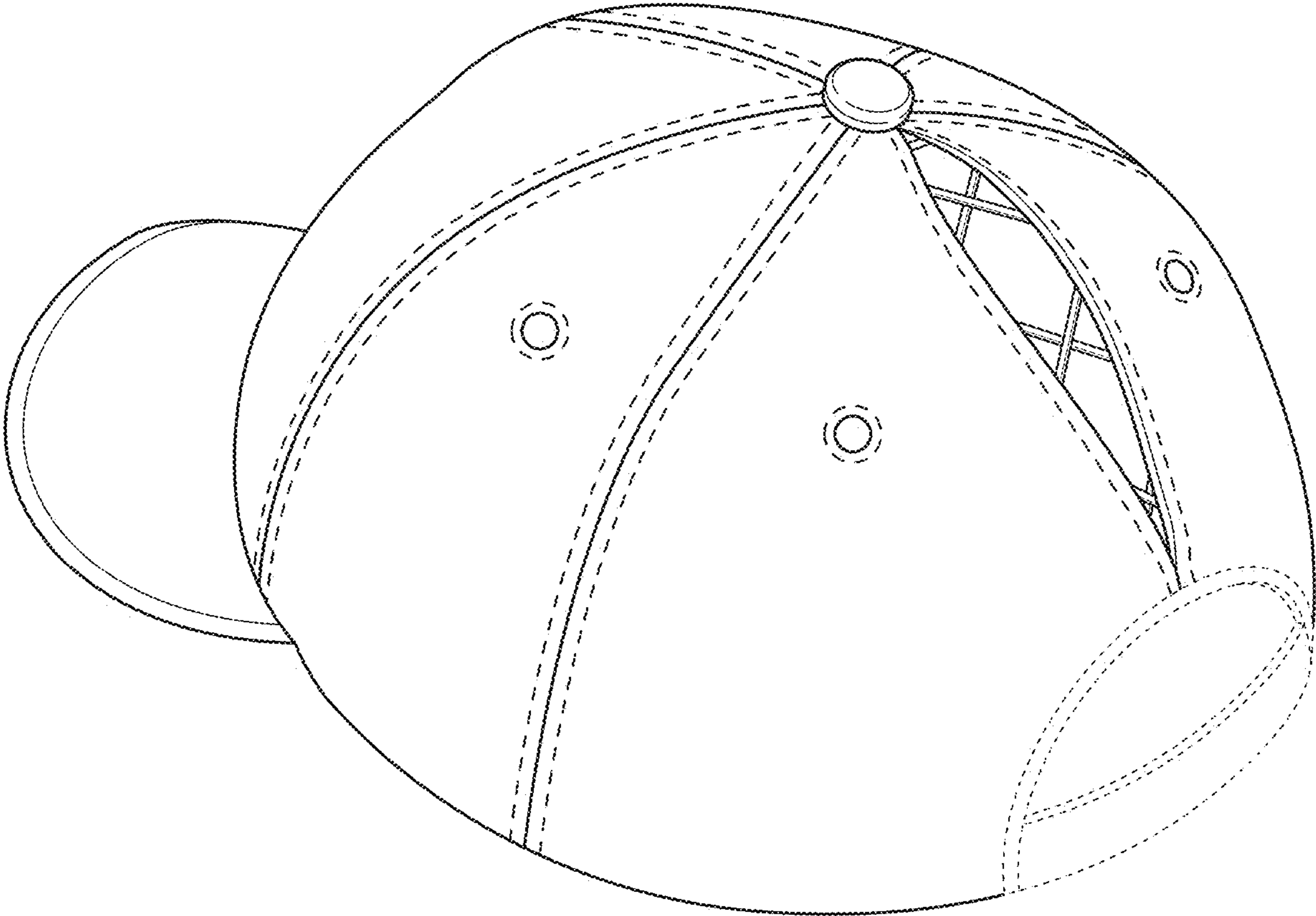

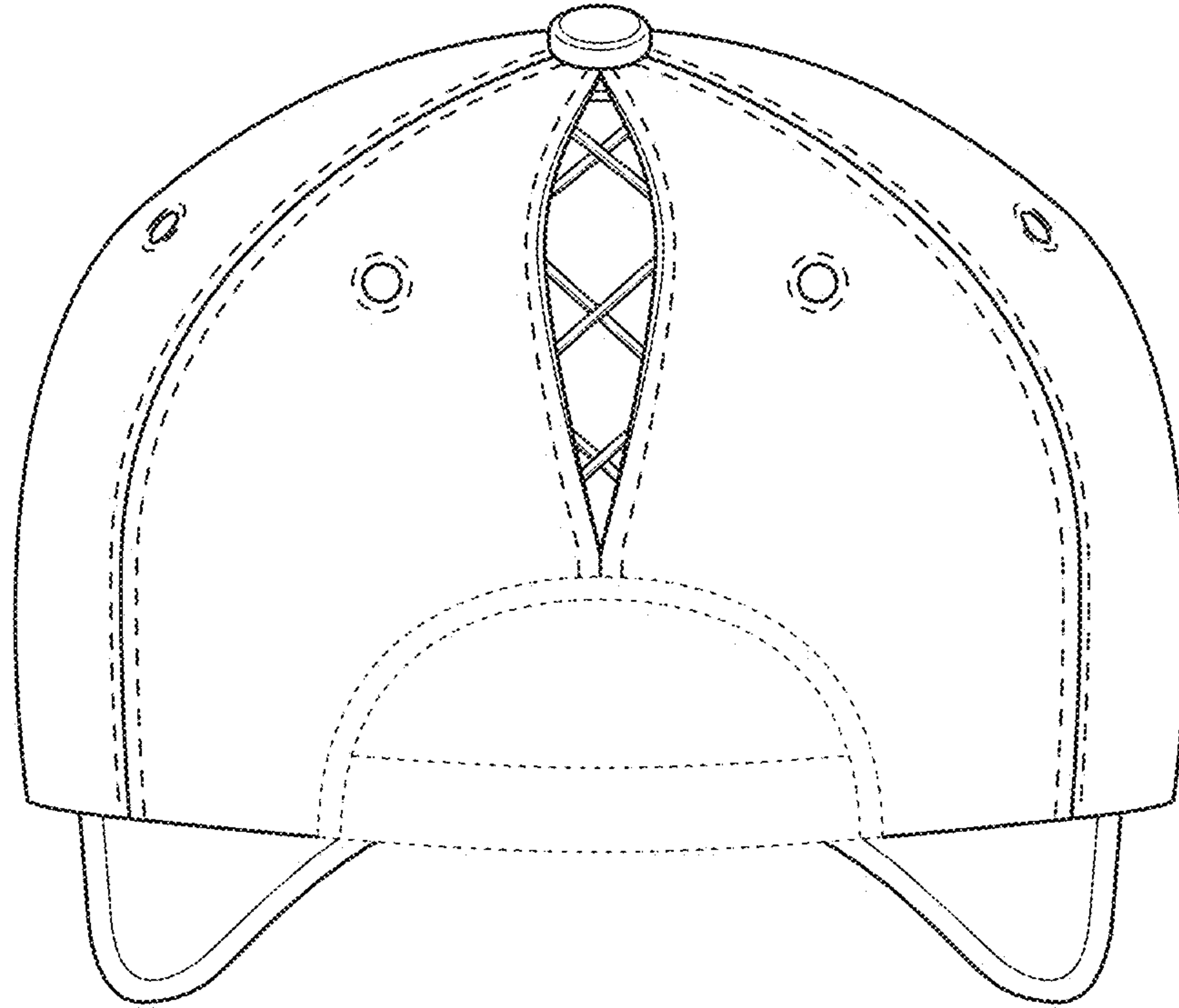

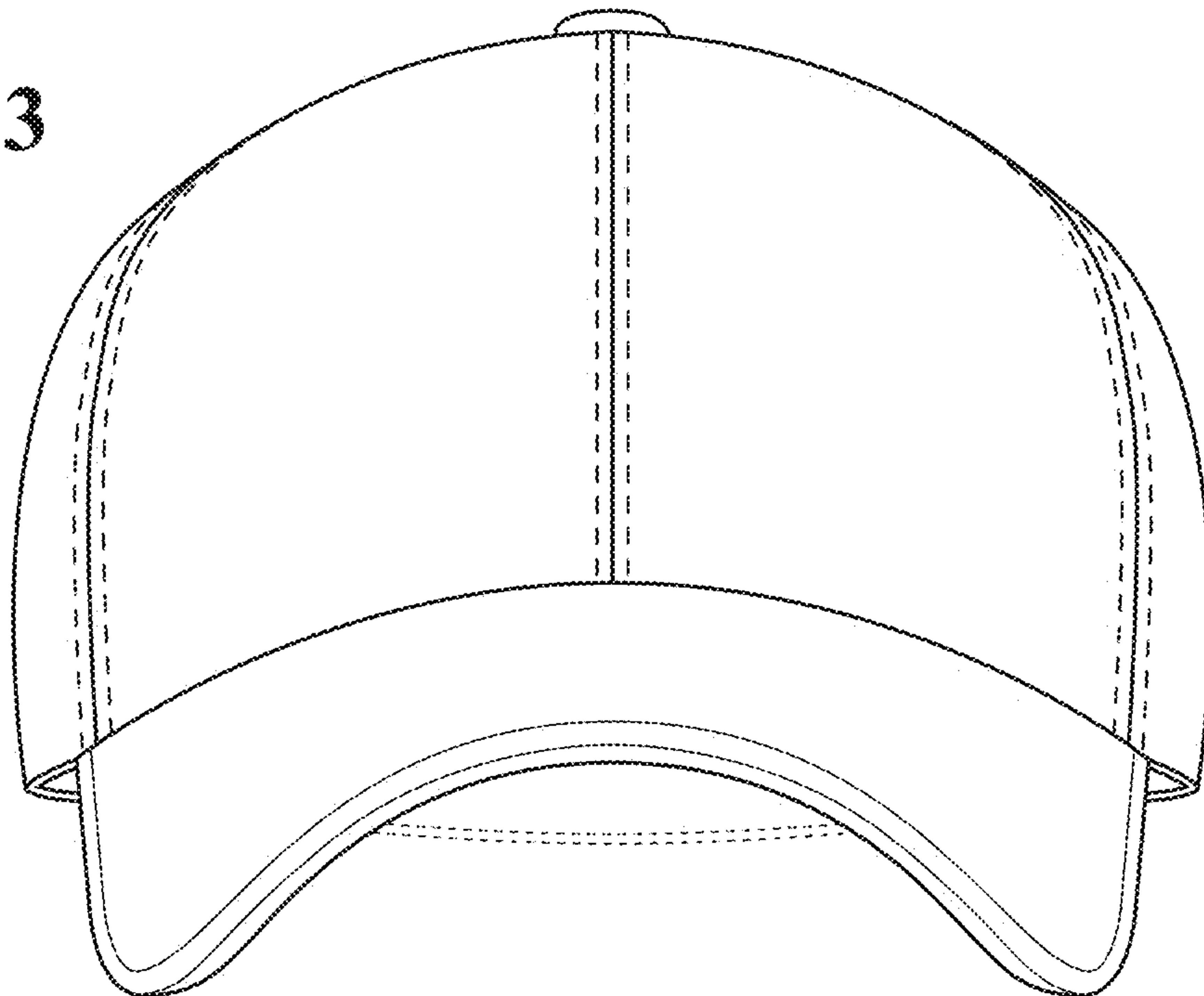

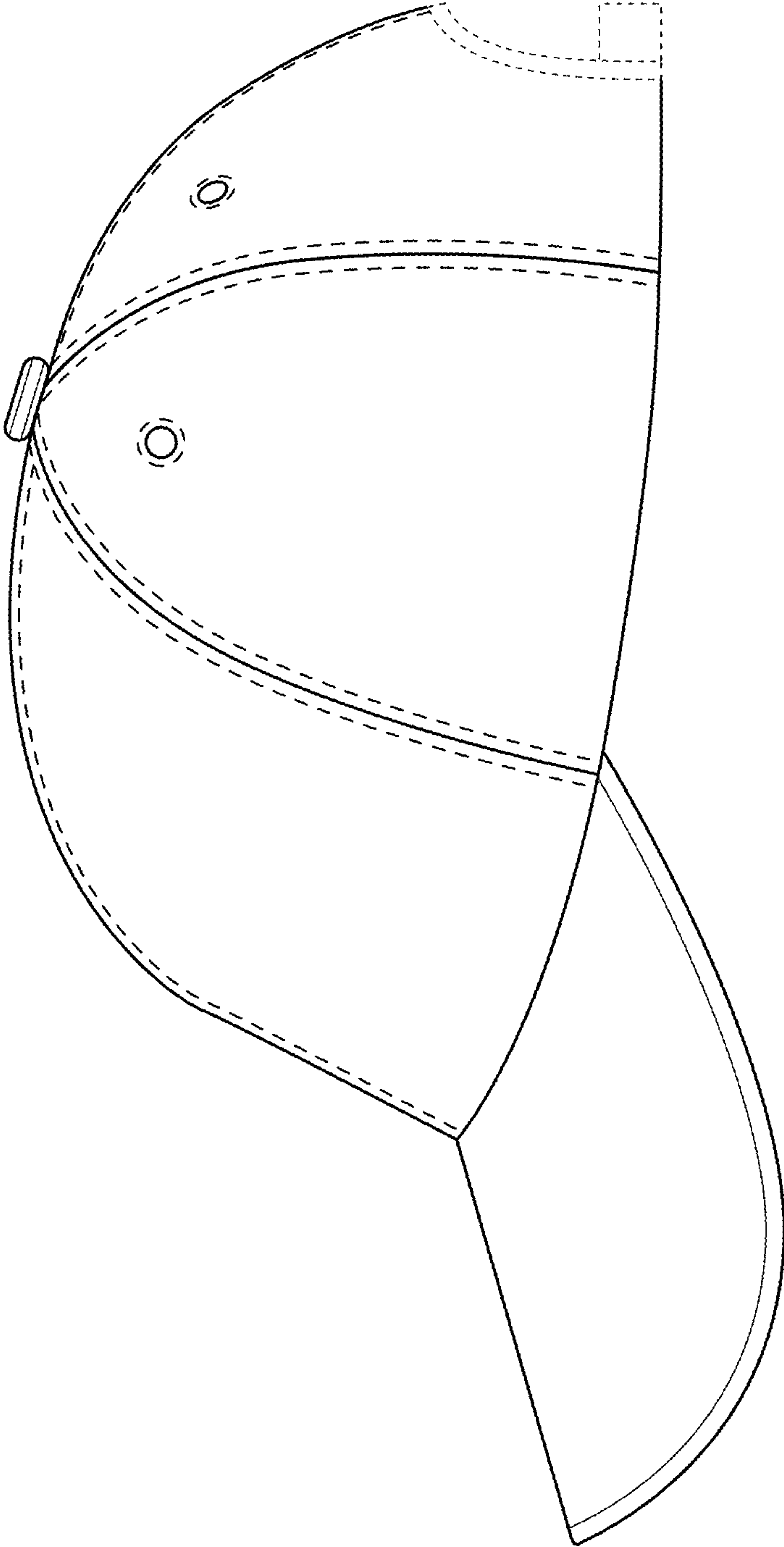

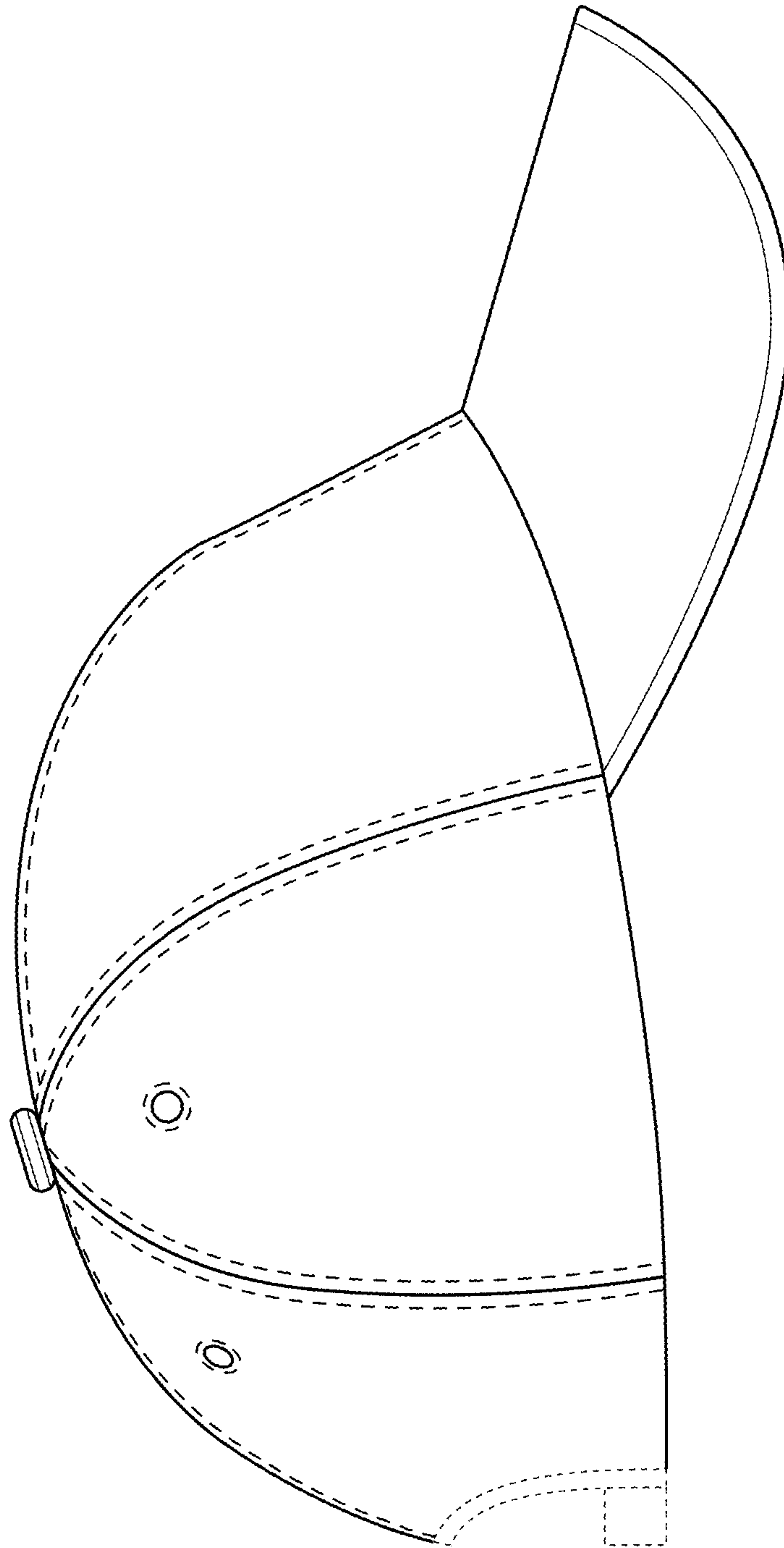

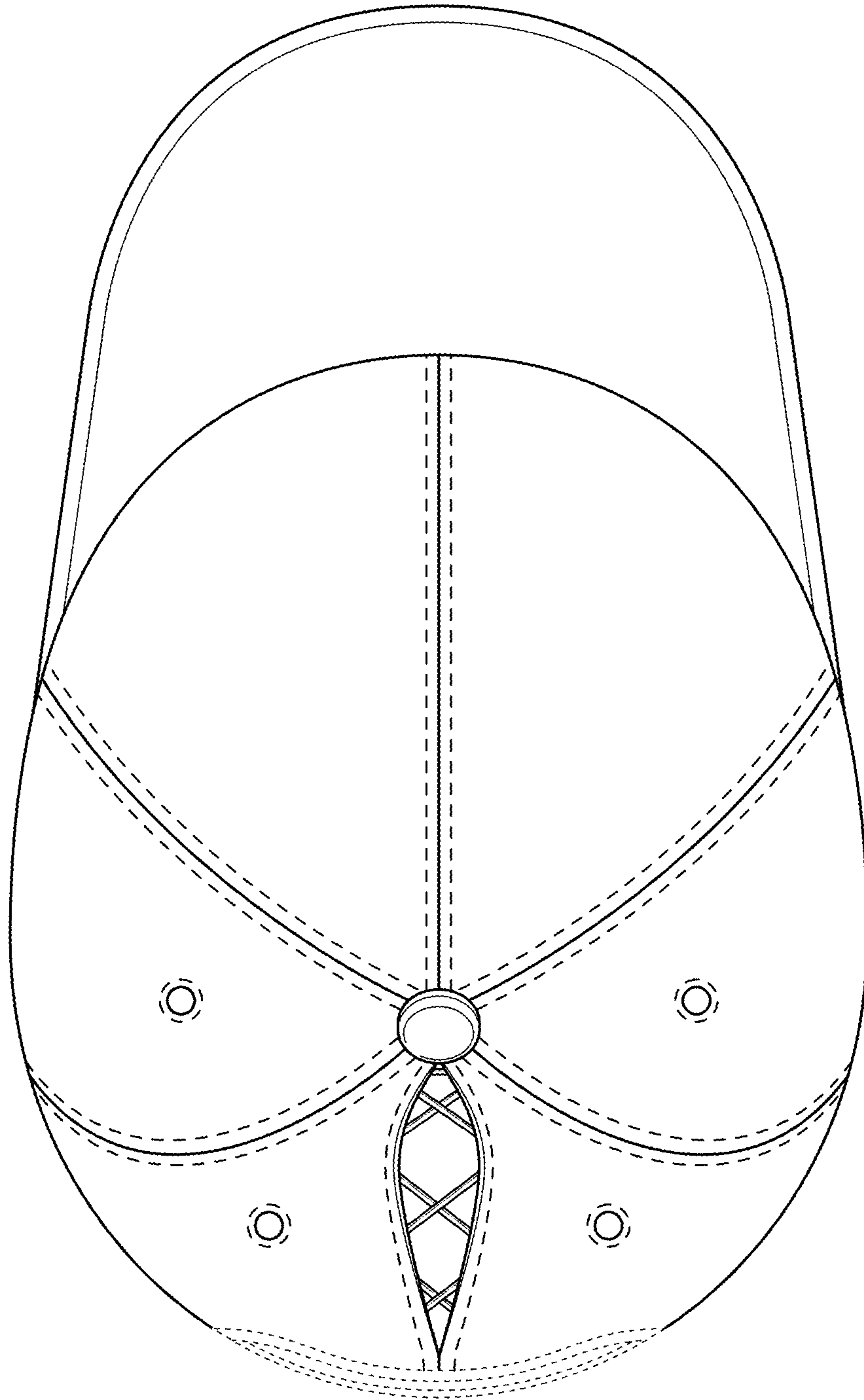

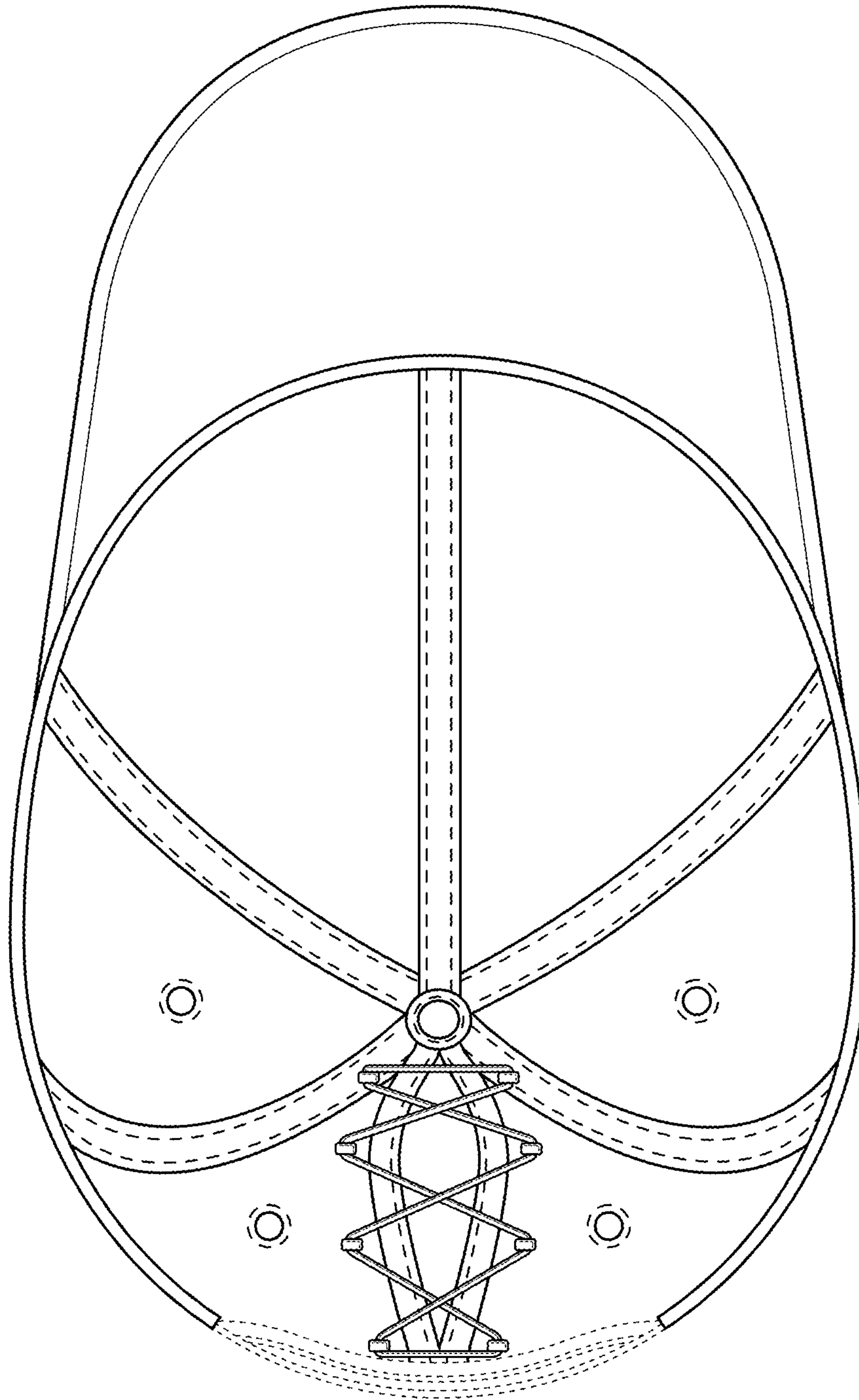
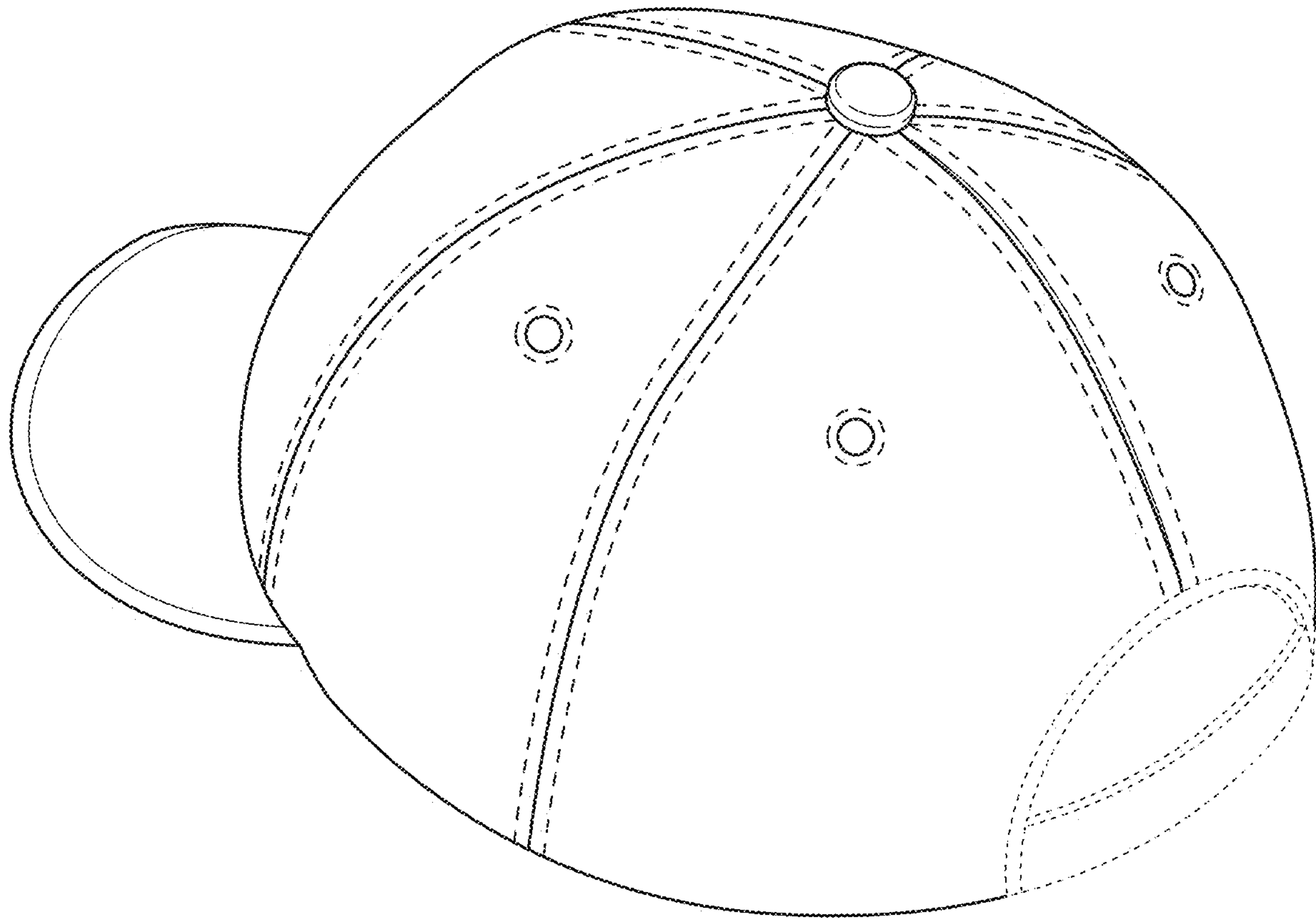
