FIG. 11 is a bottom, rear, right side perspective view thereof;

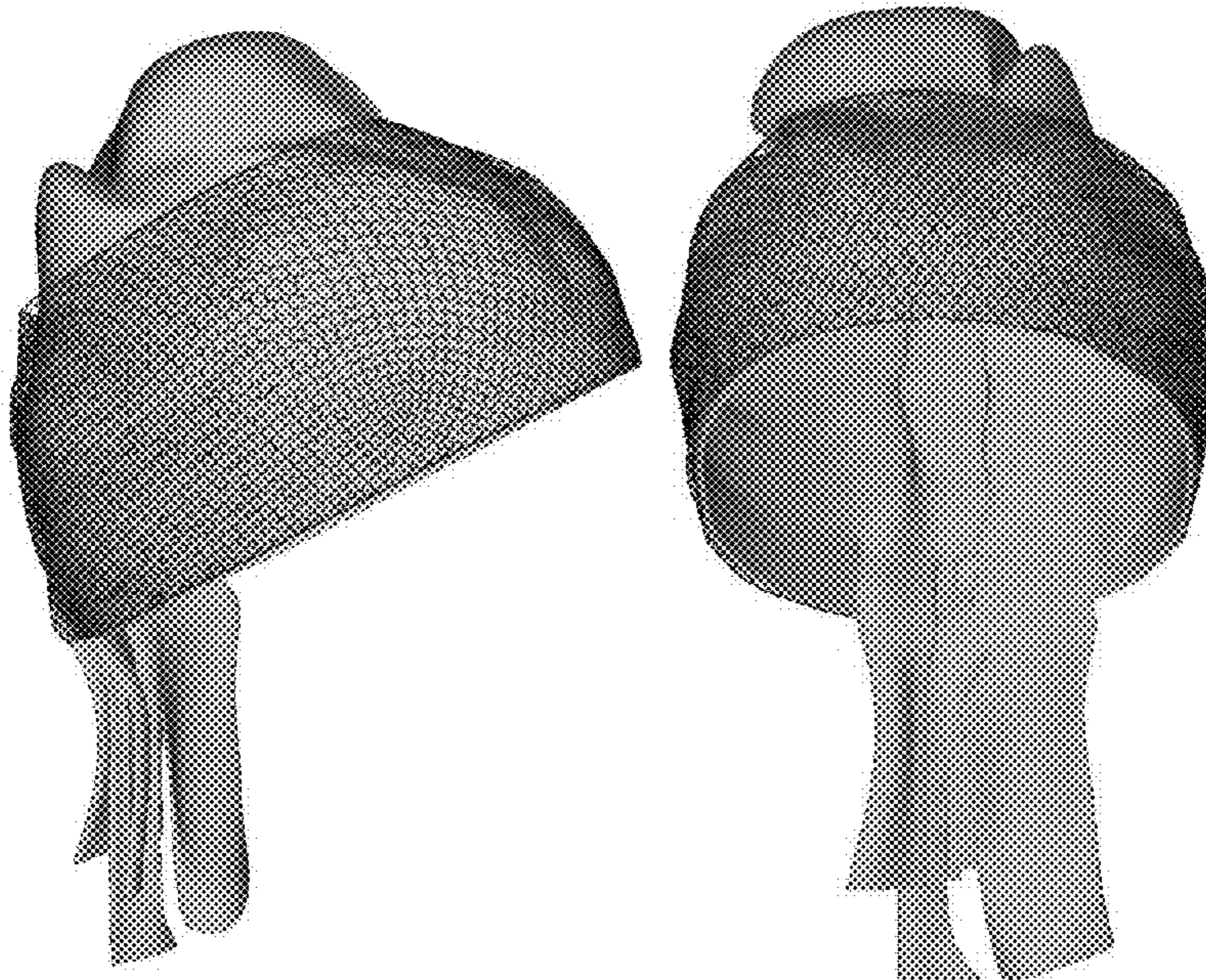
FIG. 12 is a top, front, right side perspective view thereof;

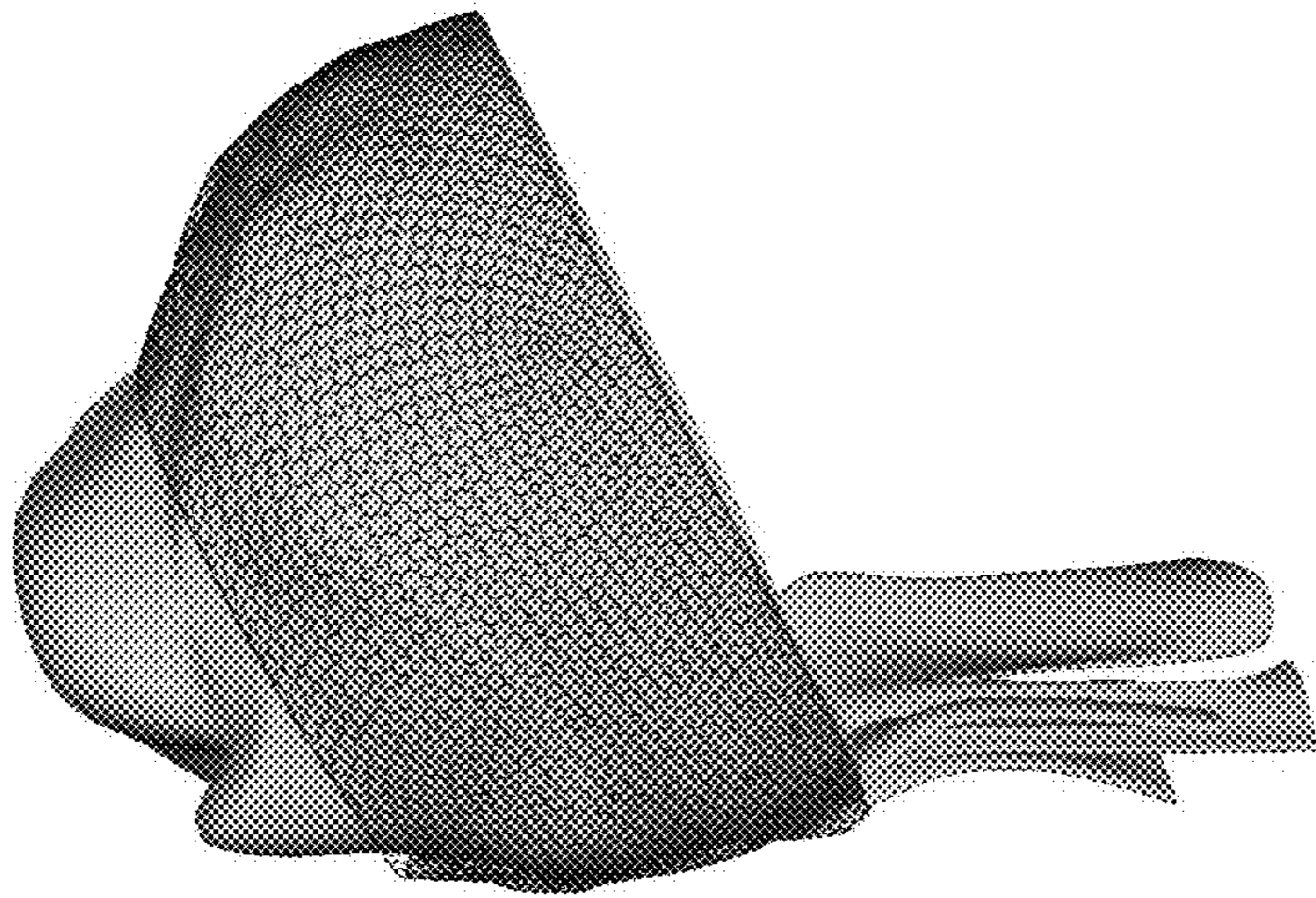

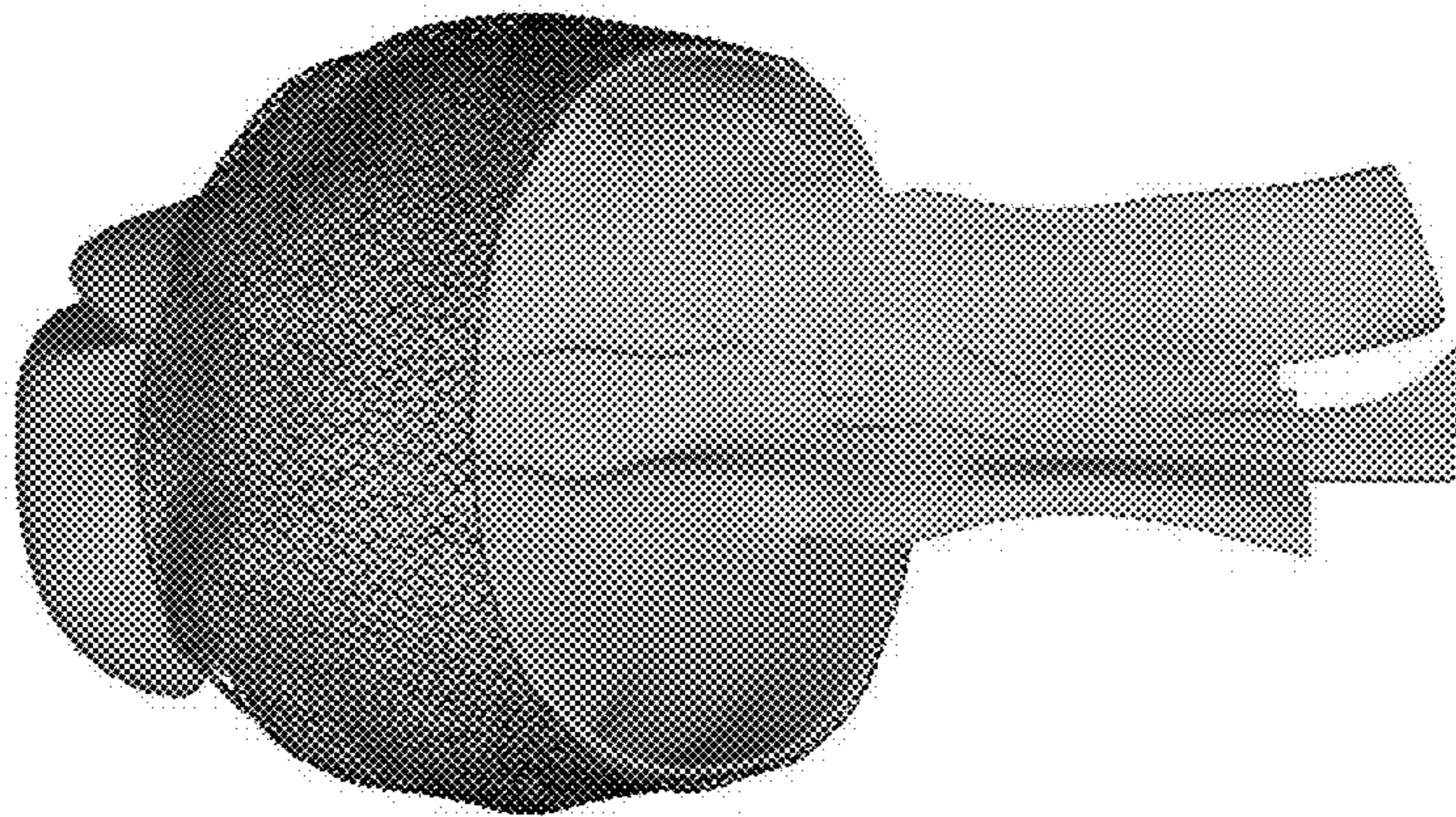

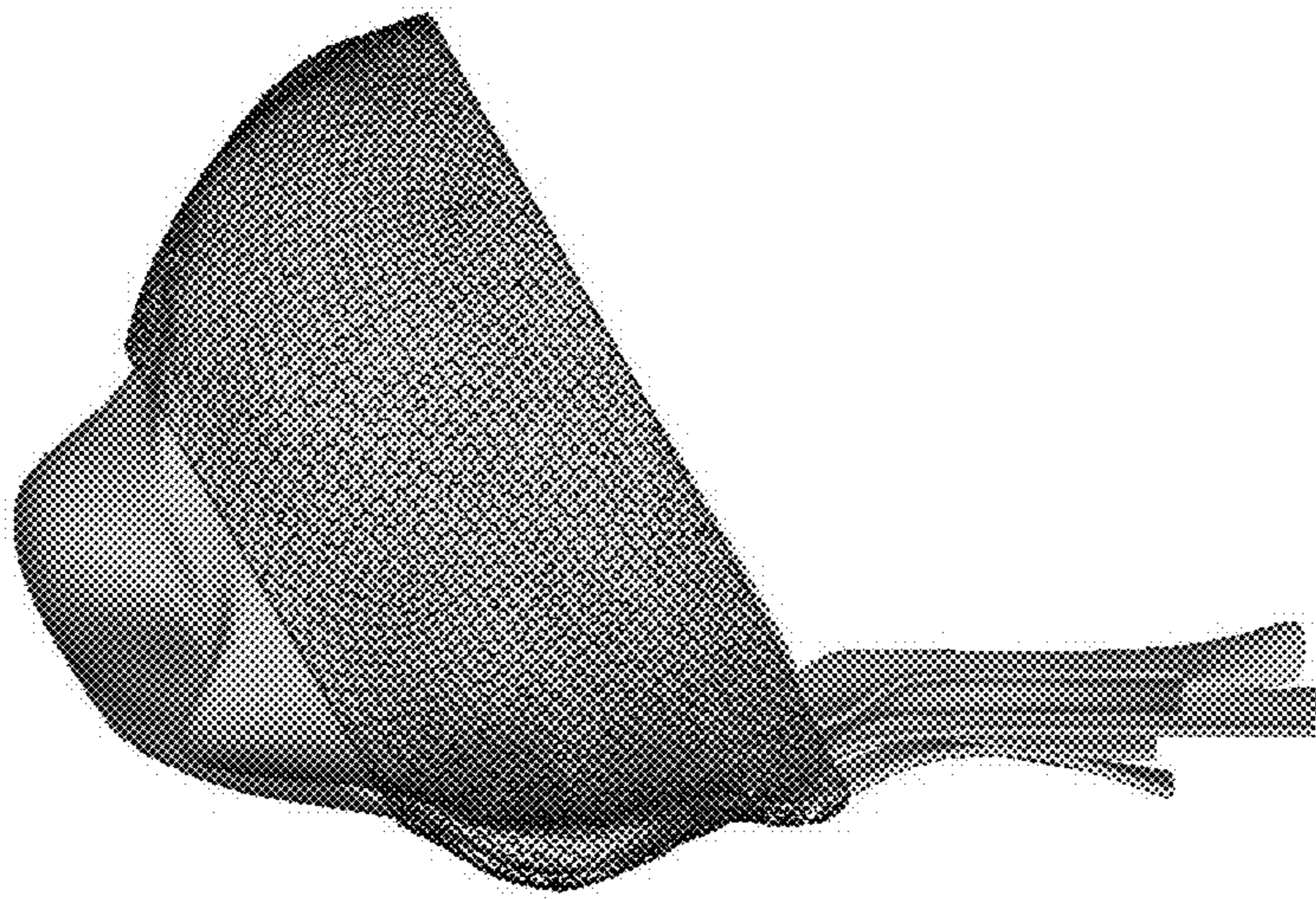

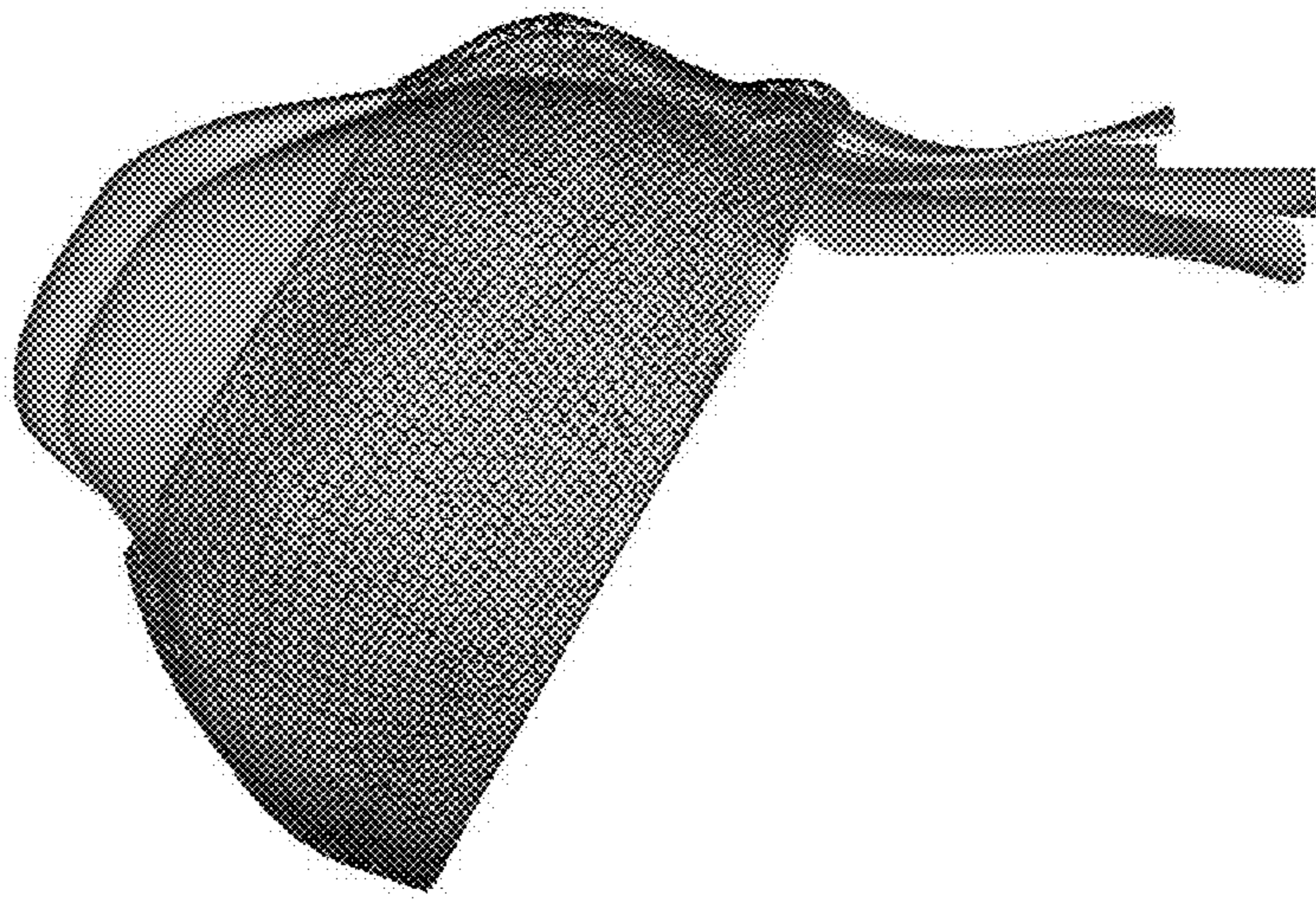

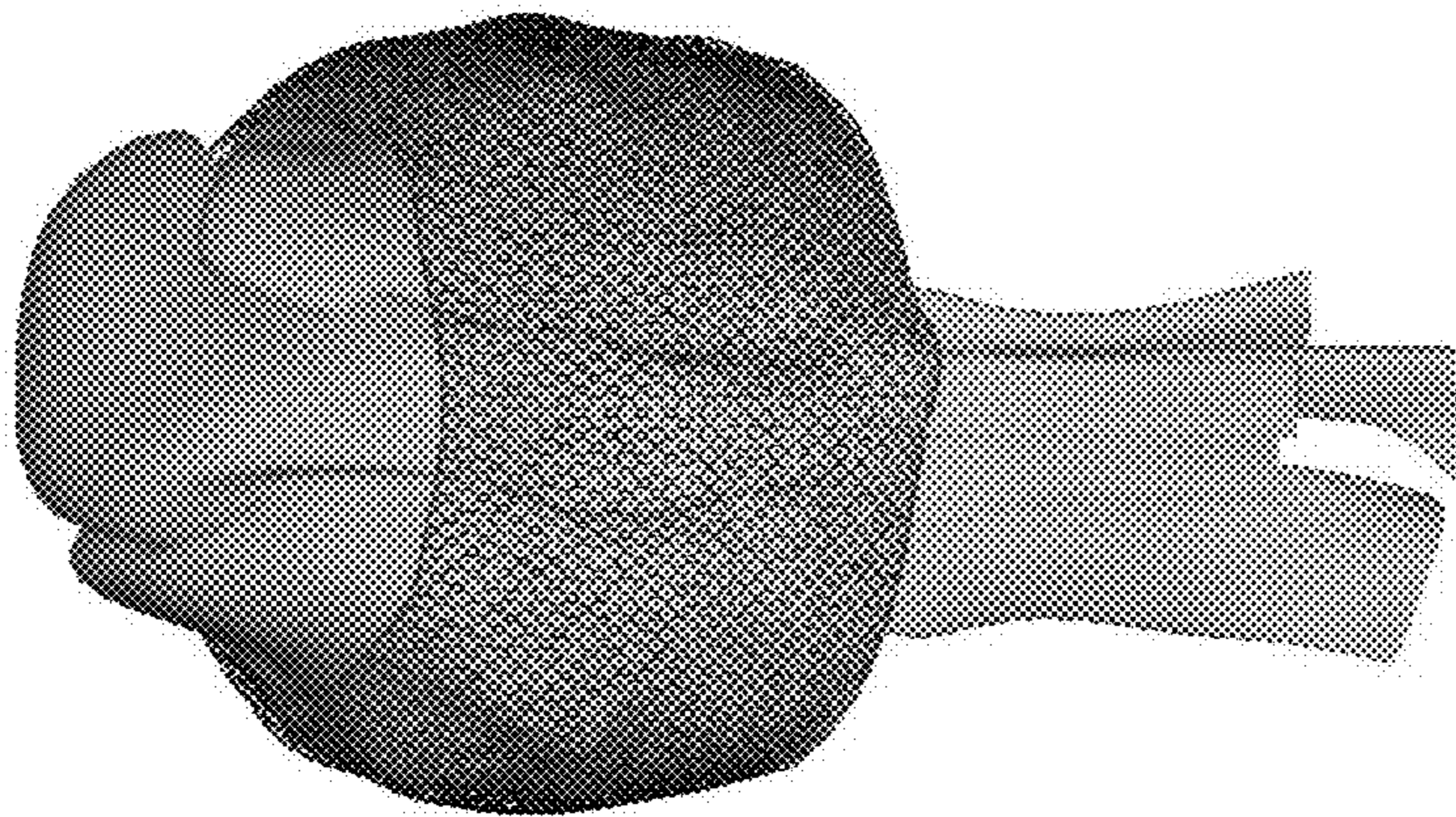

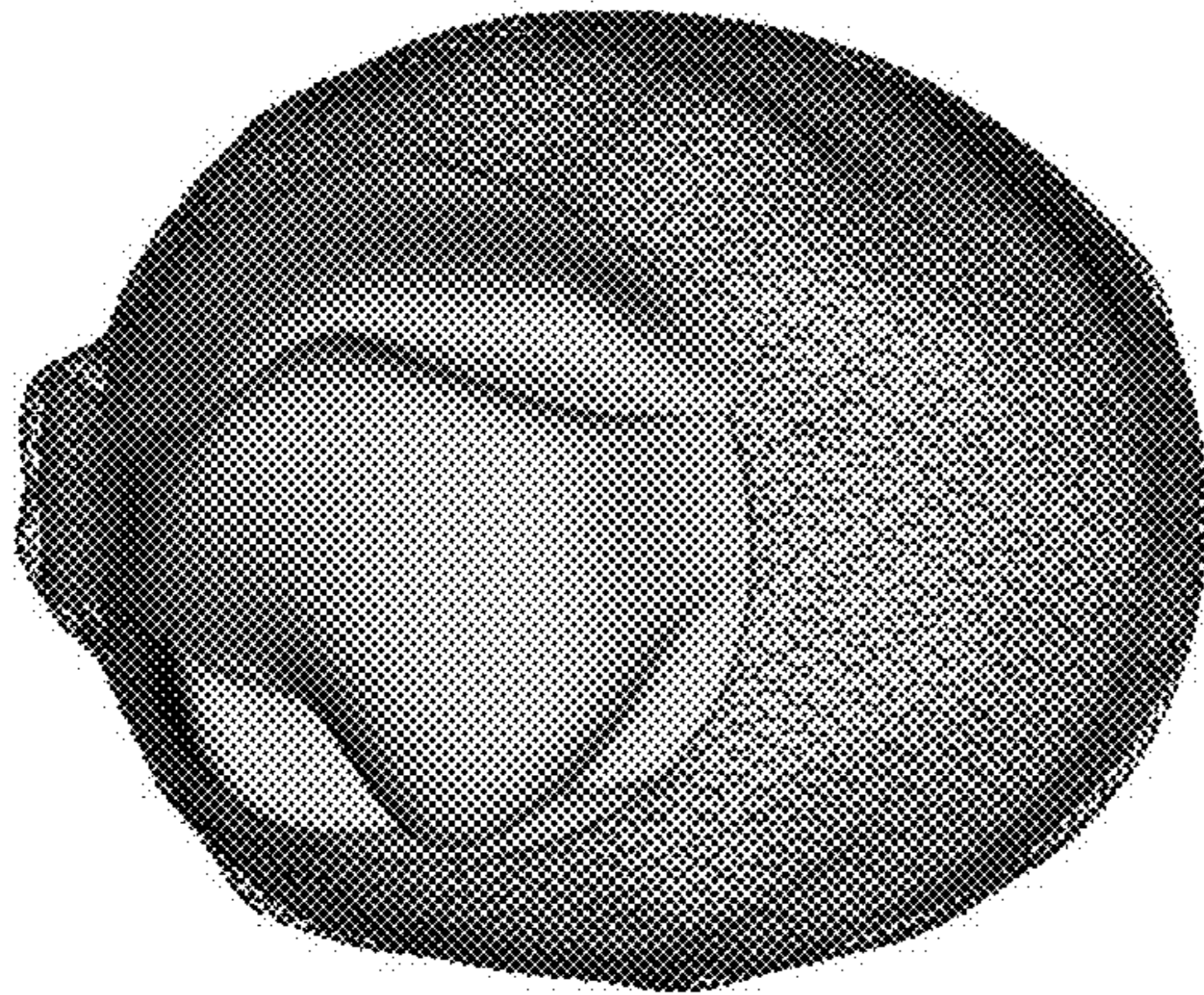

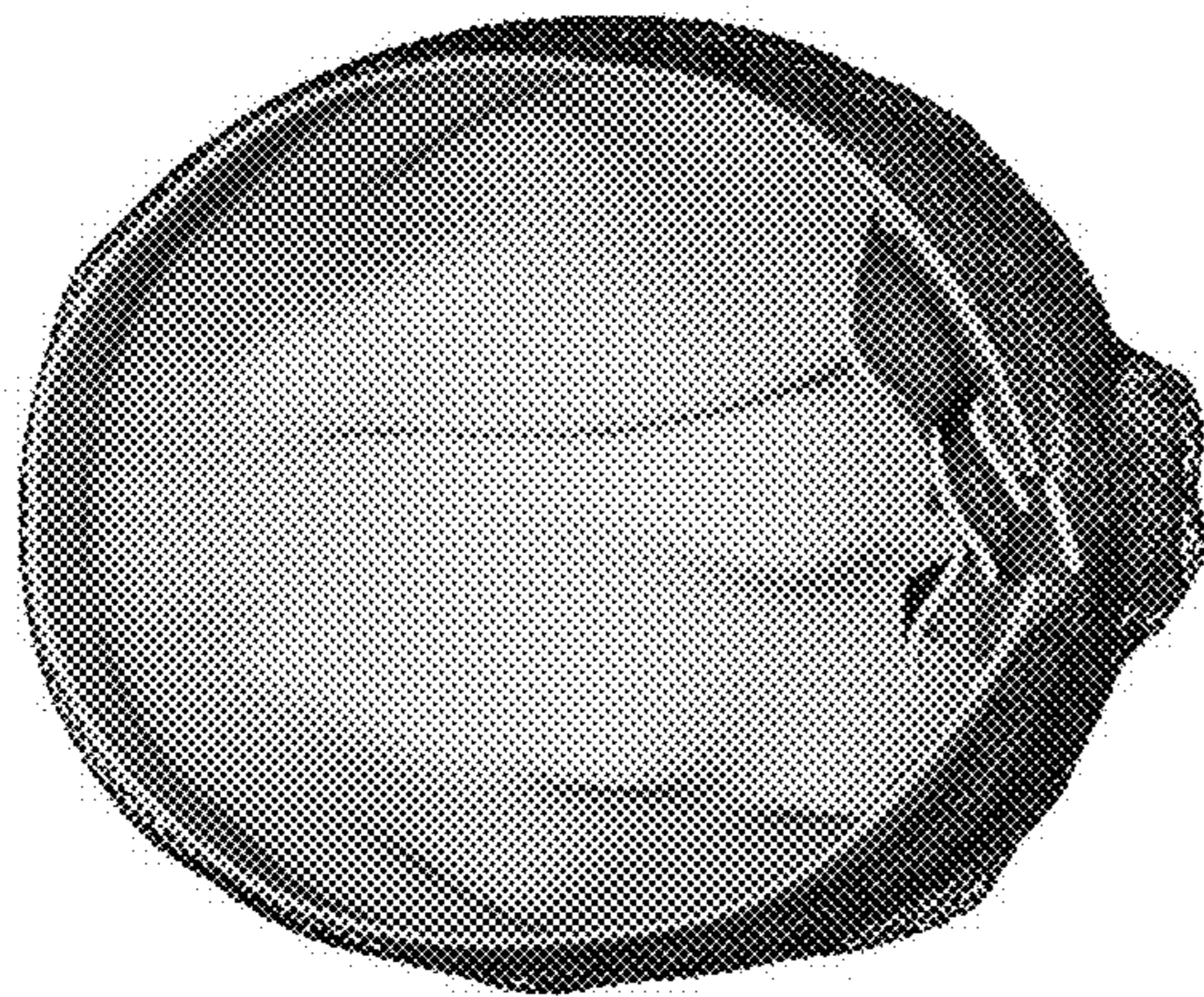

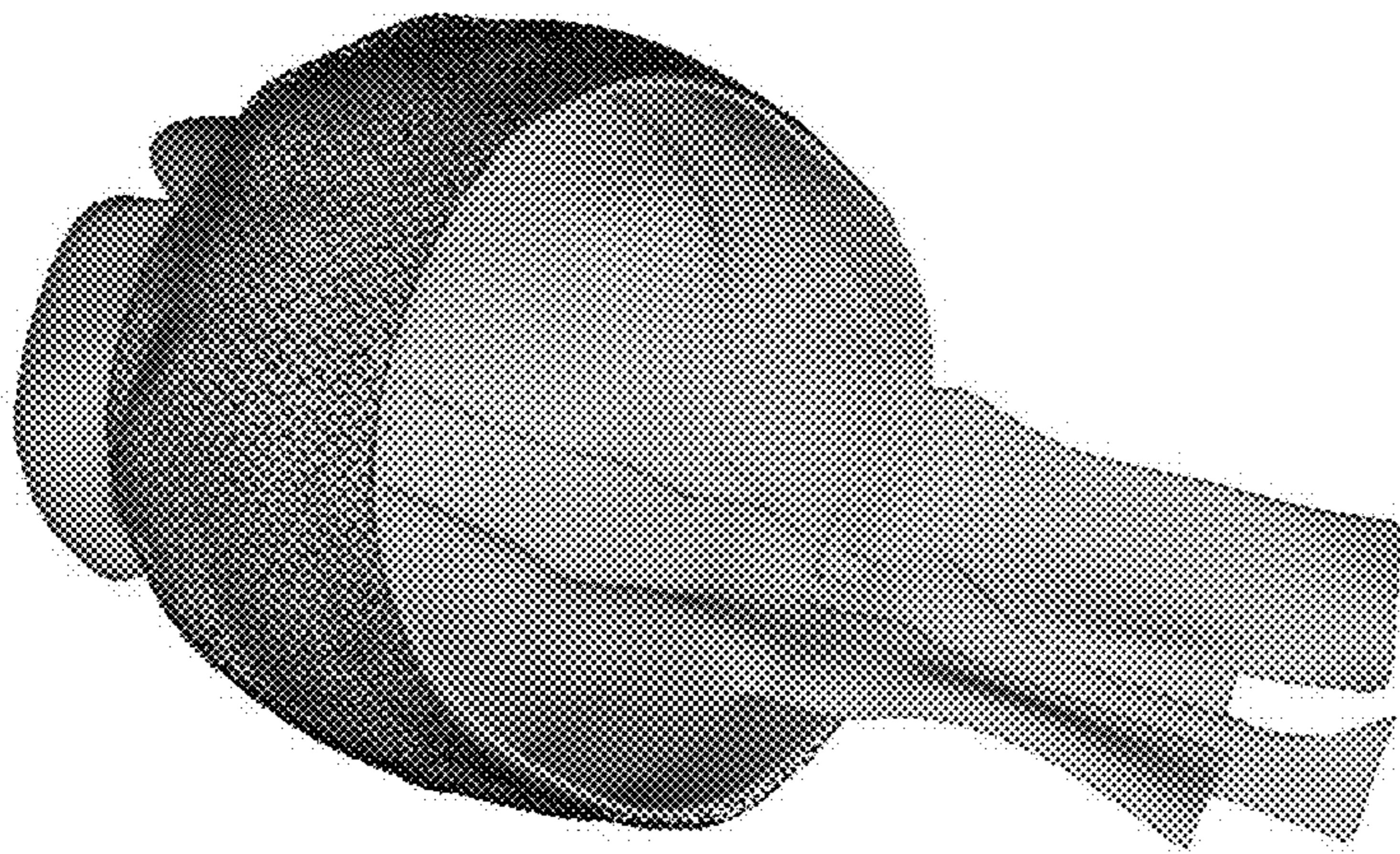

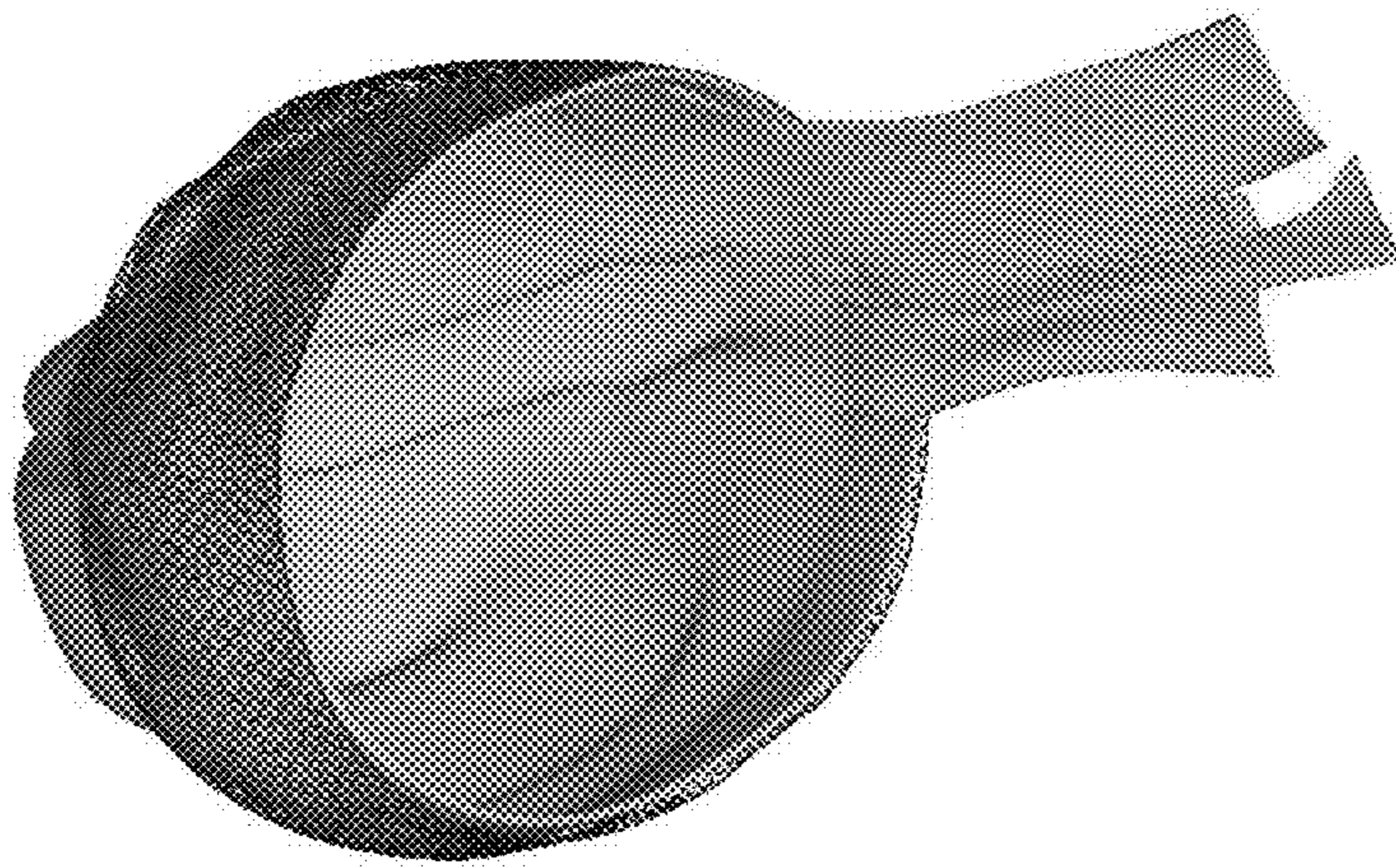

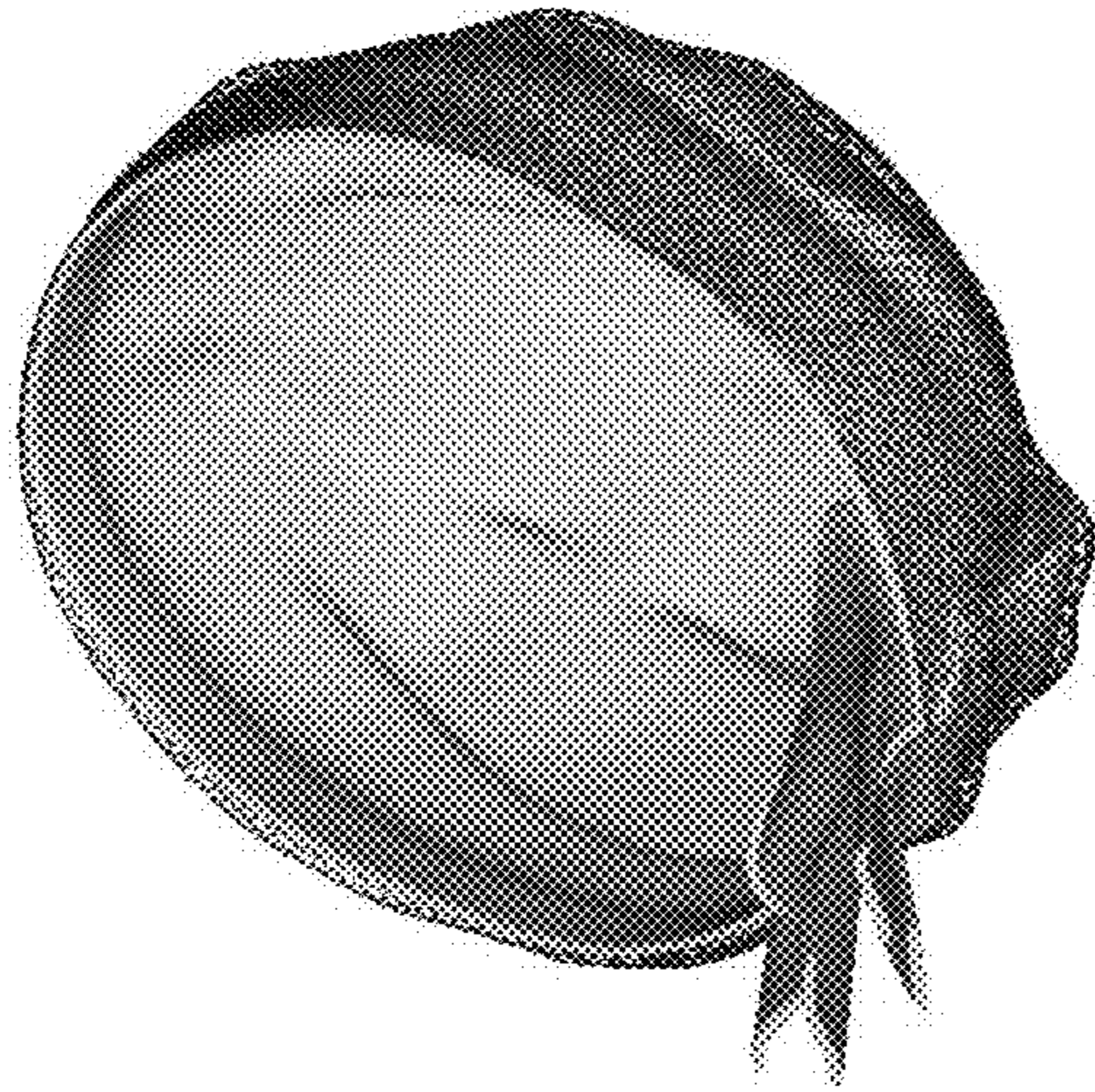

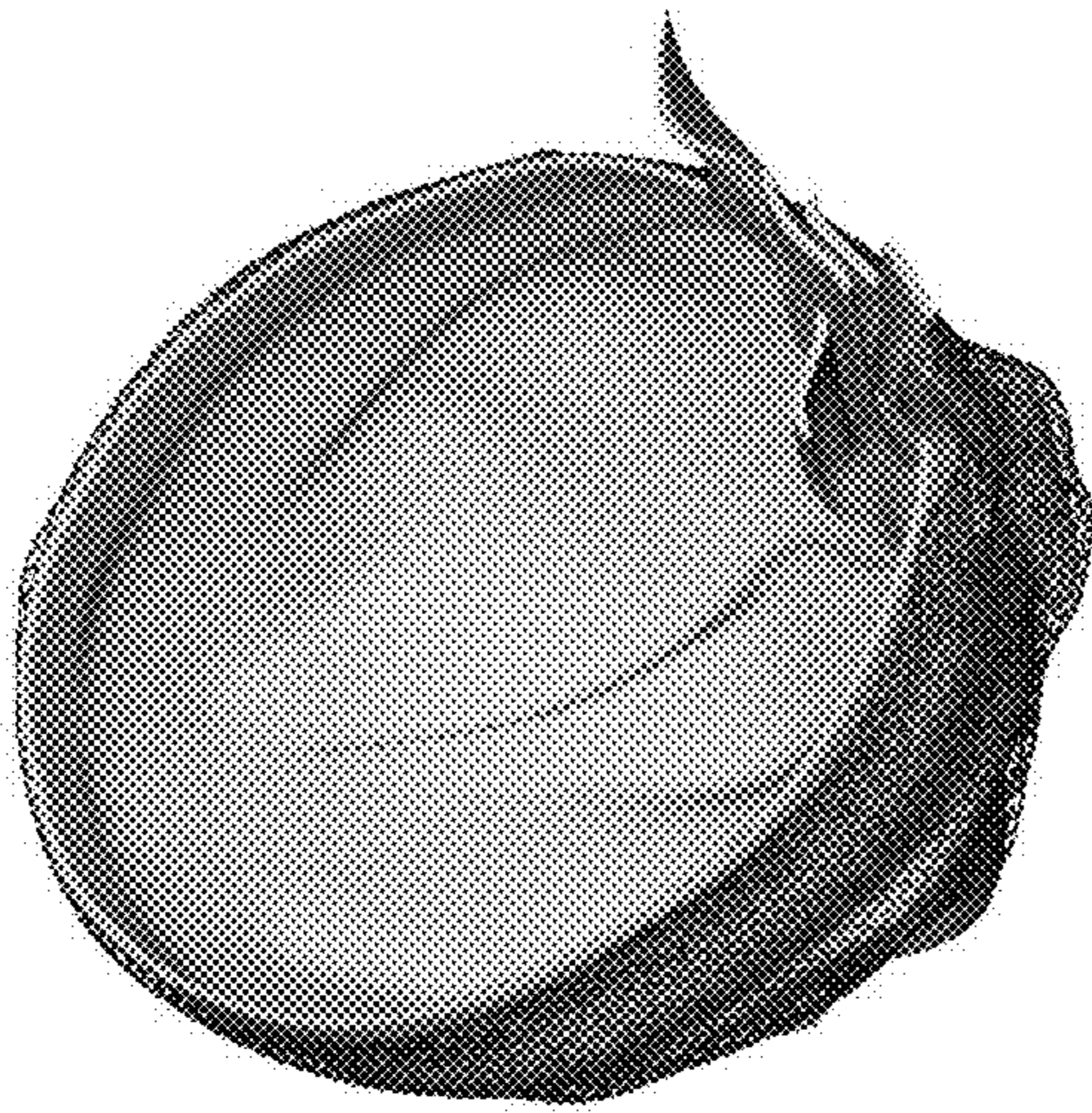

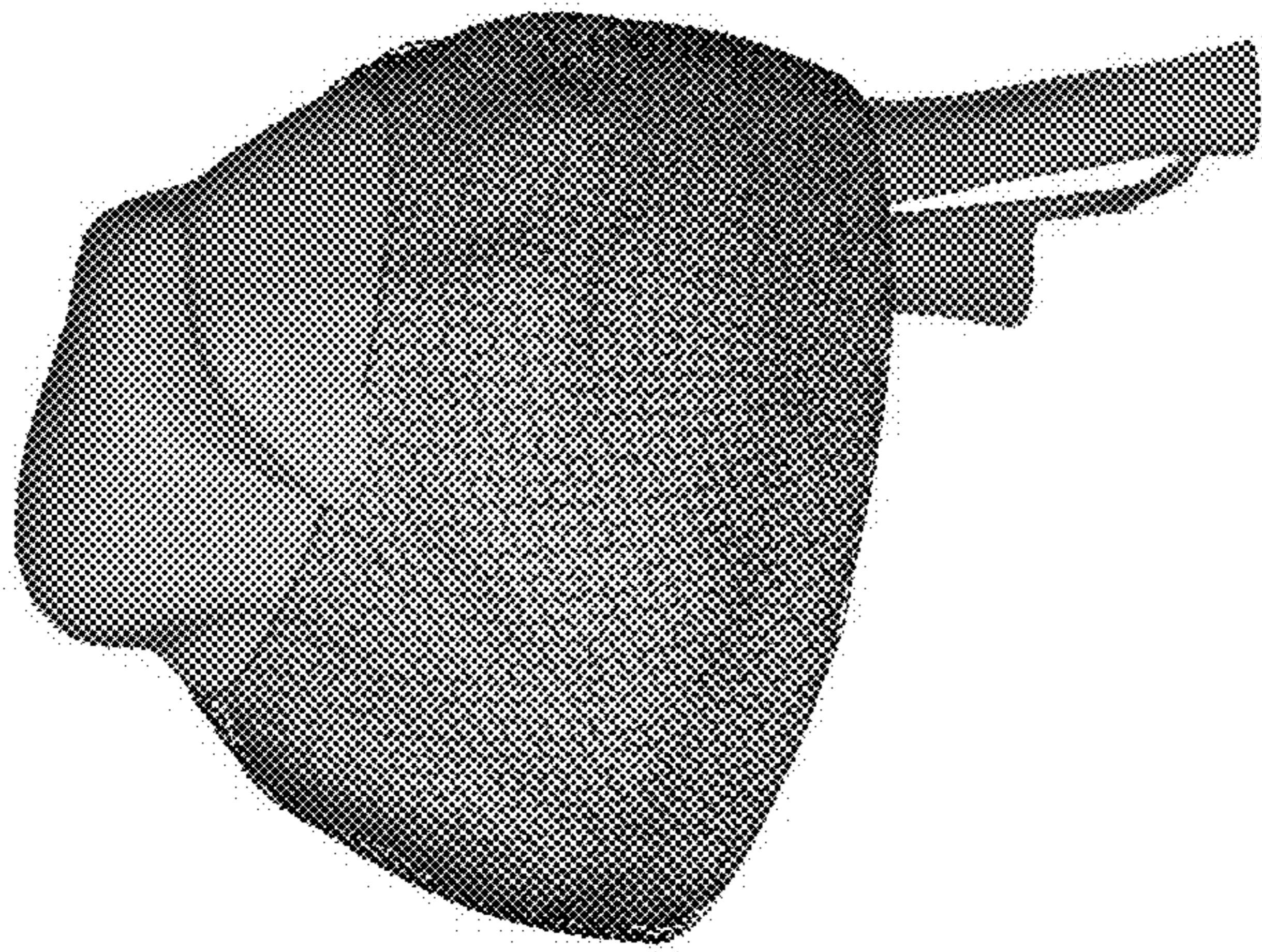

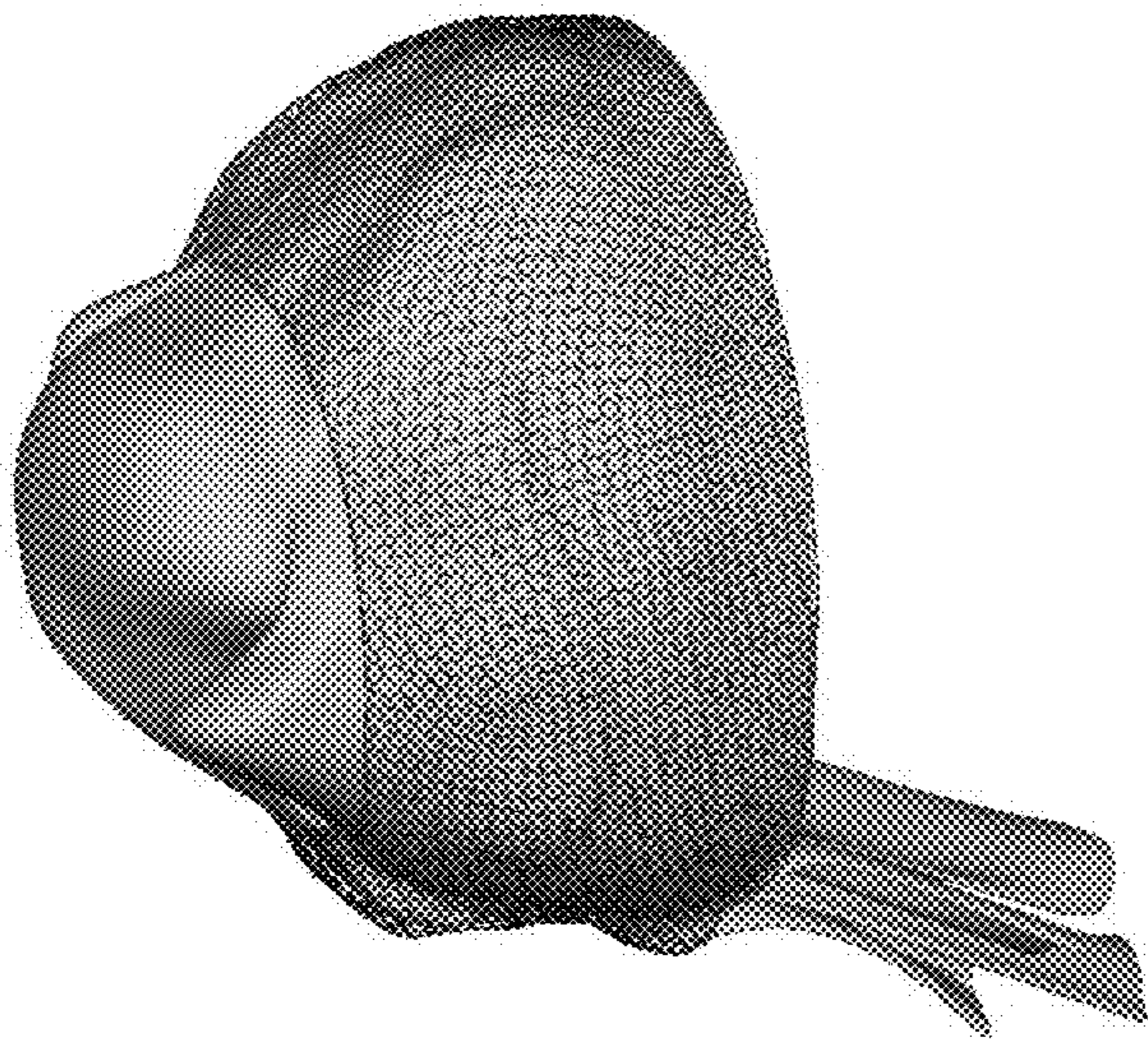

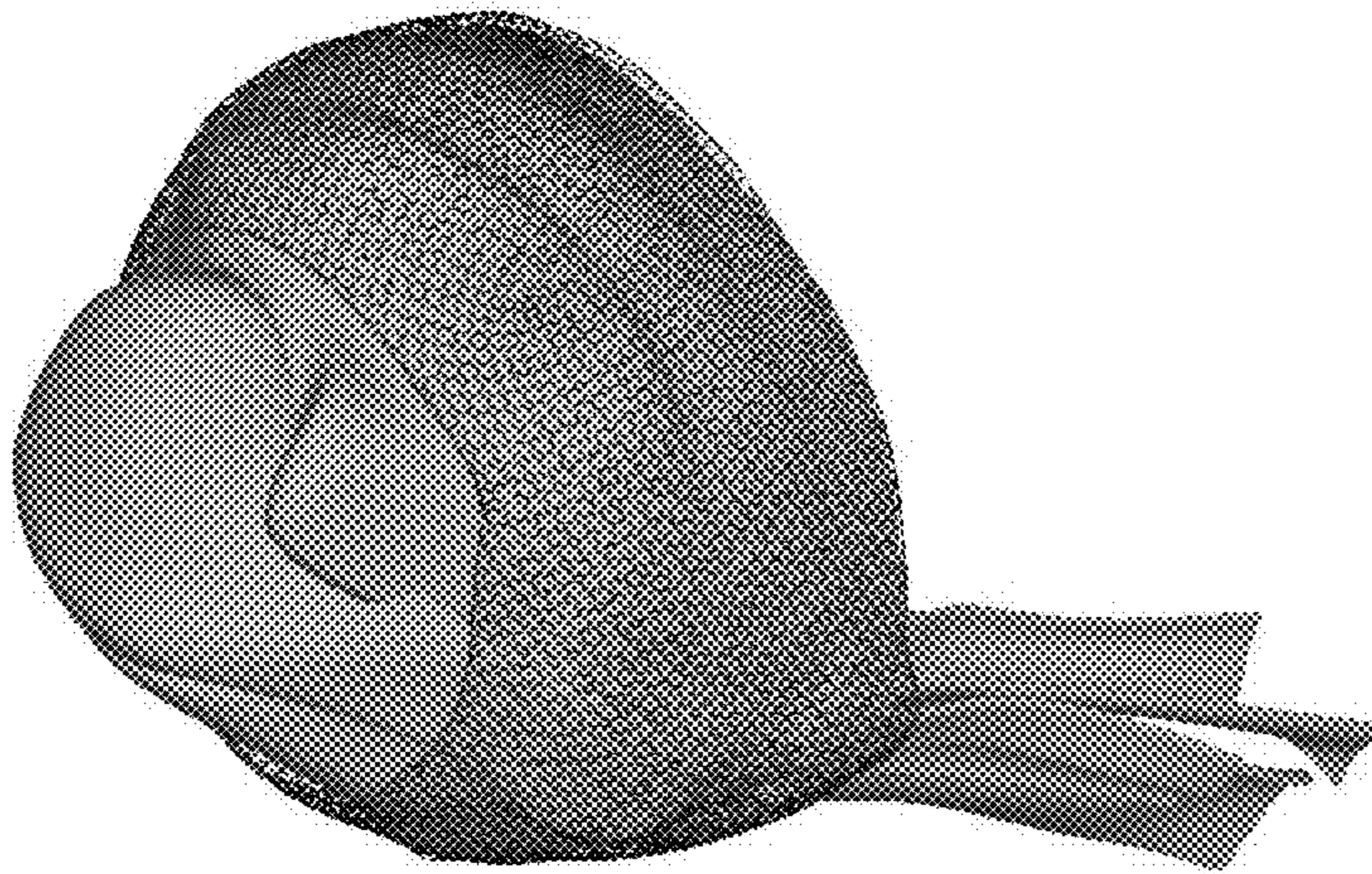

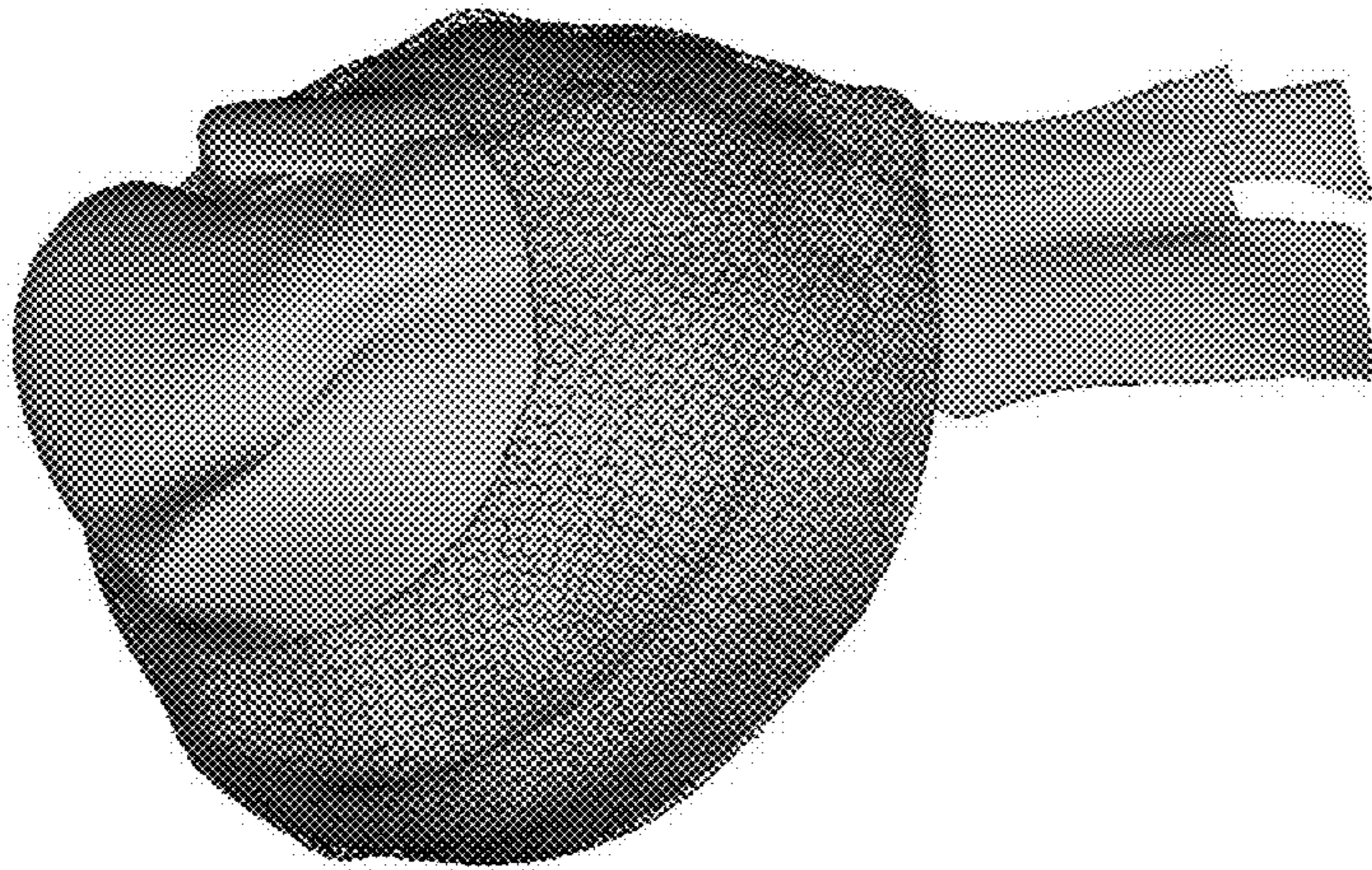
