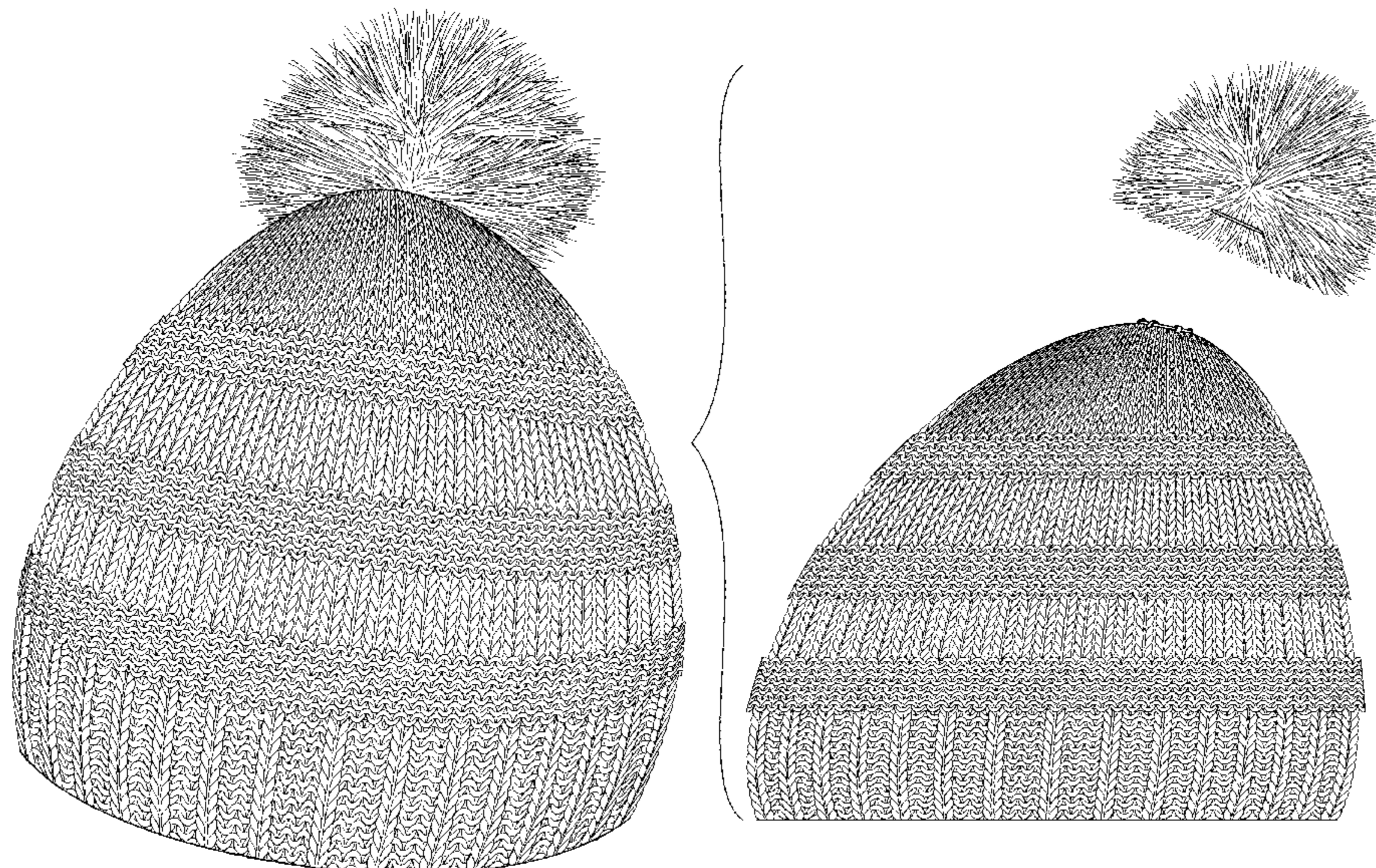
(57) **CLAIM**

I claim the ornamental design for a knitted hat with detach-
able pom-pom, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a knitted hat with detachable
pom-pom, showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a right-side elevational view thereof, the left-side
elevational view being a mirror image thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is an exploded perspective view of the knitted hat
with detachable pom-pom in which the pom-pom has been
removed;
FIG. 8 is an exploded front elevational view thereof;
FIG. 9 is an exploded rear elevational view thereof;
FIG. 10 is an exploded right-side elevational view thereof,
the left-side elevational view being a mirror image thereof;
FIG. 11 is an exploded top plan view thereof; and,
FIG. 12 is an exploded bottom plan view thereof.
The broken lines in FIGS. 6 and 12 depict portions of the
knitted hat with detachable pom-pom that form no part of the
claimed design.

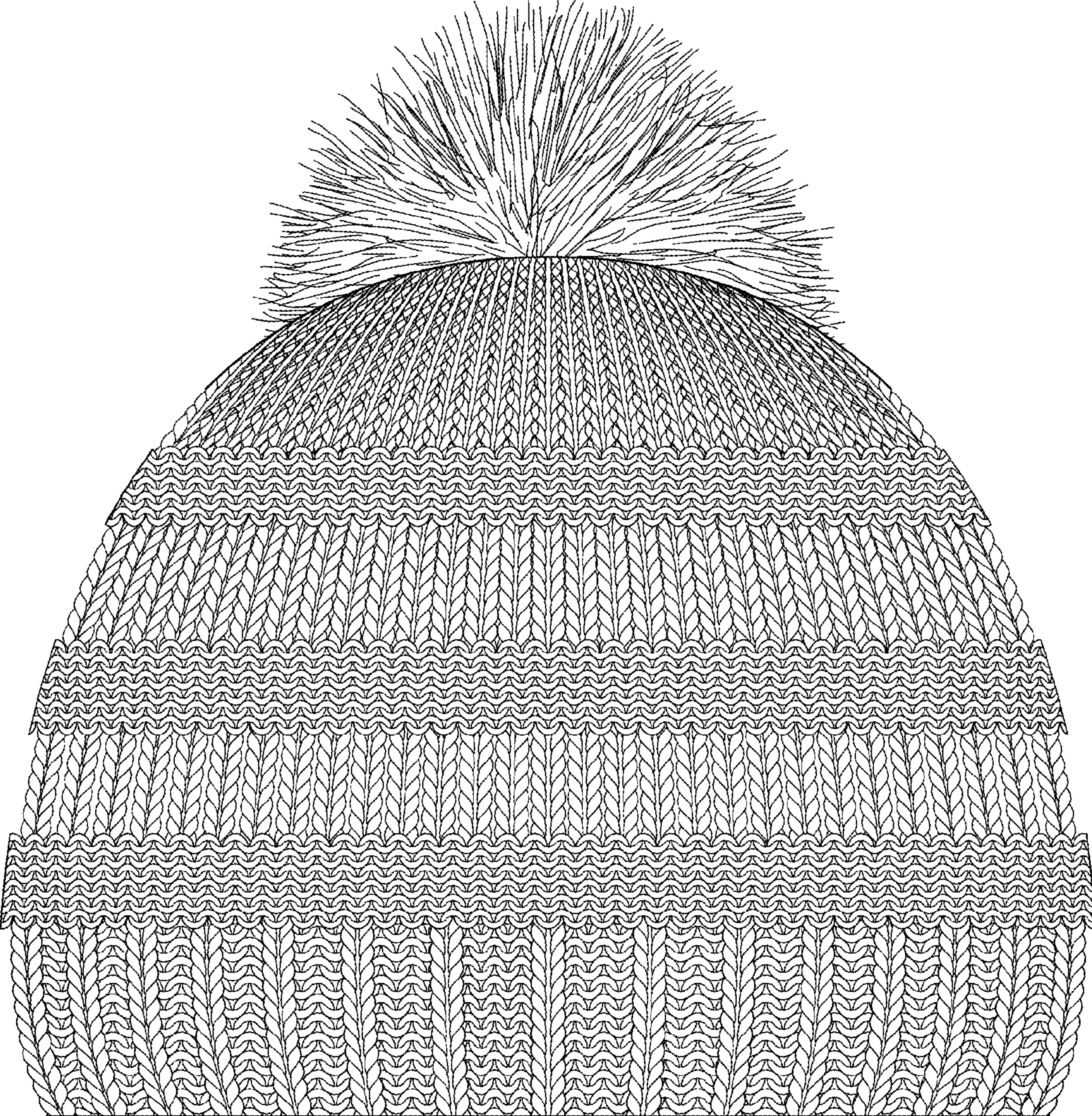

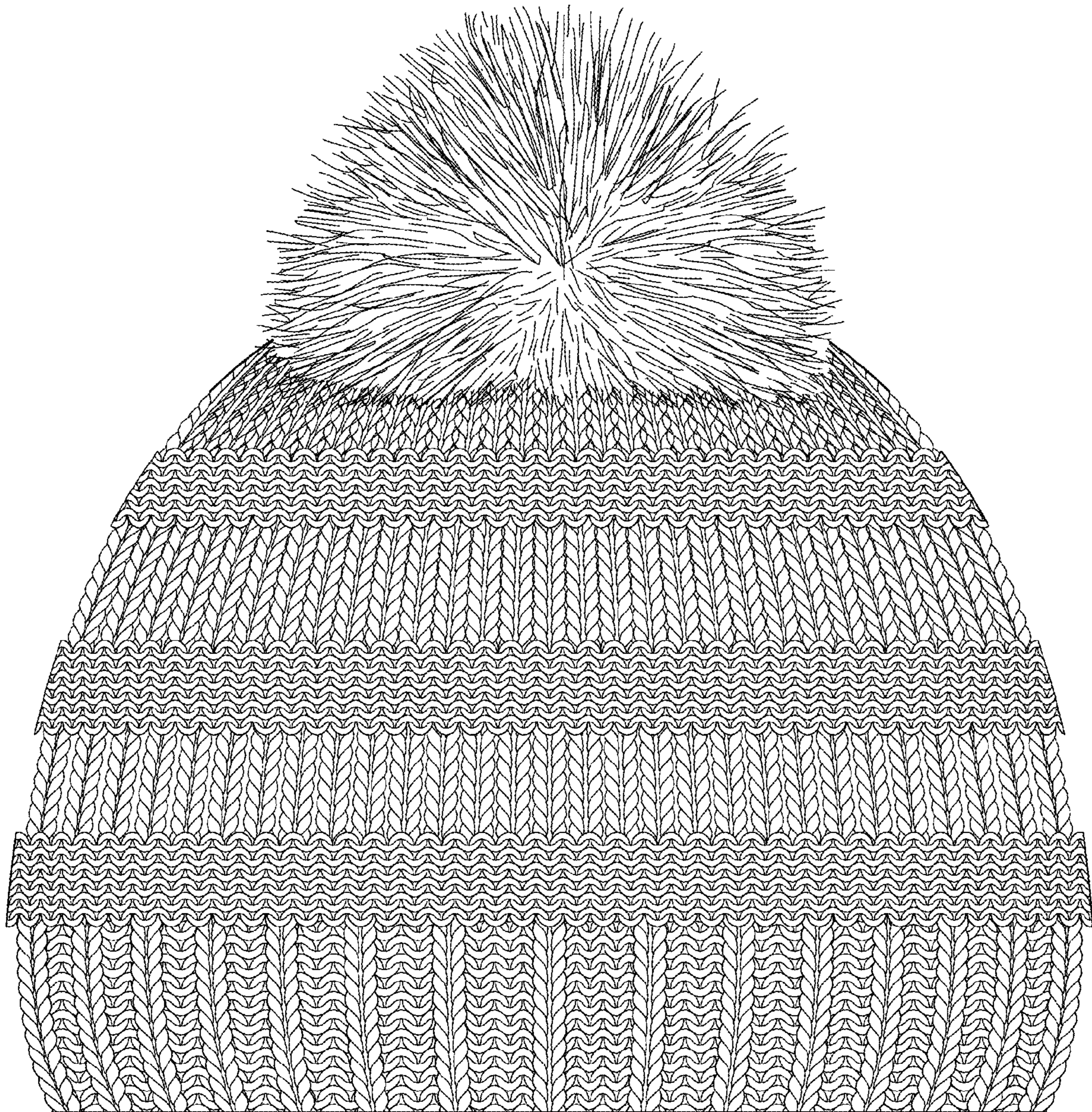

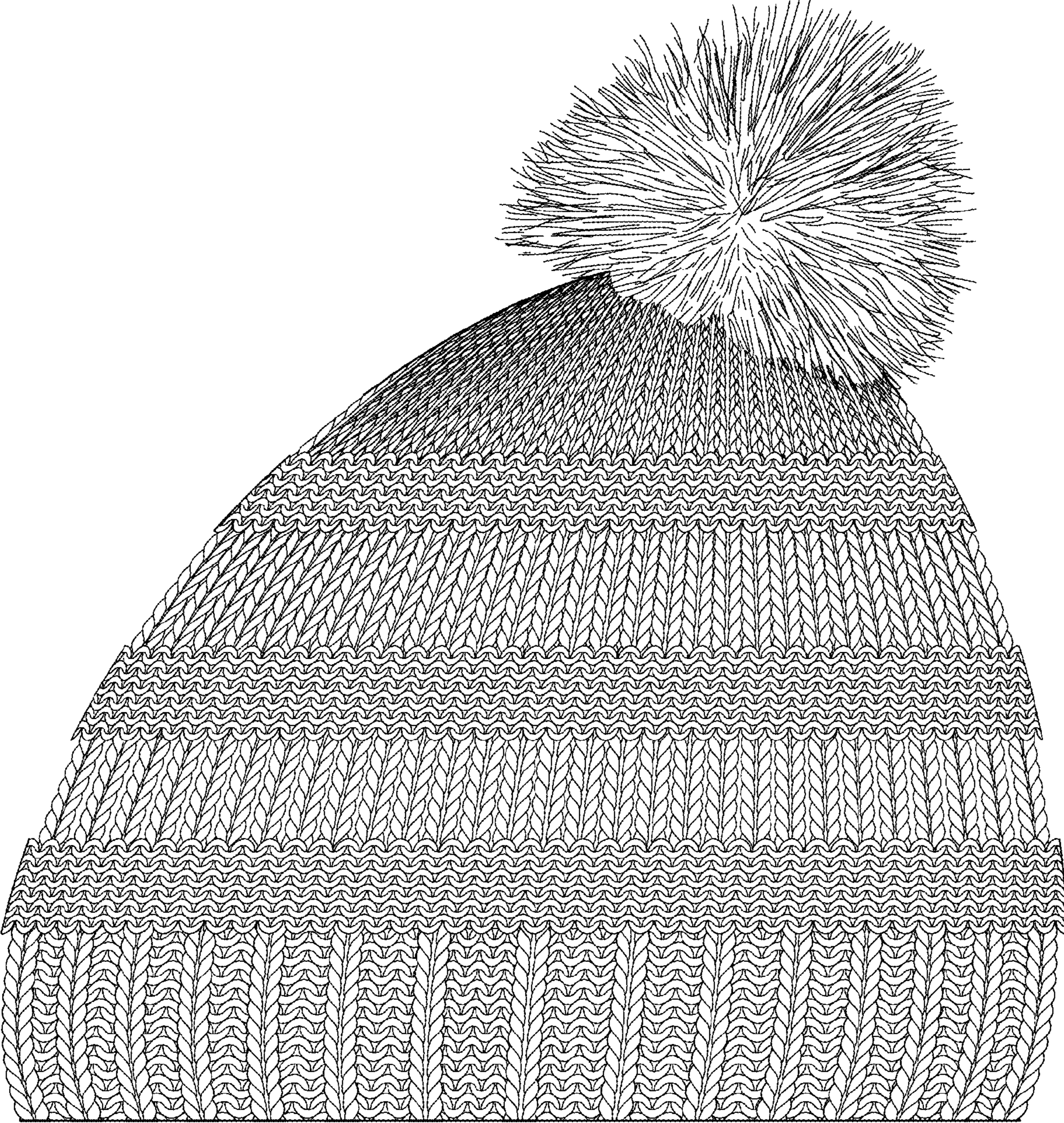

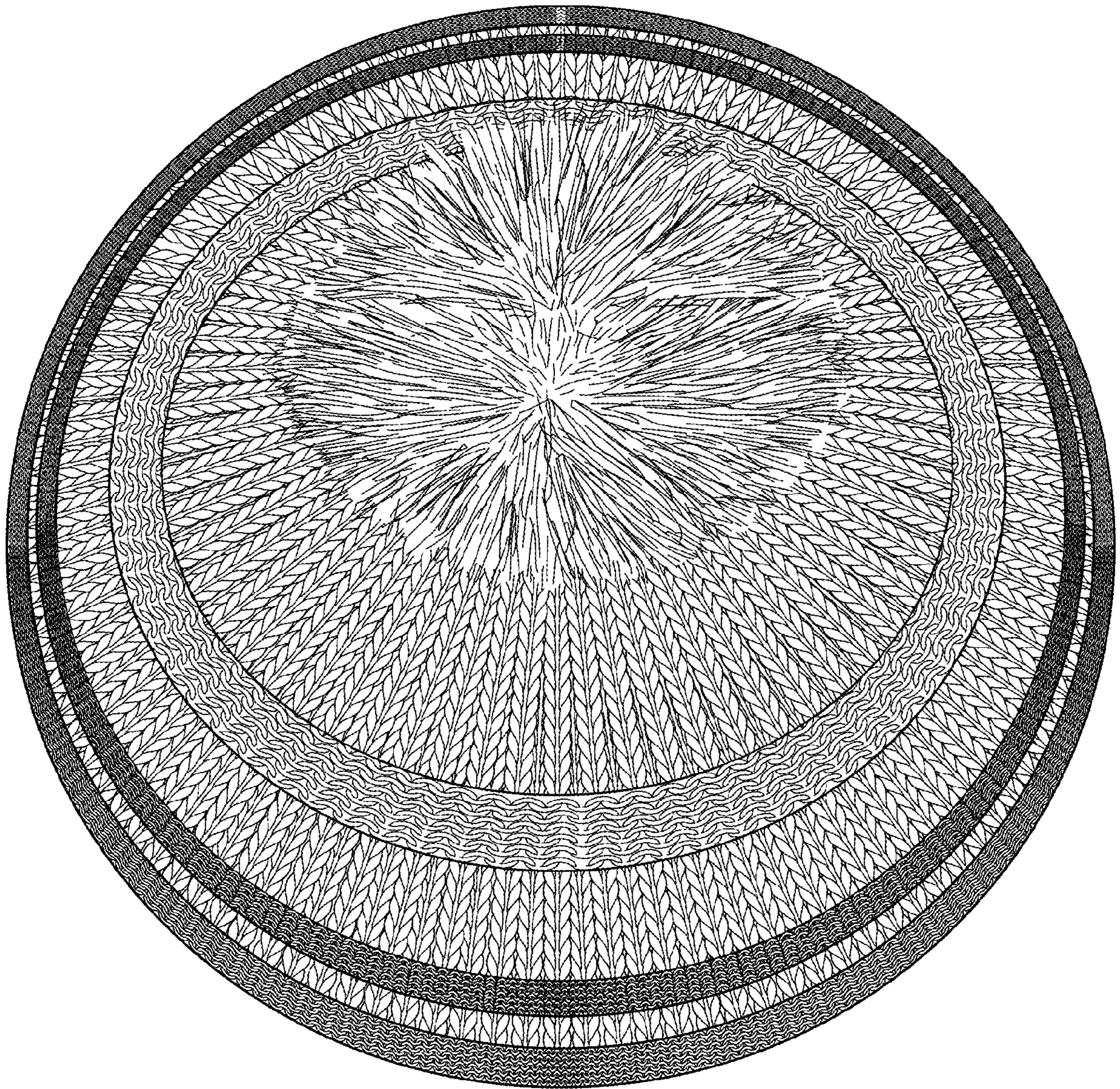

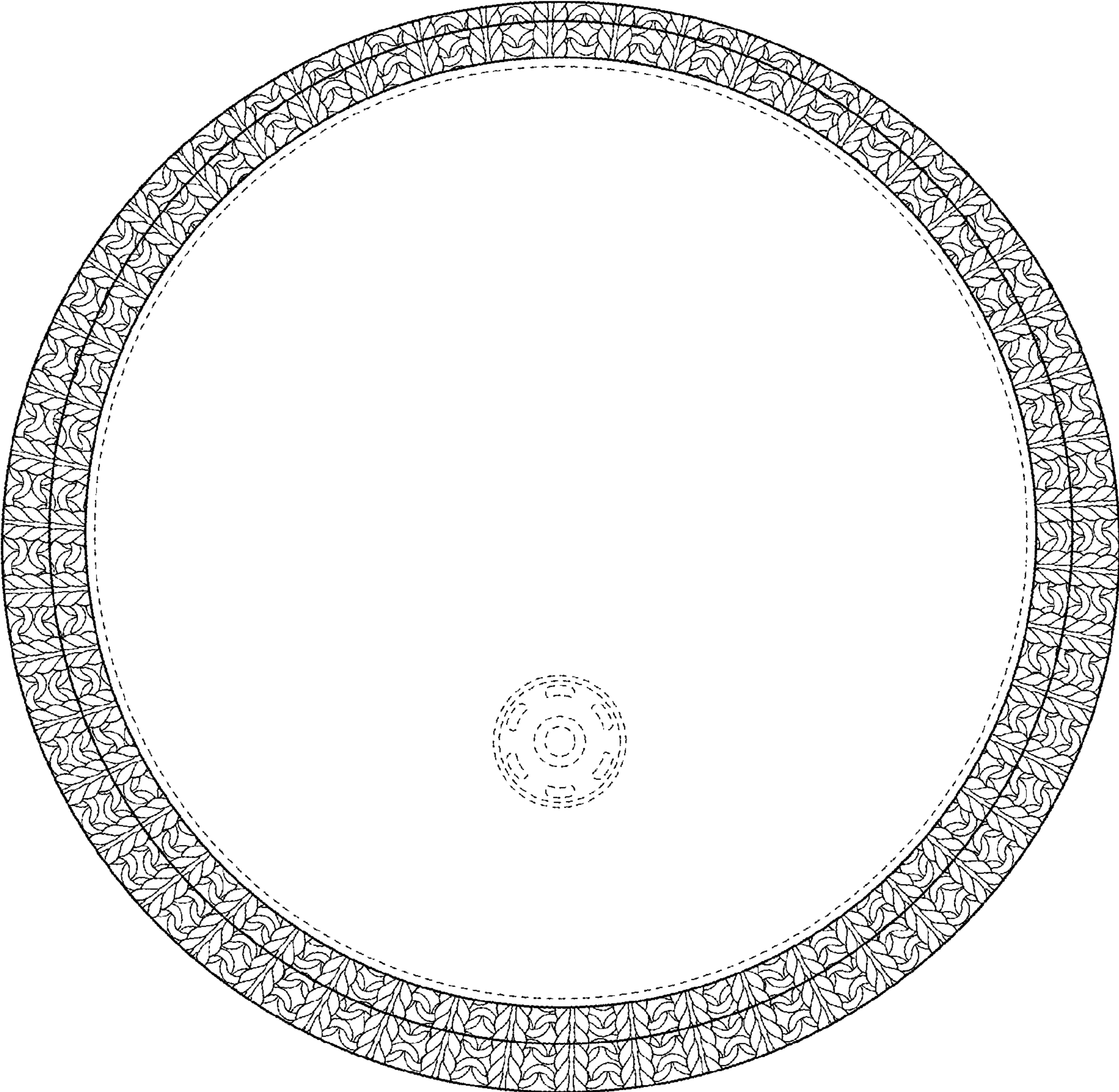

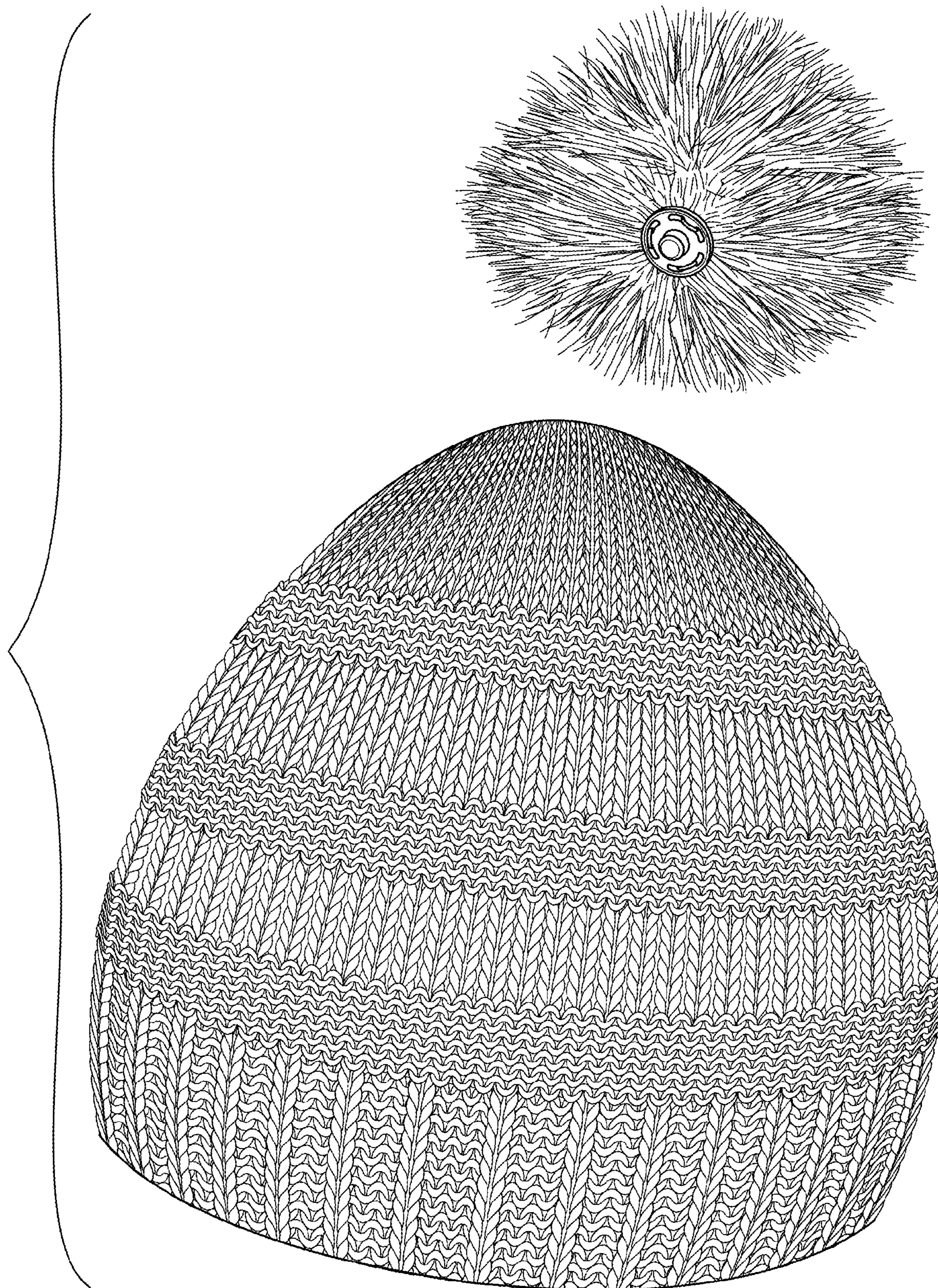

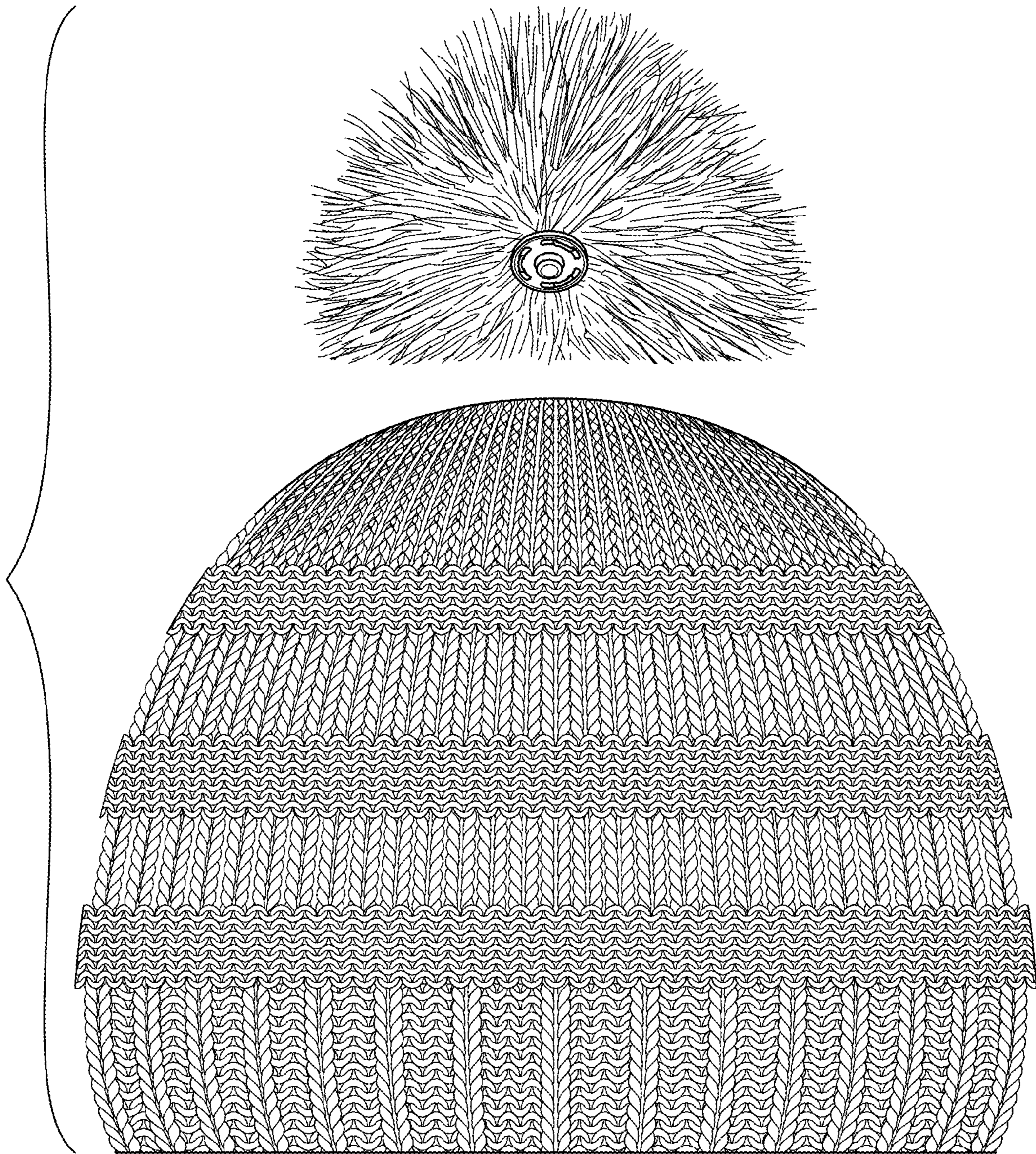

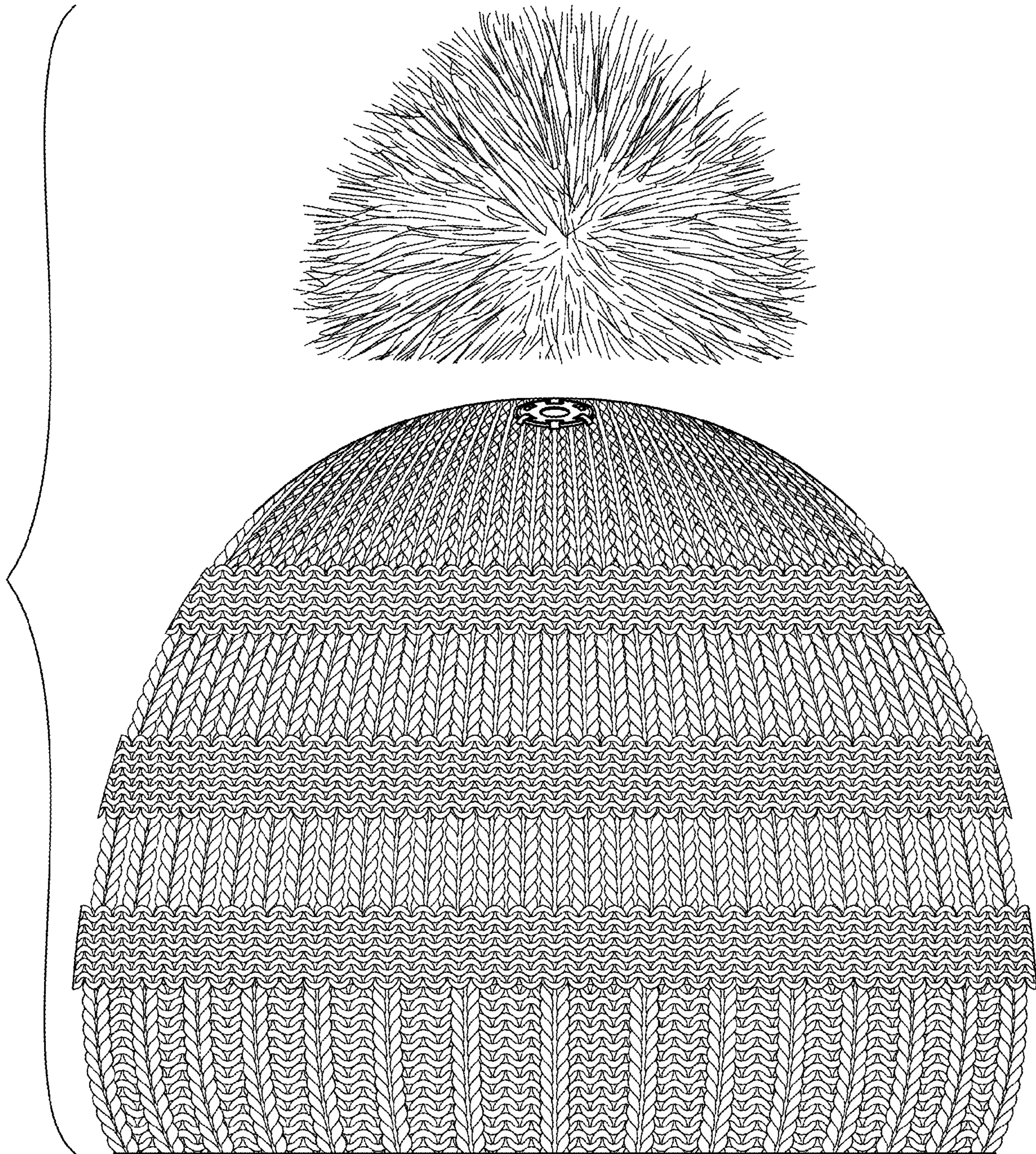

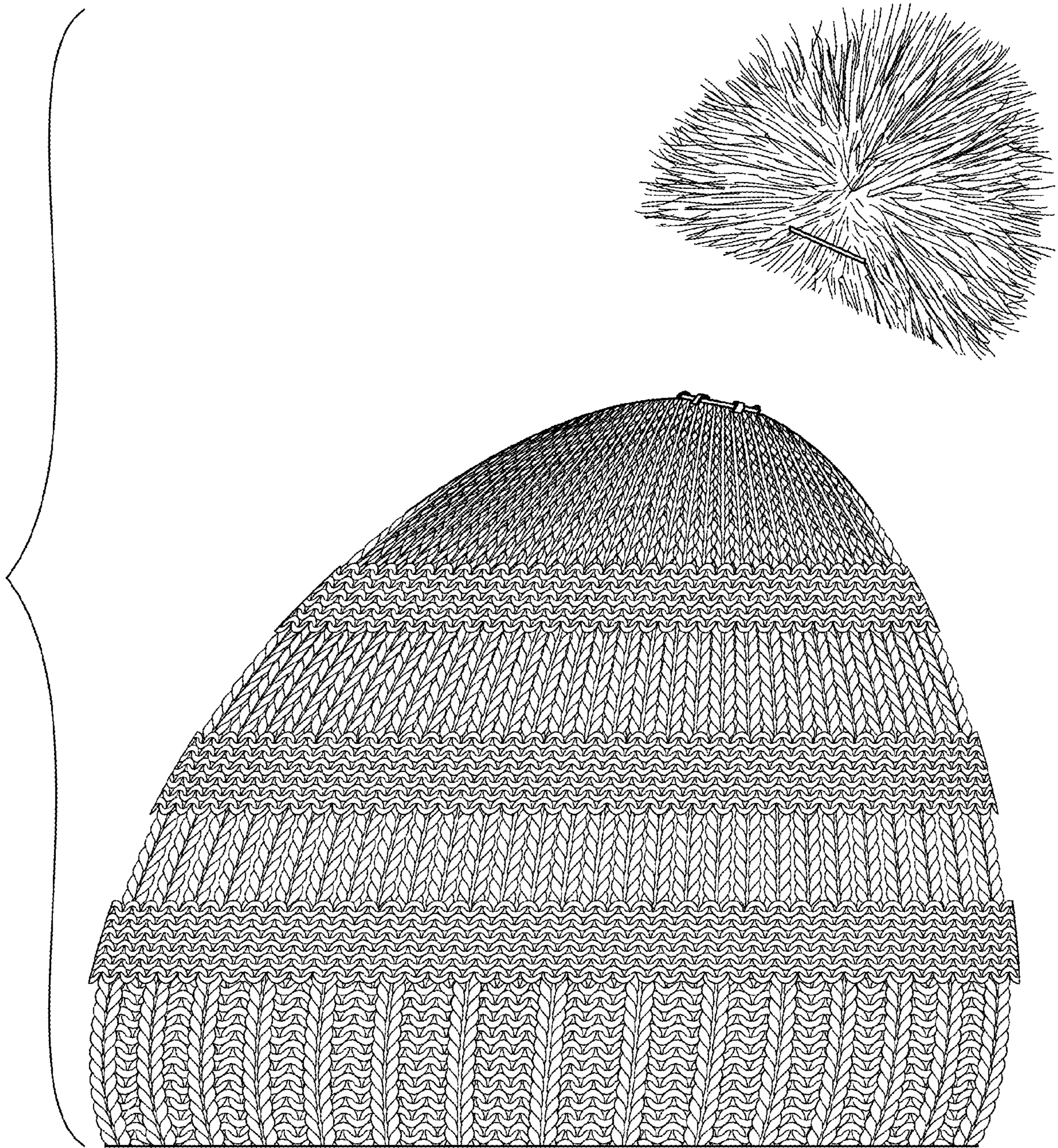

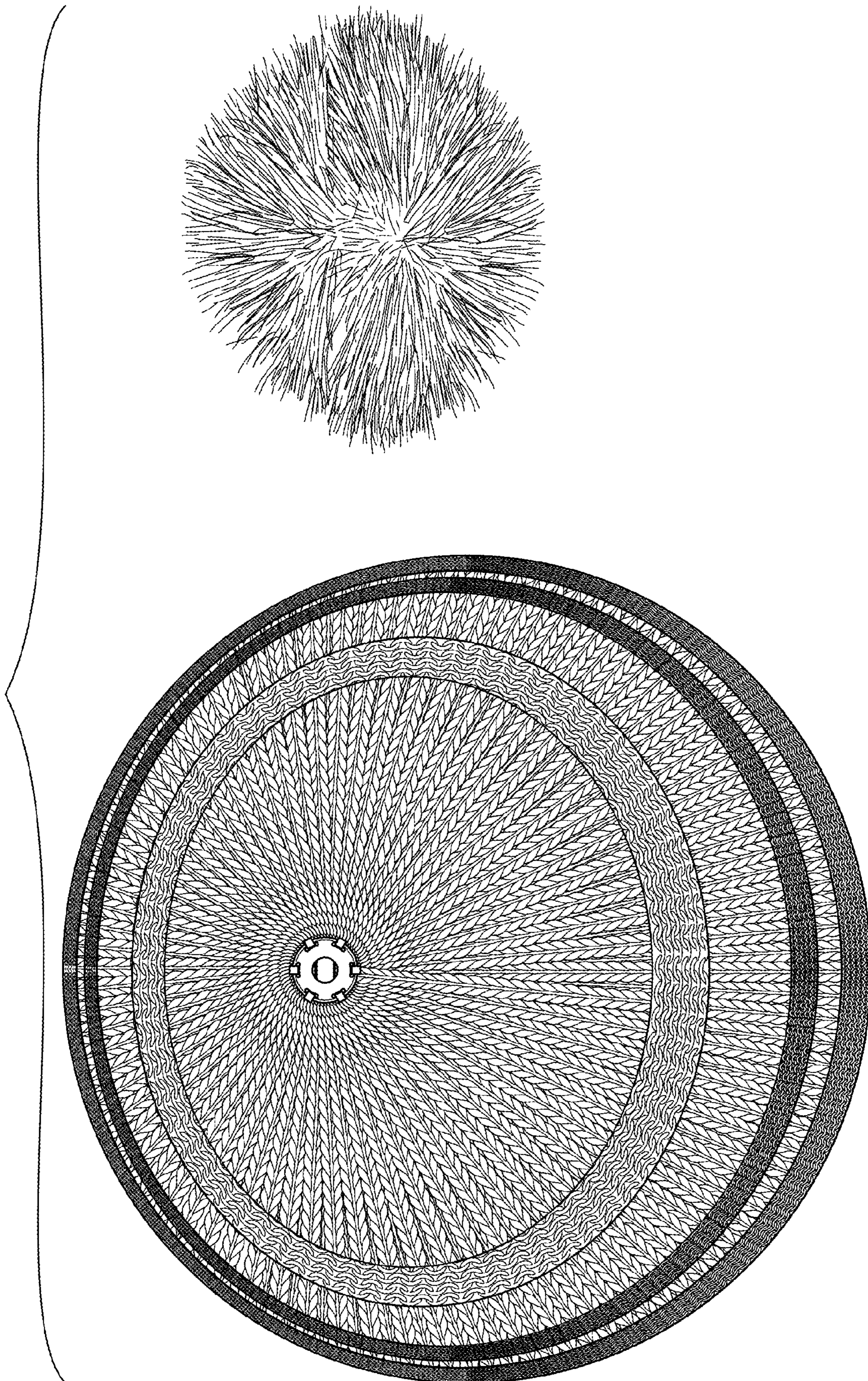

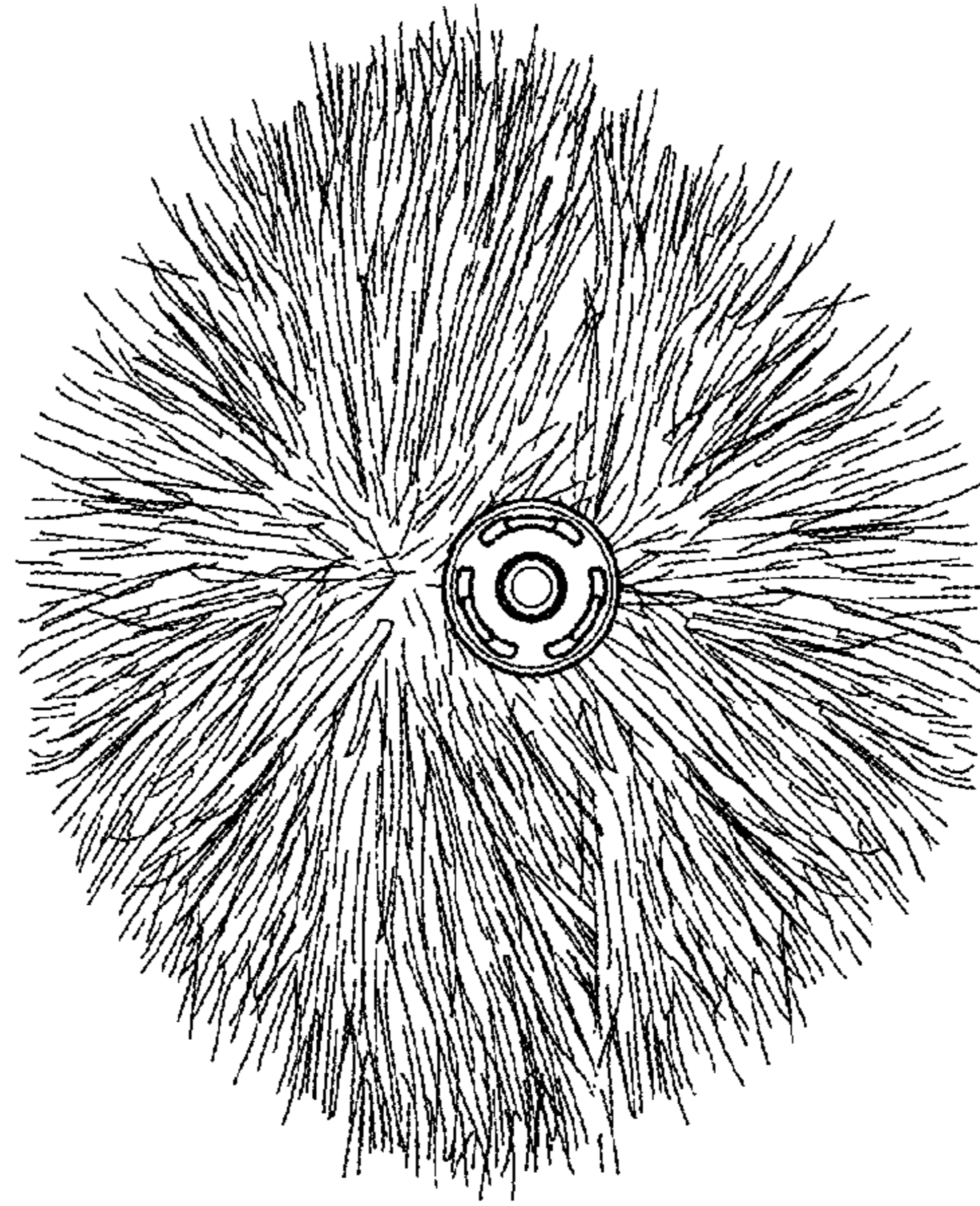
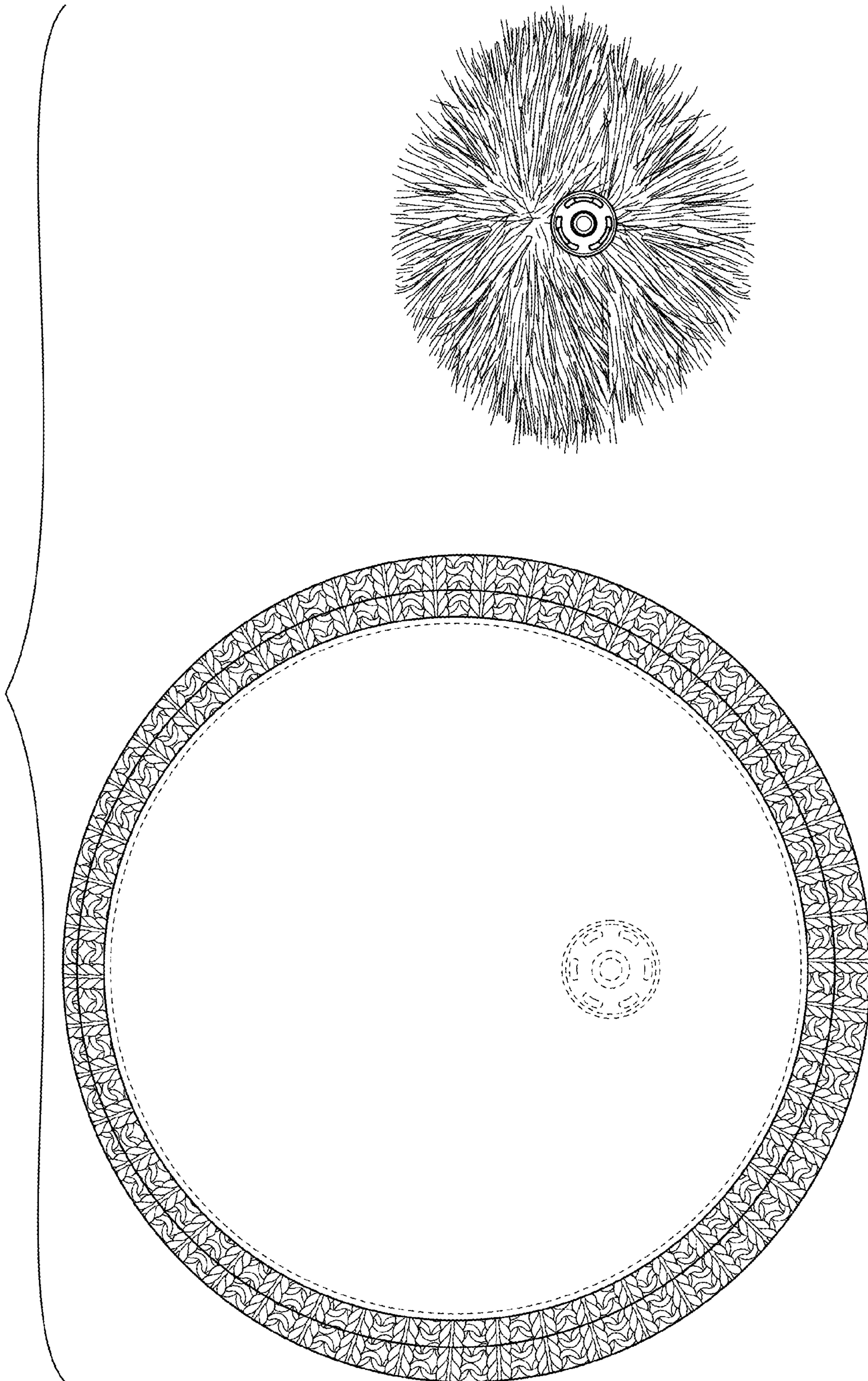
