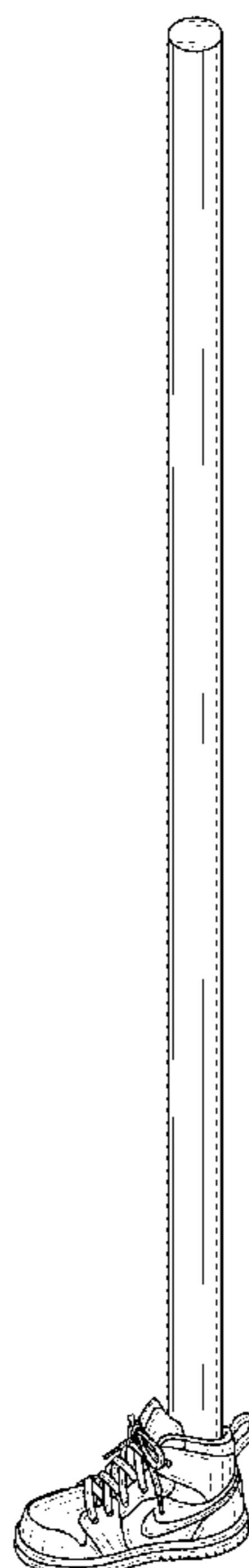

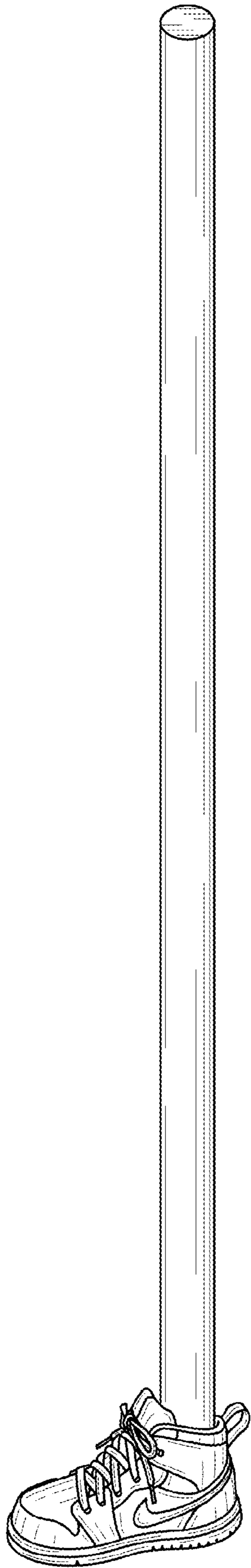
The ornamental design for a walking cane, as shown and described.

**DESCRIPTION**

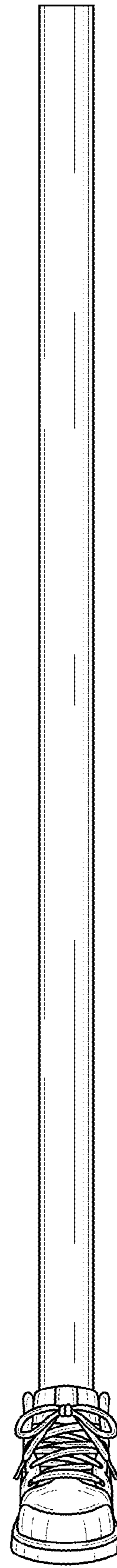

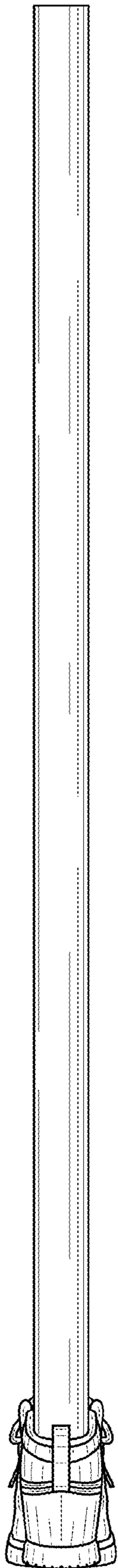




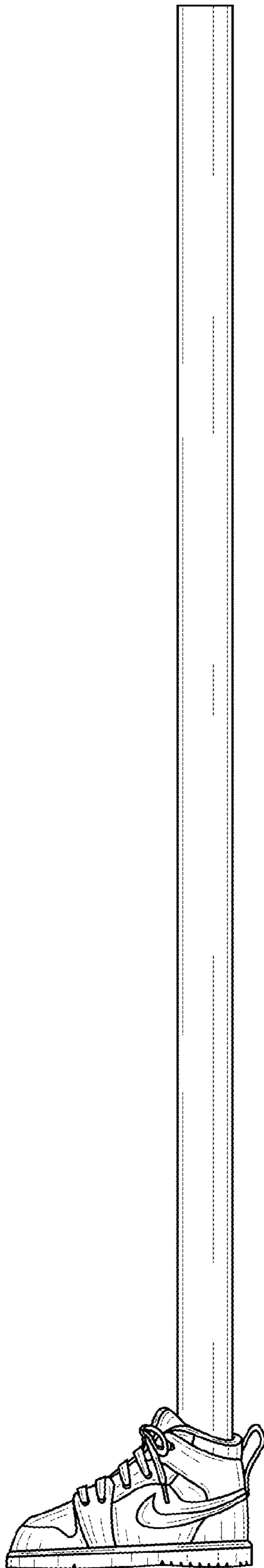

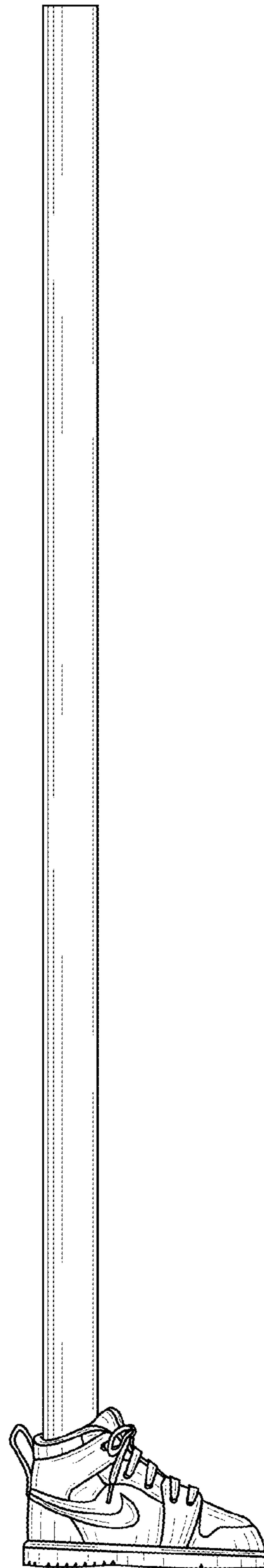
