FIG. 7 is a bottom view thereof.

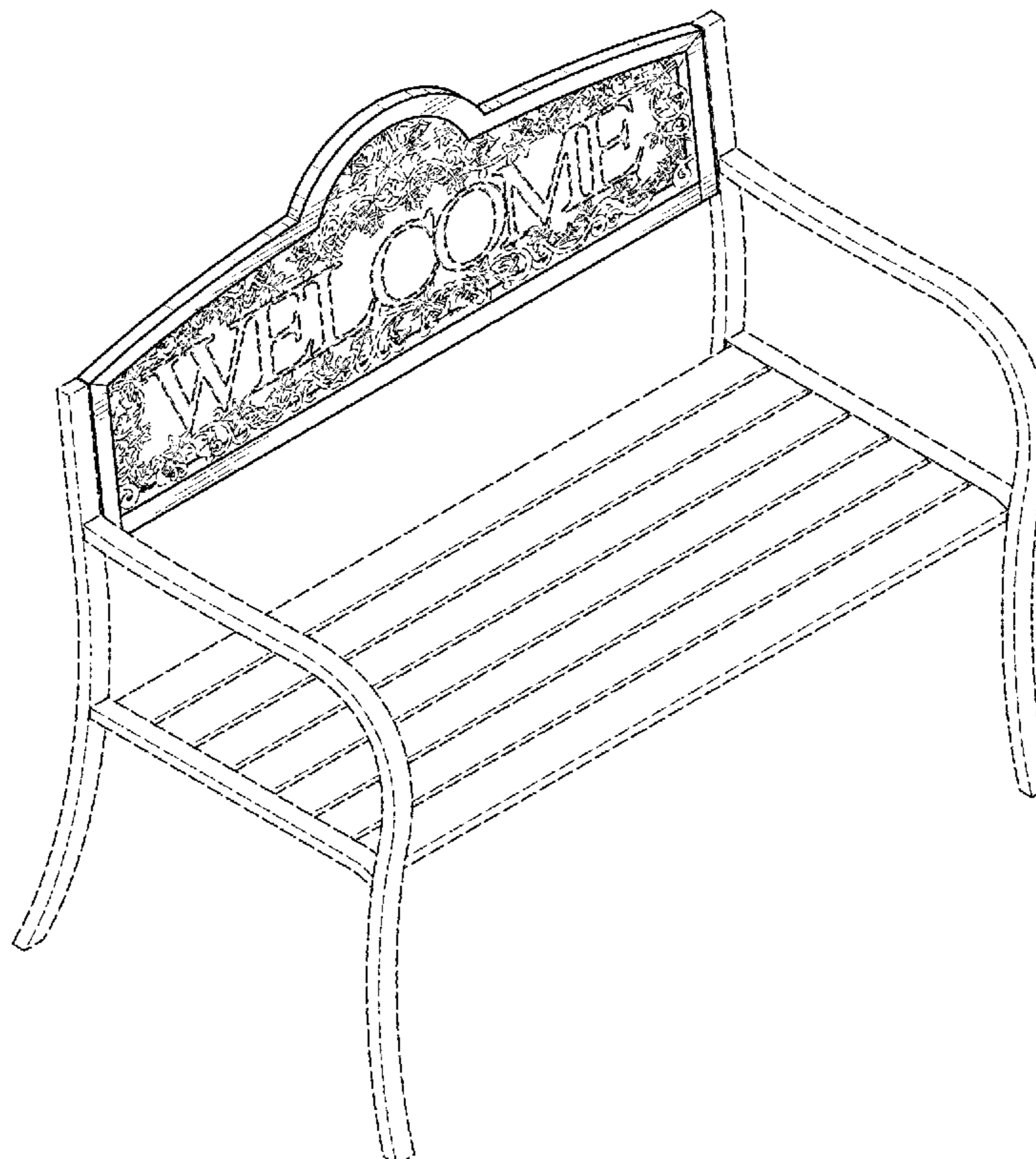
The features presented in broken lines, including the floral pattern and text, represent environmental structure and unclaimed portions of the bench back and form no part of the claimed design.

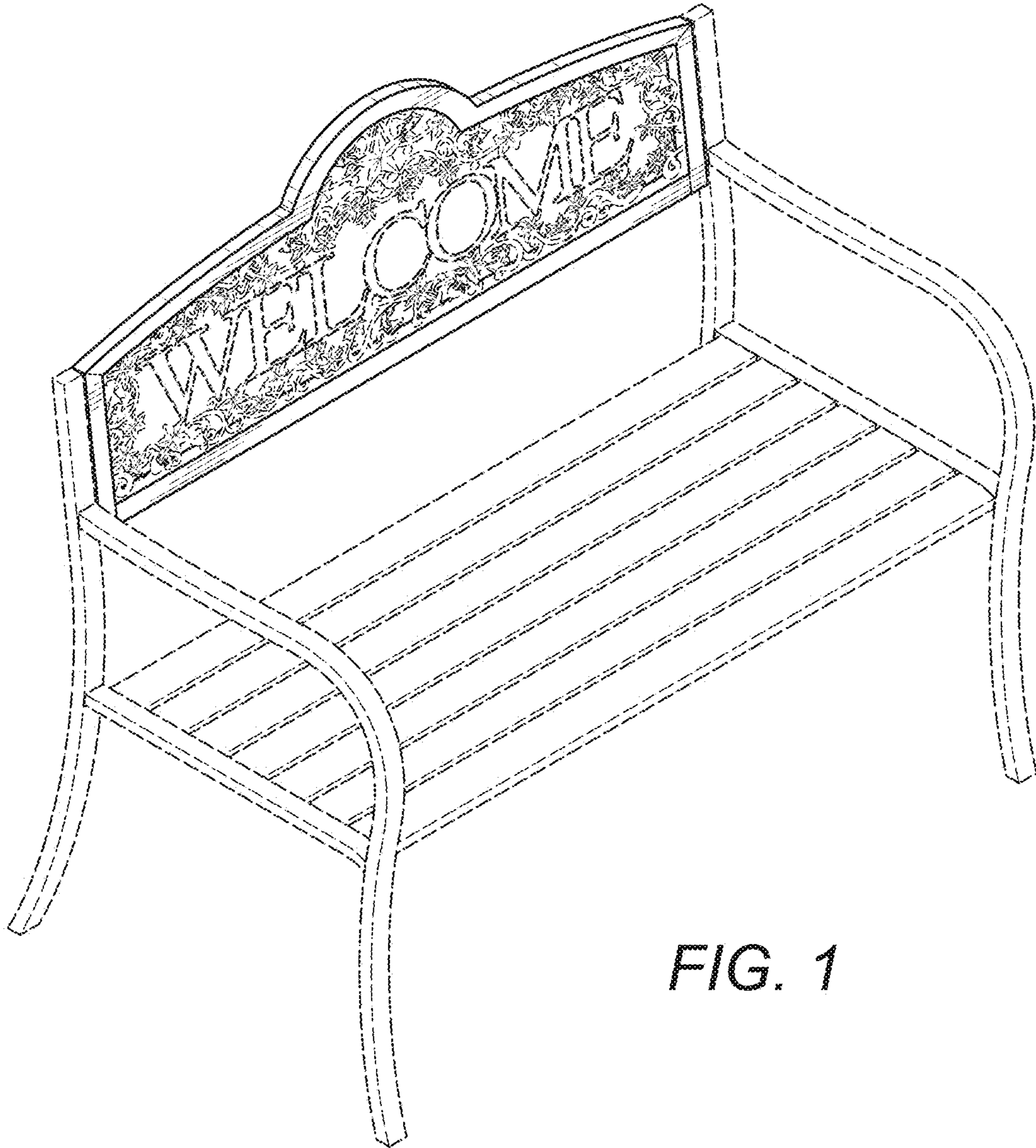

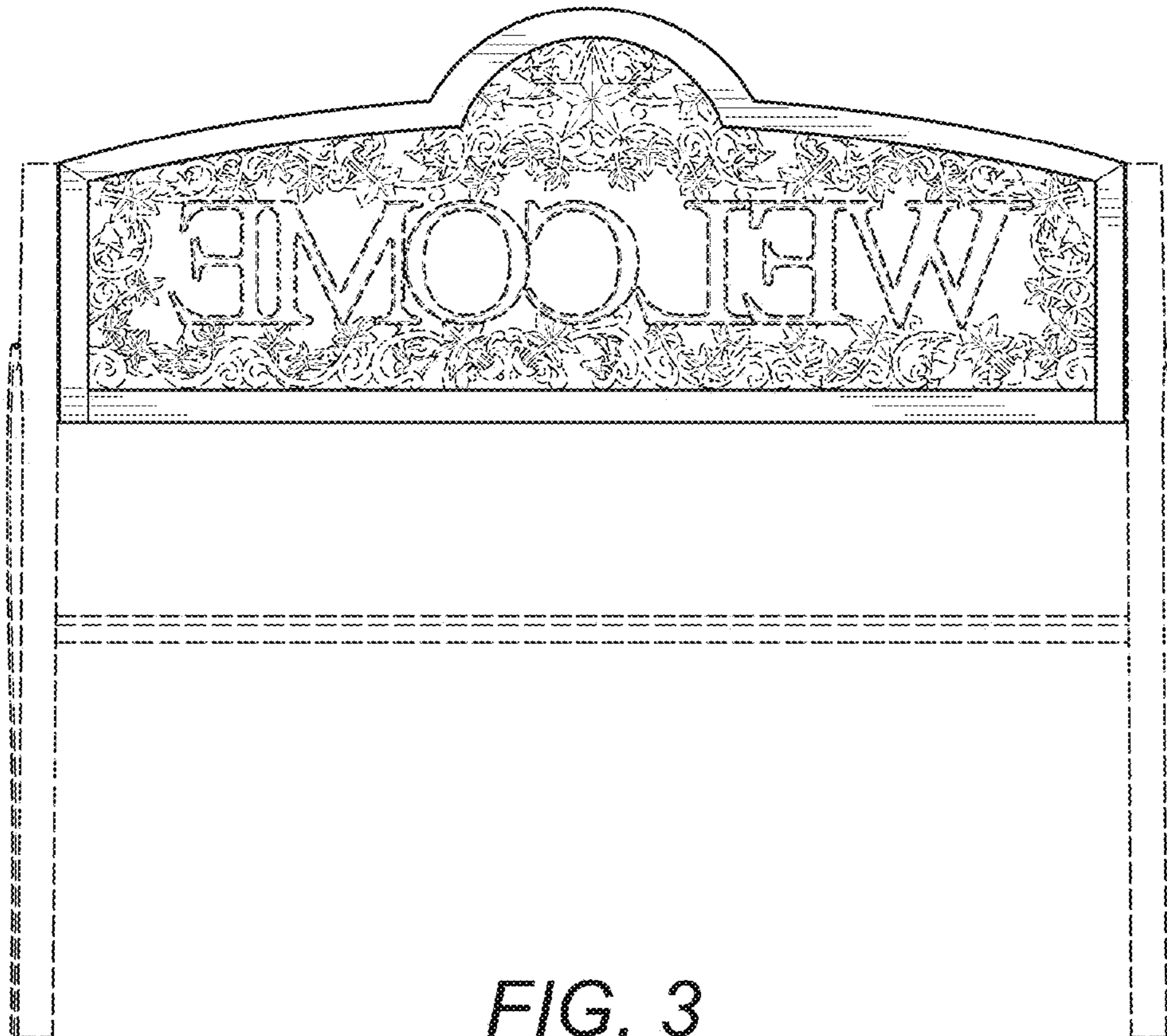

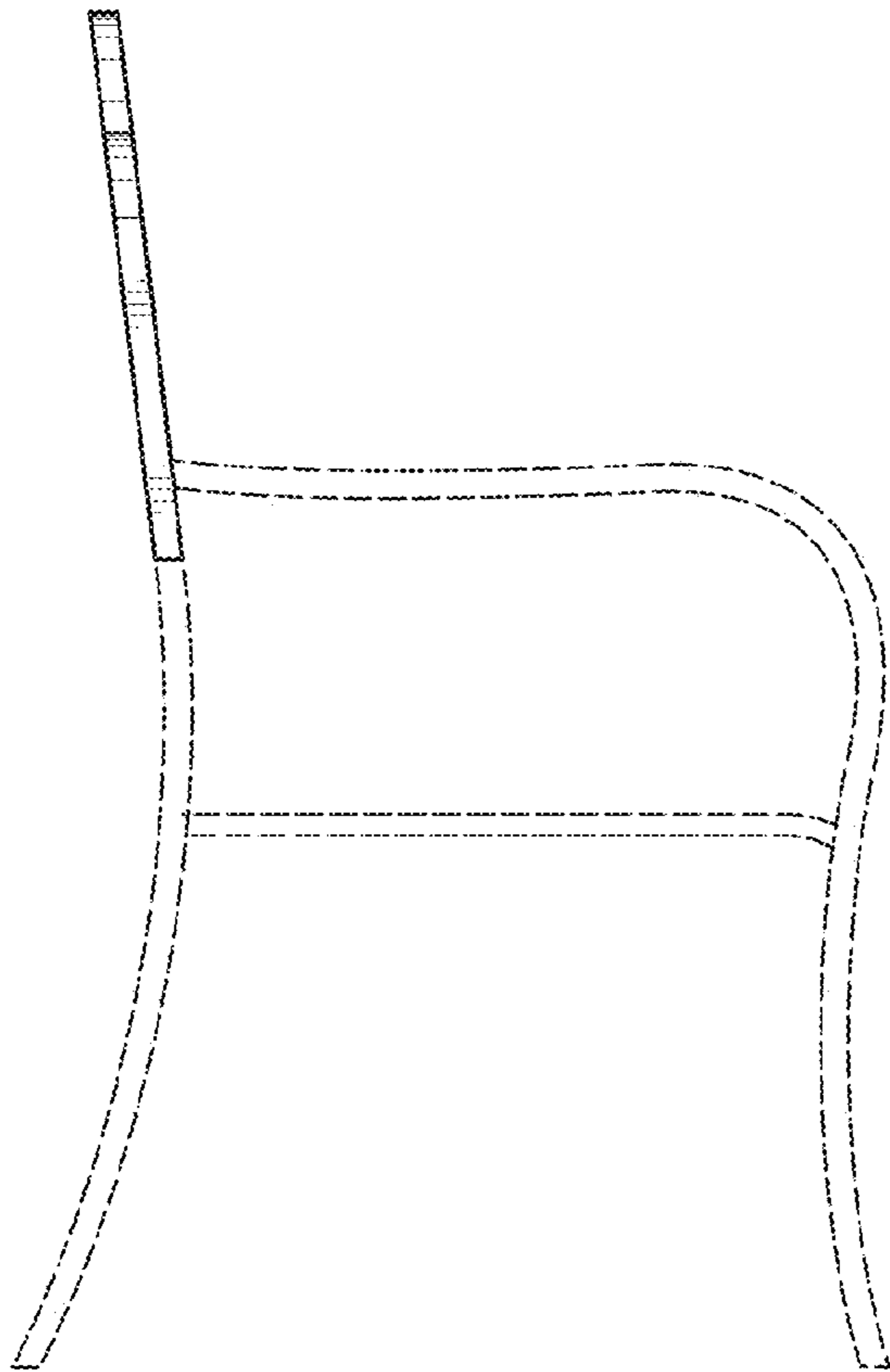

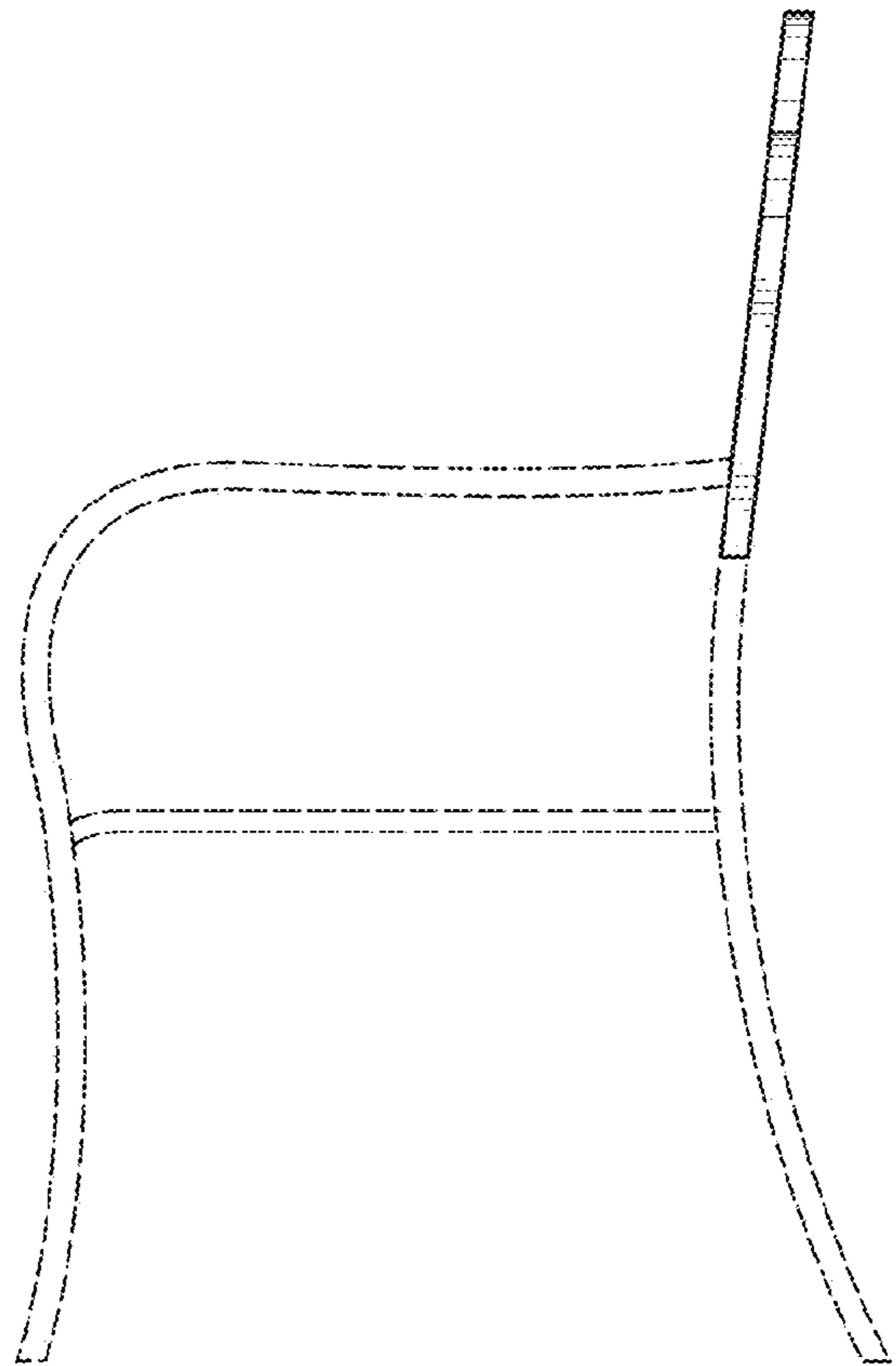

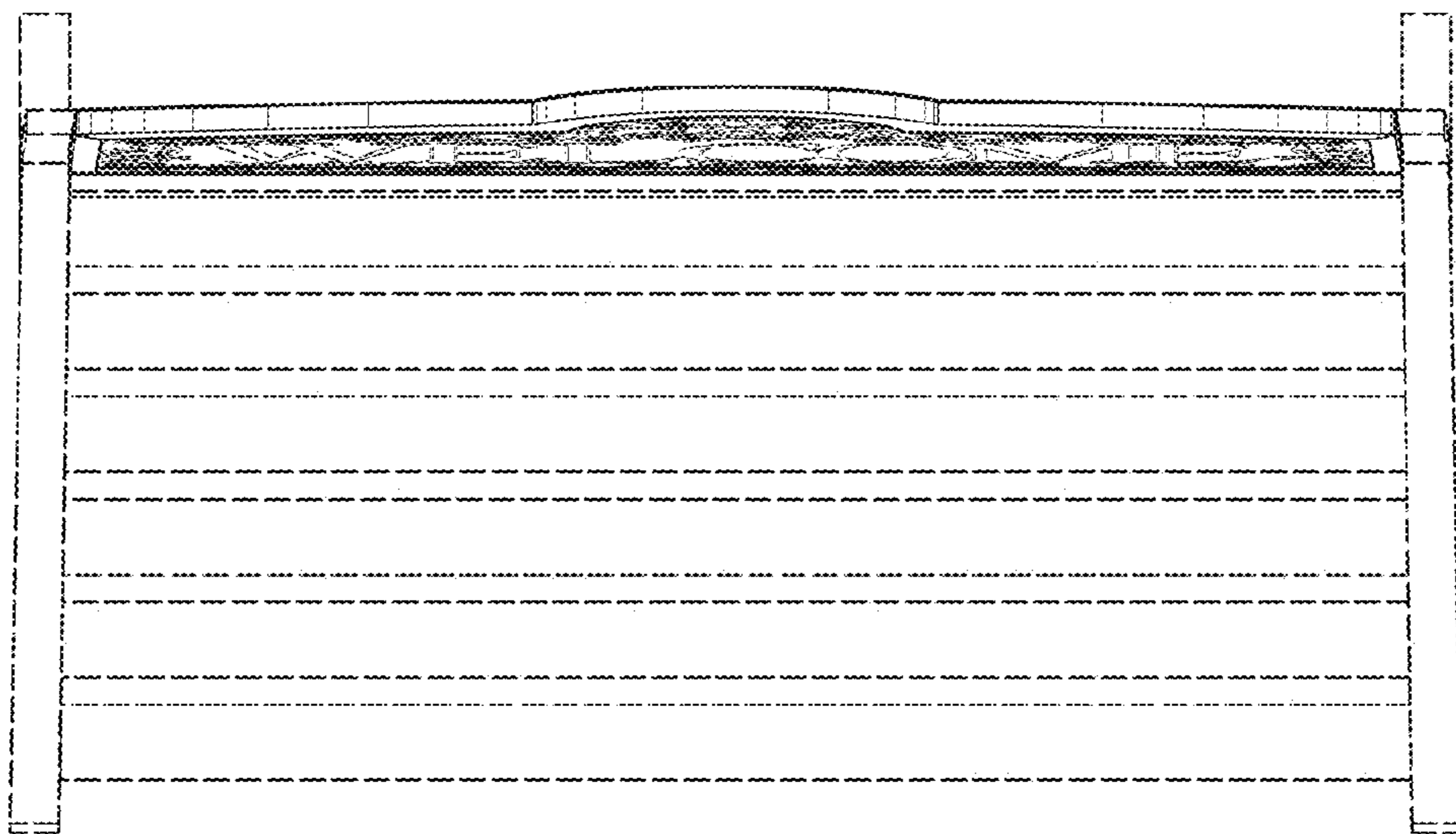

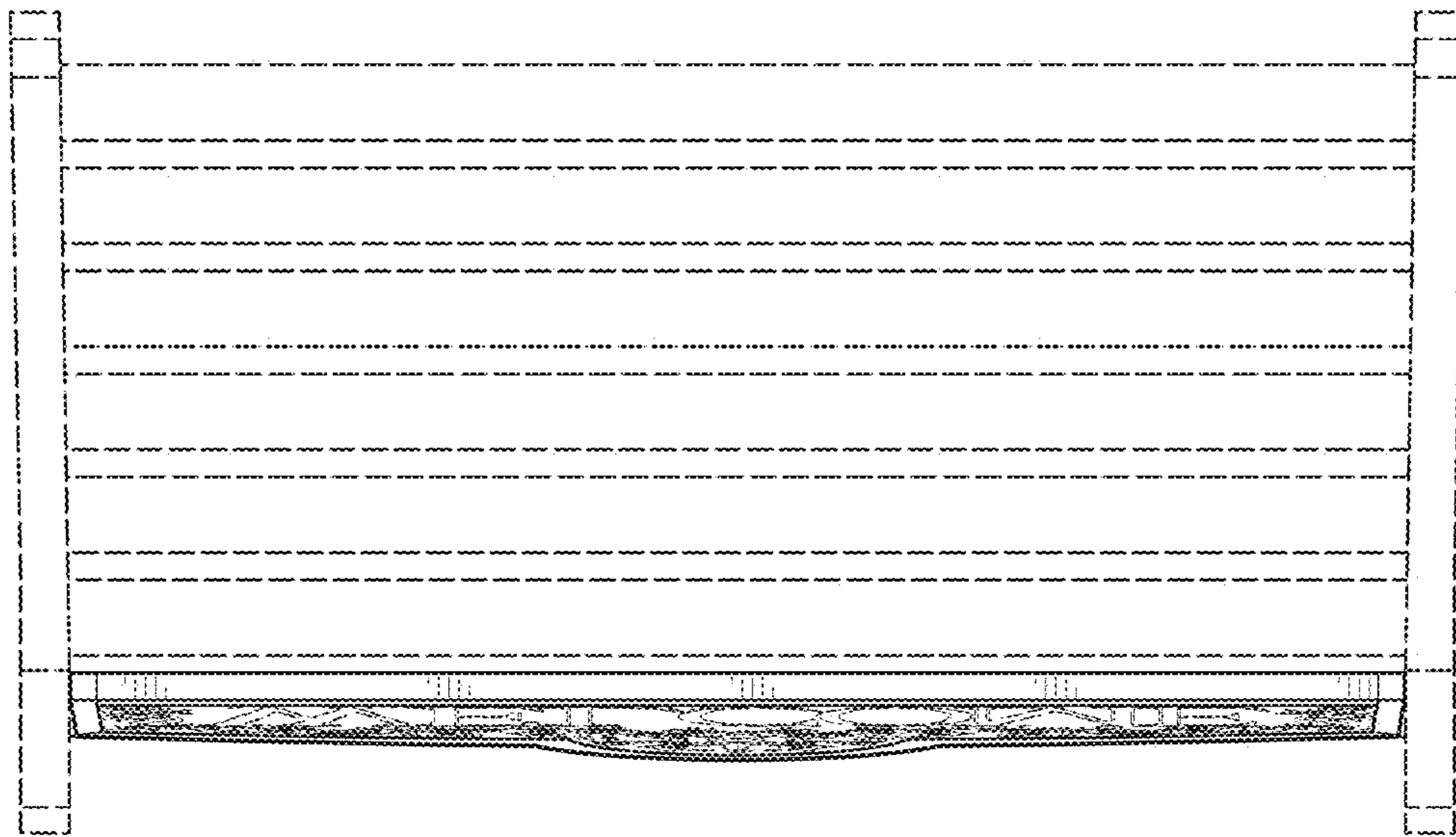
