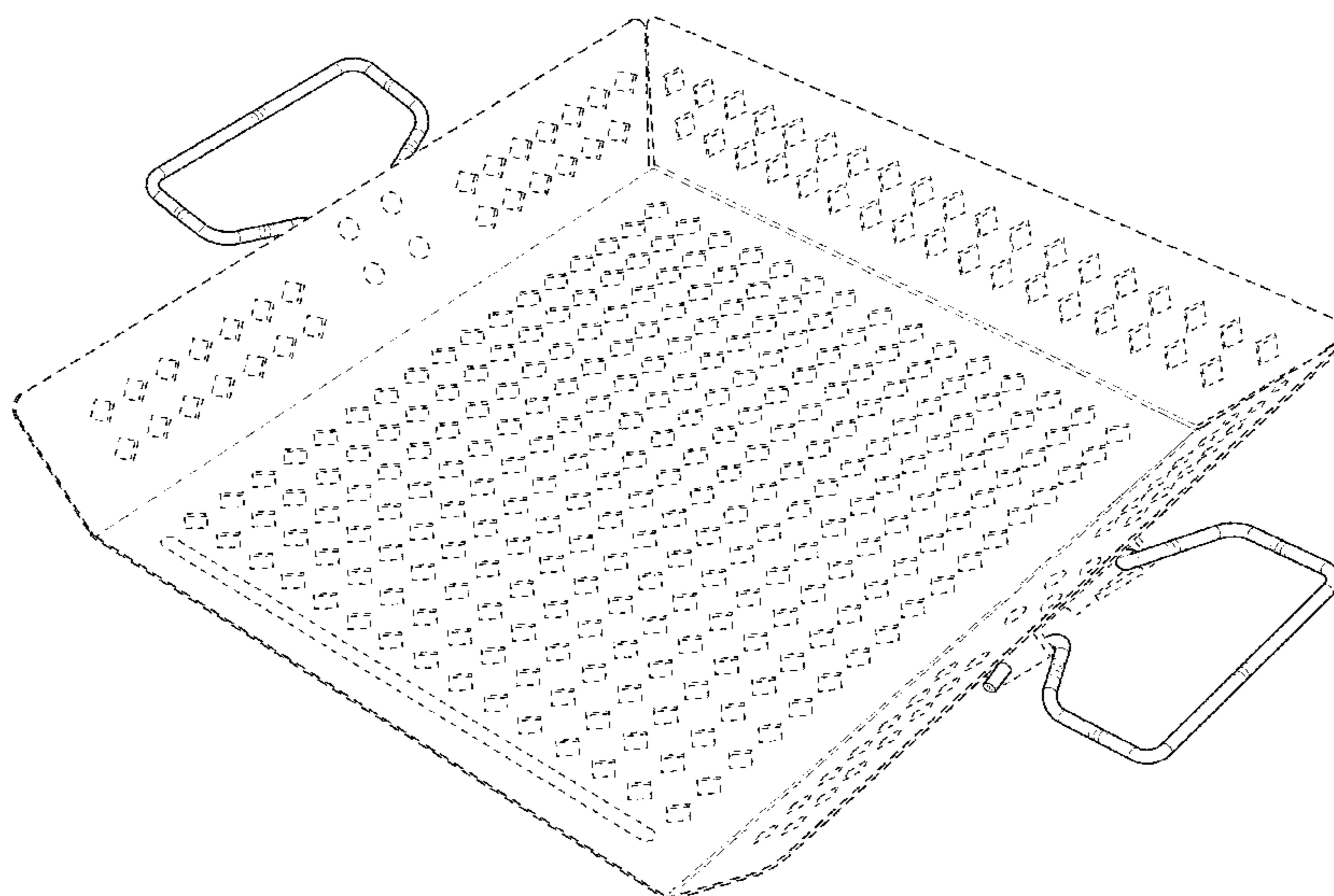
(57) **CLAIM**

The ornamental design for a pair of foldable handles for a tray, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a pair of foldable handles for a tray, in an open position in accordance with the present design;
FIG. 2 is a right side elevational view thereof;
FIG. 3 is a left side elevational view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a bottom perspective view thereof; and,
FIG. 9 is a bottom perspective view thereof with handles in a closed position.

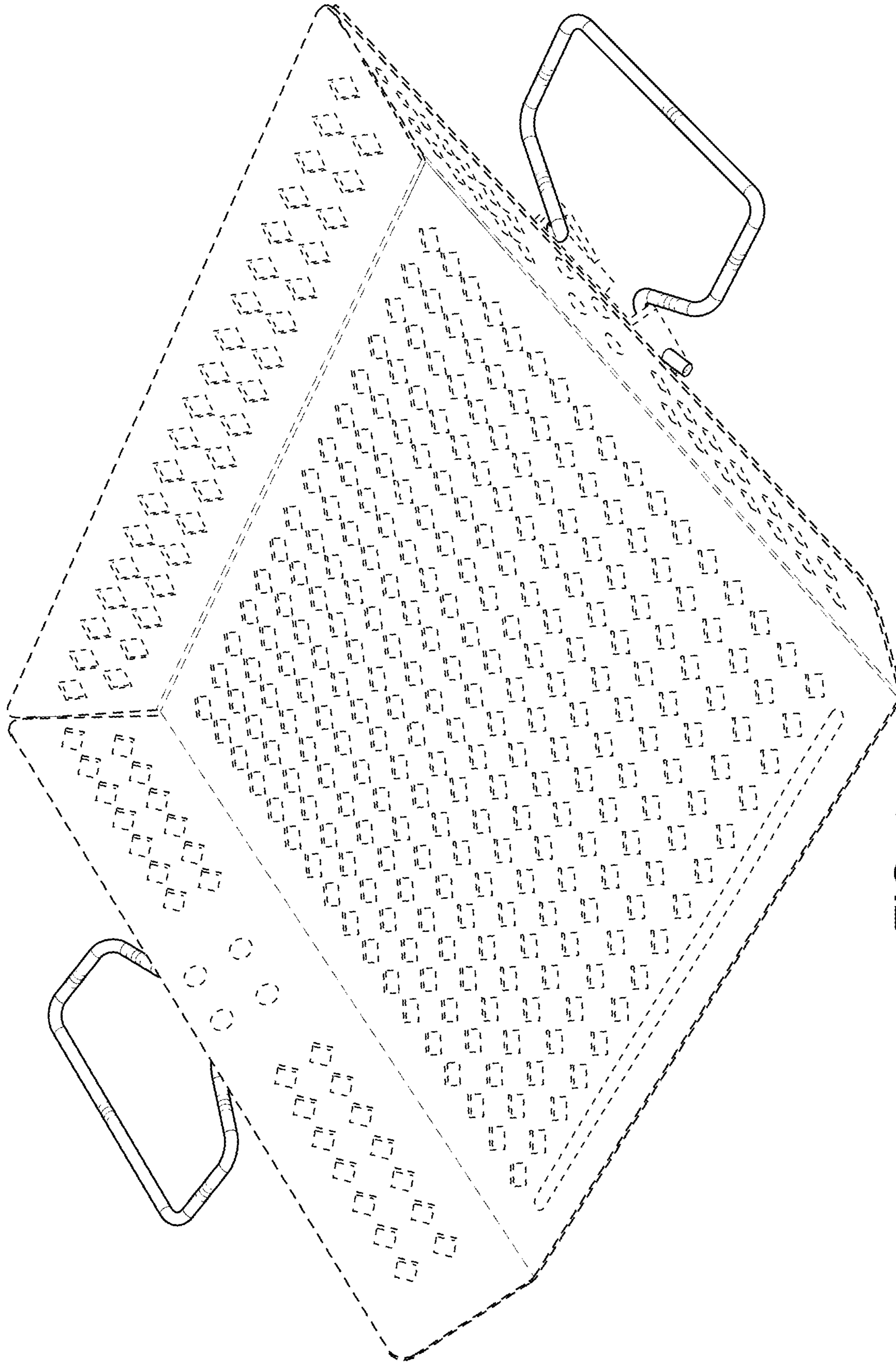

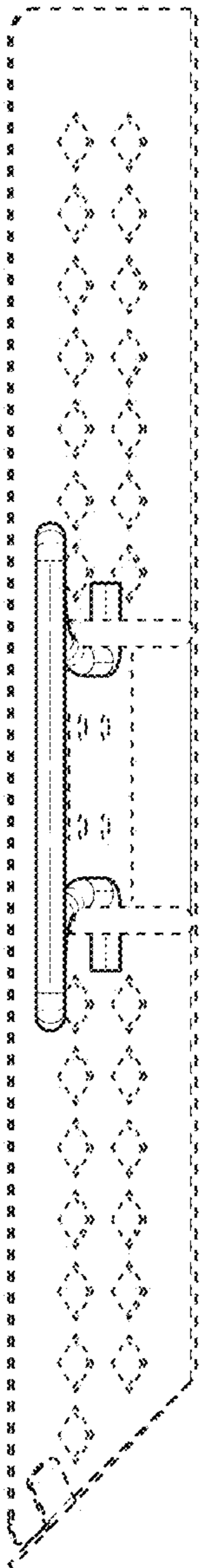

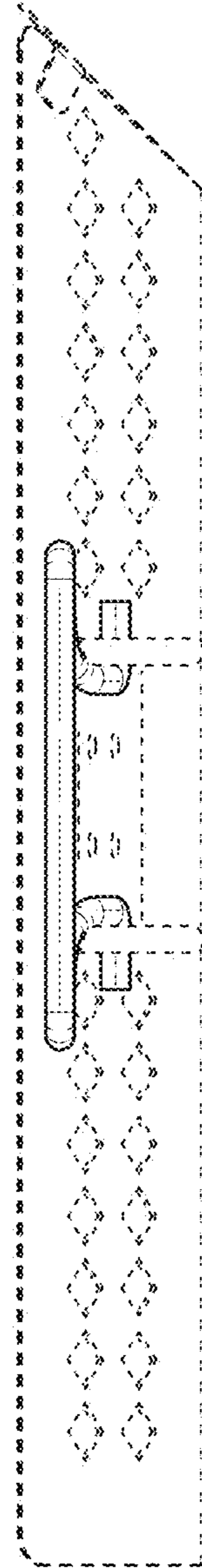

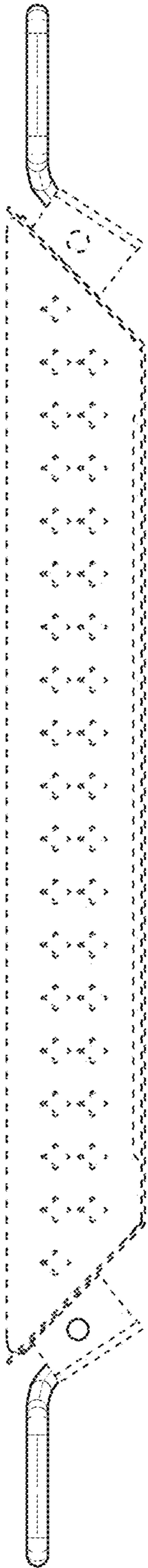

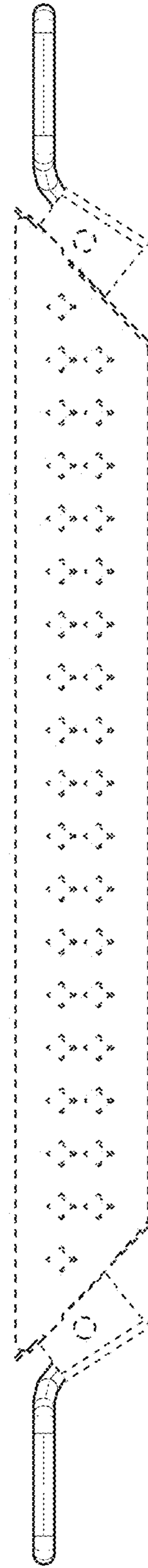

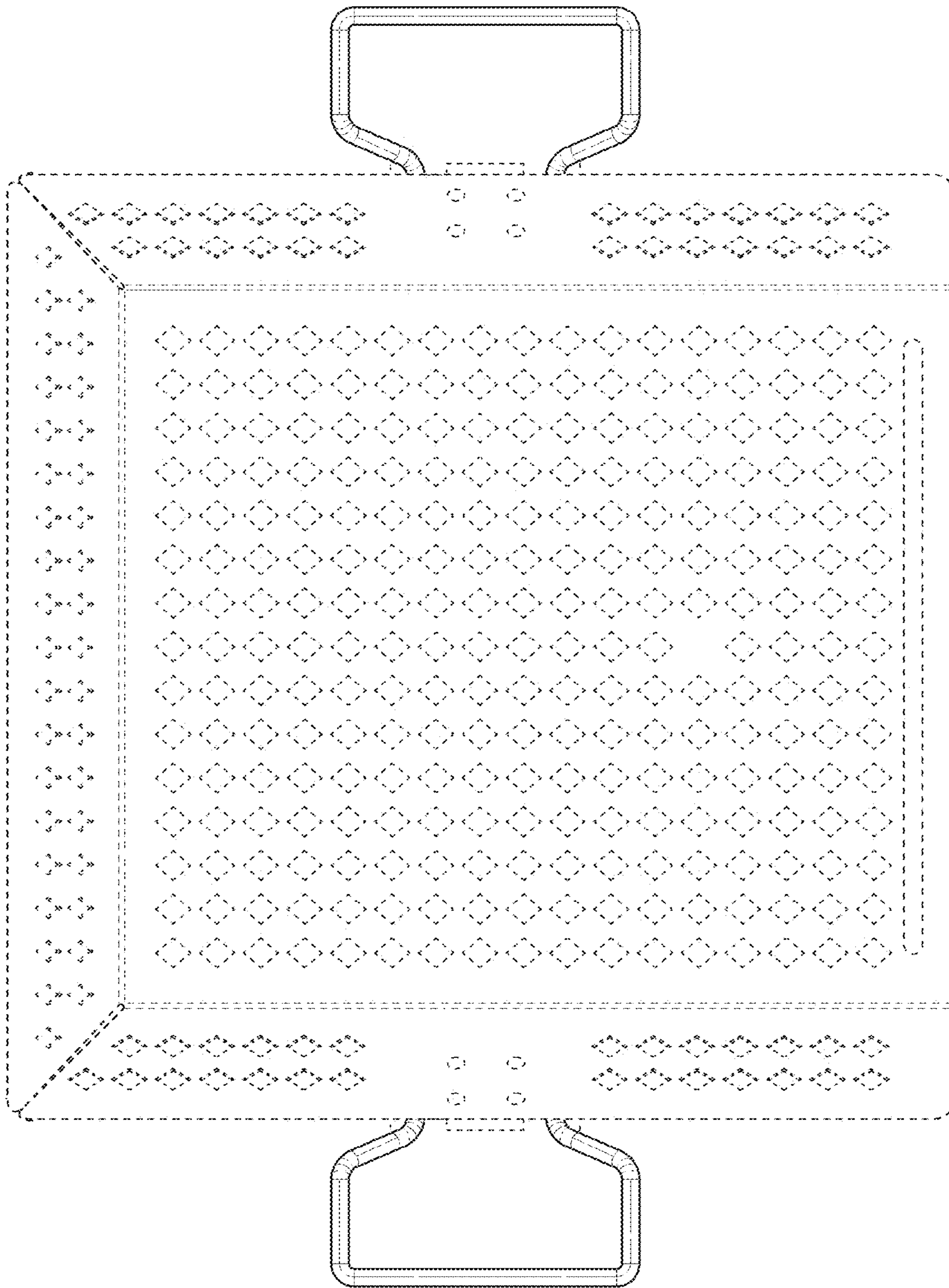

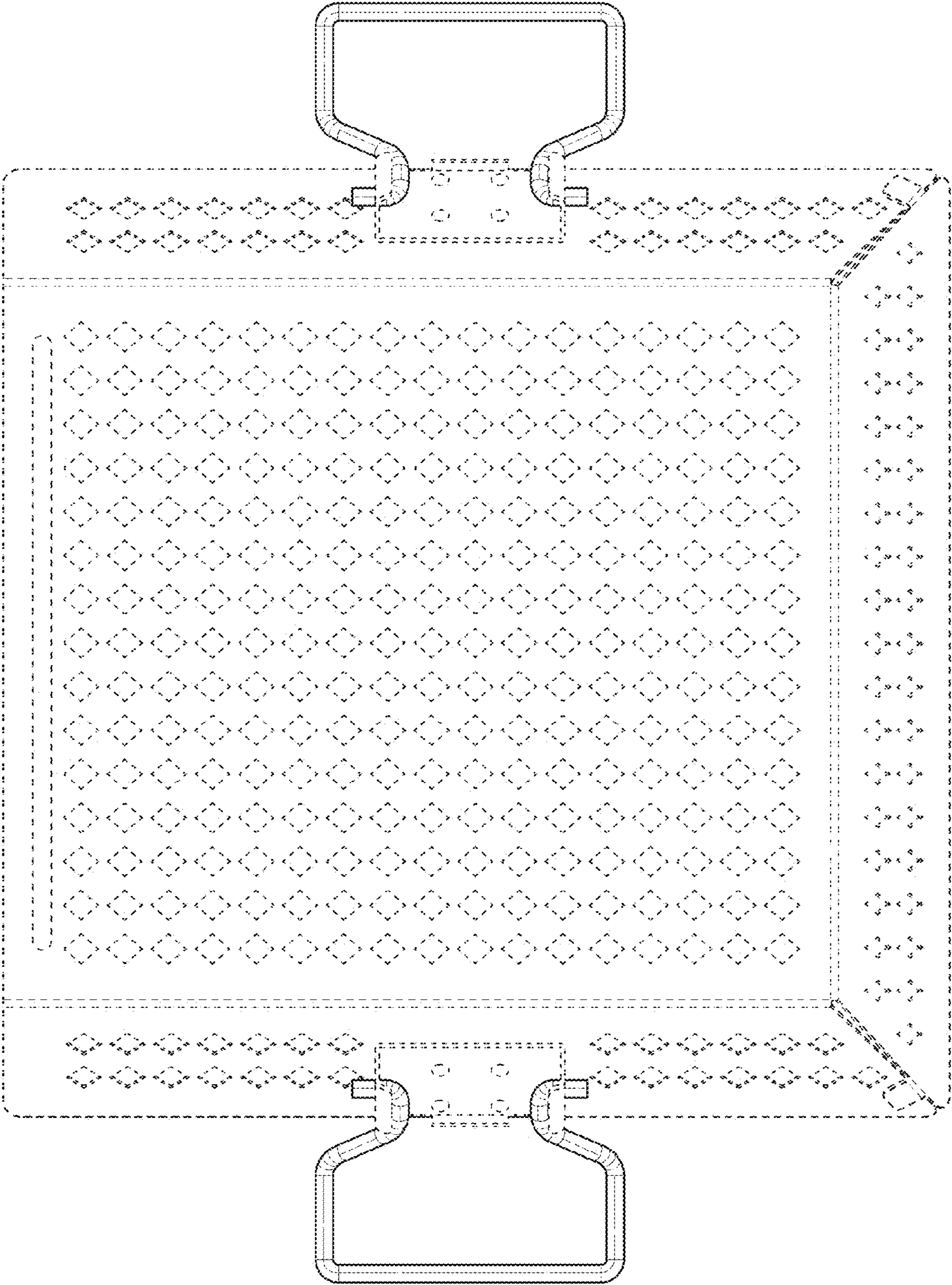

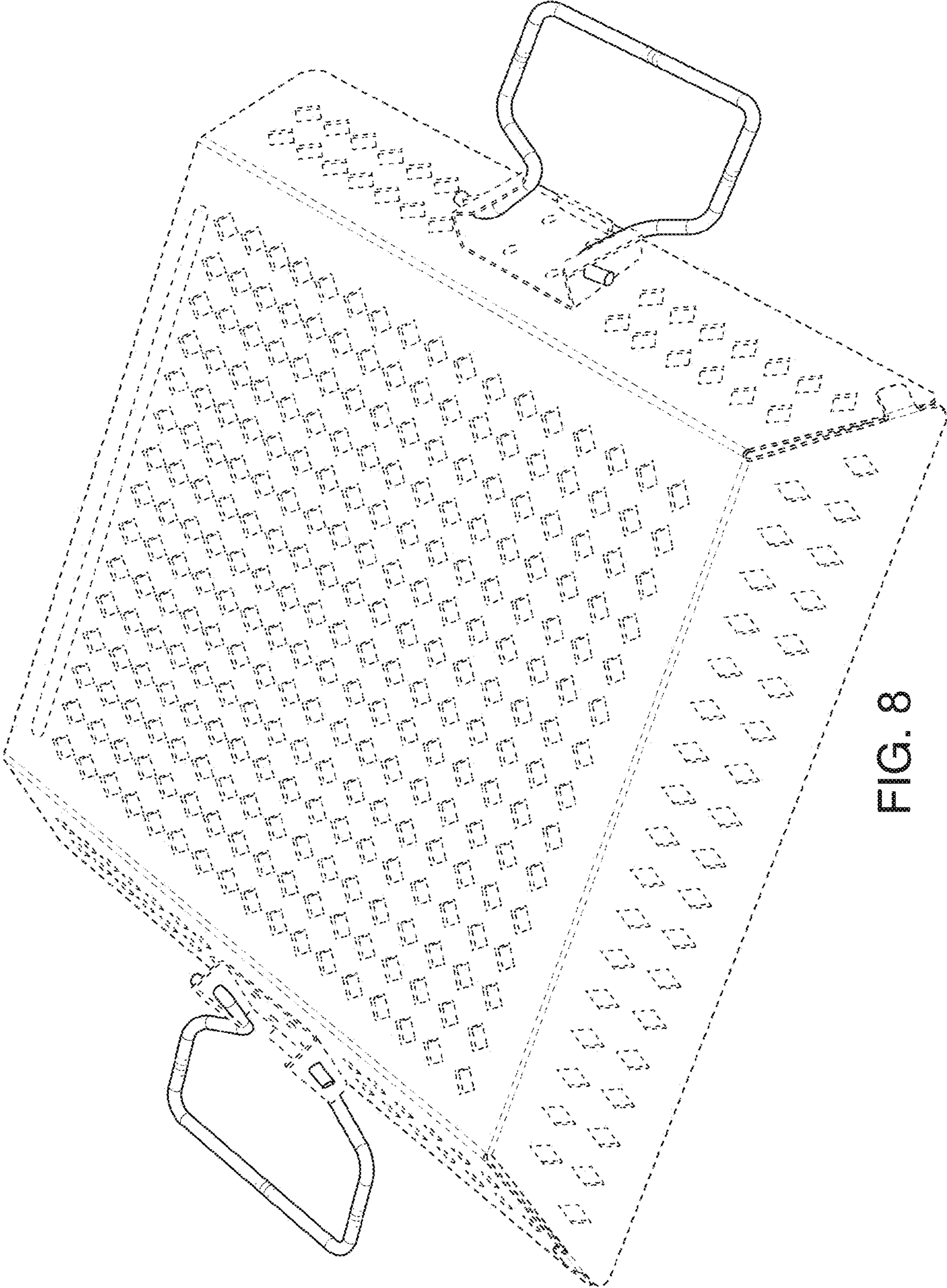

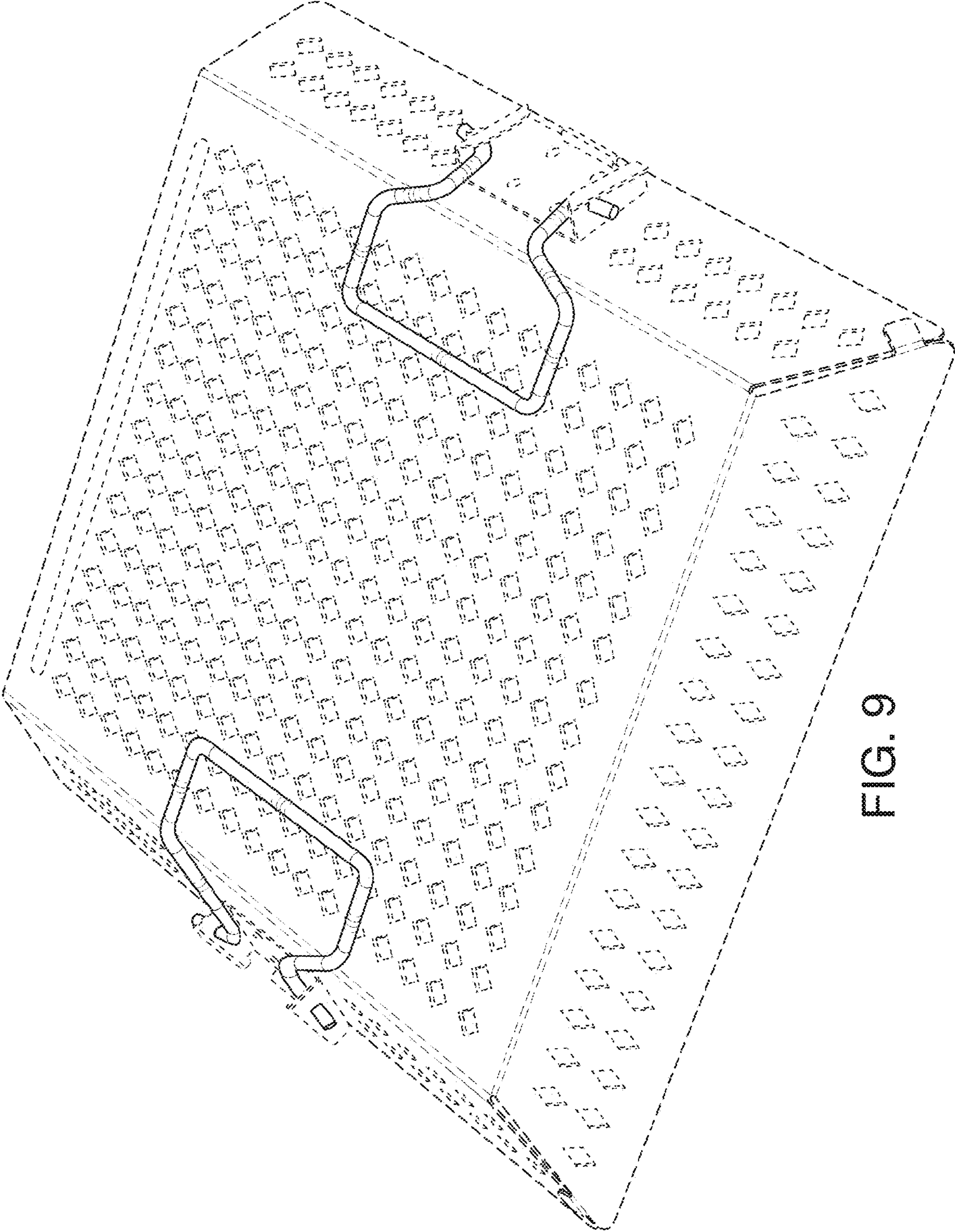
