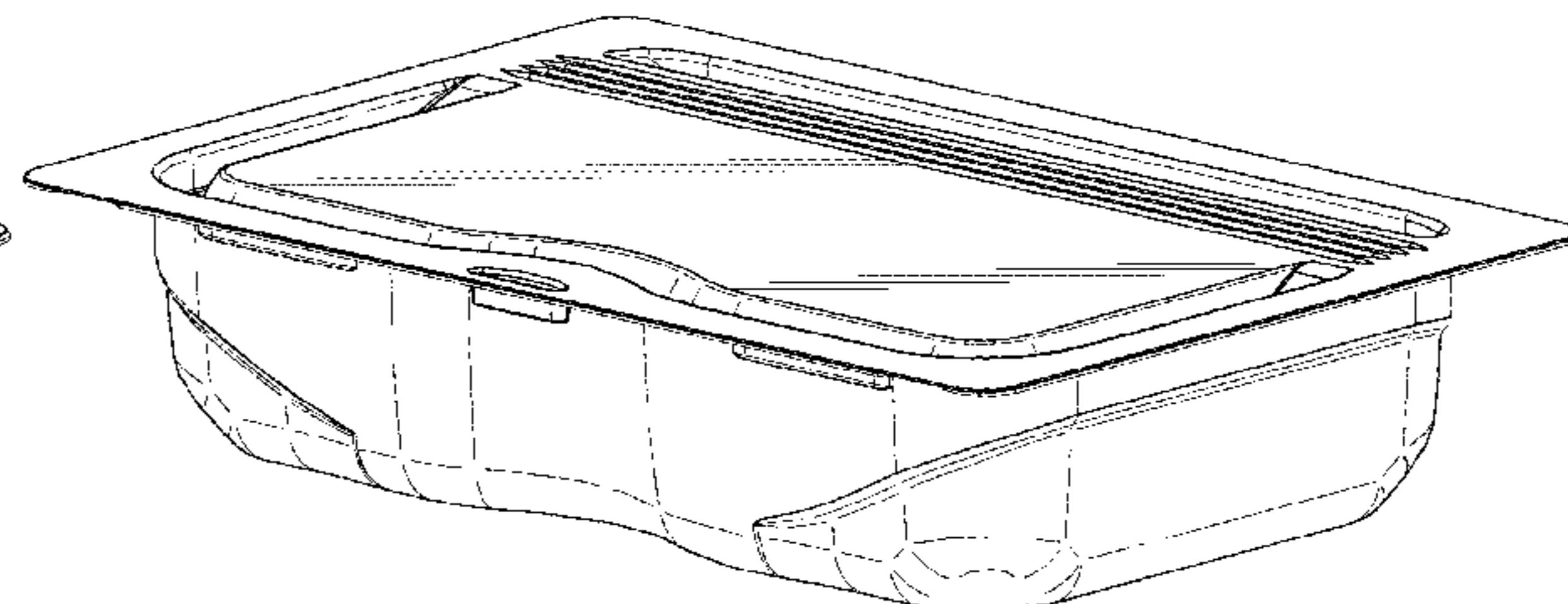
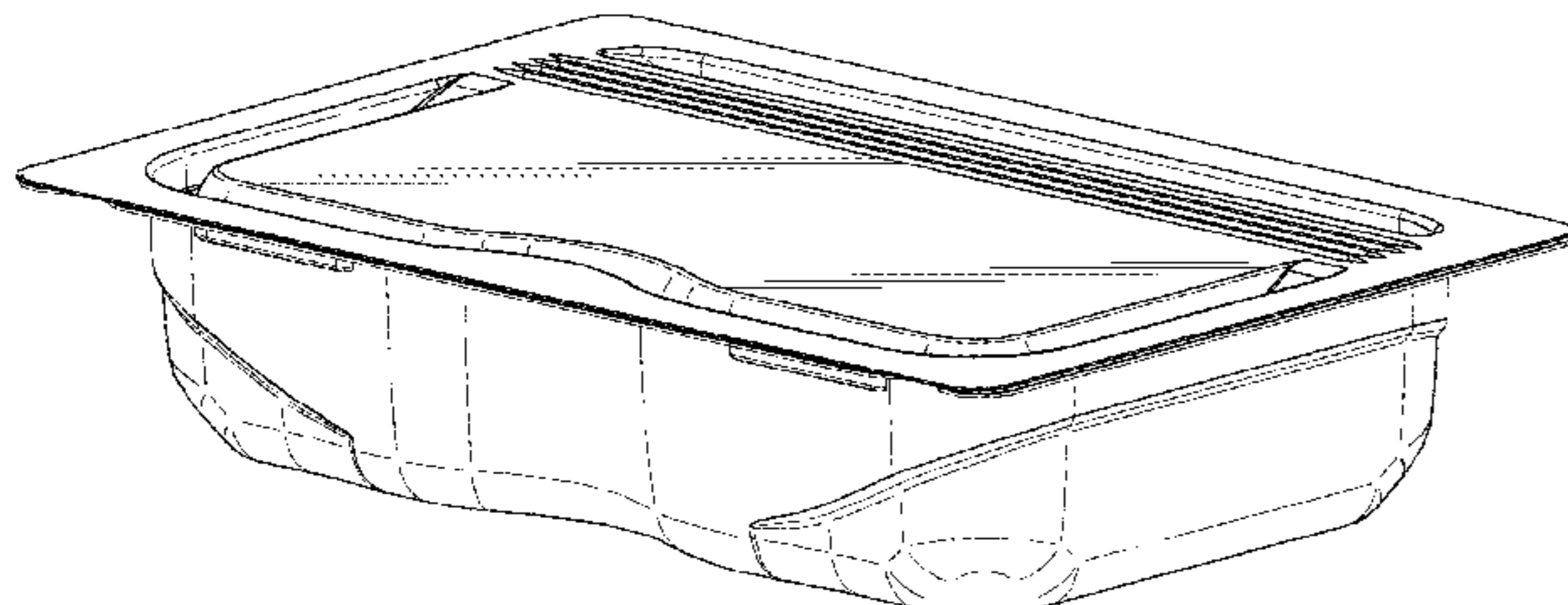
(57) **CLAIM**

We claim the ornamental design for a reclosable packaging, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a reclosable packaging showing our new design.

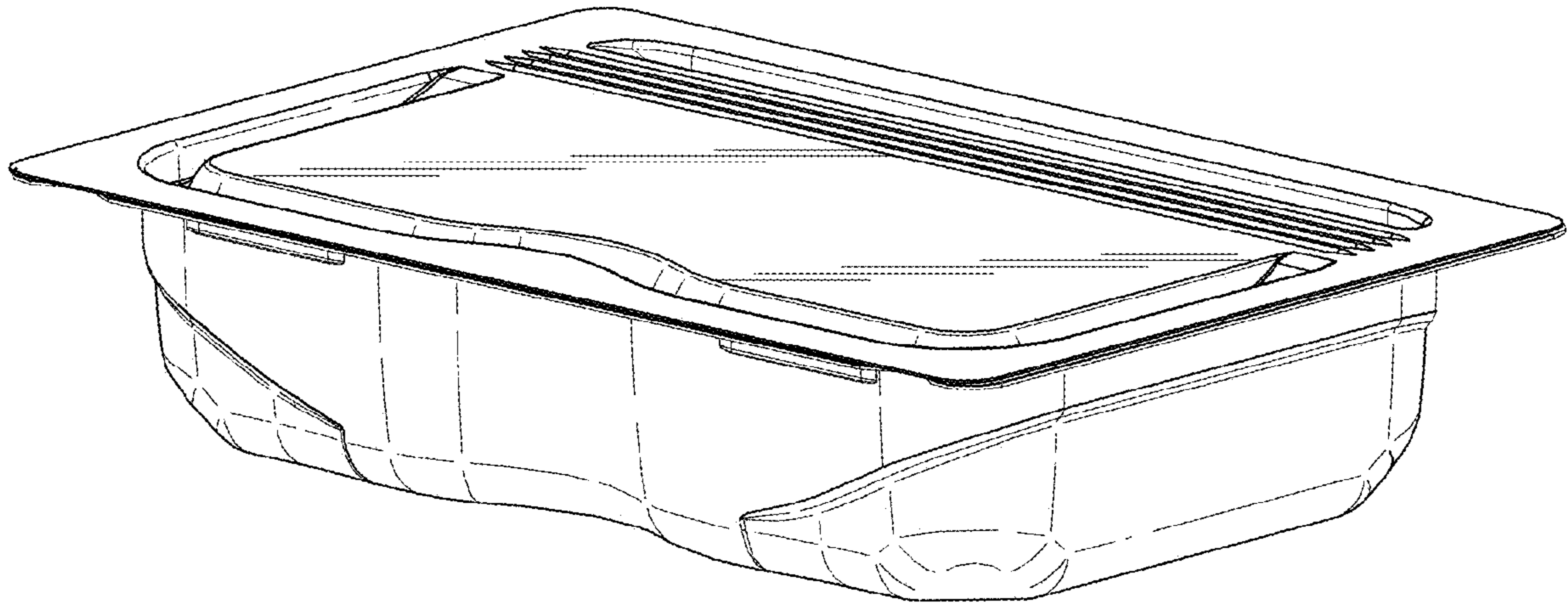

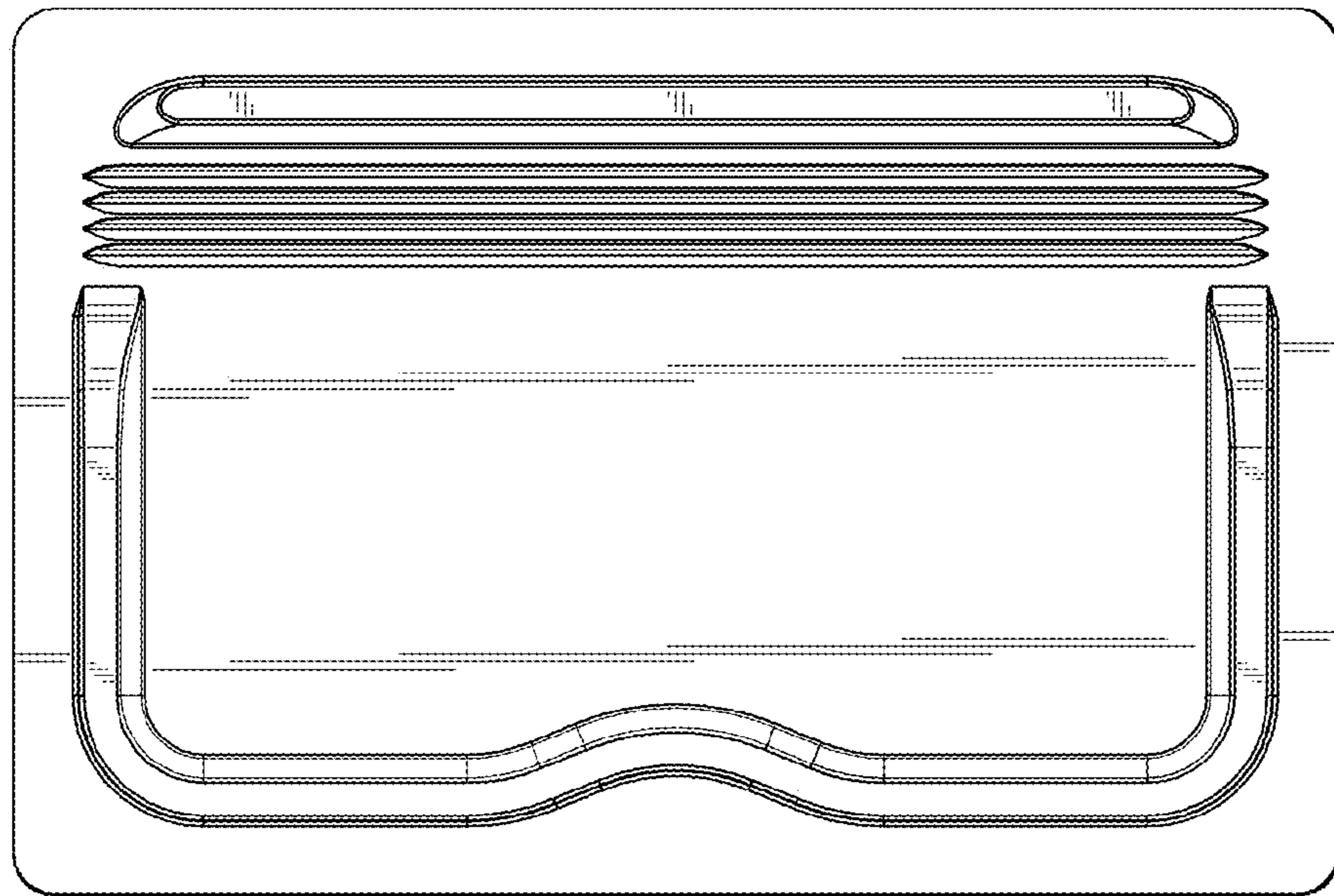

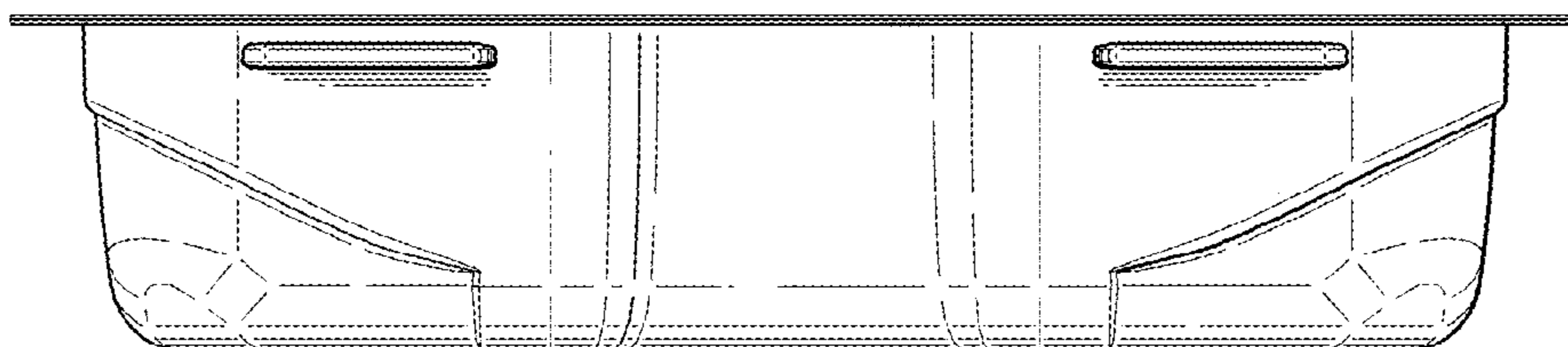

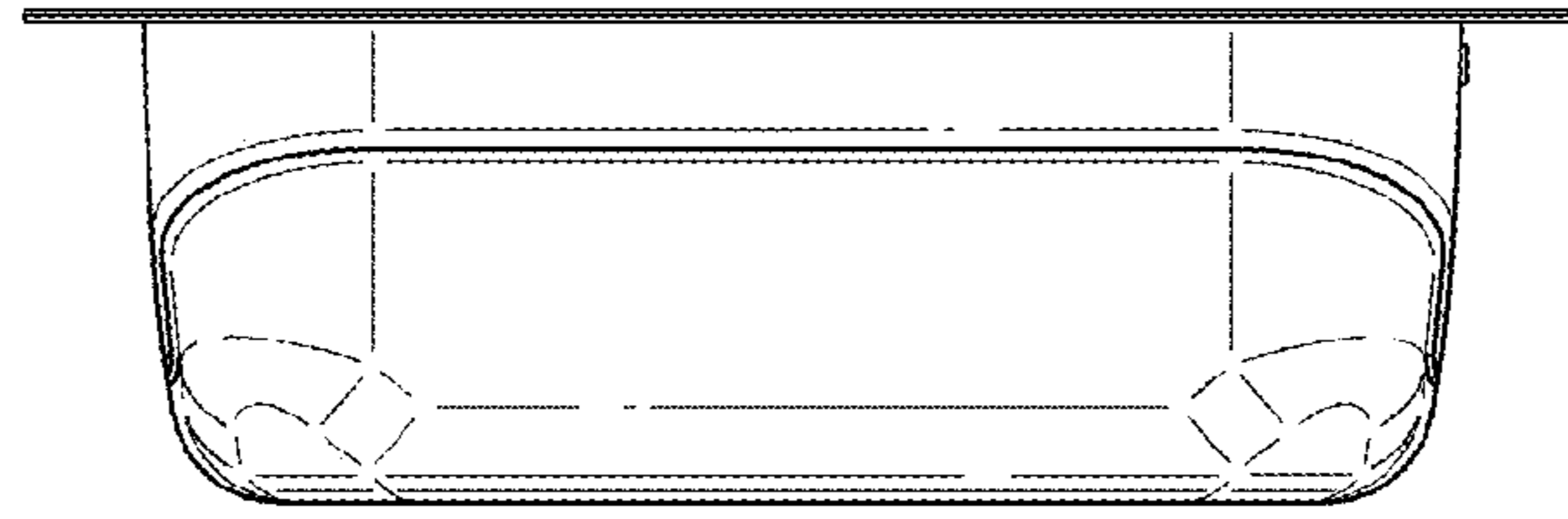

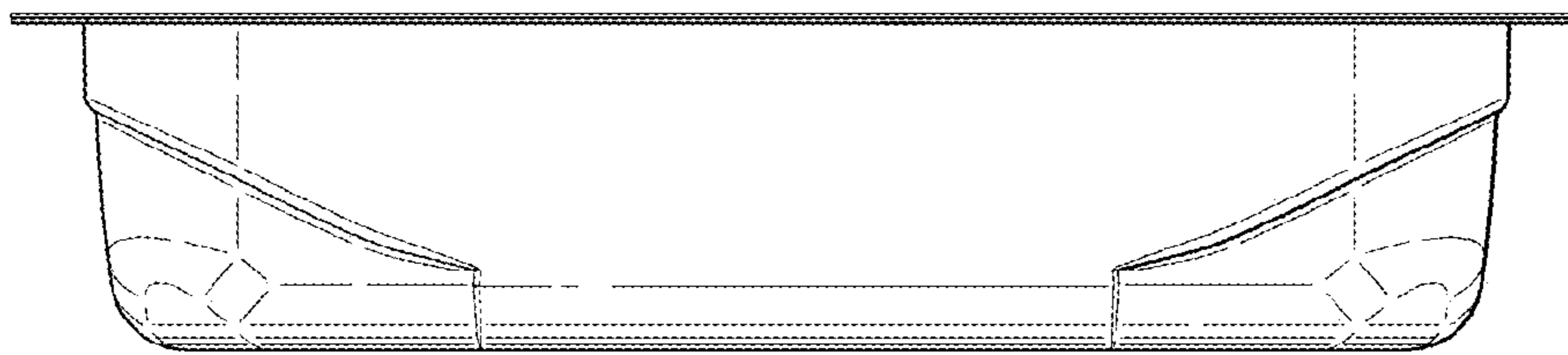

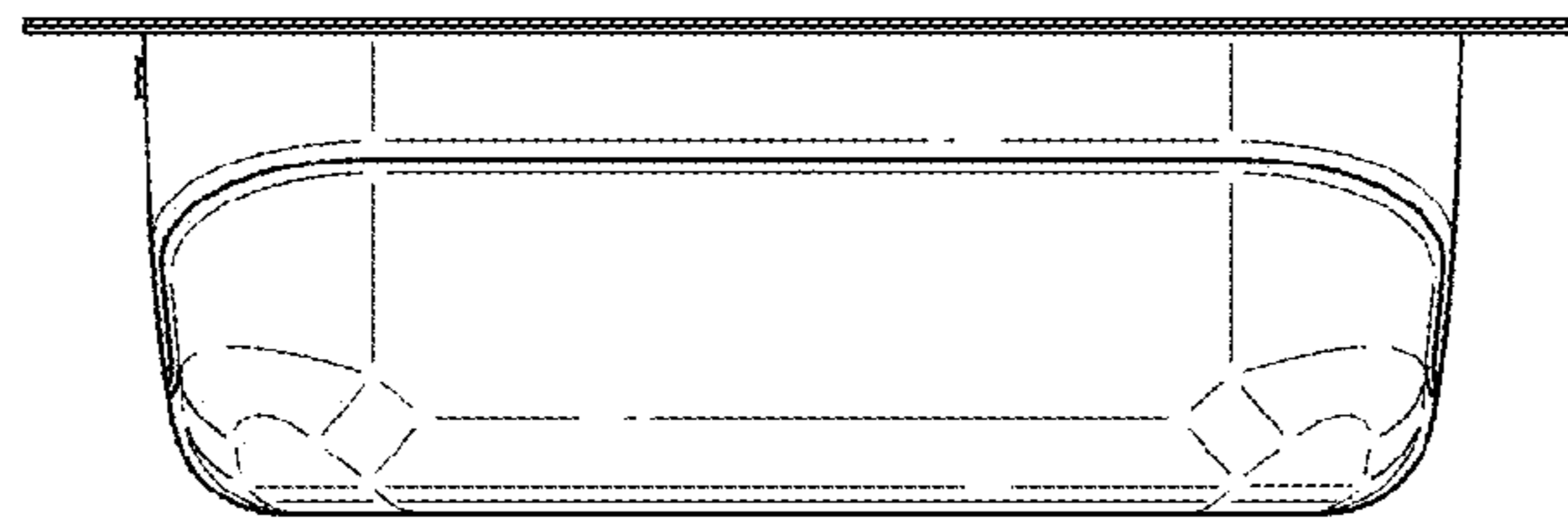

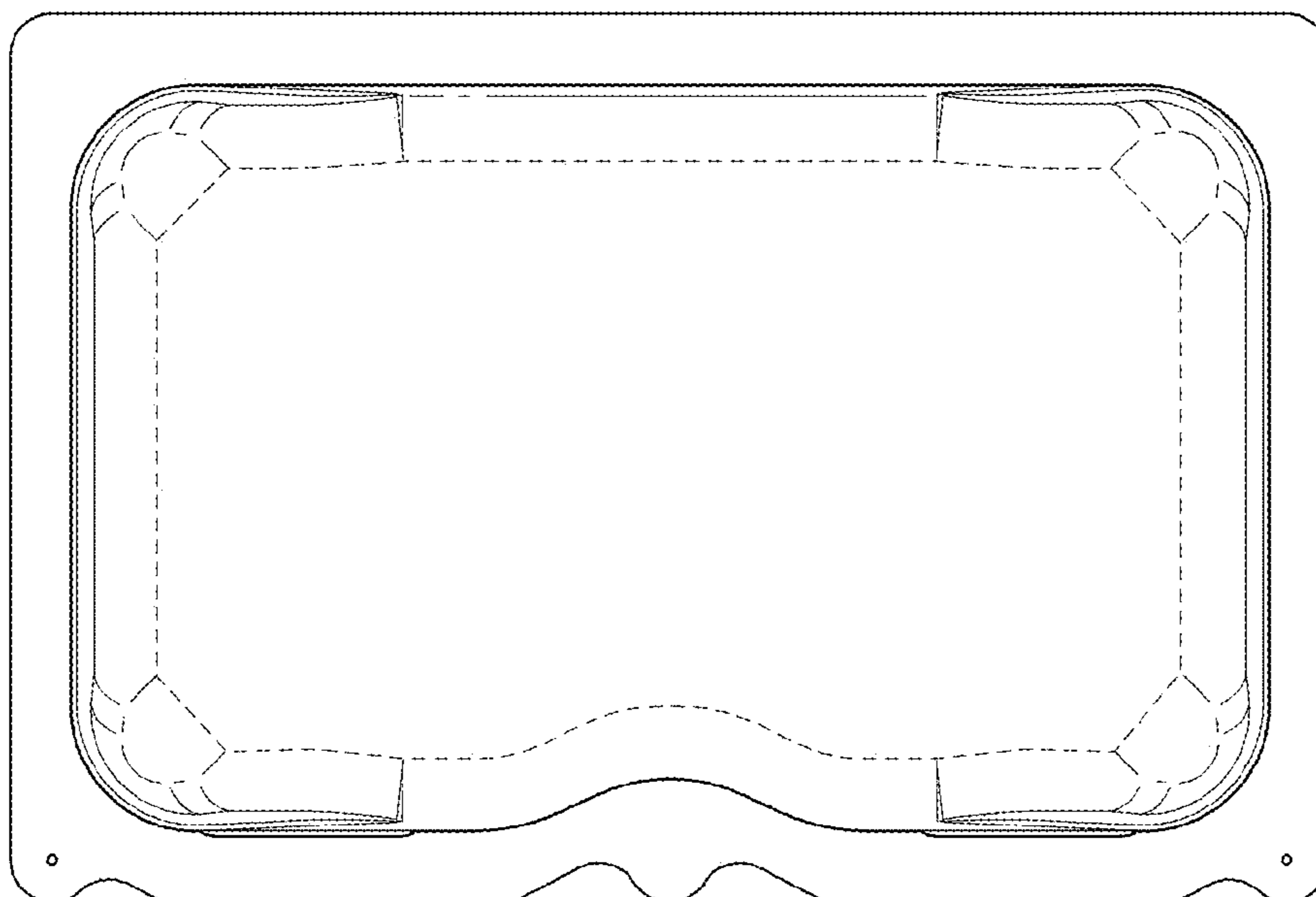

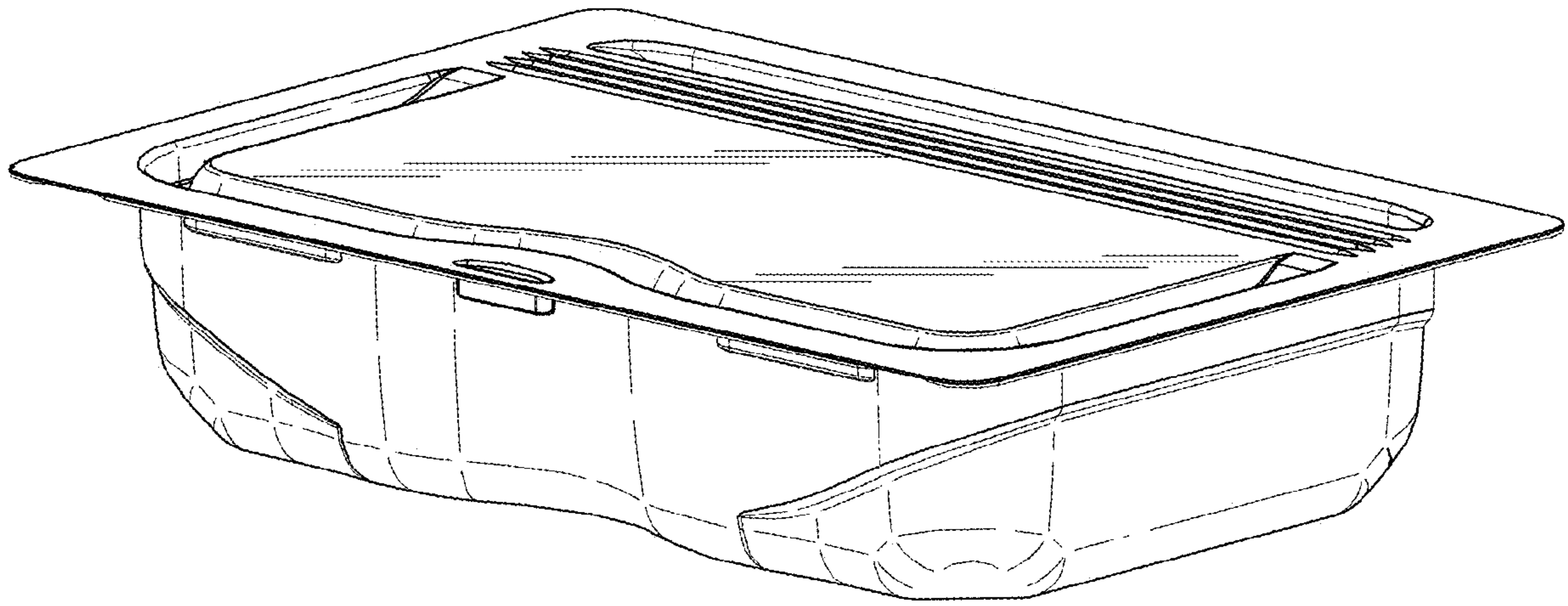

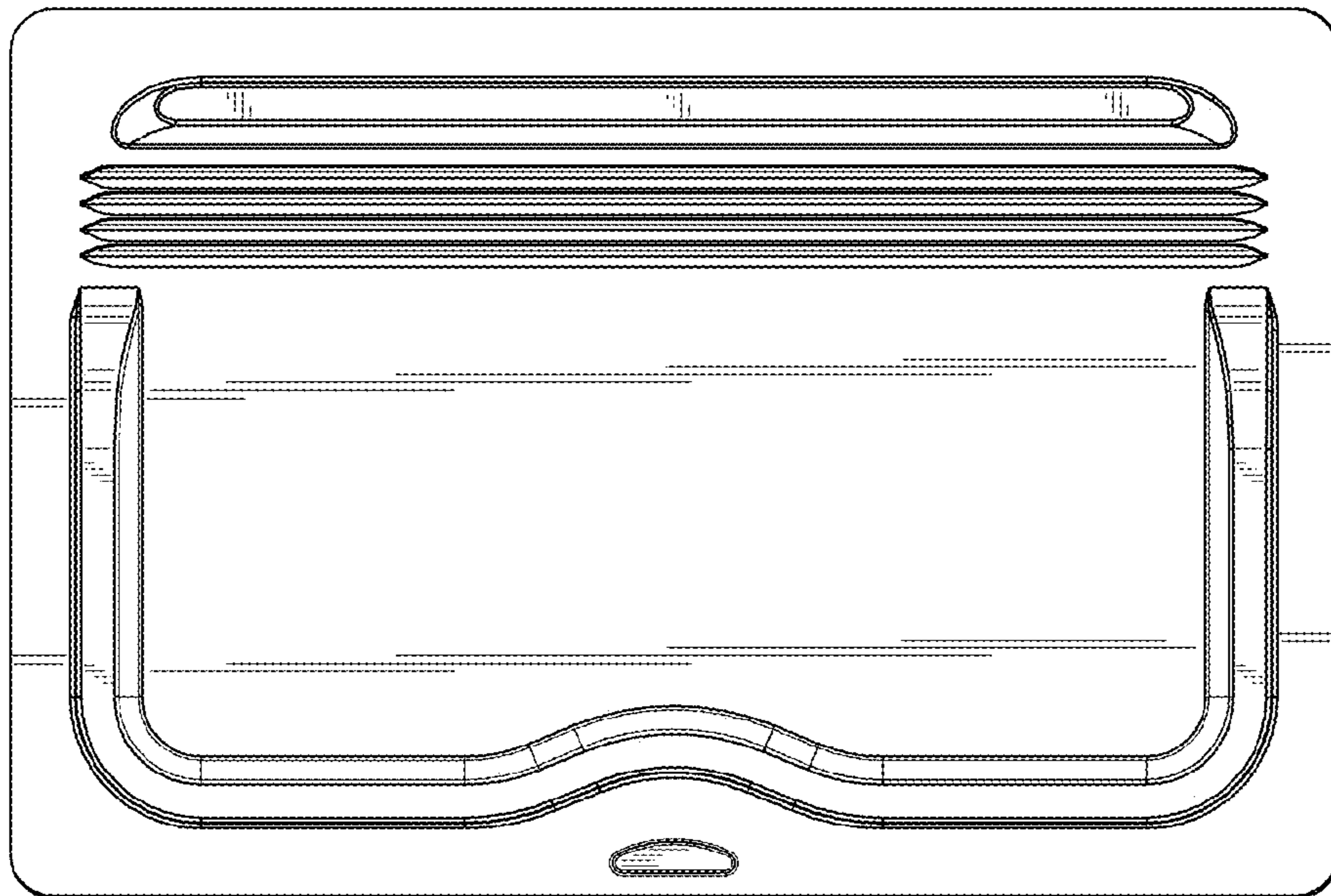

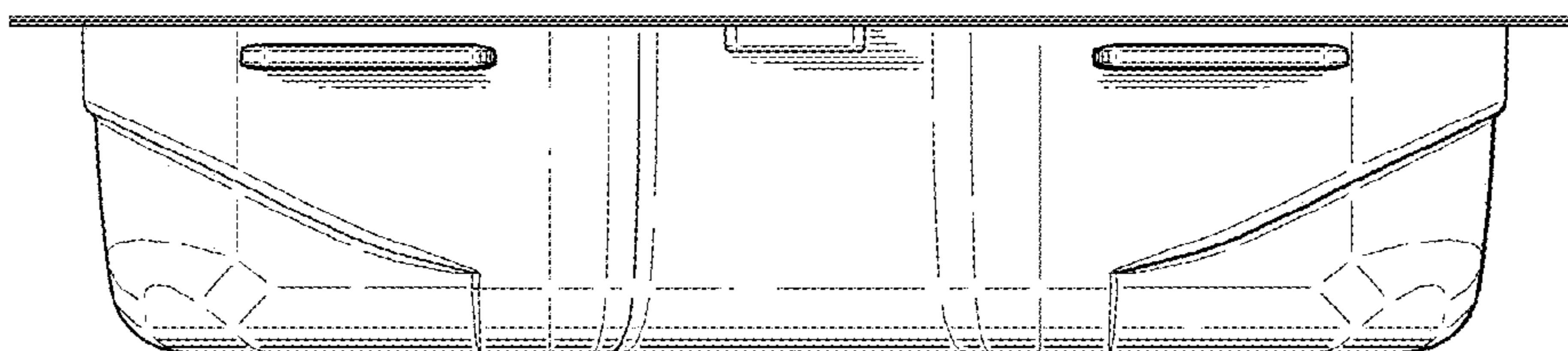

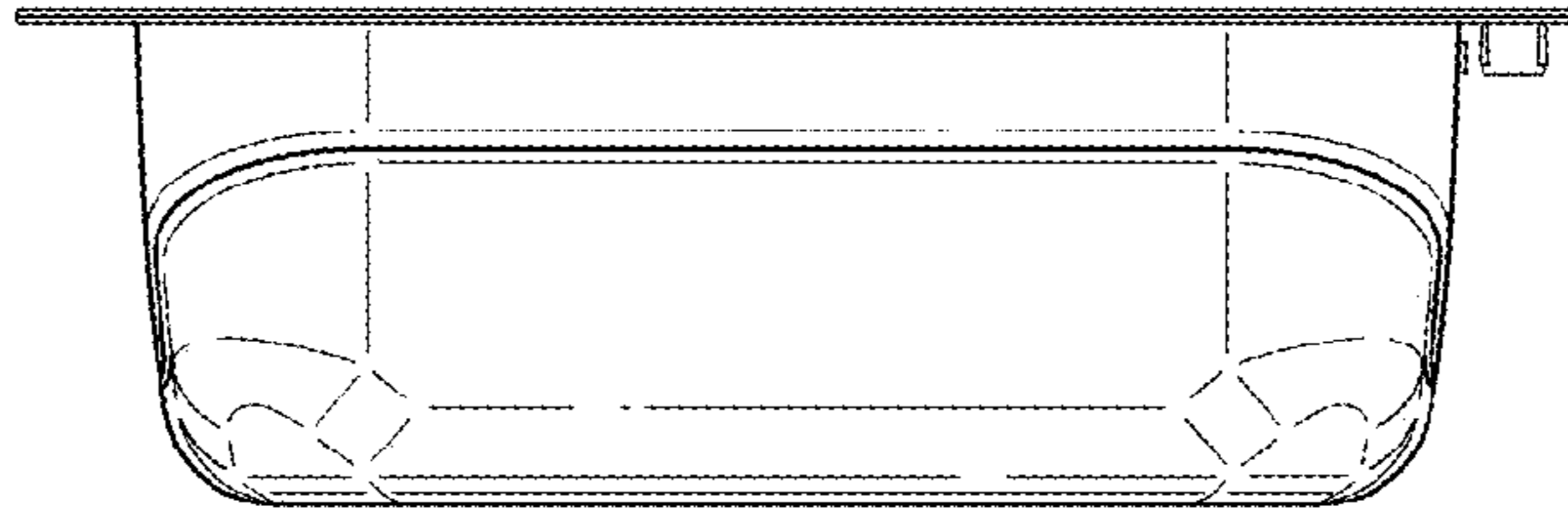

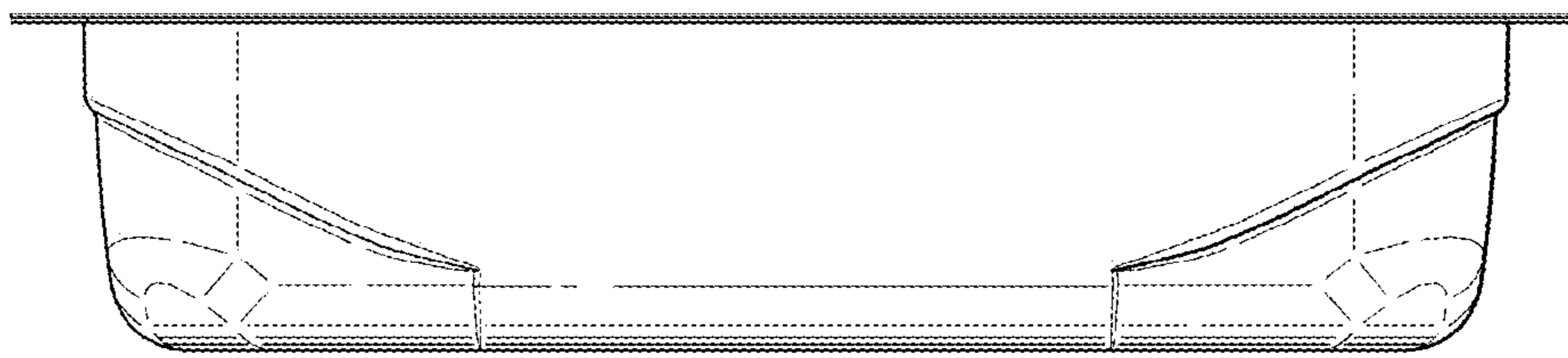

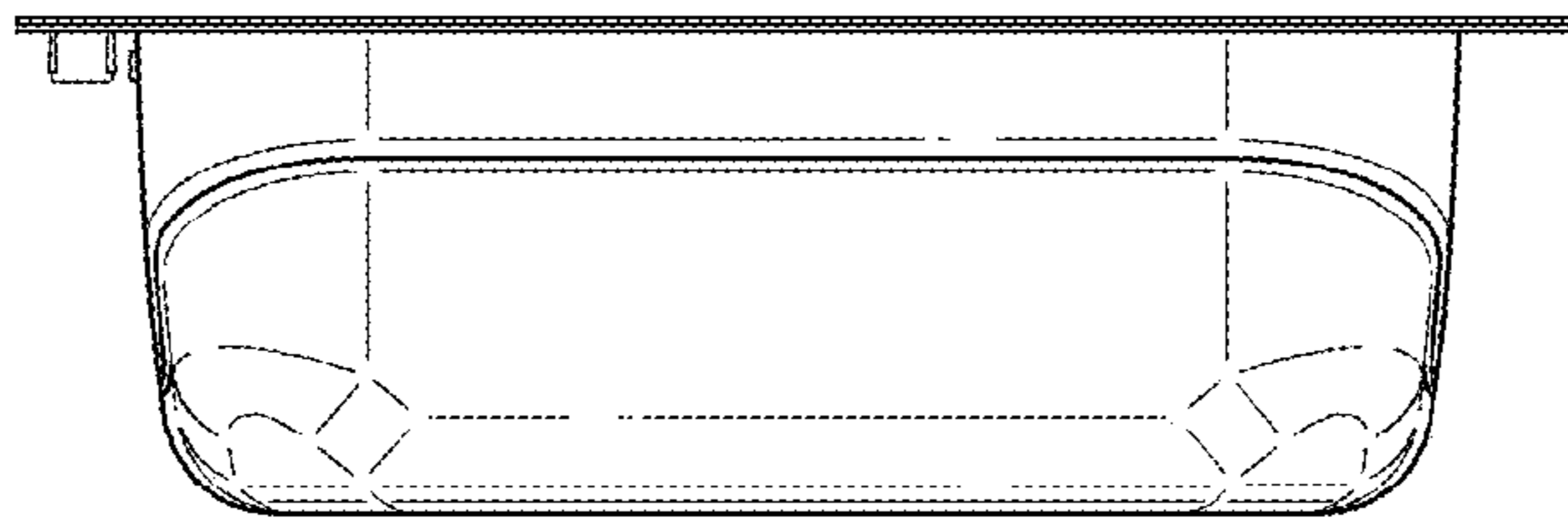
