FIG. 4 is a top view thereof; and,

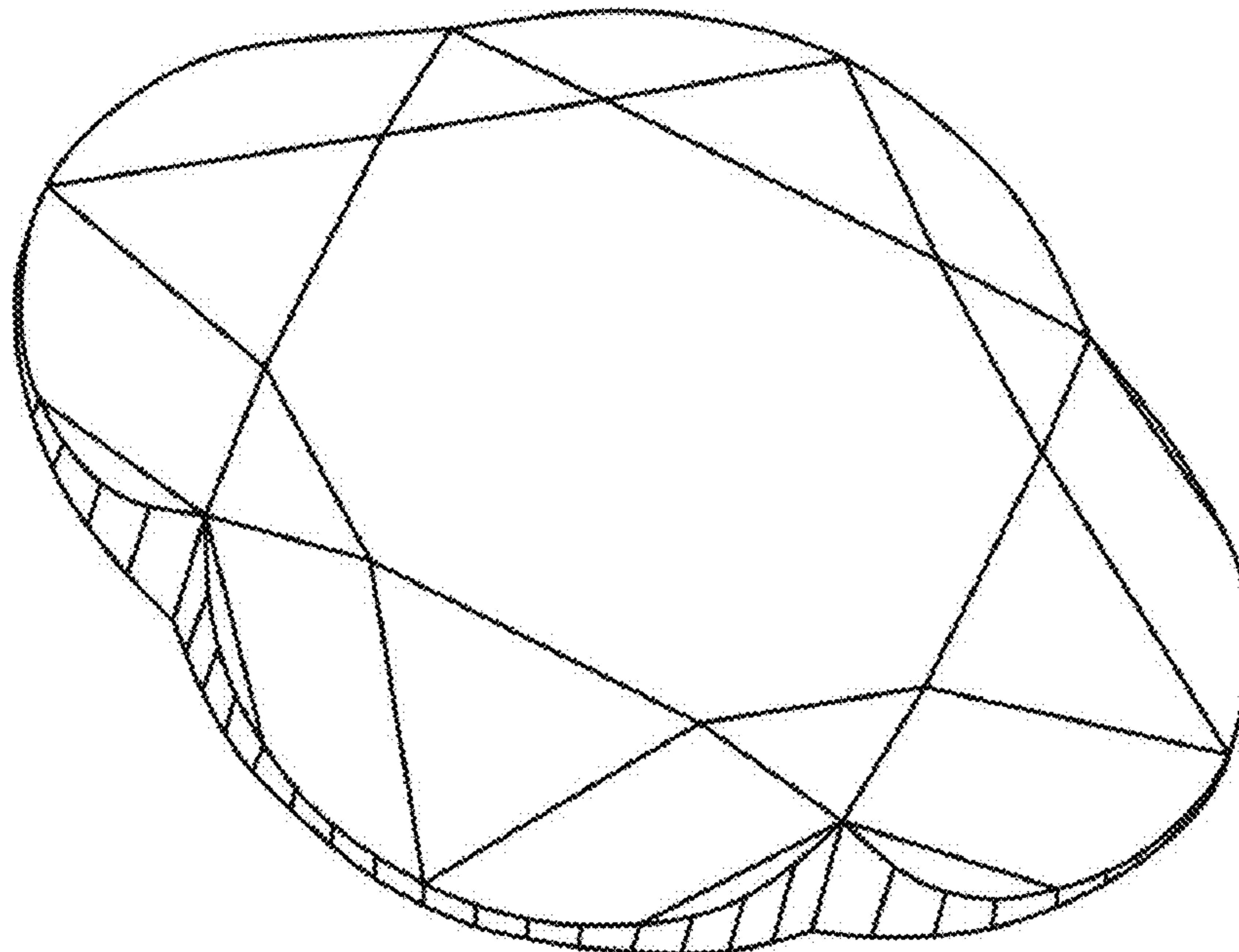
FIG. 5 is a bottom view thereof.

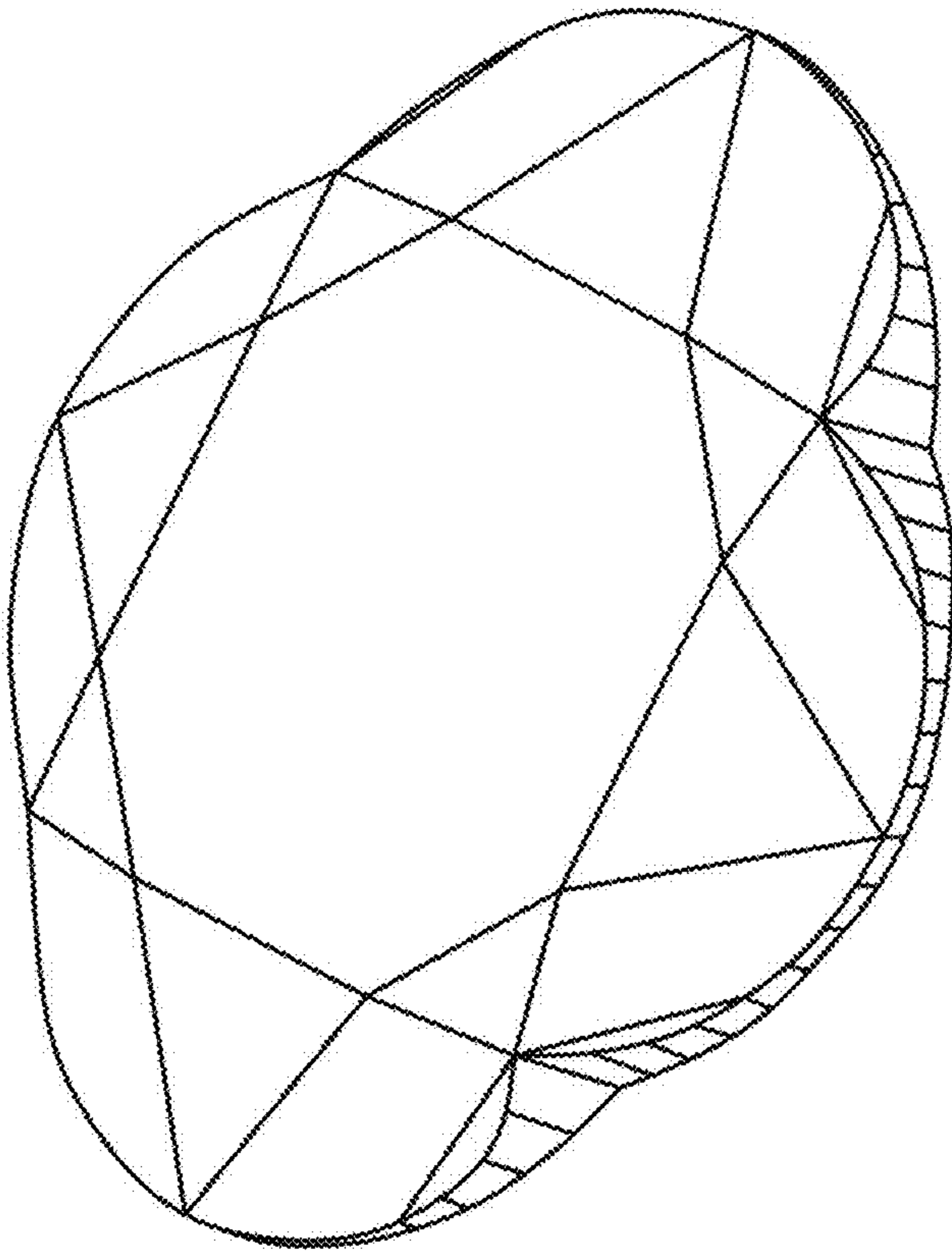

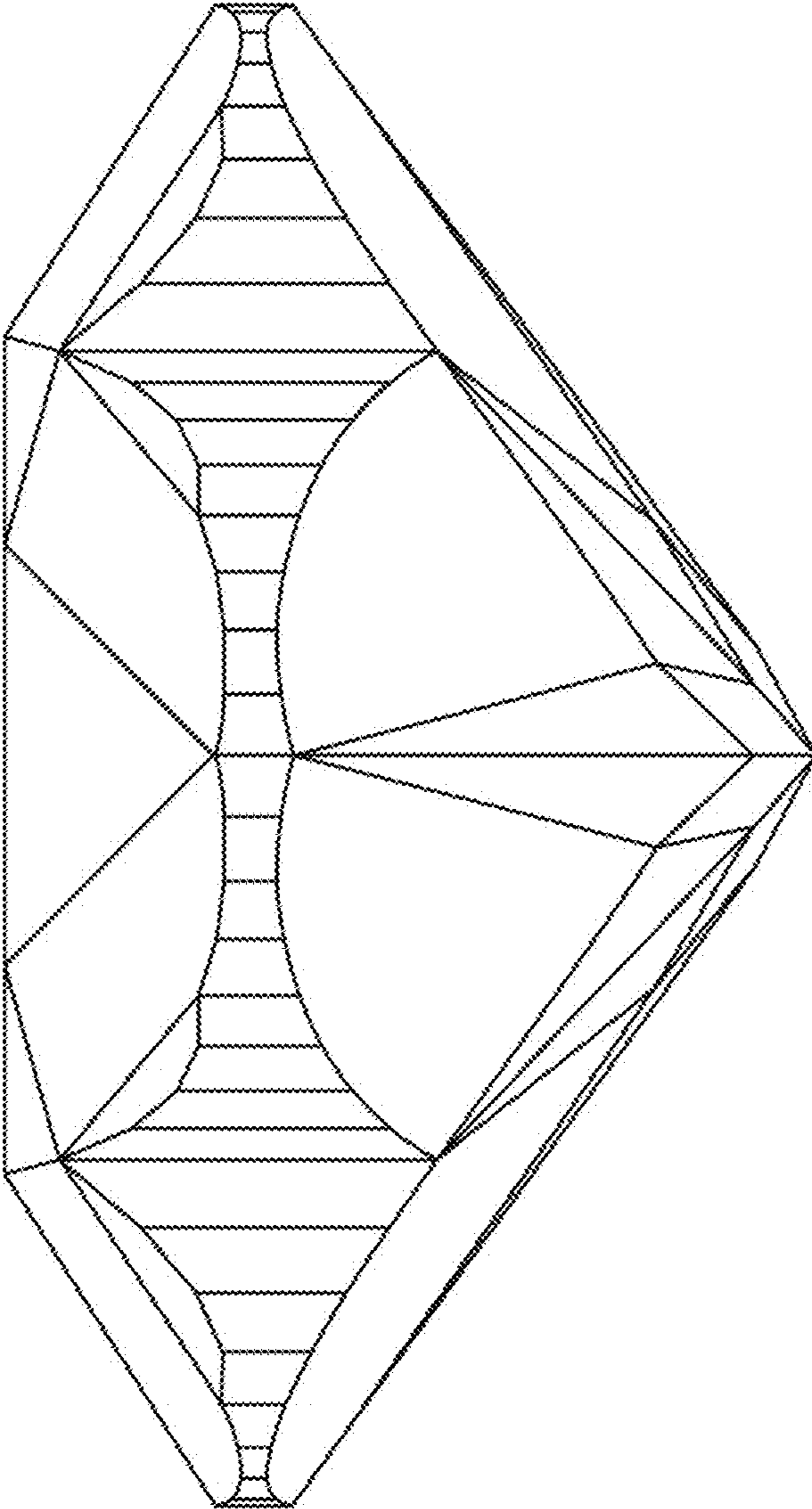

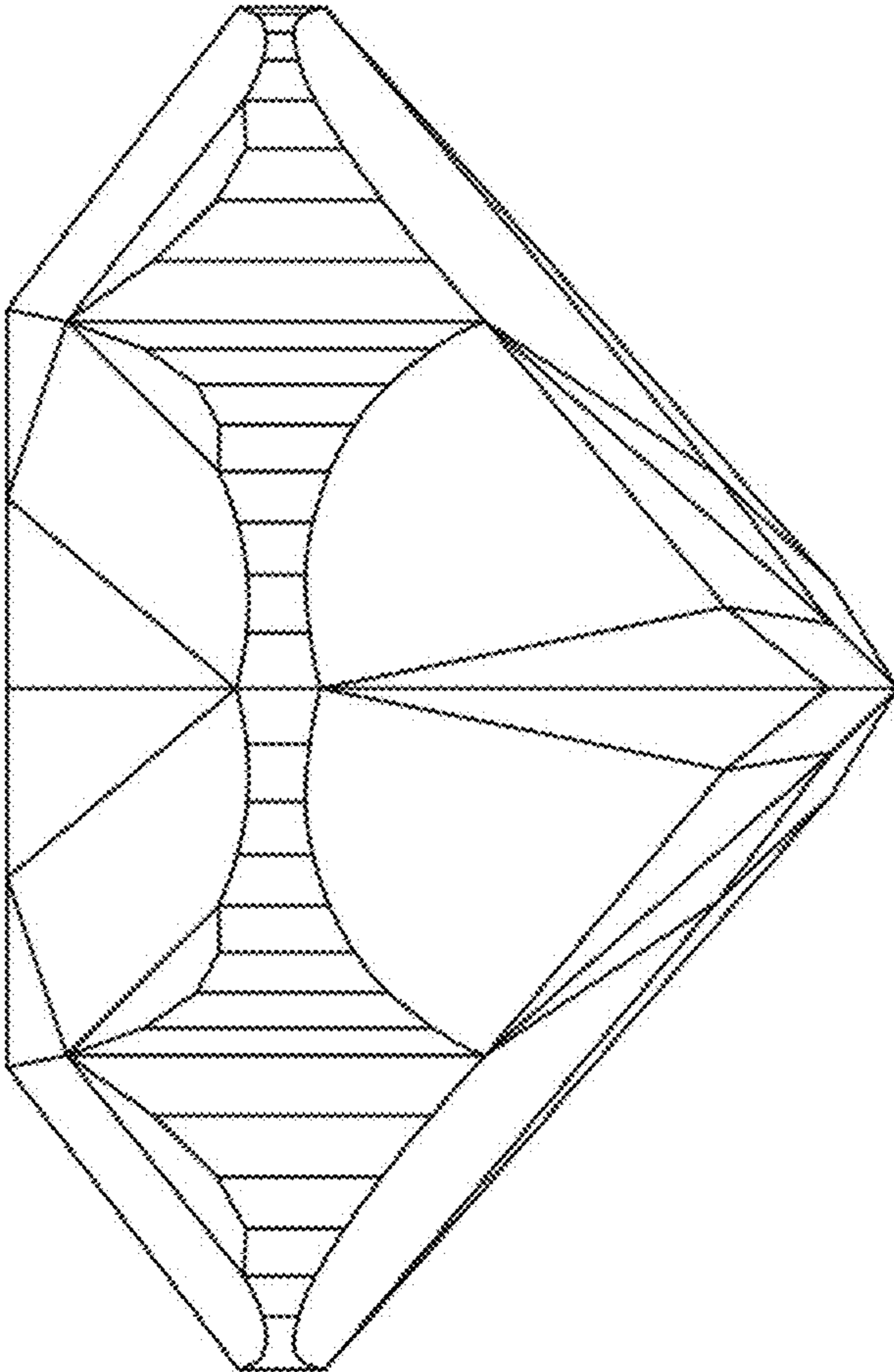

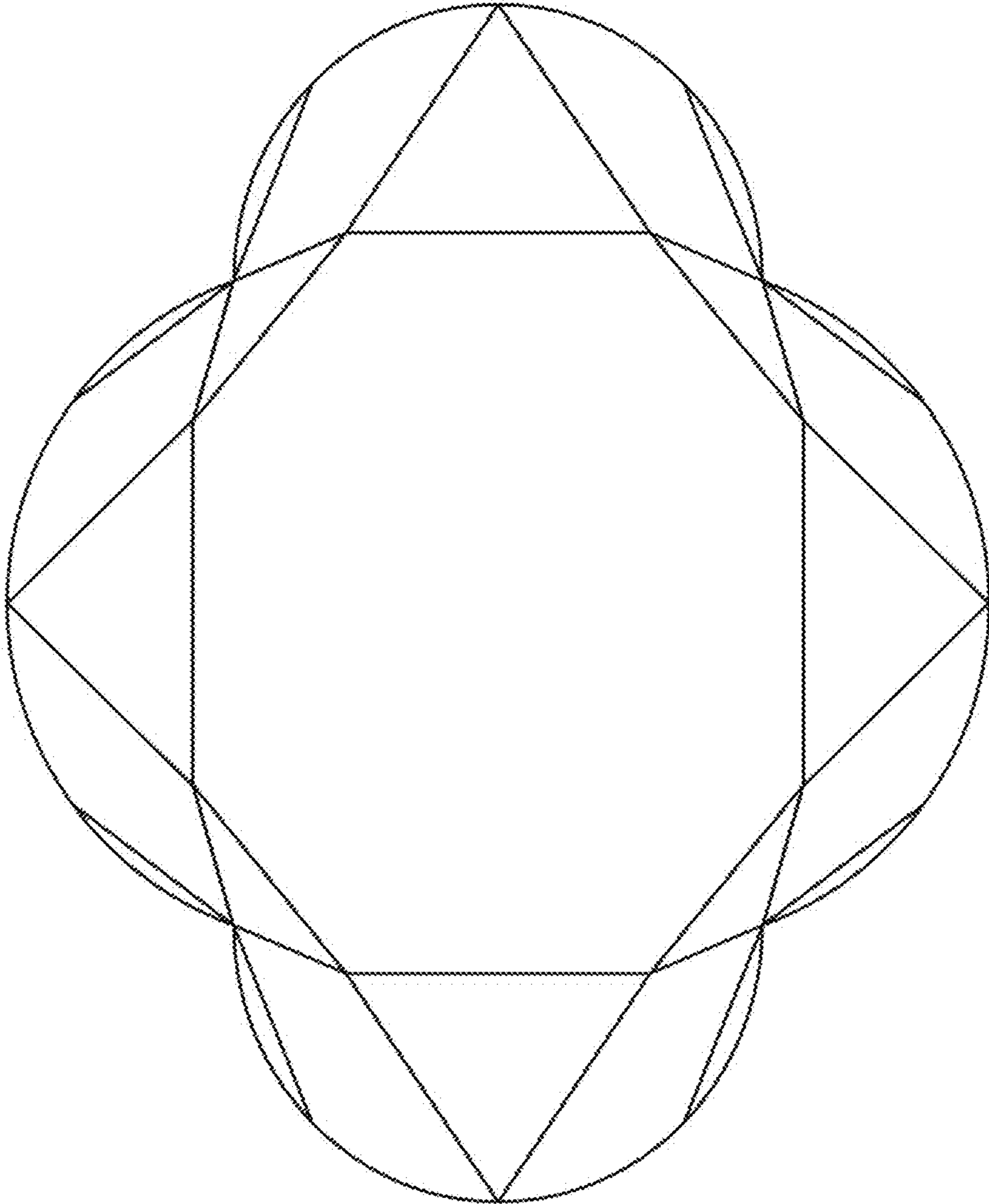

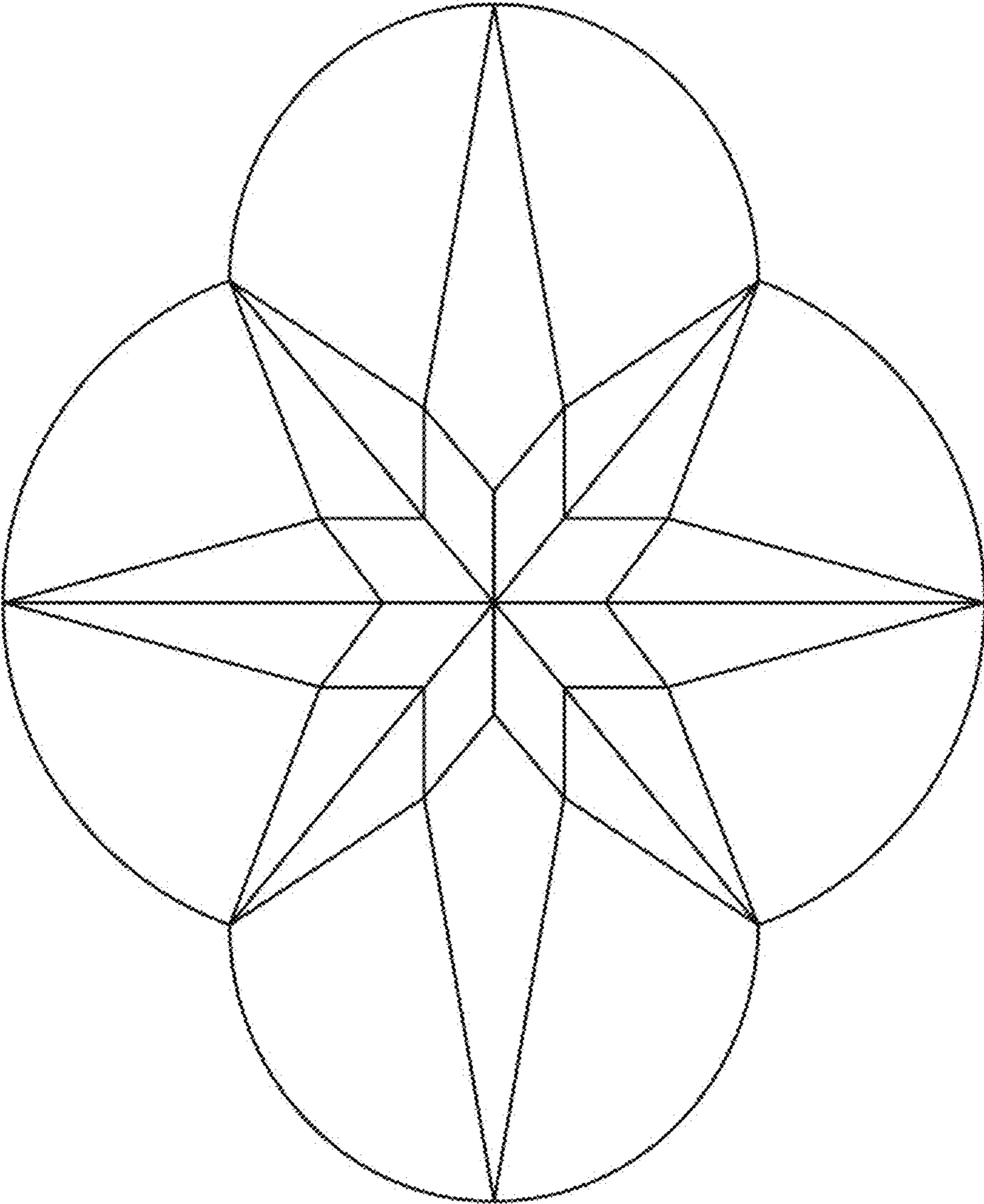
