FIG. 3 is a top plan view thereof;

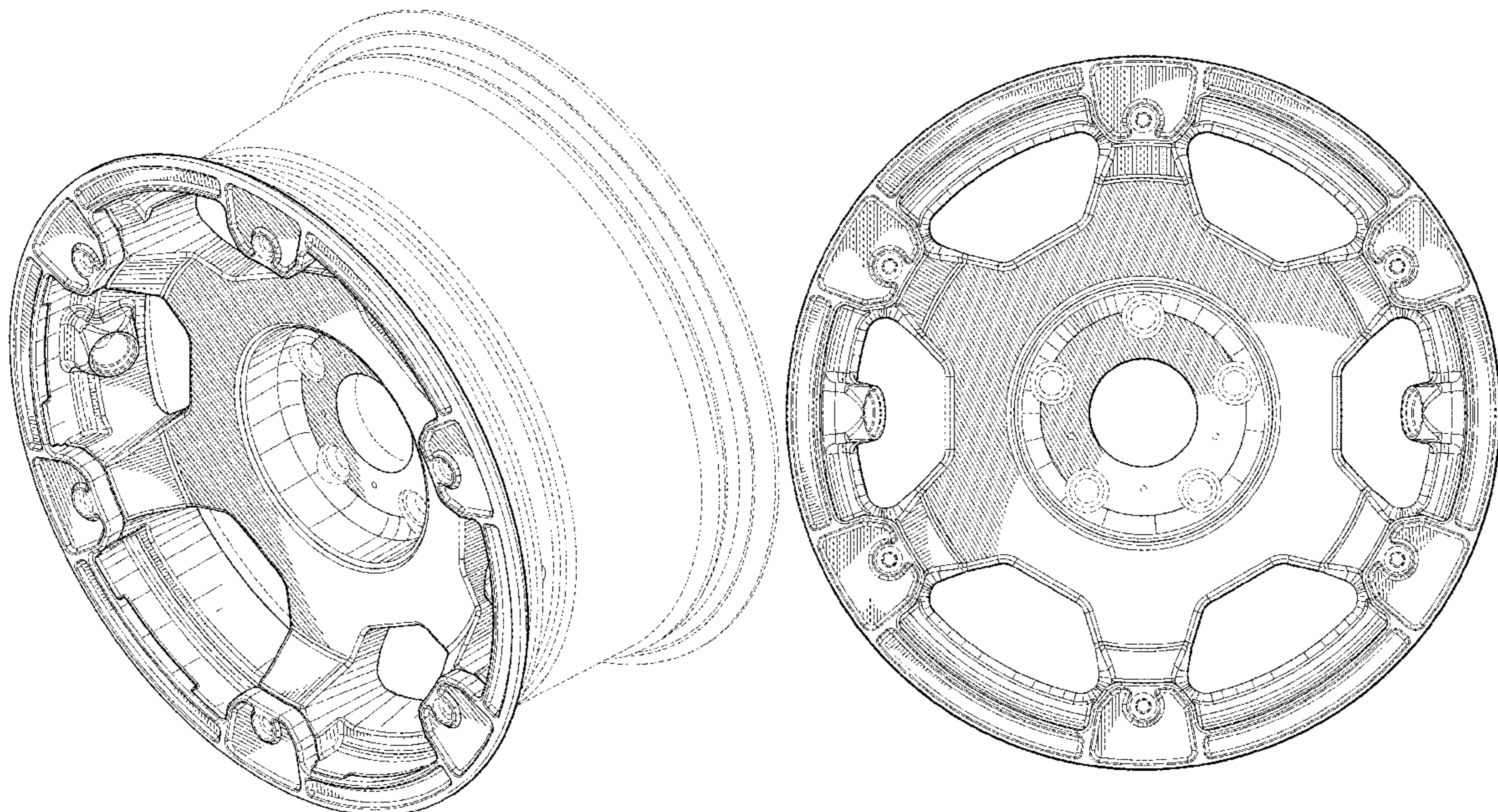
FIG. 4 is a perspective view of a second embodiment of a vehicle wheel, showing our new design;

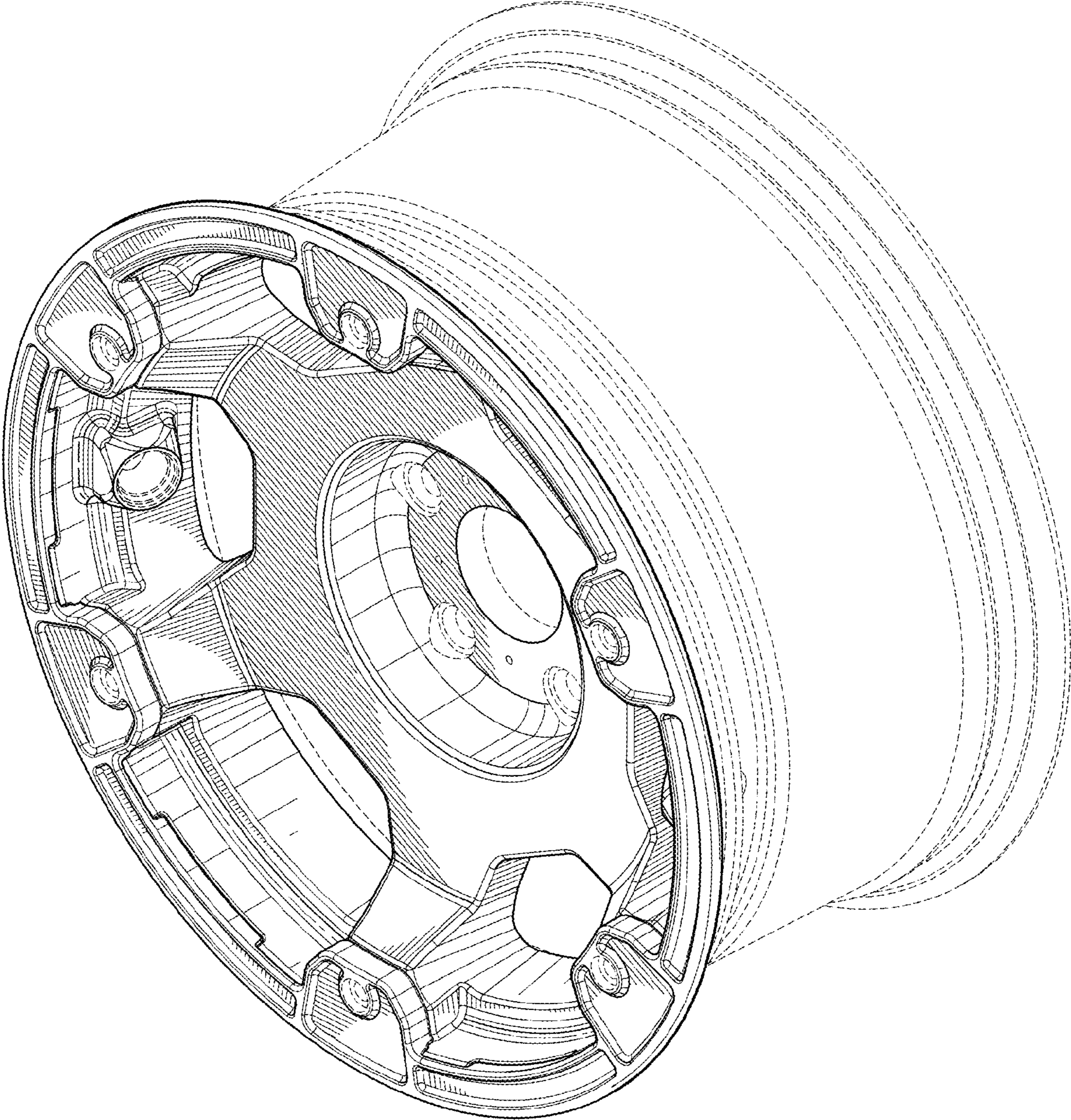
FIG. 5 is a front view of FIG. 4; and,

FIG. 6 is a top plan view of FIG. 4.

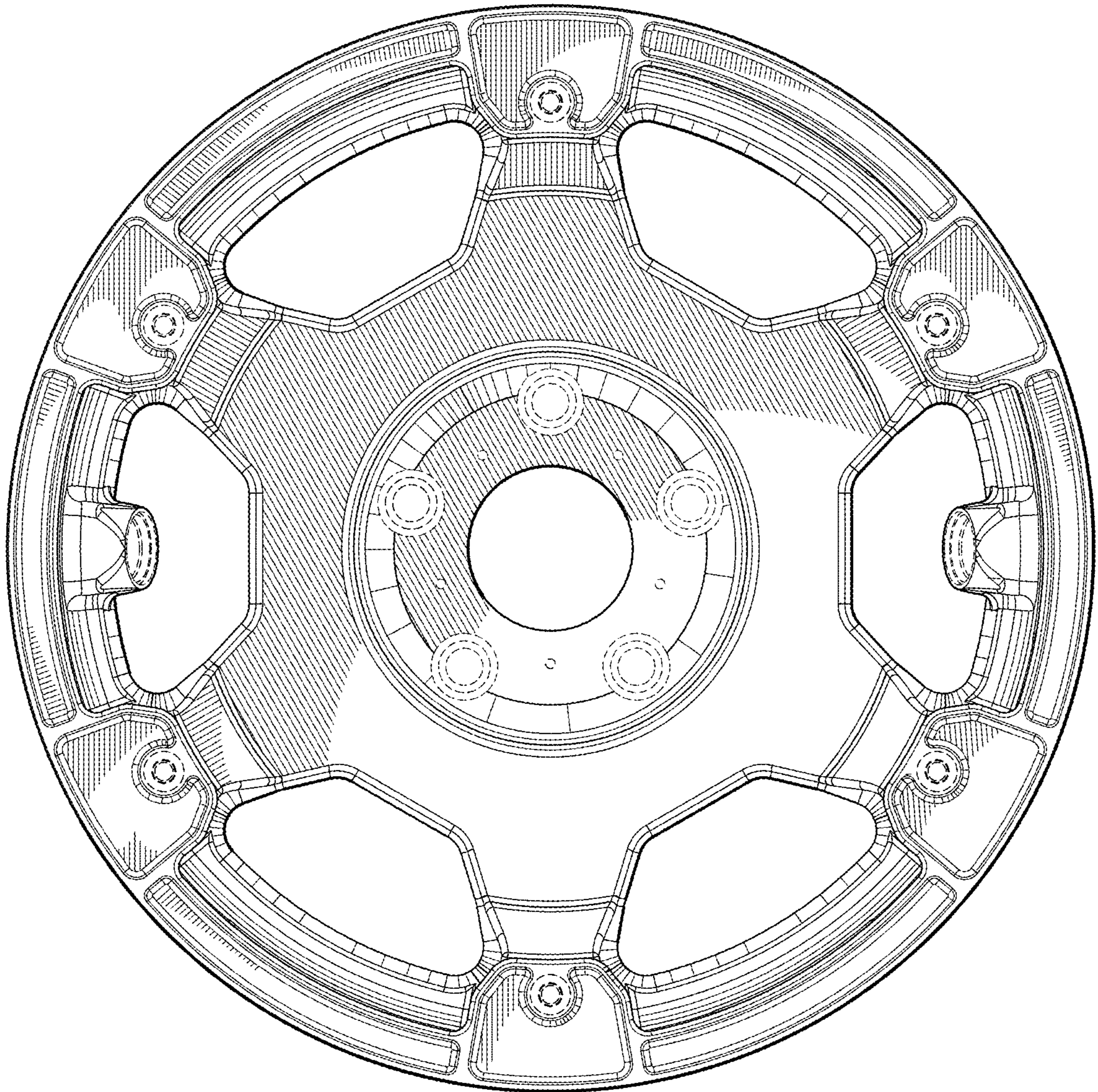
The broken lines show portions of the vehicle wheel which form no part of the claimed design.

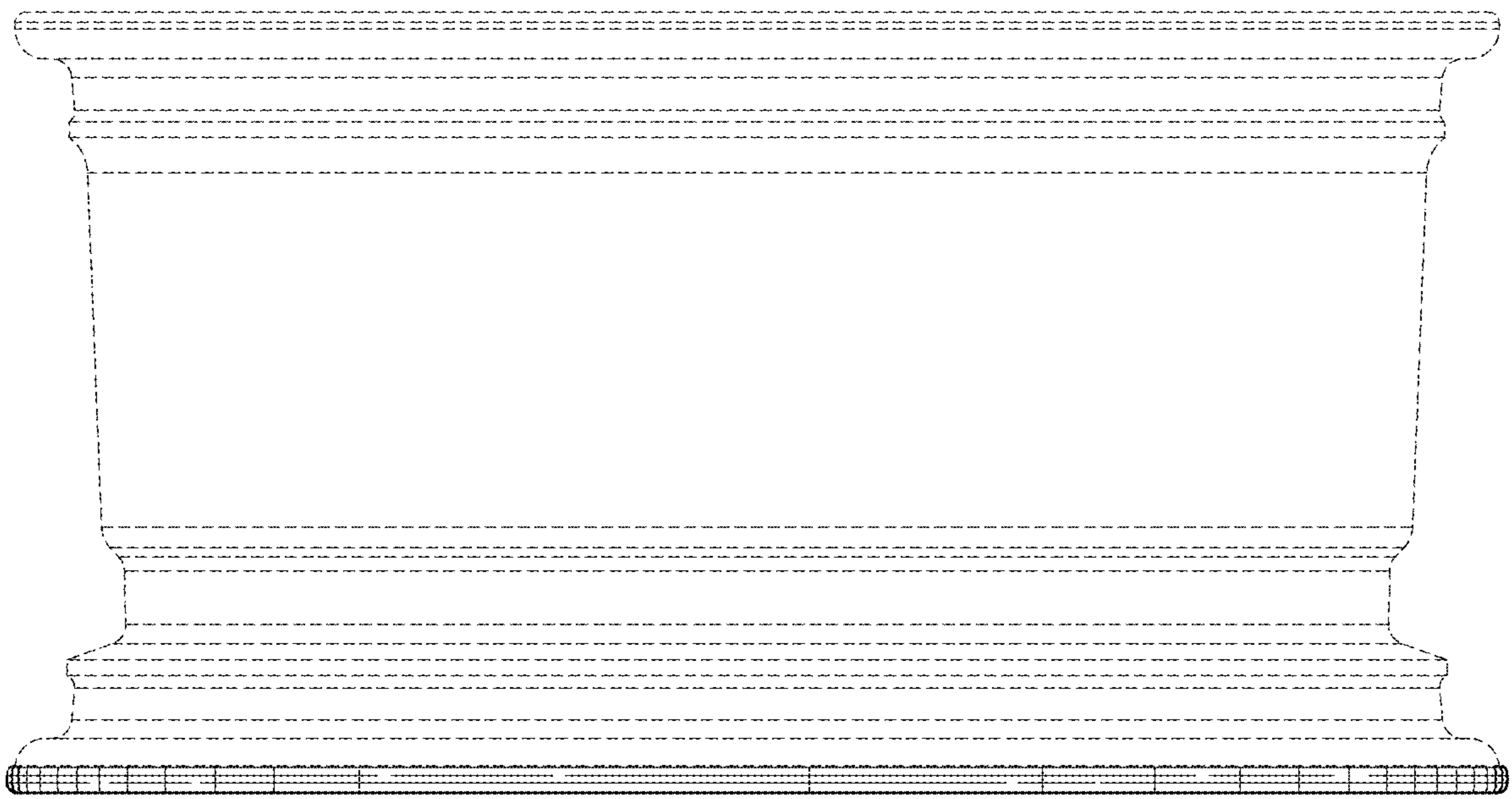




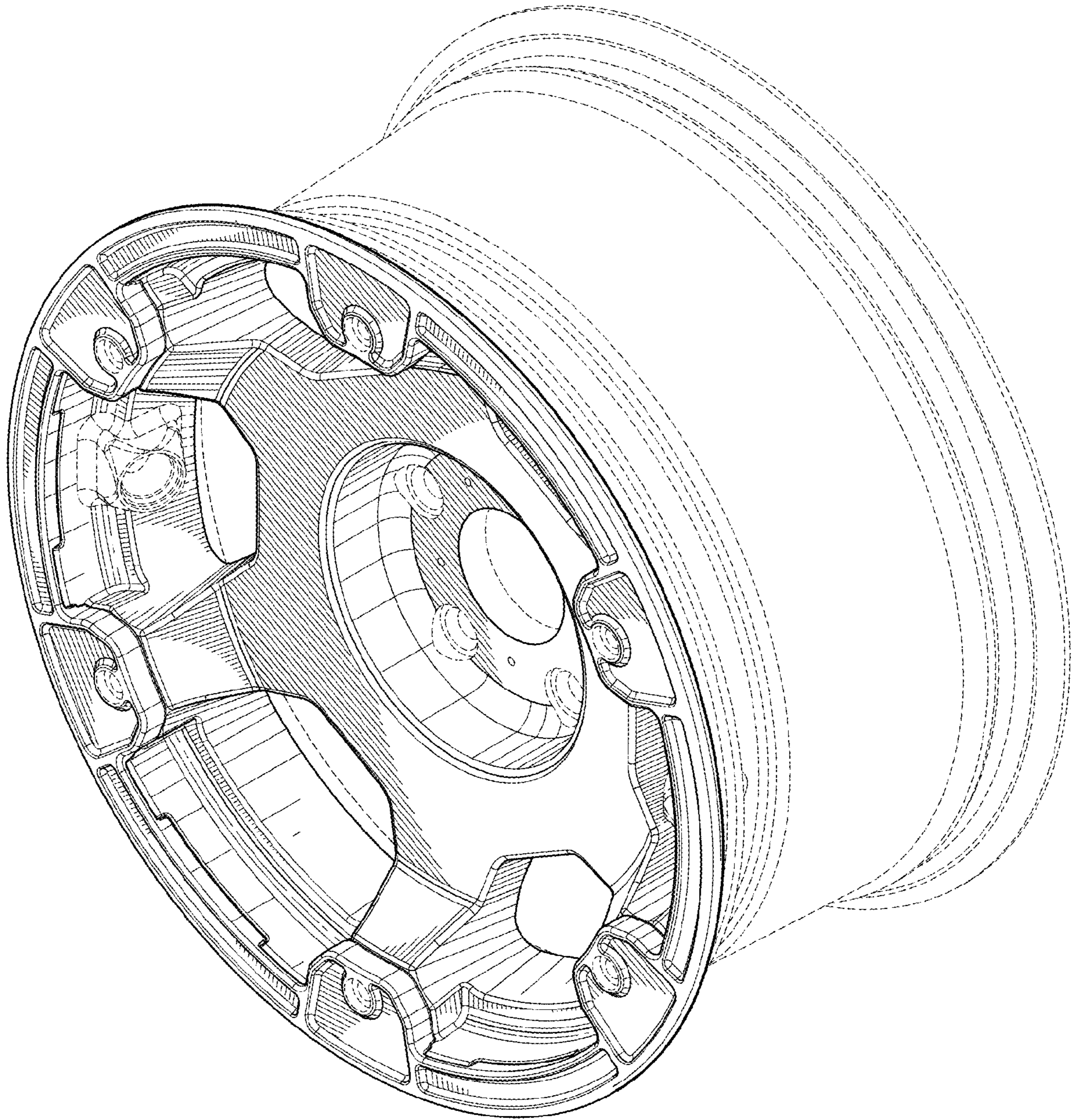

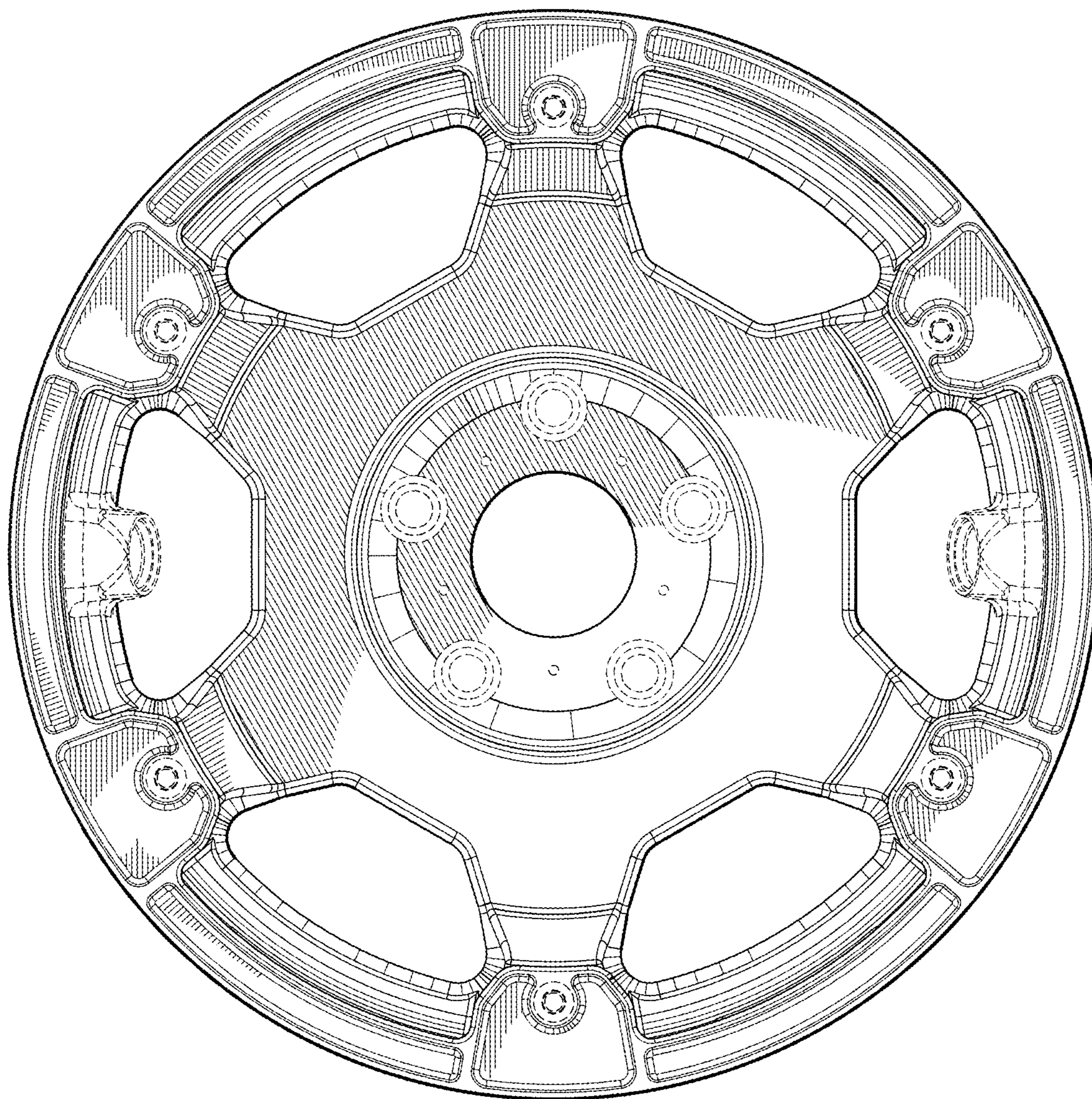
