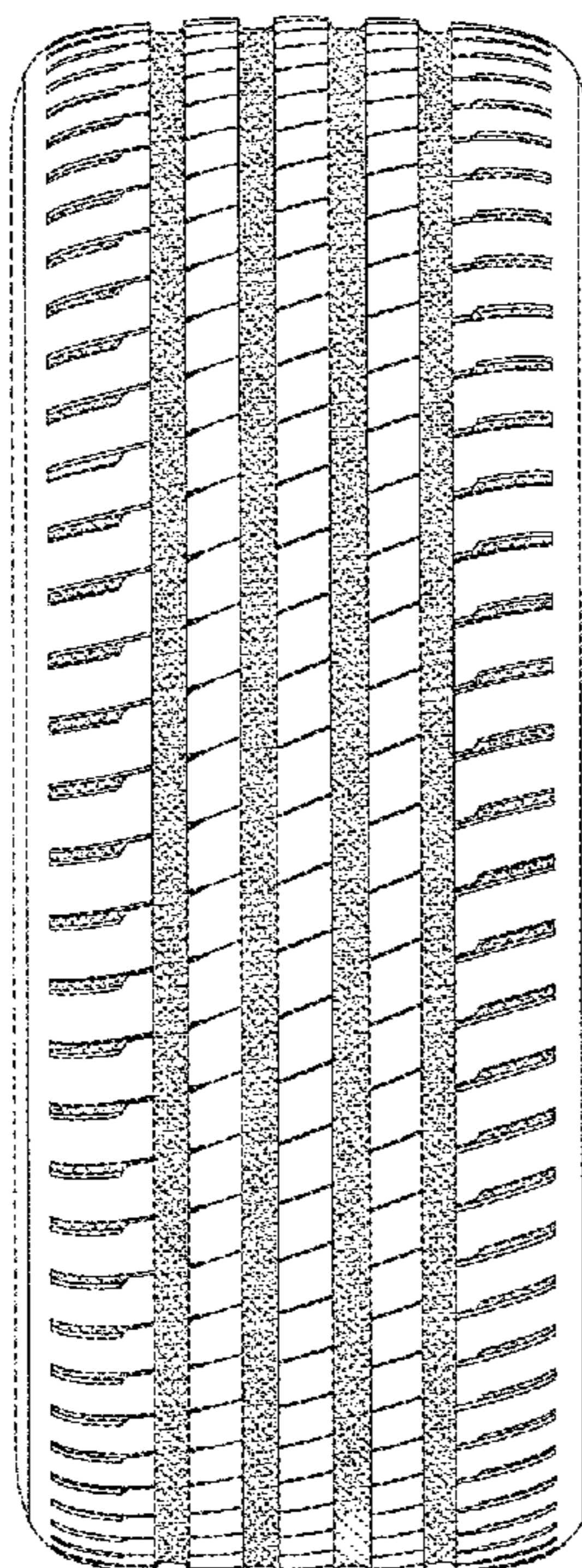
FIG. 1 is a perspective view of the tire;

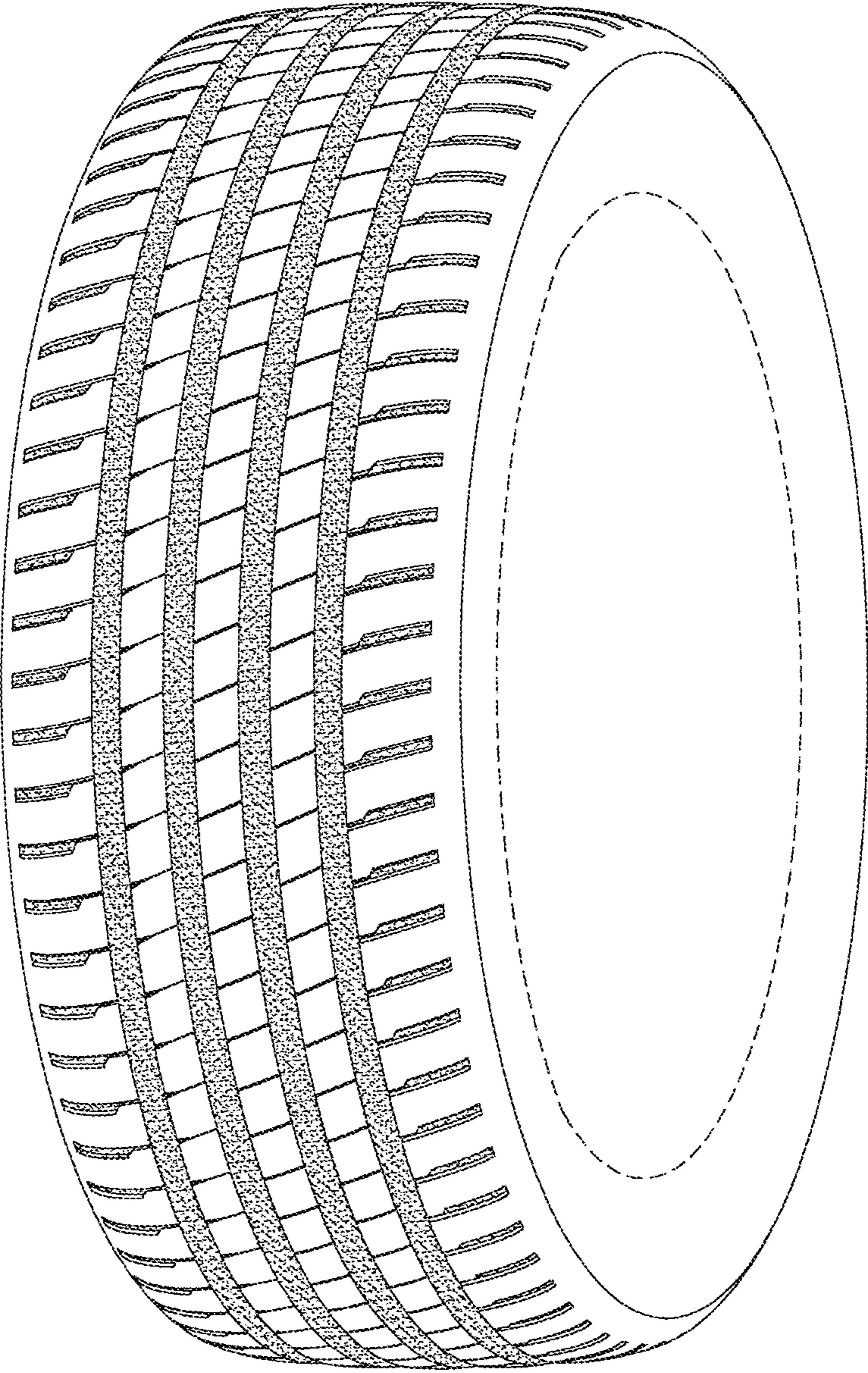

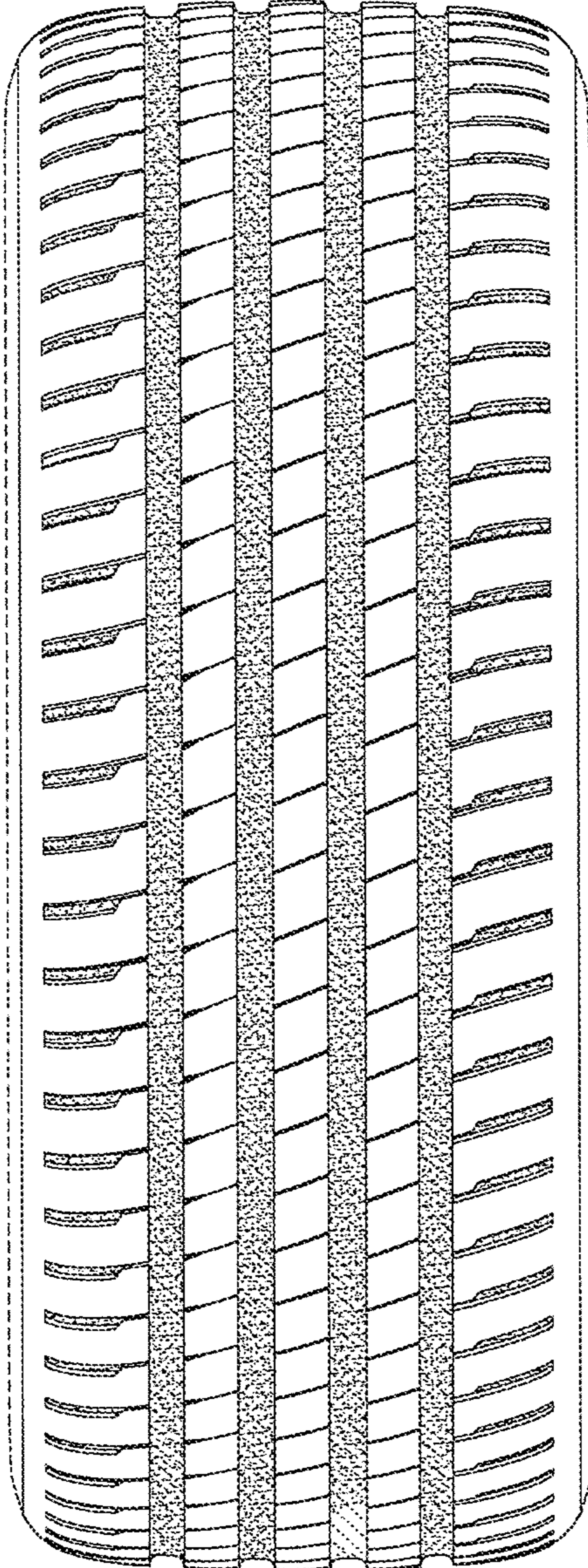

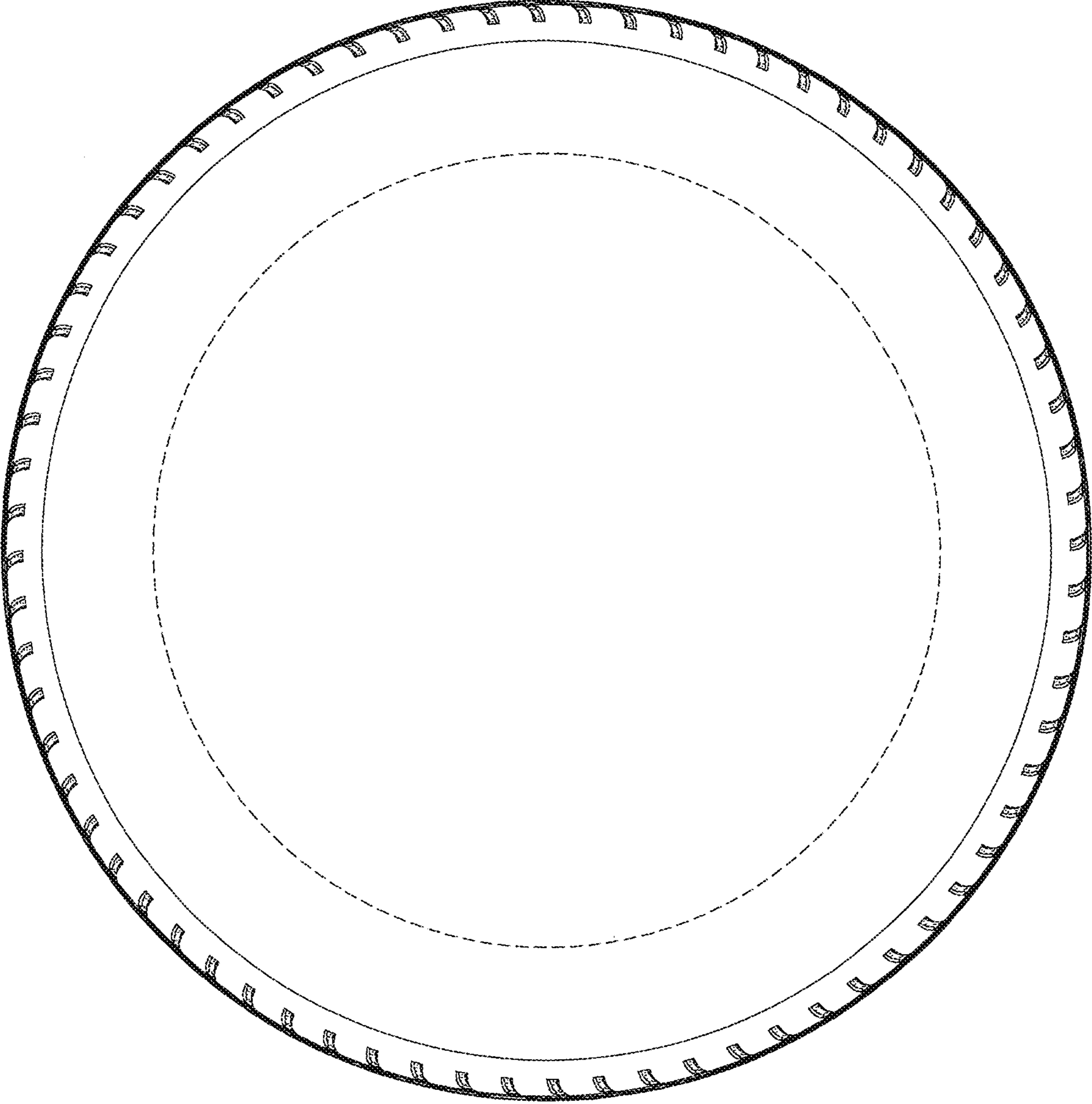

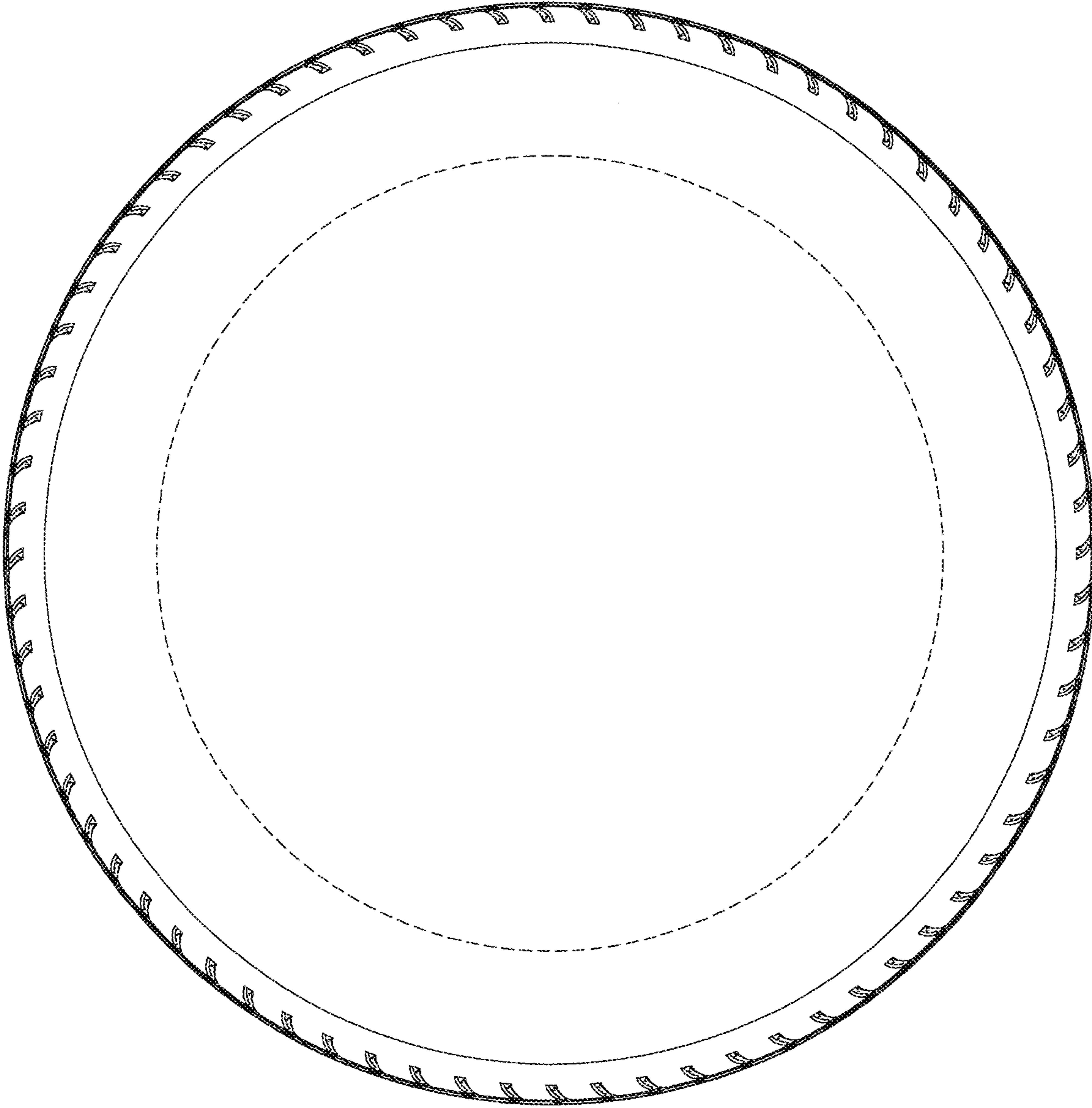

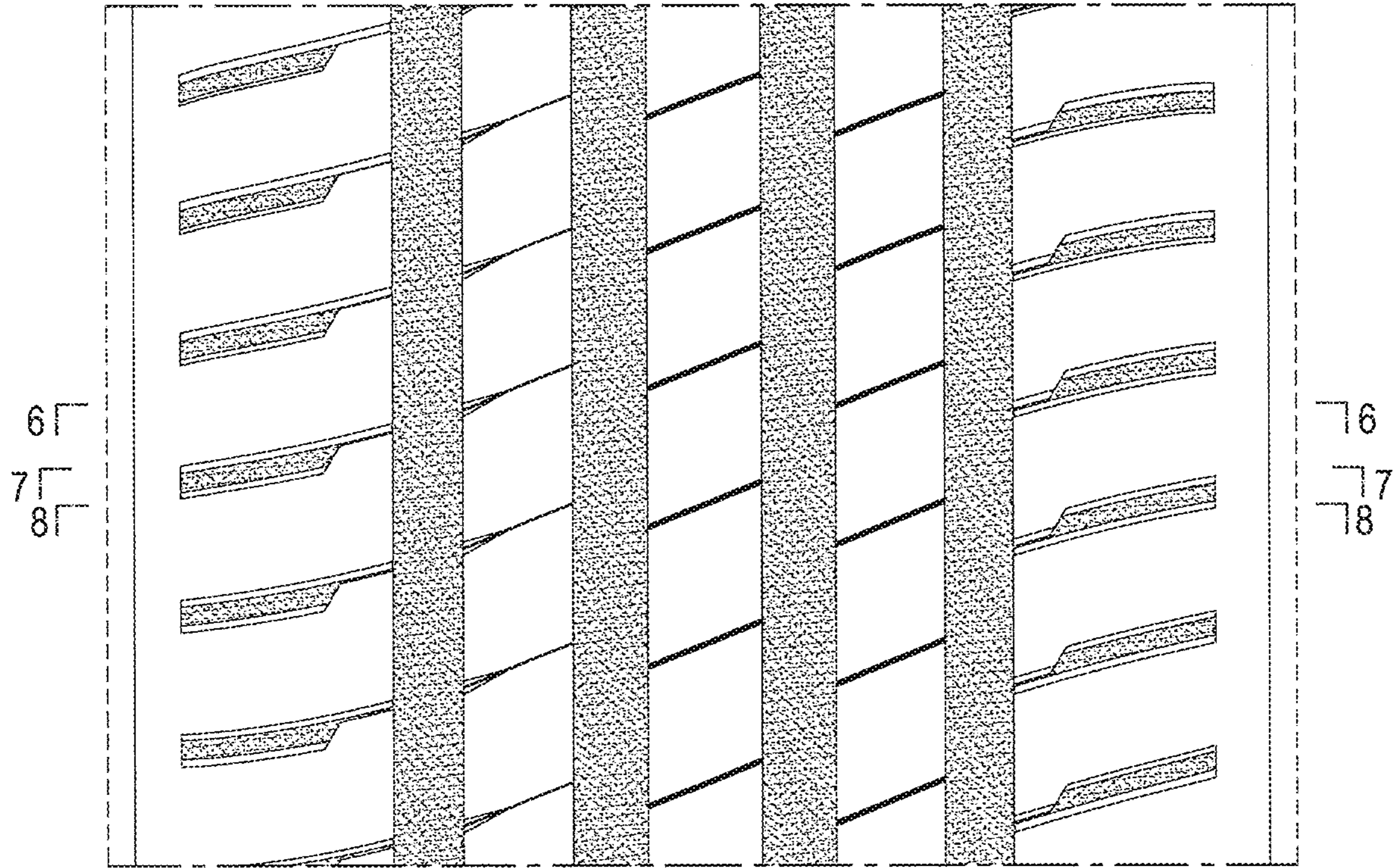

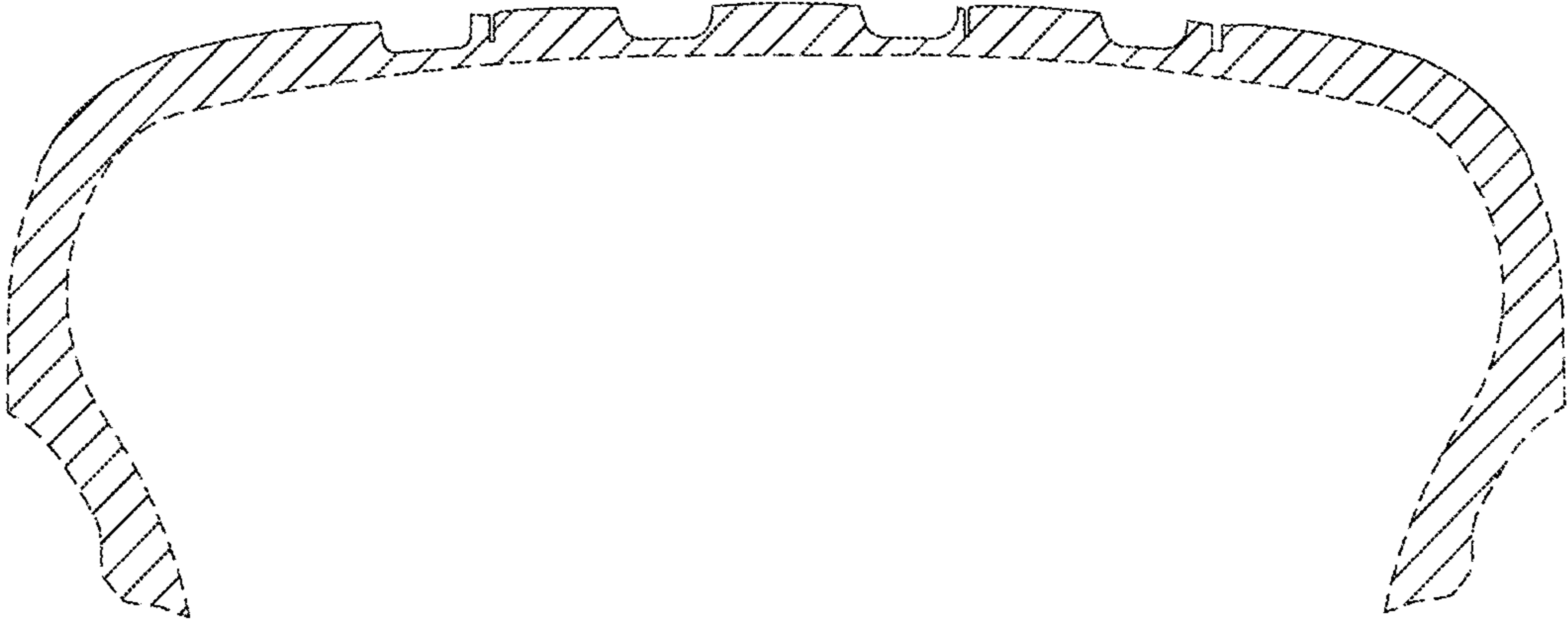

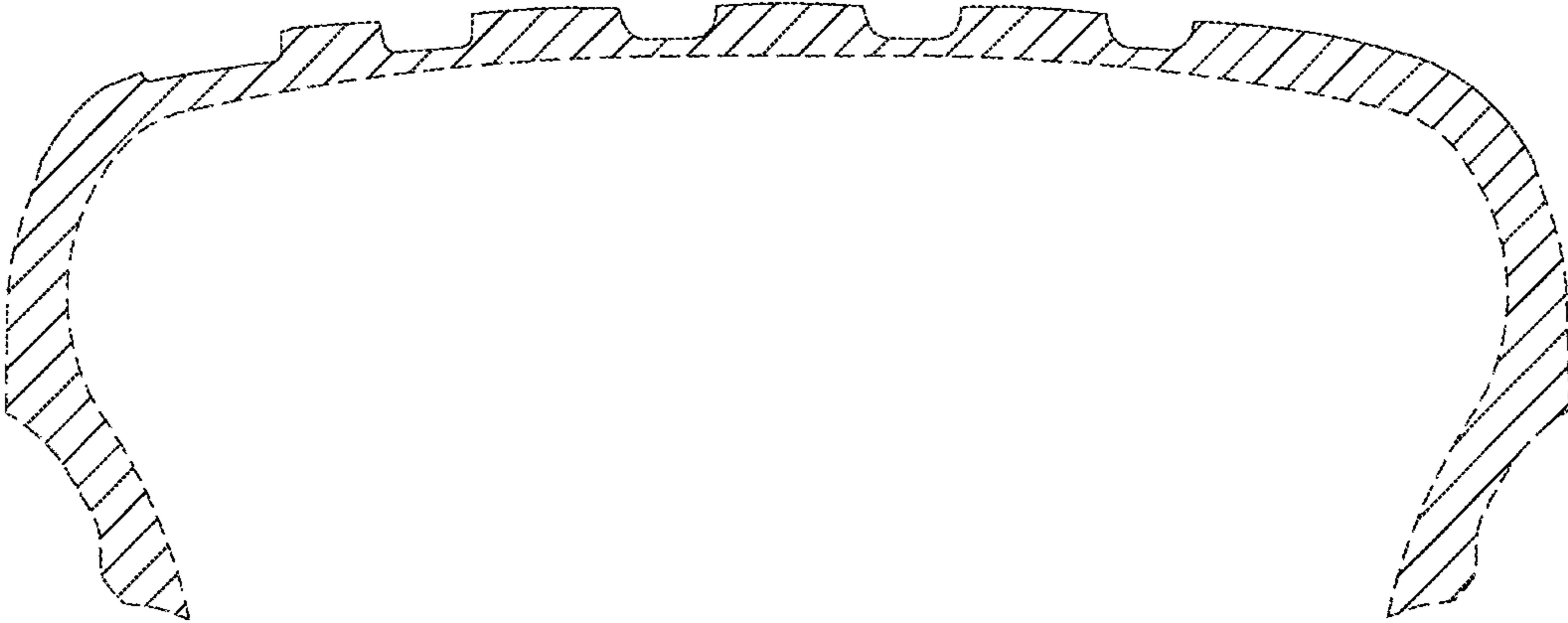

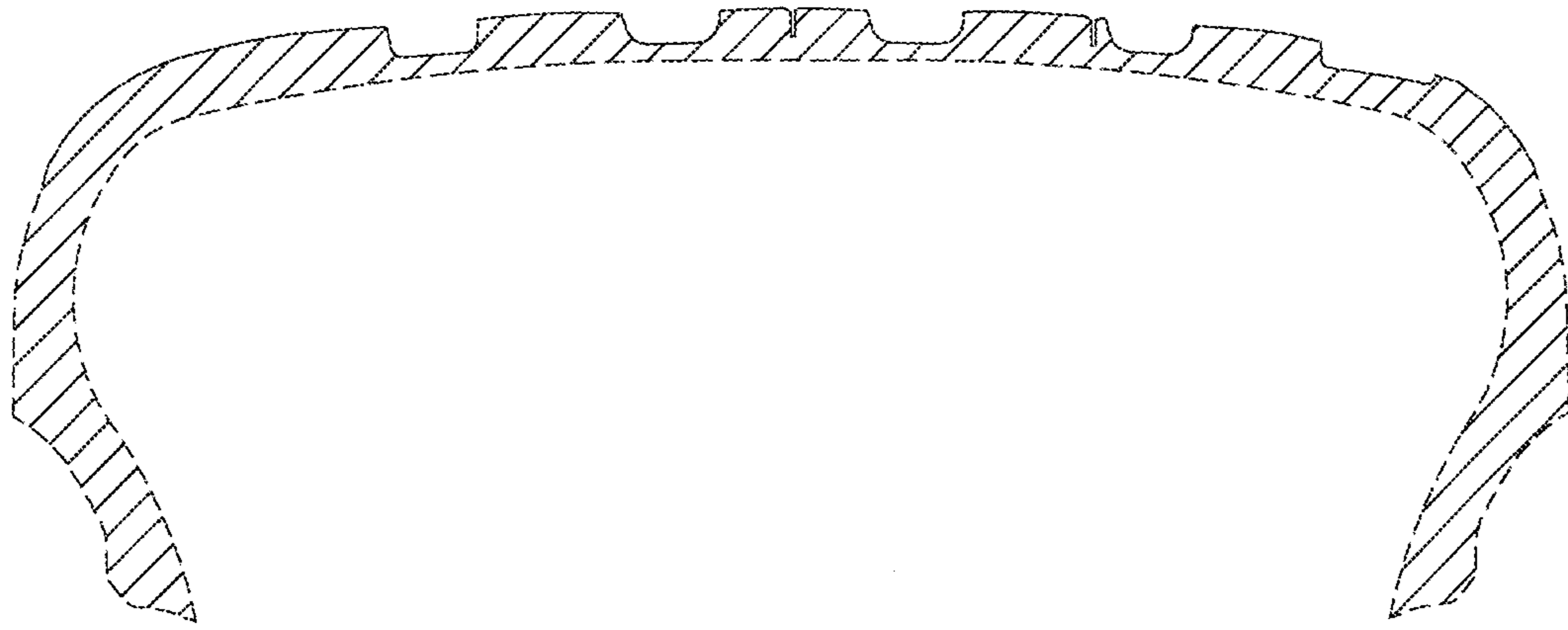
