DESCRIPTION

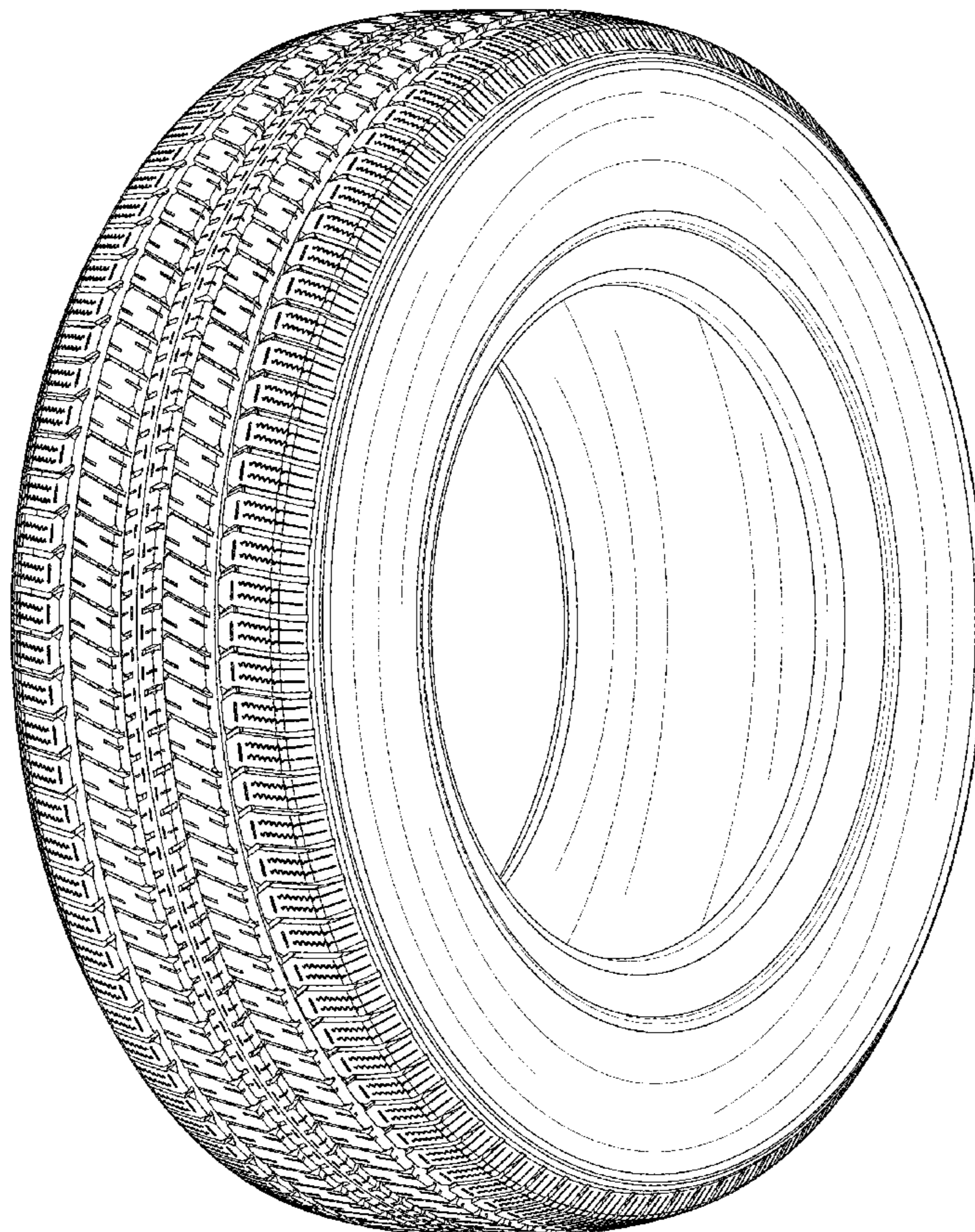
FIG. 1 is a sectional view of a tire according to the claimed design;

The broken lines shown in FIG. 4, bordering the enlarged partial view of the tire form no part of the claimed design.

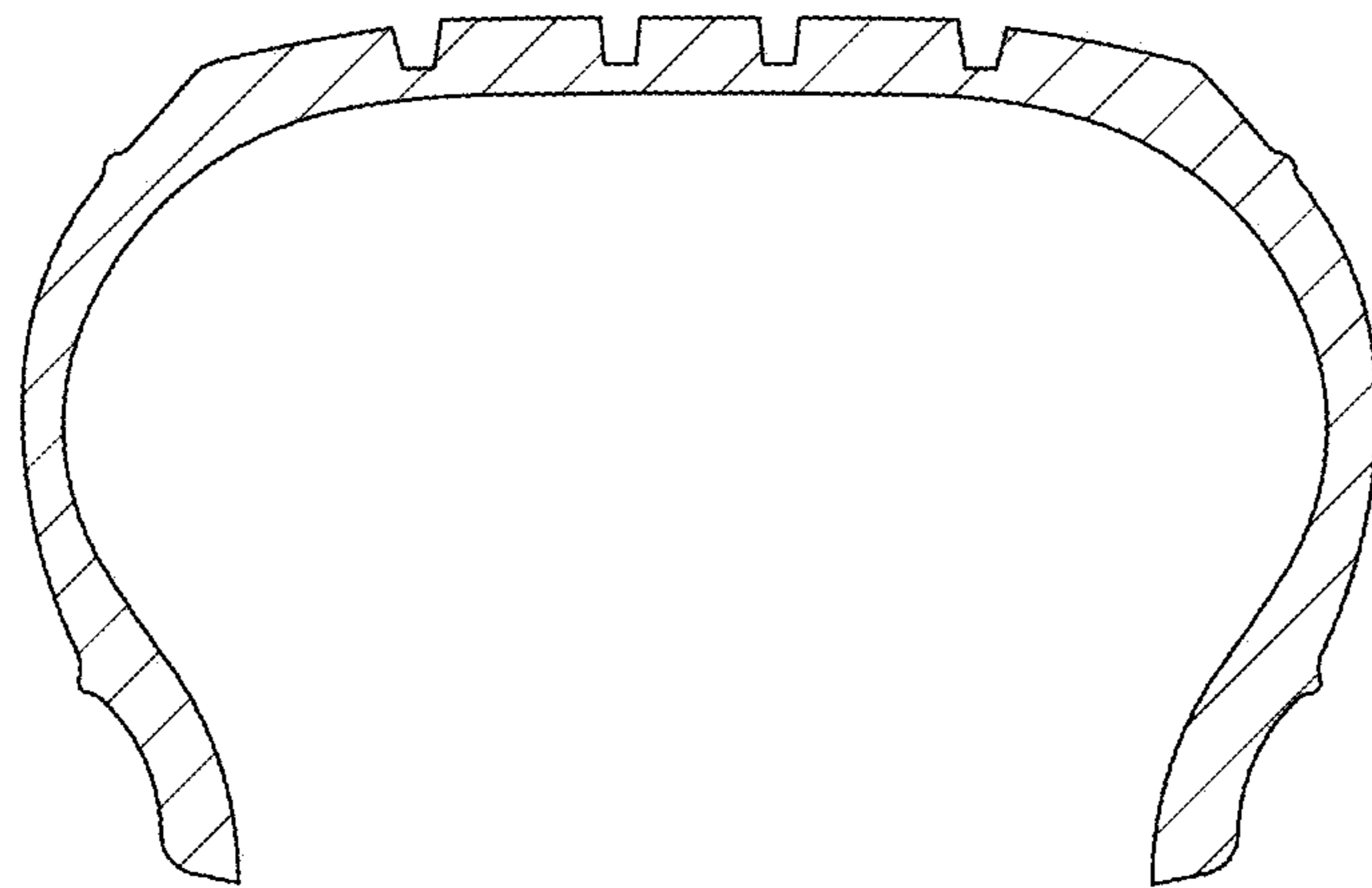

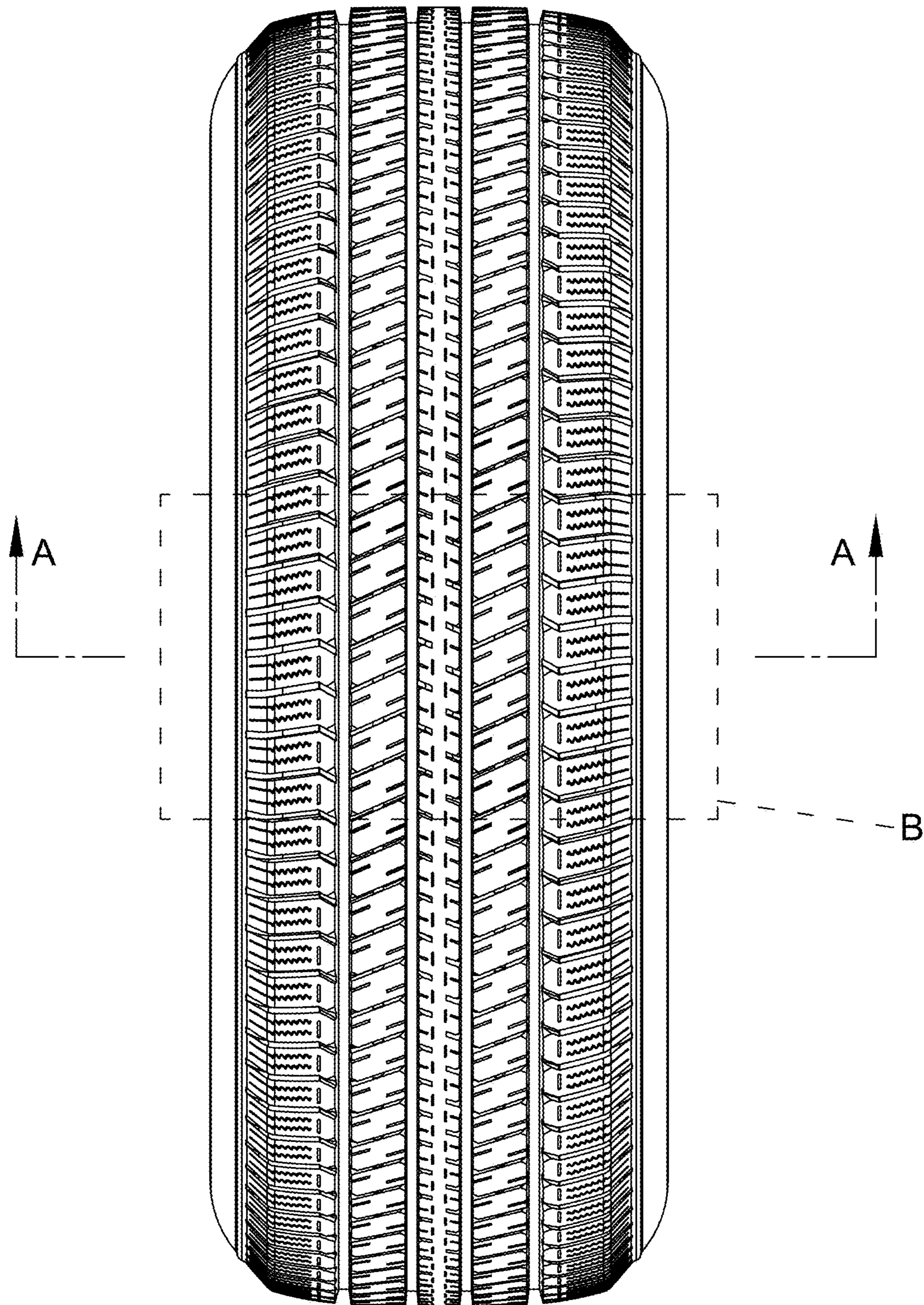

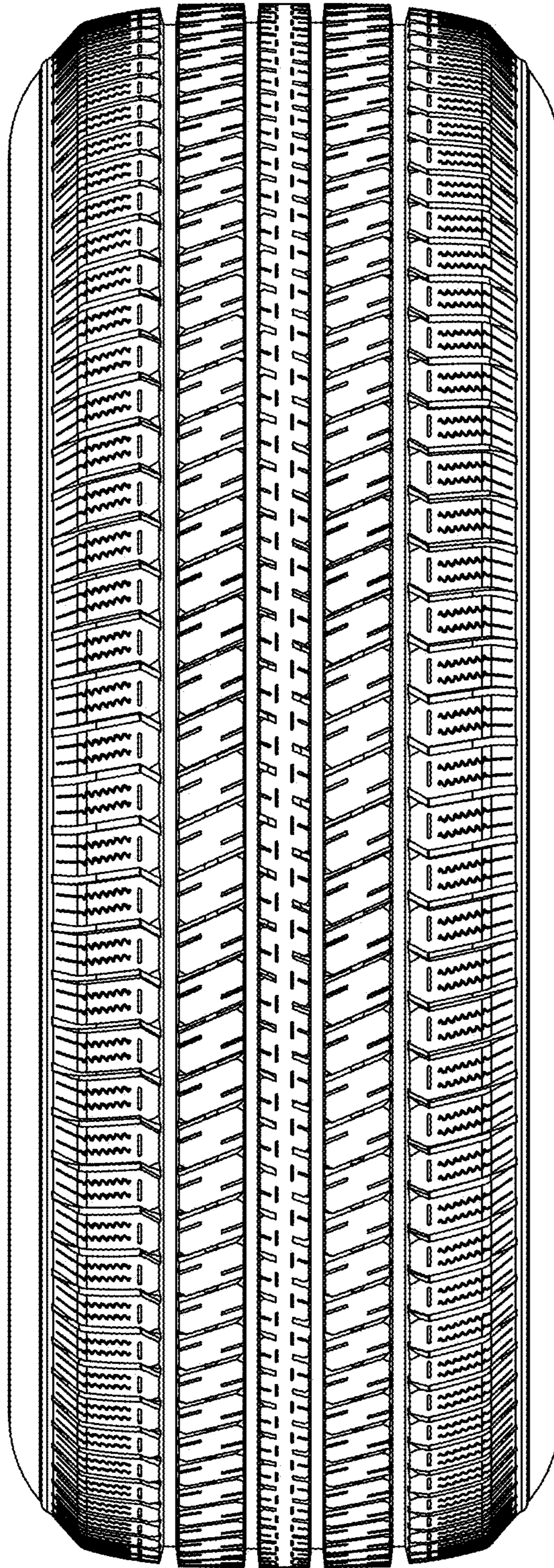

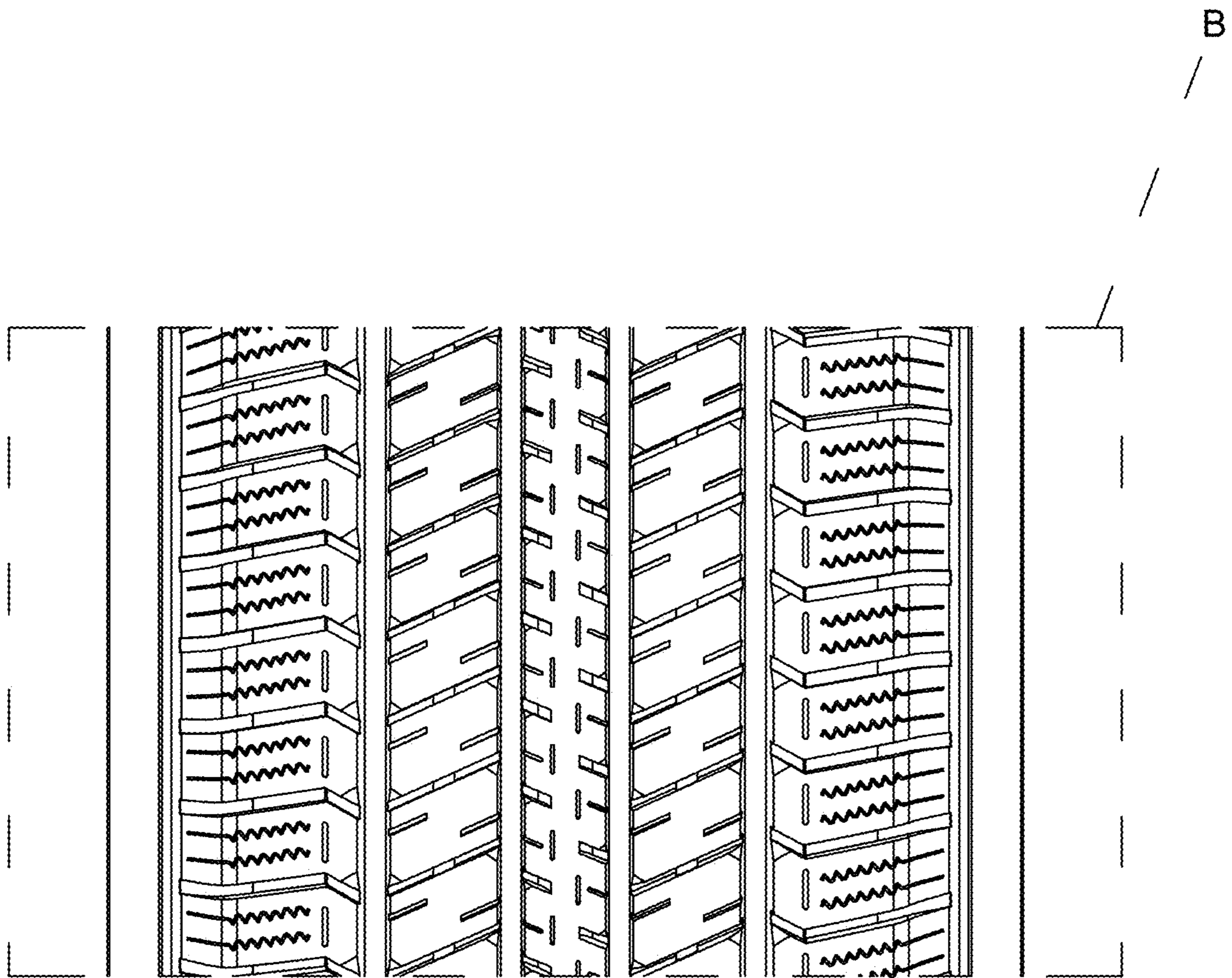

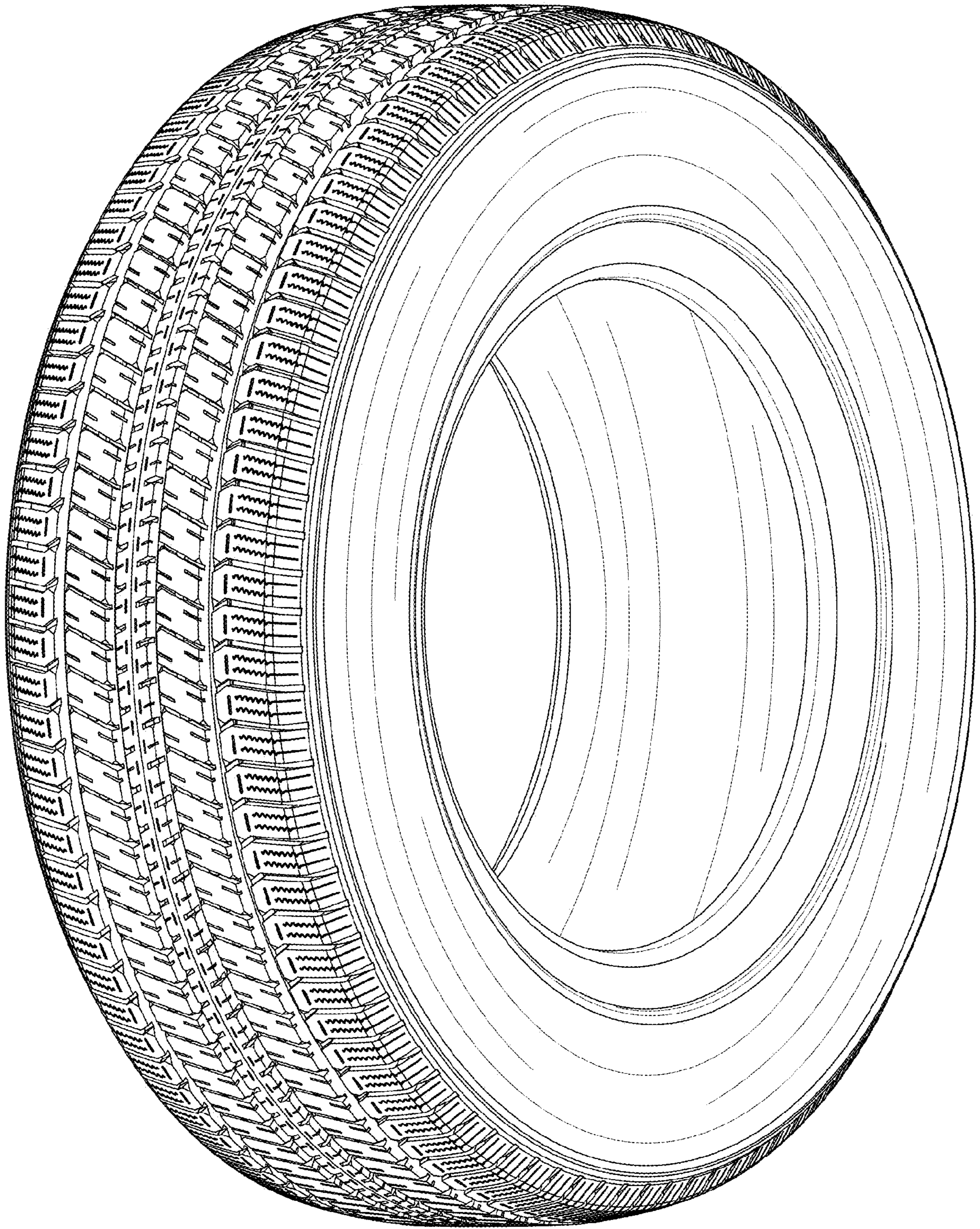

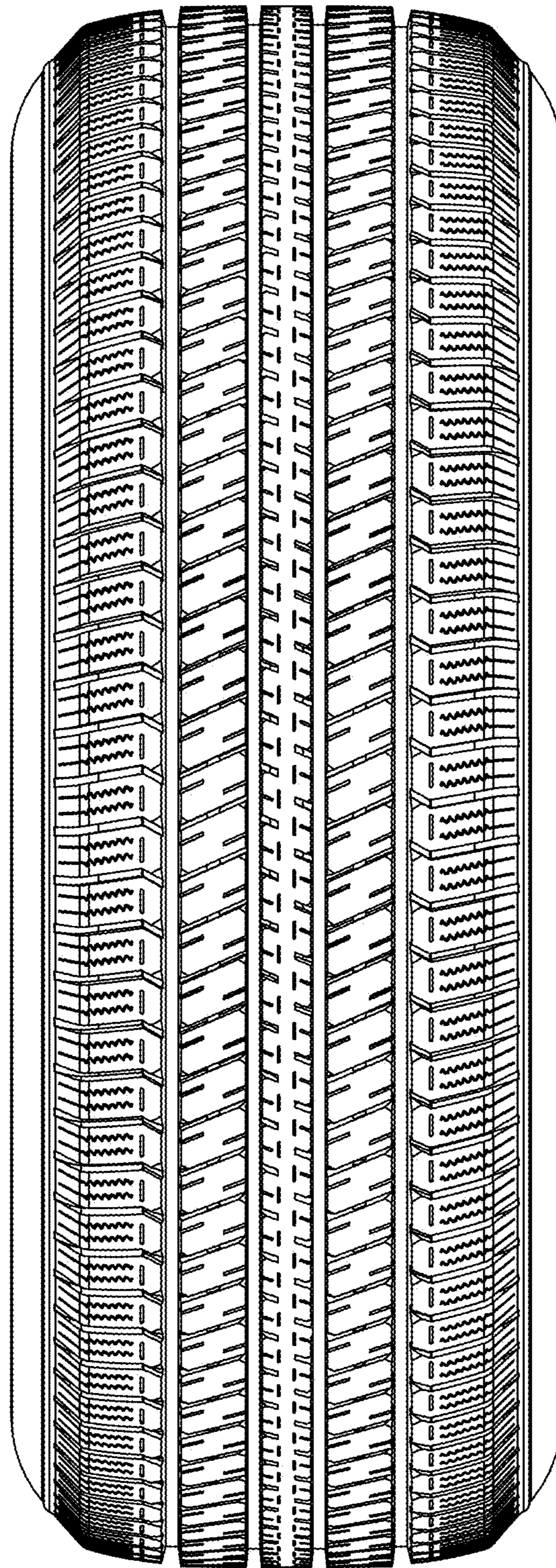

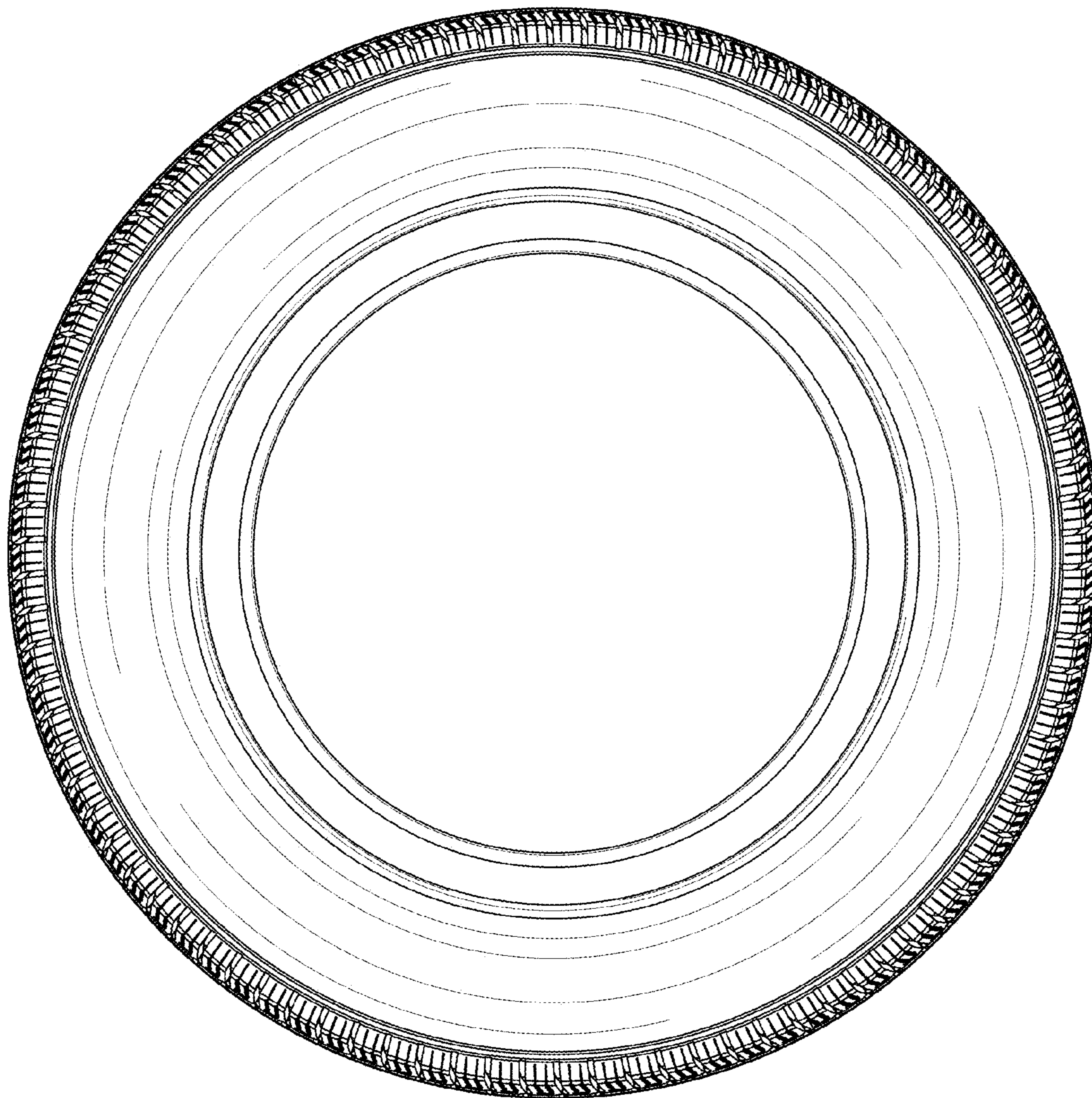
