(57) **CLAIM**

I claim the ornamental design for a digital audio player, as shown and described.

DESCRIPTION

FIG. 1 is a front, right and top perspective view of a digital audio player;
FIG. 2 is a front, right and bottom perspective view thereof;
FIG. 3 is a rear, left and bottom perspective view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a rear view thereof;
FIG. 6 is a left-side view thereof;
FIG. 7 is a right-side view thereof;
FIG. 8 is a top view thereof; and,
FIG. 9 is a bottom elevation view thereof.
The material of the design is metal (aluminum, etc.), glass or synthetic resin.

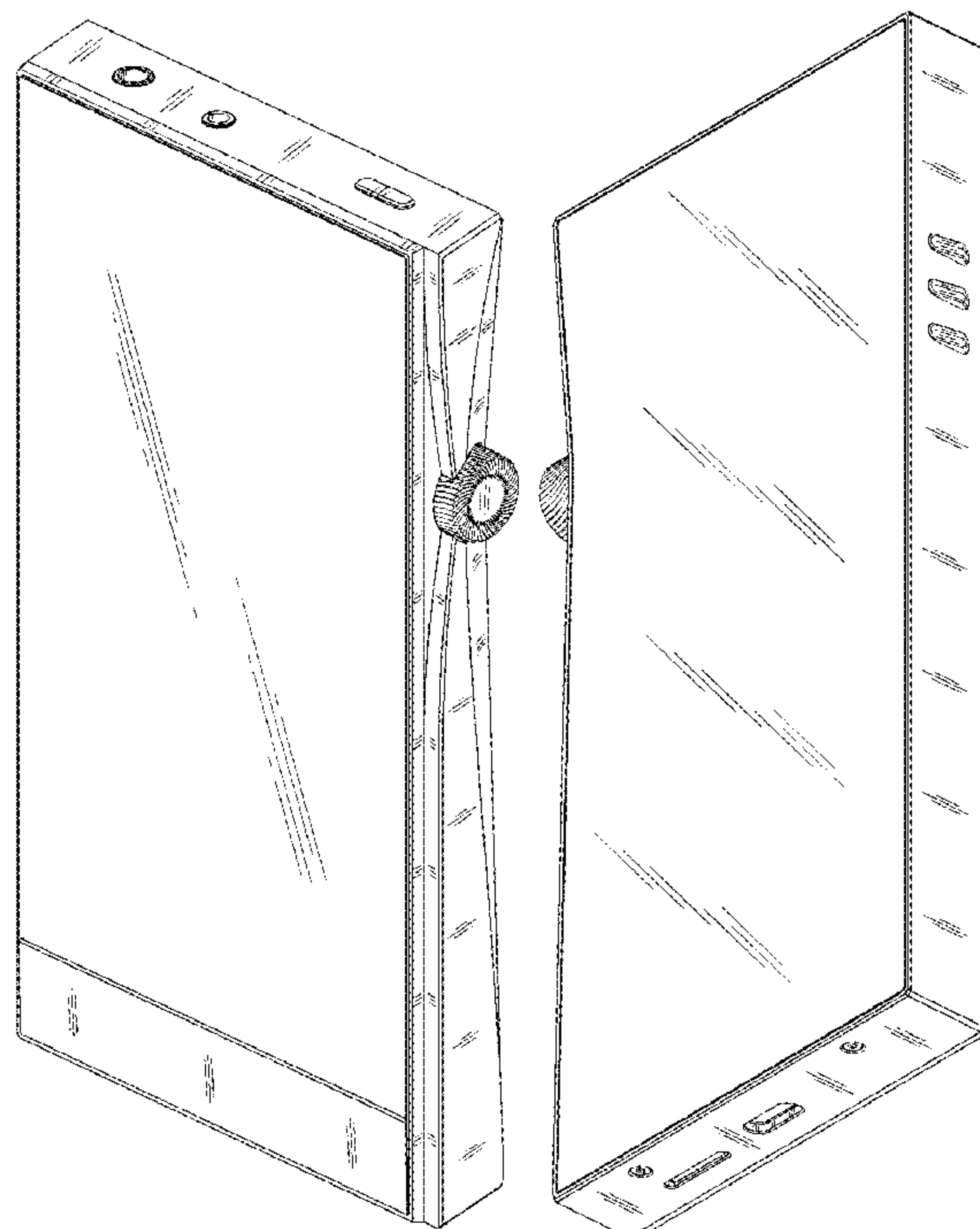

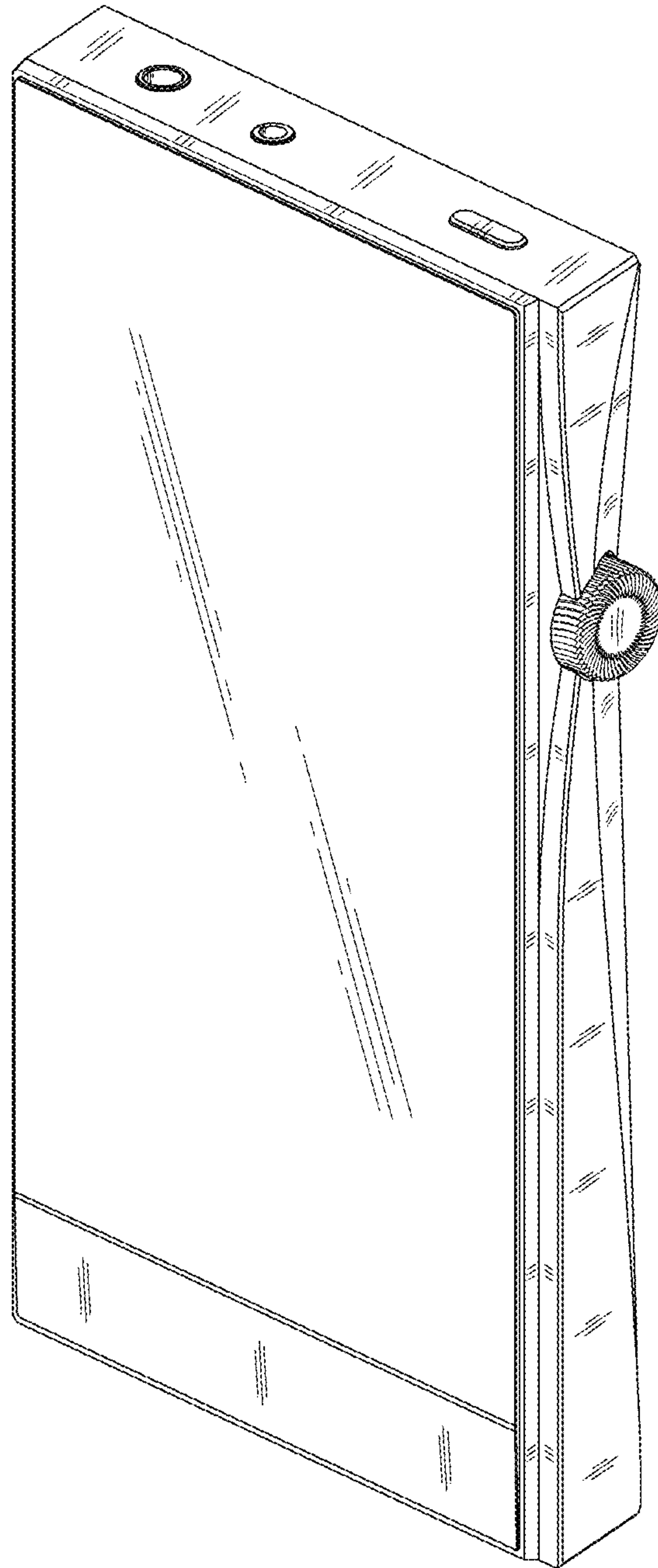

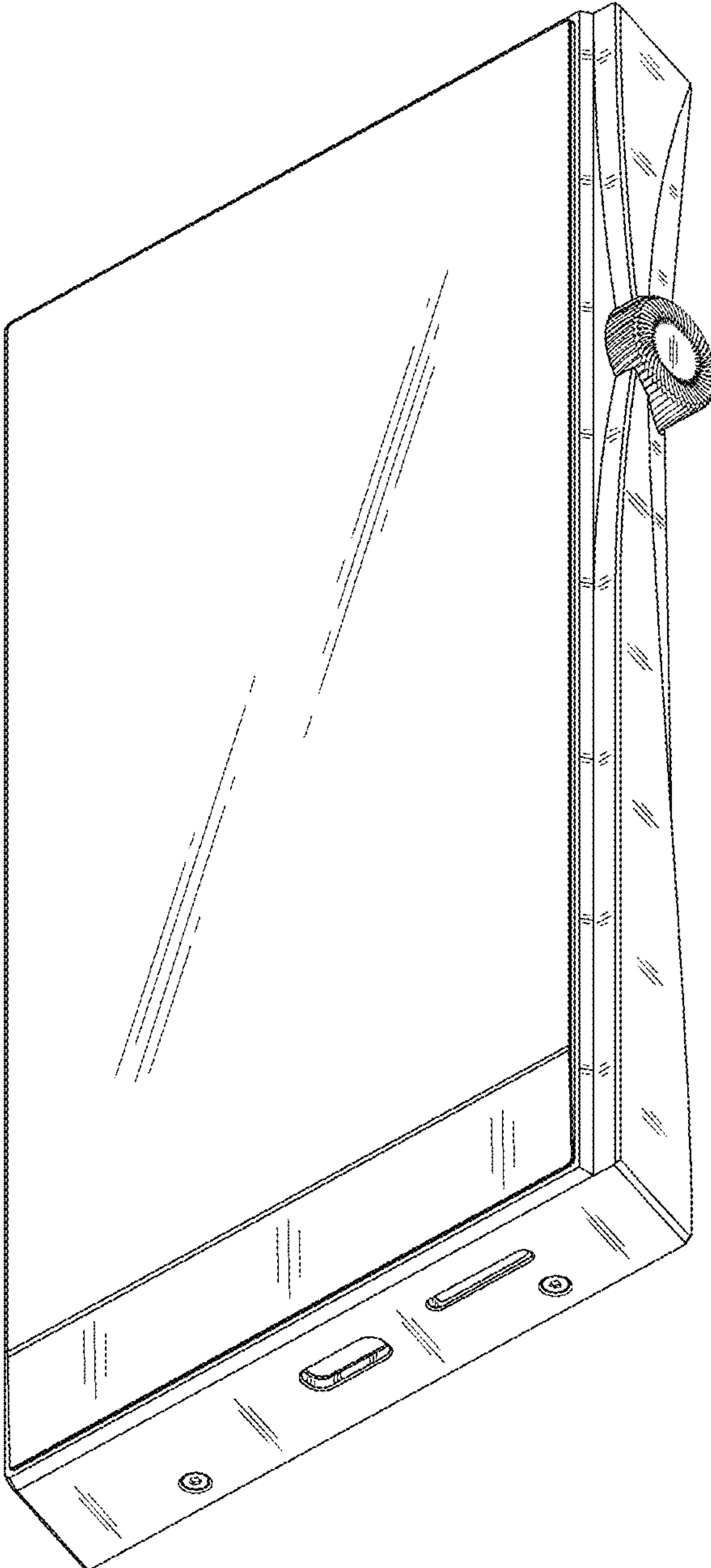

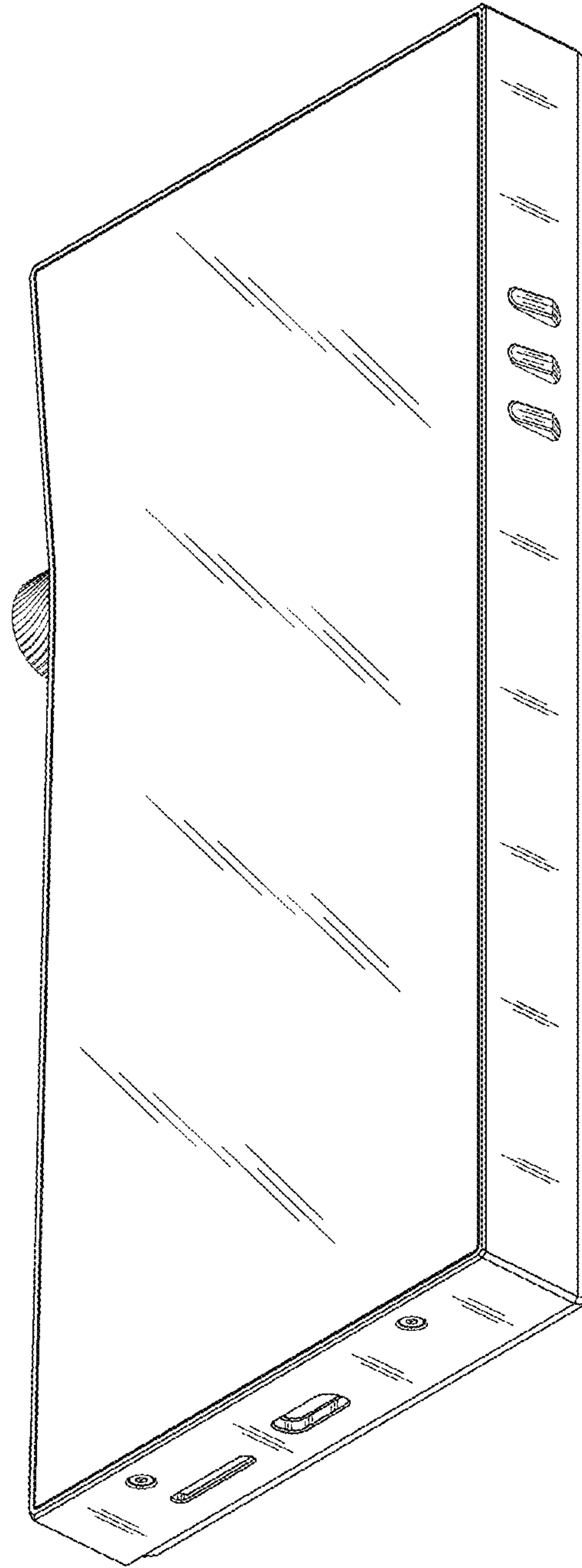

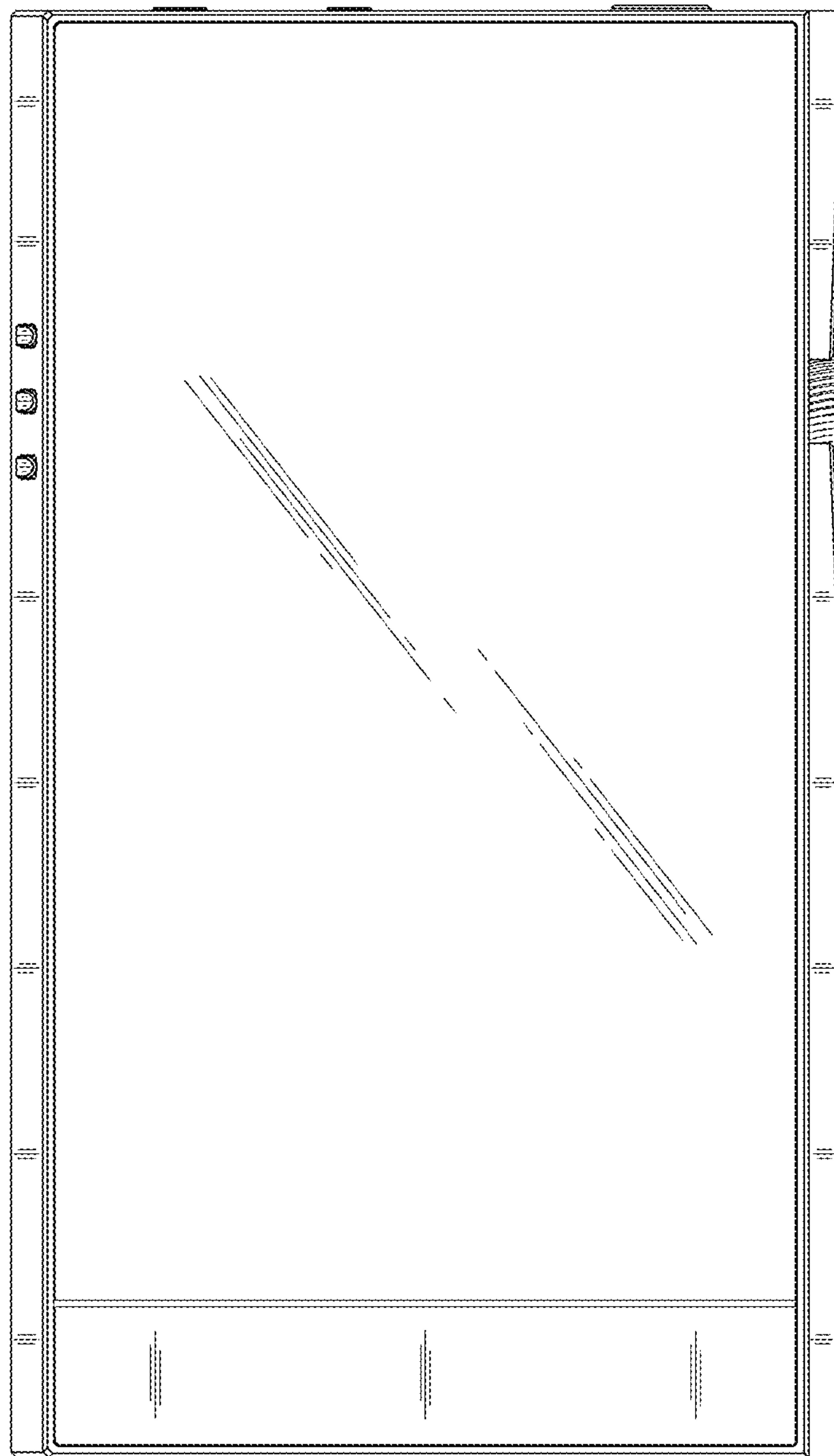

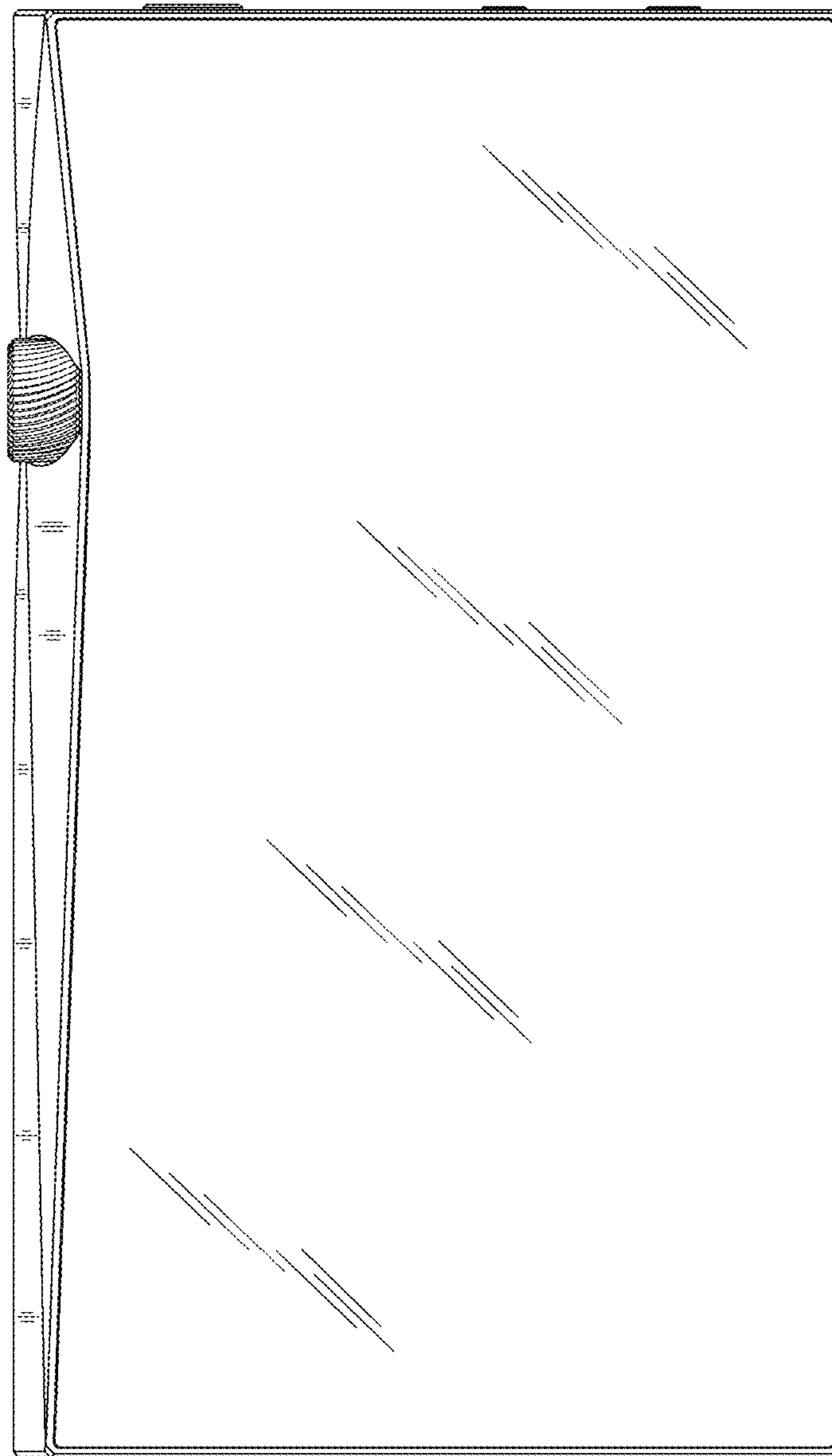

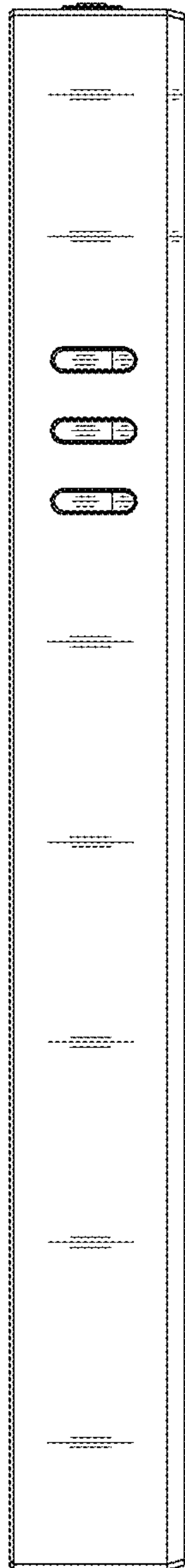

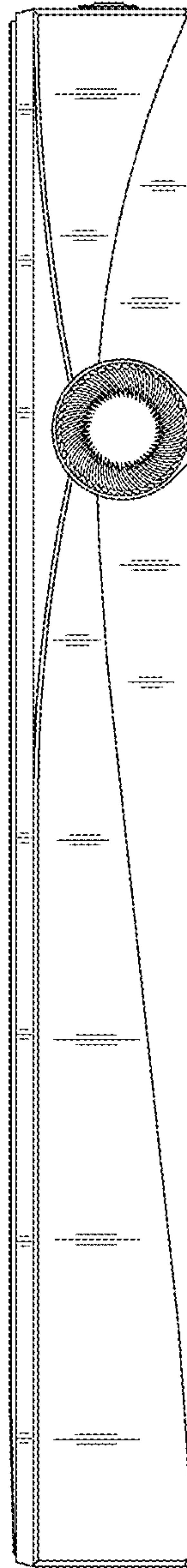

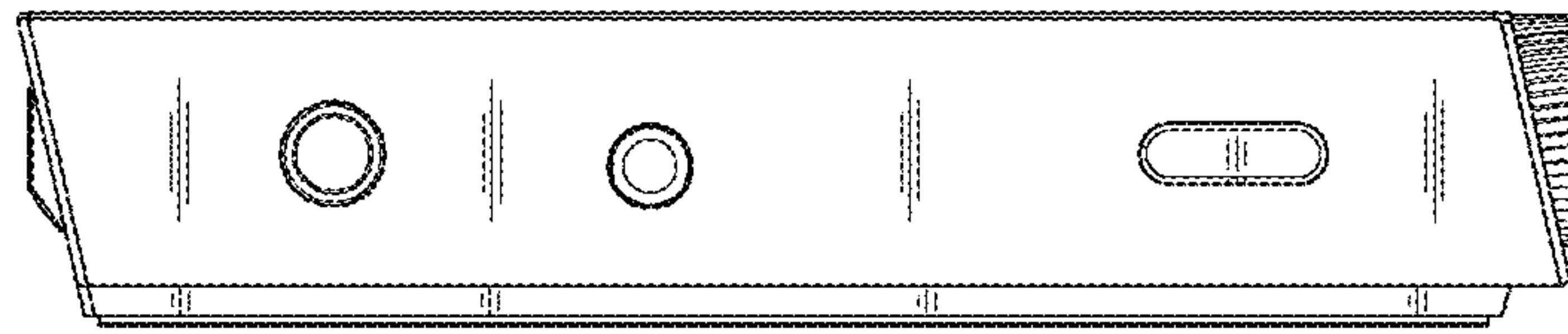
