(57) **CLAIM**

The ornamental design for a display screen or portion thereof with transitional graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first image of a display screen or portion thereof with transitional graphical user interface, showing our new design;

FIG. 2 is a front view of the second image thereof;

FIG. 3 is a front view of the third image thereof;

FIG. 4 is a front view of the fourth image thereof;

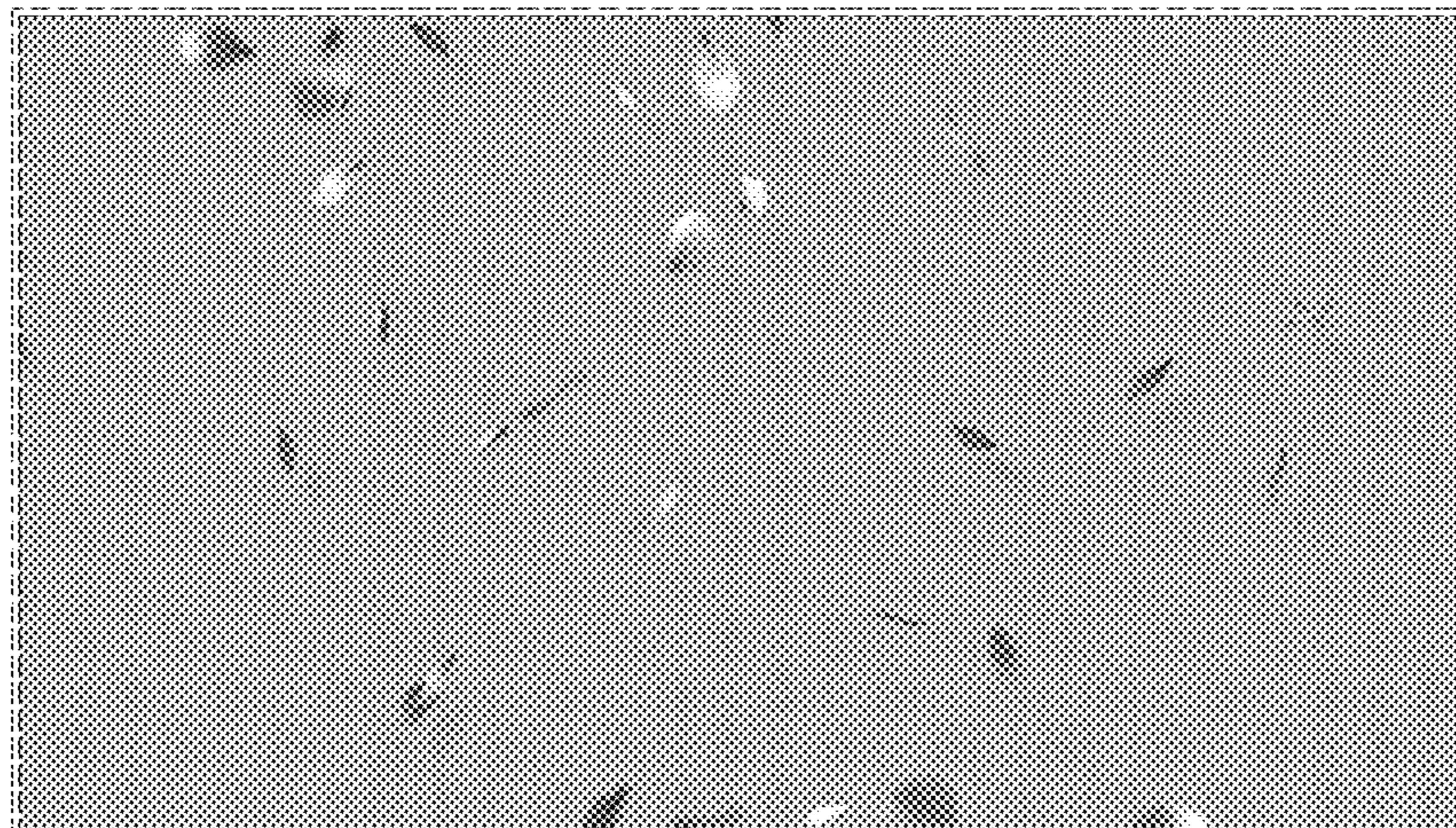
FIG. 5 is a front view of the fifth image thereof; and,

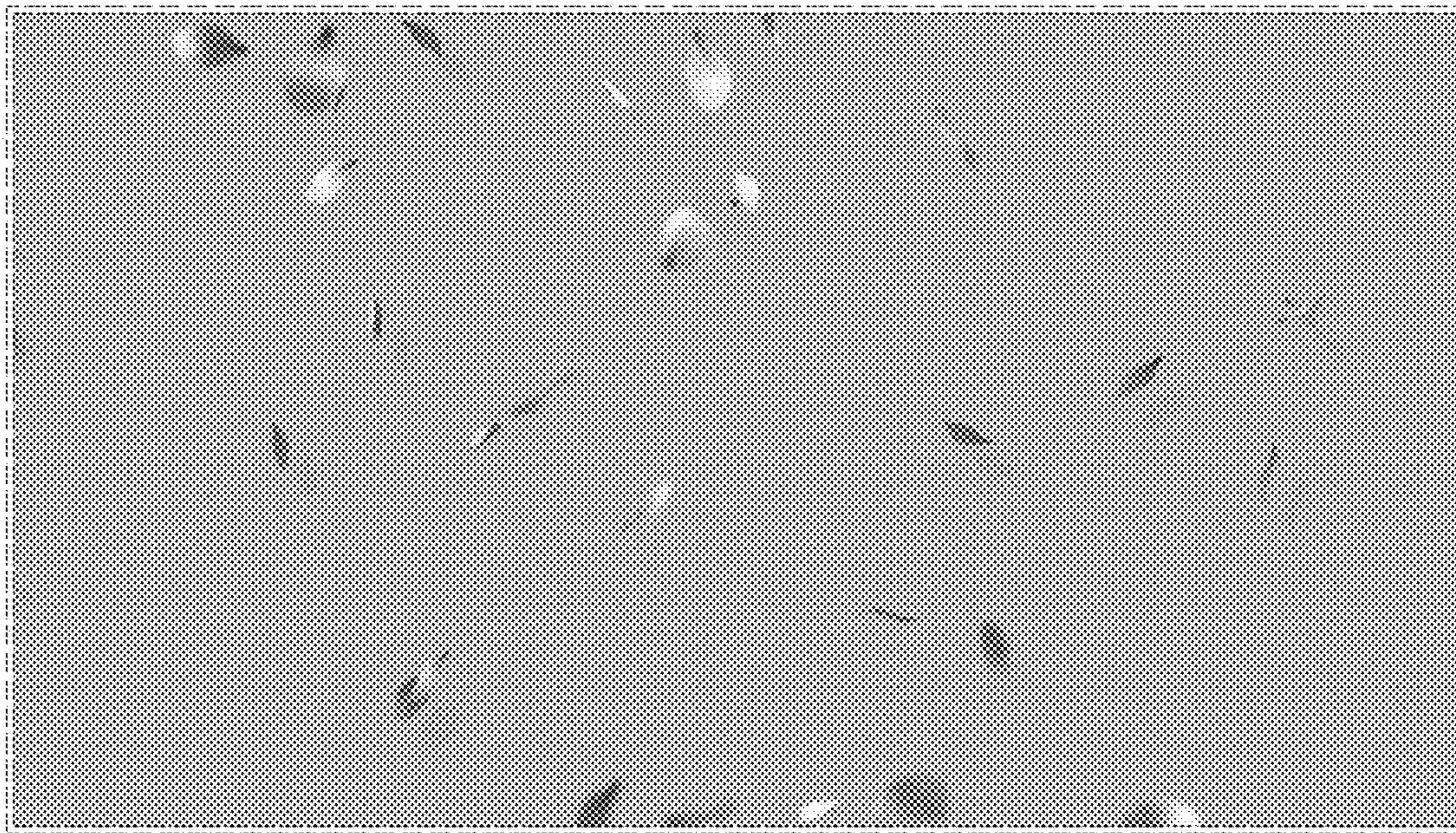

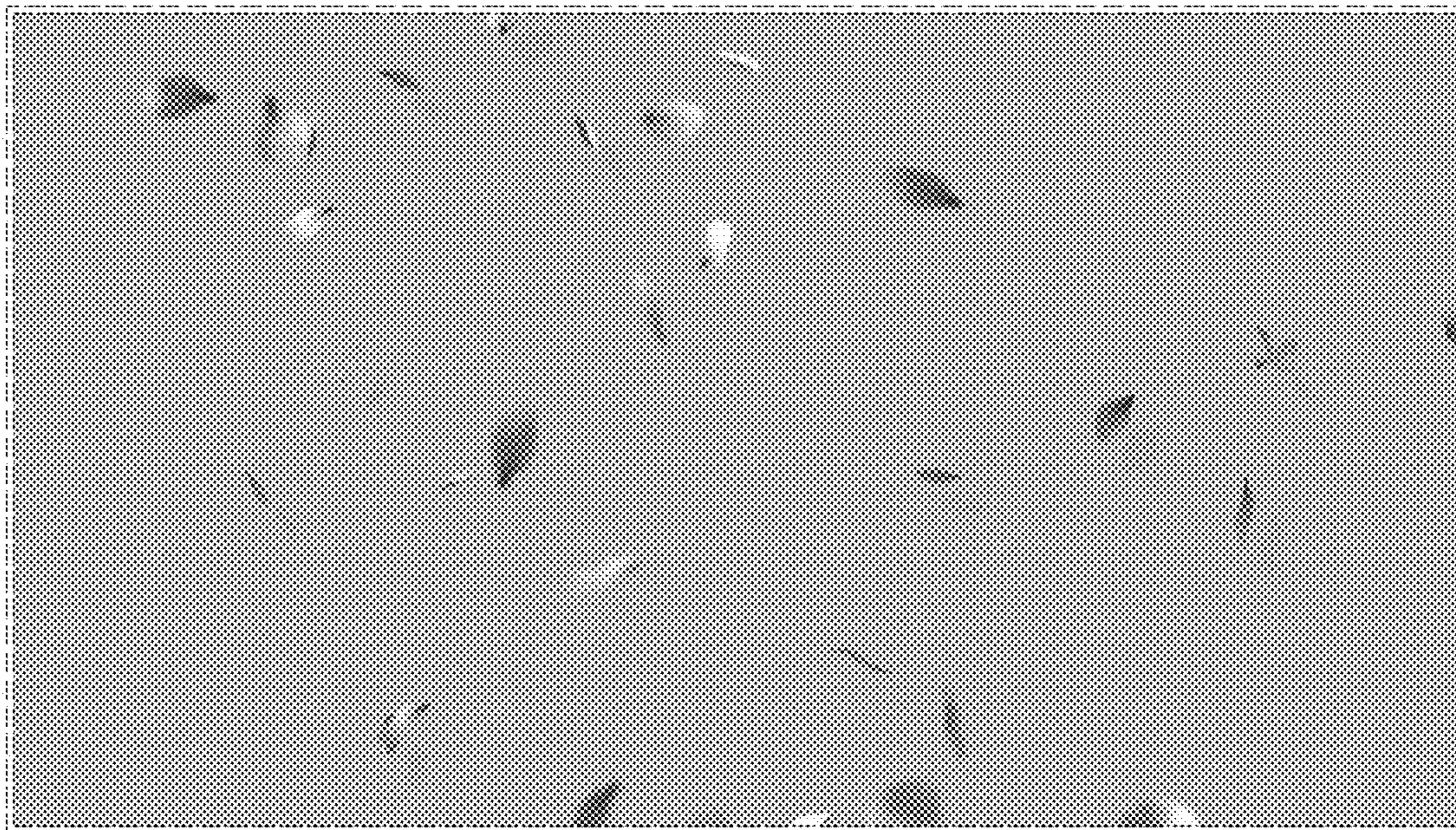

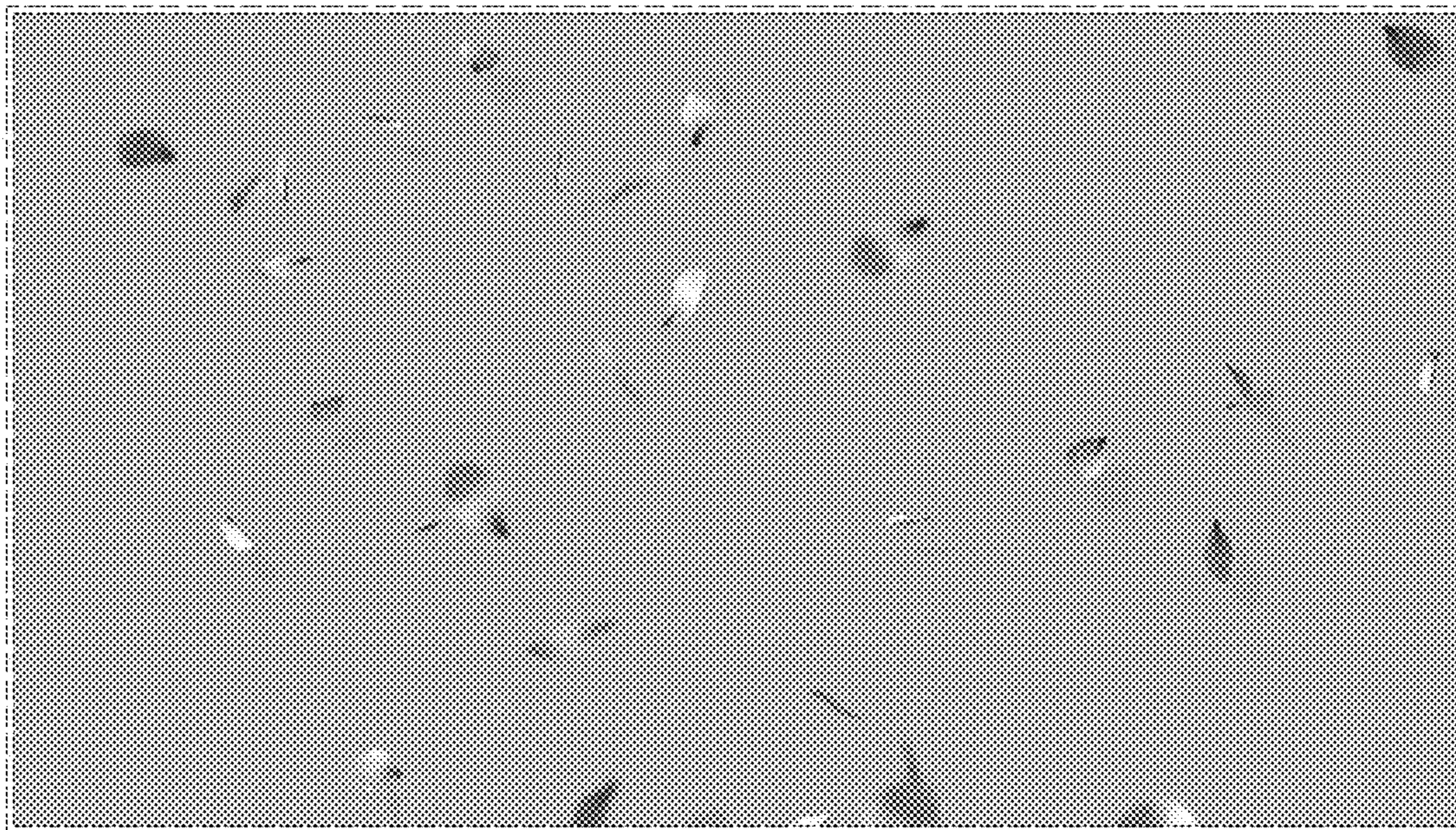

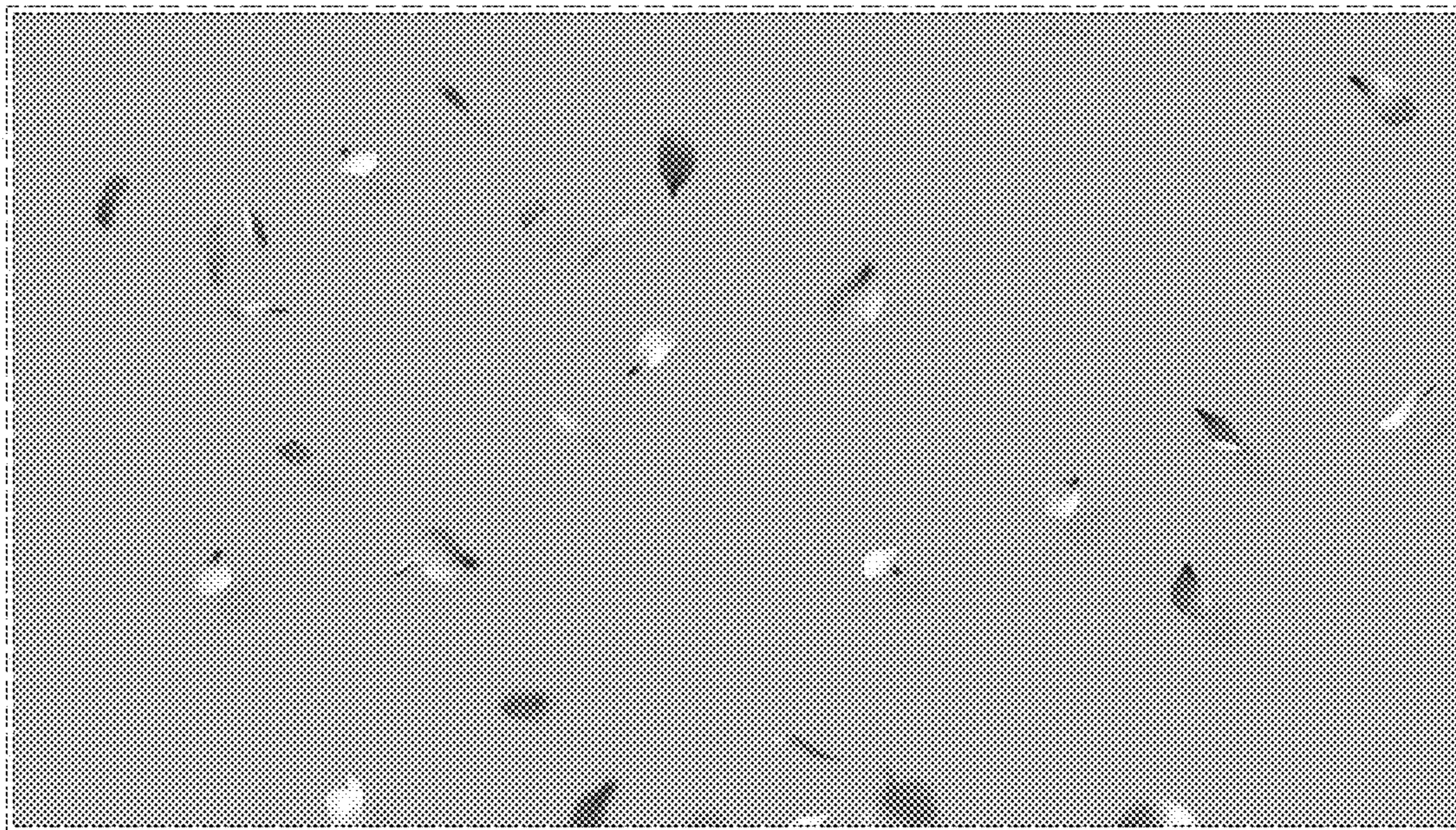

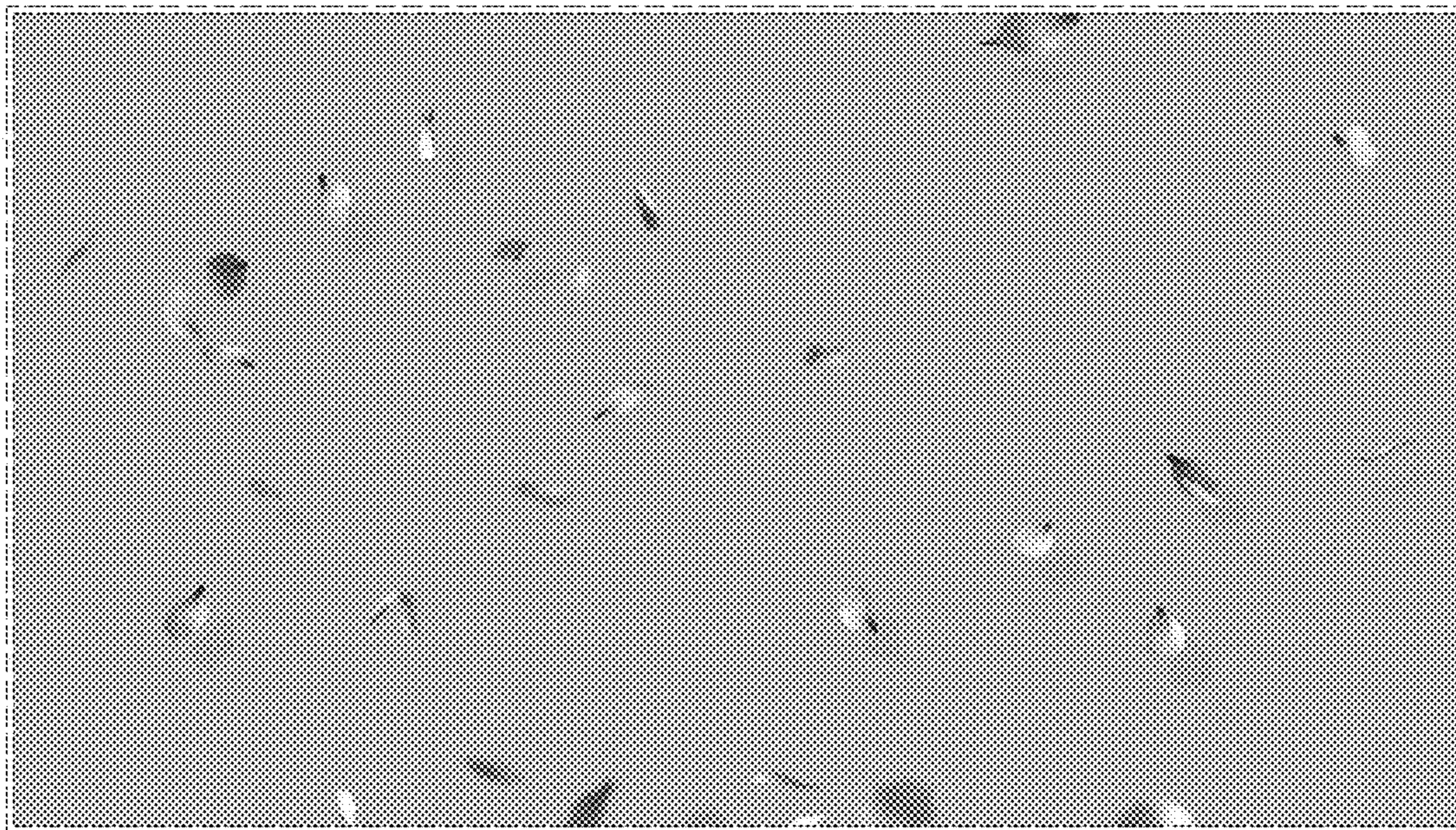
