component design of FIG. 1;

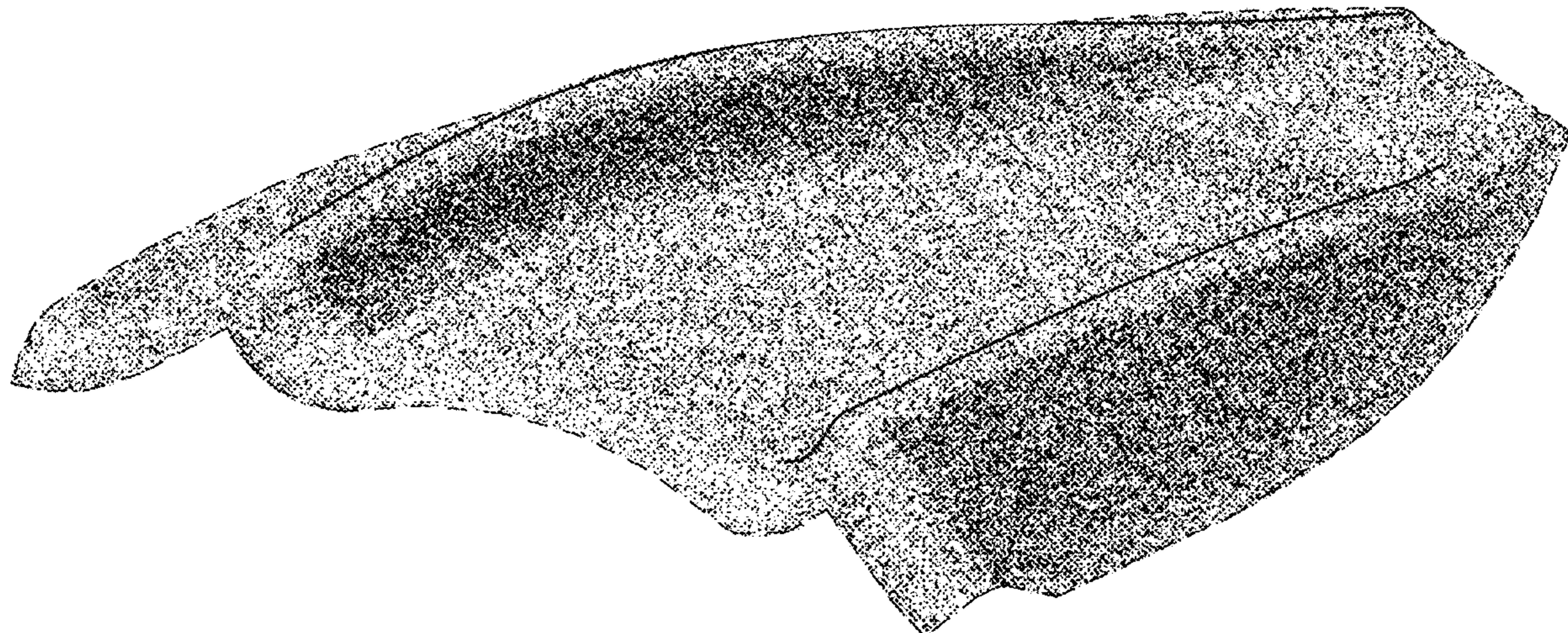
FIG. 4 is a right side view of the ornament for an engine

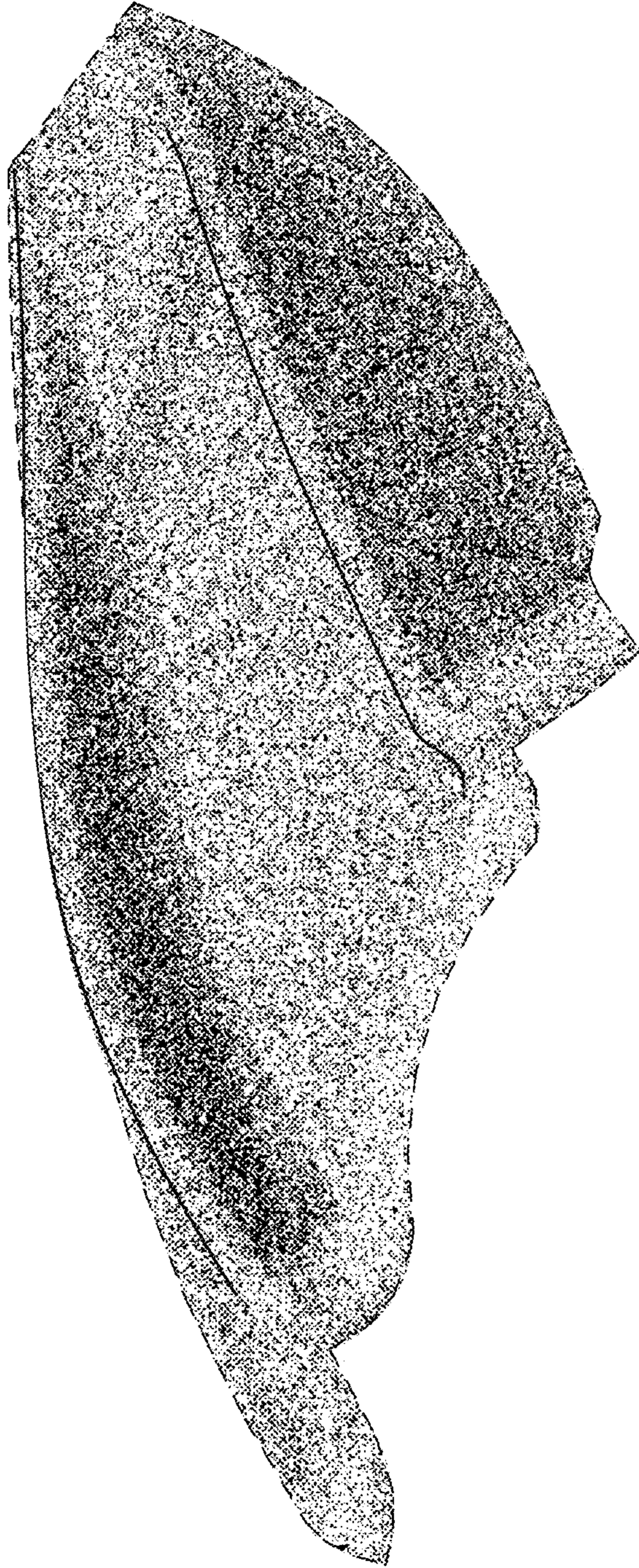

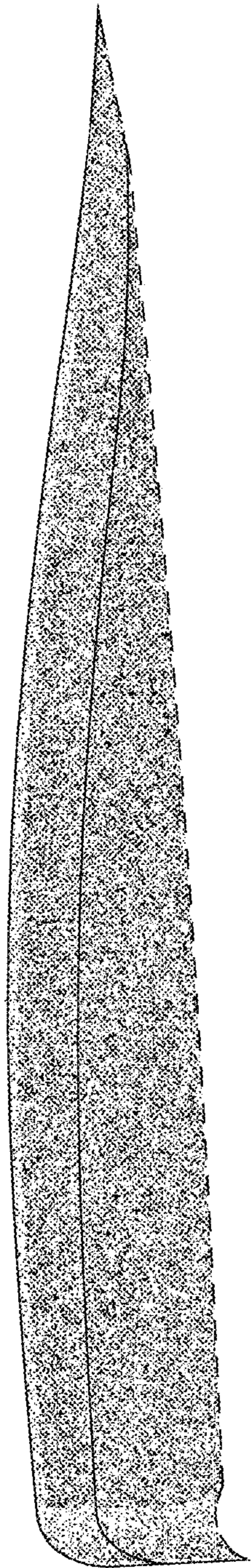

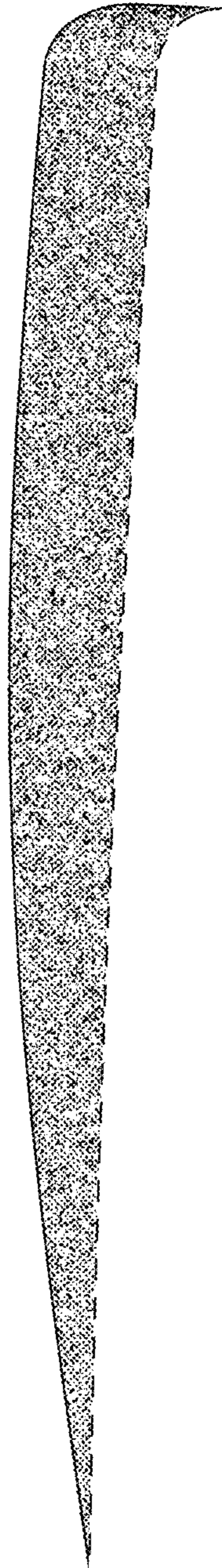

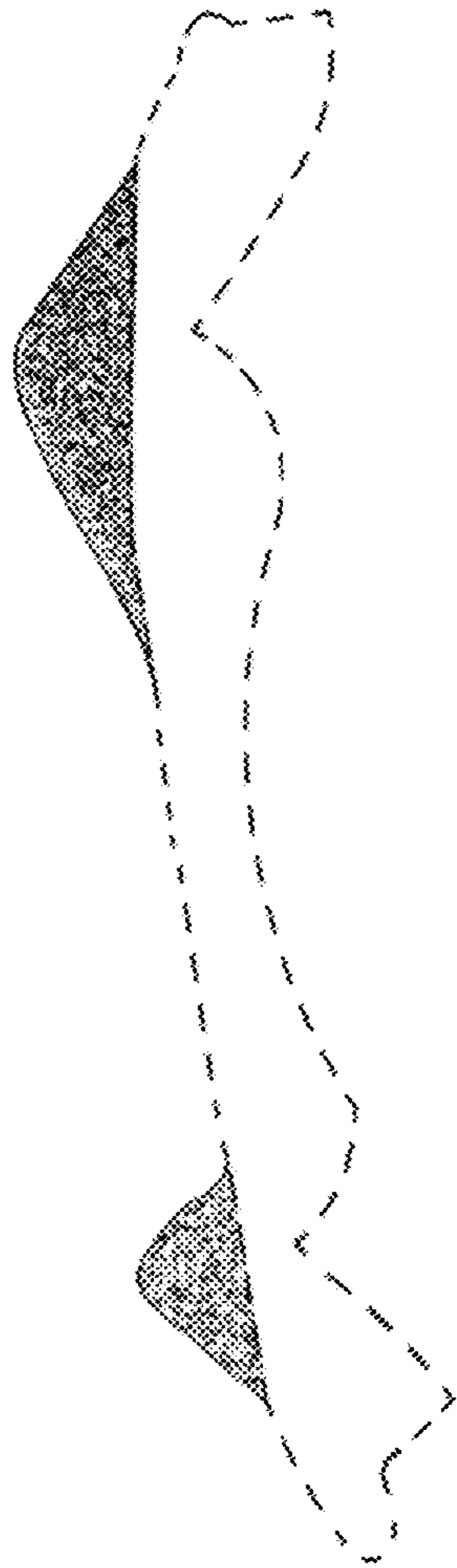

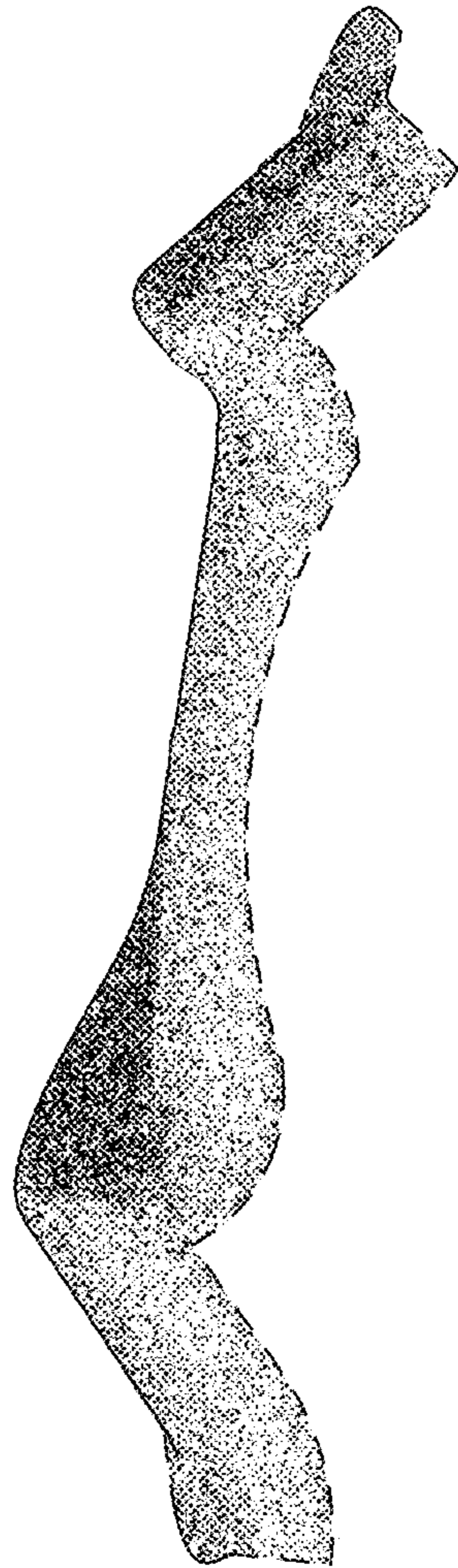

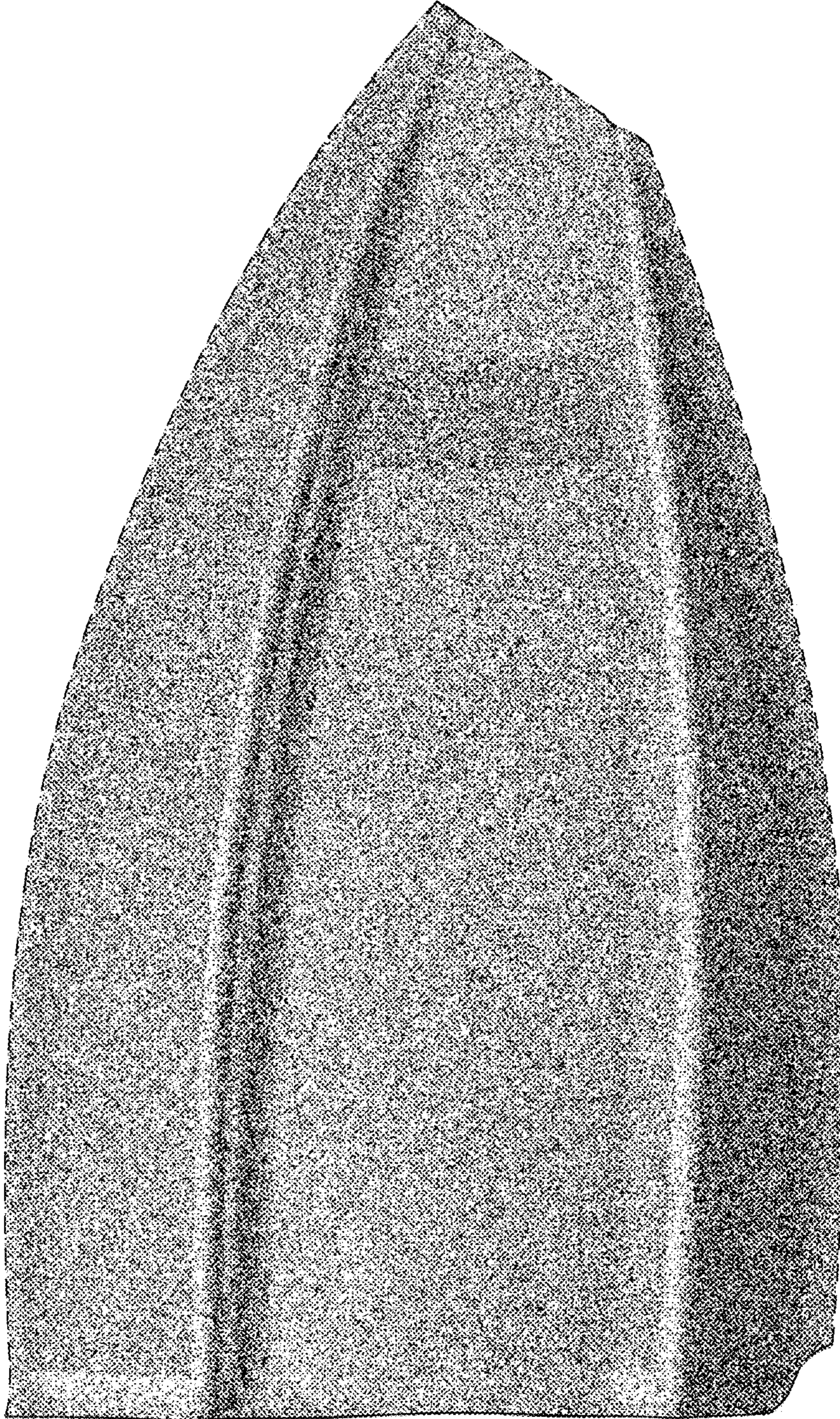
