DESCRIPTION

FIG. 1 is a front view of a three-dimensional printer showing the new design;

FIG. 4 is a view of the left side thereof, the right side being a mirror image thereof;

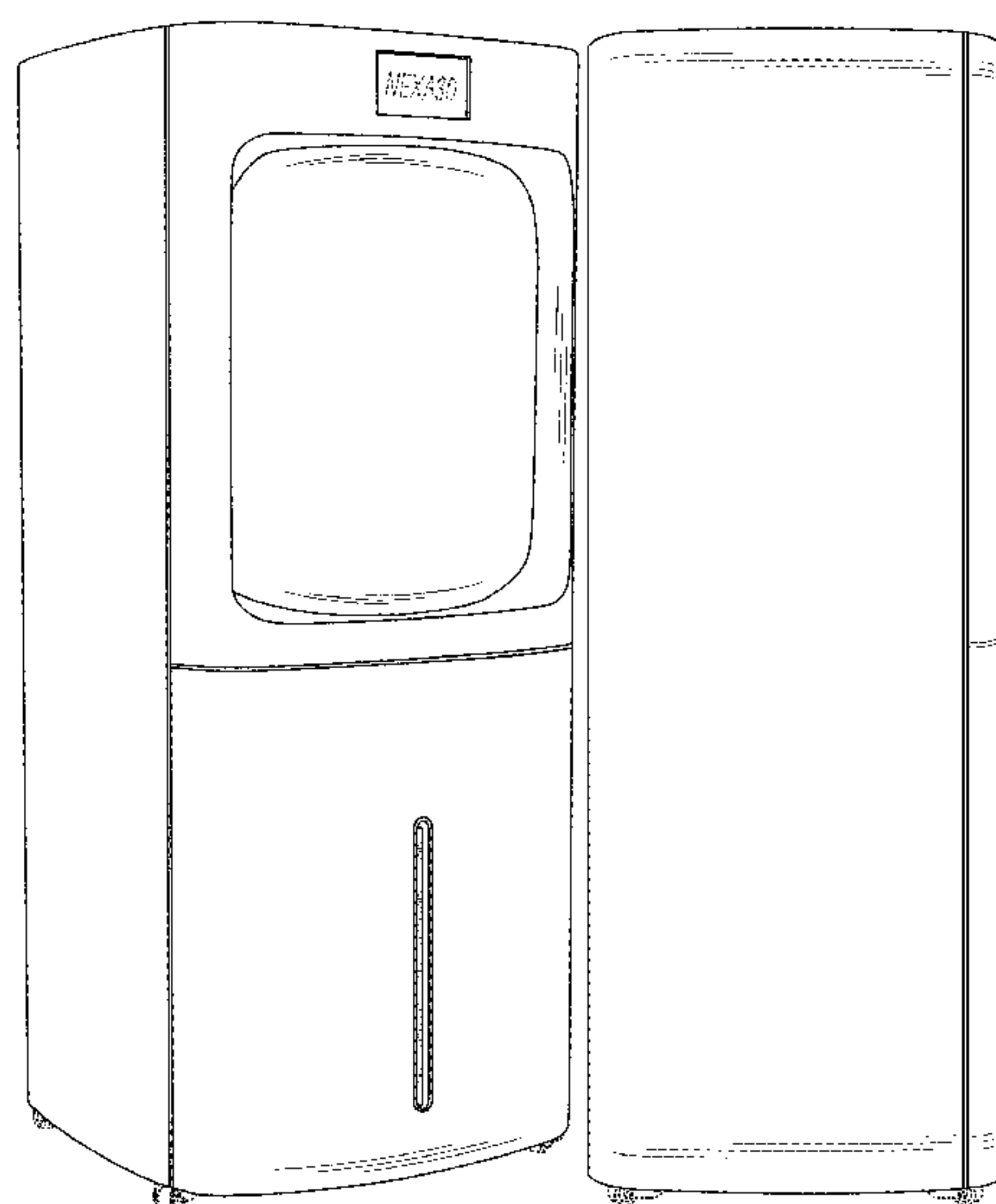
FIG. 5 is a back view thereof;

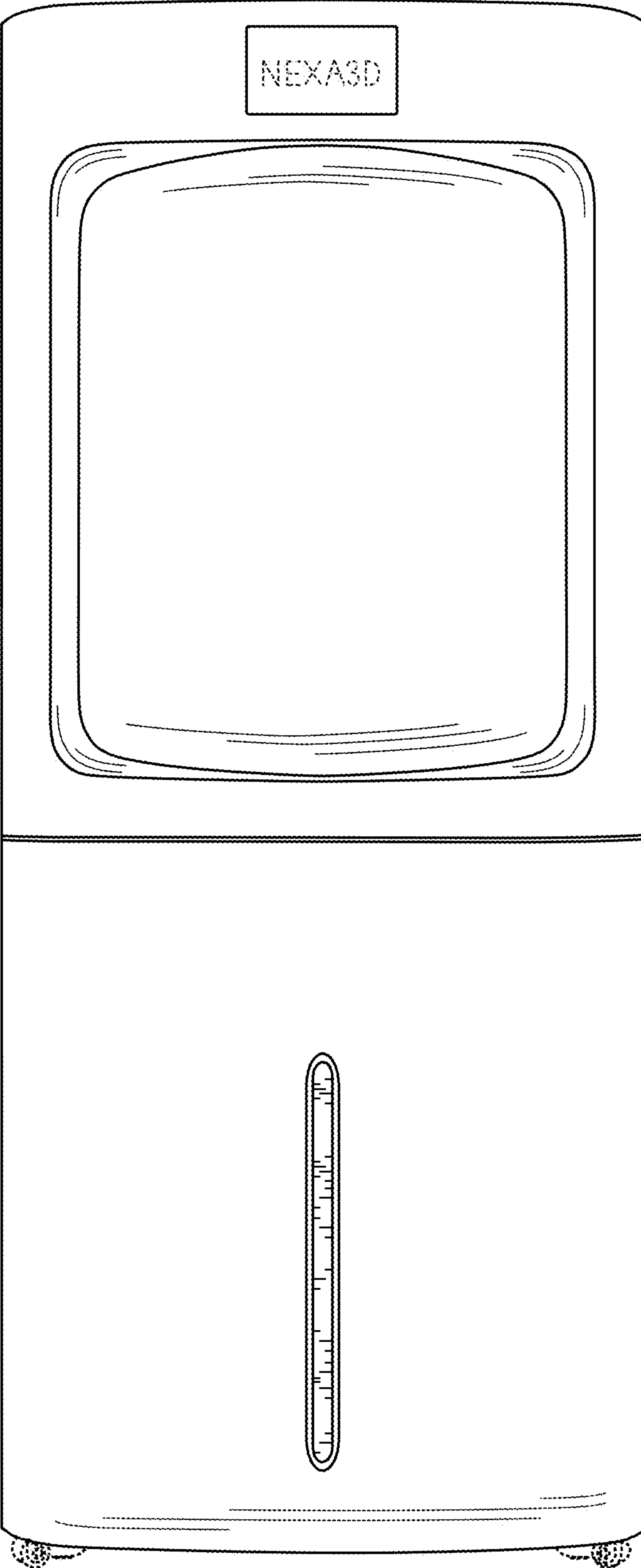

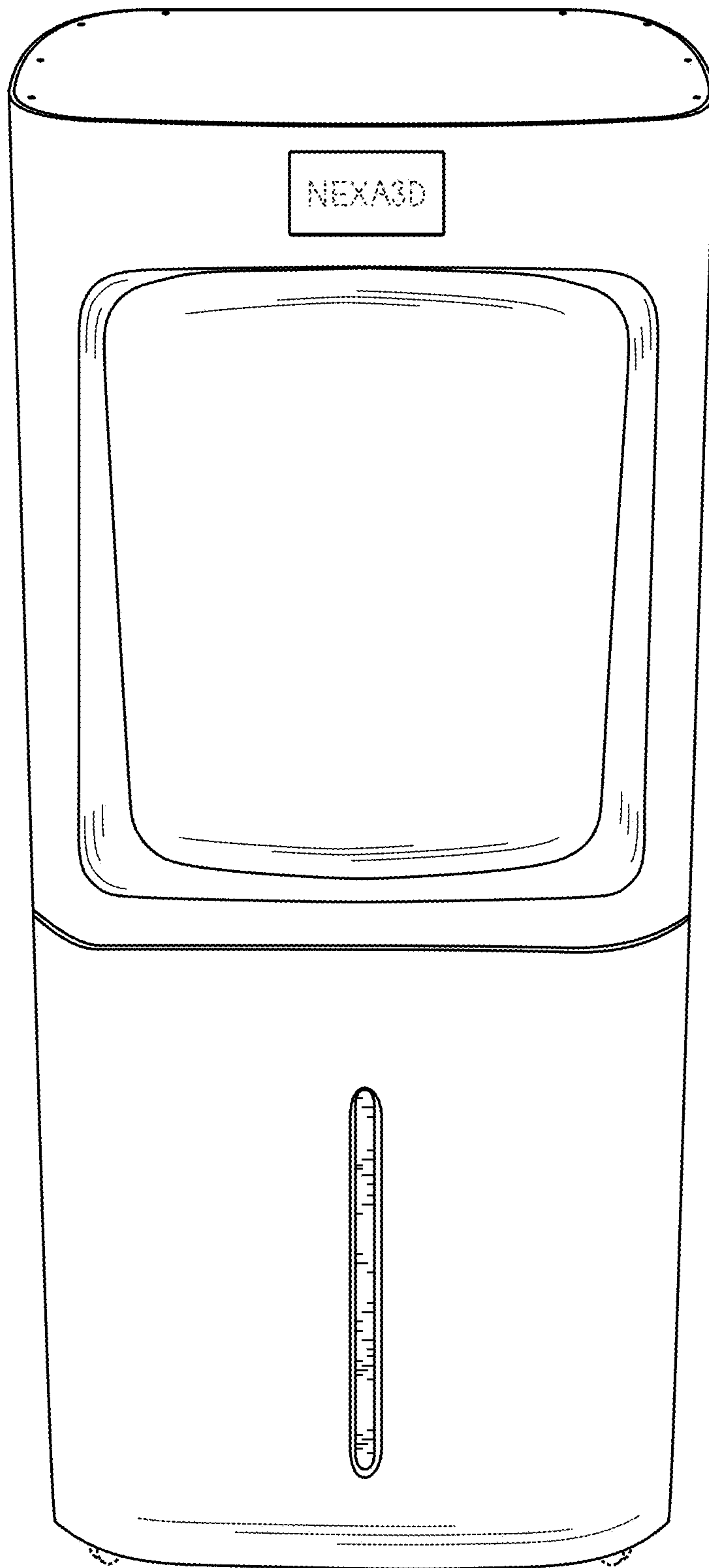

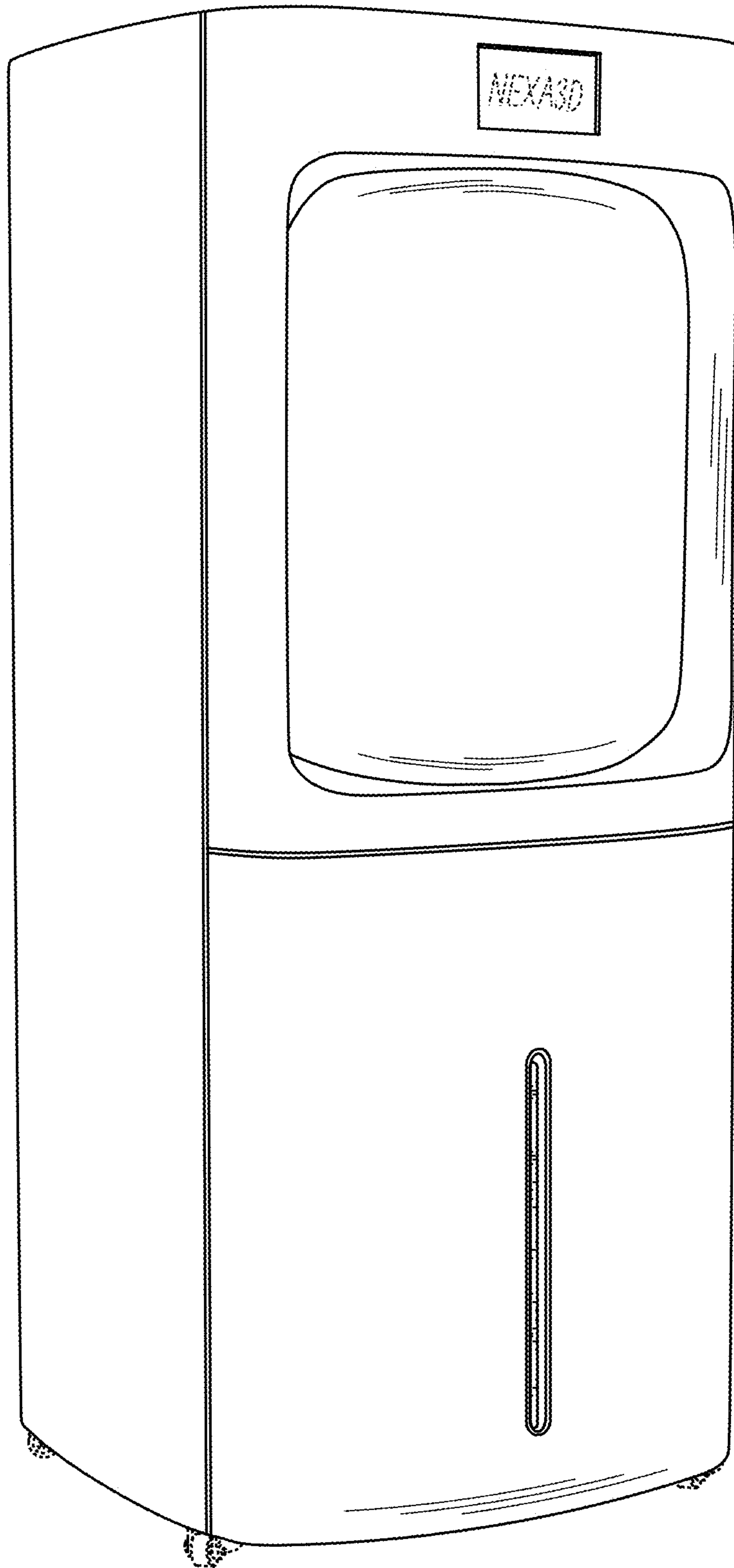

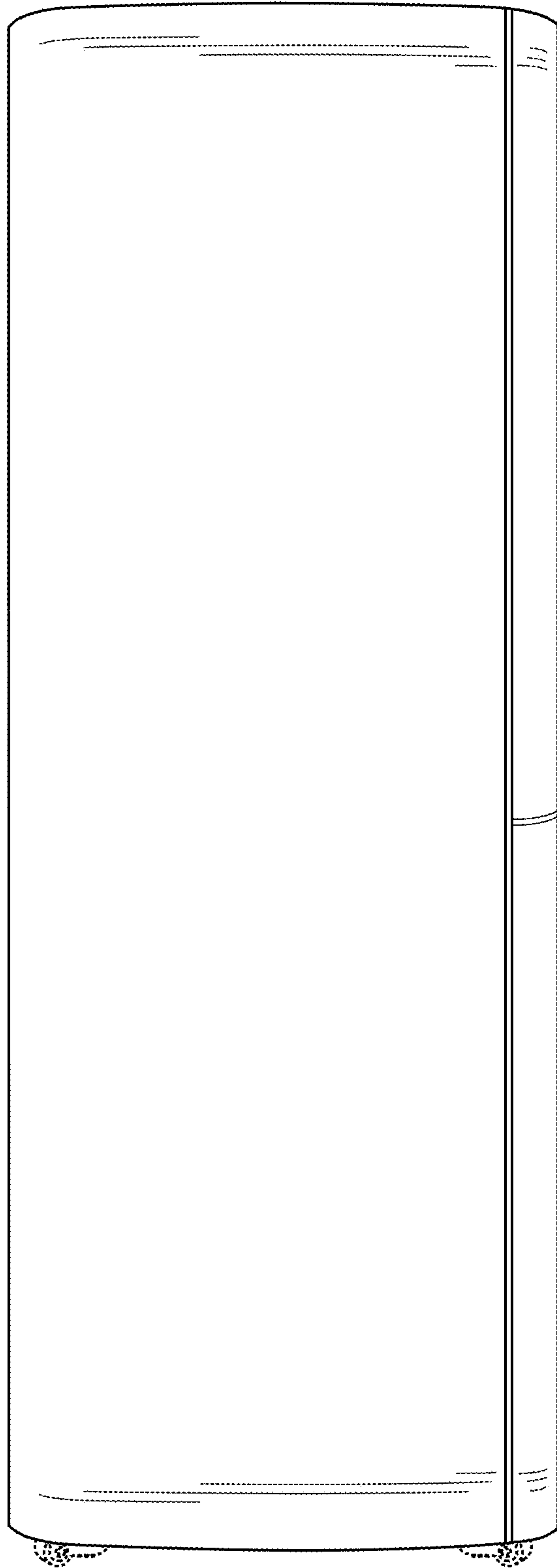

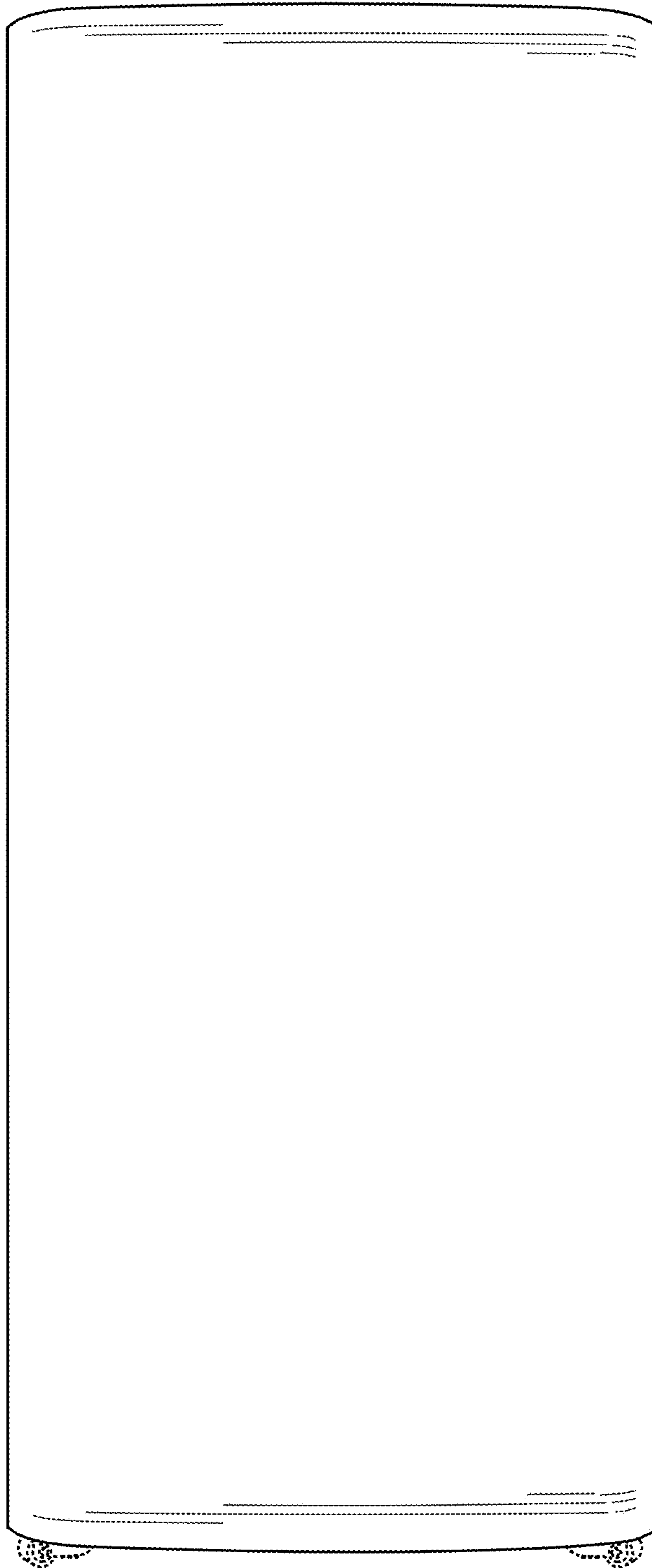

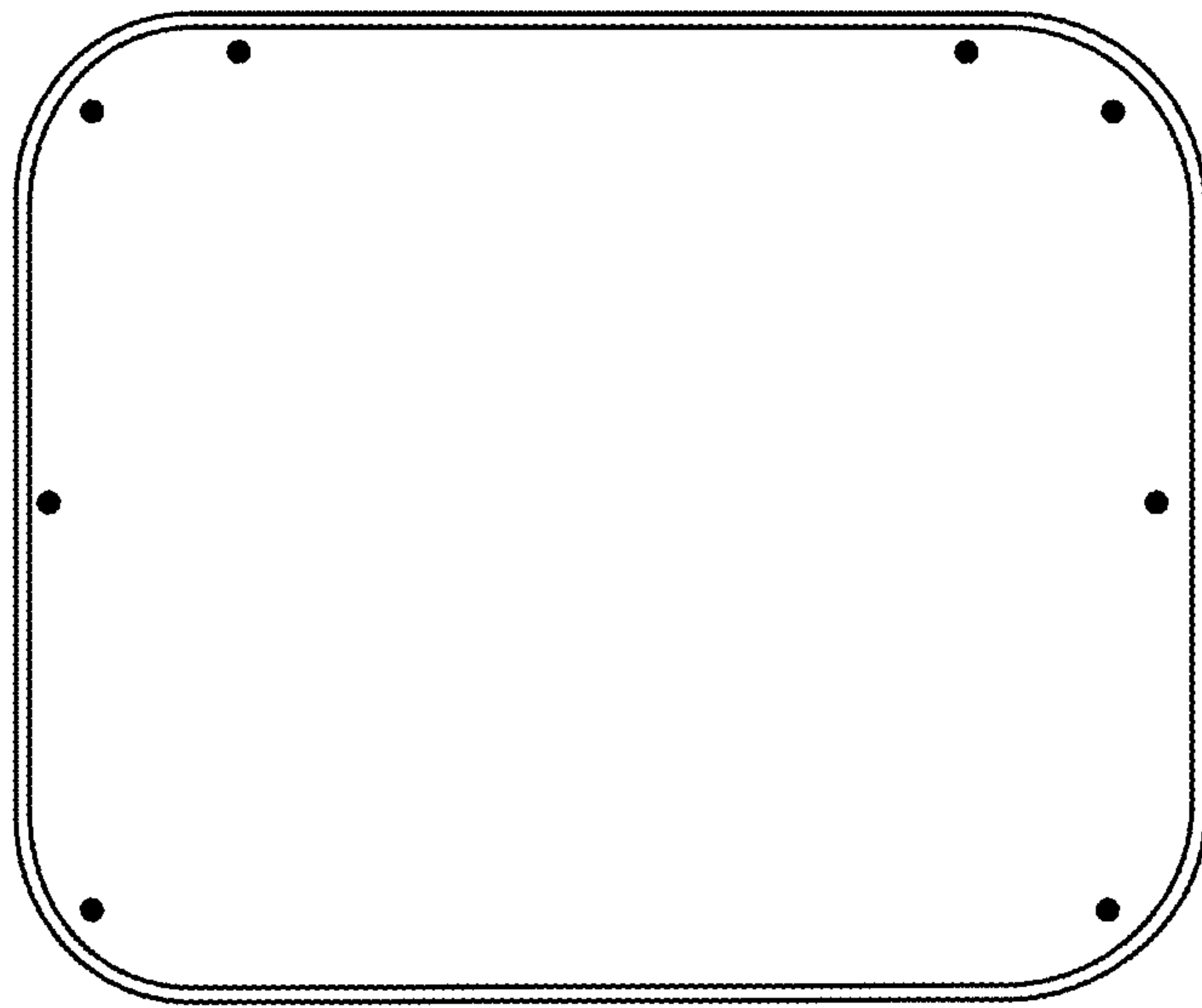

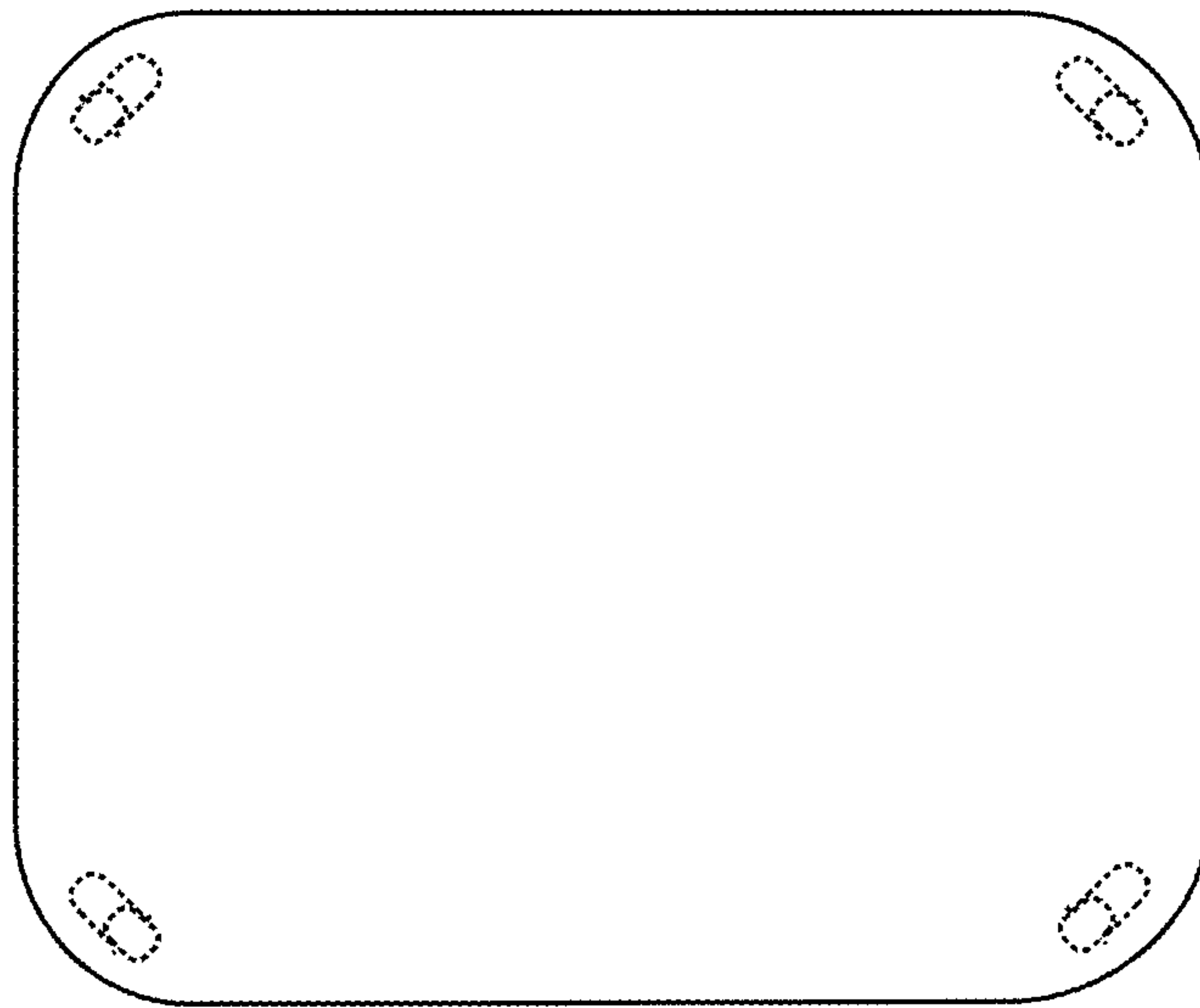
