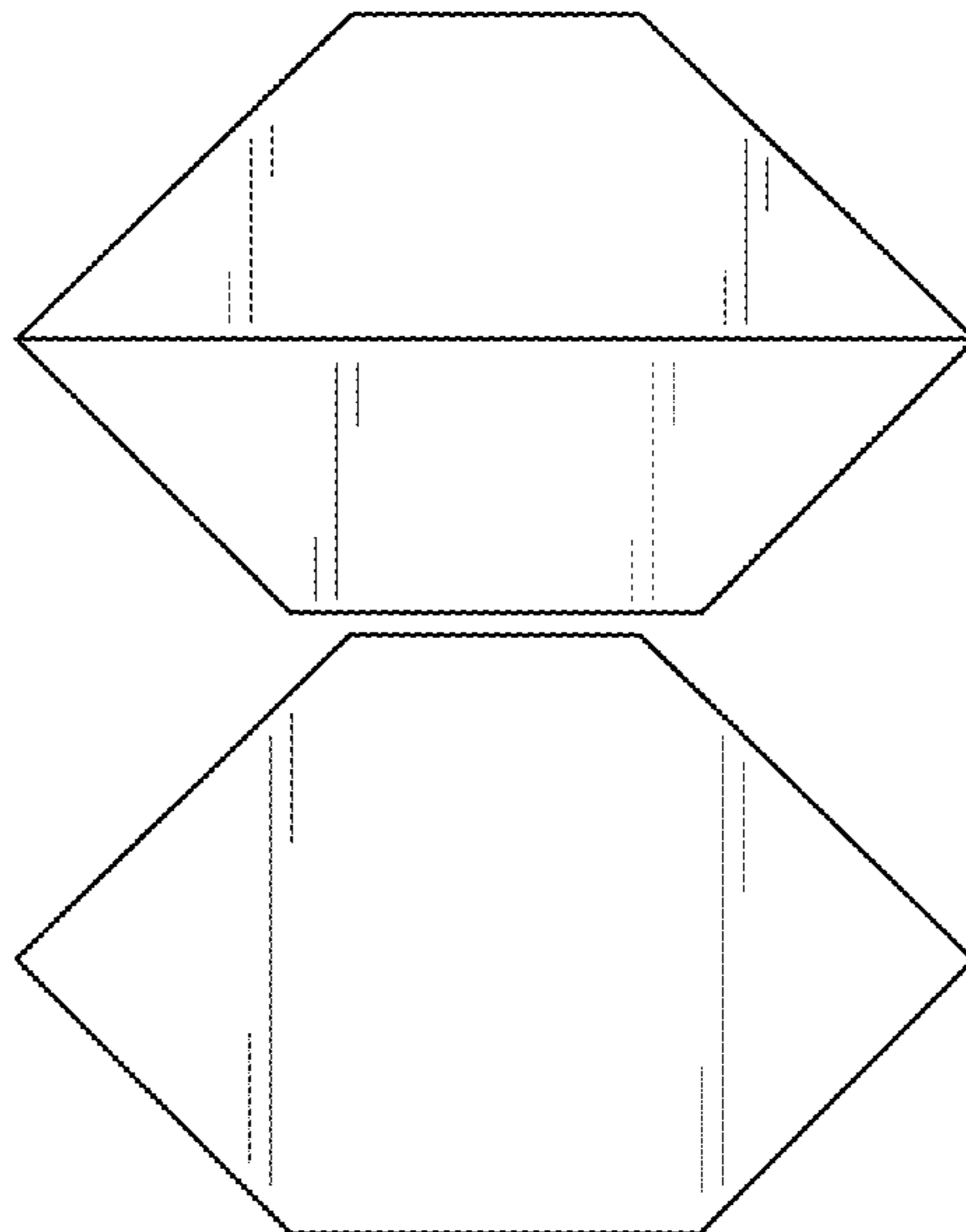
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top plan view of a page marker showing my design;
FIG. 2 is a bottom plan view thereof;

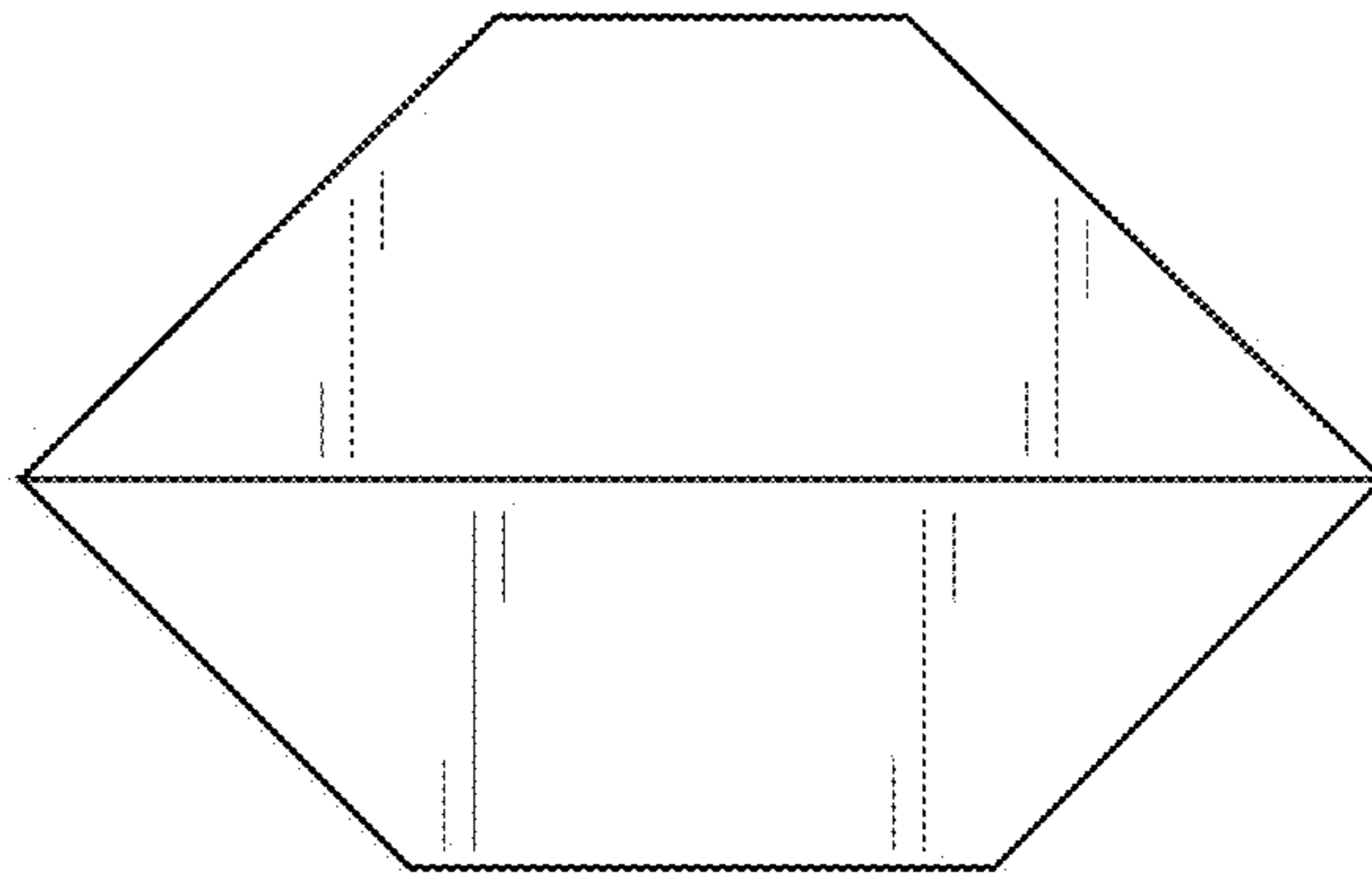

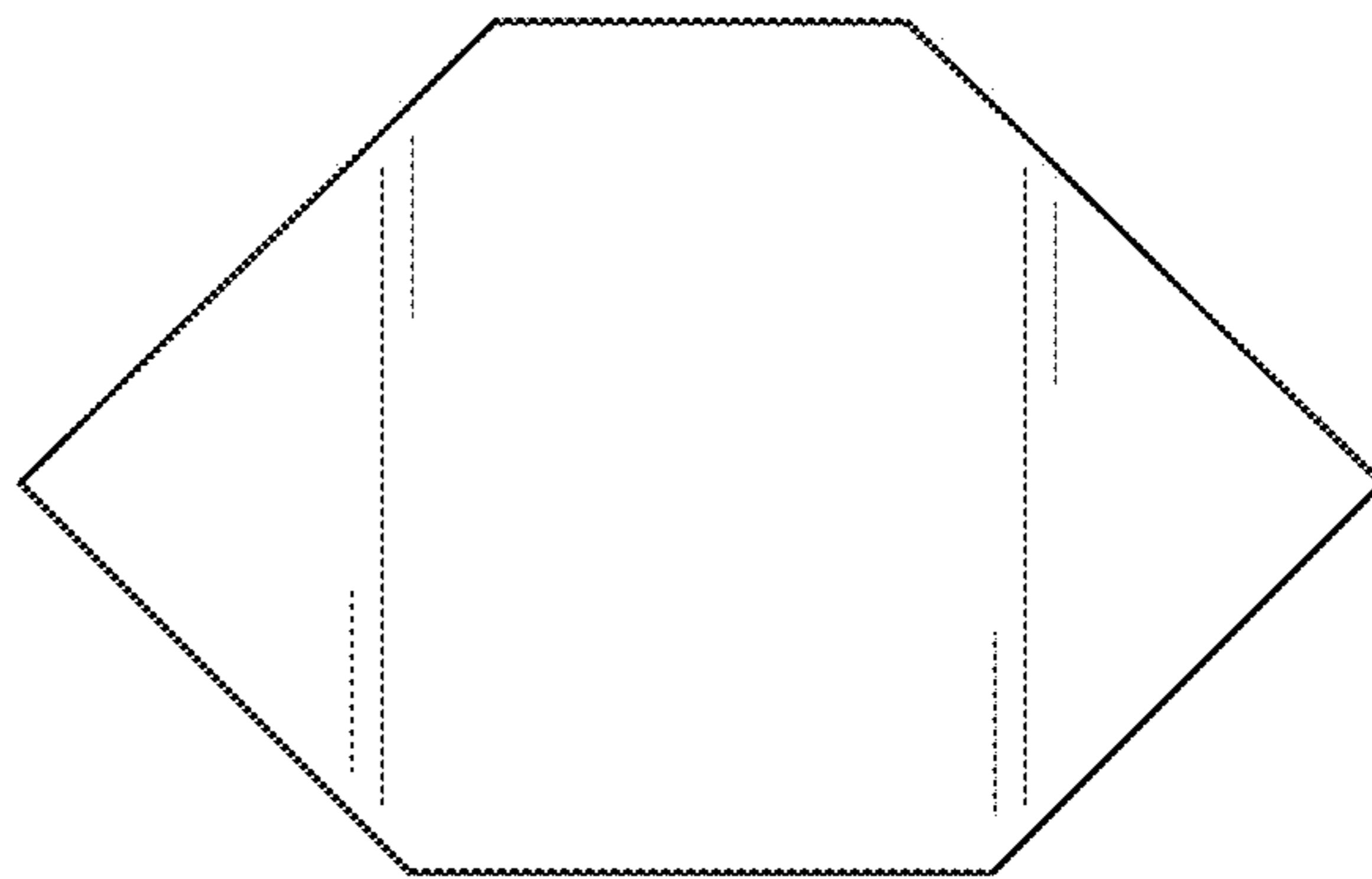

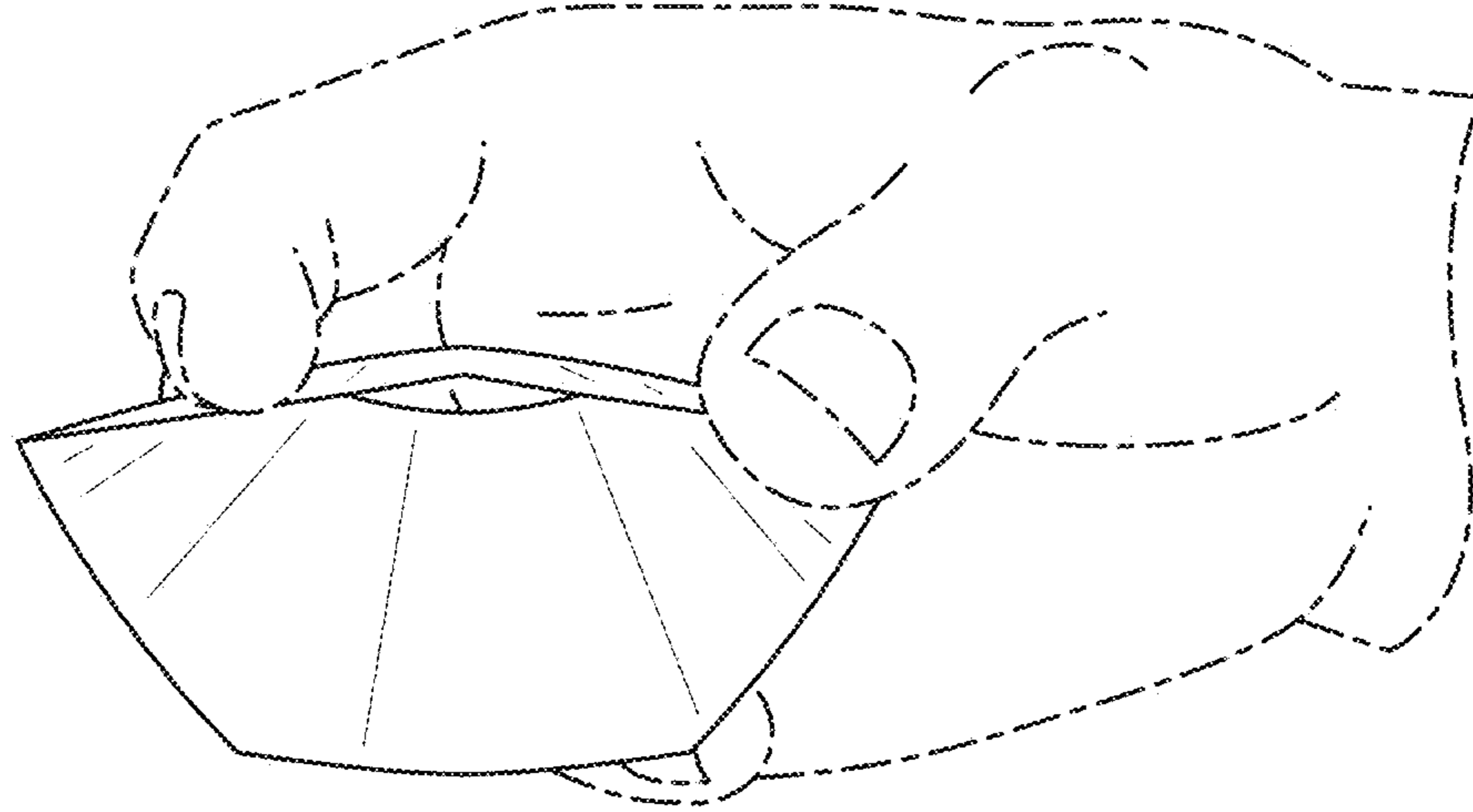

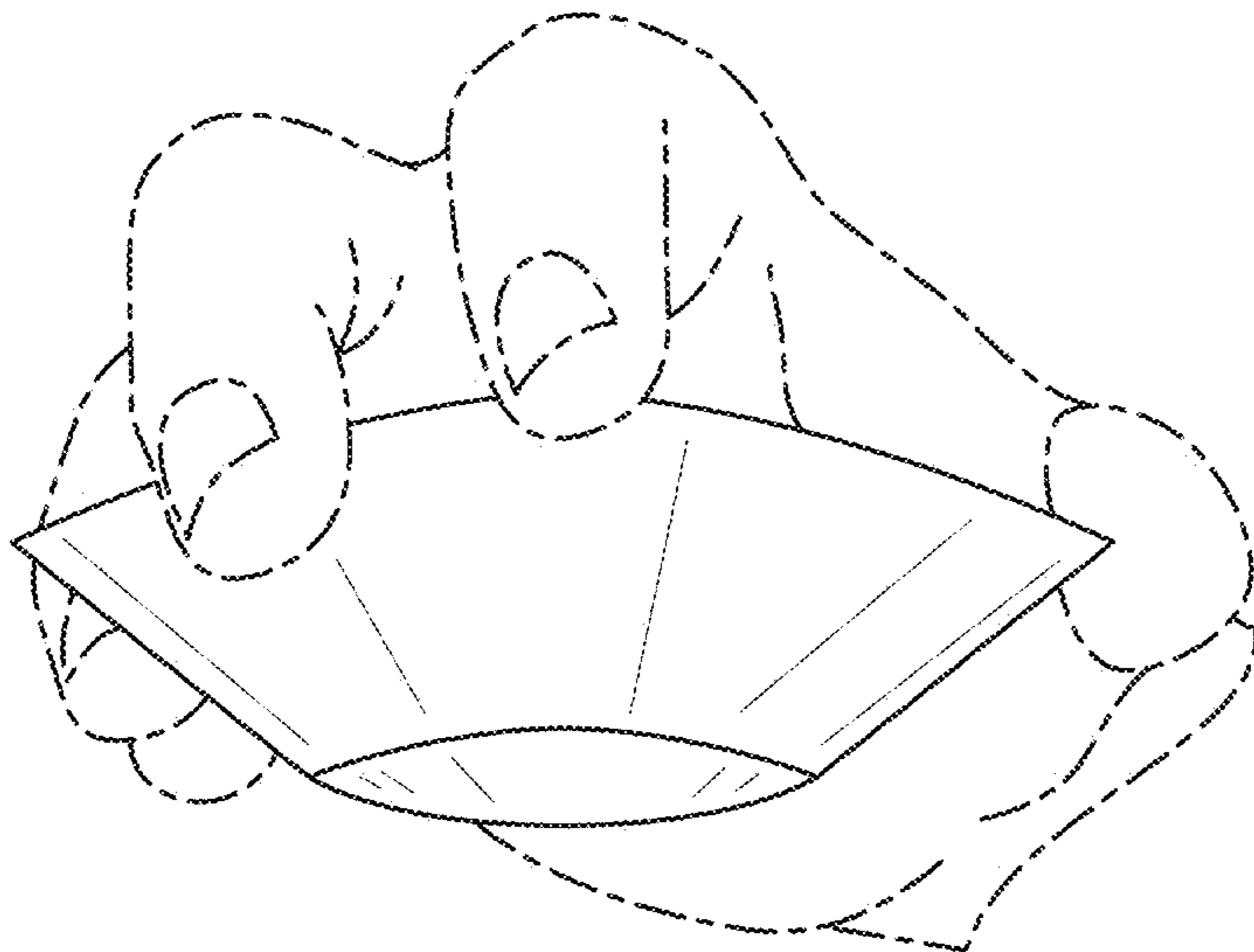

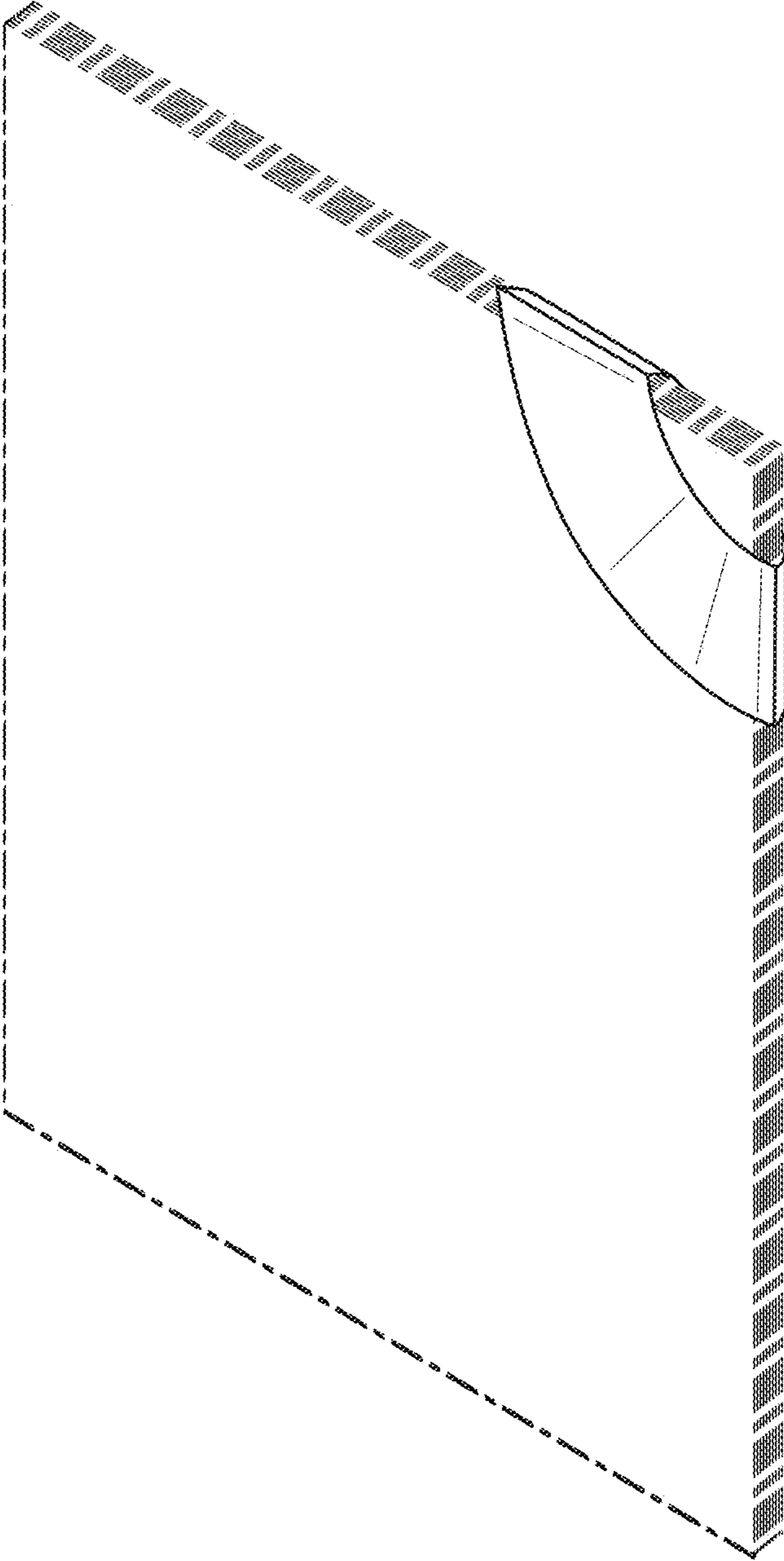

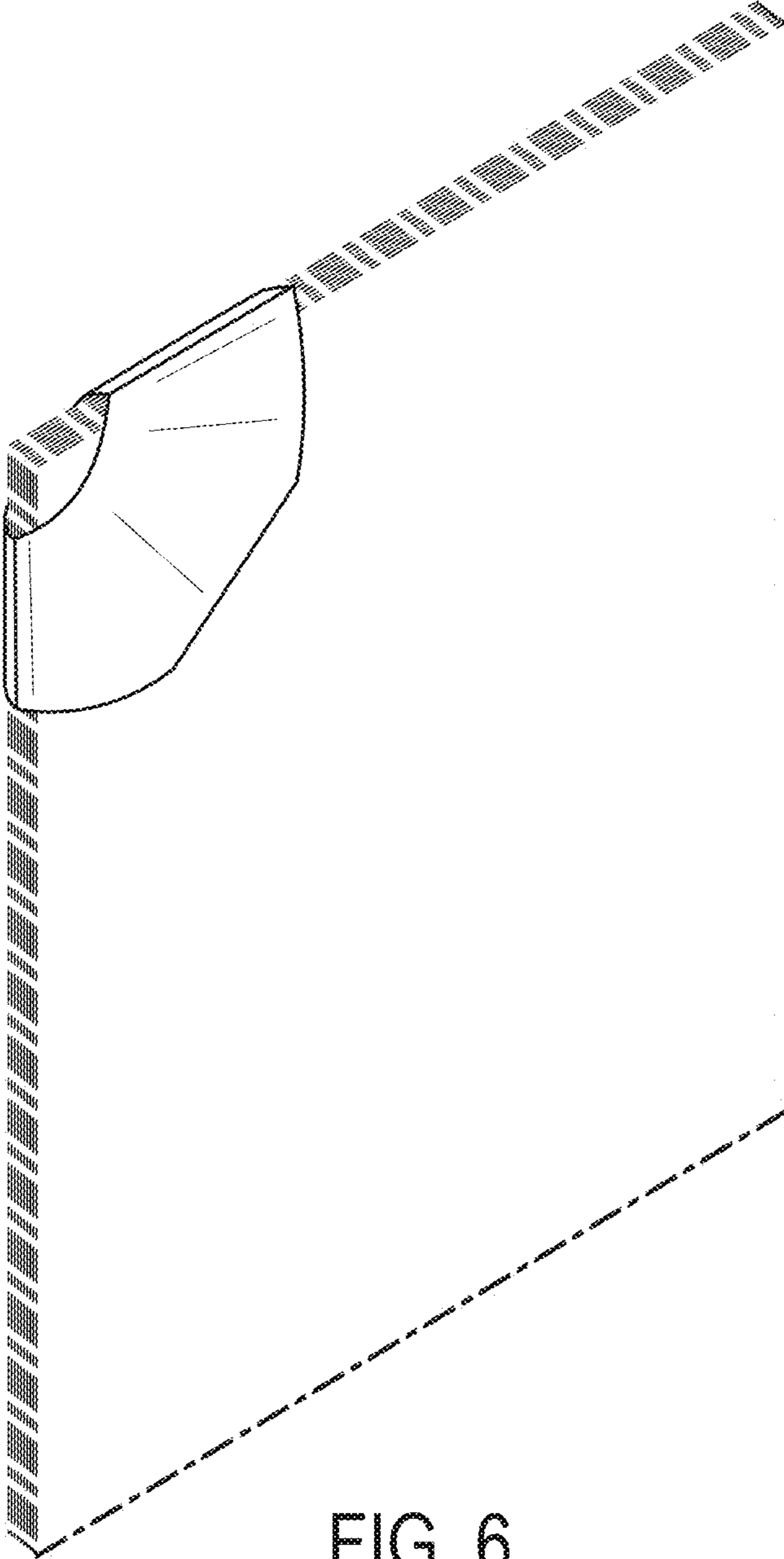

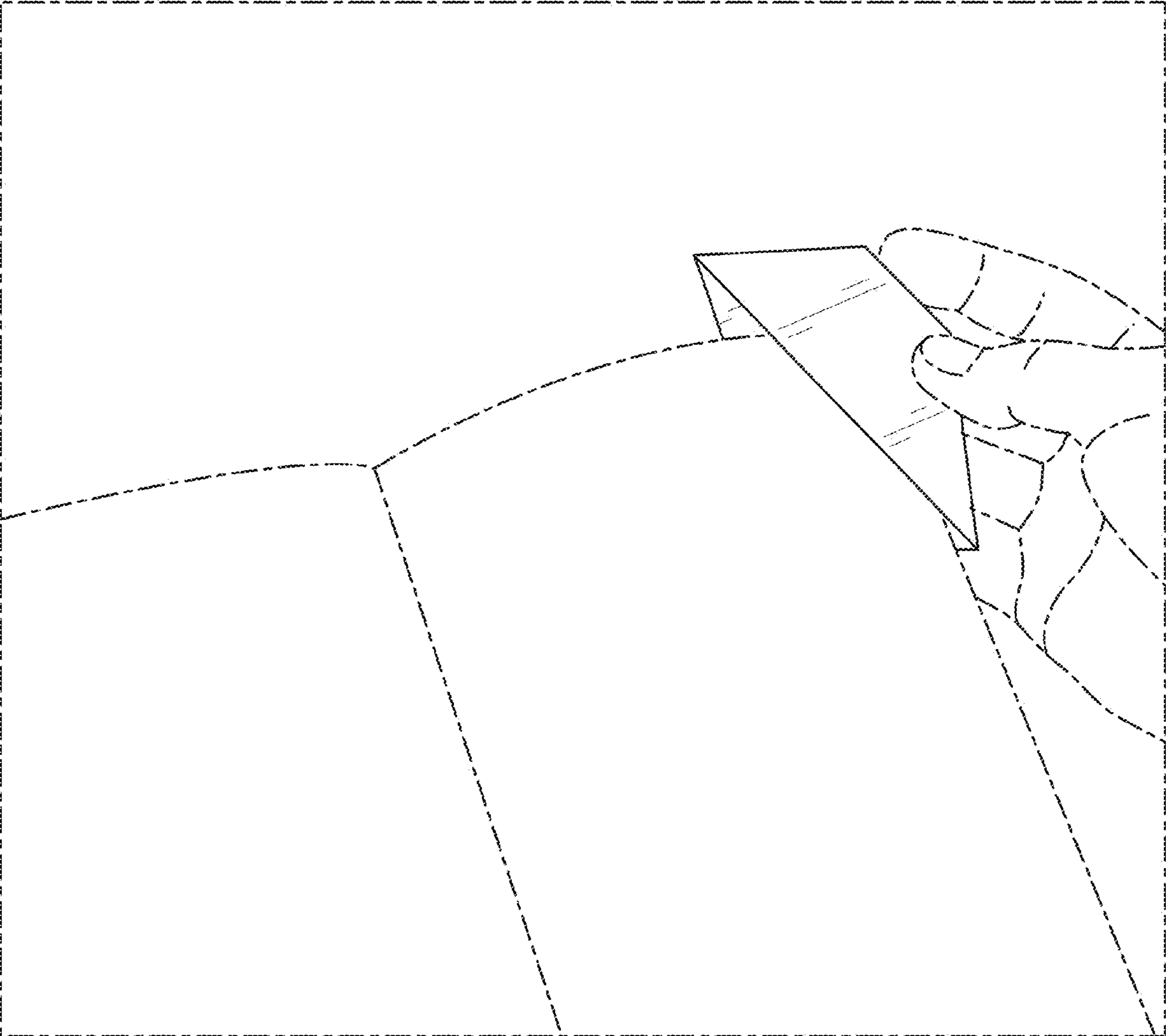

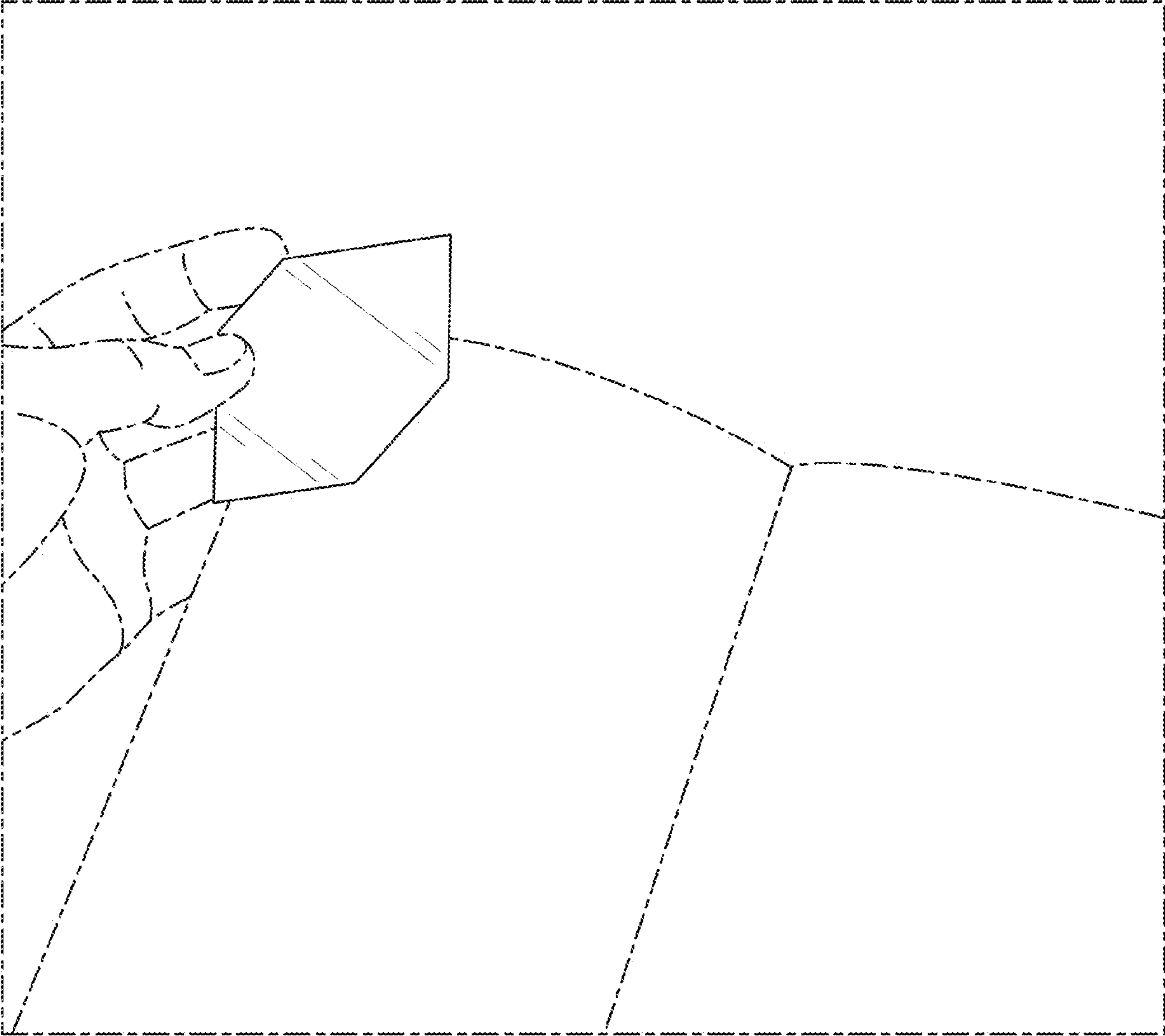
