DESCRIPTION

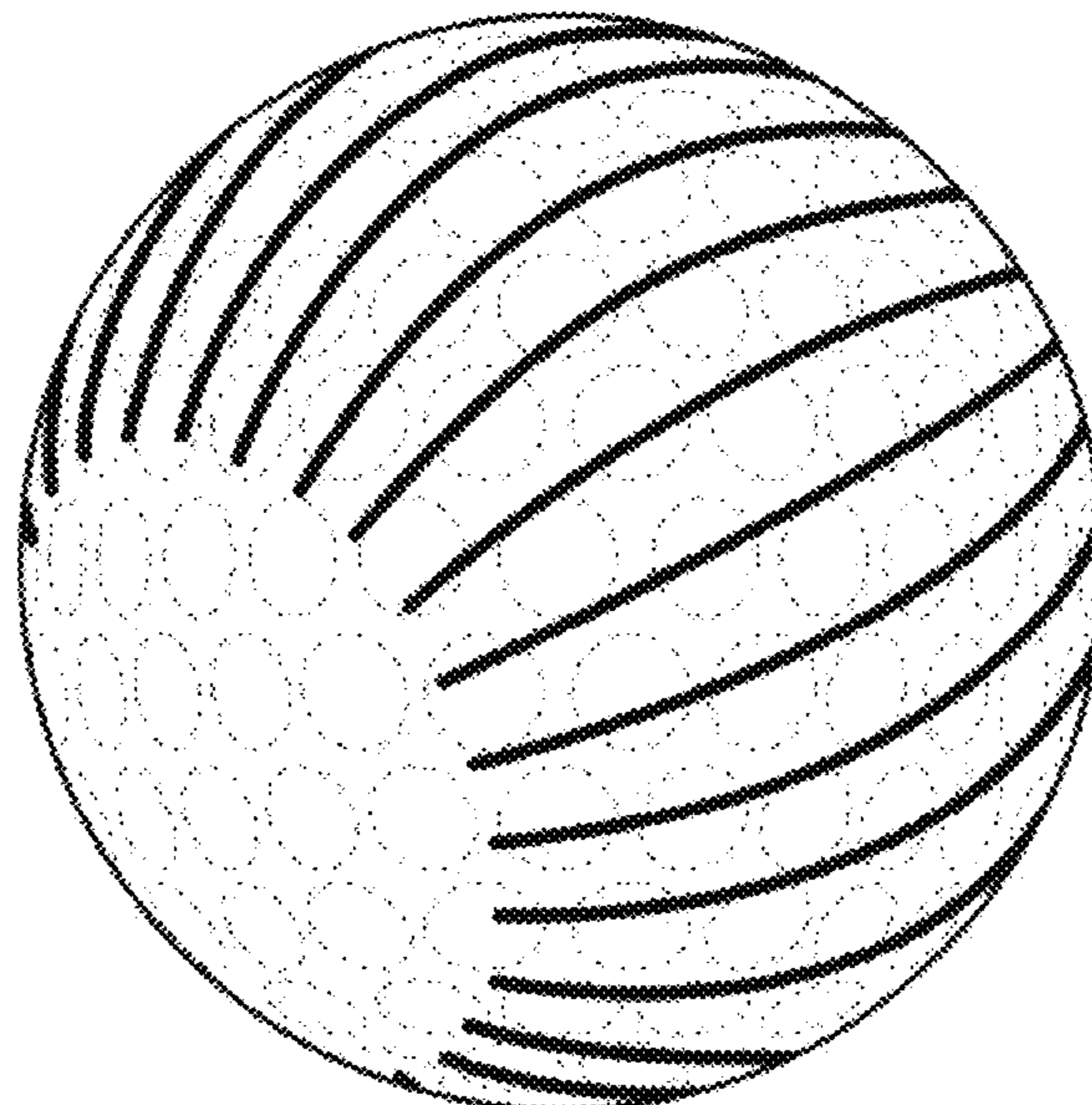
FIG. 1 is a perspective view of a sports ball showing my new design.

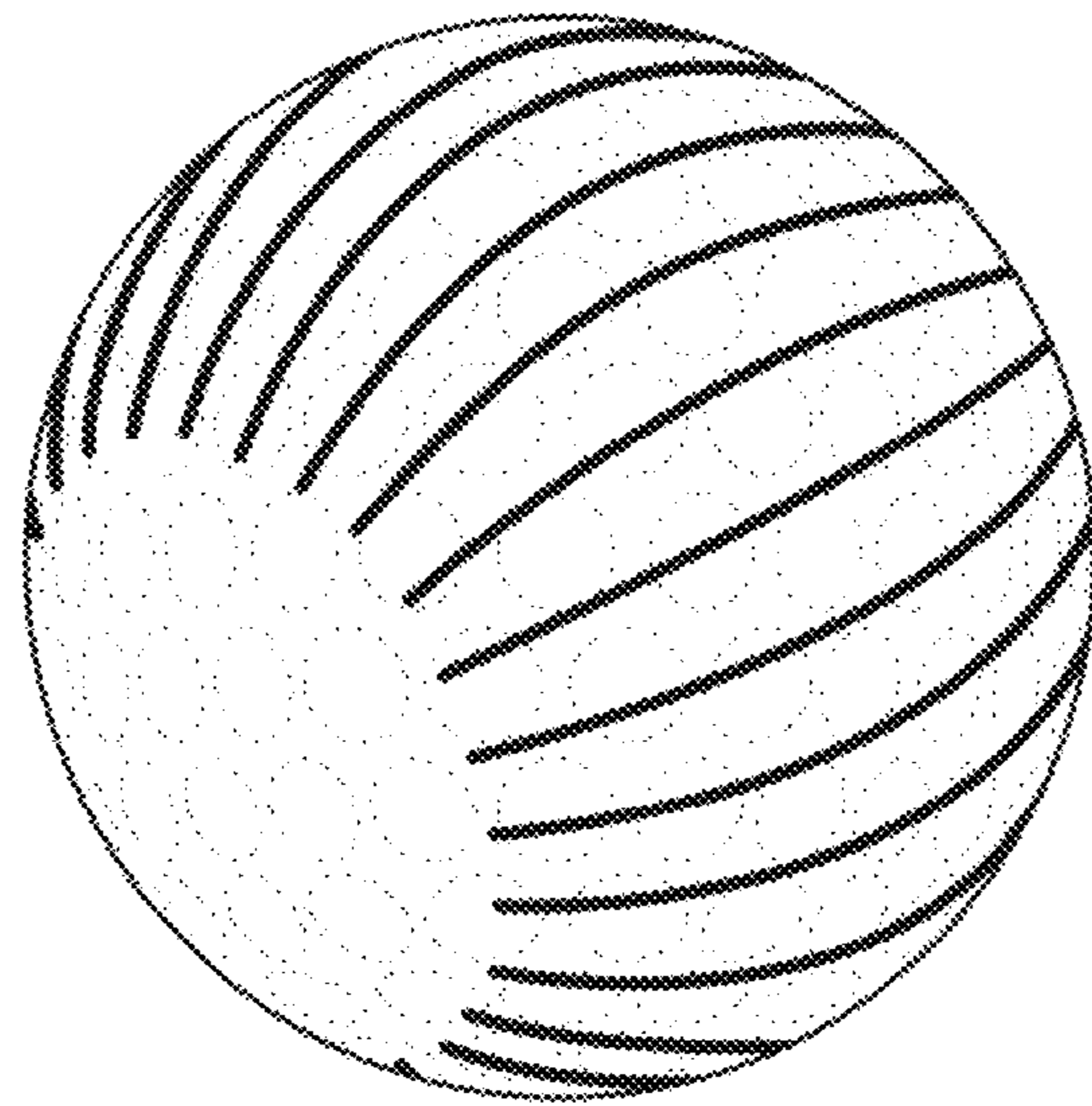

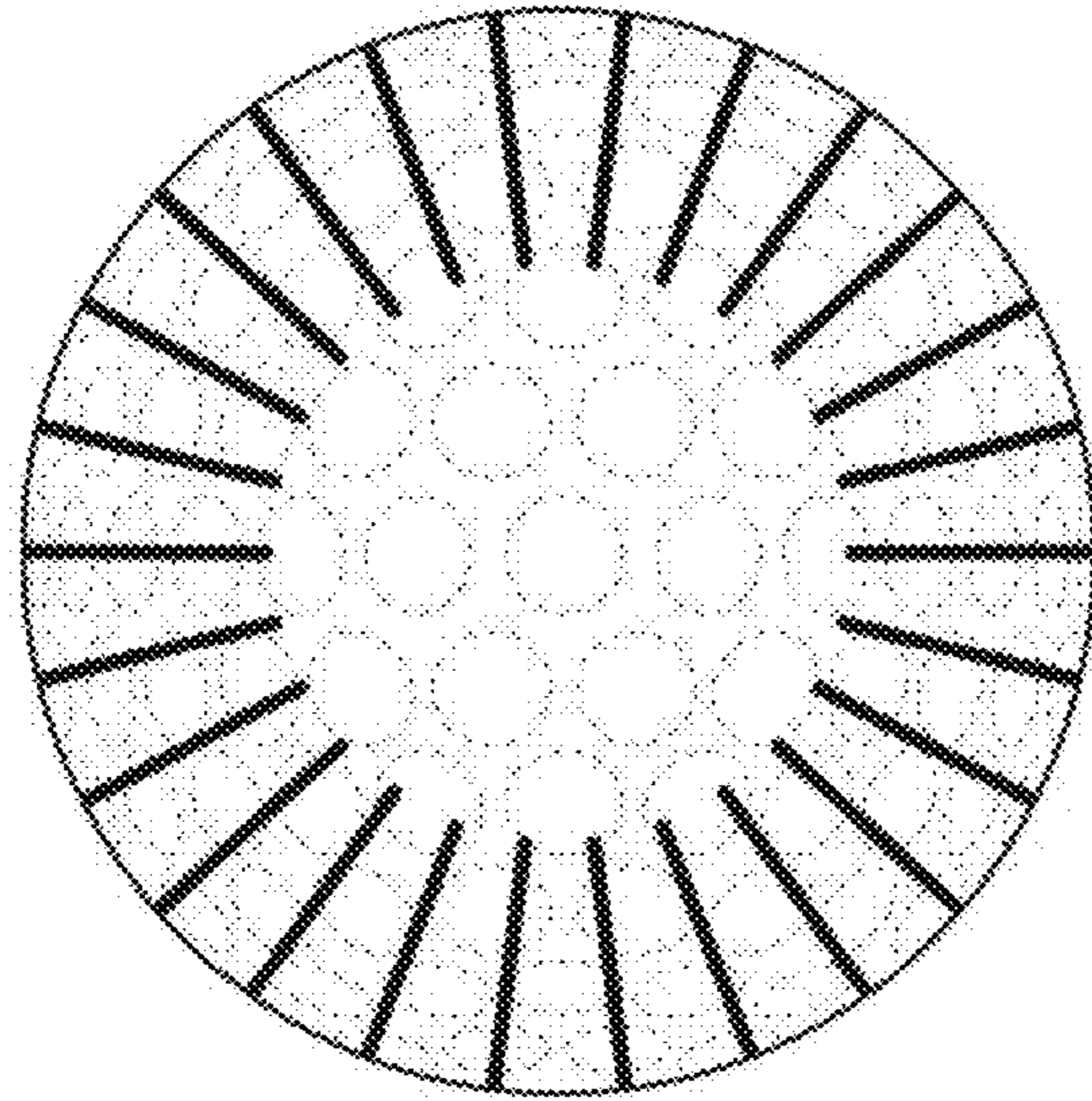

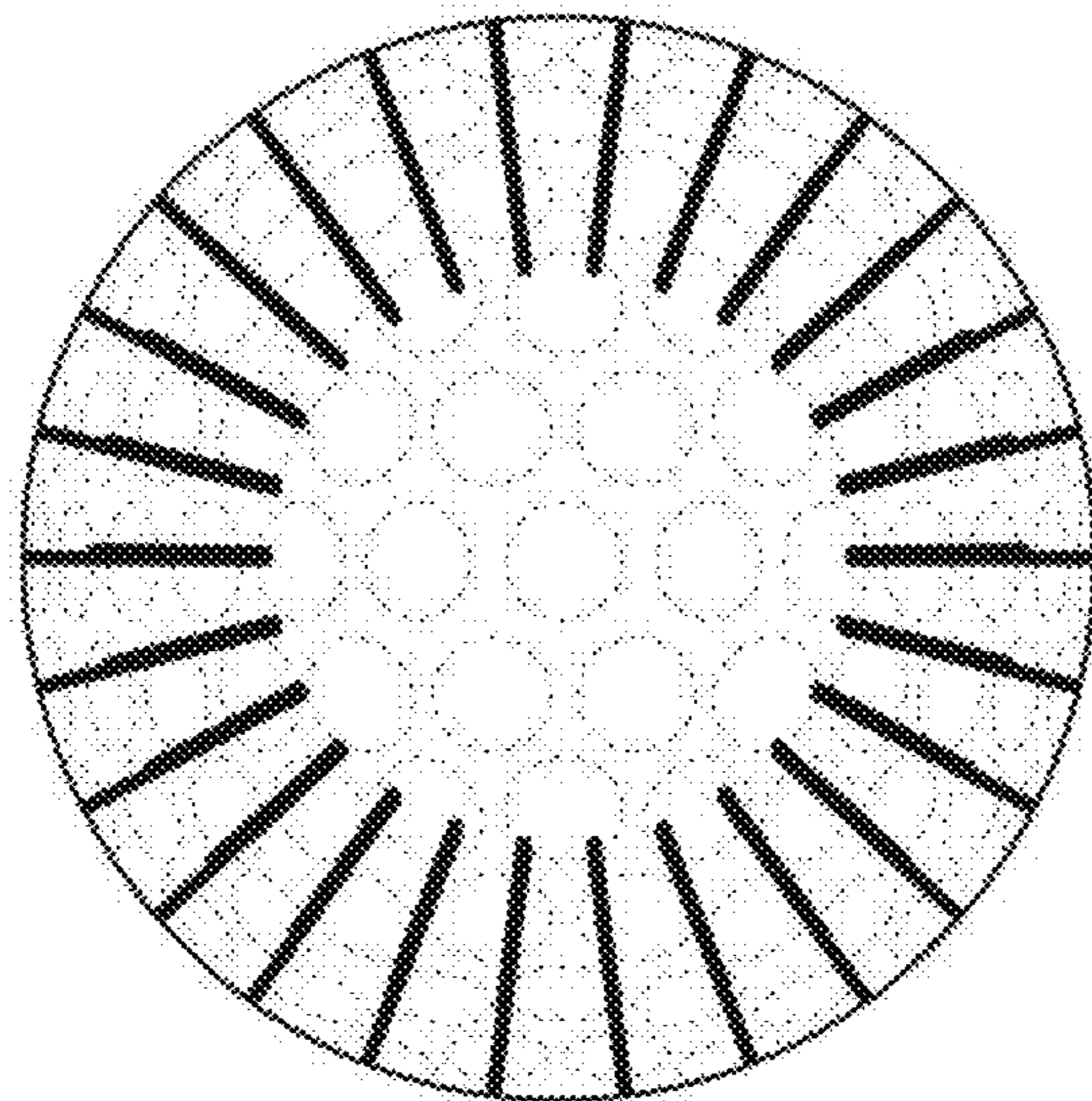

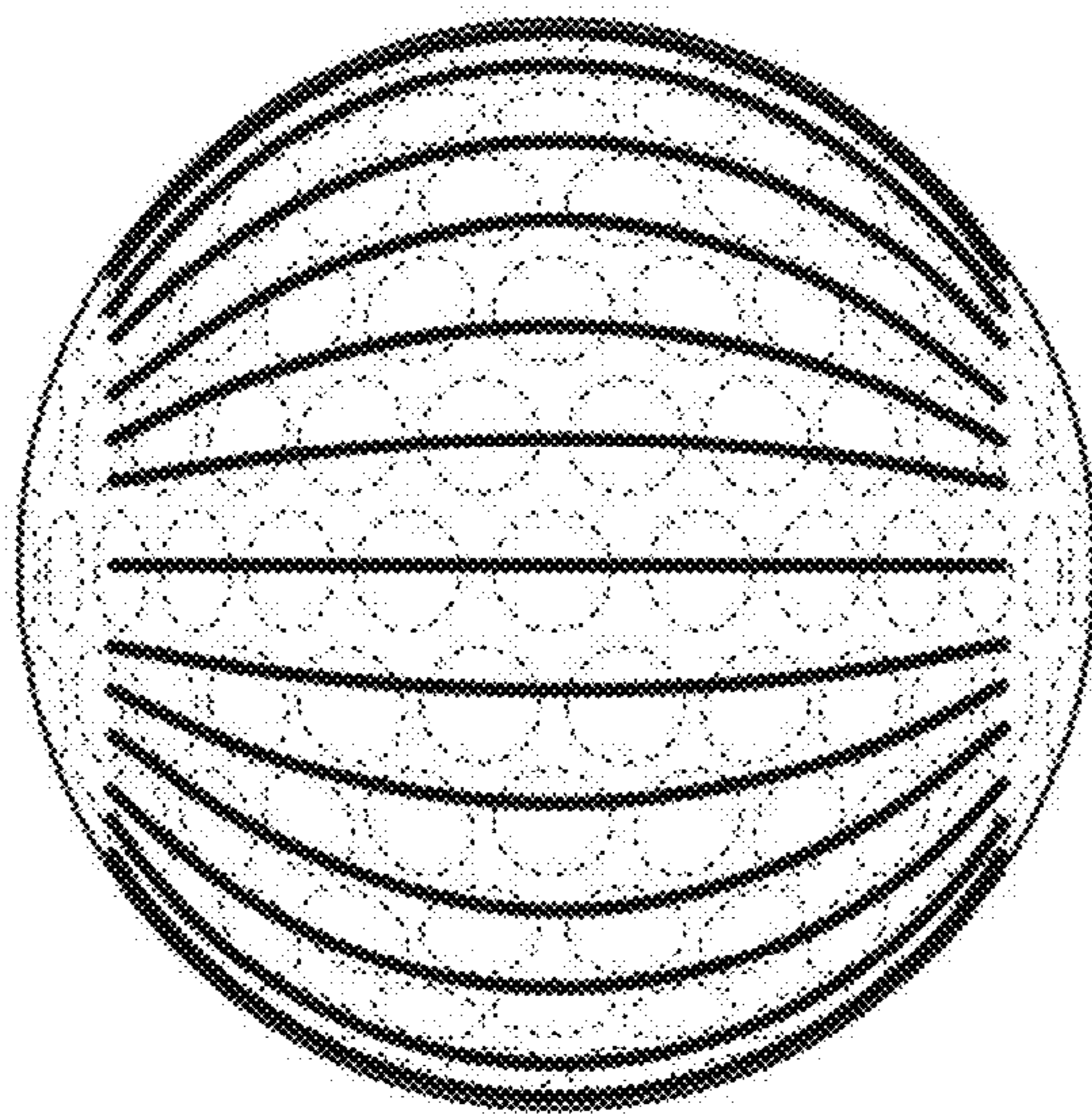

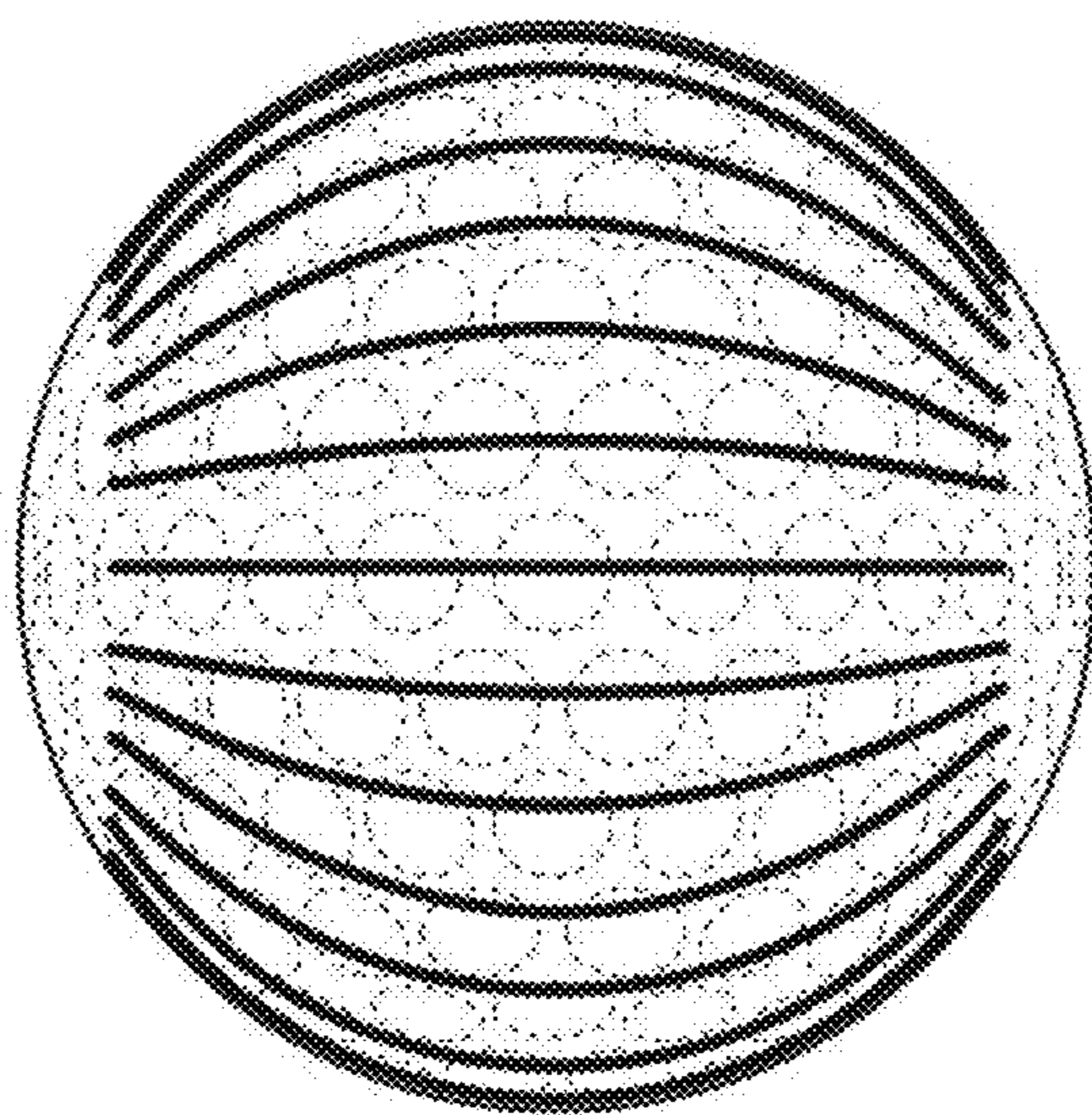

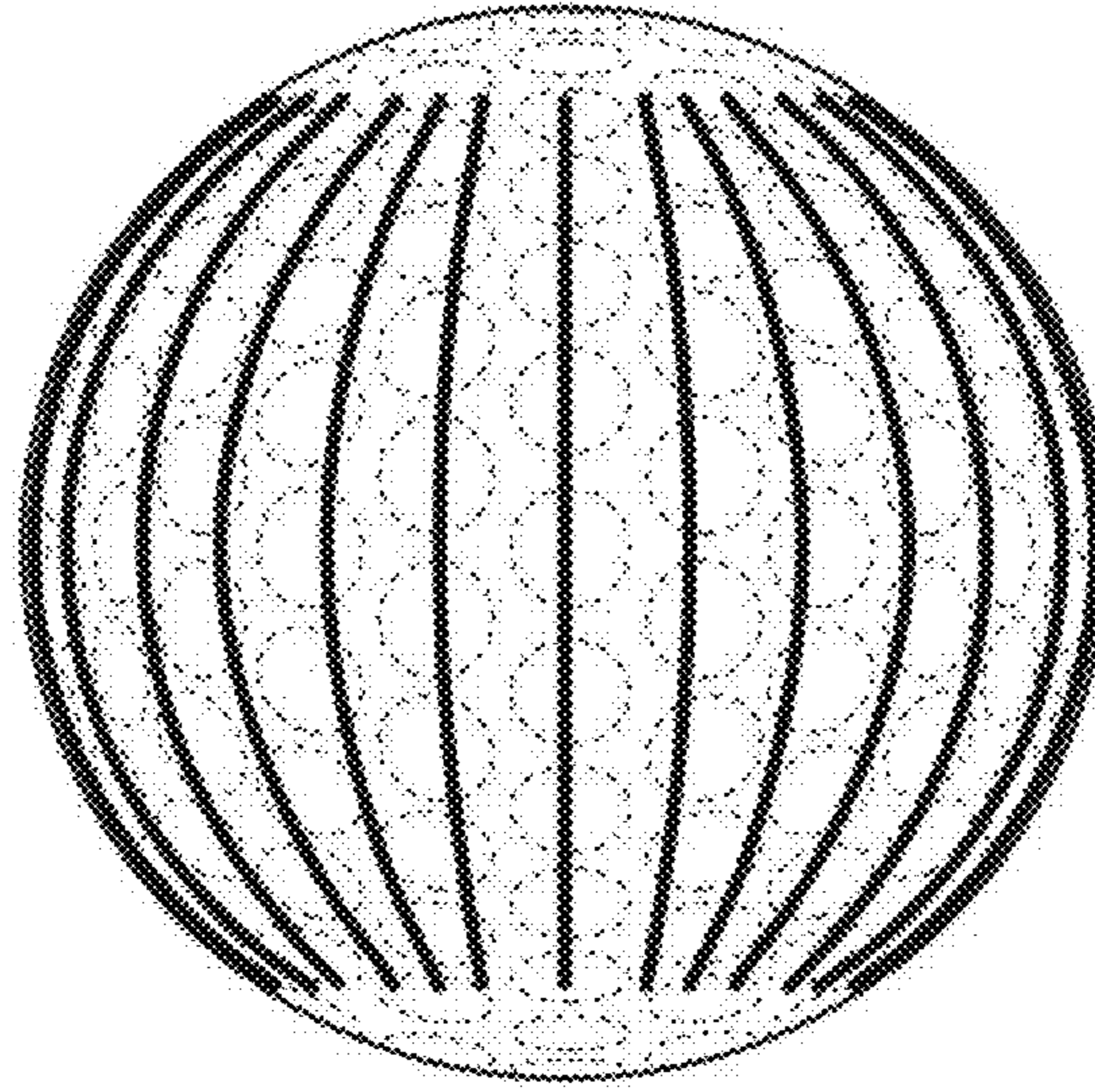

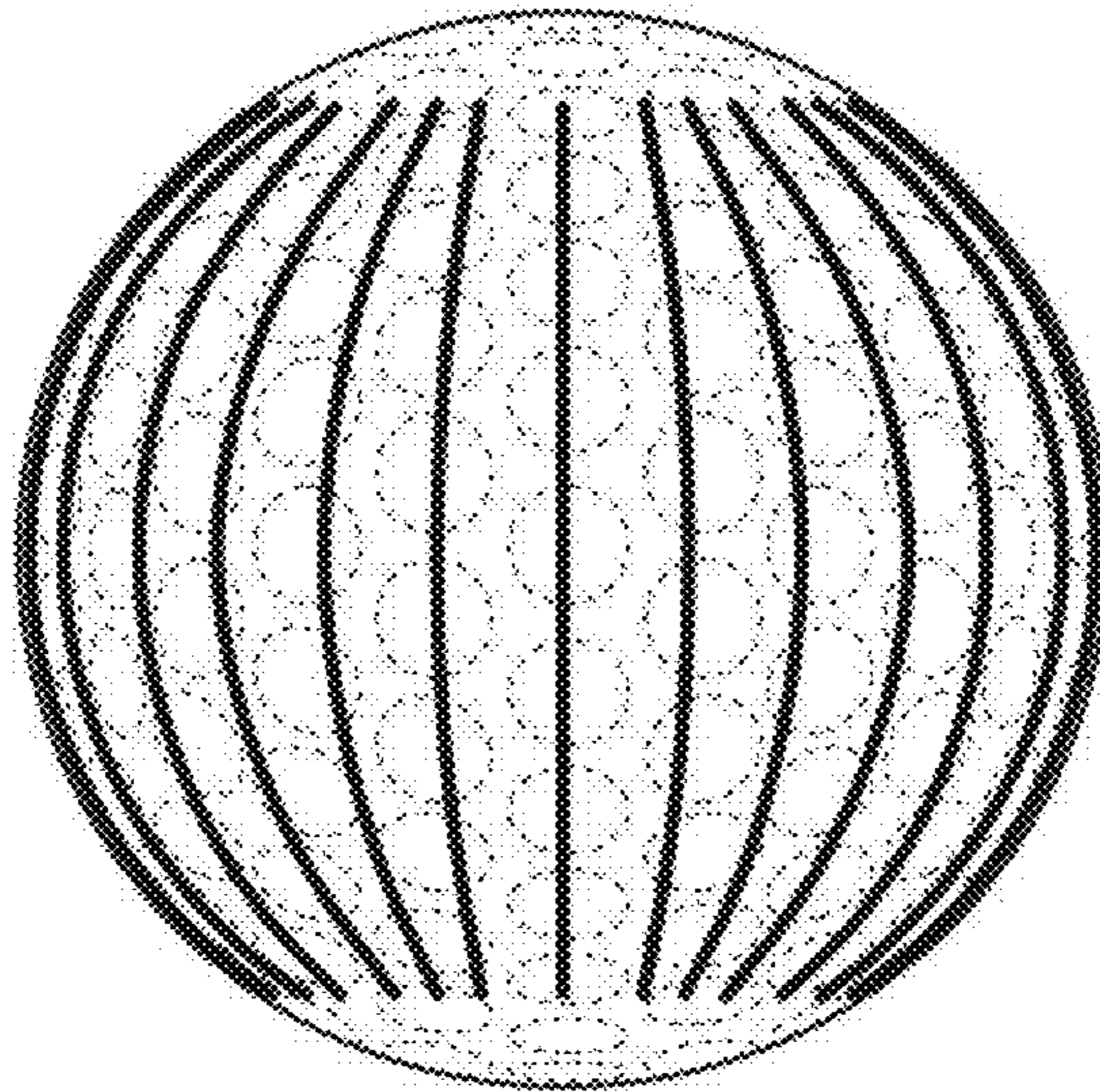
