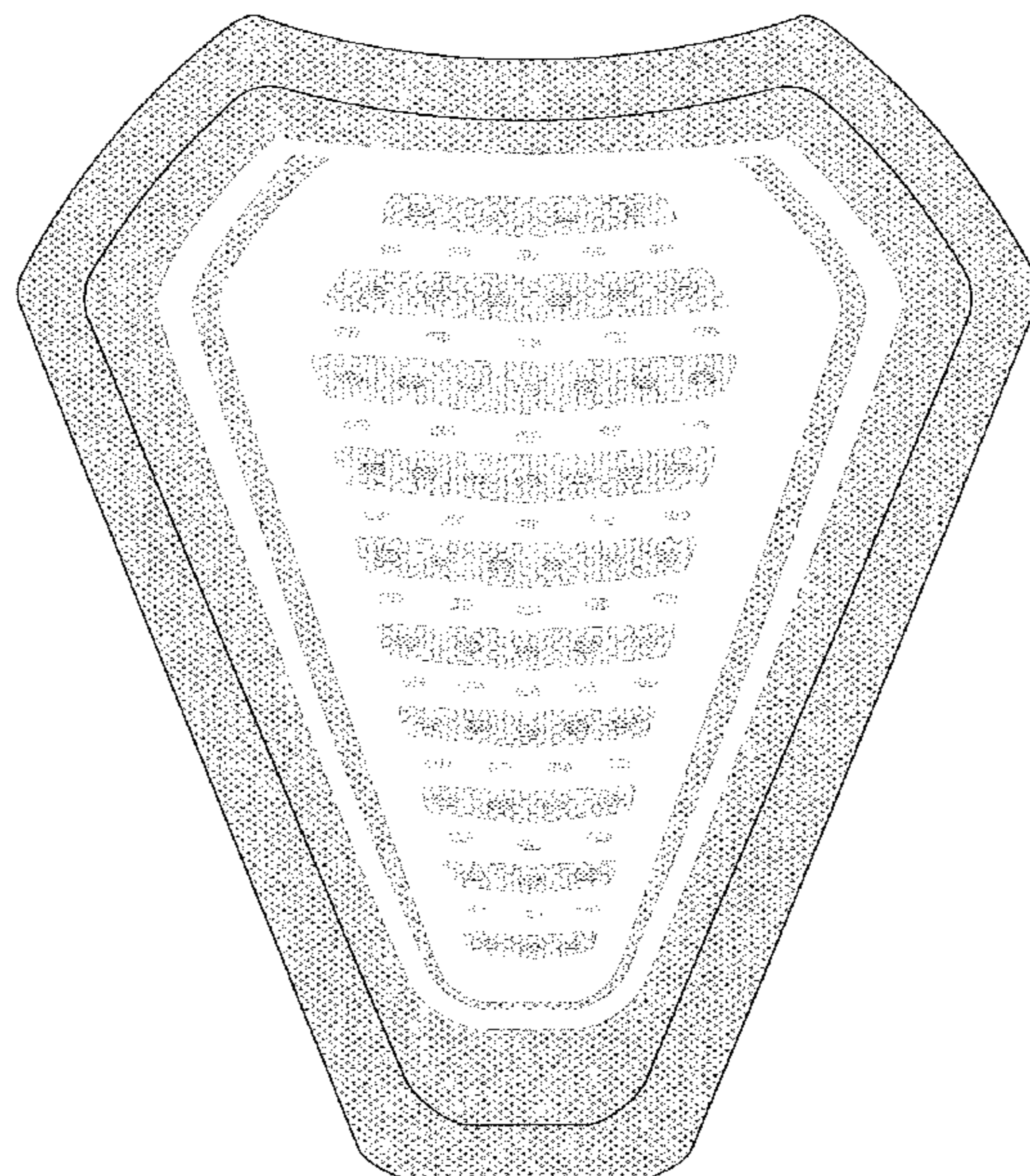
(57) **CLAIM**

The ornamental design for a sanitary article, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a sanitary article showing our new design.
FIG. 2 is a bottom plan view thereof.
FIG. 3 is a front elevational view thereof.
FIG. 4 is a rear elevational view thereof.
FIG. 5 is a left side elevational view thereof; and,
FIG. 6 is a right side elevational view thereof.
The broken lines shown in FIG. 2 illustrate portions of the sanitary article that form no part of the claimed design.

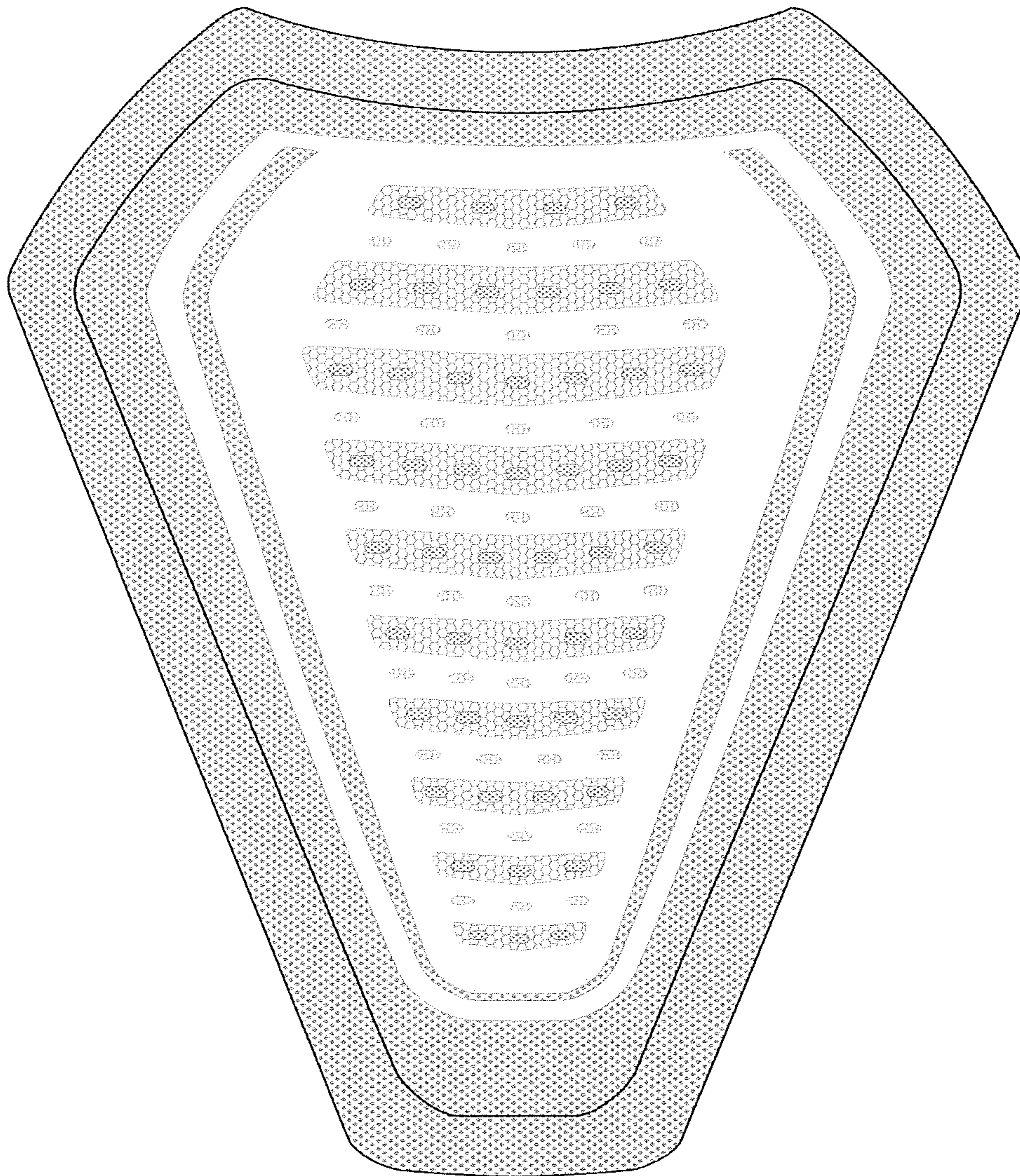

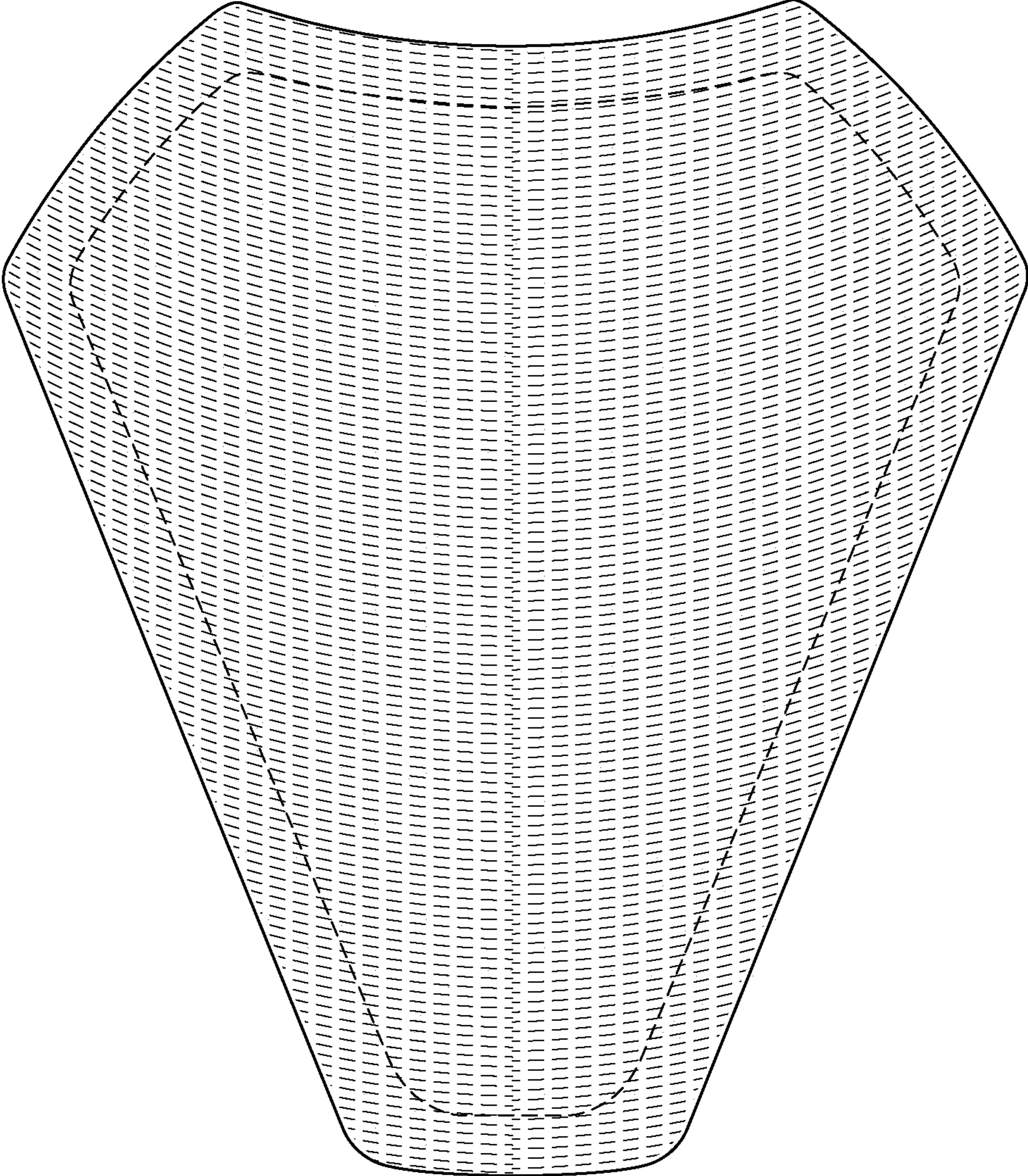

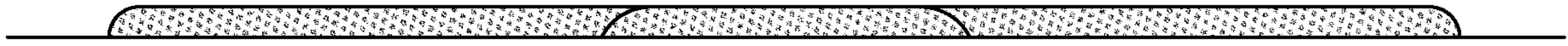

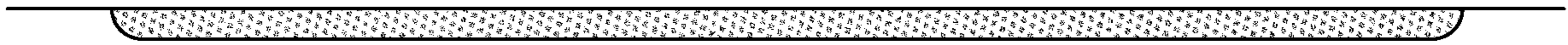

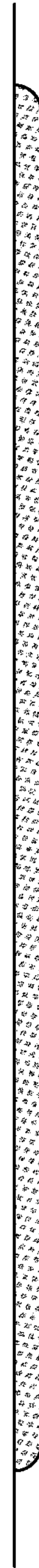
