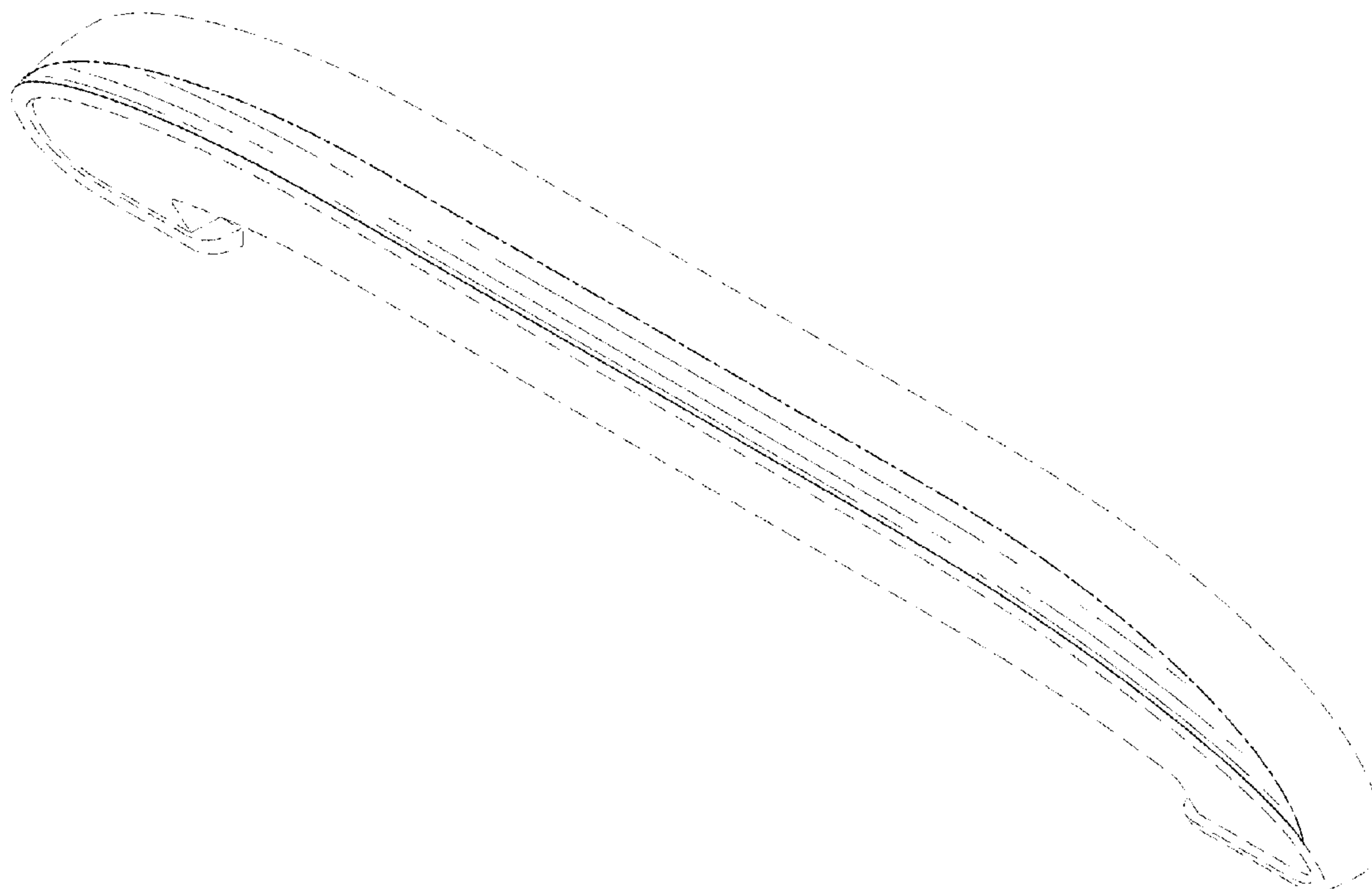

The ornamental design for a portion of a side cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a portion of a side cover showing our new design;

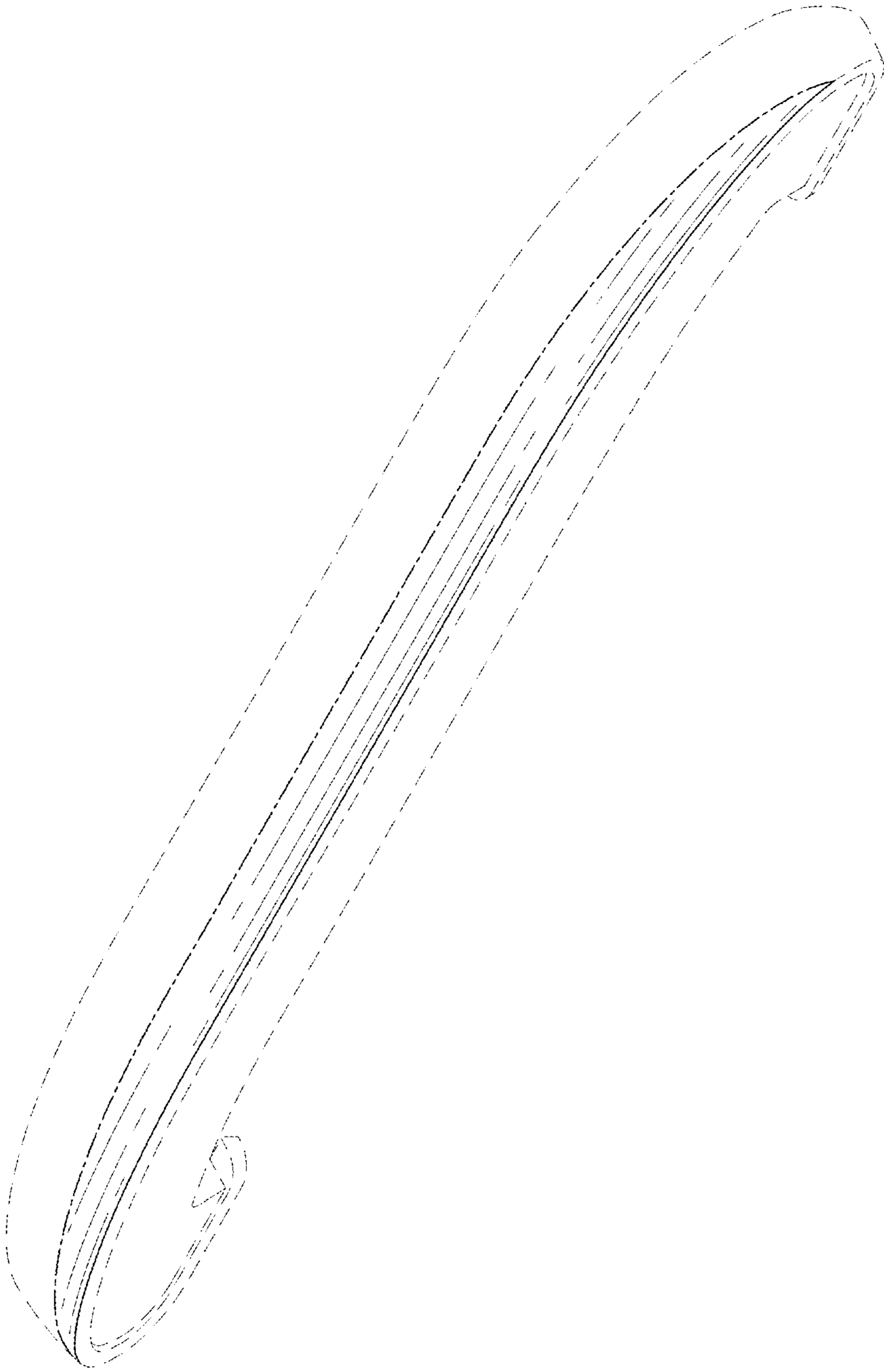

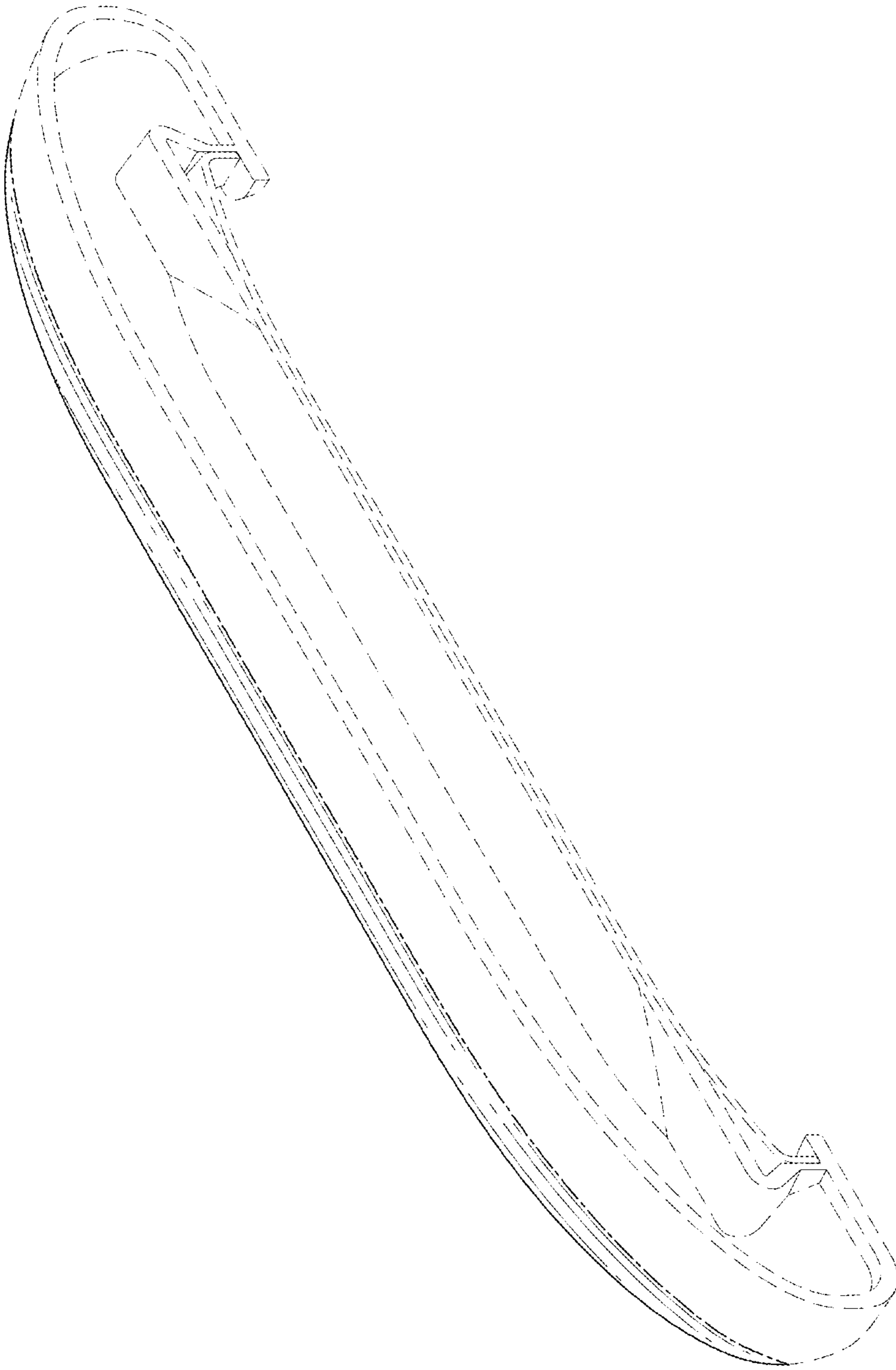

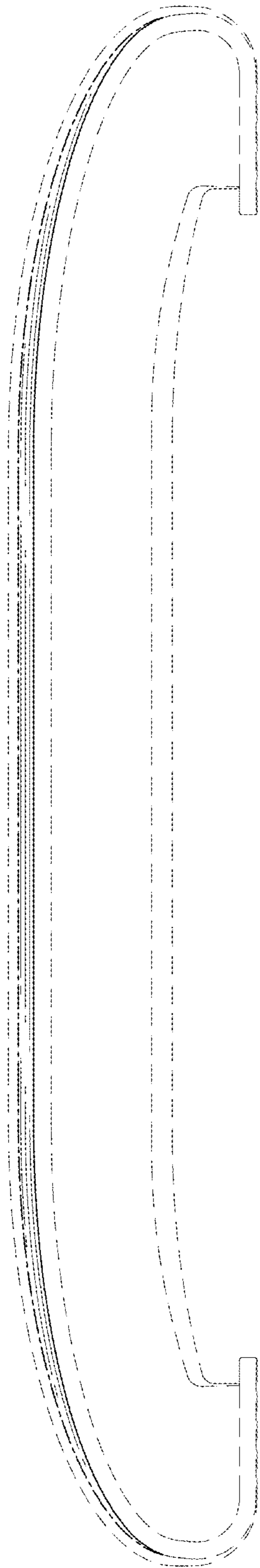

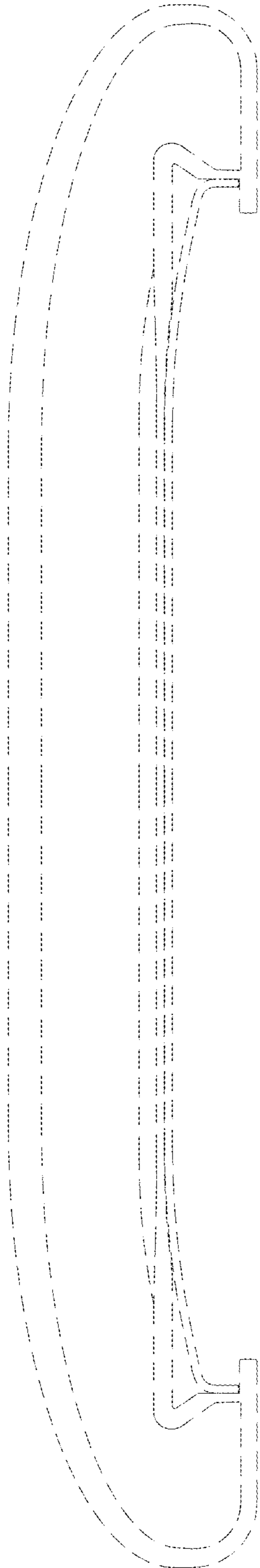

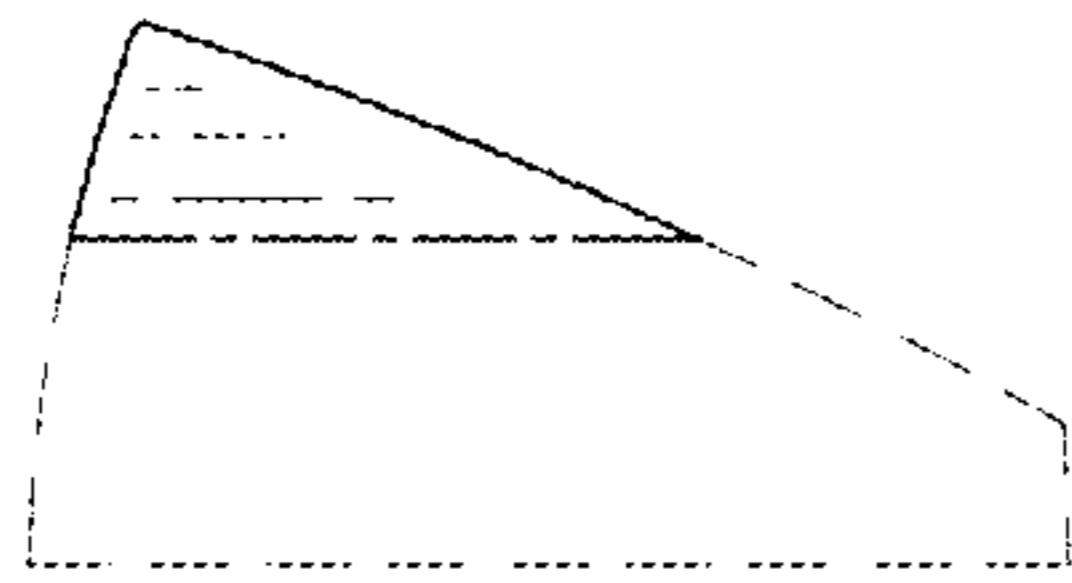

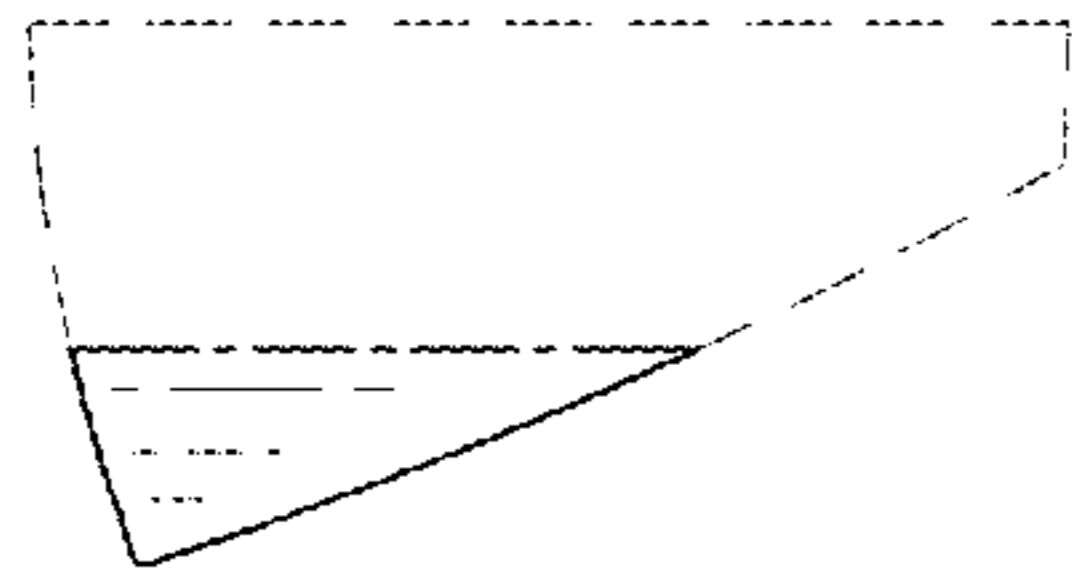

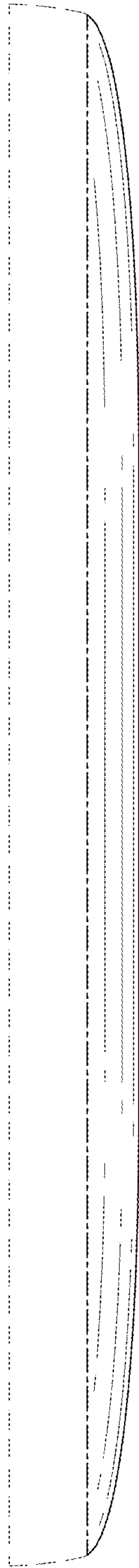

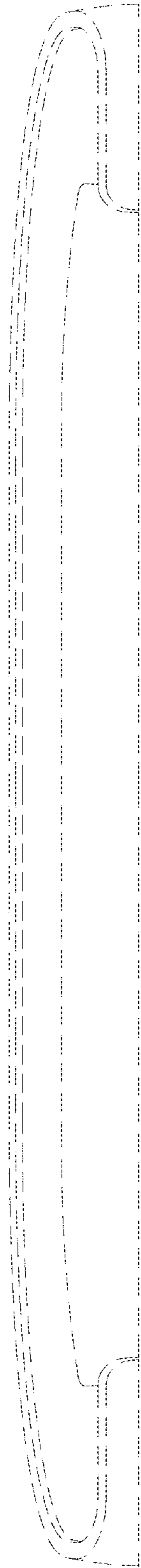
