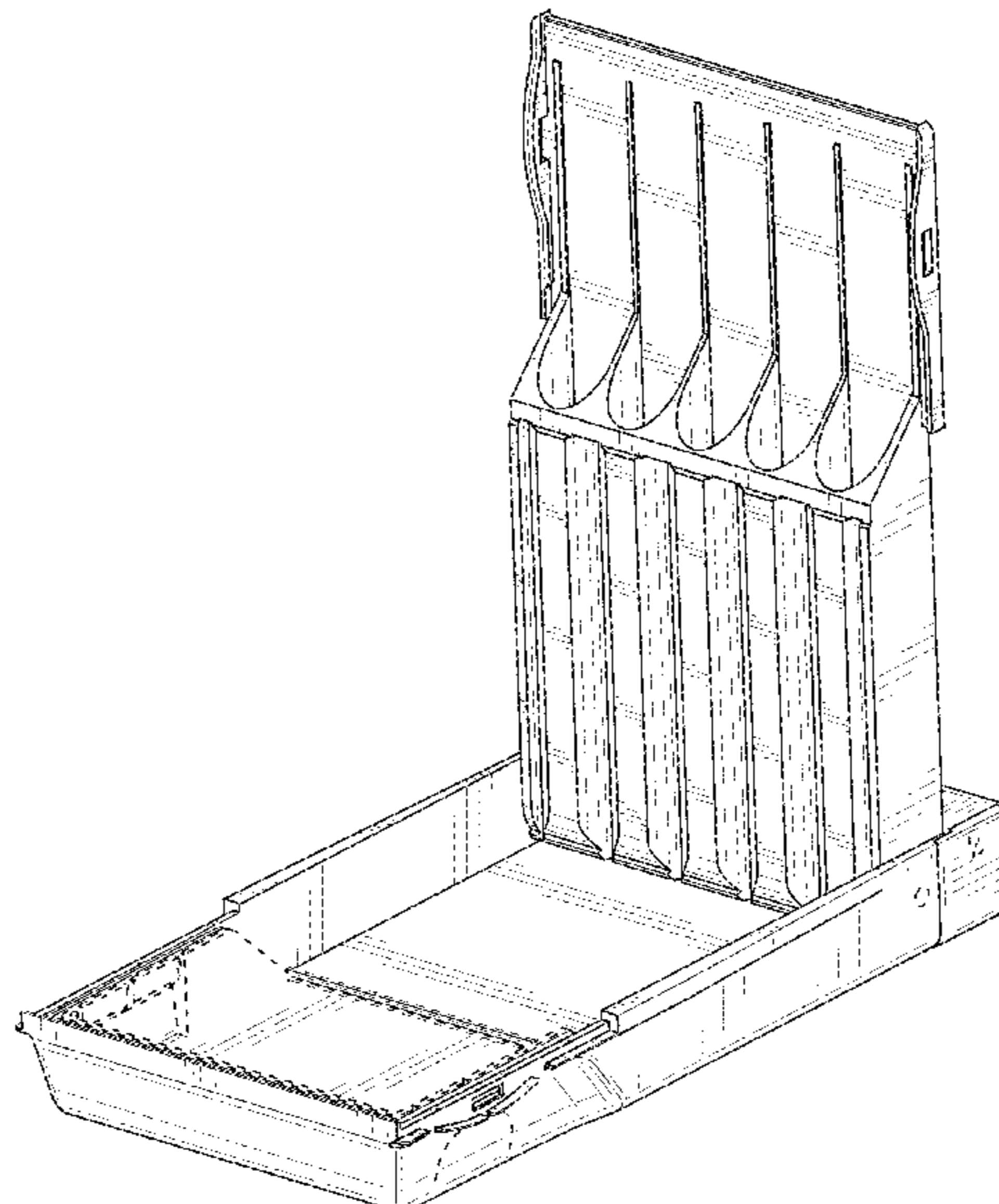
(57) **CLAIM**

The ornamental design for a case for cigarette products, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a case for cigarette products in the open position,
FIG. 2 is a front elevational view of the case in the open position;
FIG. 3 is a rear elevational view of the case in the open position;
FIG. 4 is a left side elevational view of the case in the open position;
FIG. 5 is a right side elevational view of the case in the open position;
FIG. 6 is a top plan view of the case in the open position;
FIG. 7 is a bottom plan view of the case in the open position;
FIG. 8 is a front perspective view of a case for tobacco products in the closed position,
FIG. 9 is a front elevational view of the case in the closed position;
FIG. 10 is a rear elevational view of the case in the closed position;
FIG. 11 is a left side elevational view of the case in the closed position;
FIG. 12 is a right side elevational view of the case in the closed position;
FIG. 13 is a top plan view of the case in the closed position;

FIG. 14 is a bottom plan view of the case in the closed position.

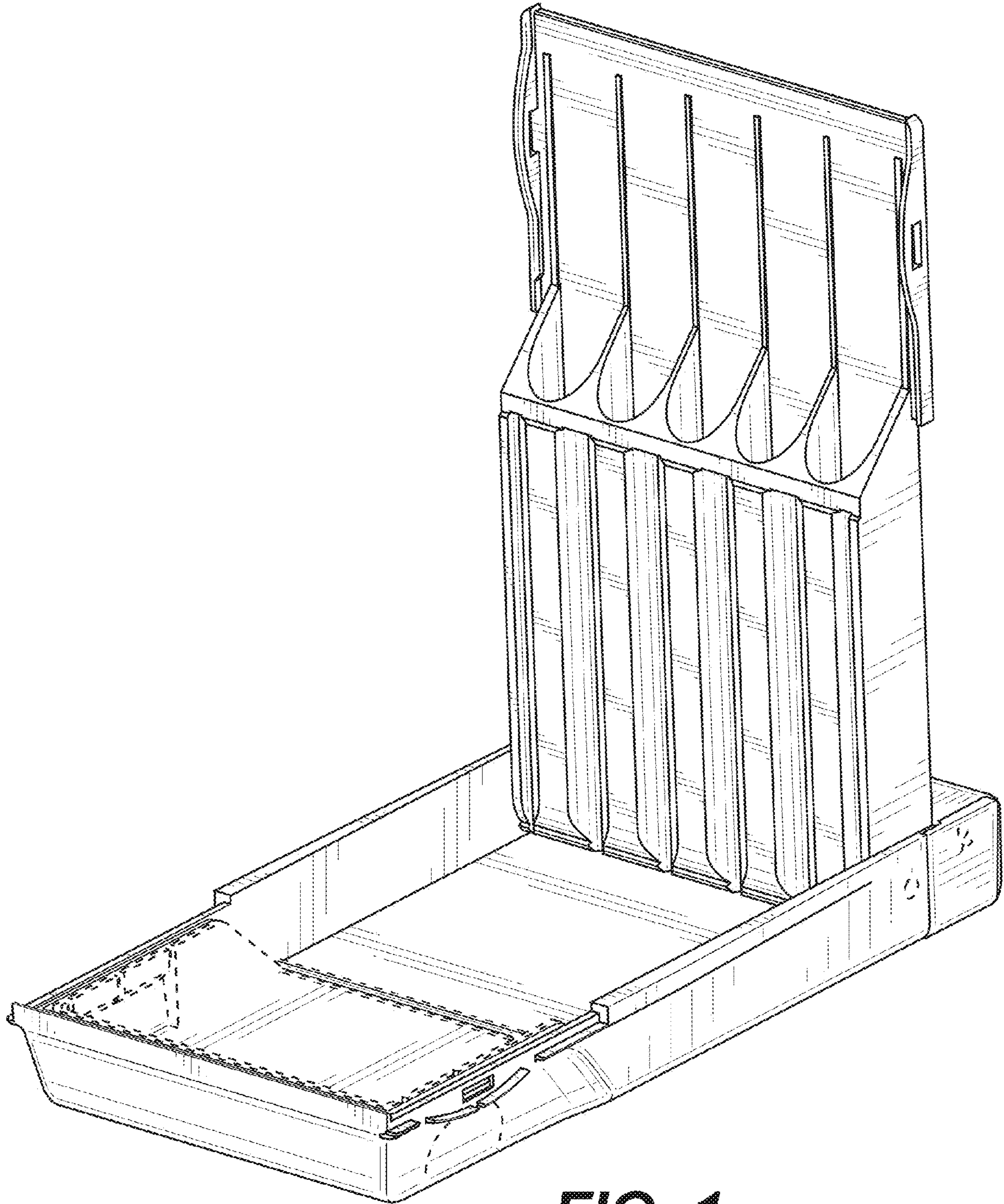

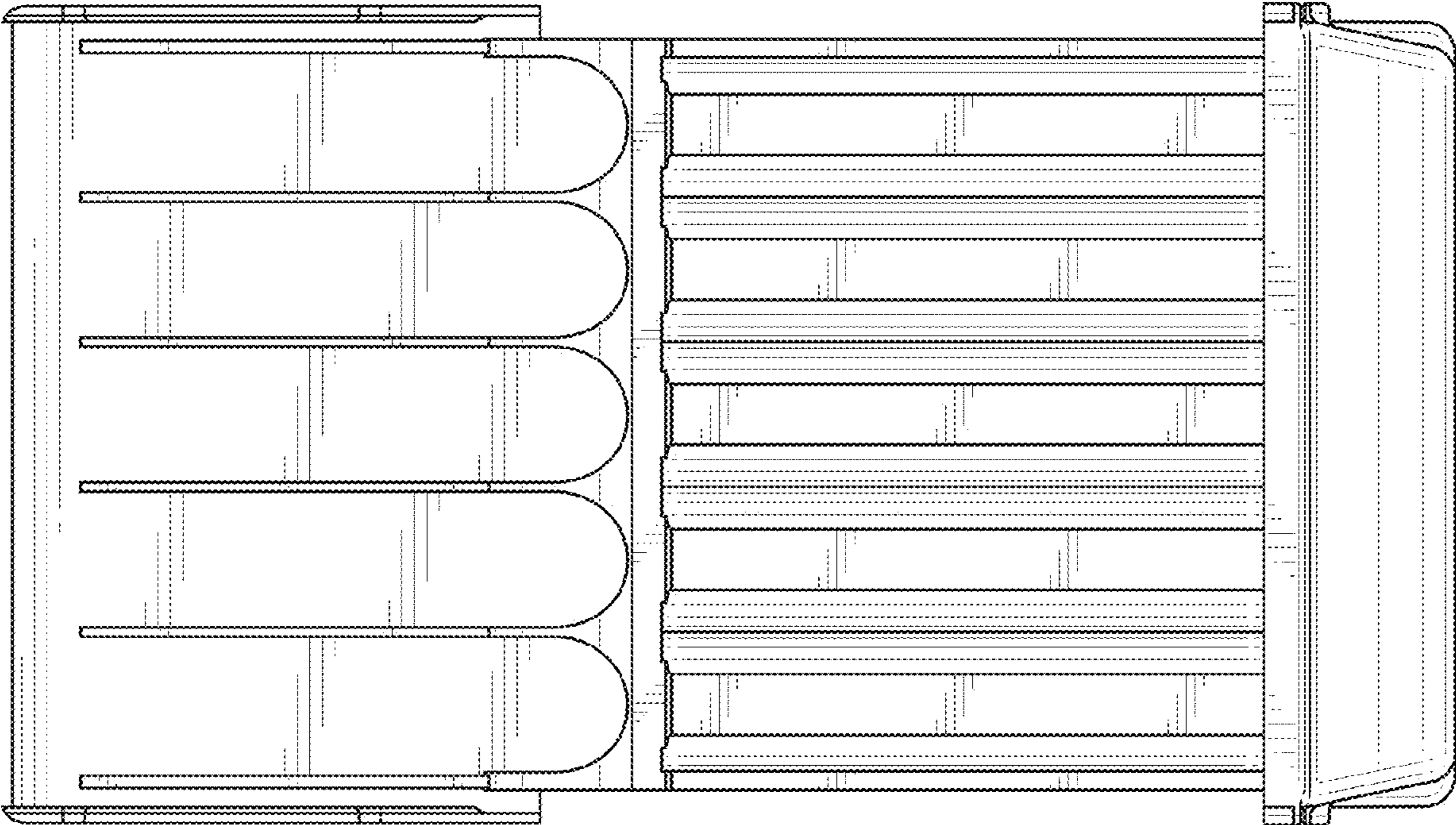

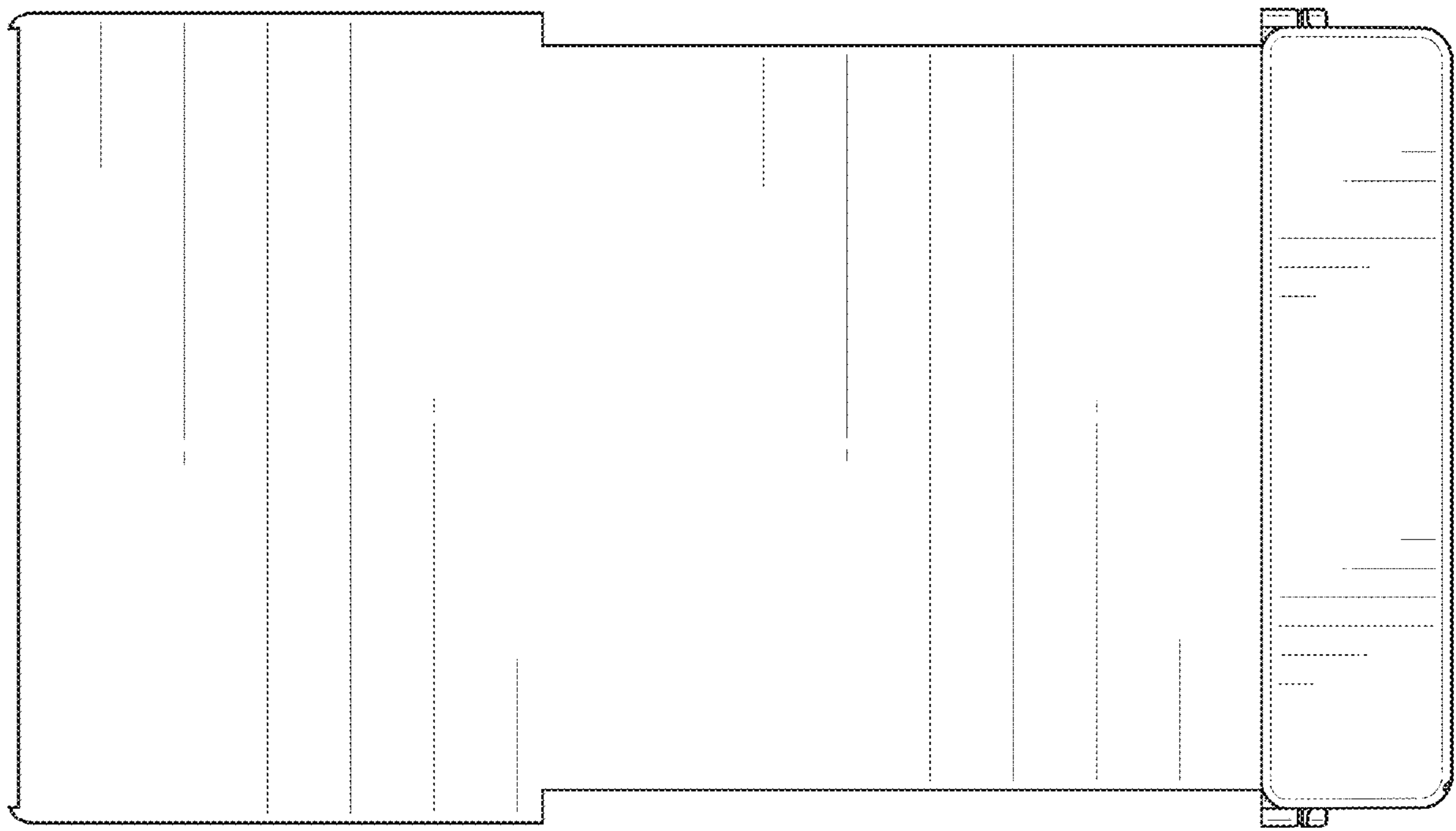
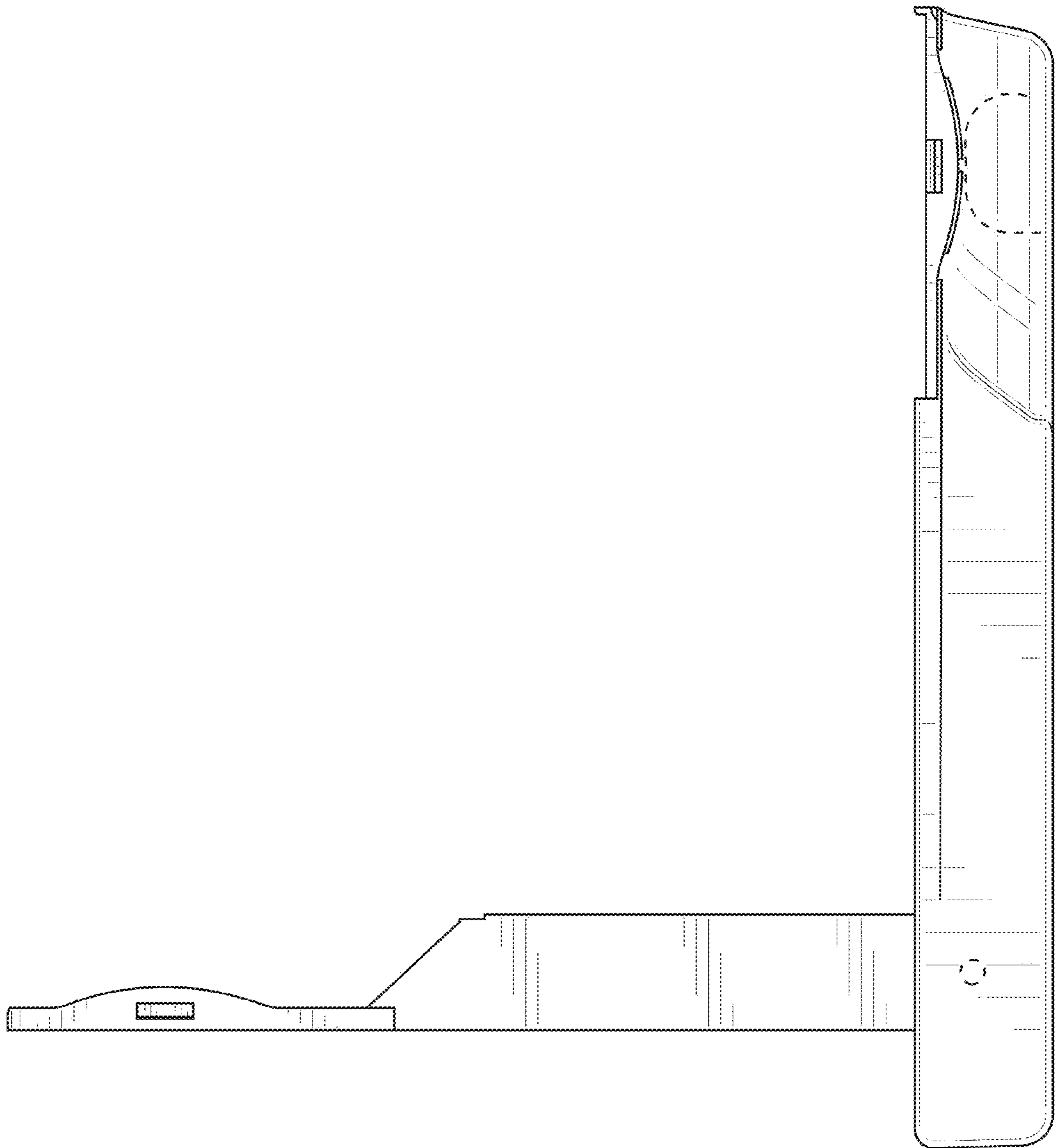

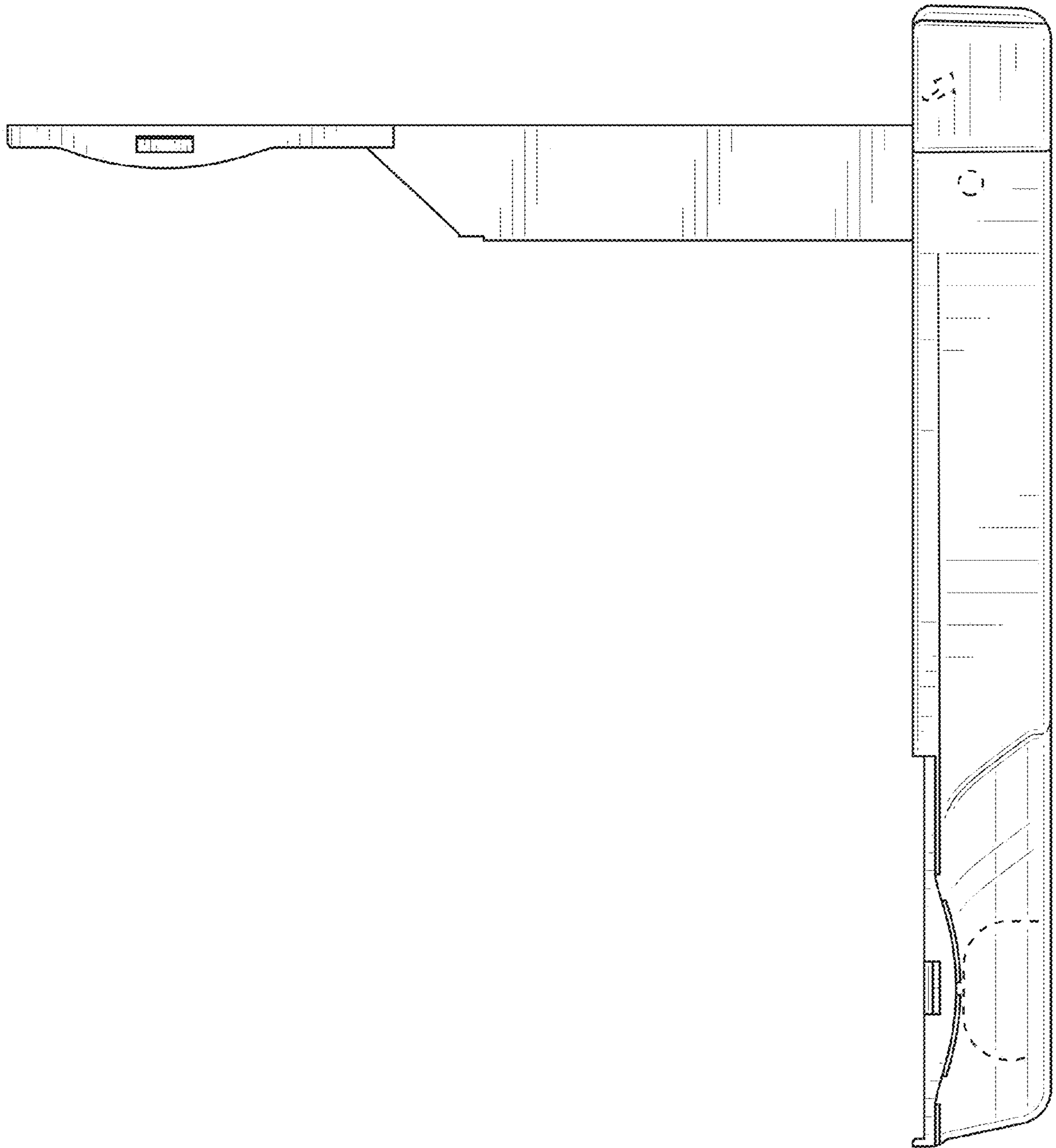

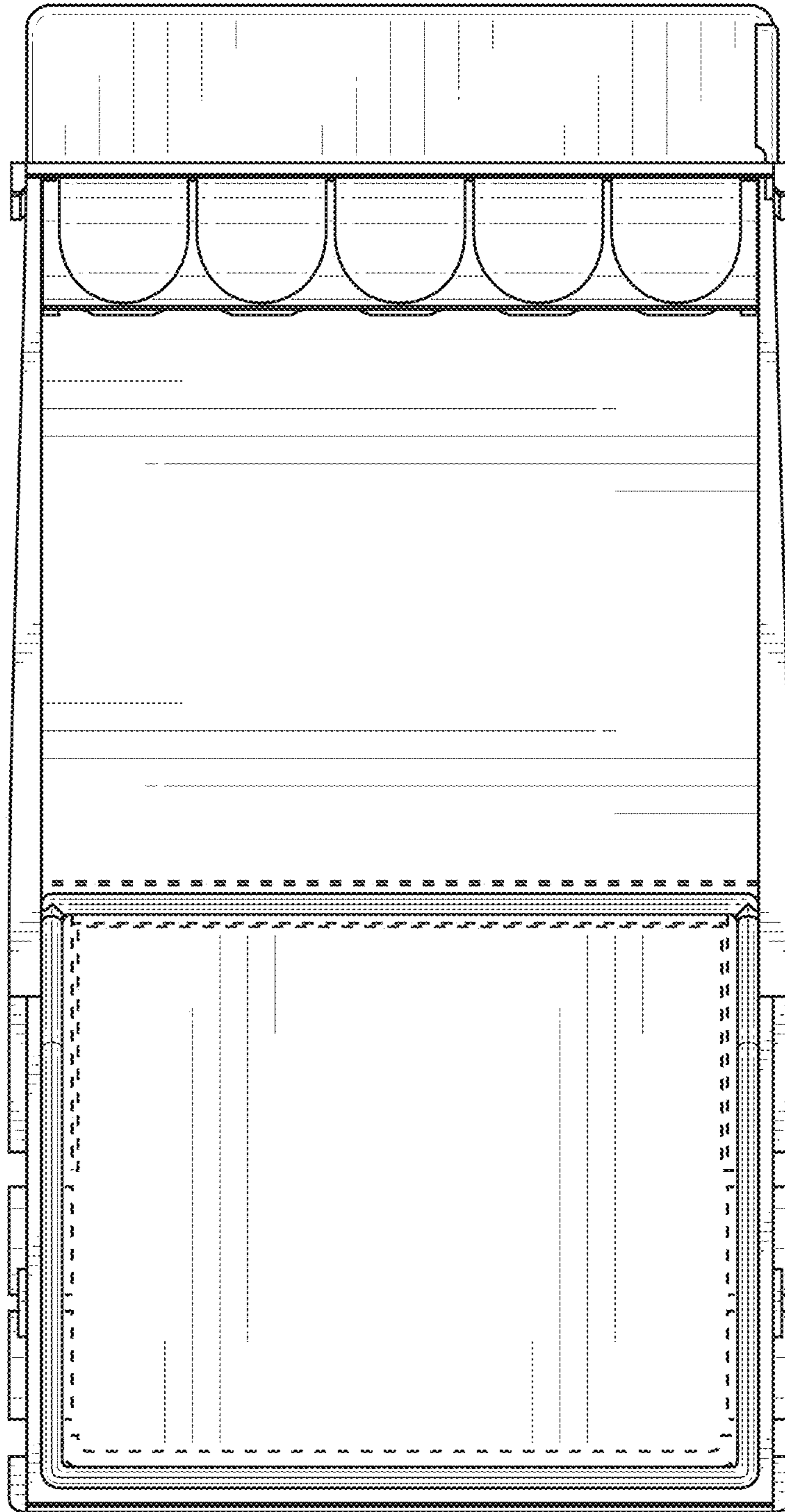

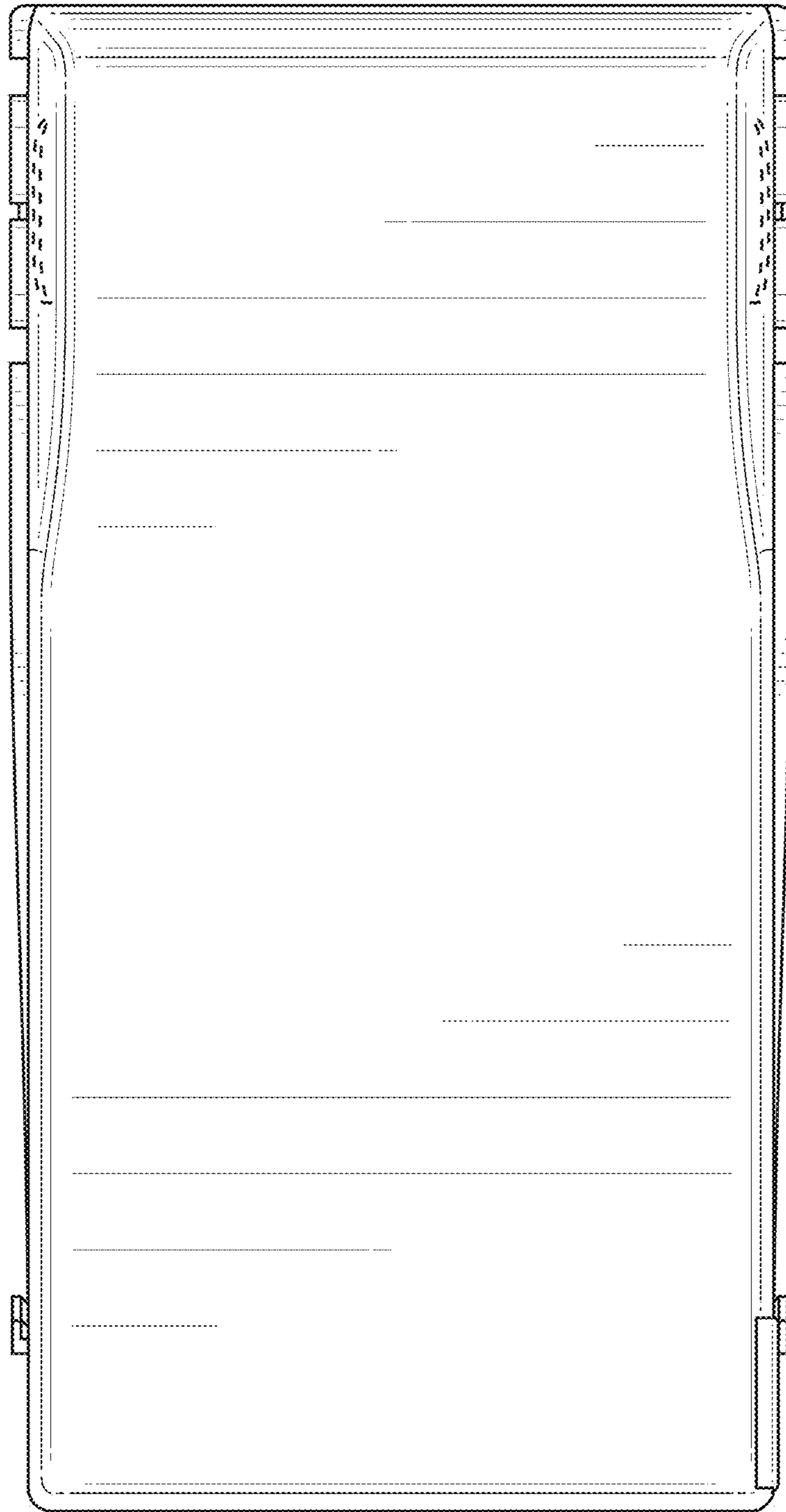

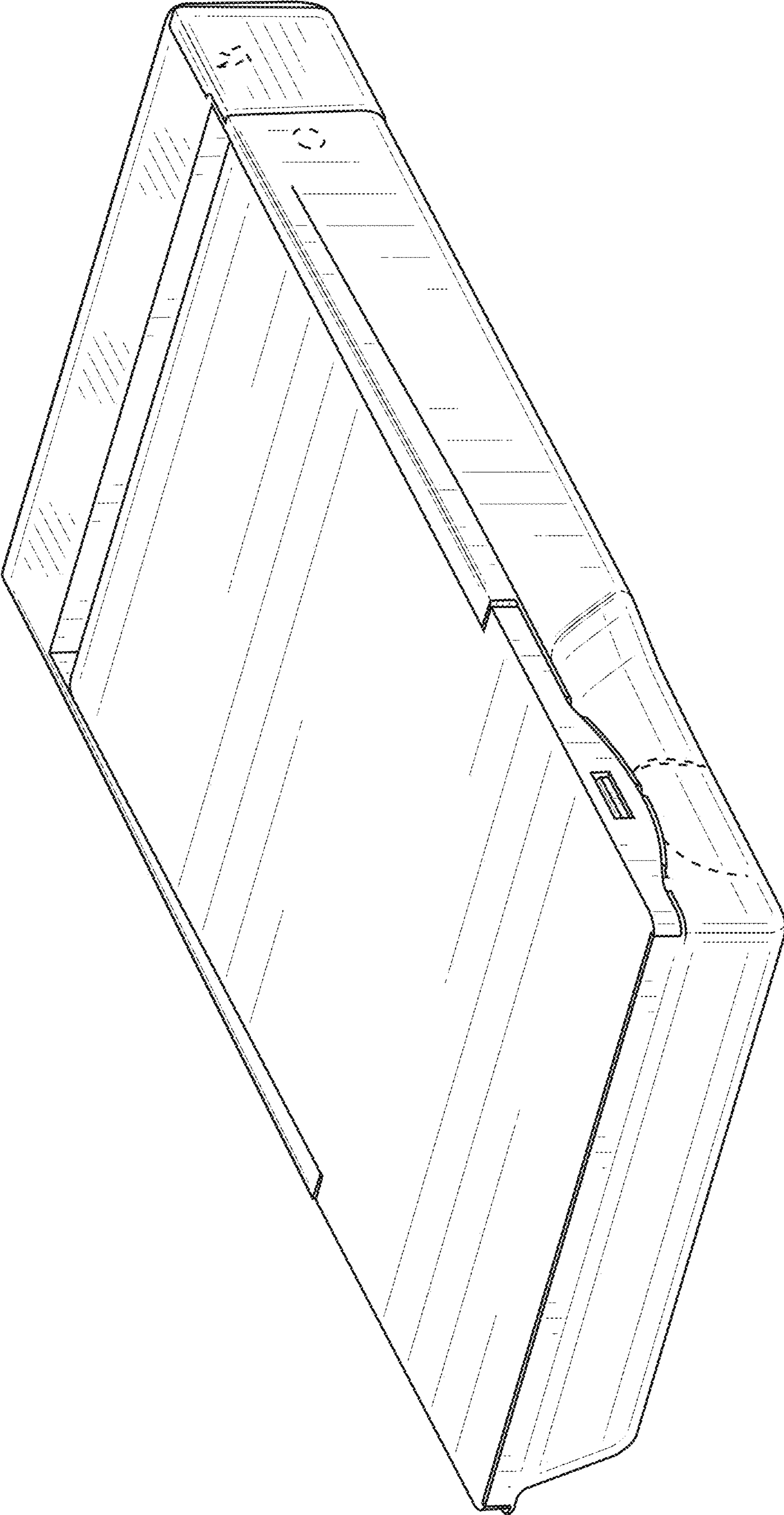

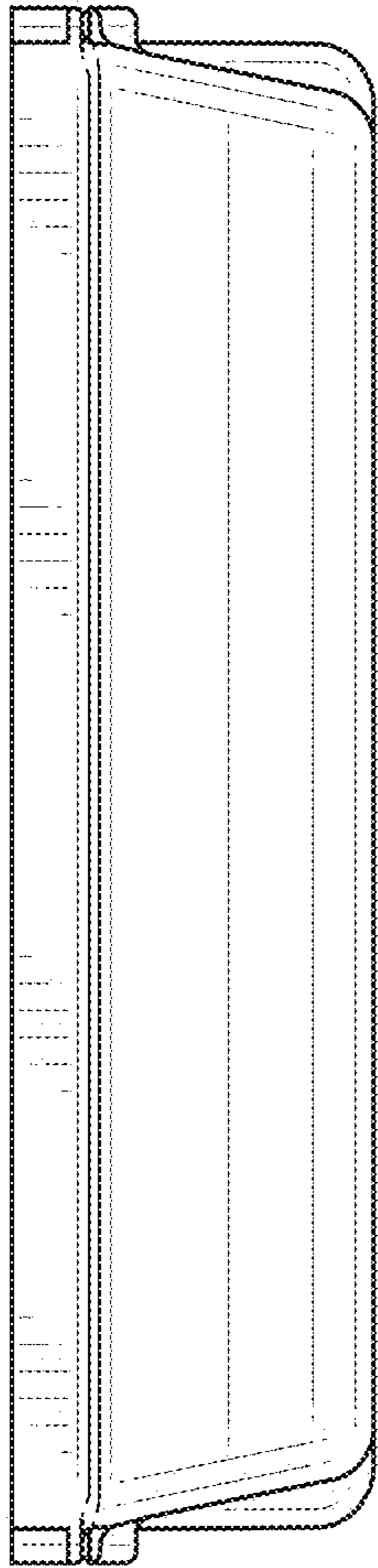

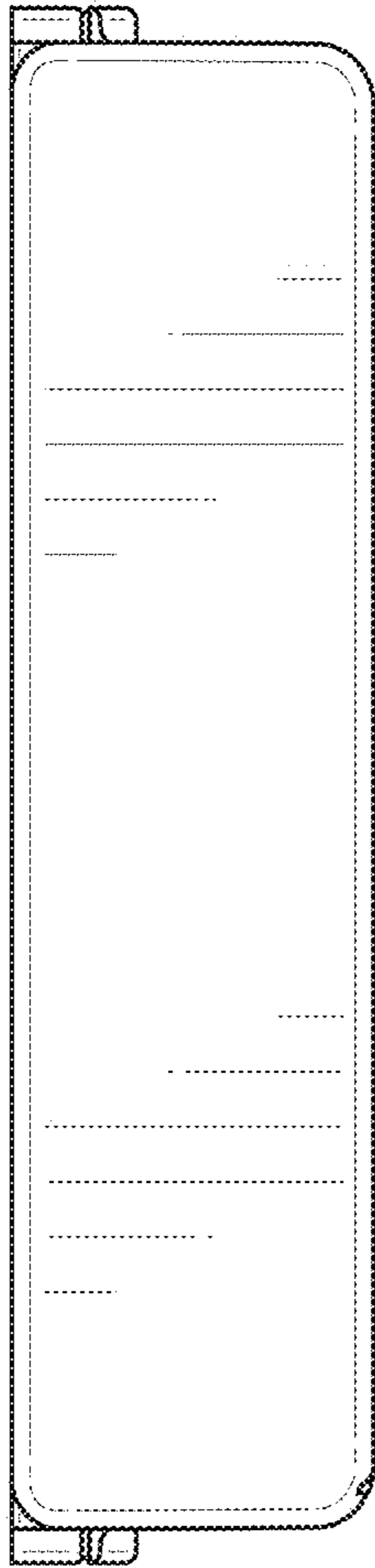

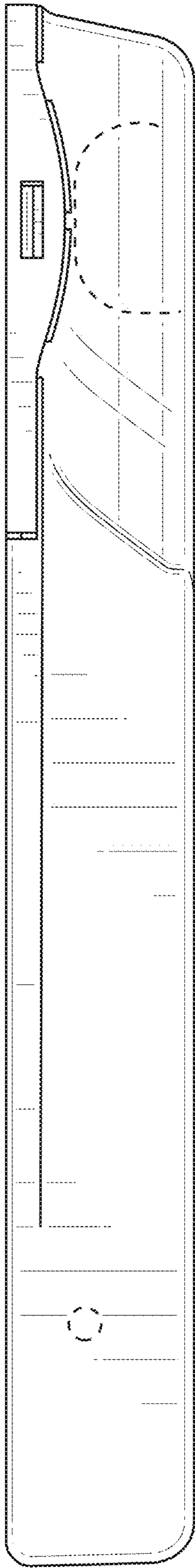

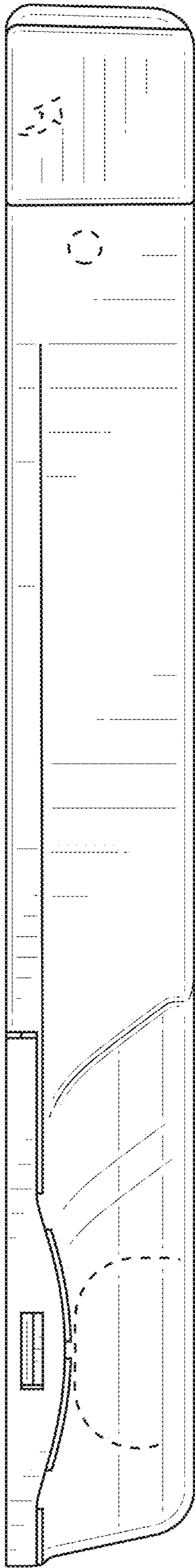

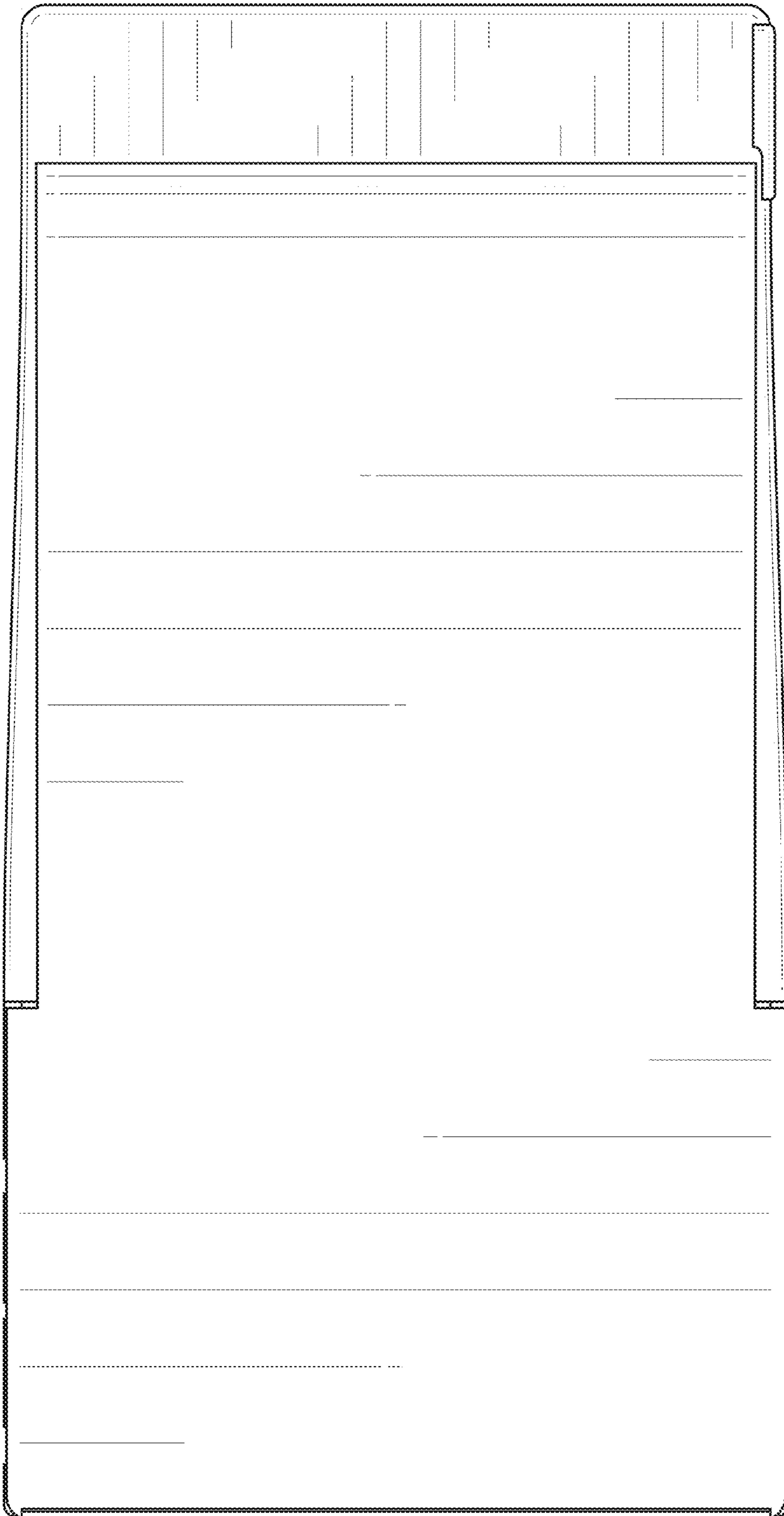

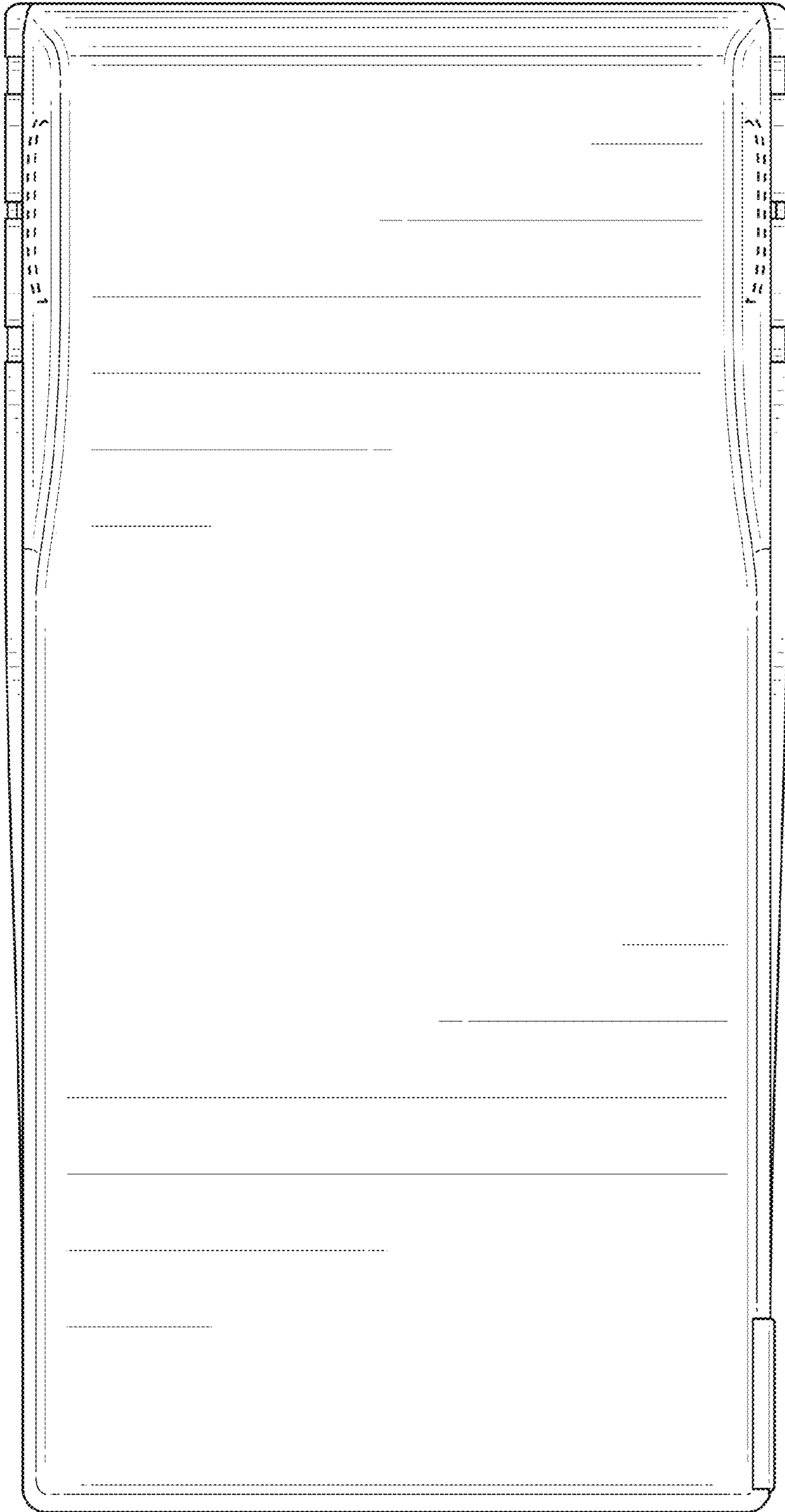
