The ornamental design for a shaver, as shown and described.

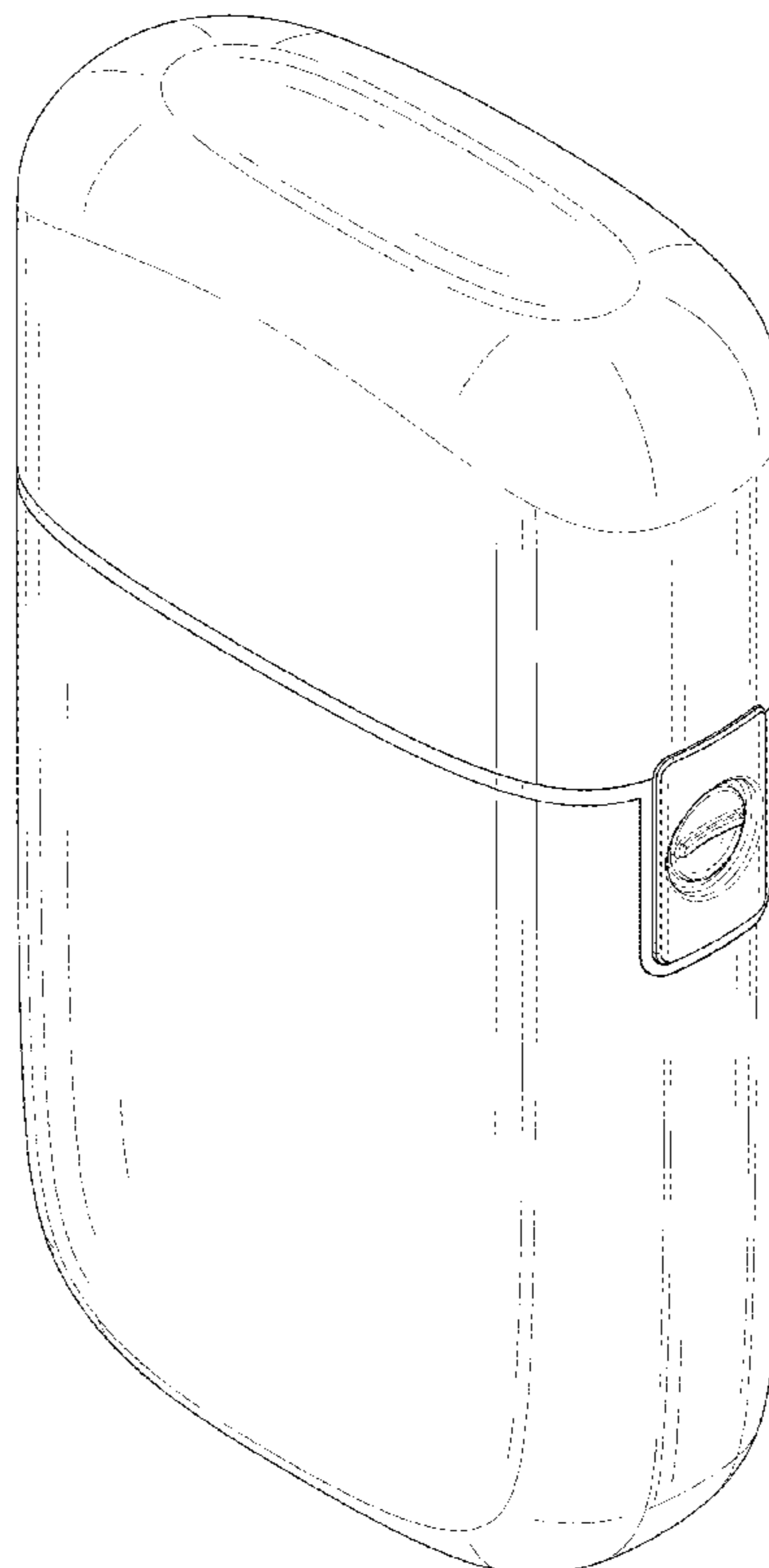
DESCRIPTION

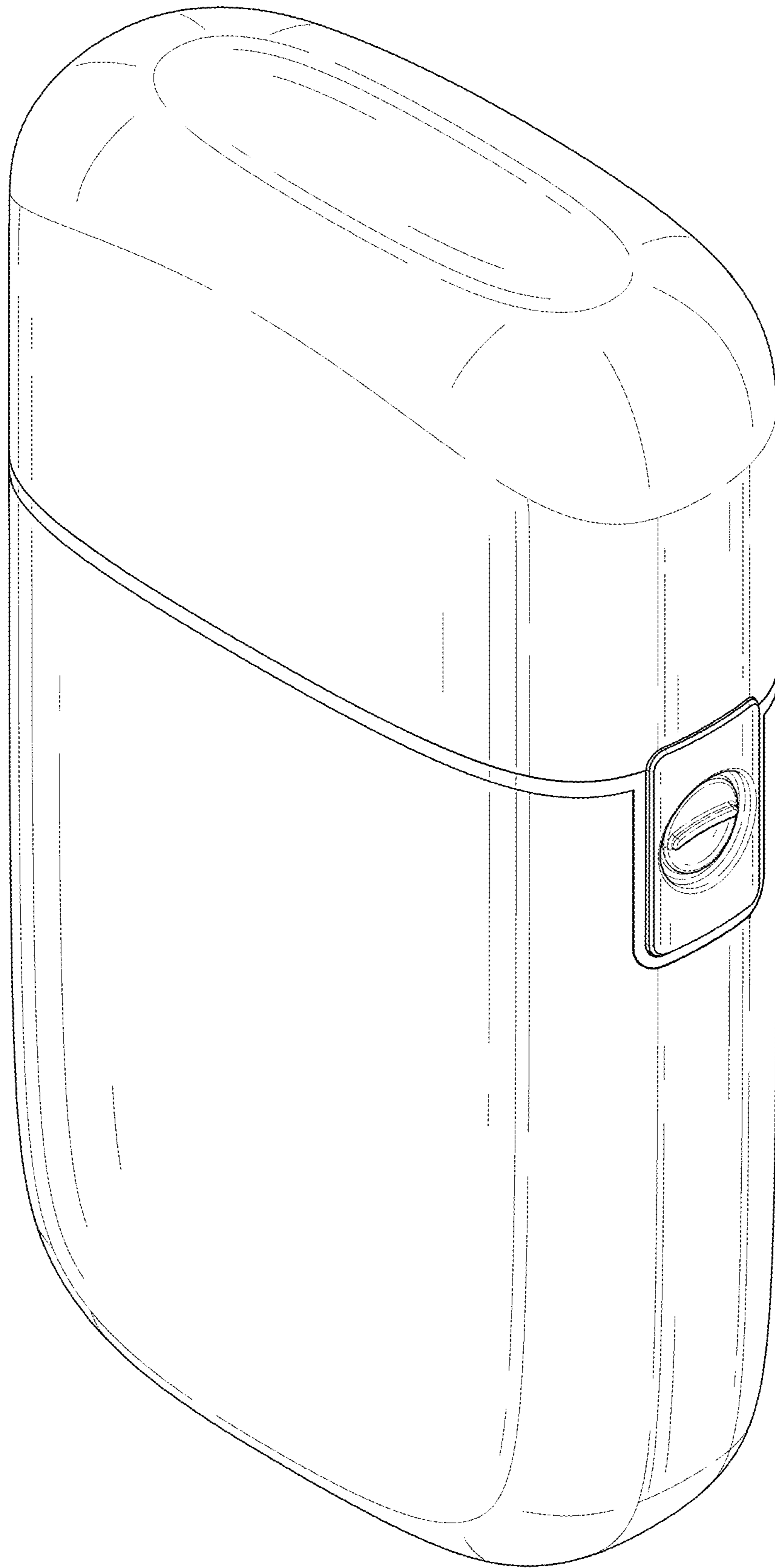

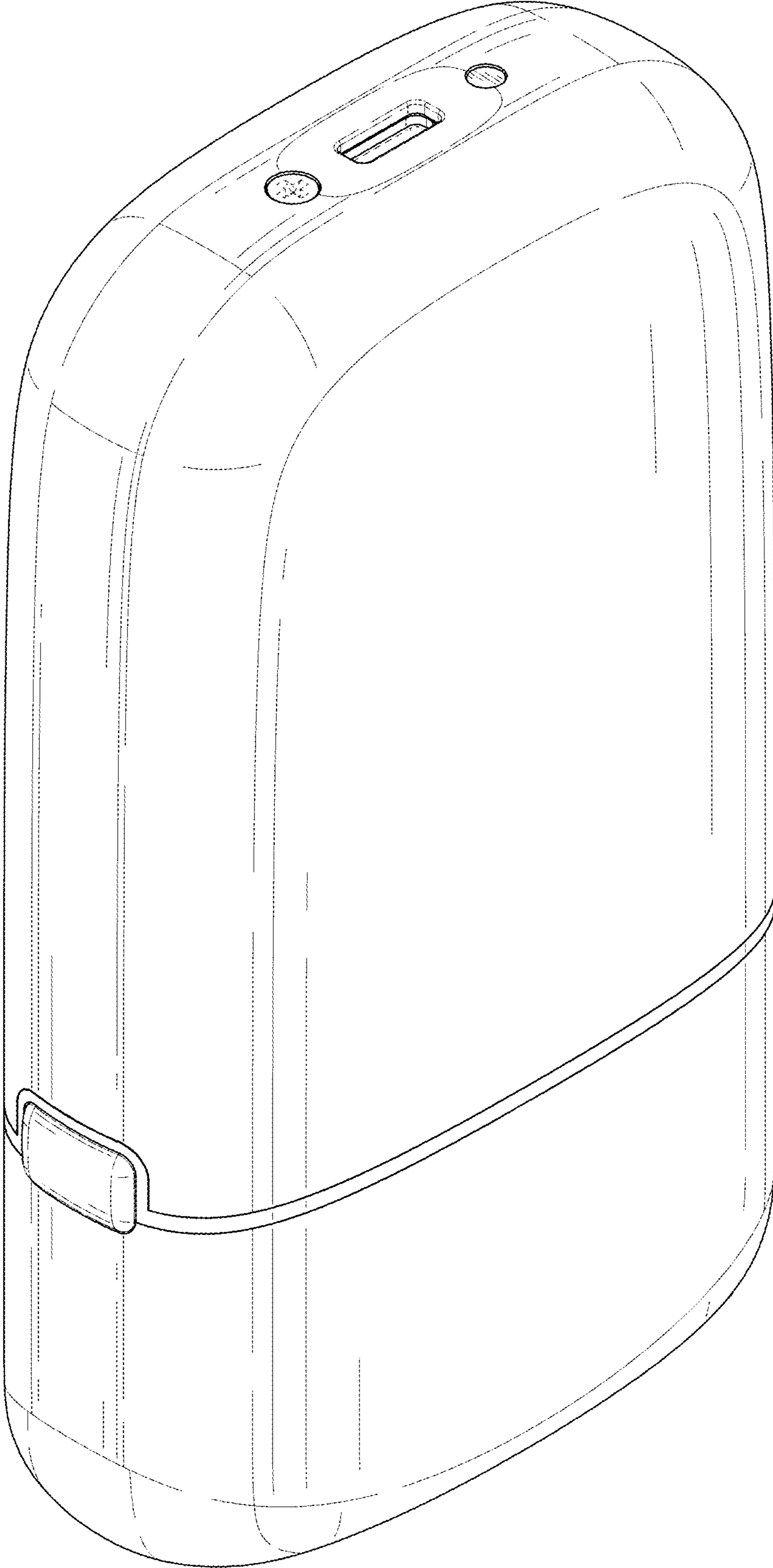

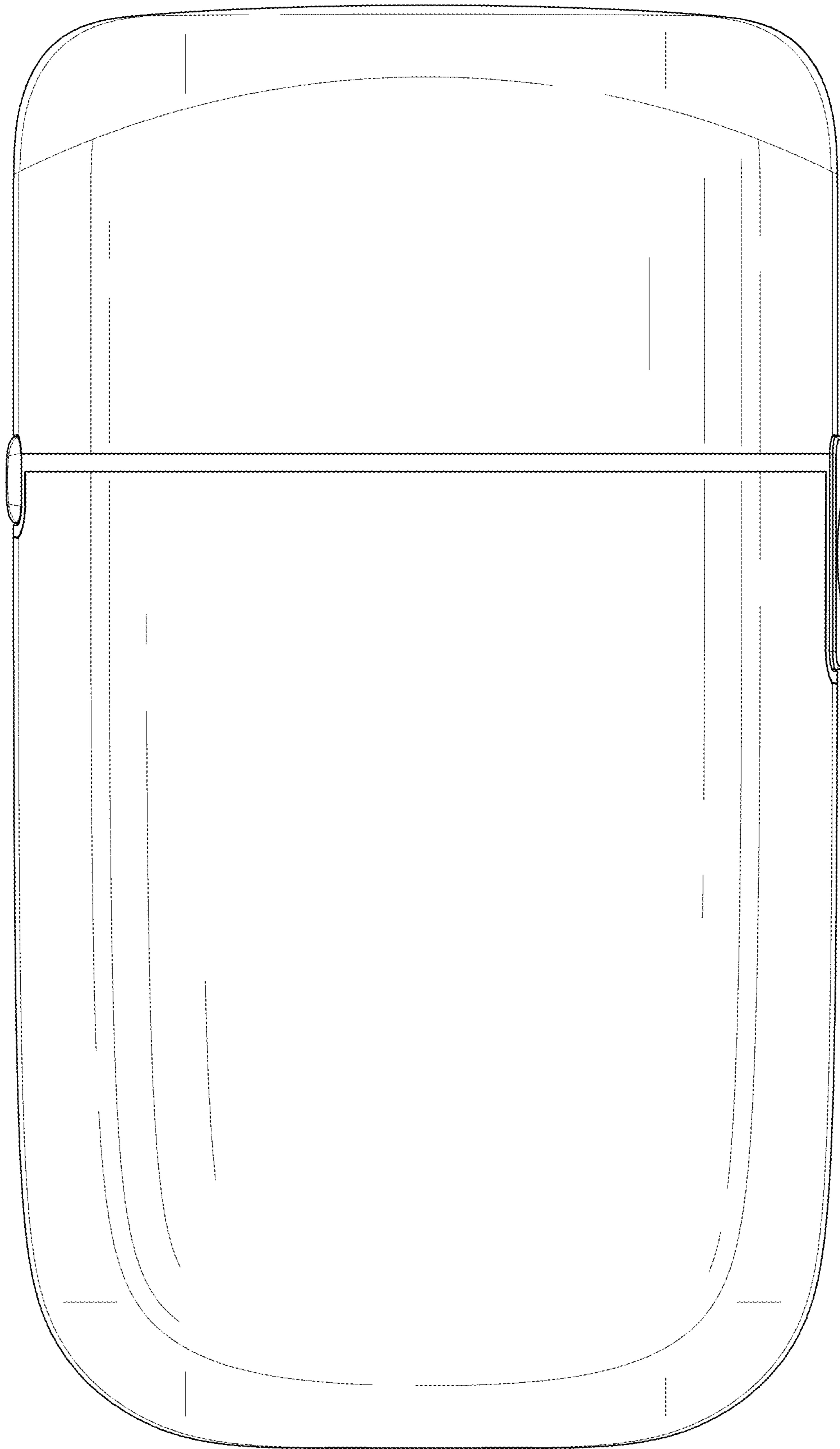

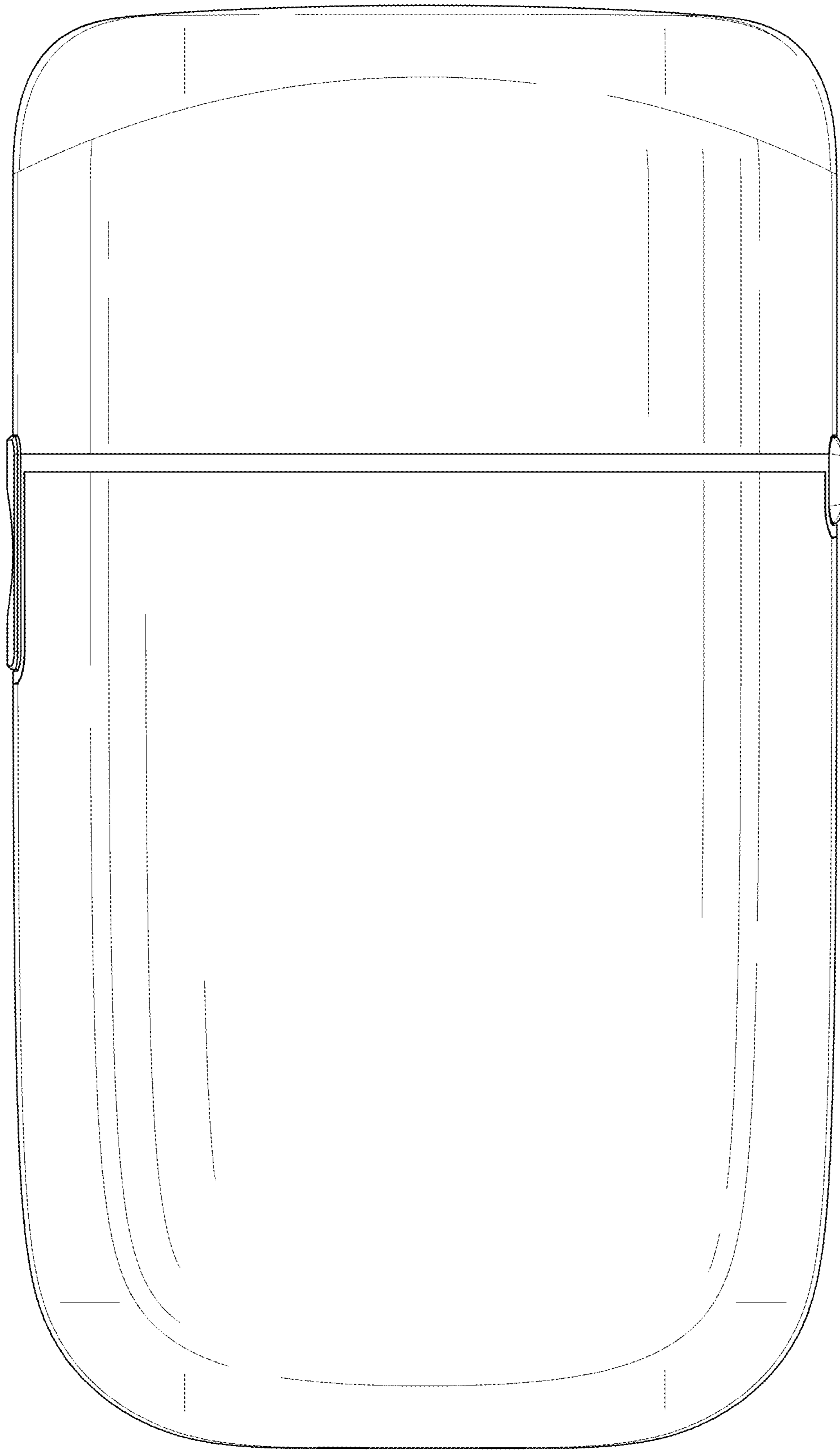

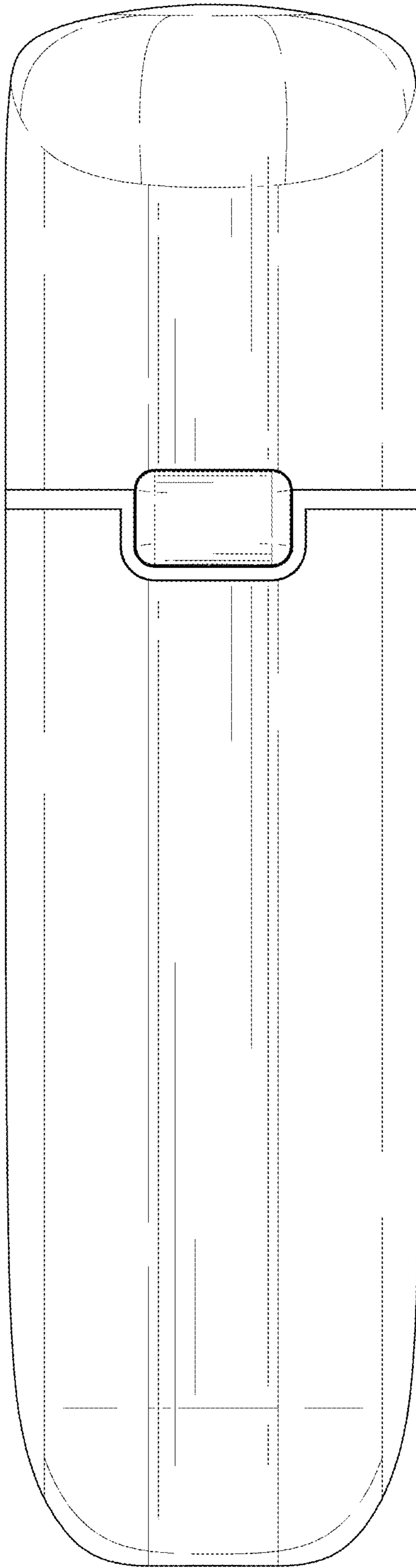

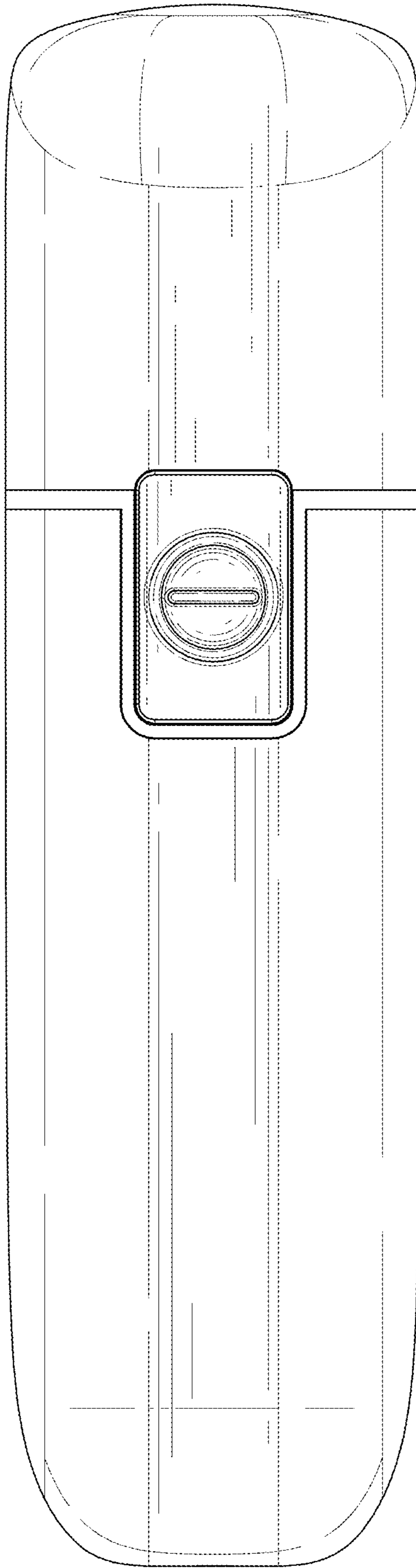

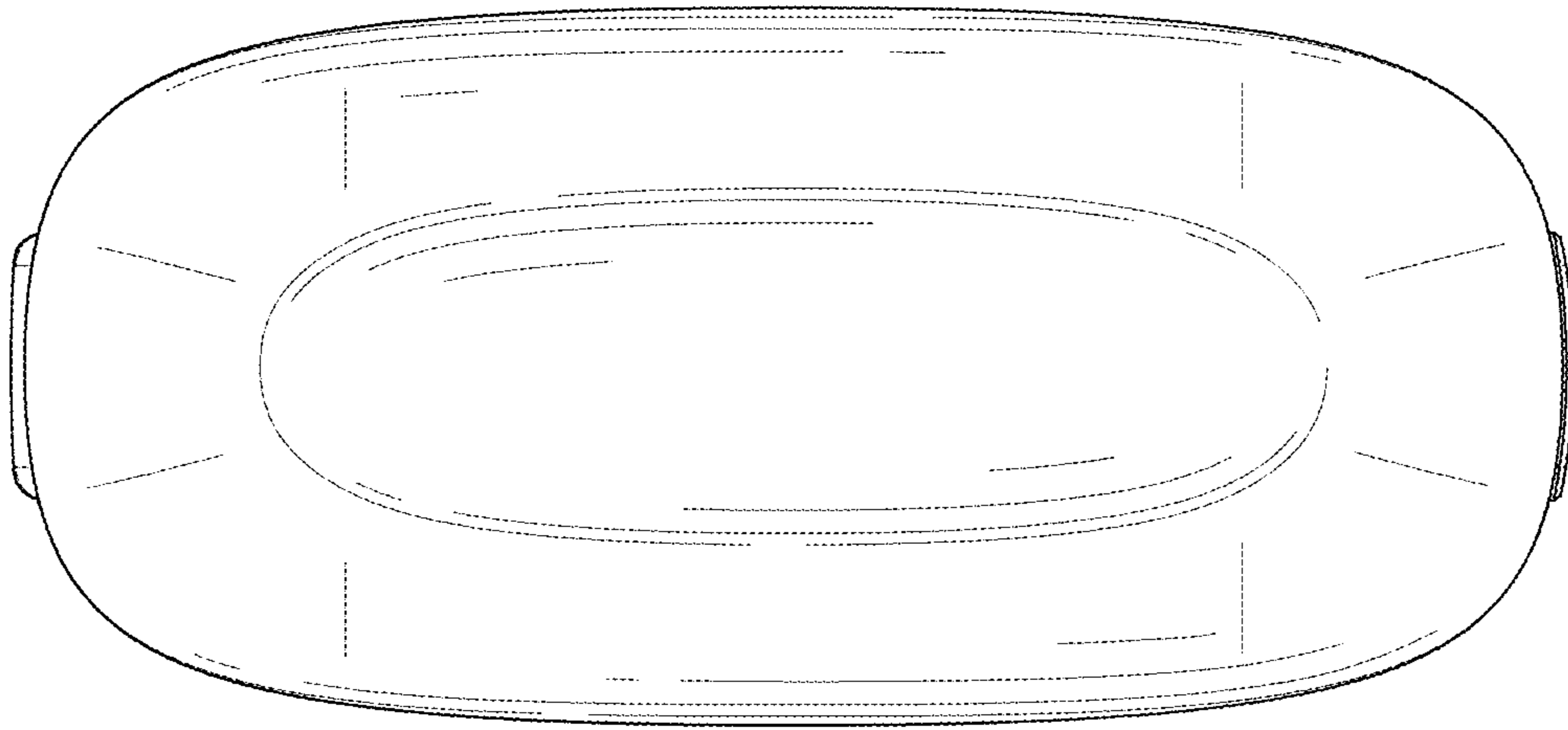

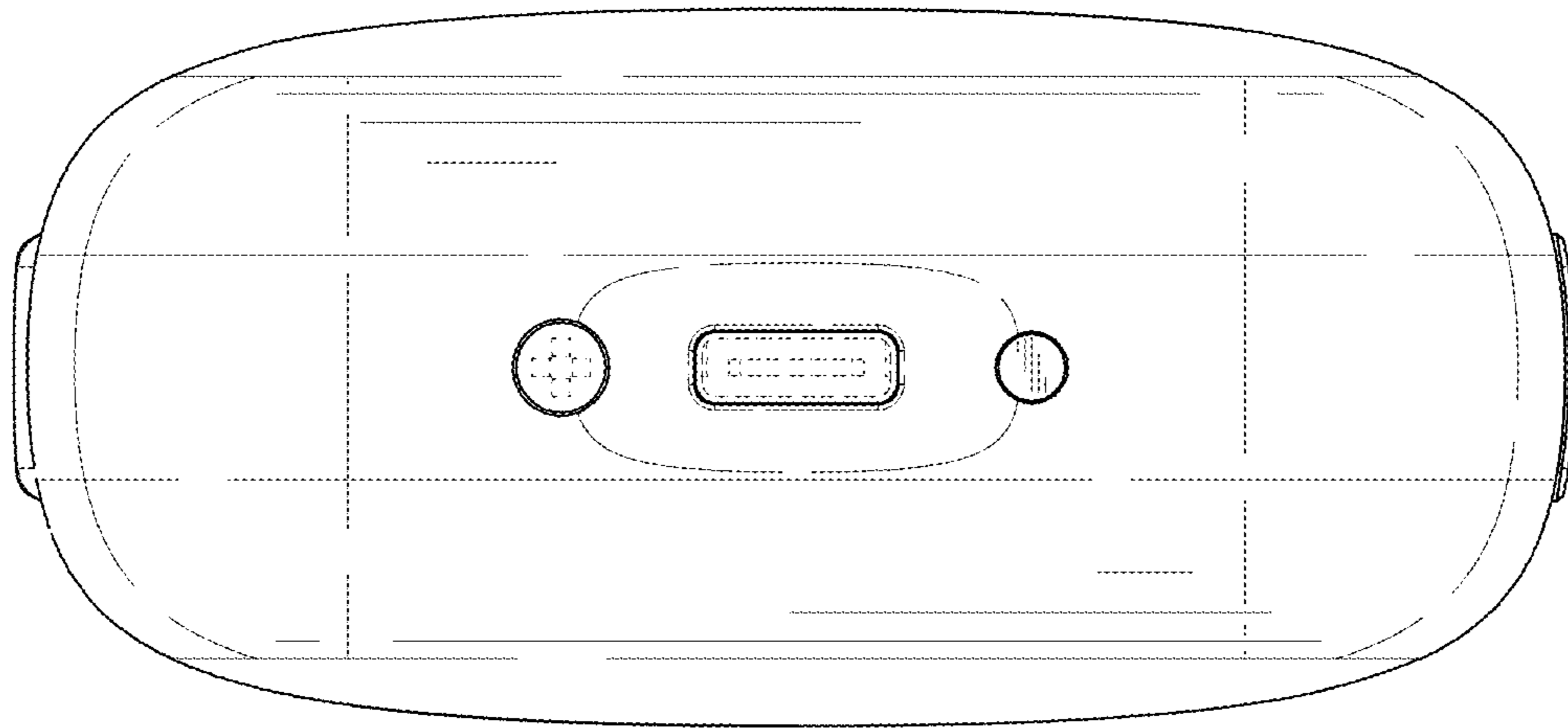
