(57) **CLAIM**

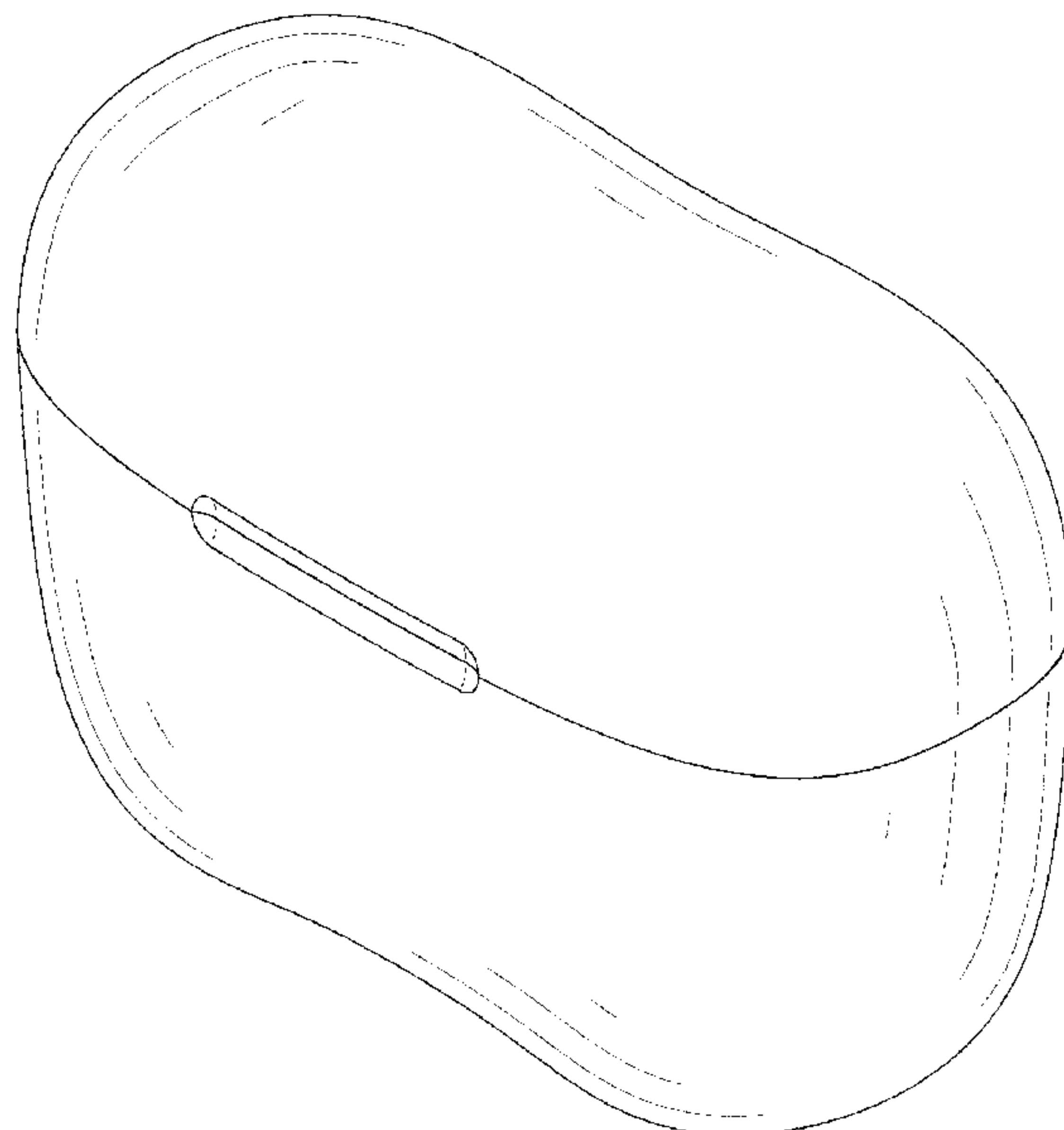
The ornamental design for an earphone case, as shown and described.

DESCRIPTION

FIG. 1 is a front and top perspective view of an earphone case, showing my new design;
FIG. 2 is a rear and bottom perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom plan view thereof; and,
FIG. 9 is a perspective view thereof, showing the earphone case in an open position.

The broken lines in the figures illustrate portions of the earphone case that form no part of the claimed design. The broken lines showing of a pair of earphones in FIG. 9 depict environmental structure and form no part, of the claimed design.

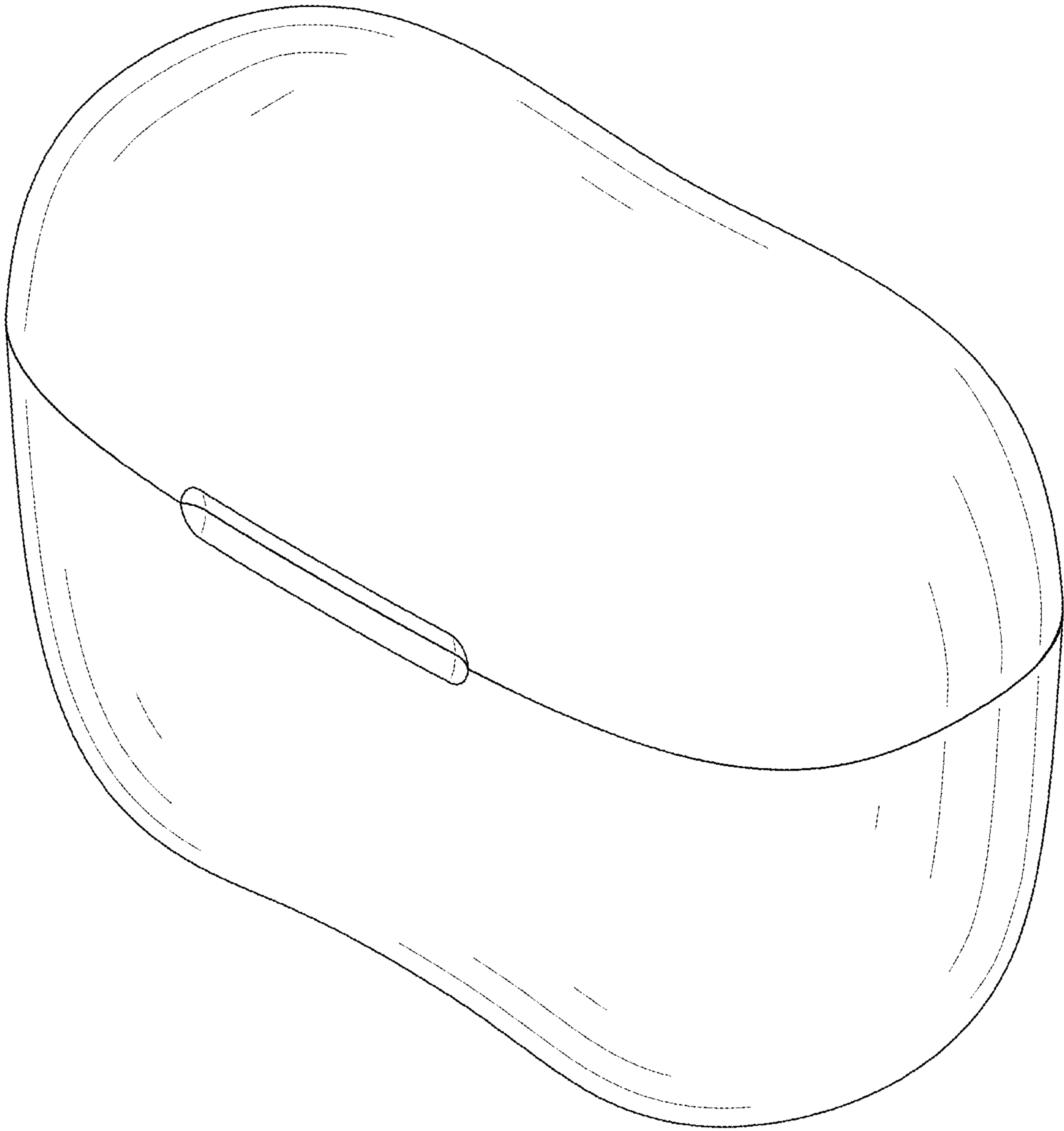

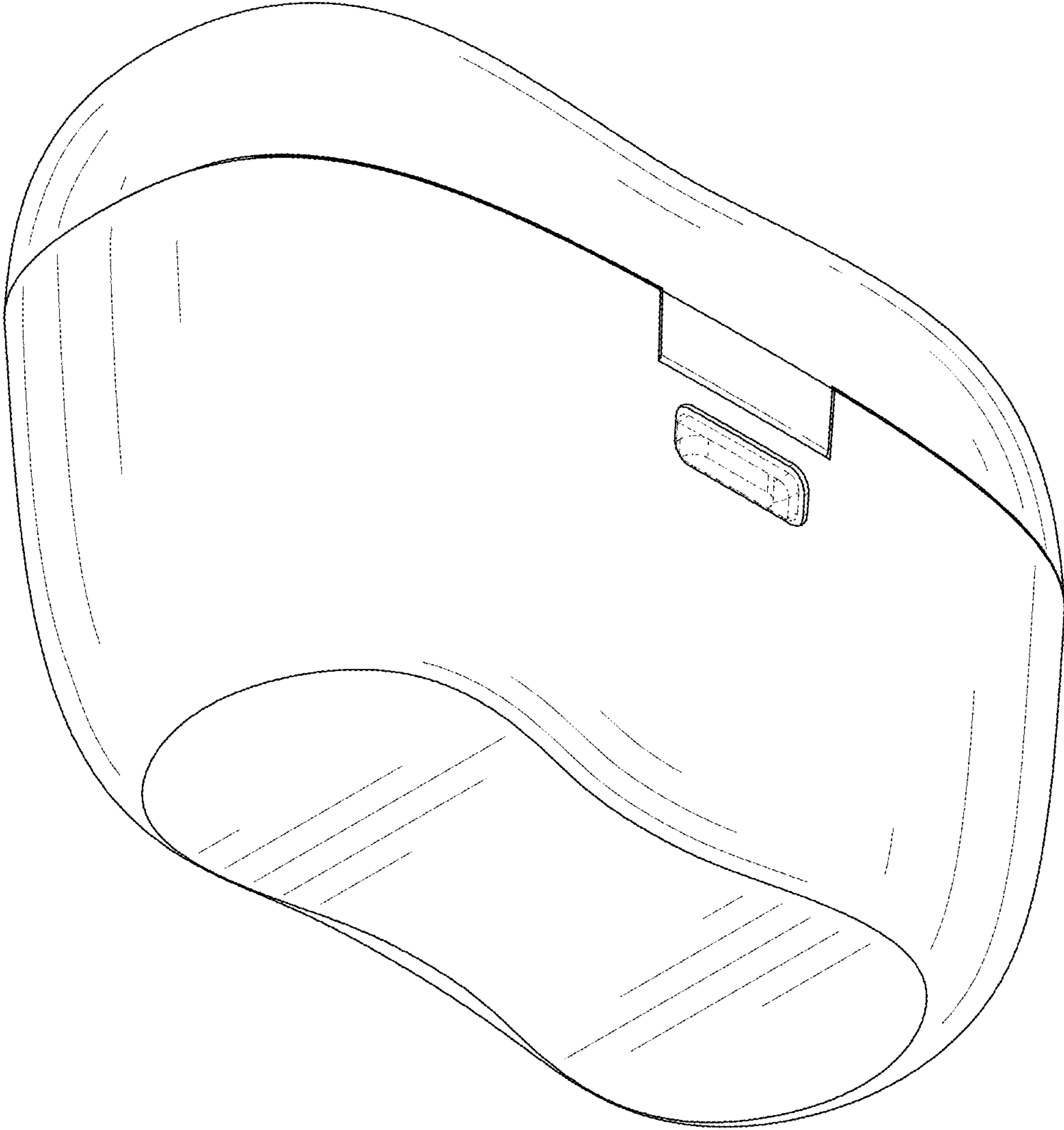

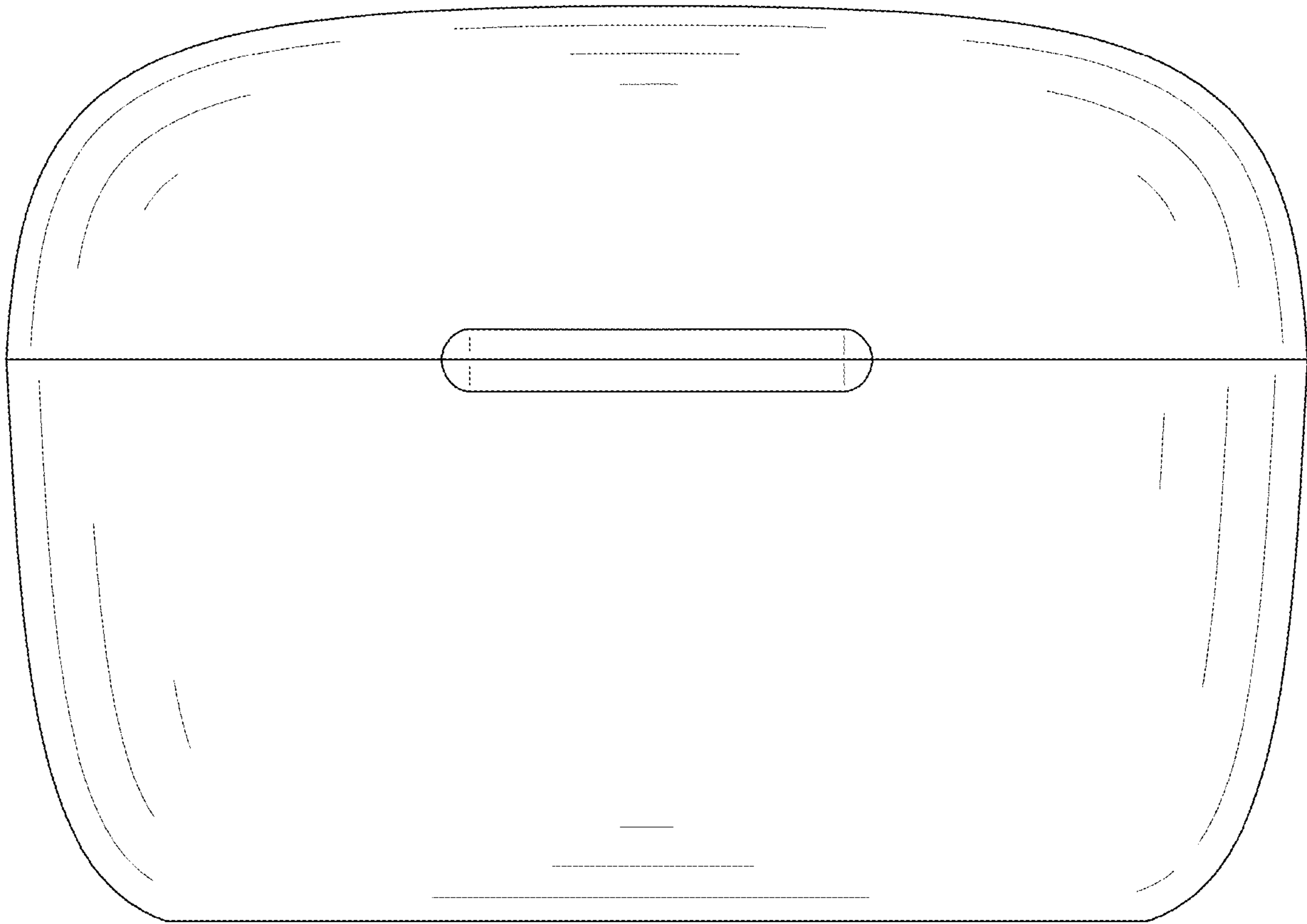

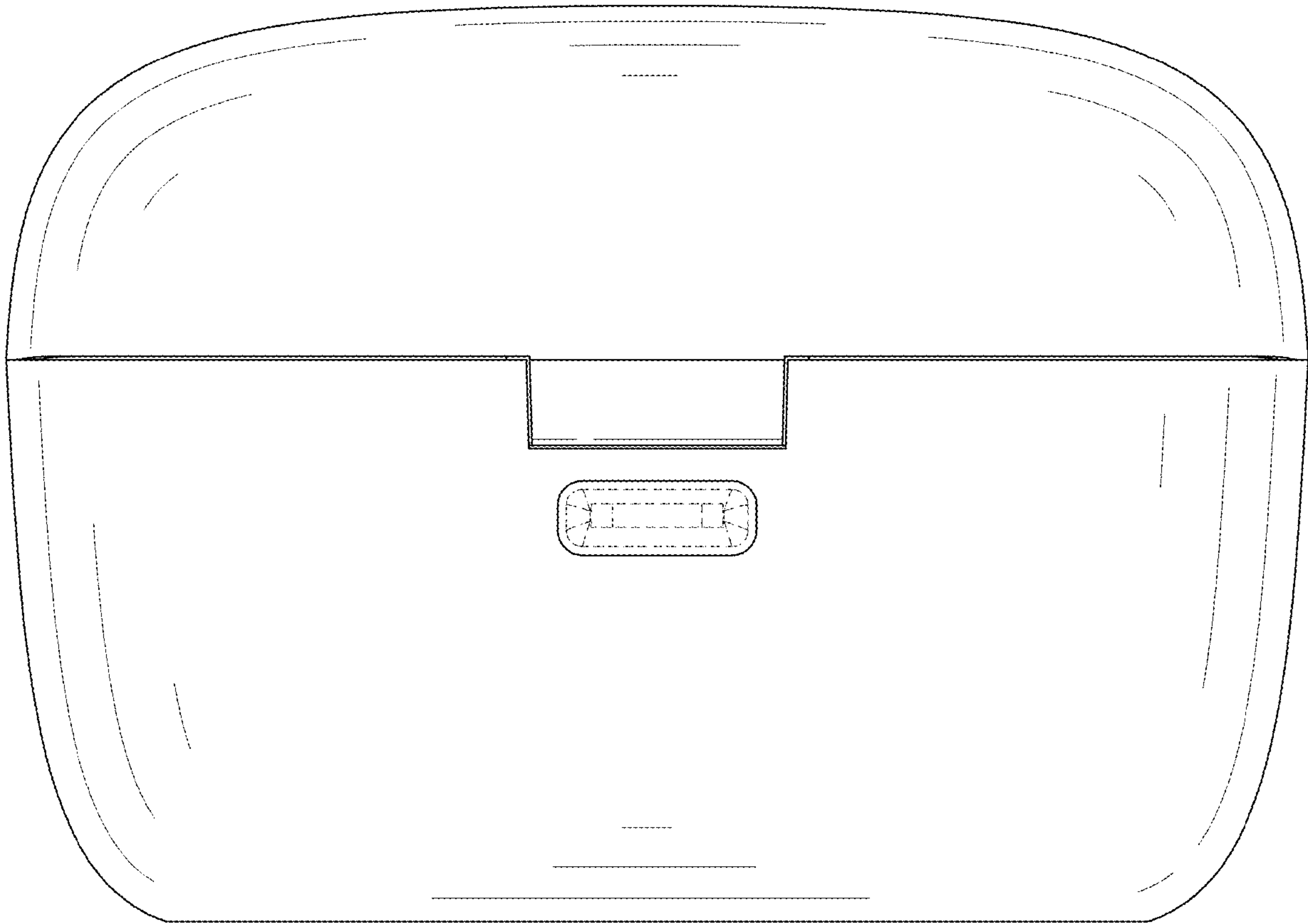

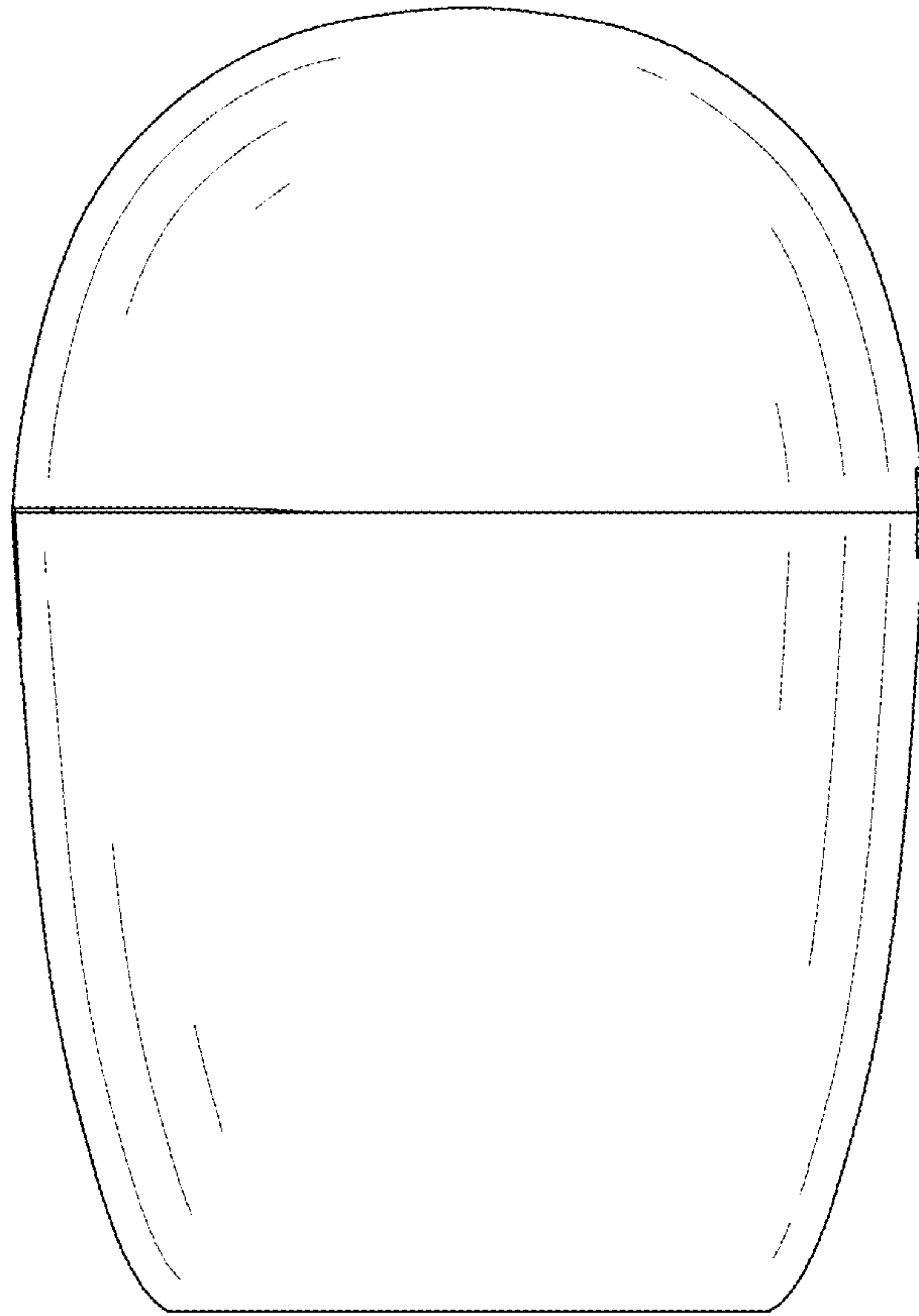

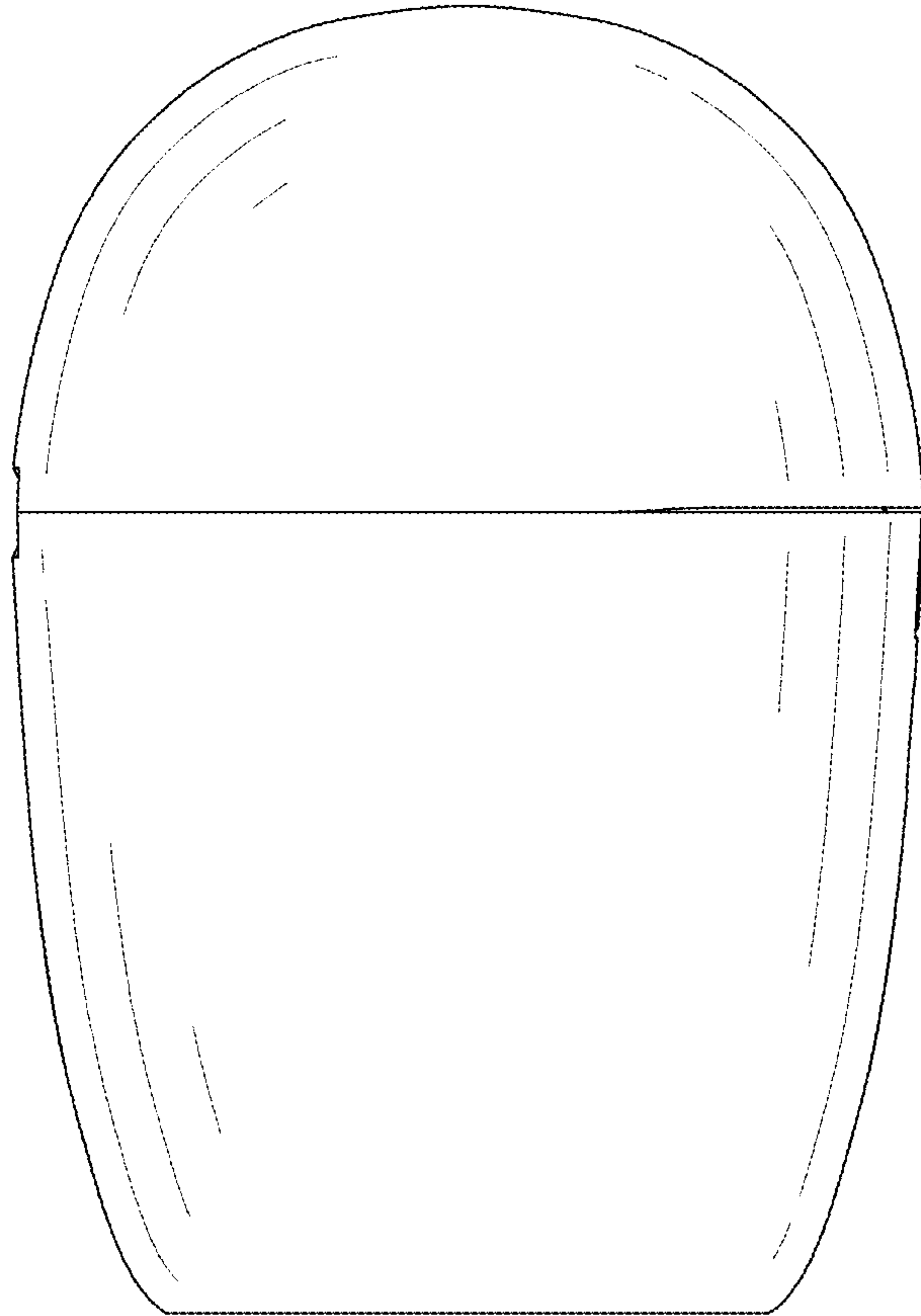

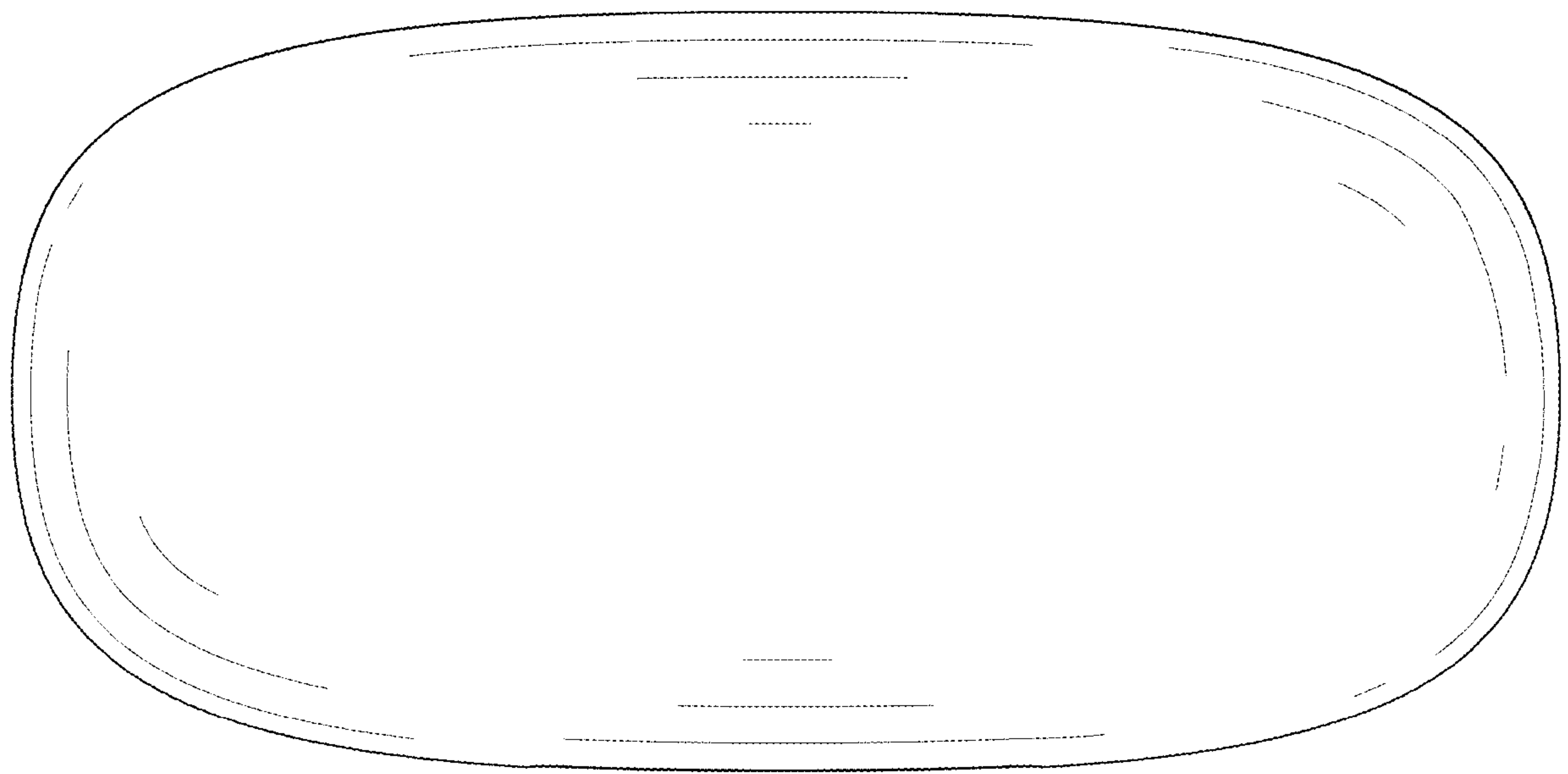

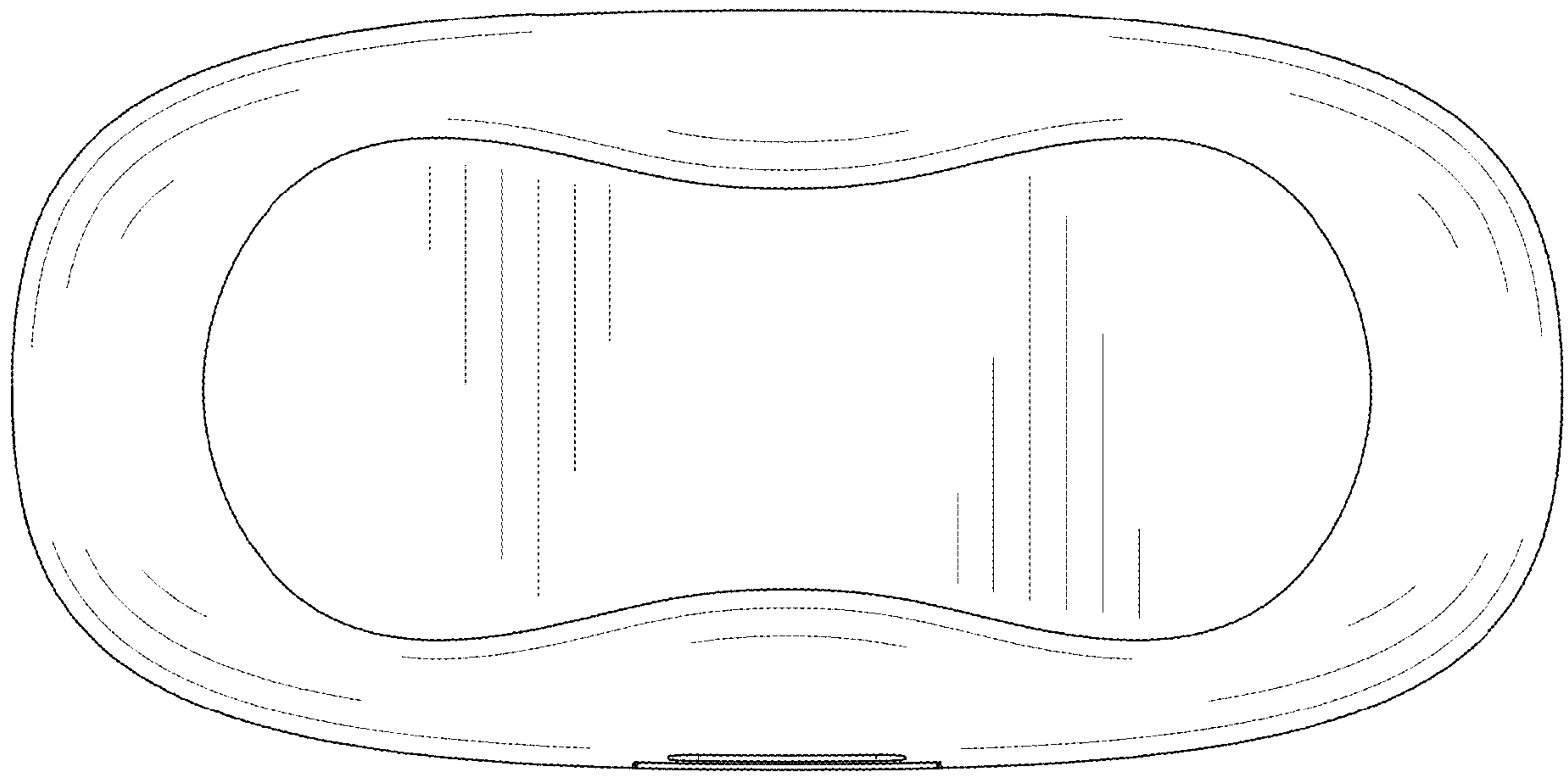

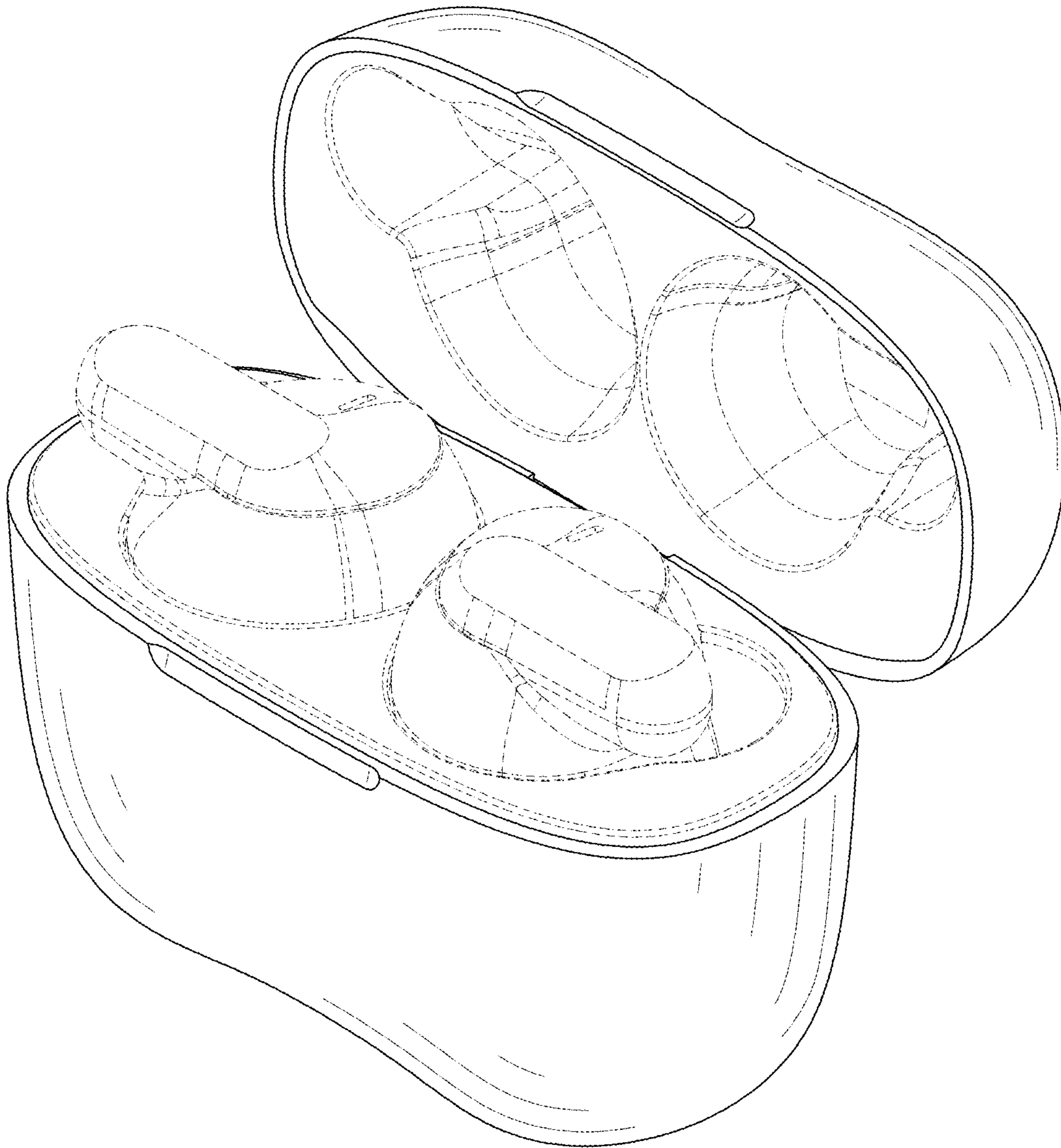
