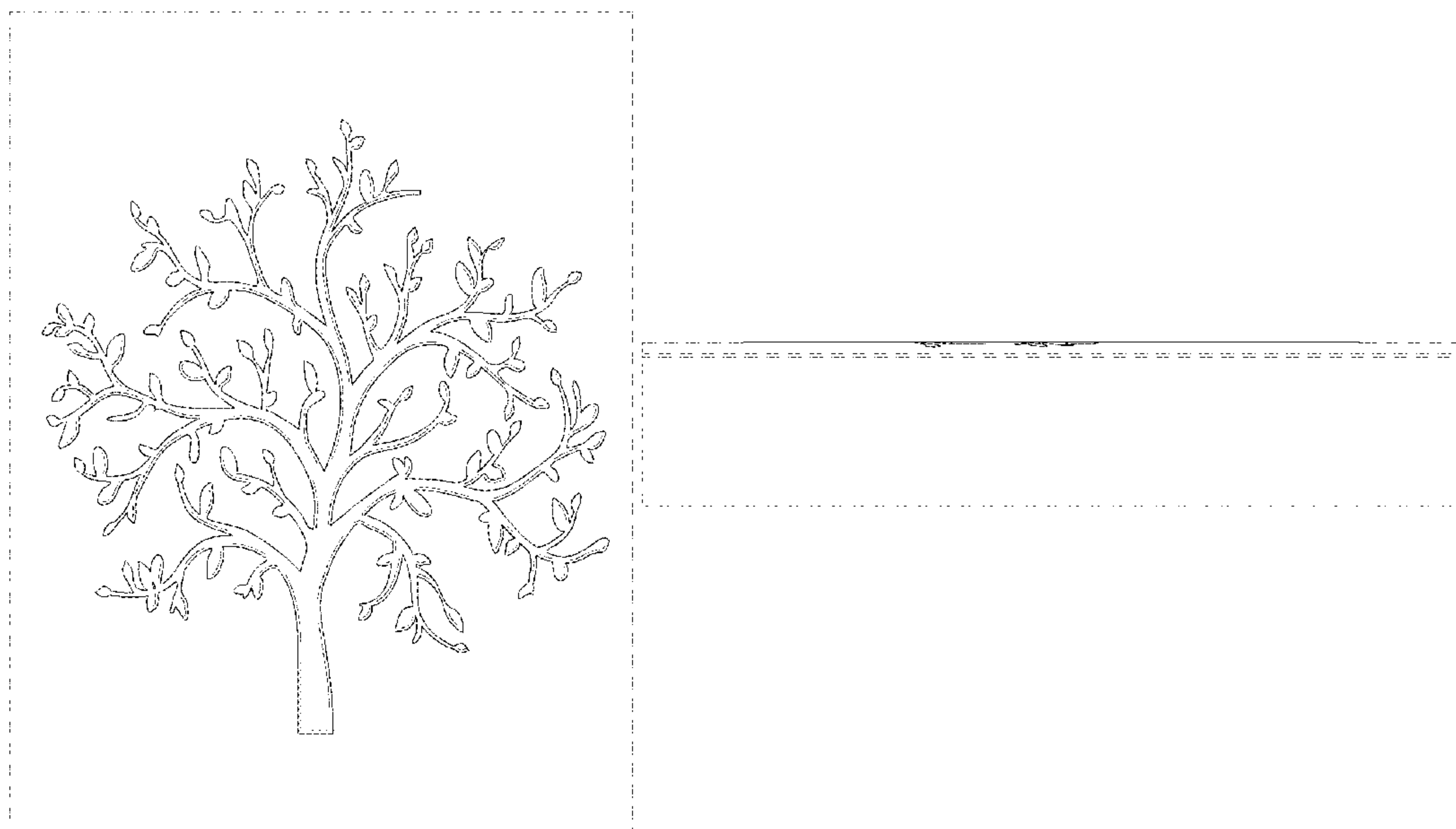
(57) **CLAIM**

The ornamental design for a journal cover with embossed tree, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a journal cover with embossed tree;
FIG. 2 is a top elevation view thereof;
FIG. 3 is a bottom elevation view thereof;
FIG. 4 is a front elevation view thereof;
FIG. 5 is a rear elevation view thereof;
FIG. 6 is a right elevation view thereof; and,
FIG. 7 is a left elevation view thereof.

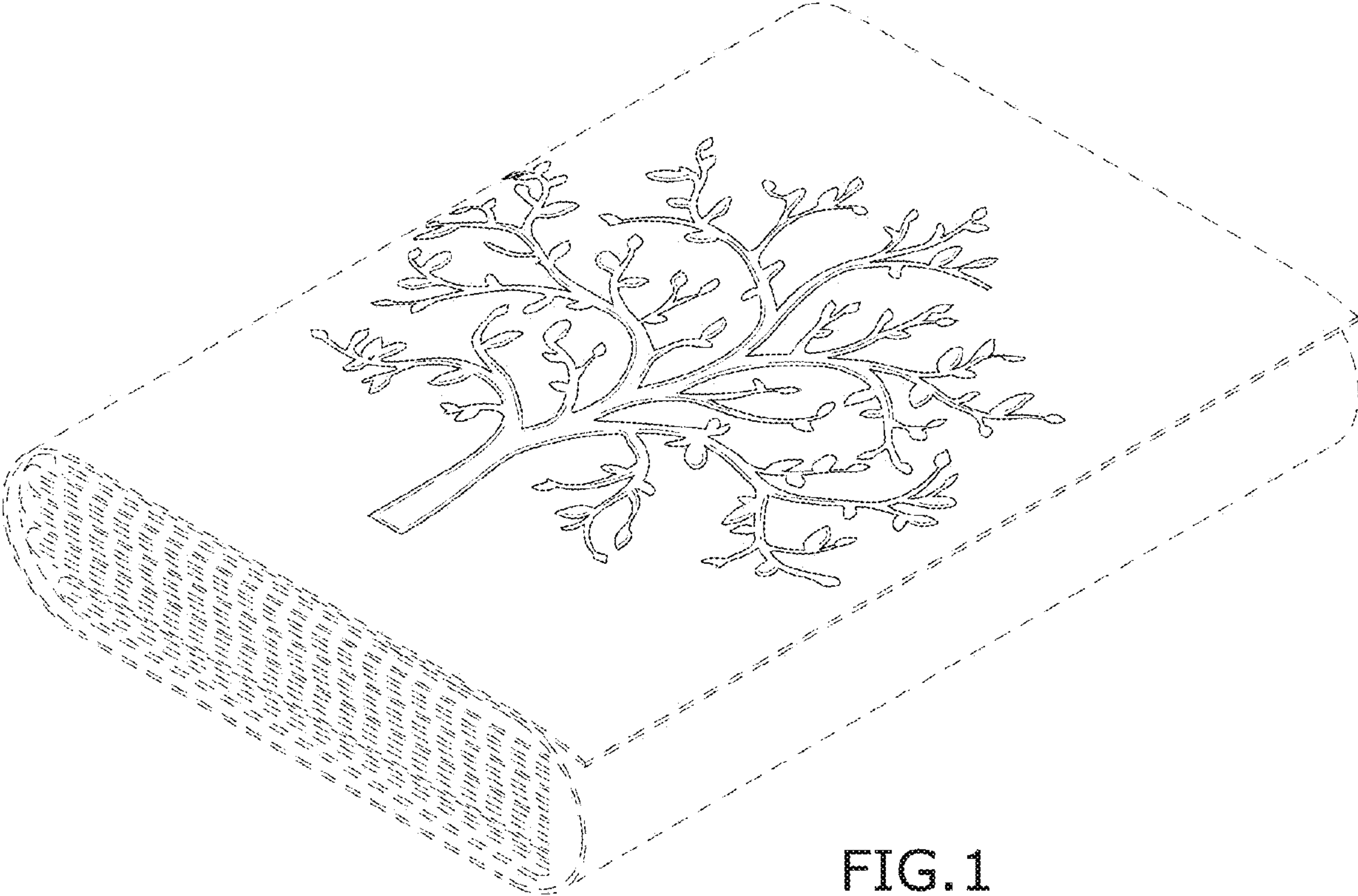

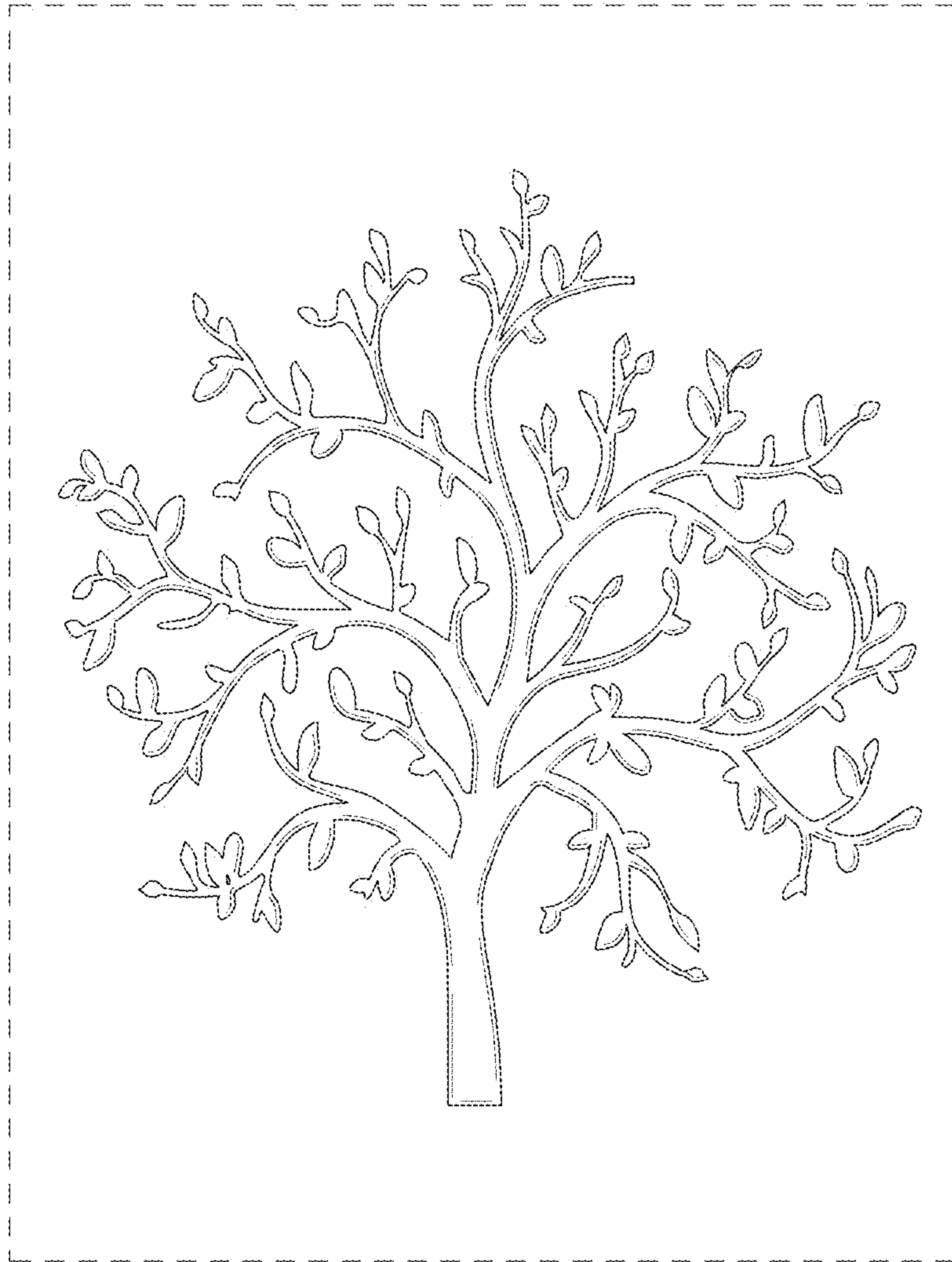

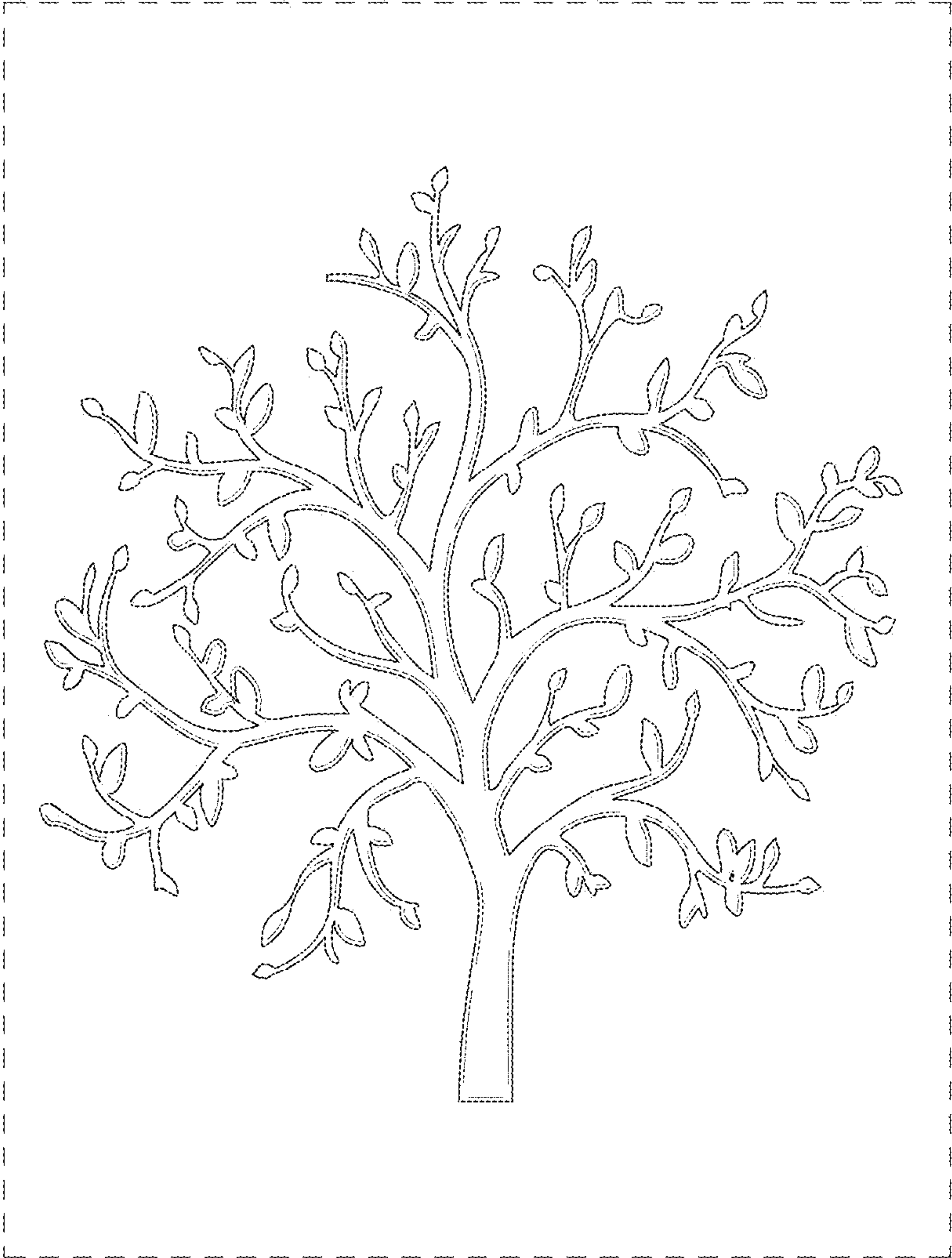

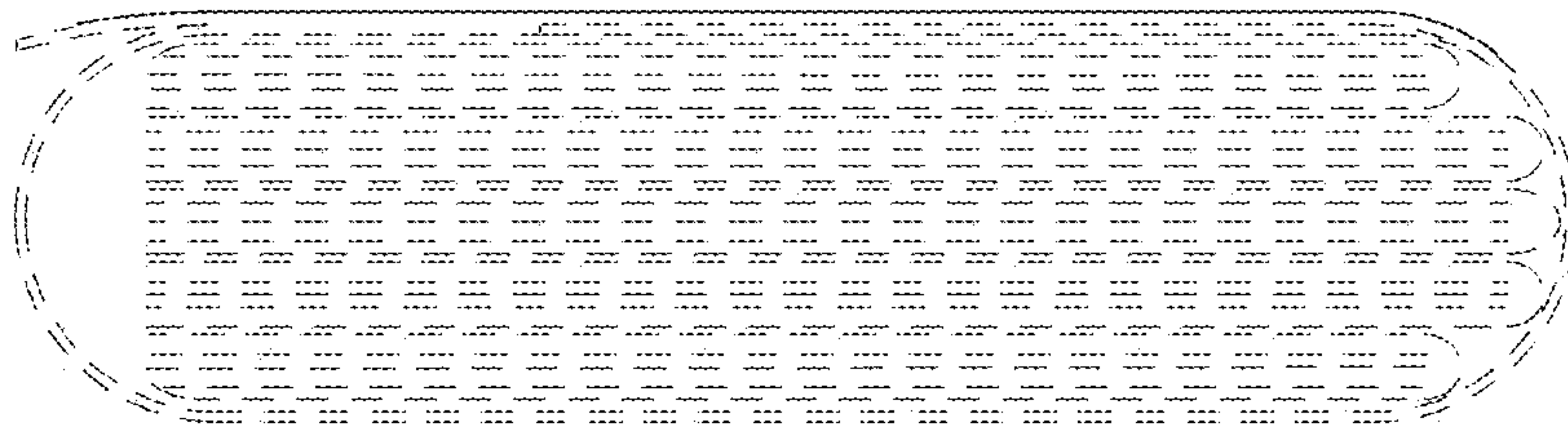

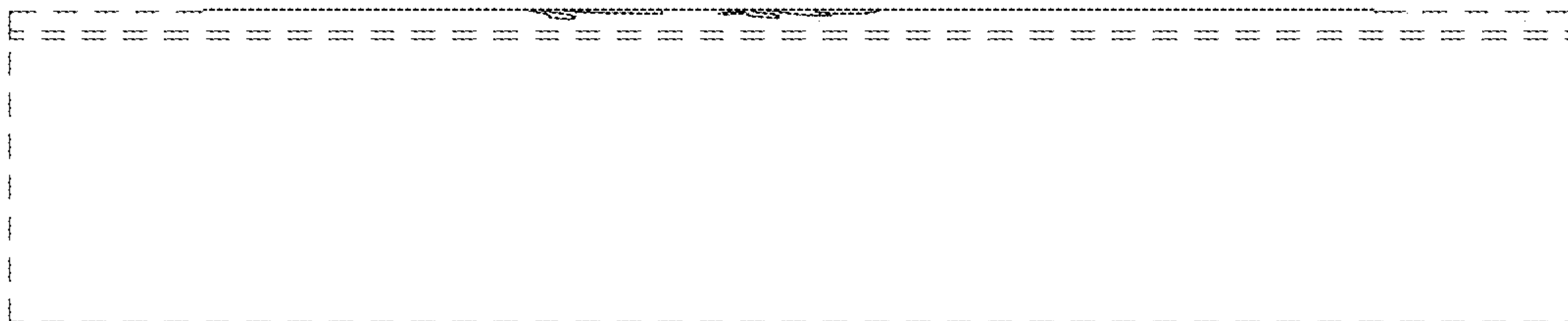

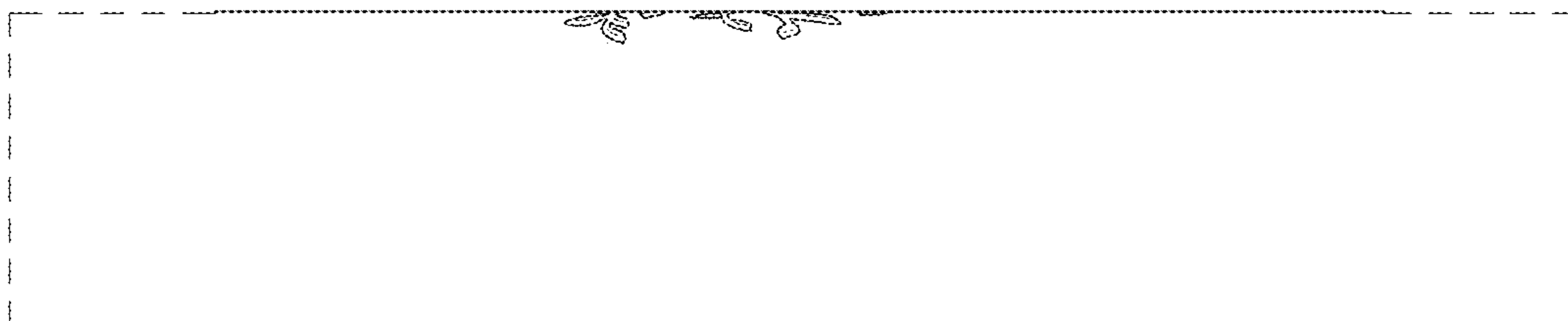
