**DESCRIPTION**

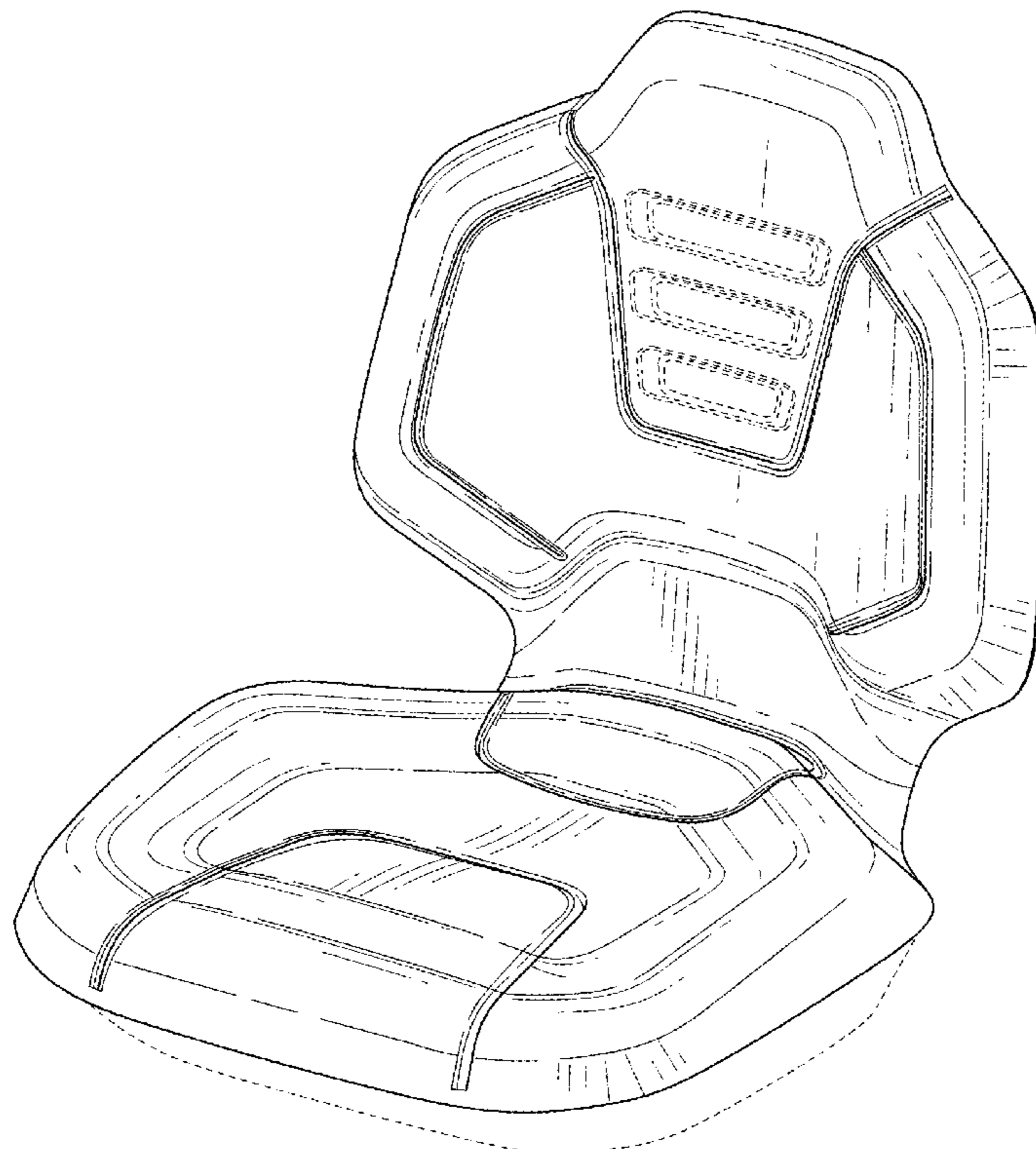
FIG. 1 is a top perspective view of a lawnmower seat in accordance with the present invention;

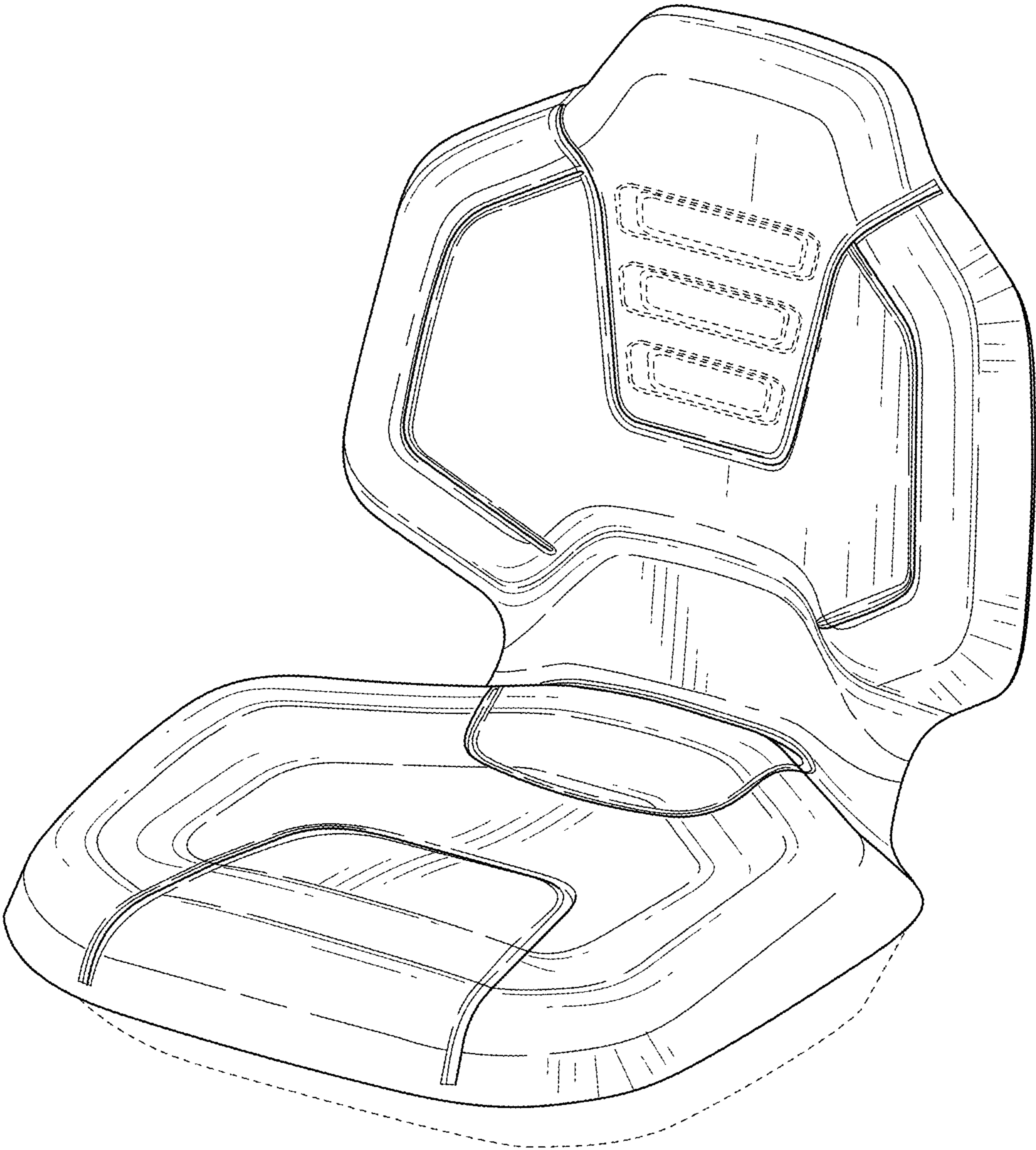

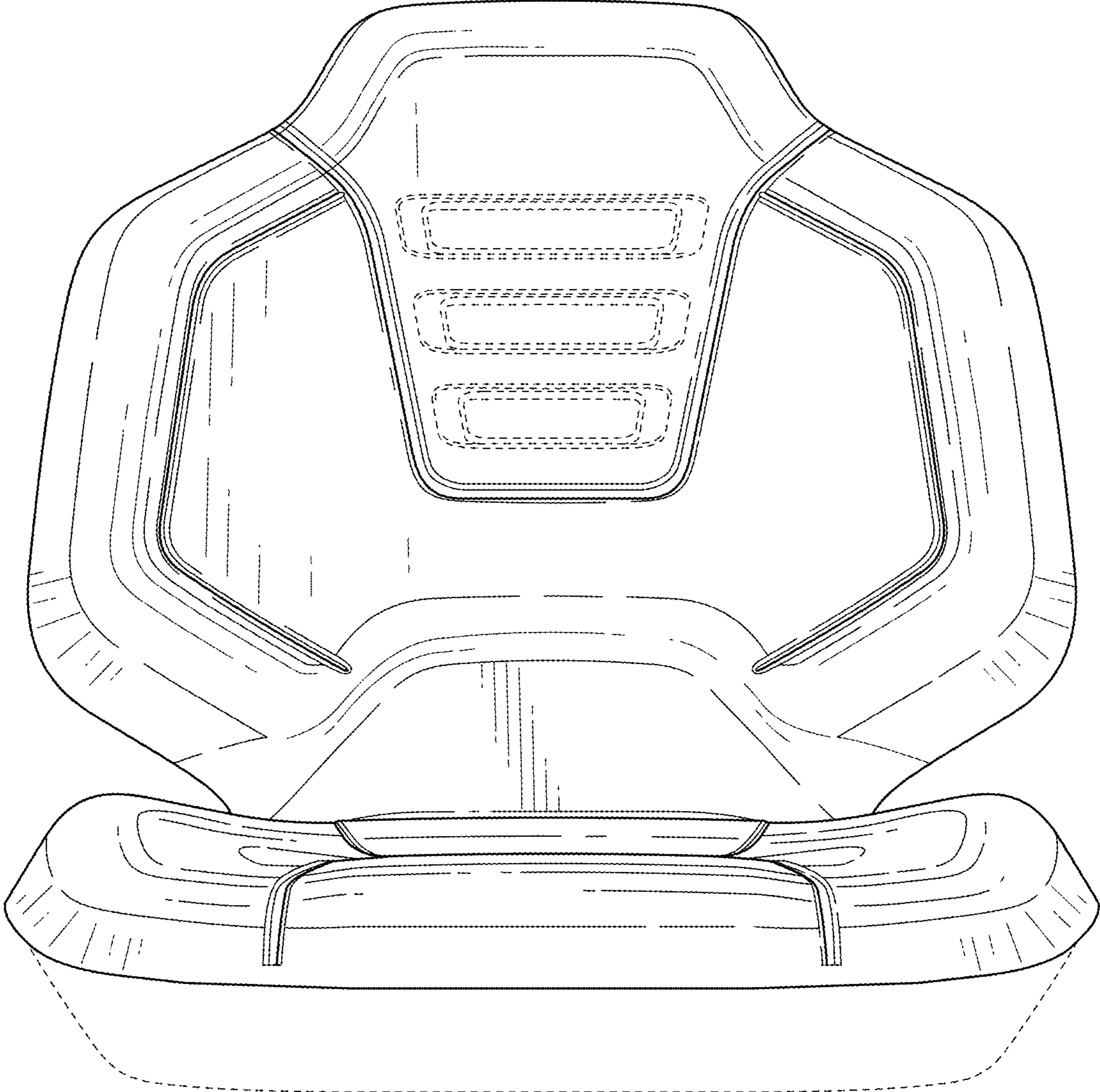

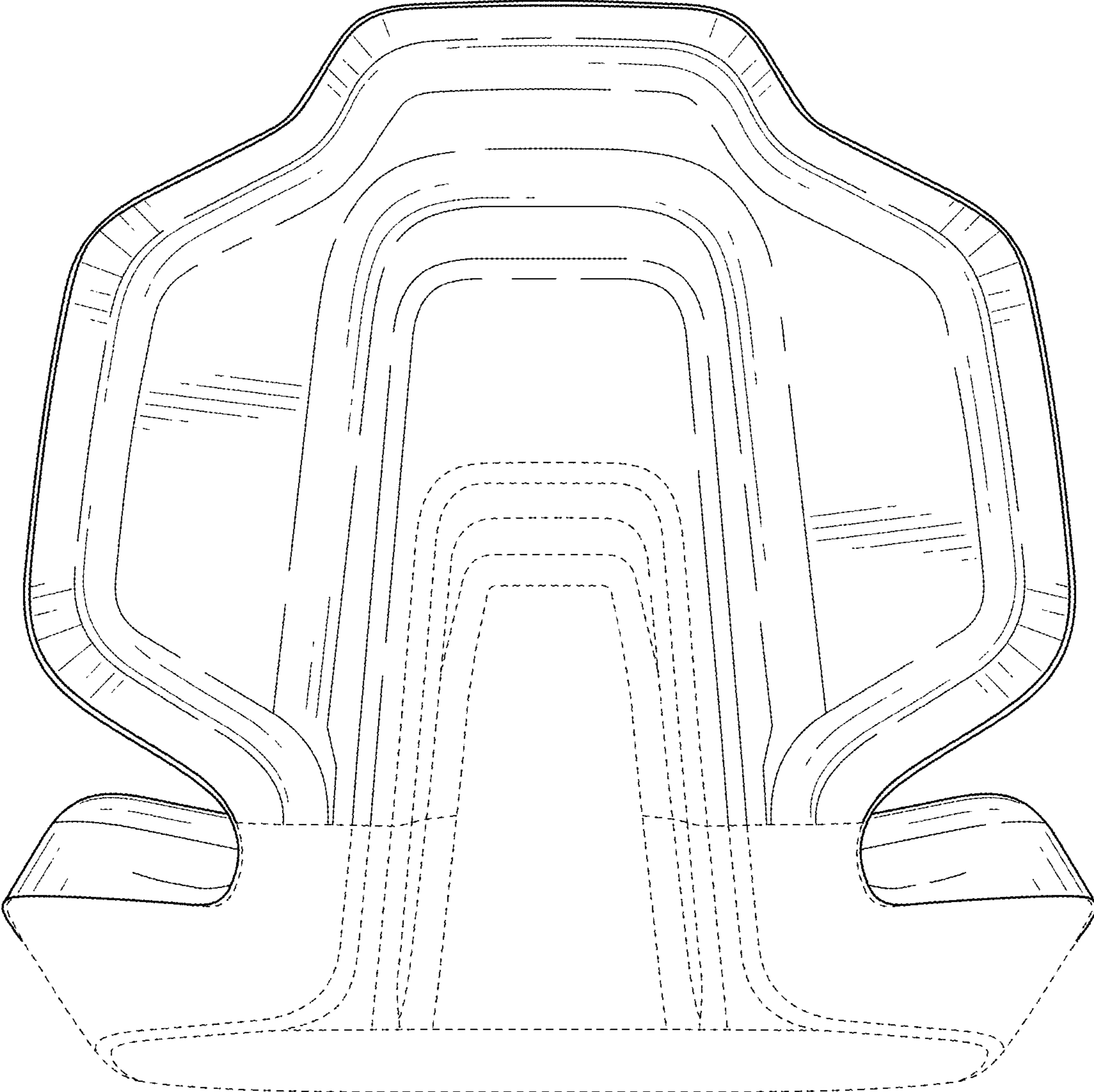

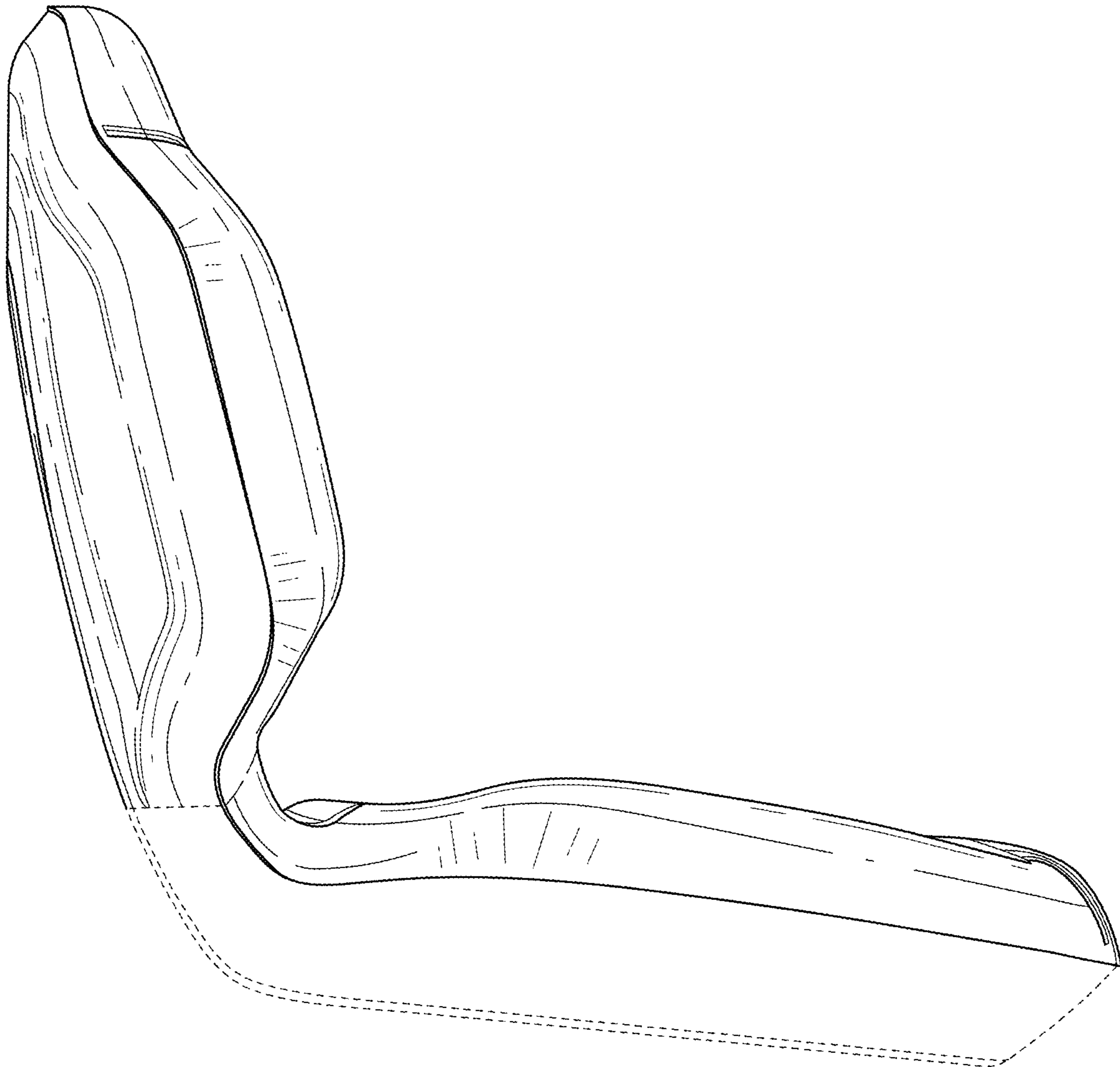

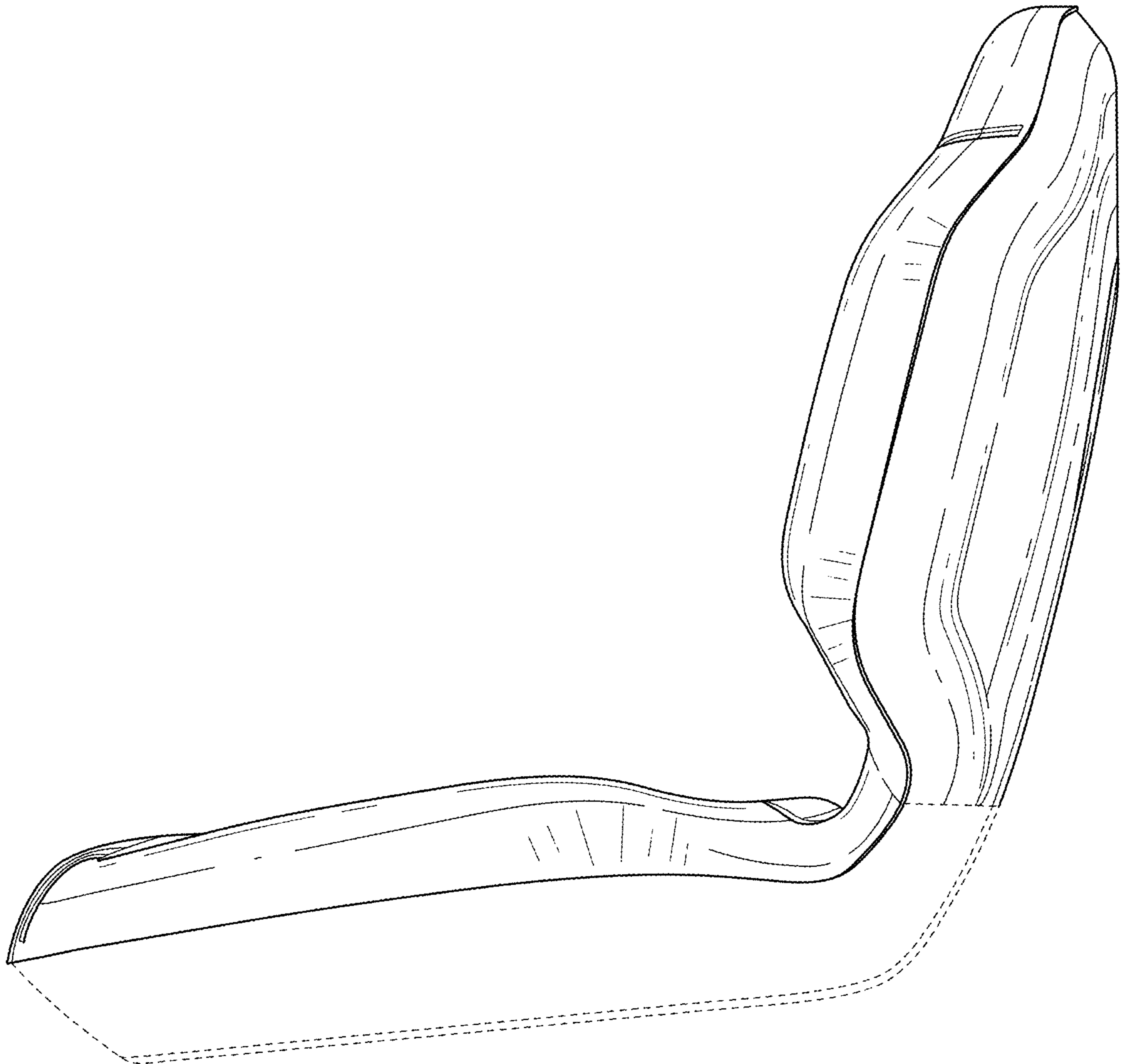

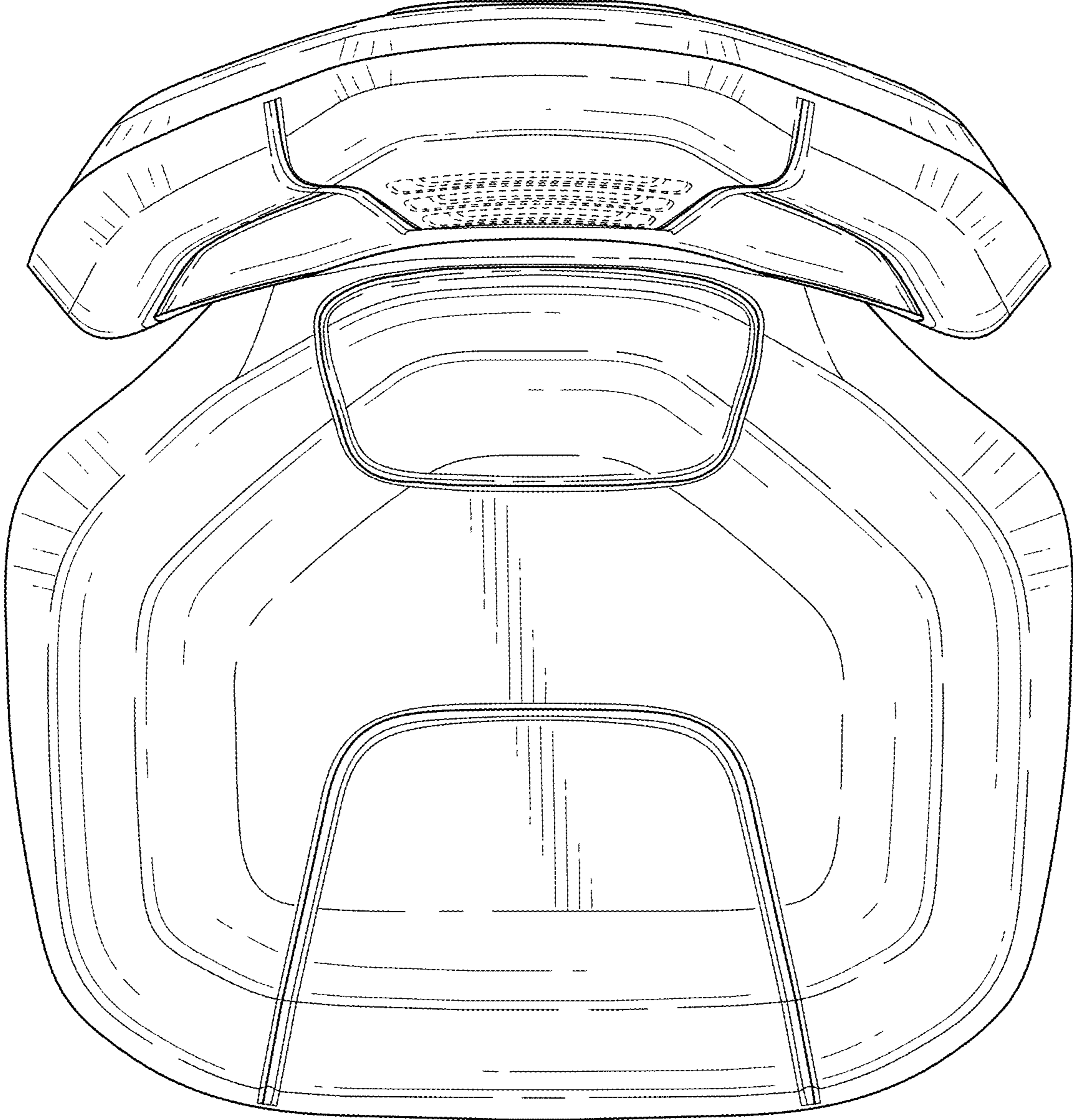

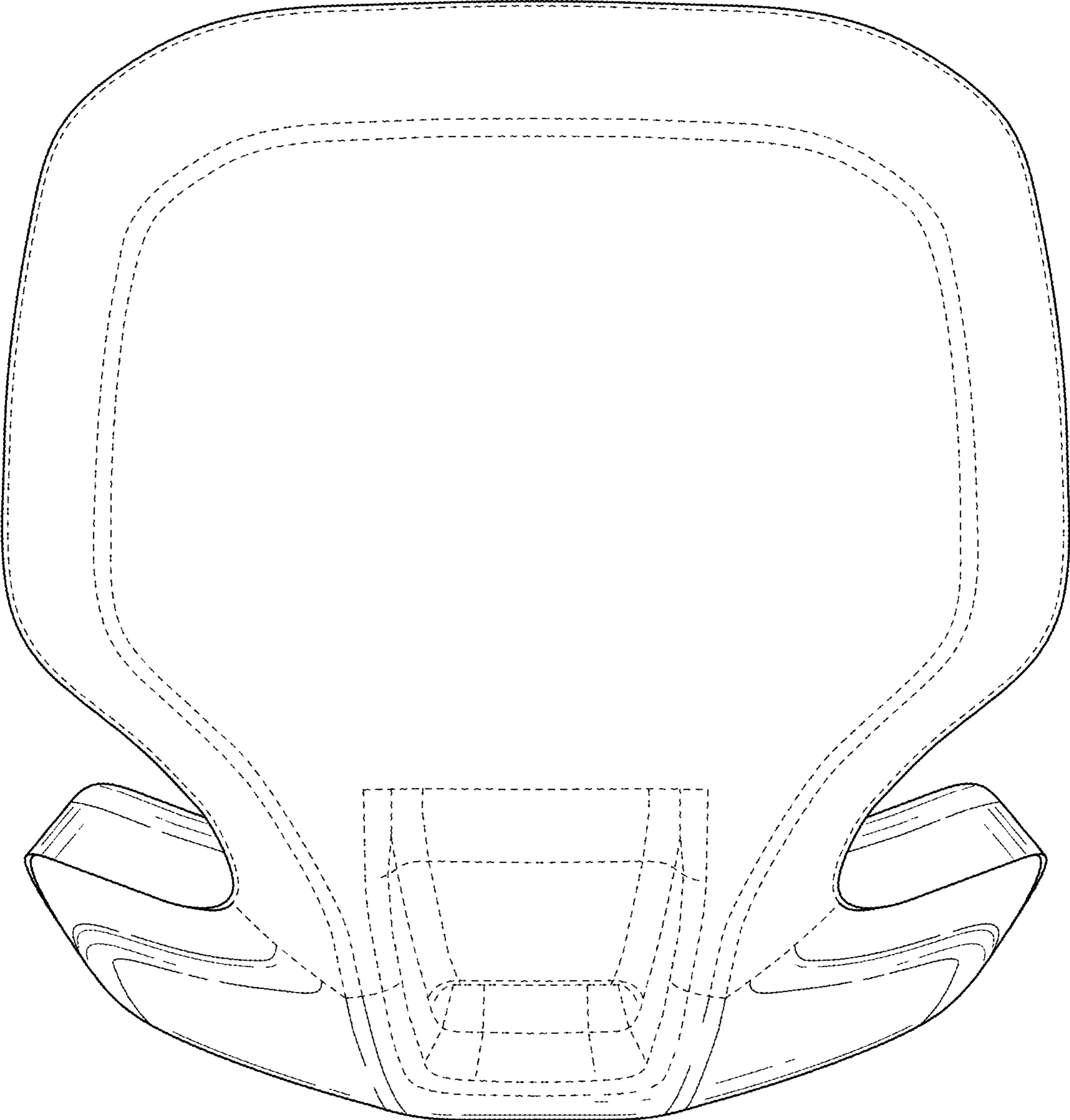
