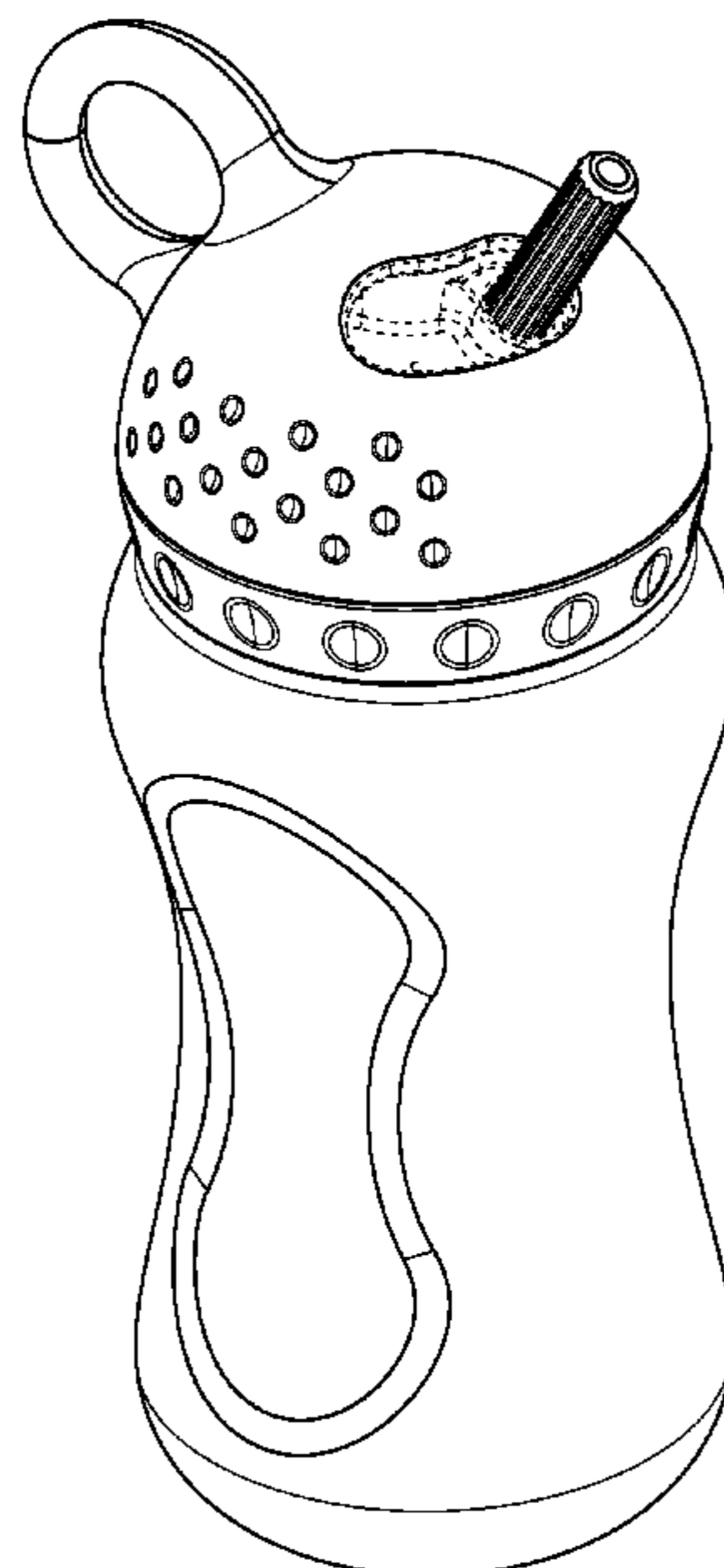
(57) **CLAIM**

The ornamental design for a cup with straw, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top and left side perspective view of a cup with straw showing my new design; FIG. 2 is a left side elevation view thereof; FIG. 3 is a right side elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a front elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The broken lines in the drawings depict portions of the cup with straw that form no part of the present invention.

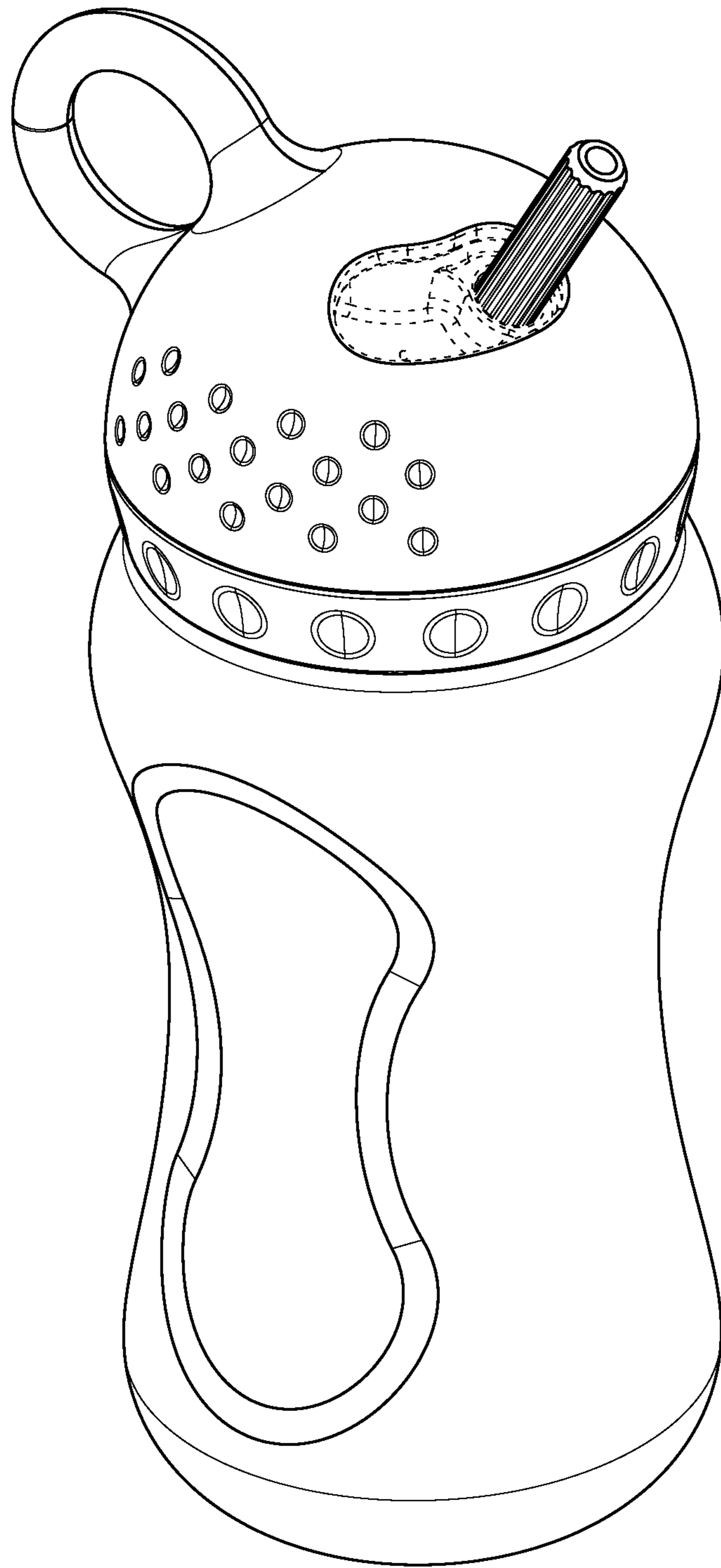

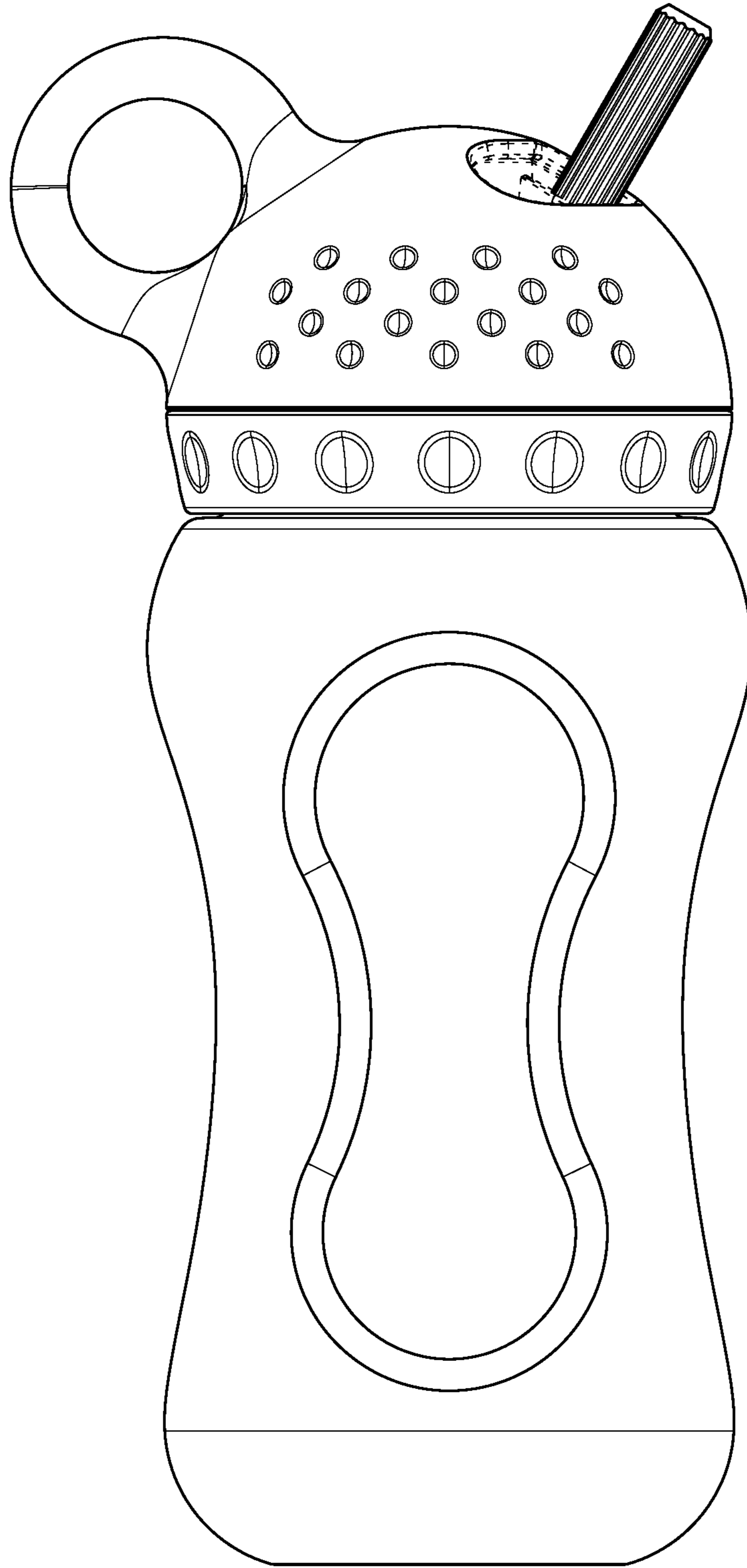

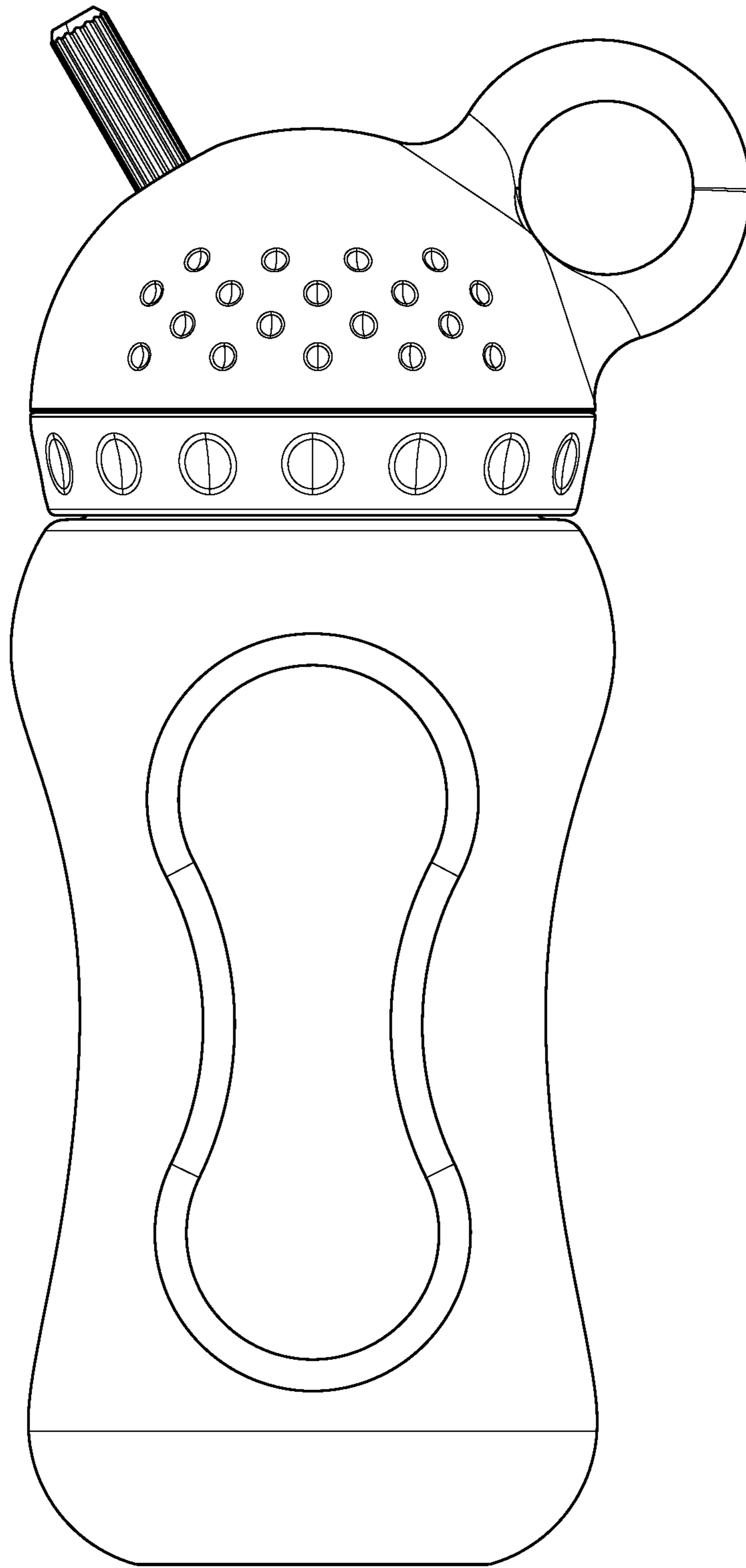

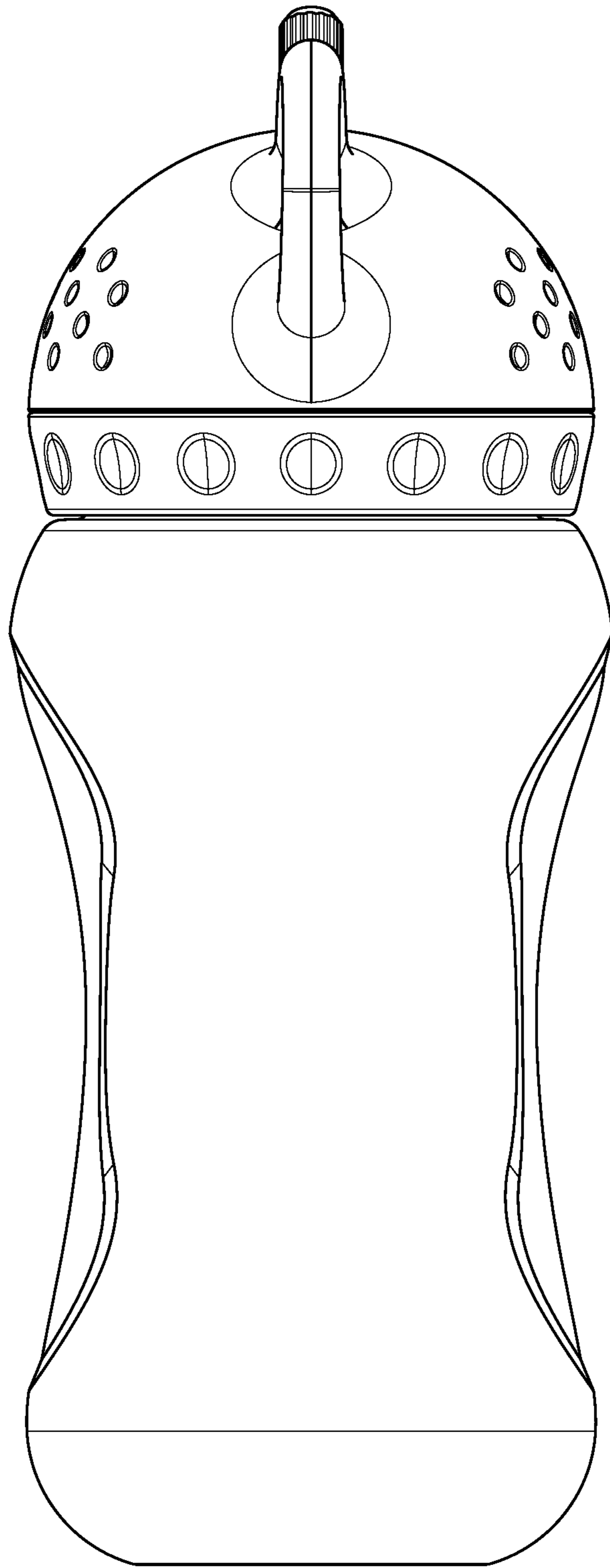

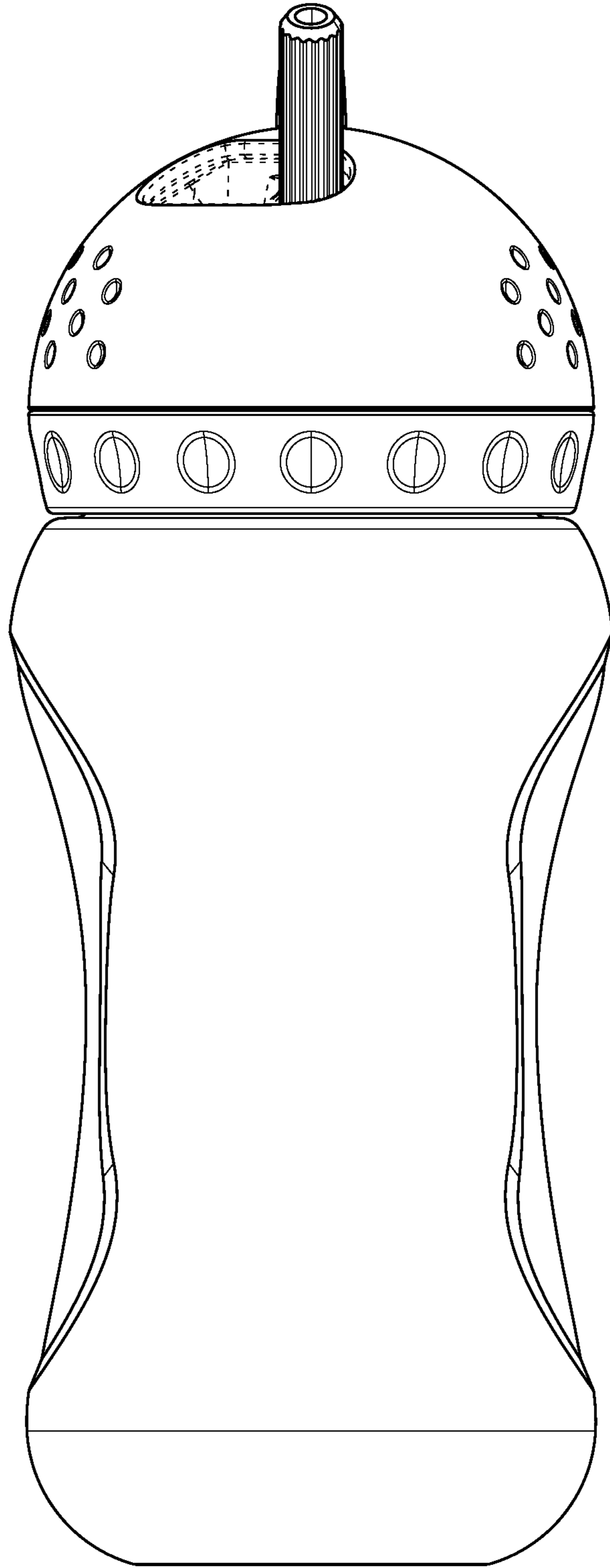

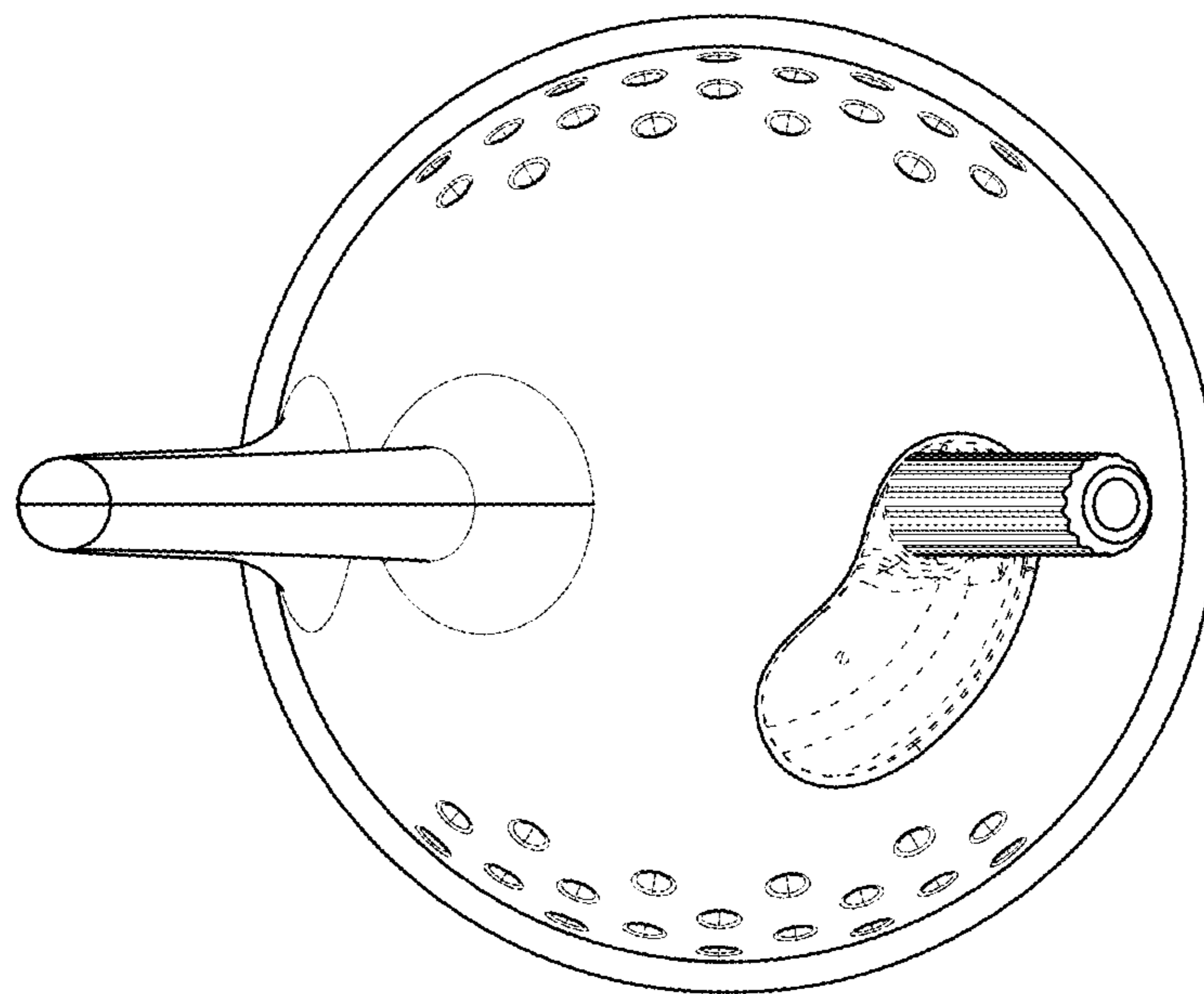

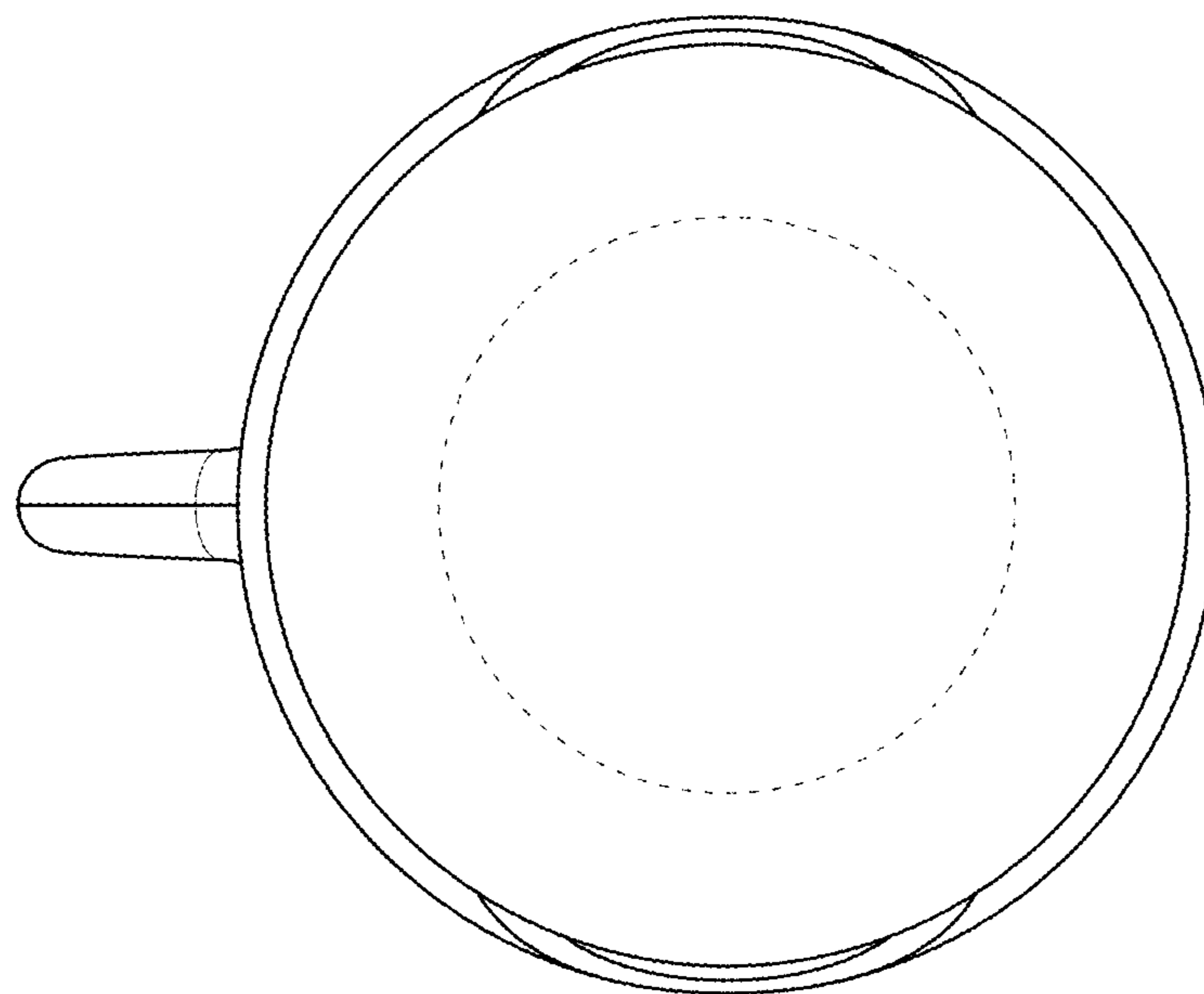
