(57) **CLAIM**

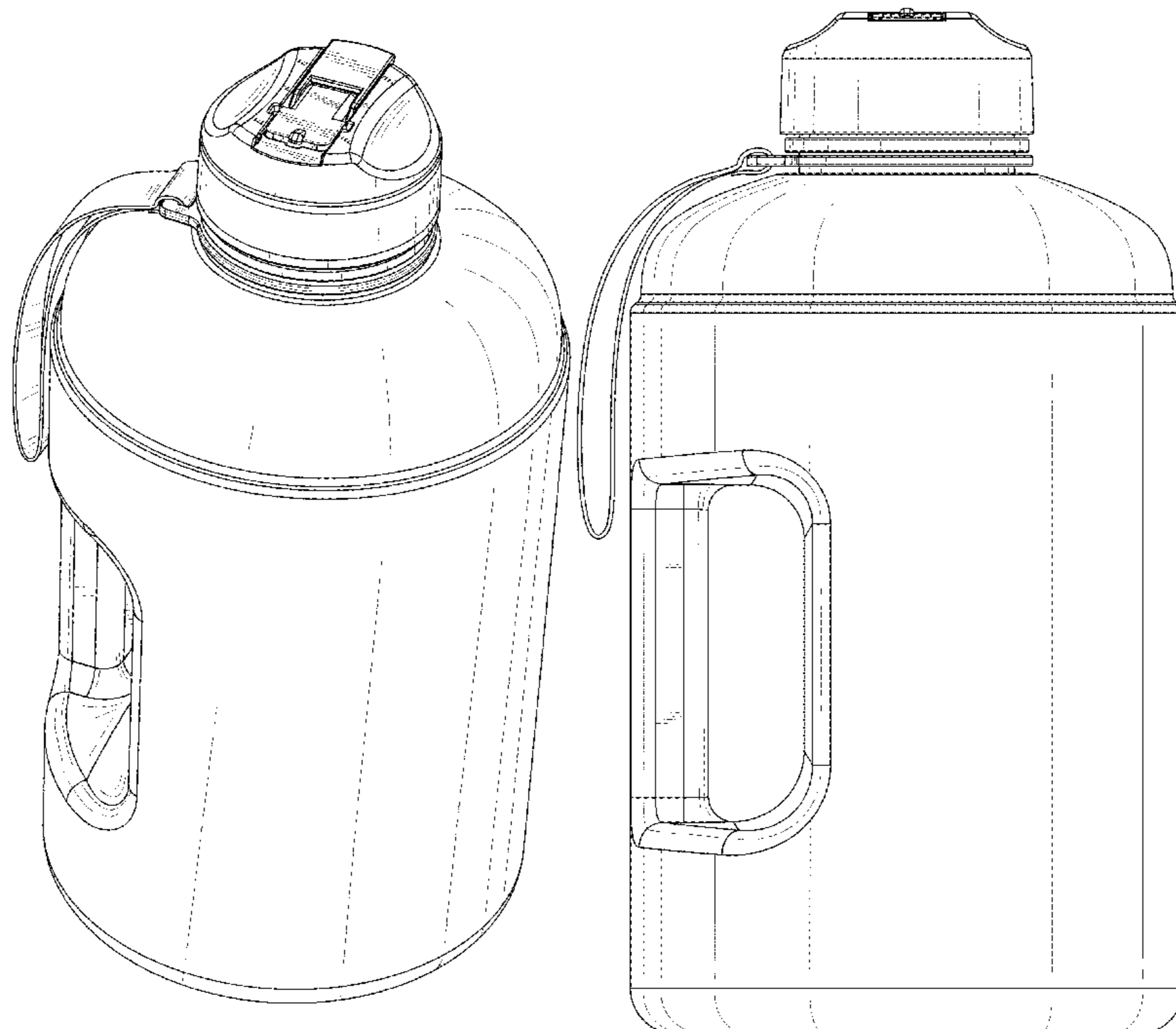
The ornamental design for a gallon water bottle with straw, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a gallon water bottle with straw showing my new design;
FIG. 2 is a perspective view thereof with the cover in its open position;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a right side view thereof;

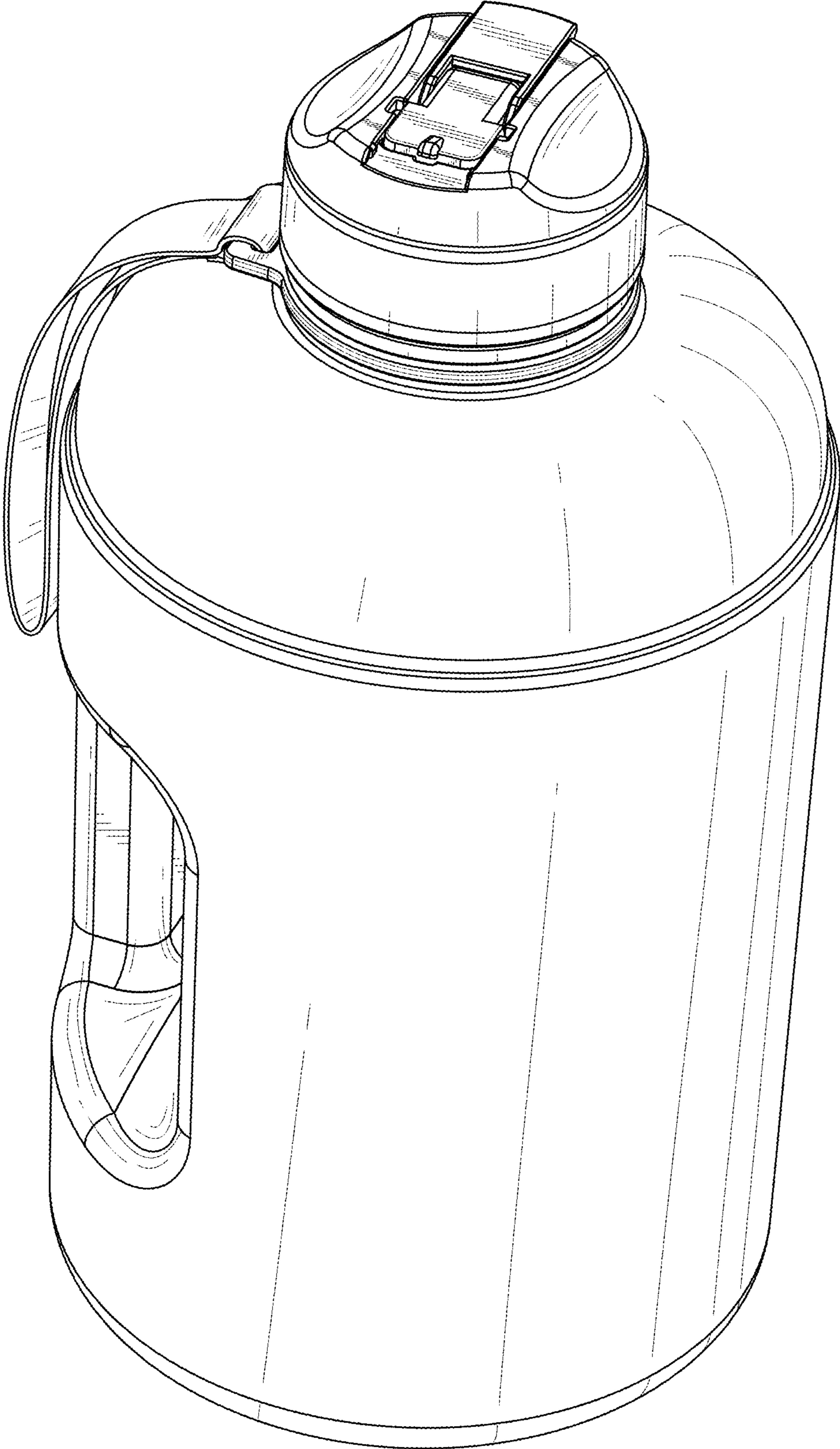

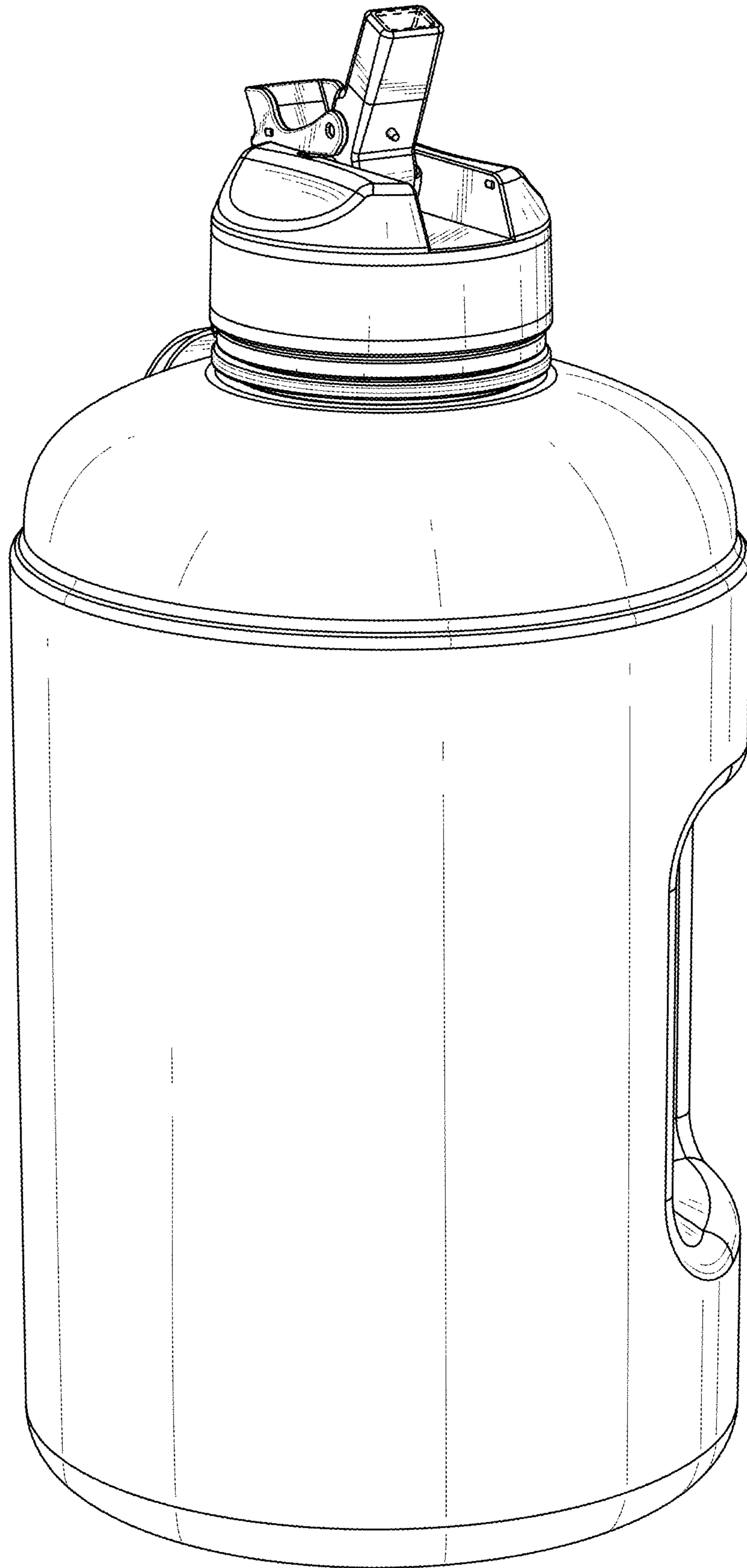

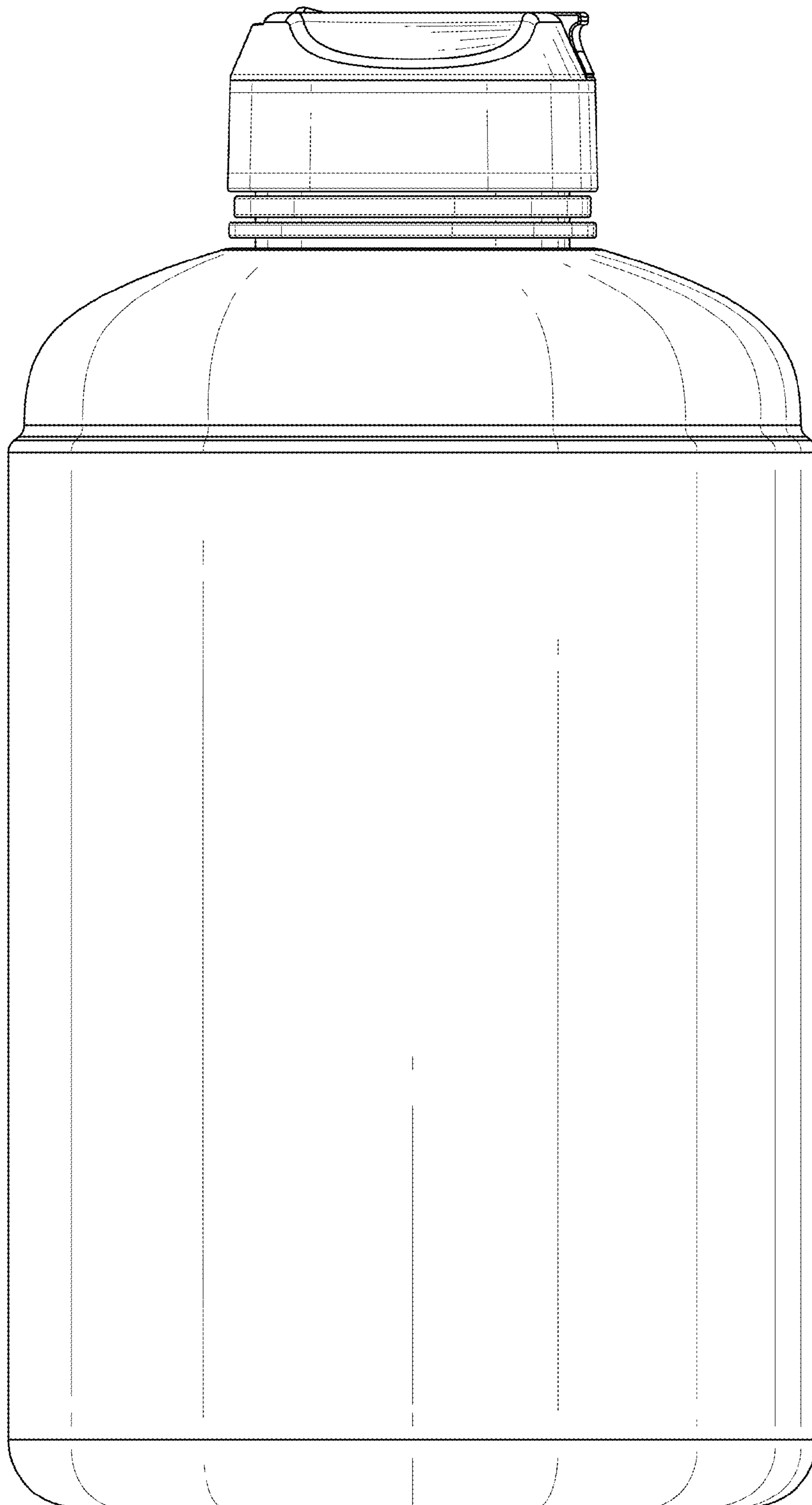

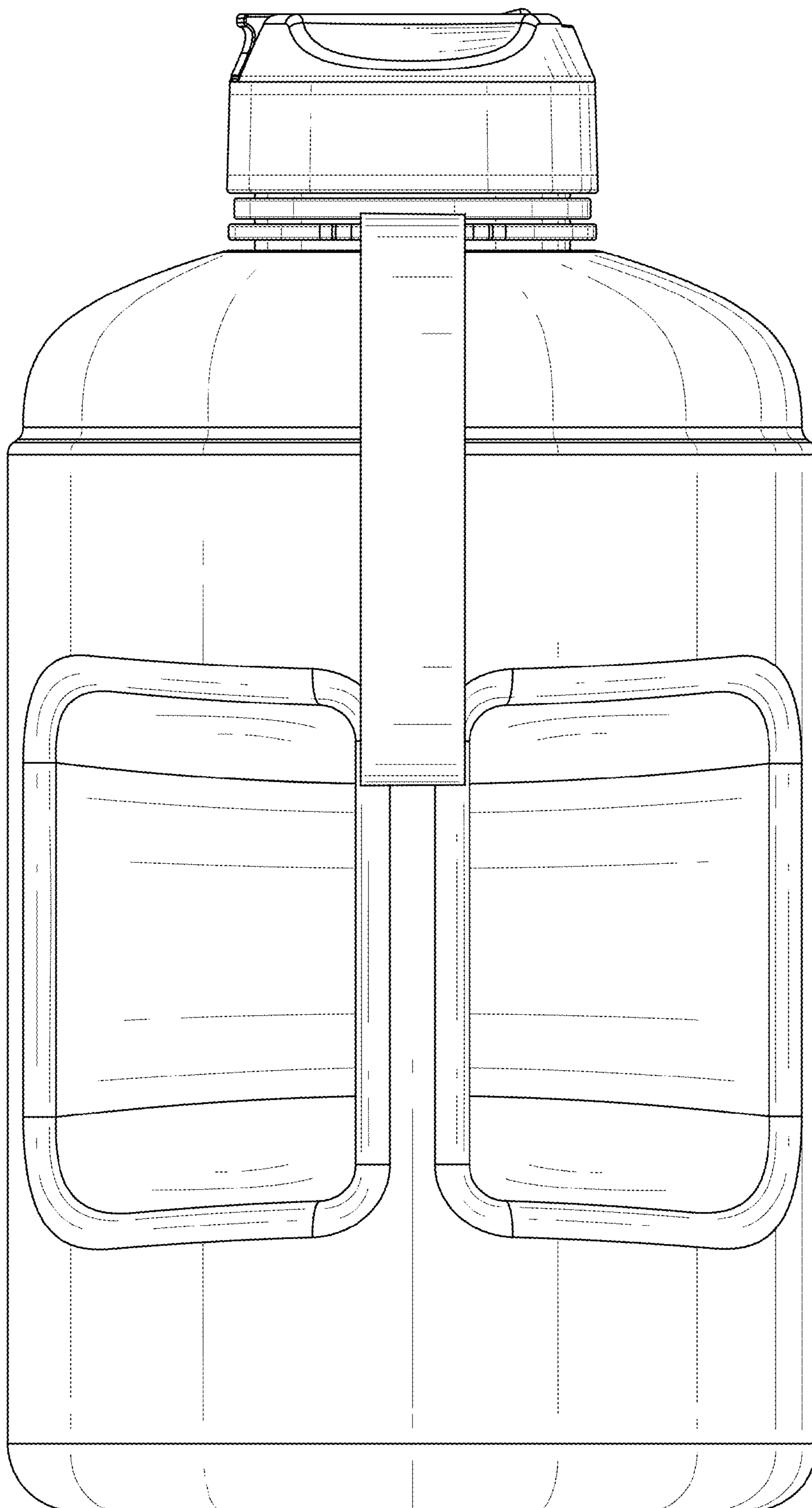

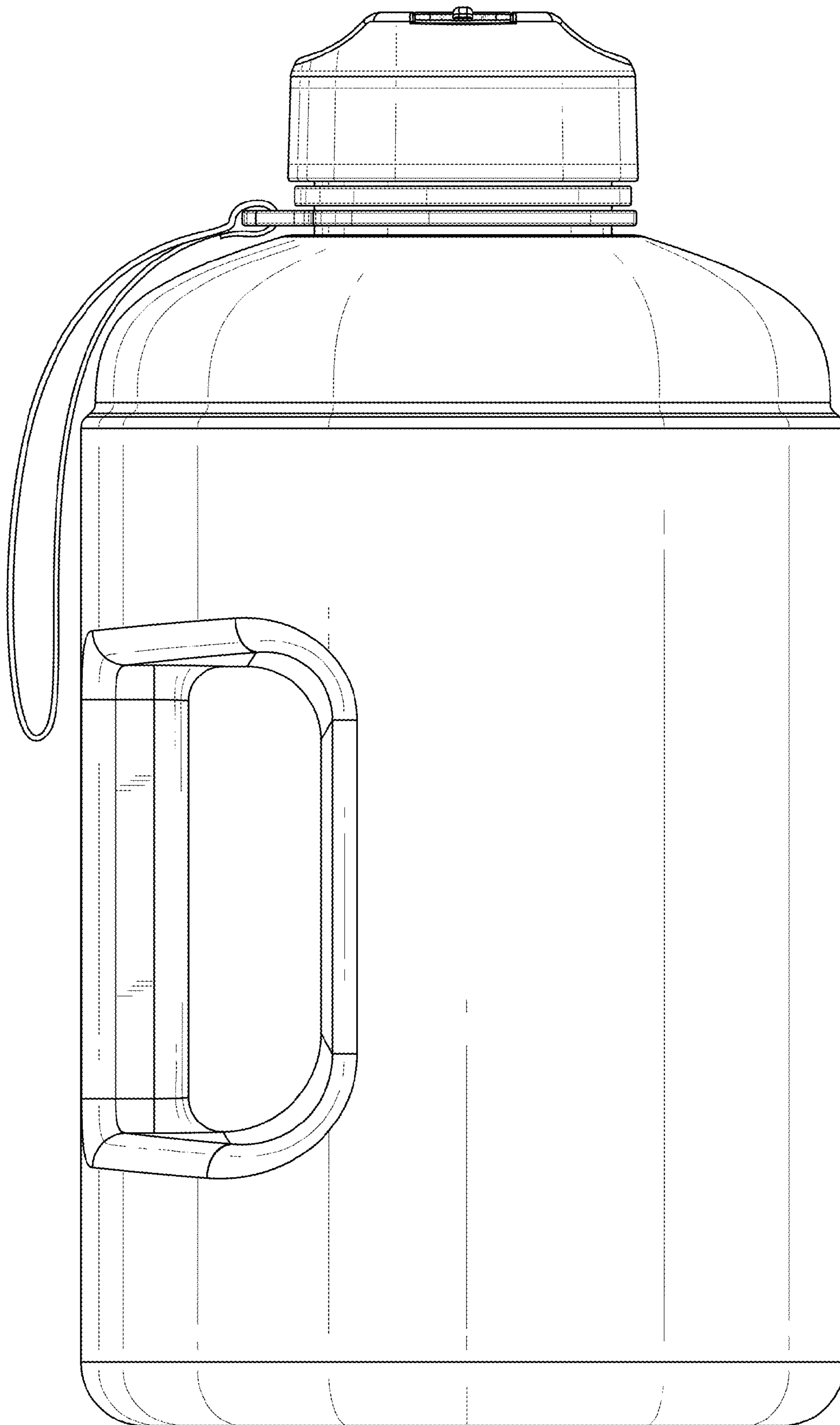

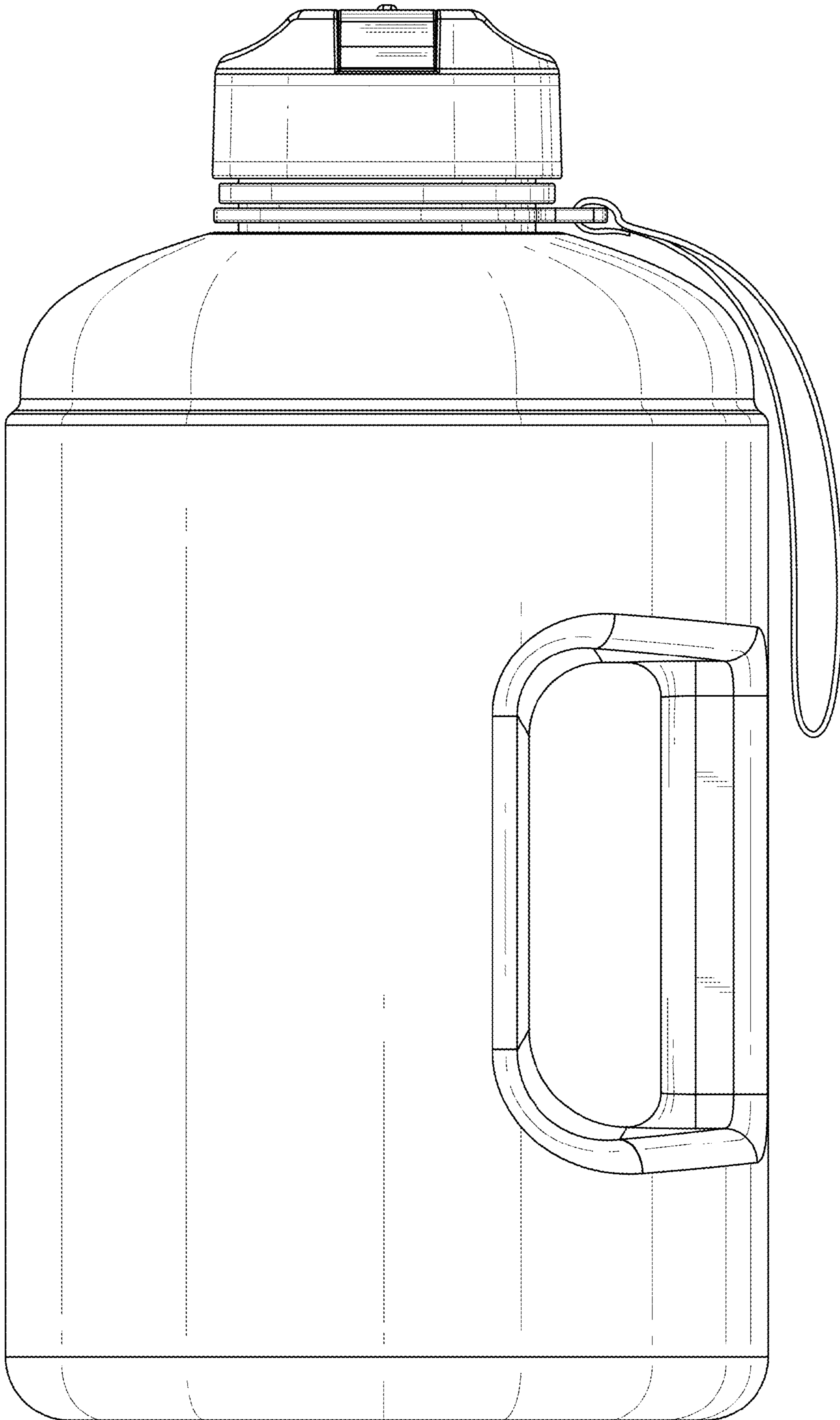

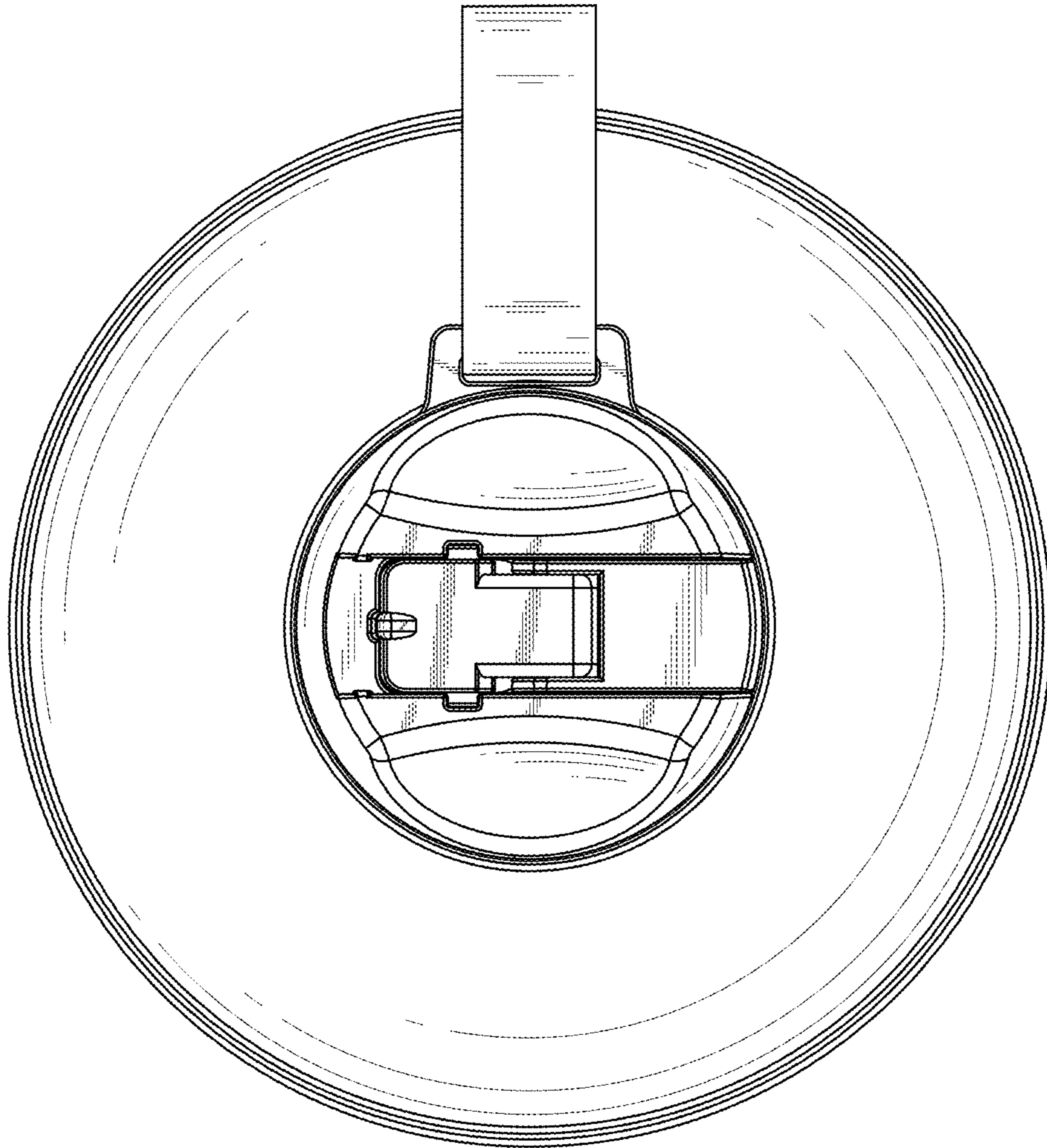

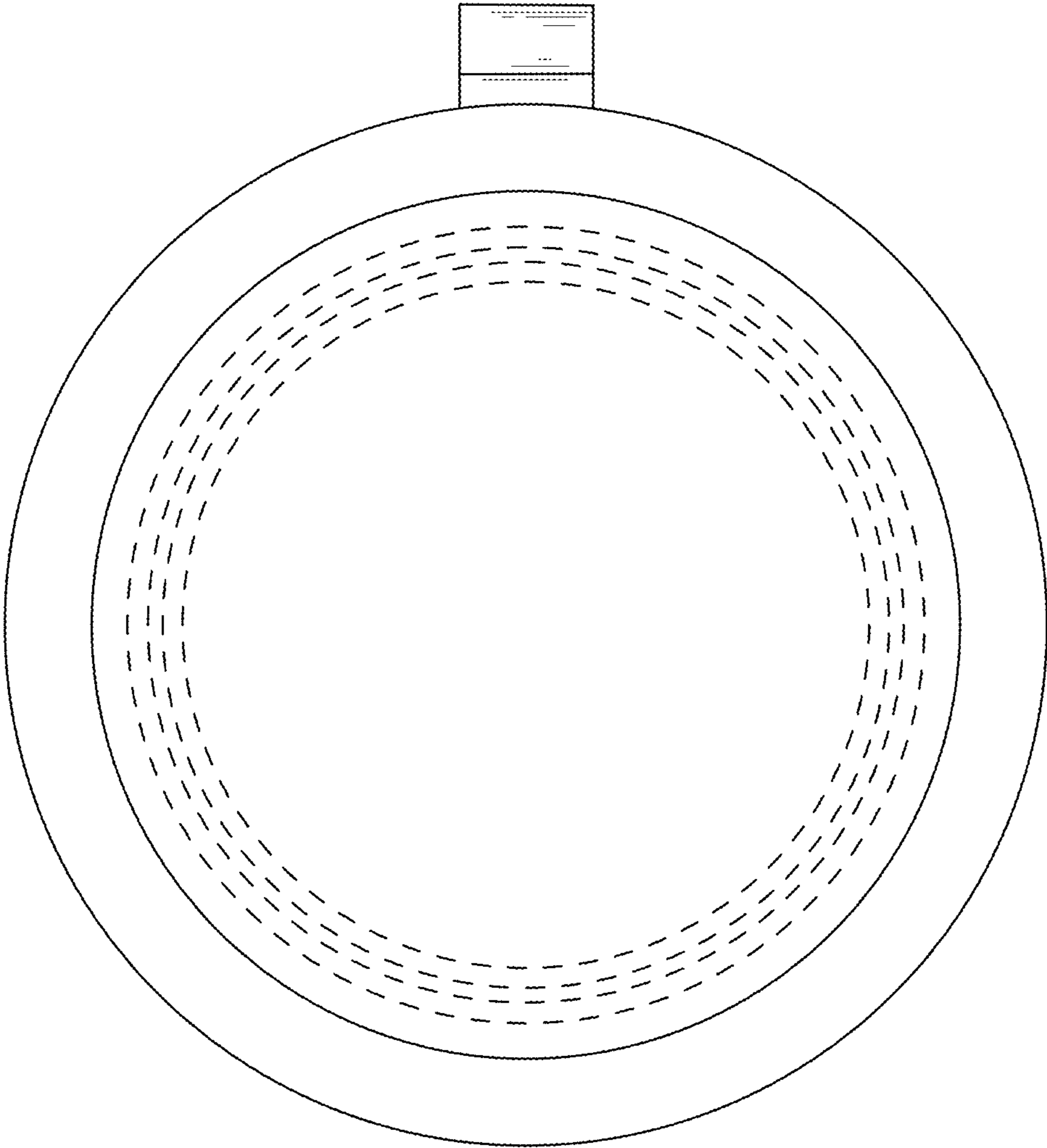
