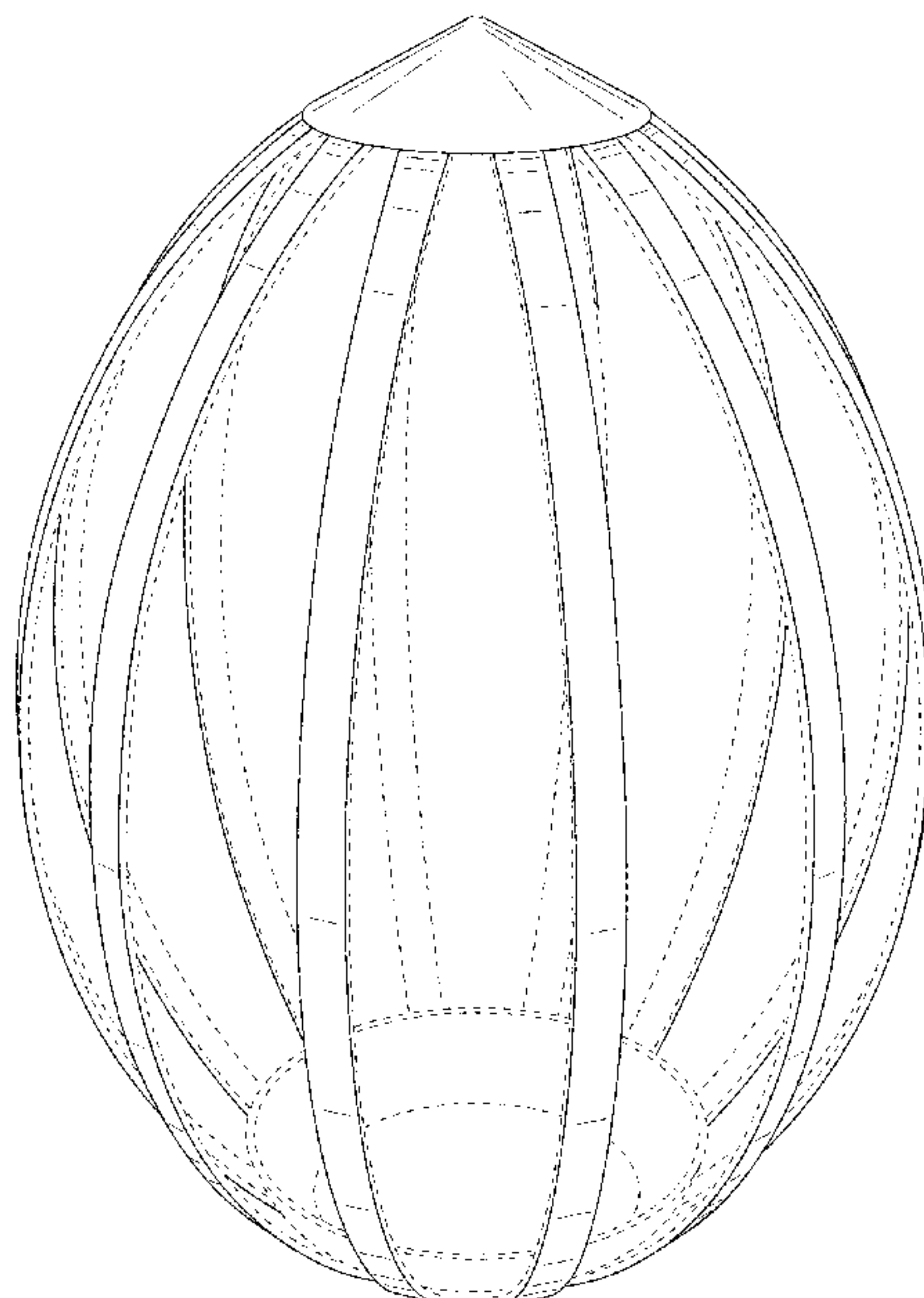
(57) **CLAIM**

The ornamental design for a decorative container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the decorative container of the subject disclosure;
FIG. 2 is a front plan view thereof, and the rear plan, right plan, and left plan views are all identical to the front plan view;
FIG. 3 is a top plan view thereof; and,
FIG. 4 is a bottom plan view thereof.

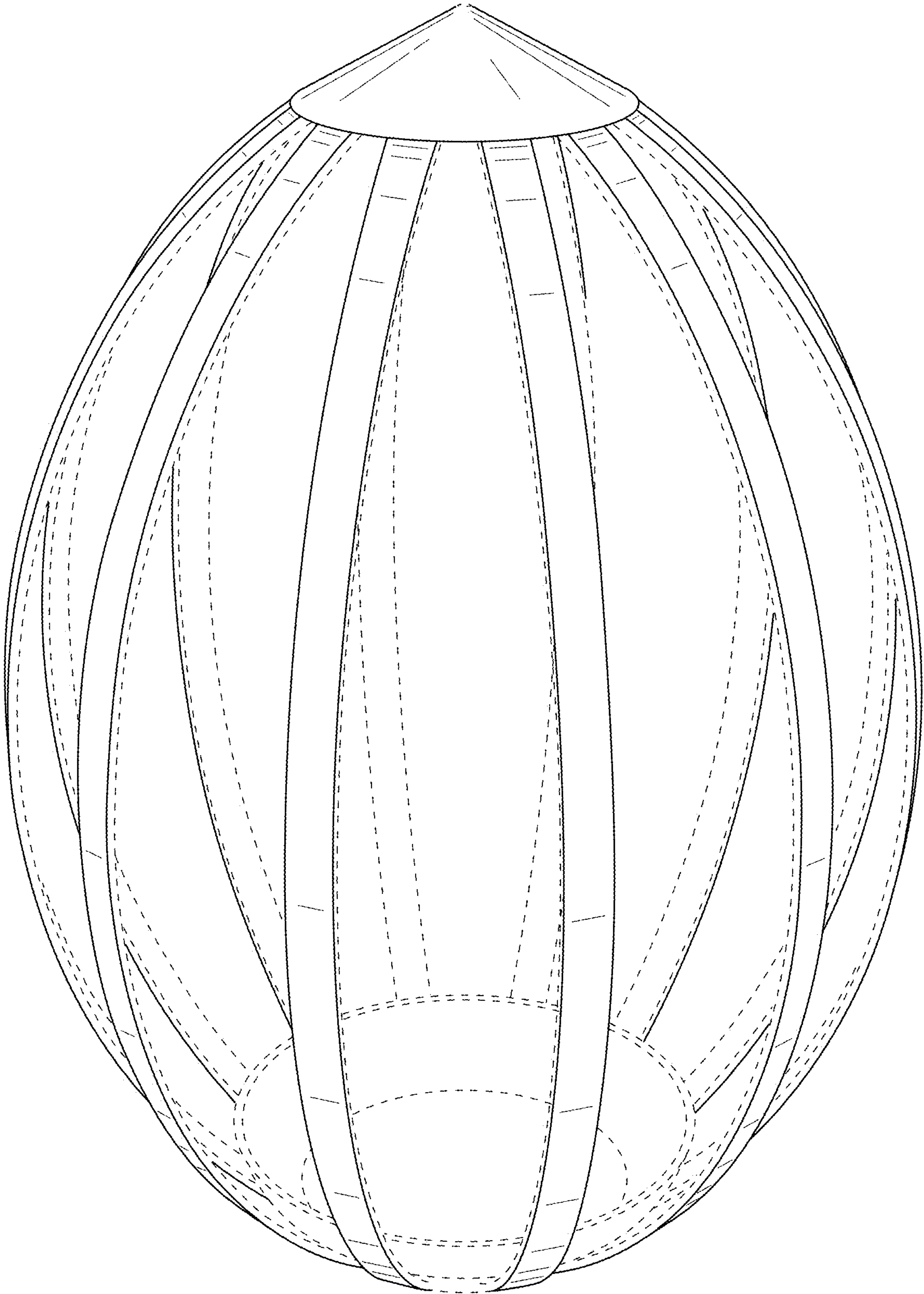

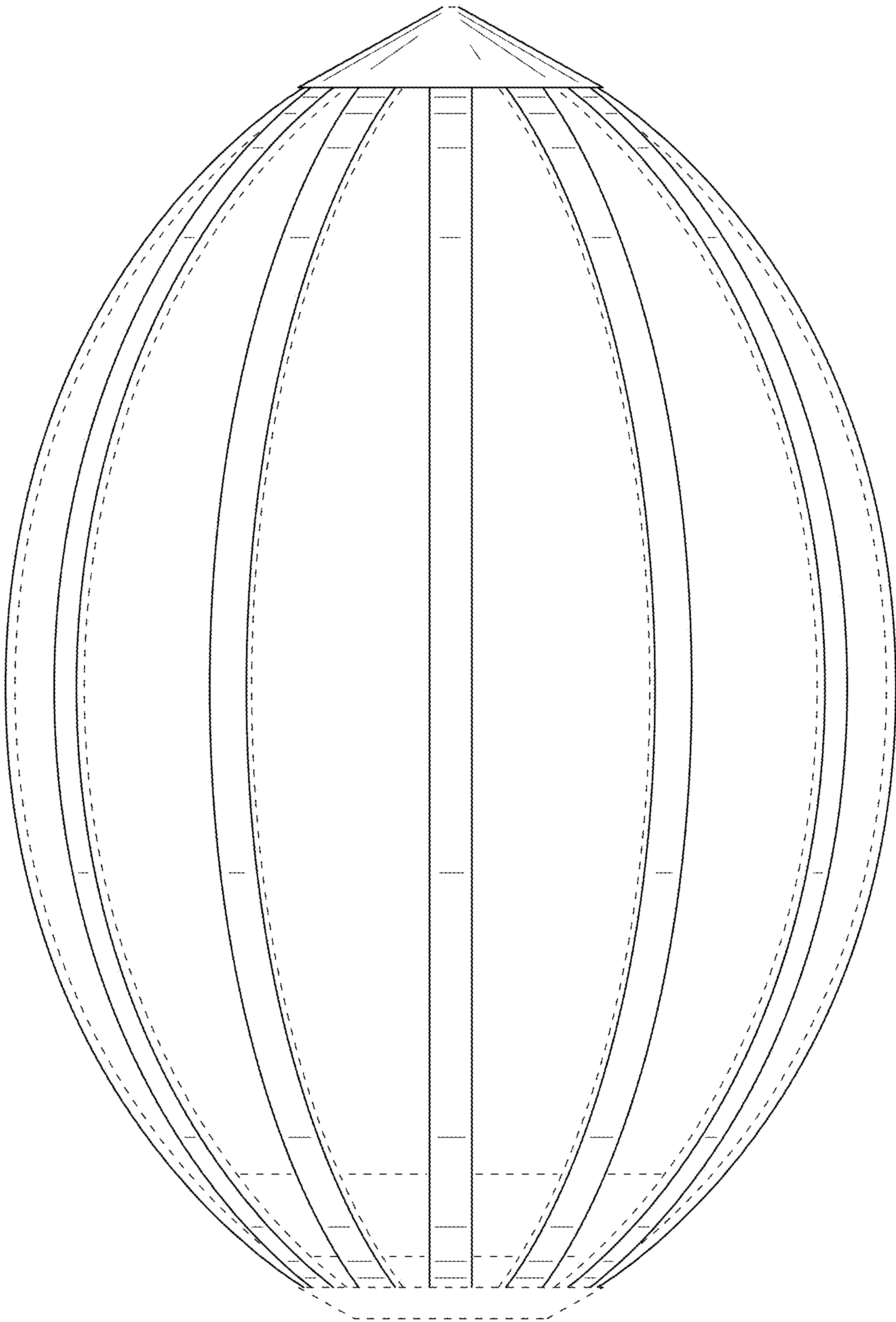

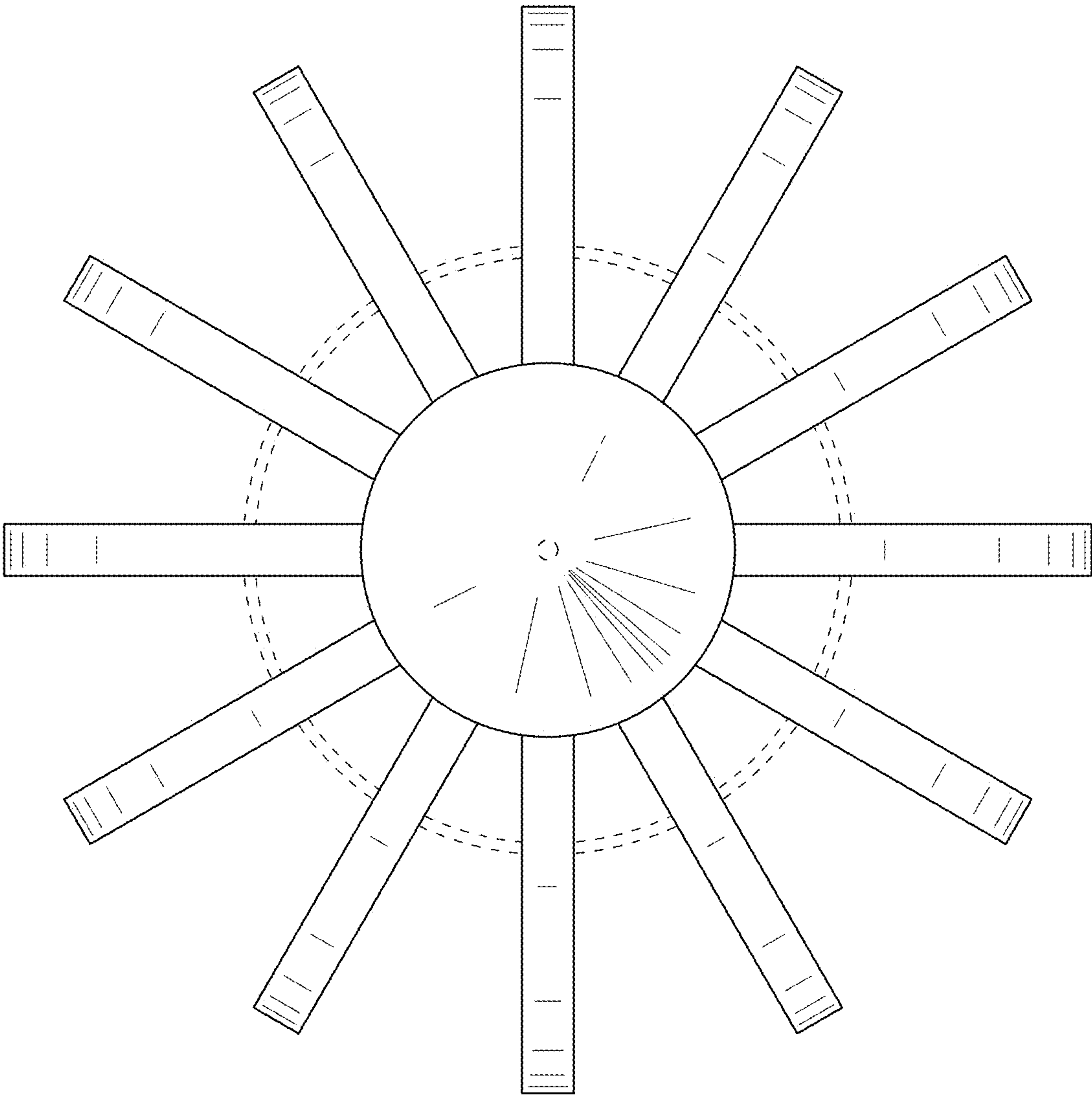

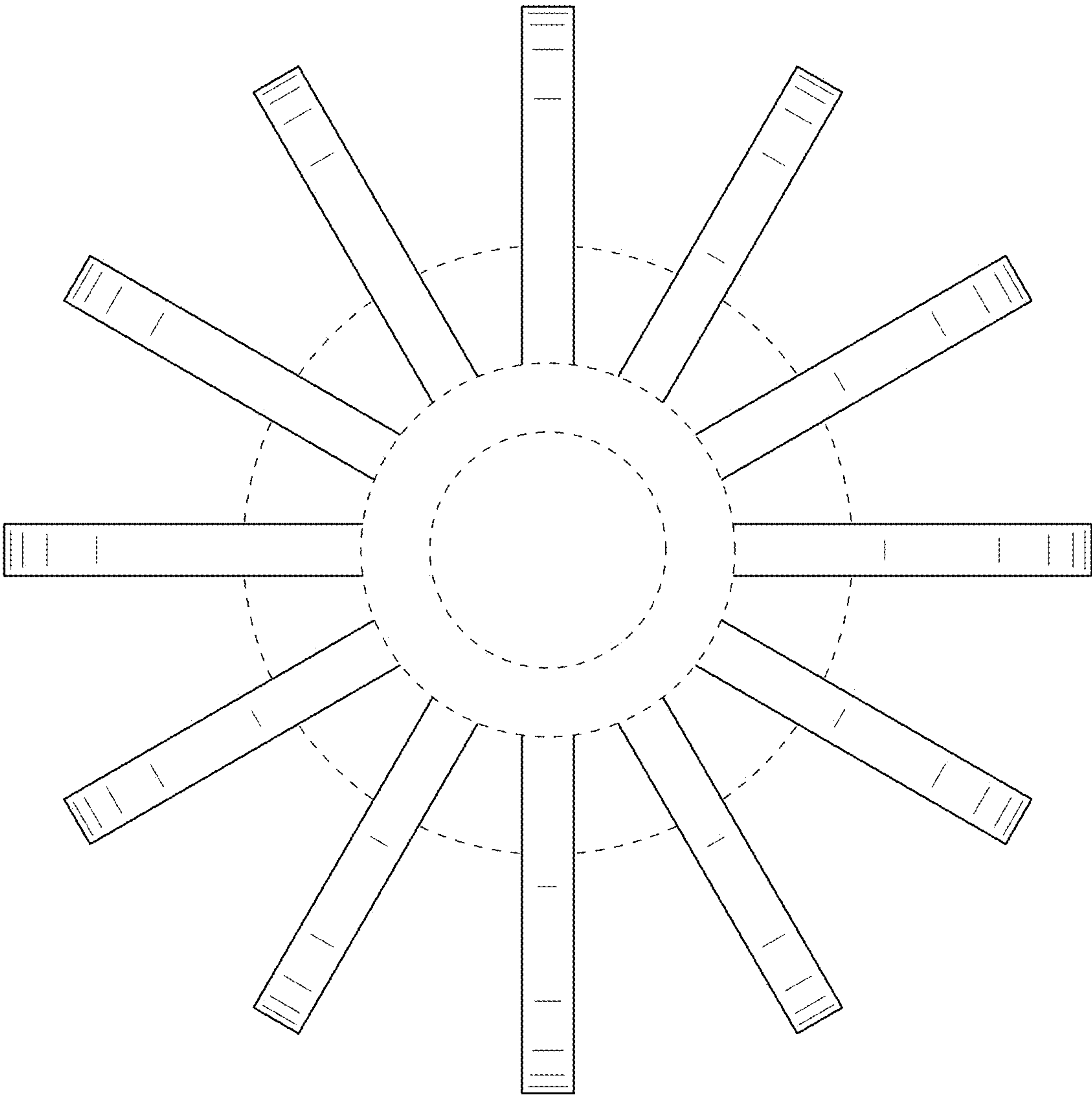
